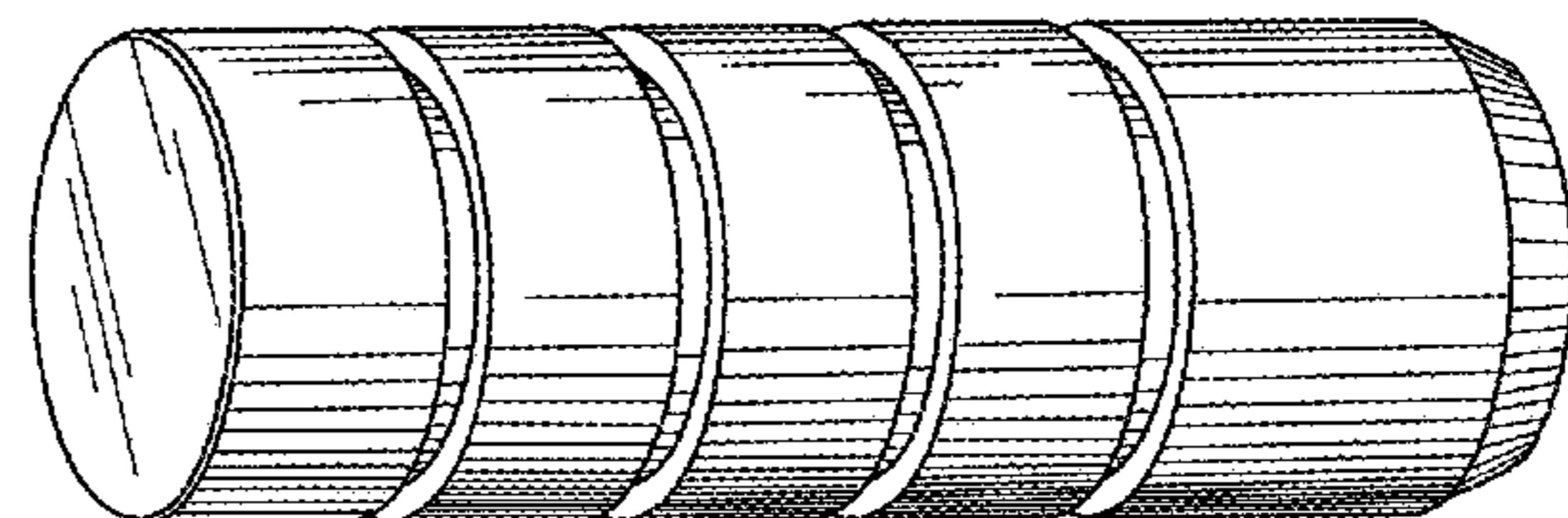
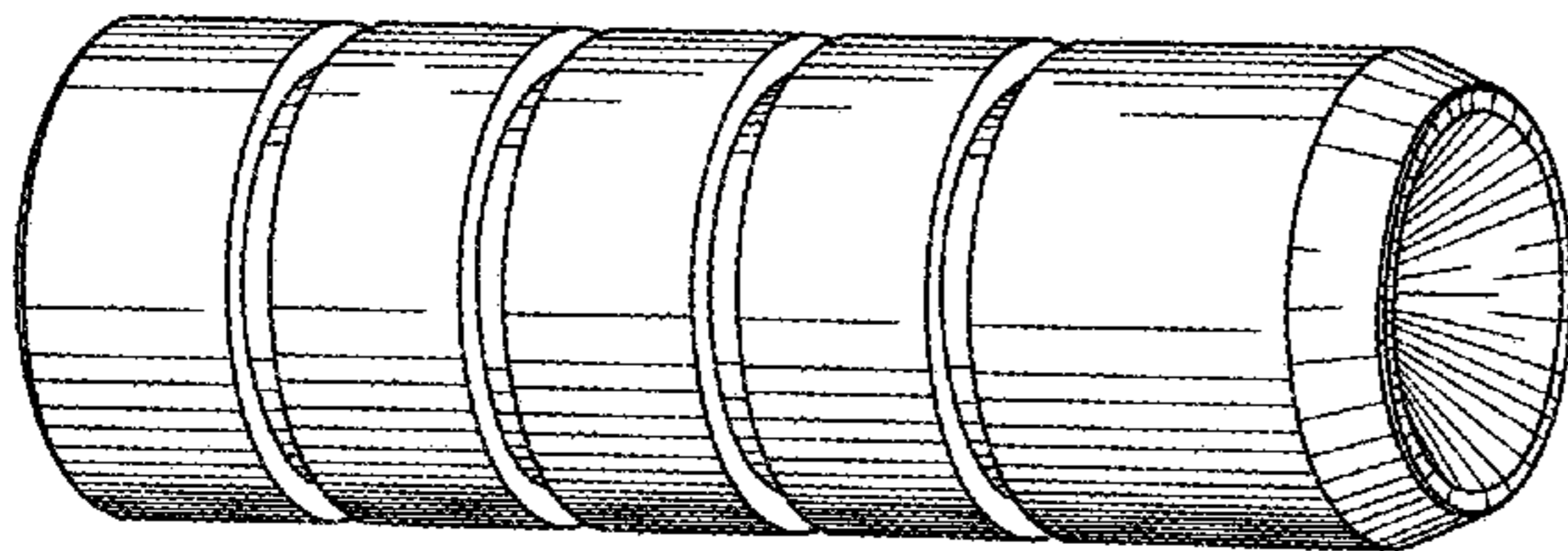
(57) **CLAIM**

The ornamental design for a slug for launching from a disruptor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the slug for launching from a disruptor showing the side and the top; FIG. 2 is another perspective view of the slug for launching from a disruptor showing the side and the bottom; FIG. 3 is a view of the side of the slug for launching from a disruptor, all sides having the same view because the slug is circular; FIG. 4 is a view of the top of the slug for launching from a disruptor; and, FIG. 5 is a view of the bottom of the slug for launching from a disruptor.

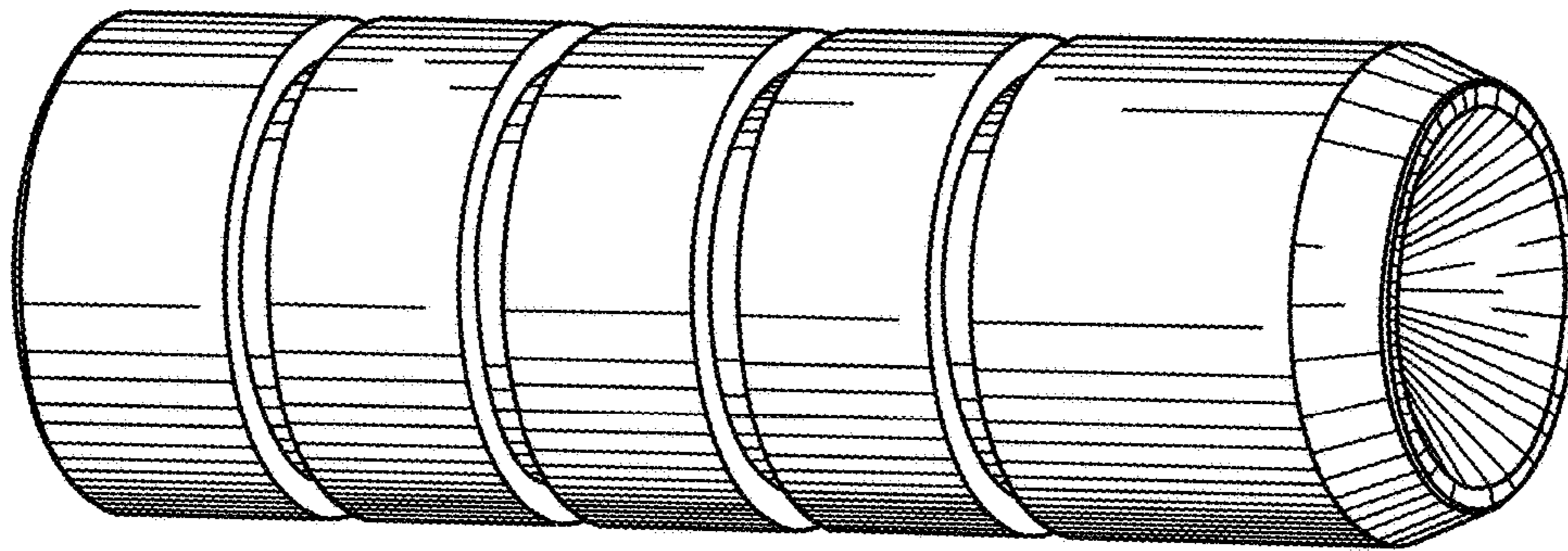

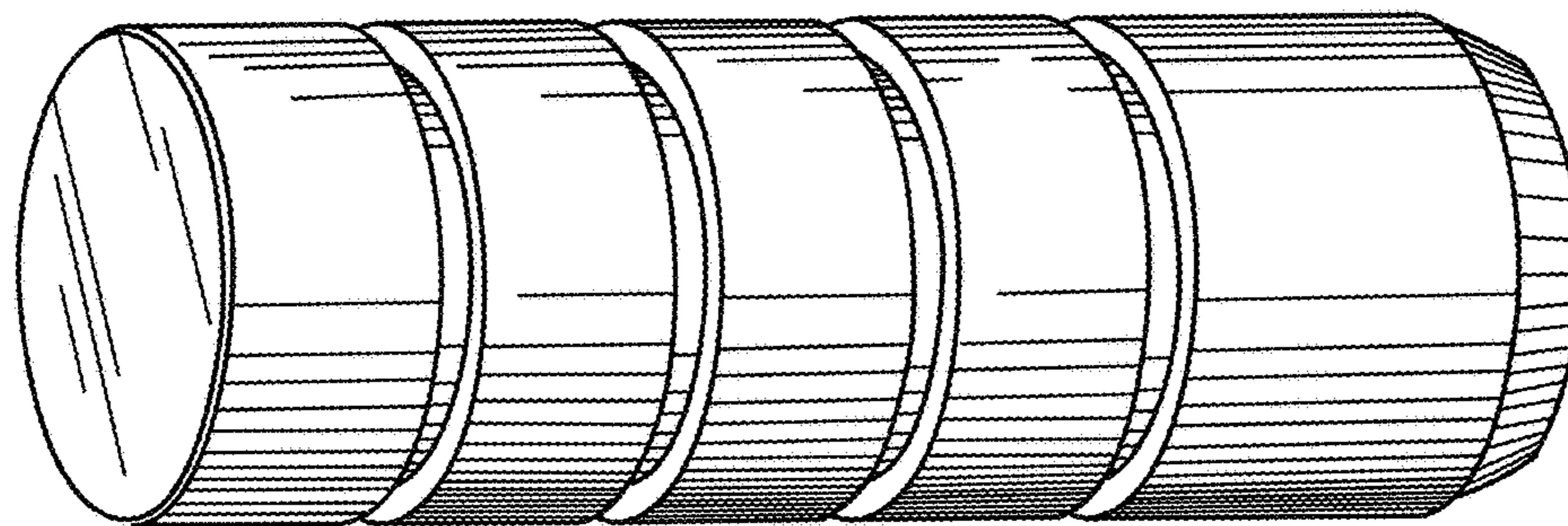

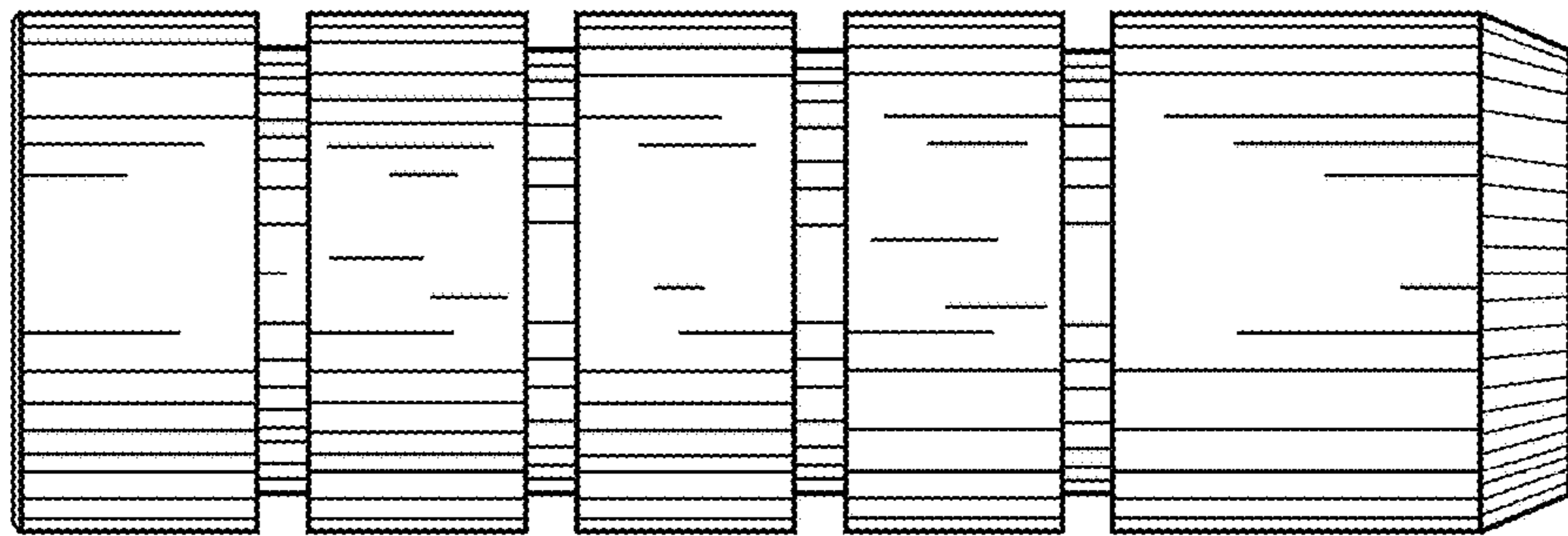

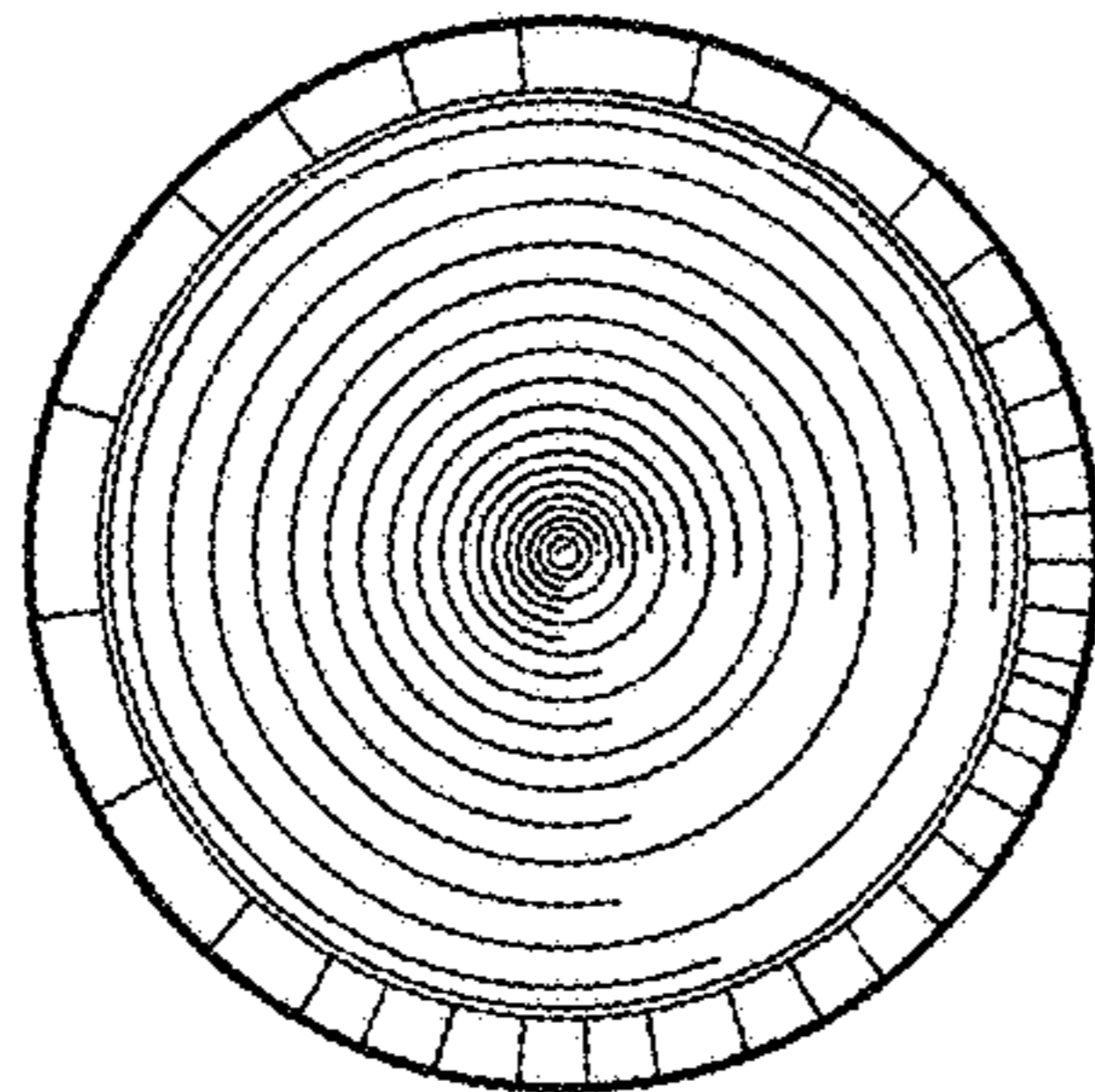

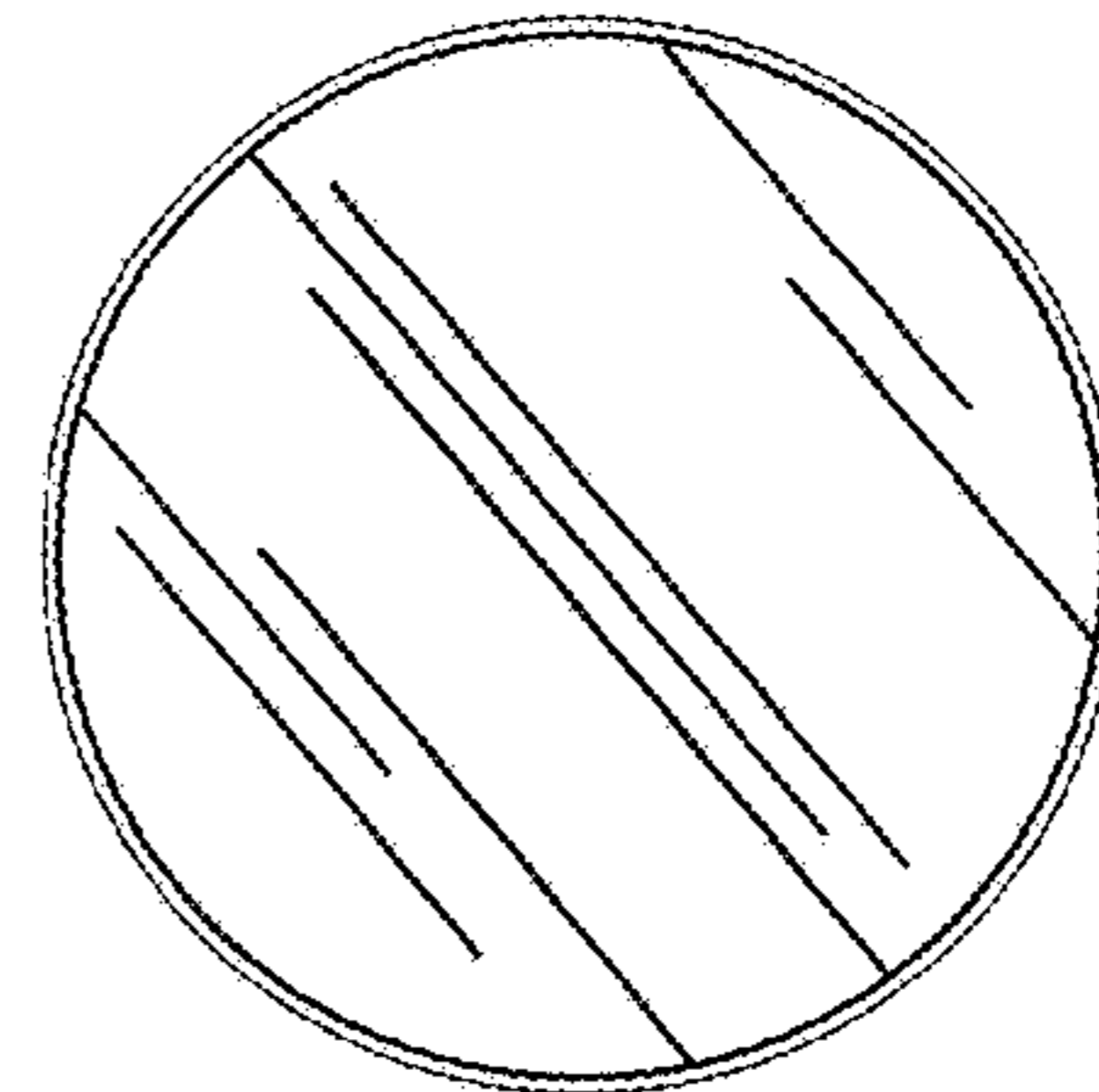
