shown in FIG. 1.

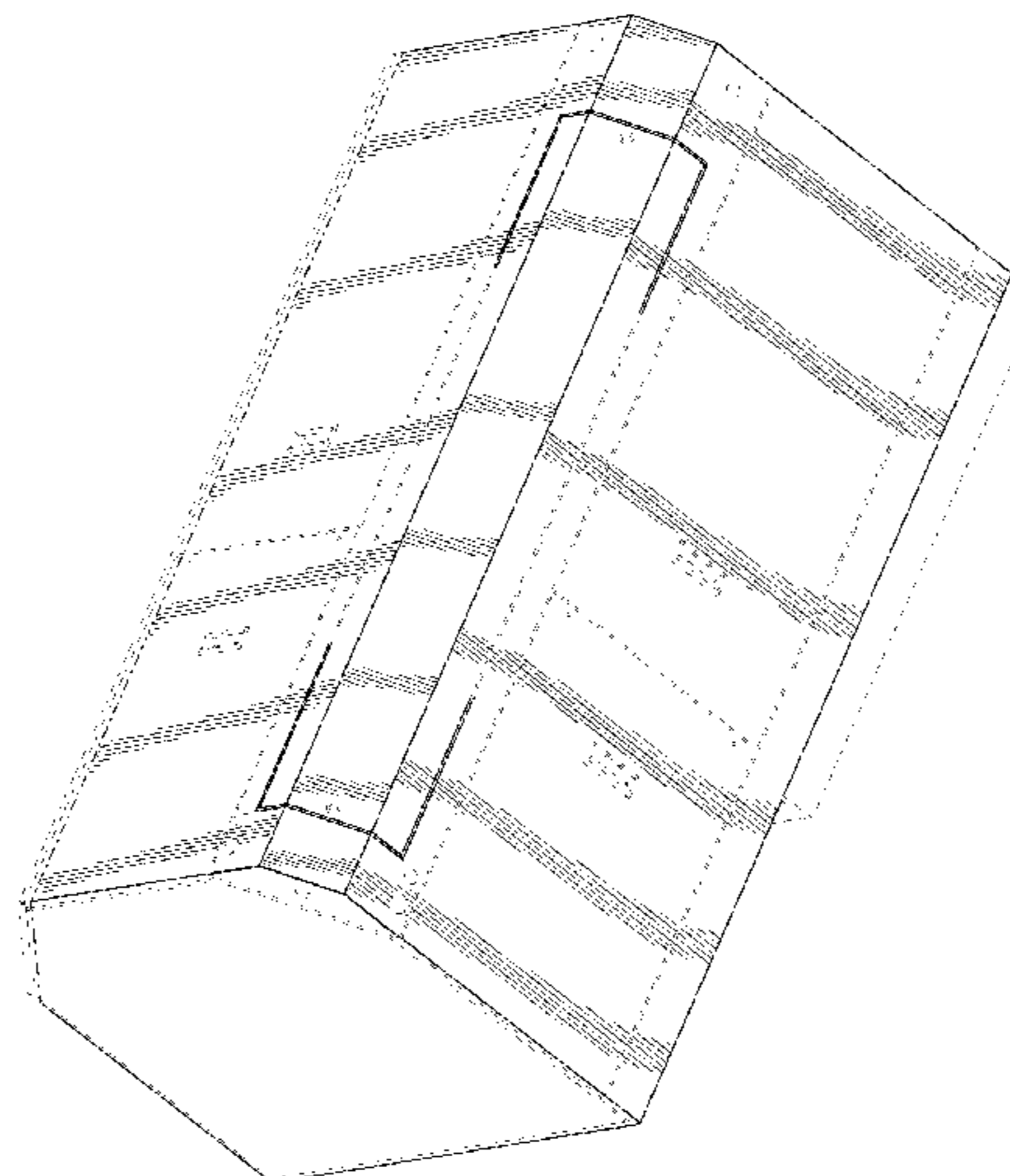
FIG. 5 is a fourth side view of the heating and cooling unit

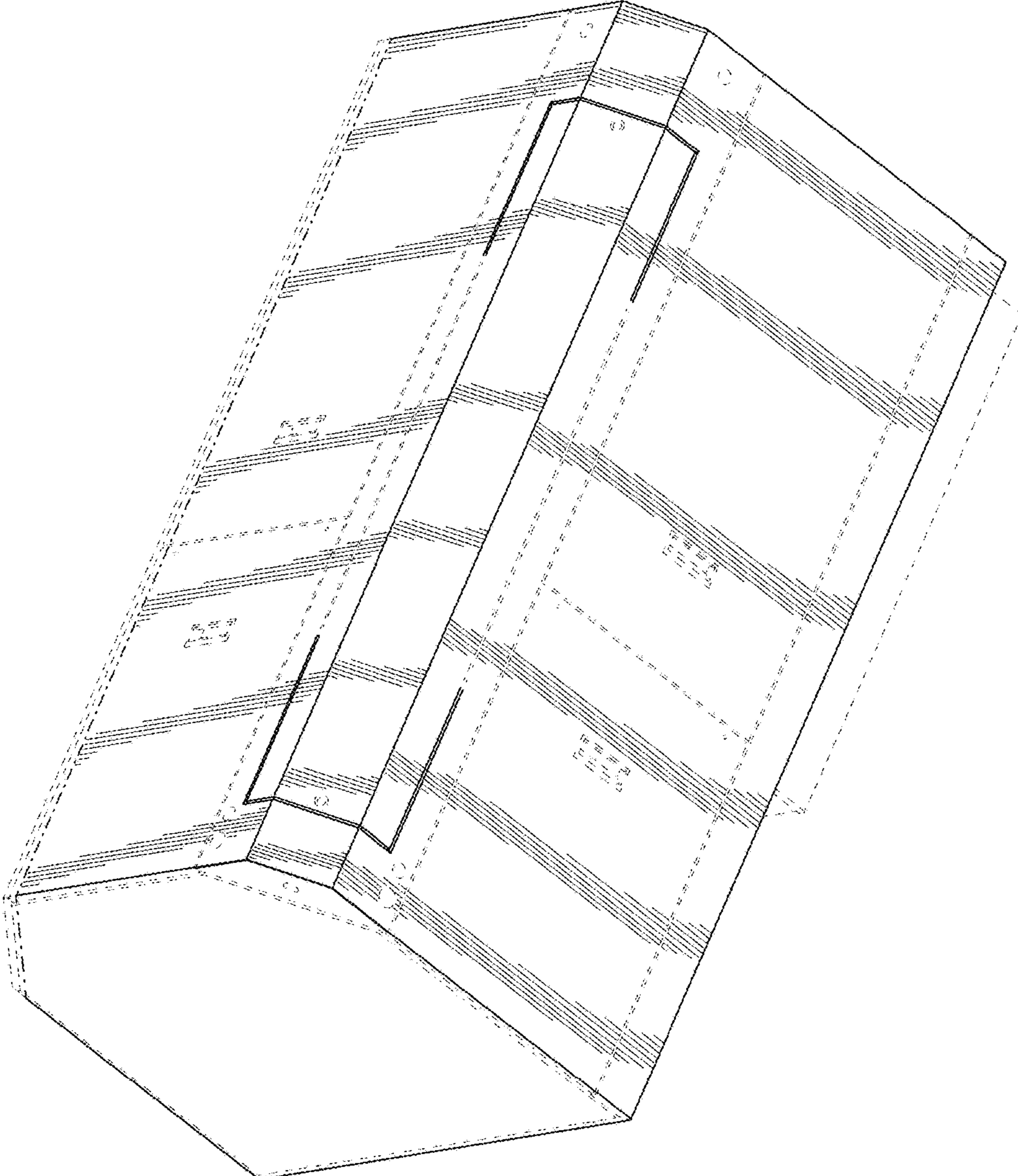

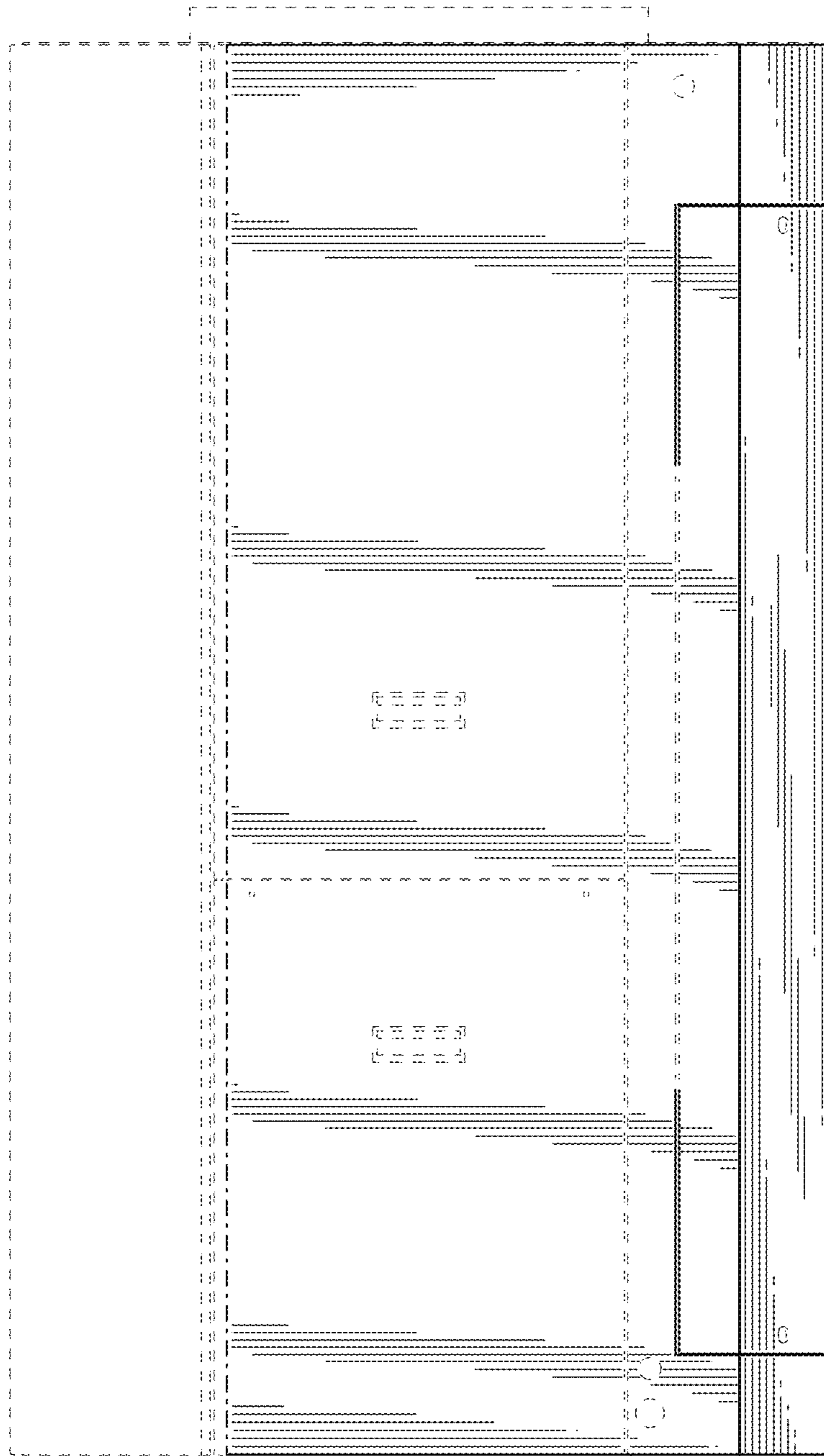

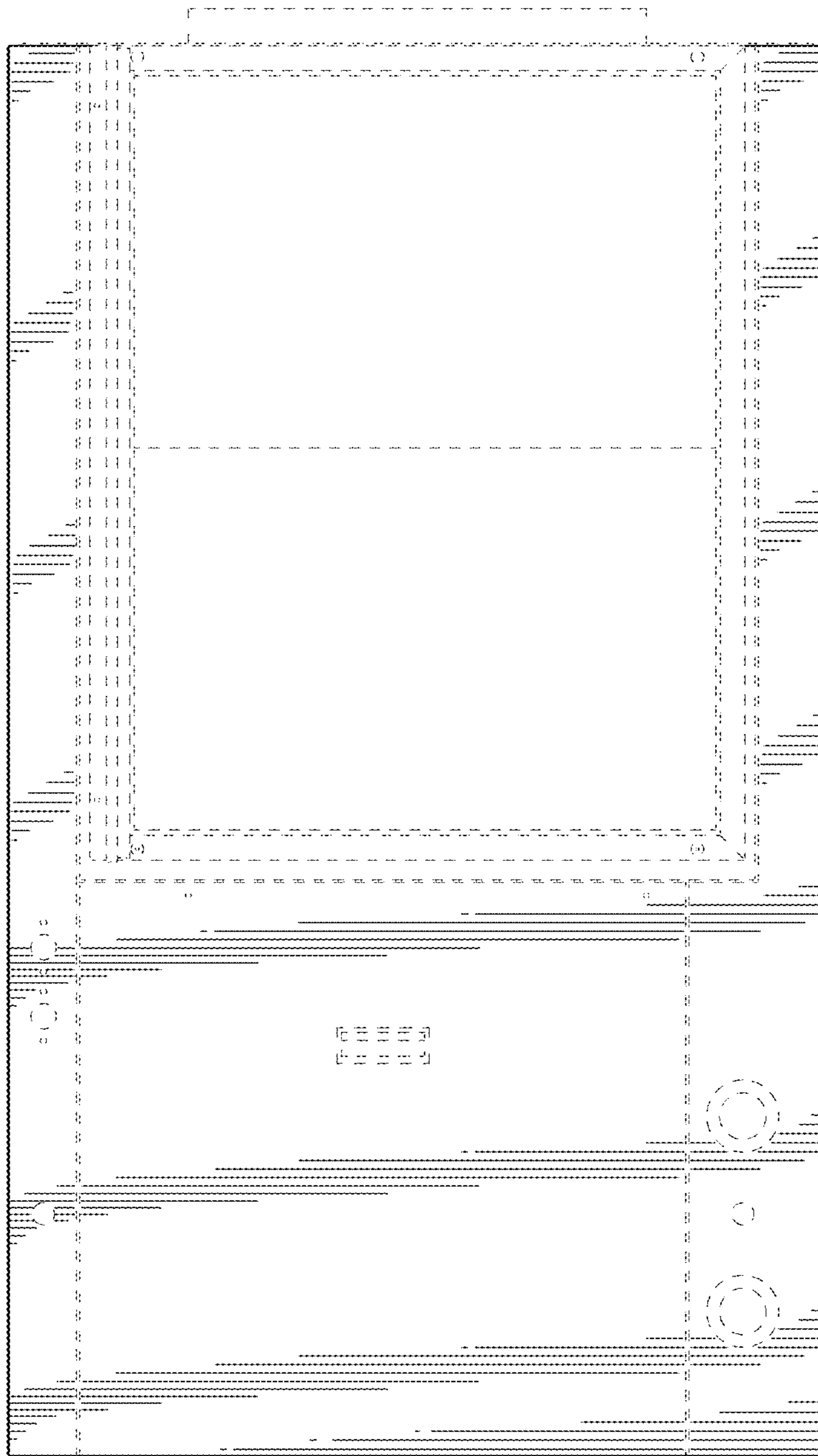

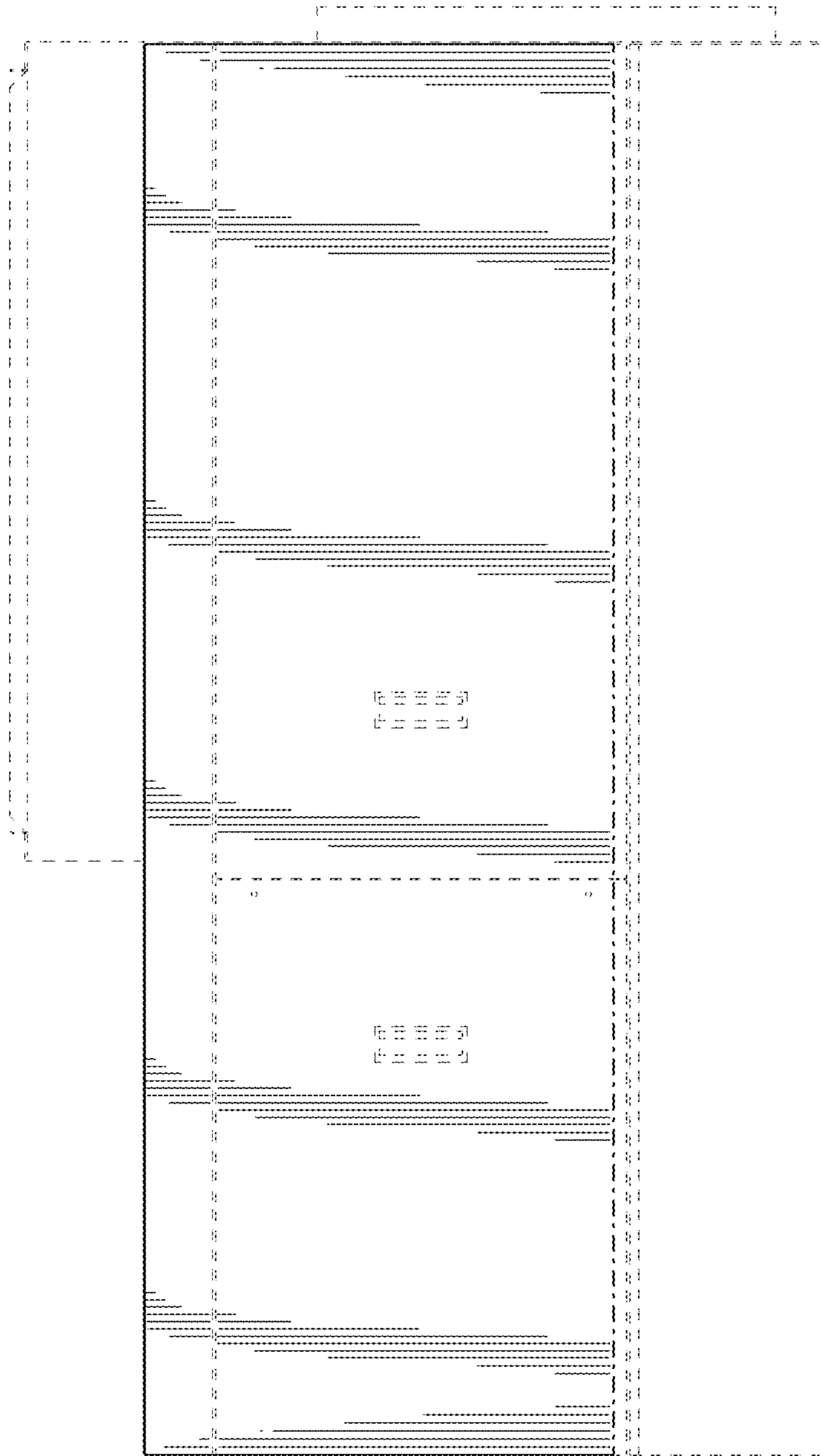

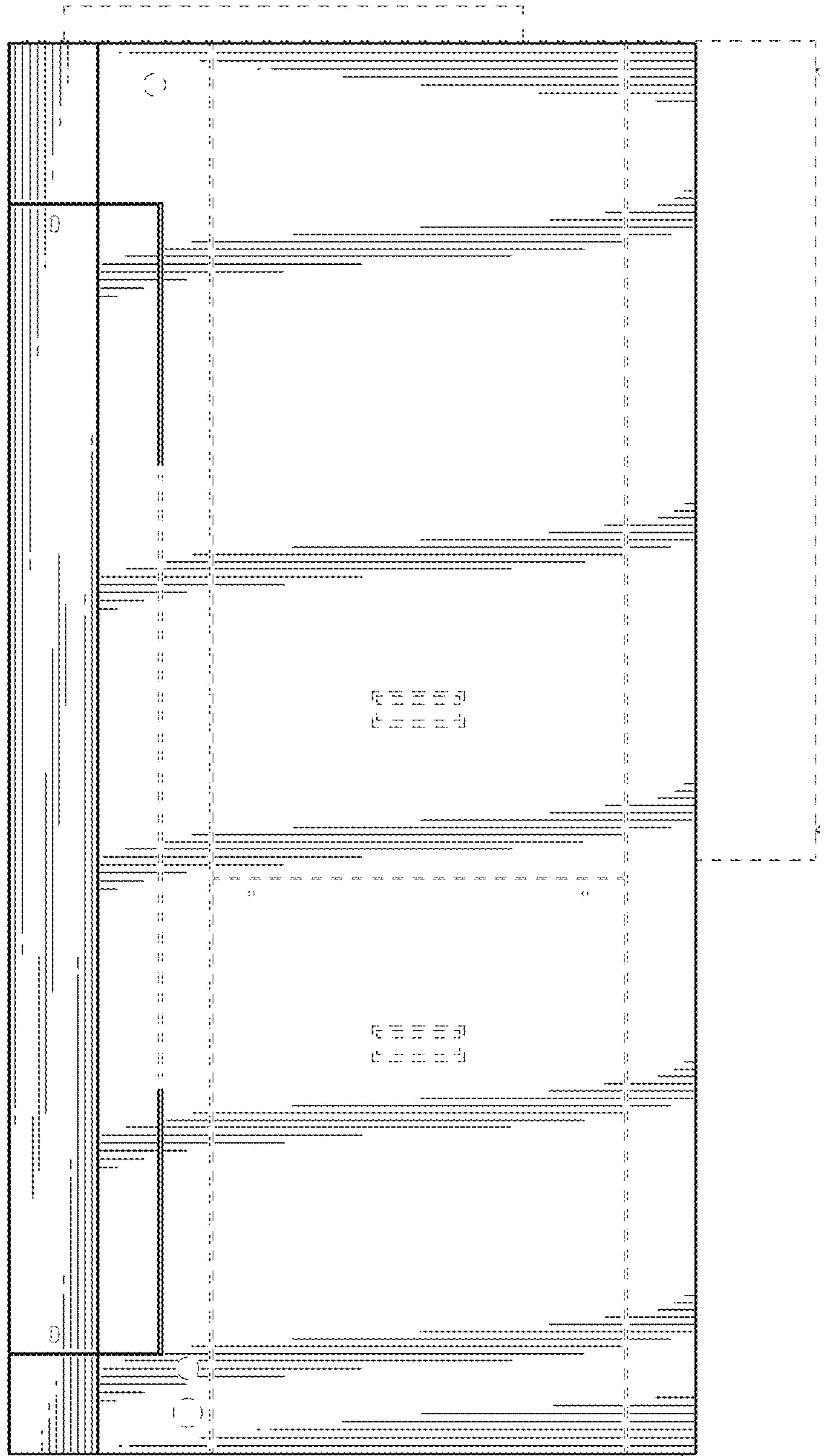

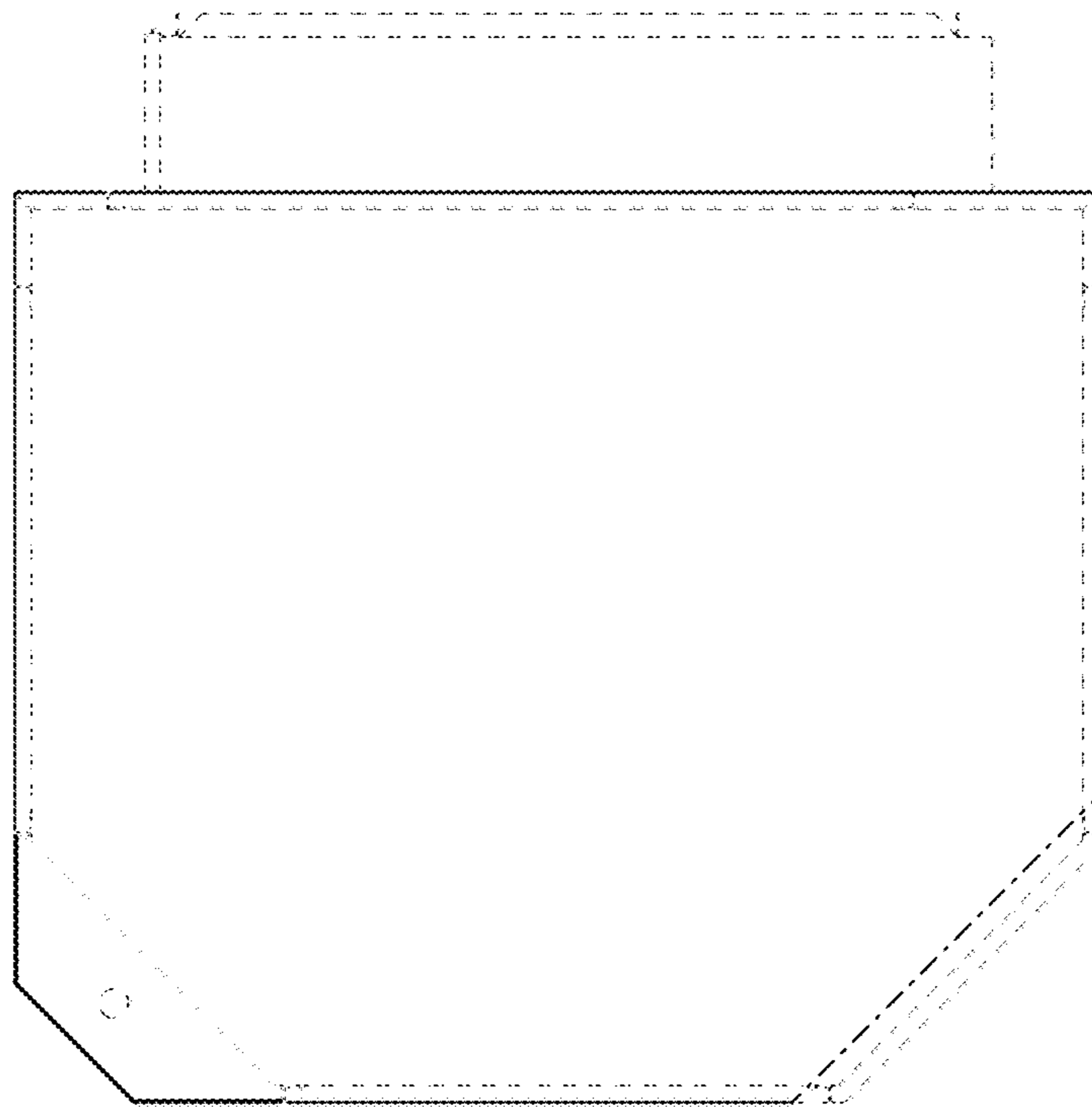

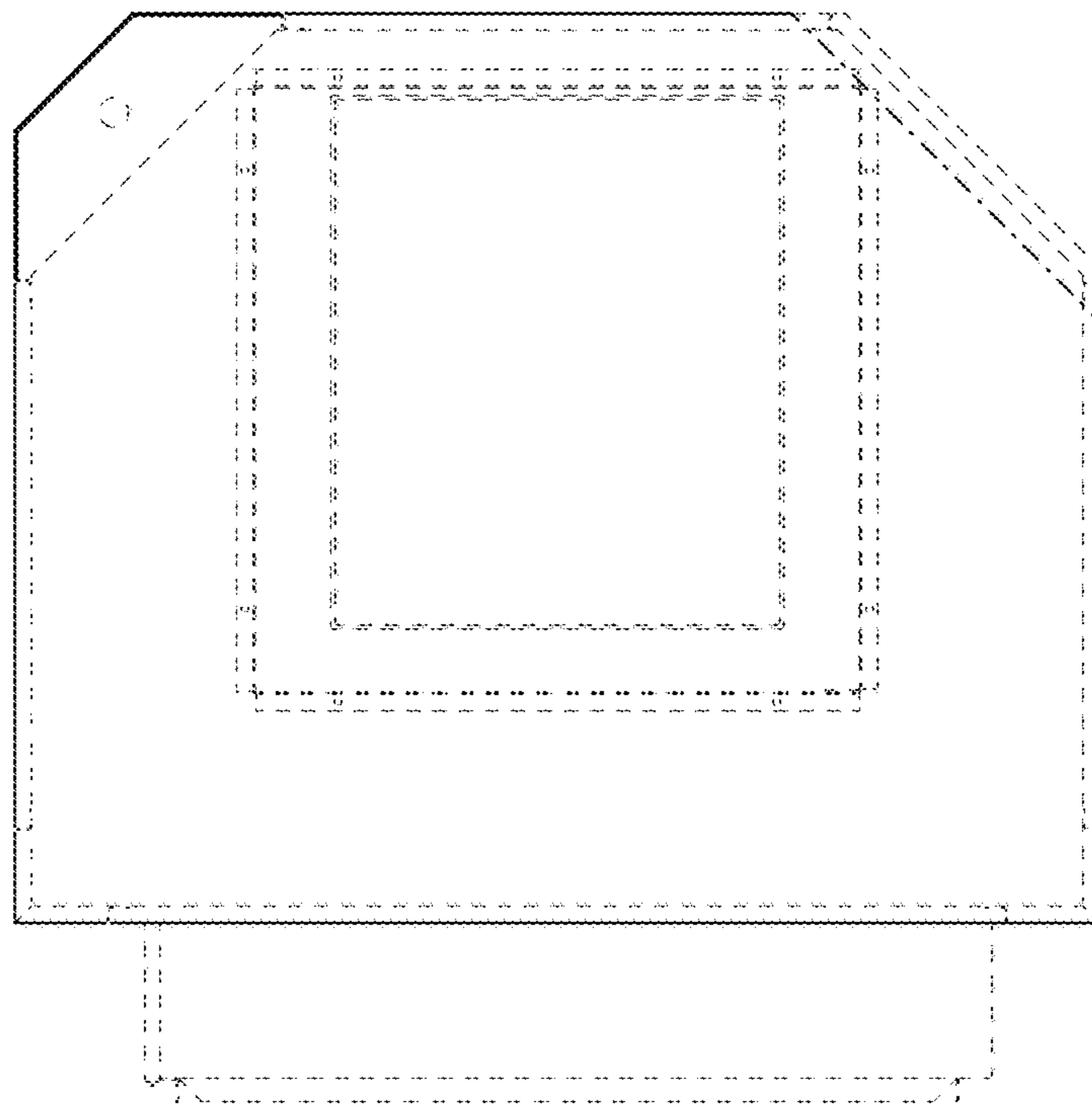
