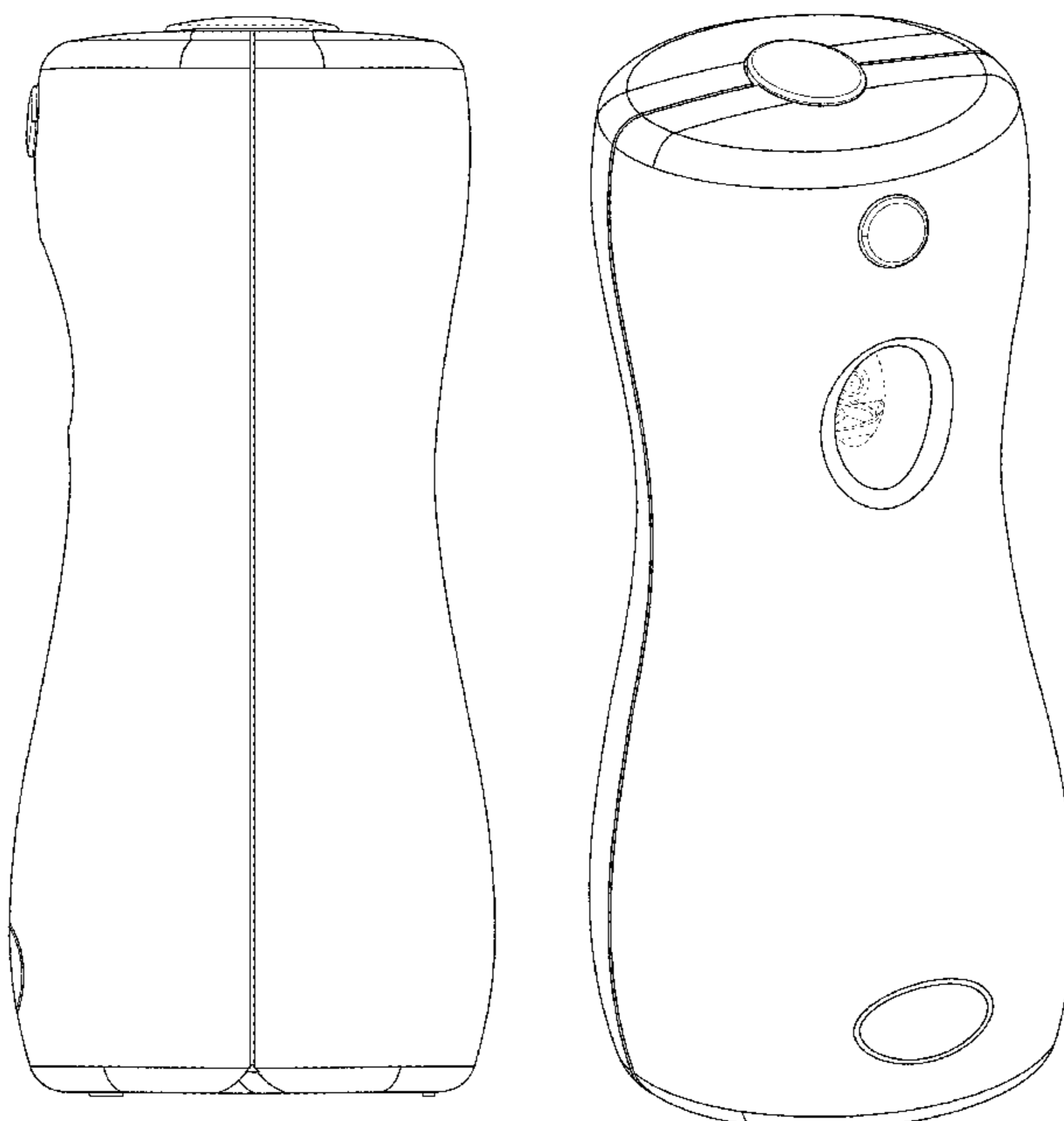
(57) **CLAIM**

The ornamental design for an air freshener, as shown and described.

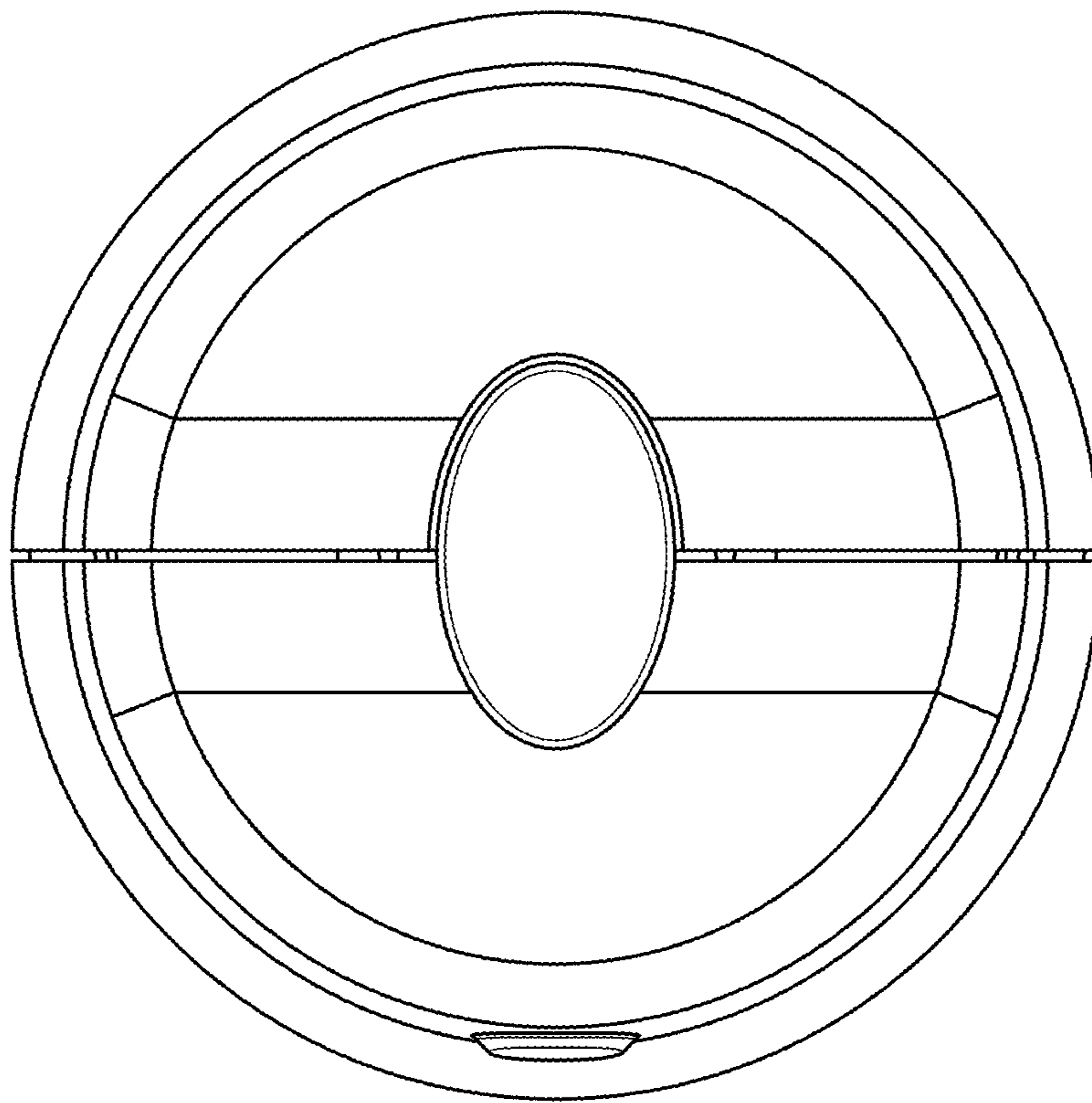
**DESCRIPTION**

The broken lines shown are included for the purpose of illustrating portions of the air freshener that form no part of the claim.

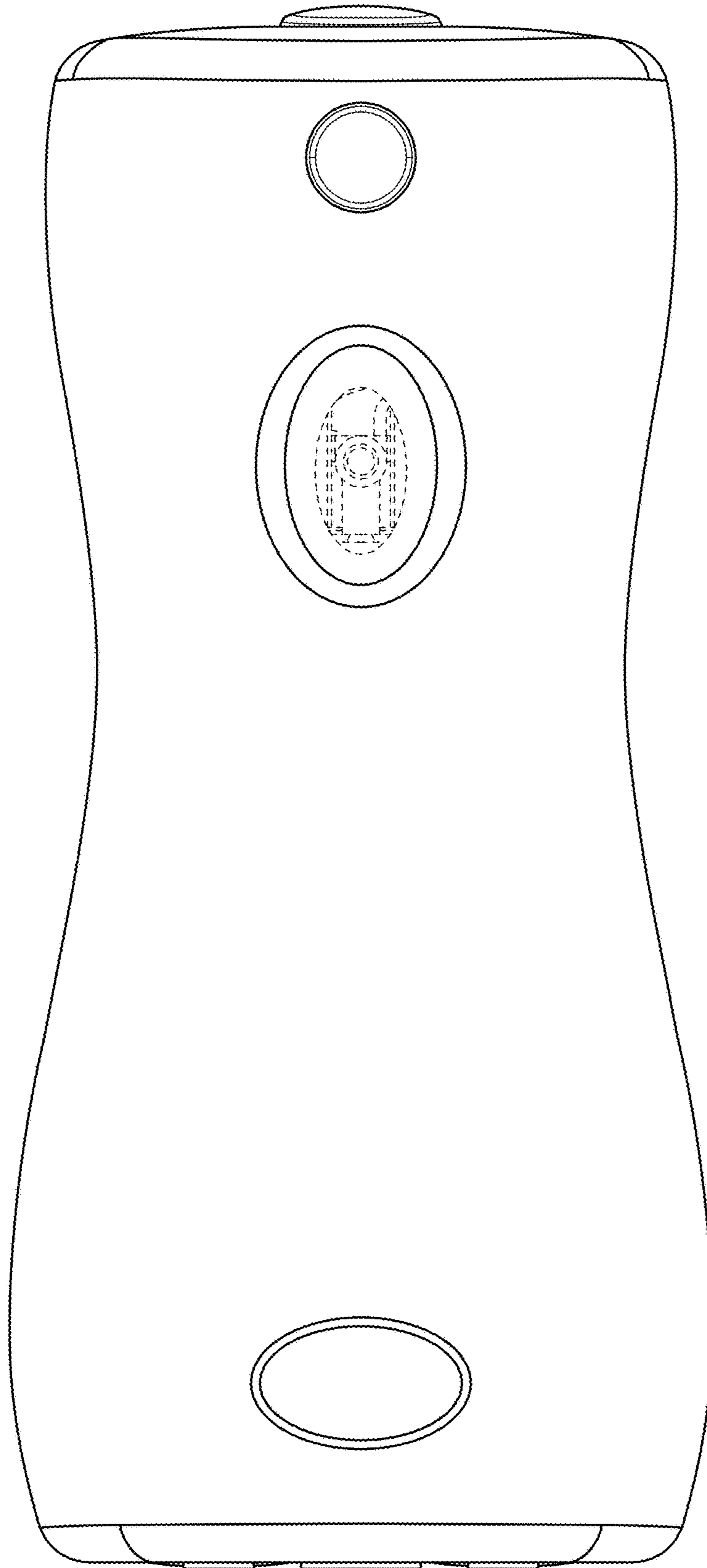

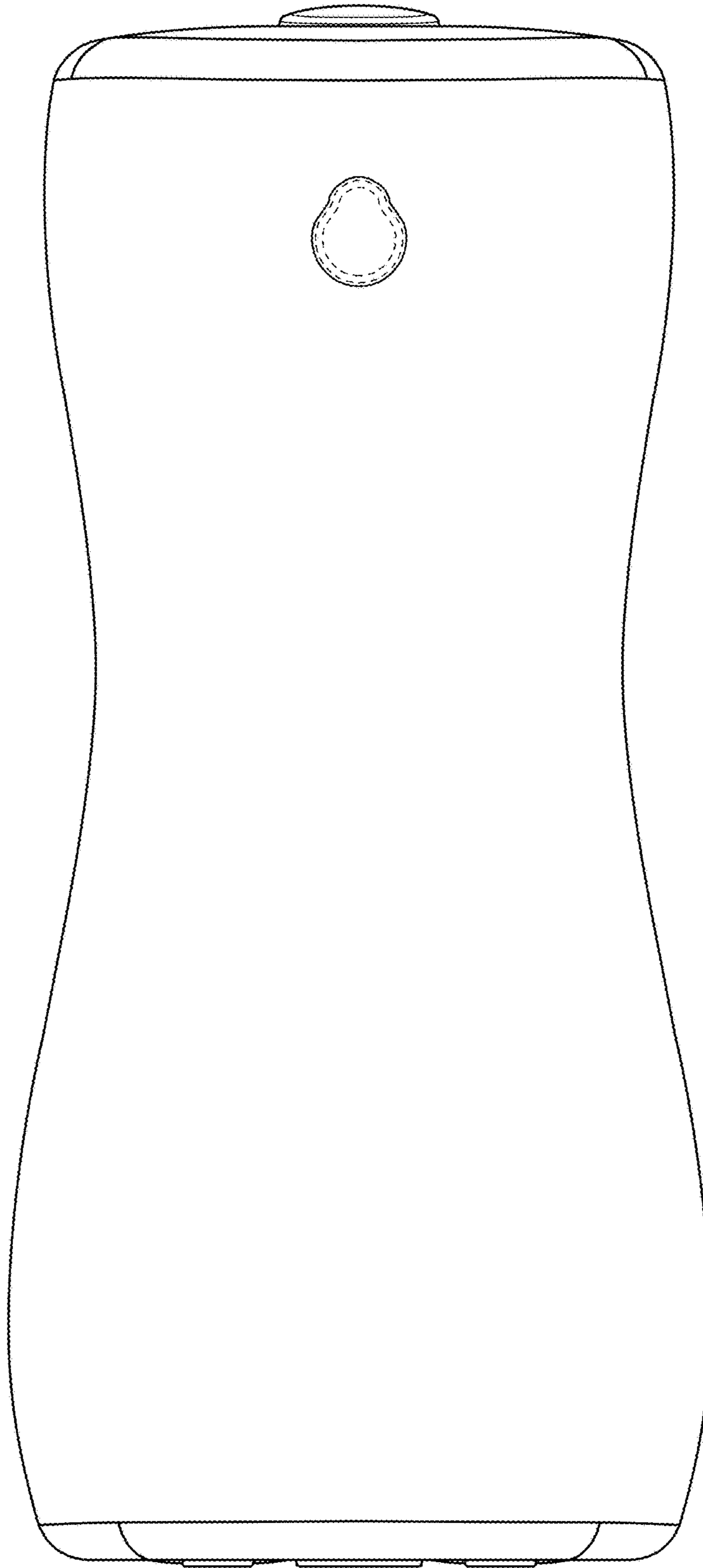

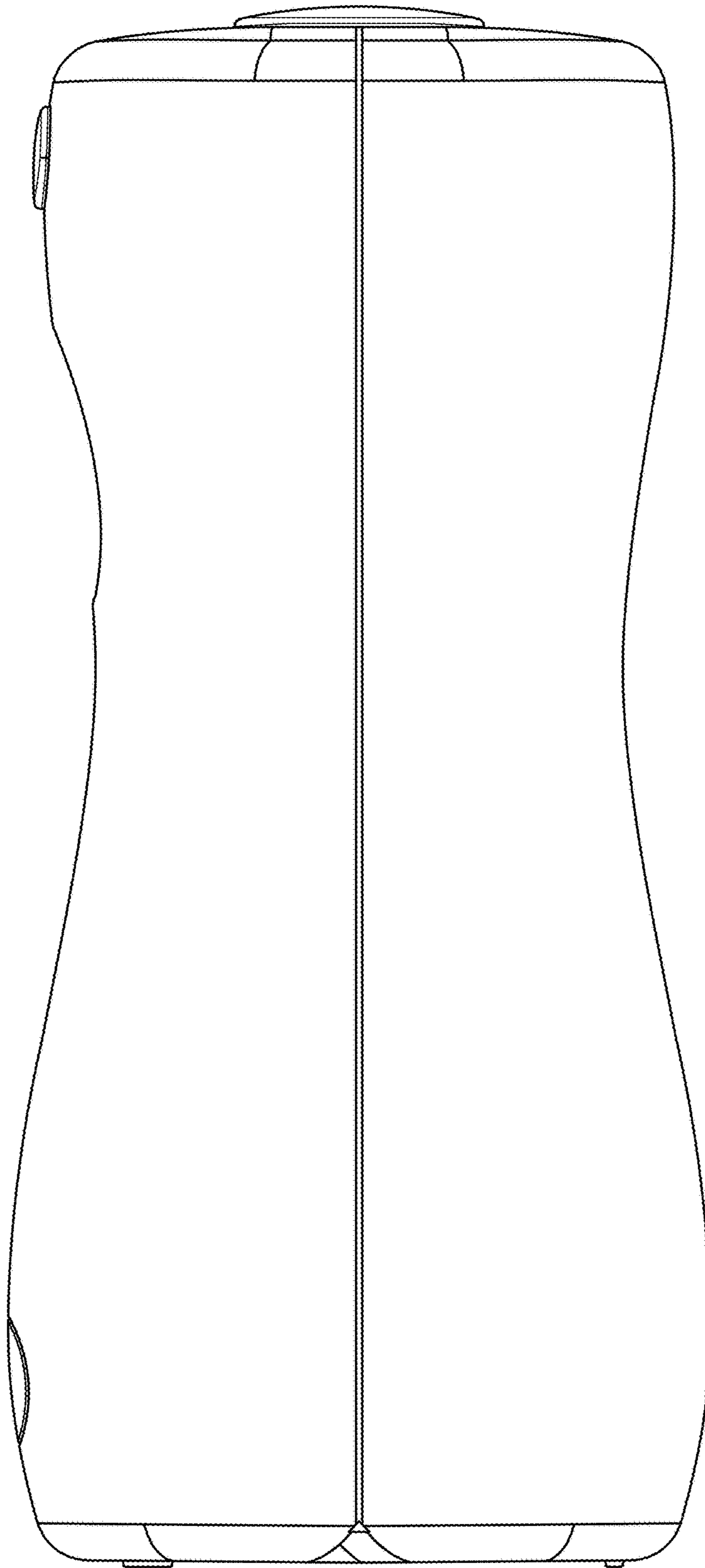

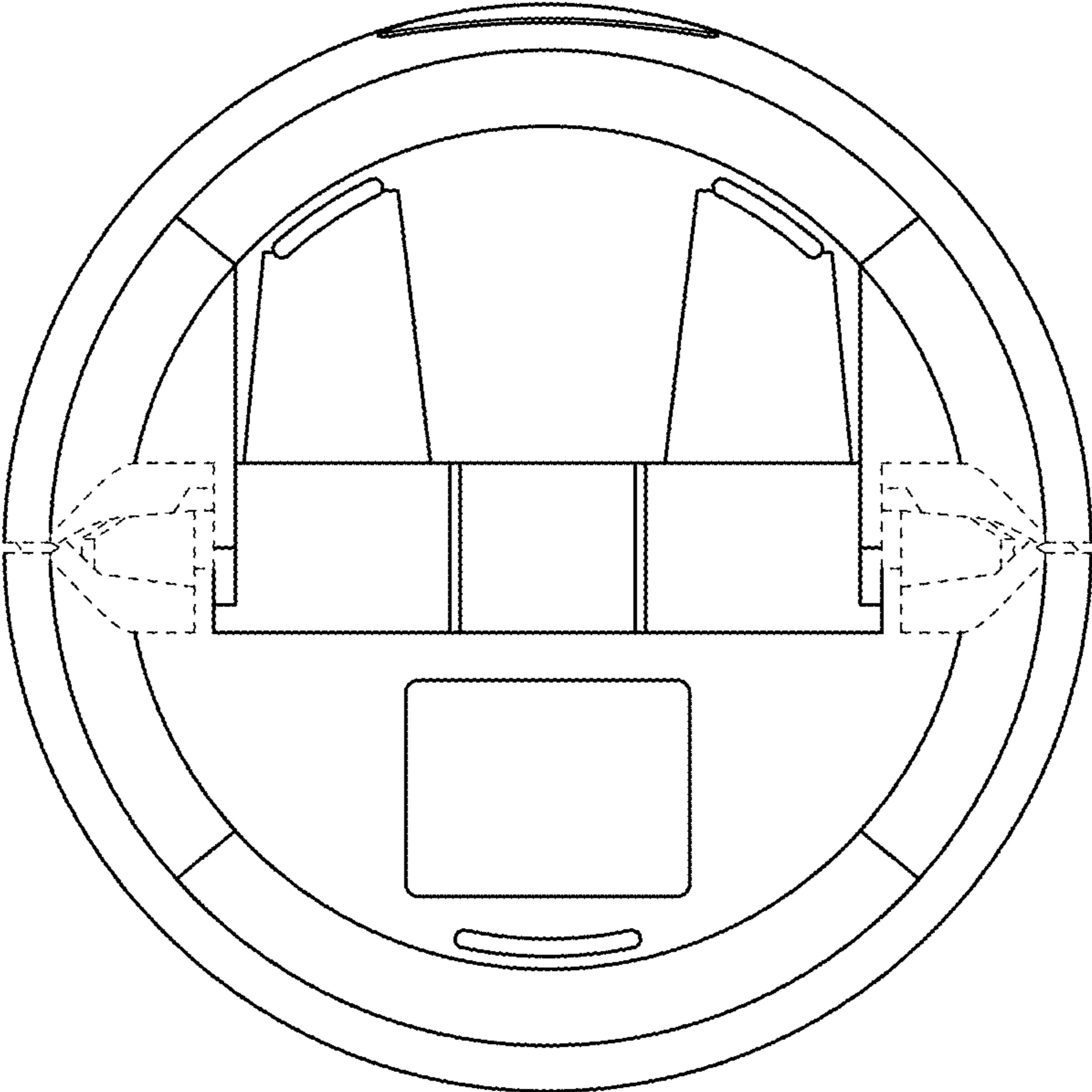

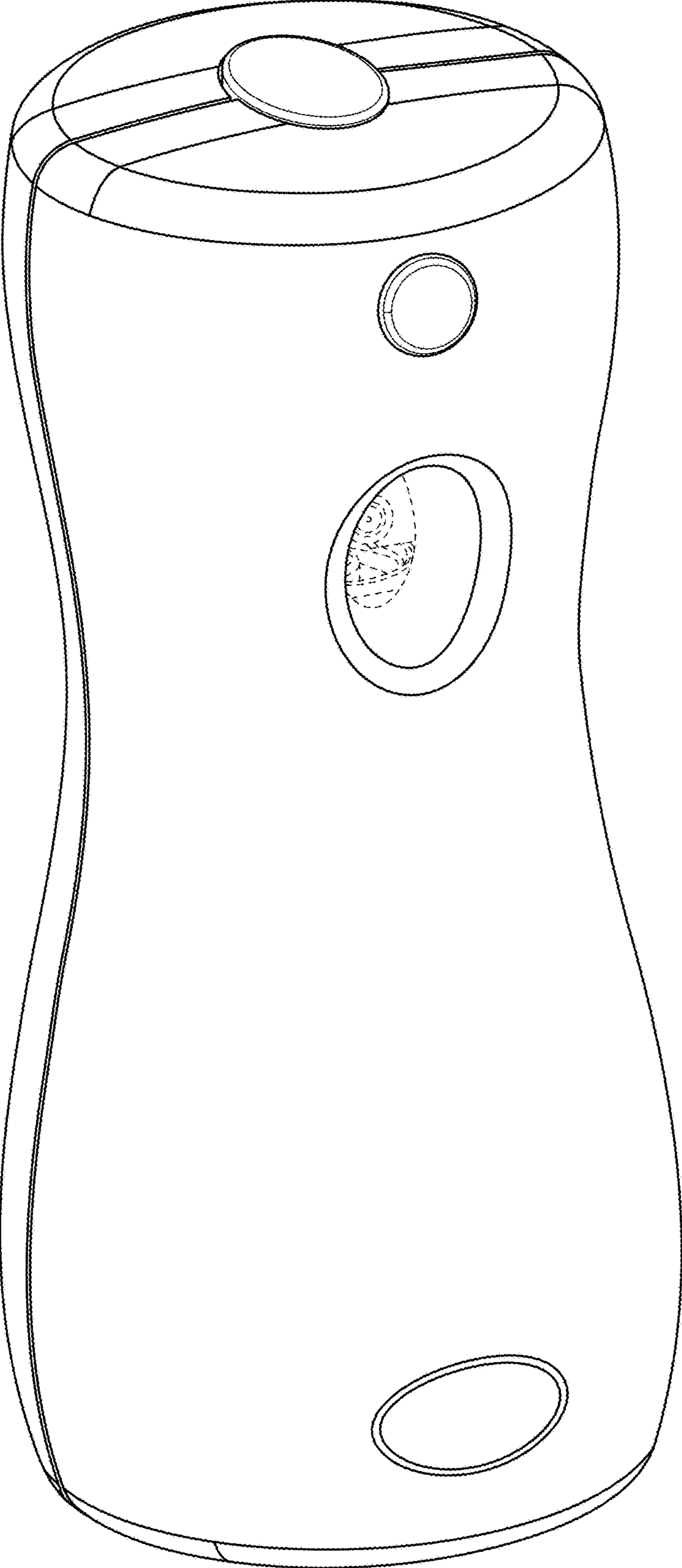
