(57) **CLAIM**

The ornamental design for a connector of a nasal cannula assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a connector for a nasal cannula assembly.

FIG. 2 is a rear view thereof.

FIG. 3 is a front view thereof.

FIG. 4 is a left side view thereof.

FIG. 5 is a right side view thereof.

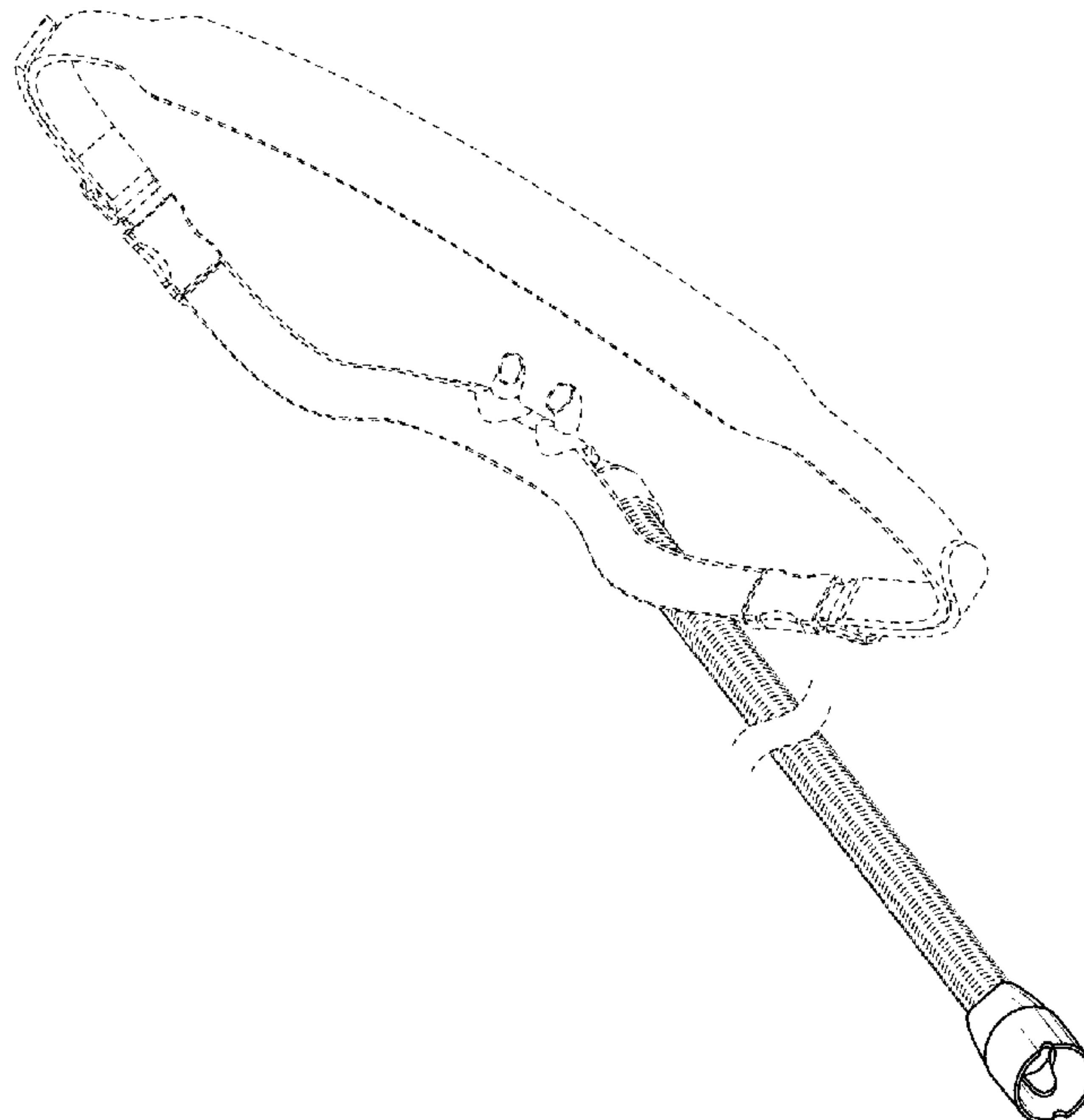
FIG. 6 is a top view thereof; and,

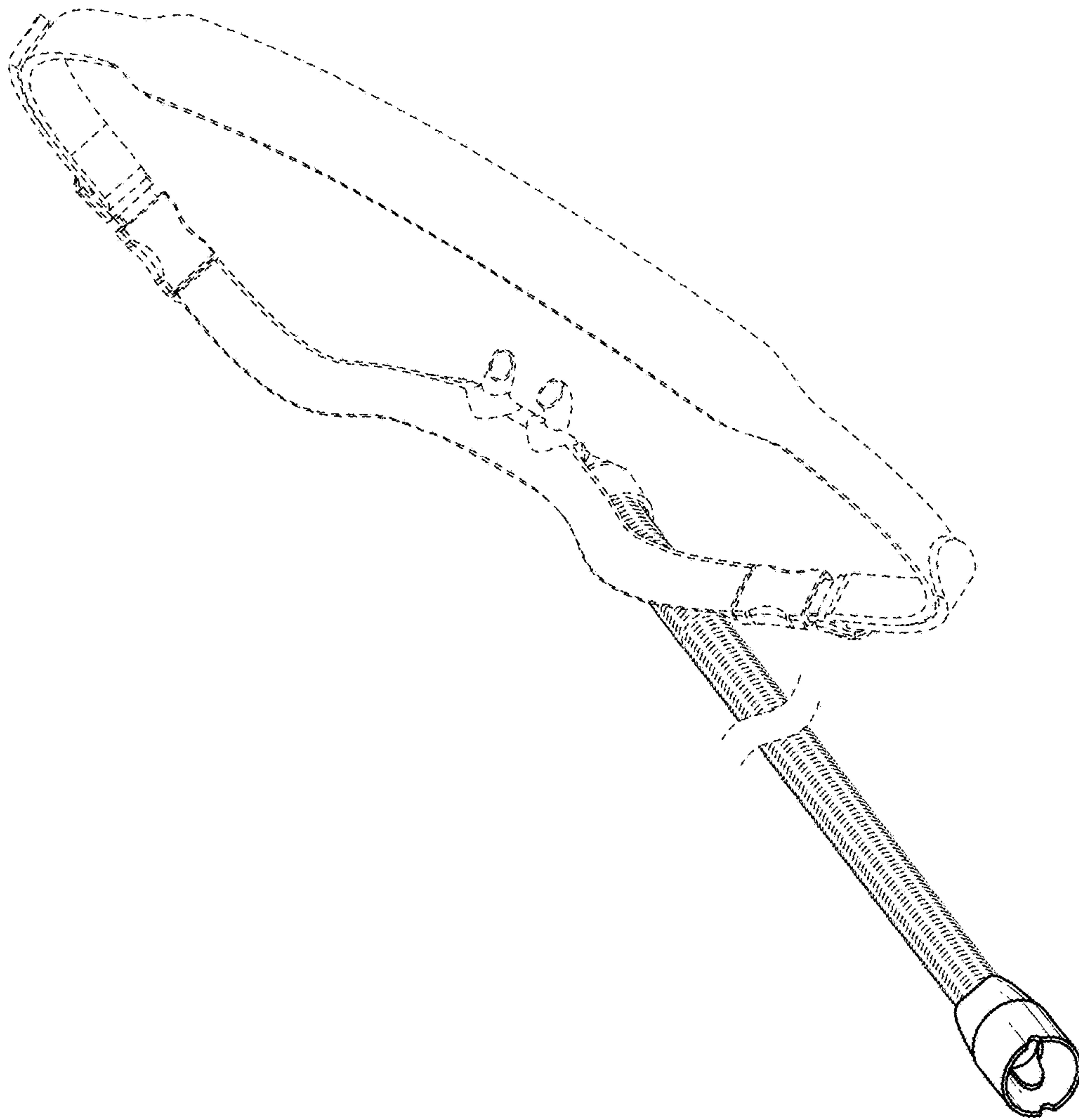

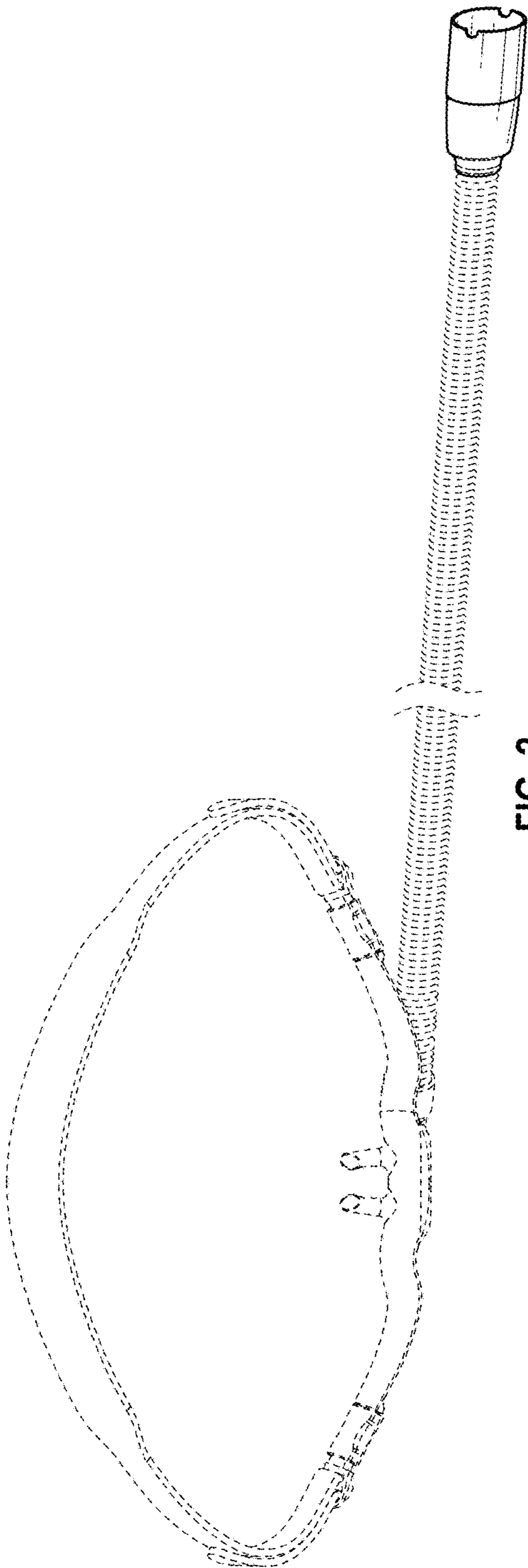

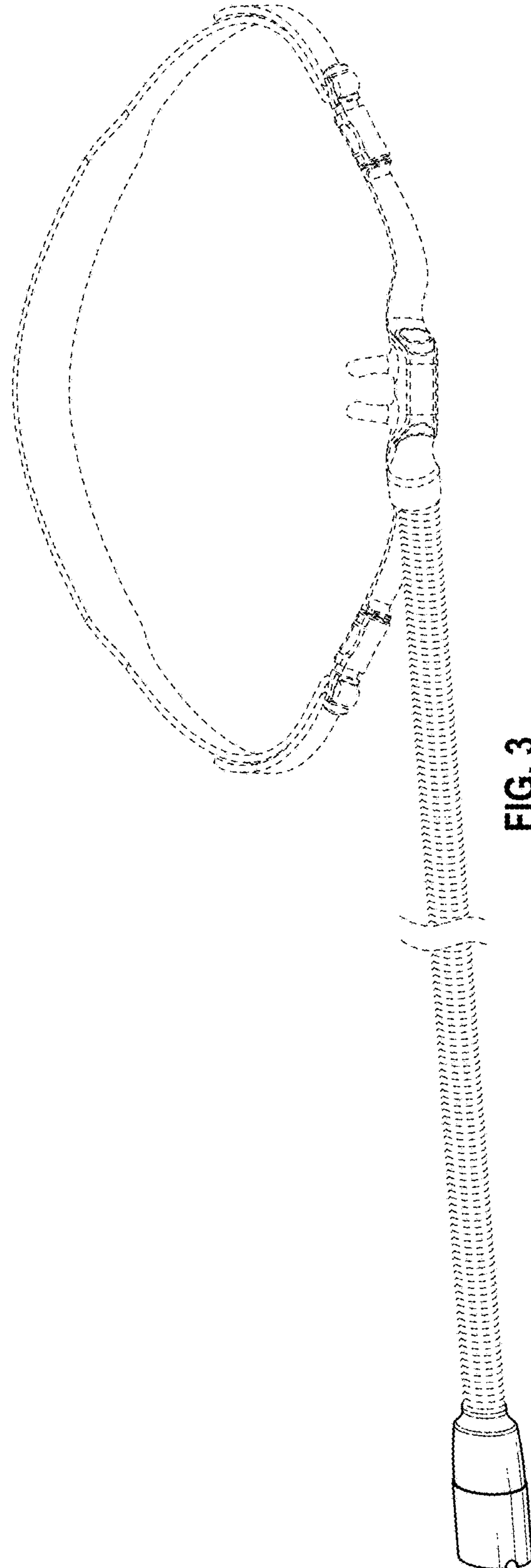

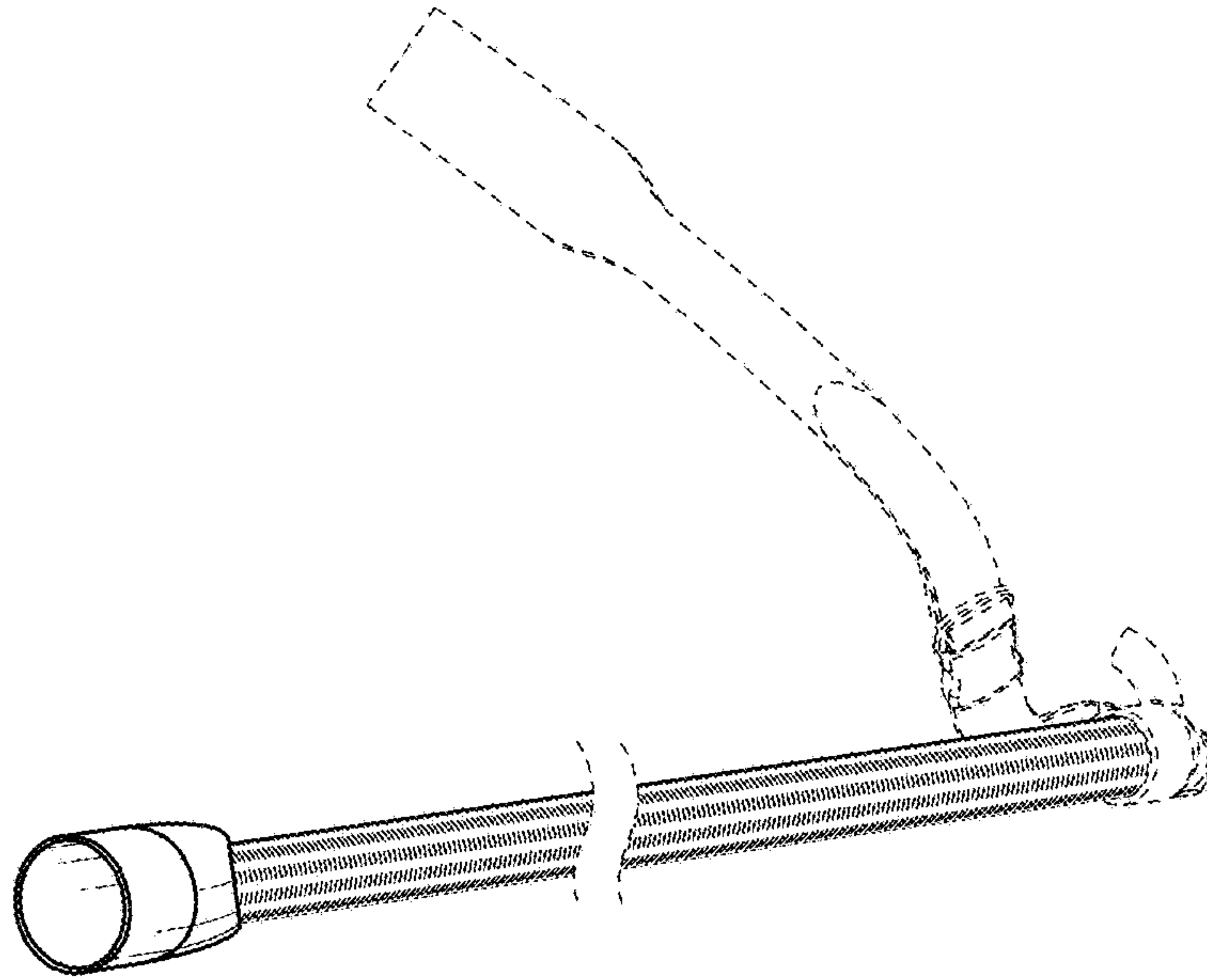

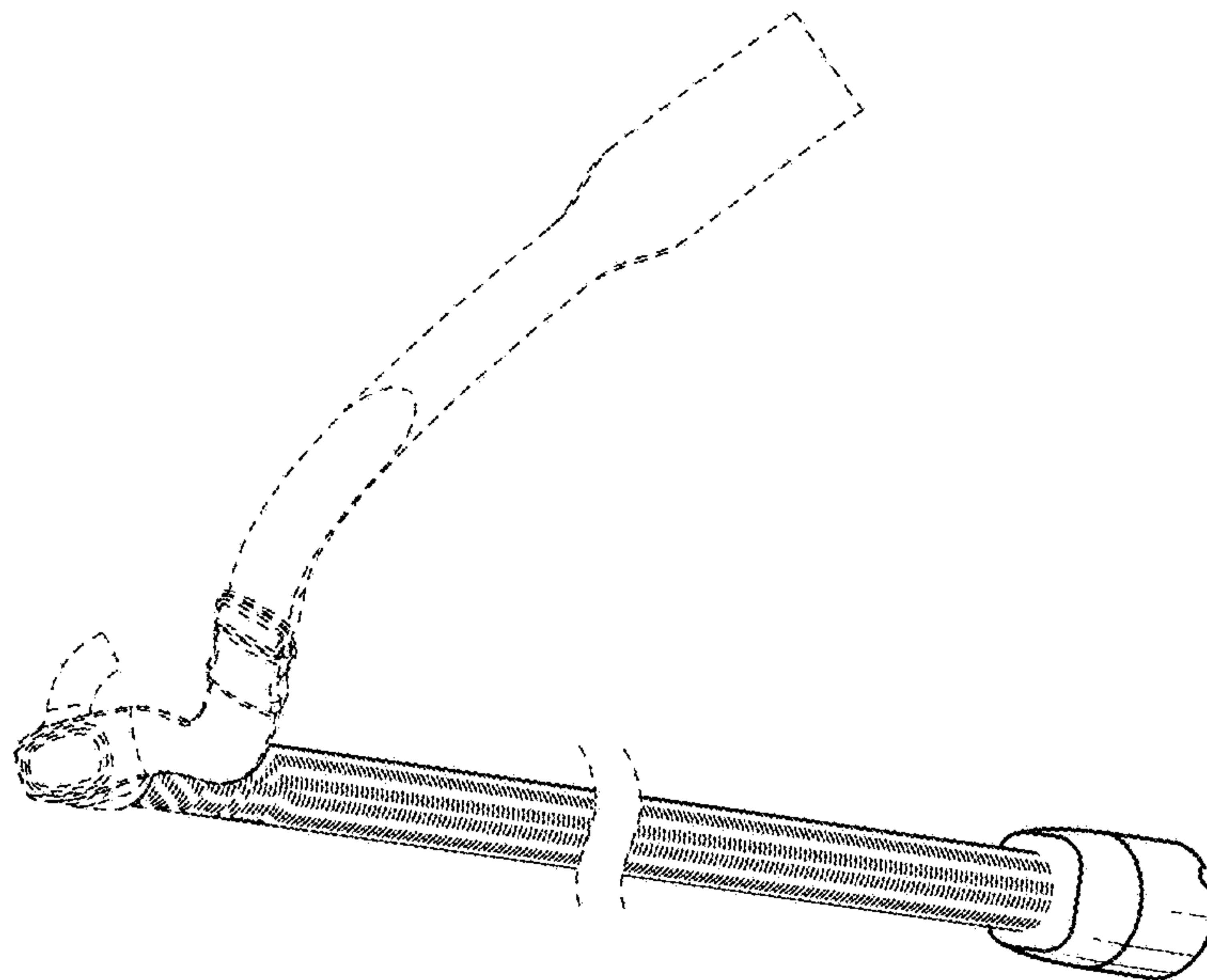

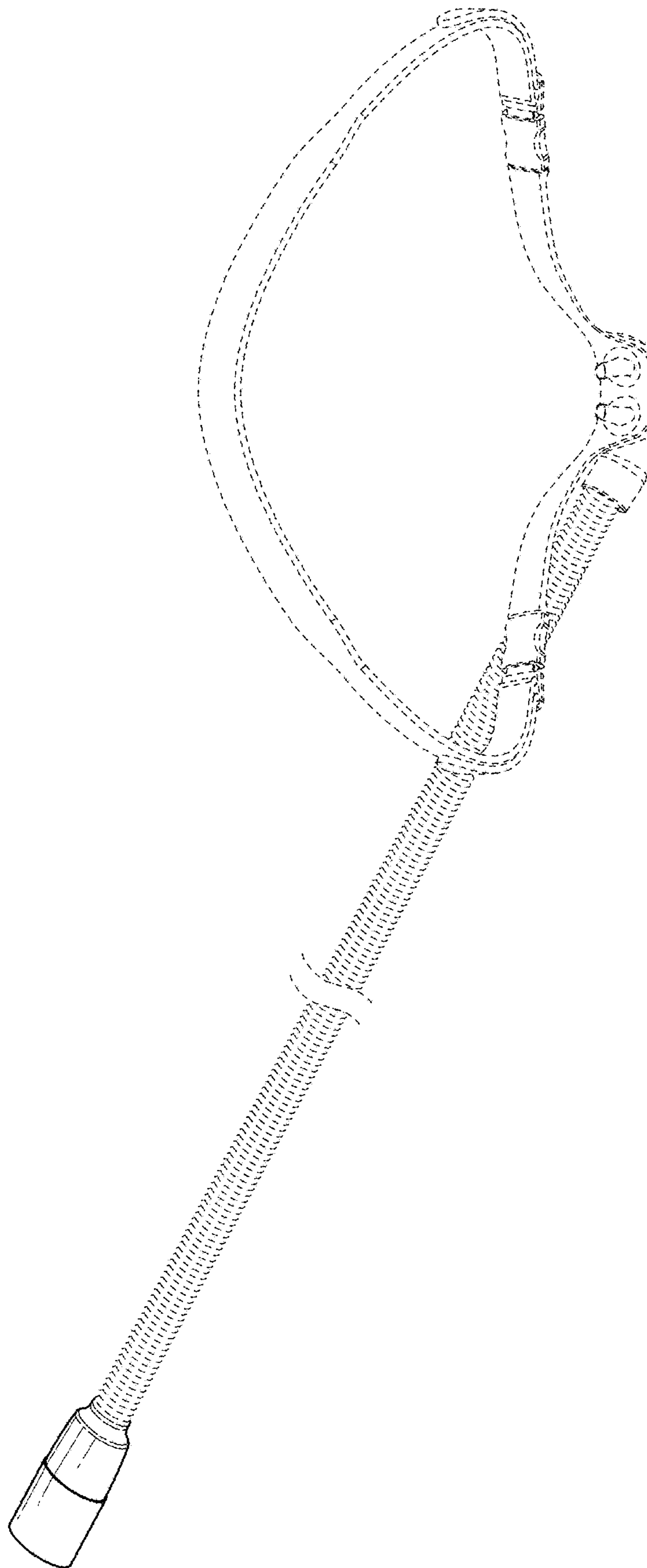

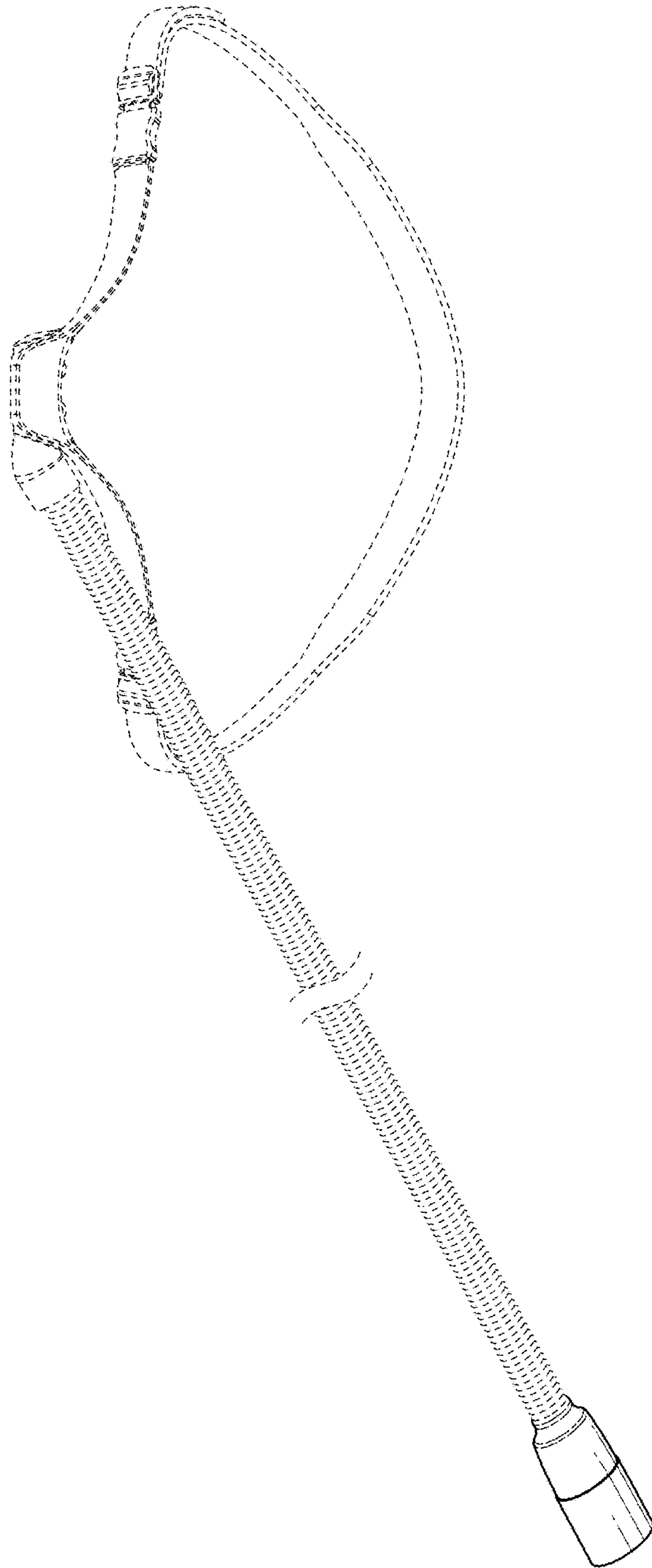
