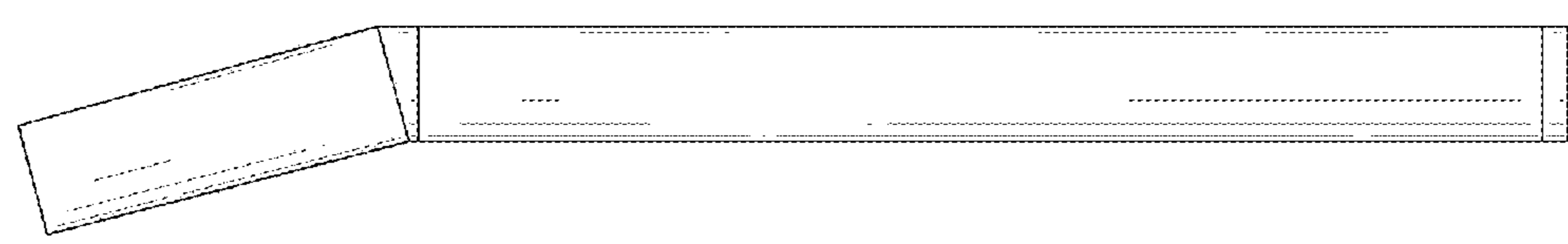
(57) **CLAIM**

The ornamental design for a device for applying eyeliner, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a cosmetic for an eyeliner showing our new design;
FIG. 2 is a back view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plain view thereof; and,
FIG. 7 is a front view without a cap.

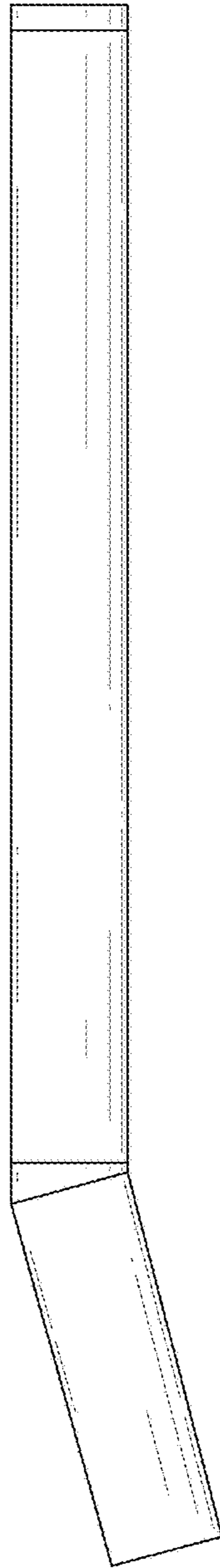

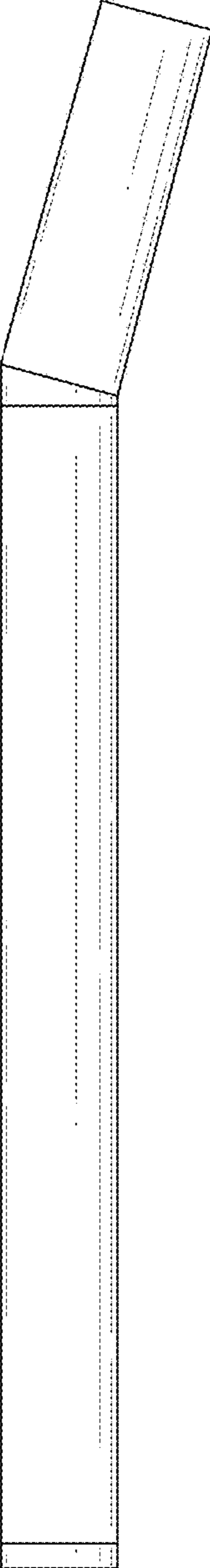

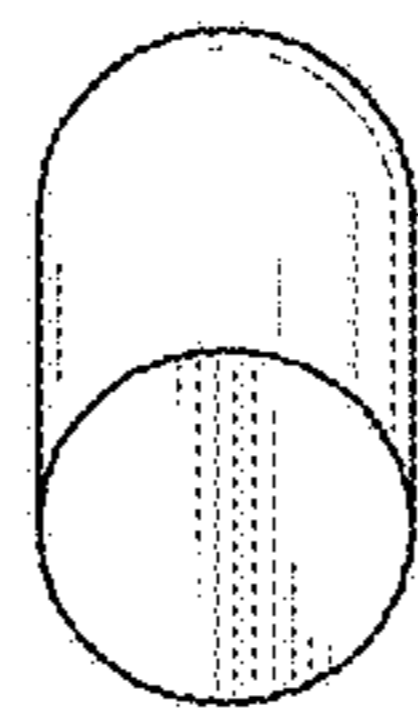

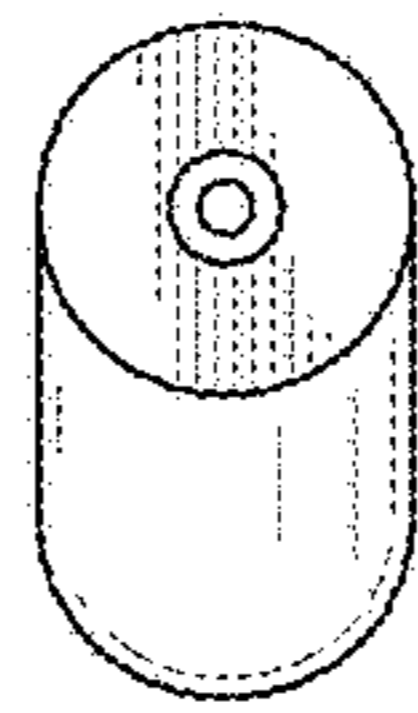

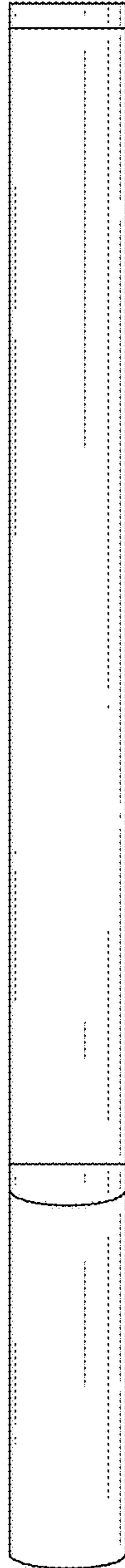

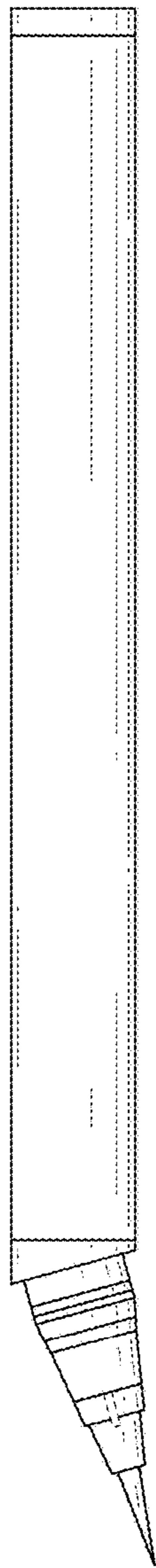
