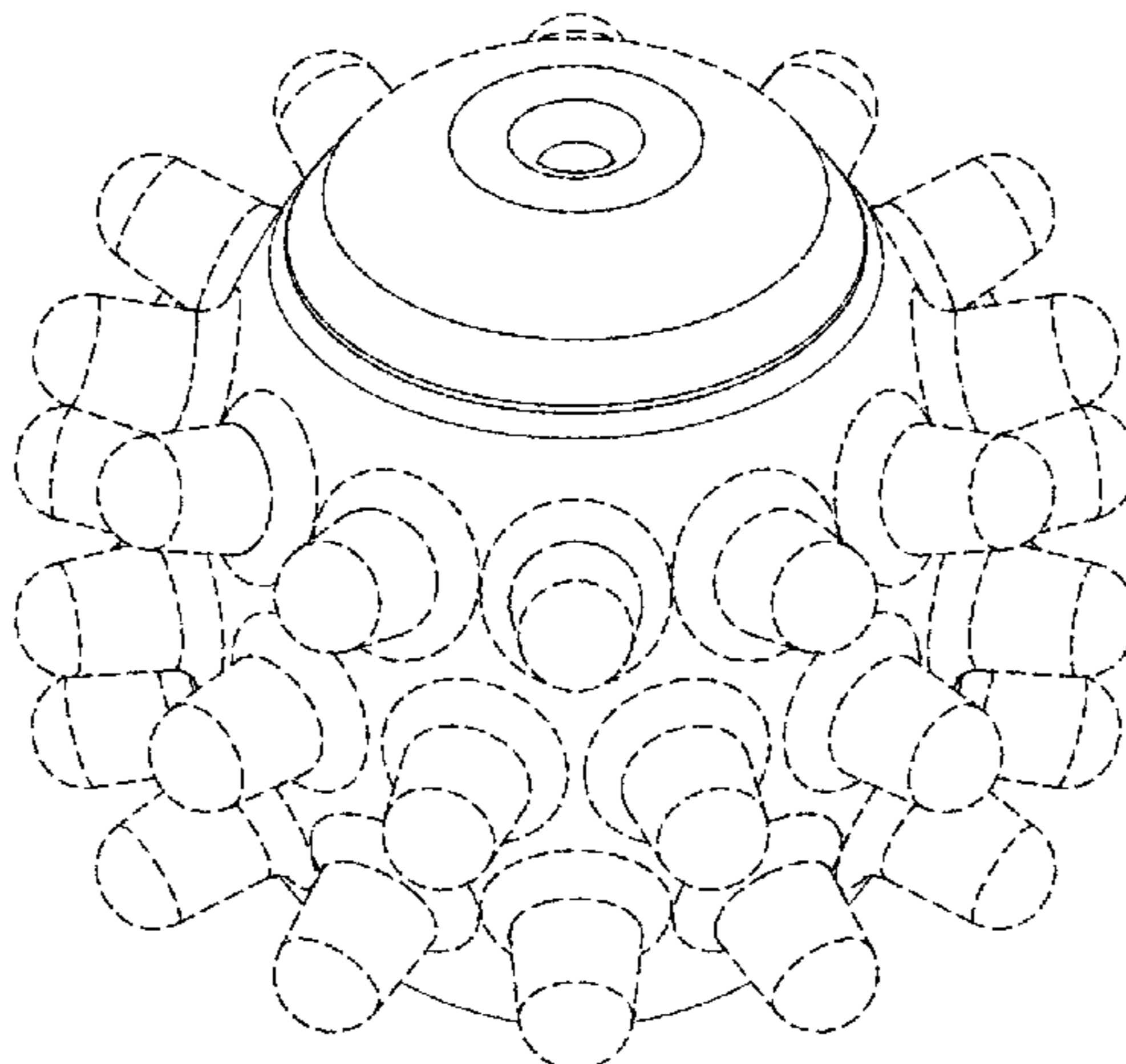
(57) **CLAIM**

The ornamental design for a pet toy, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a pet toy showing the new design;
FIG. 2 is a bottom perspective view of the pet toy of FIG. 1;
FIG. 3 is a front elevational view of the pet toy of FIG. 1;
FIG. 4 is a right side elevational view of the pet toy of FIG. 1;
FIG. 5 is a top plan view of the pet toy of FIG. 1; and,
FIG. 6 is a bottom plan view of the pet toy of FIG. 1.
The broken lines shown in the drawings depict portions of the pet toy that form no part of the claimed design.

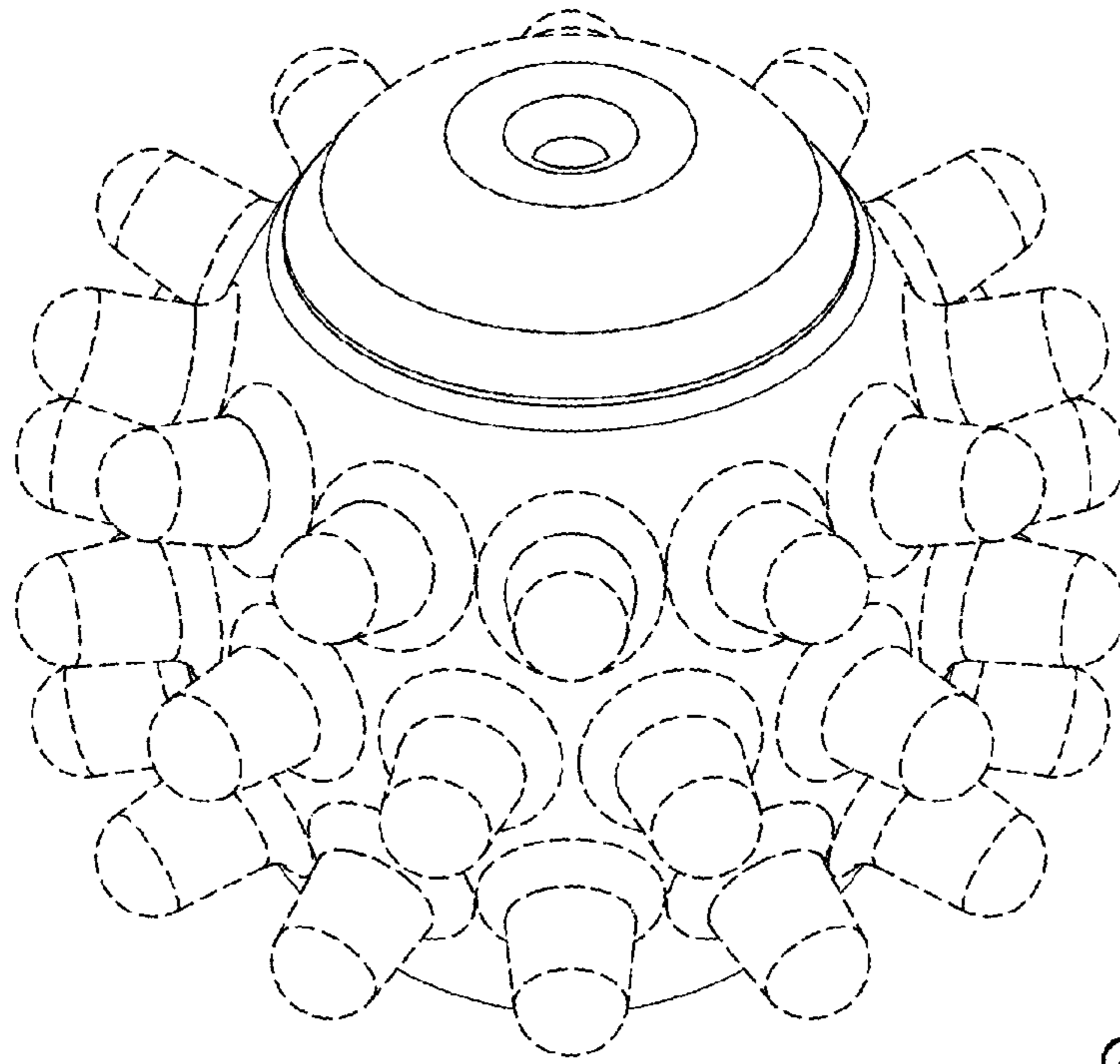

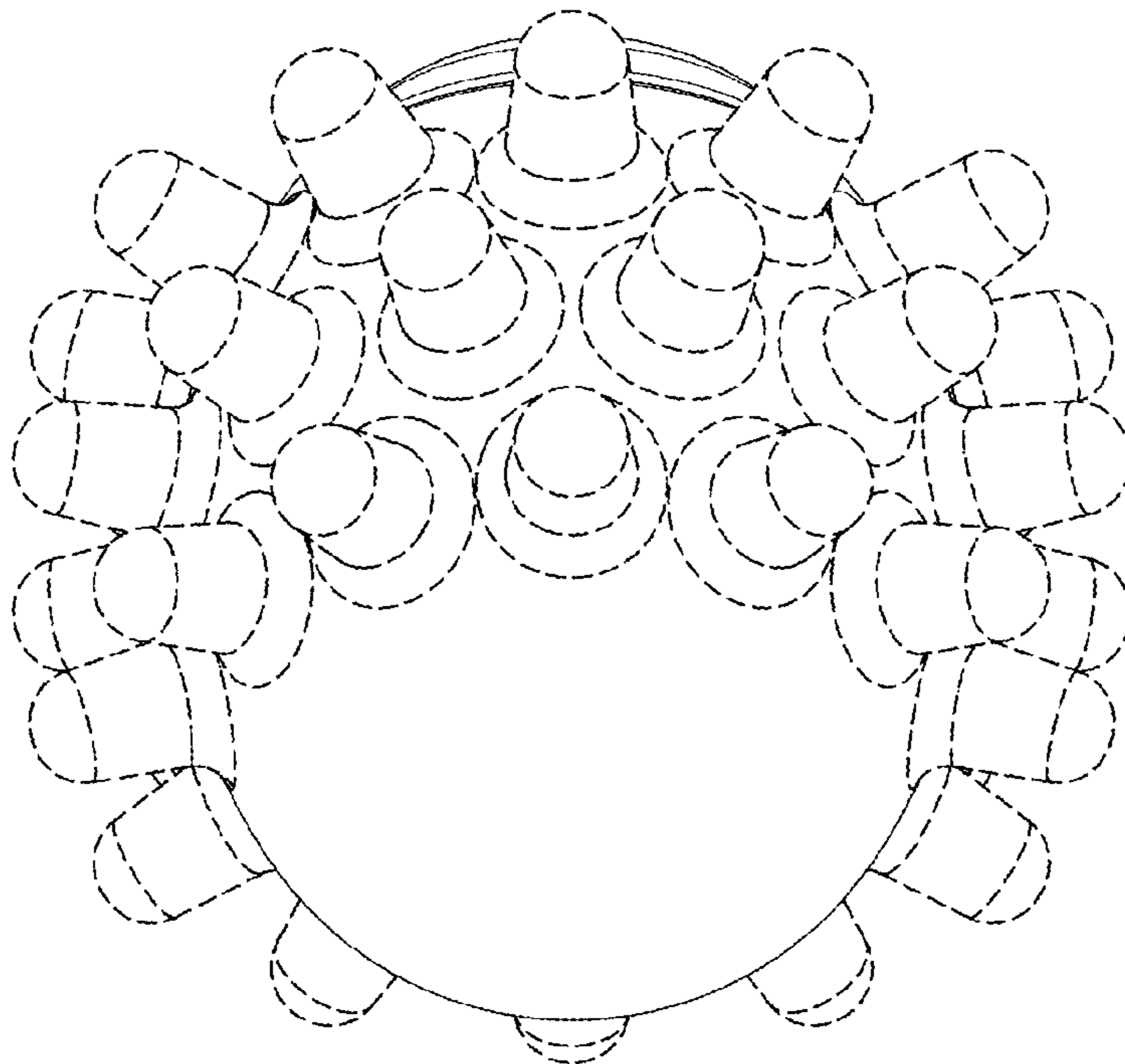

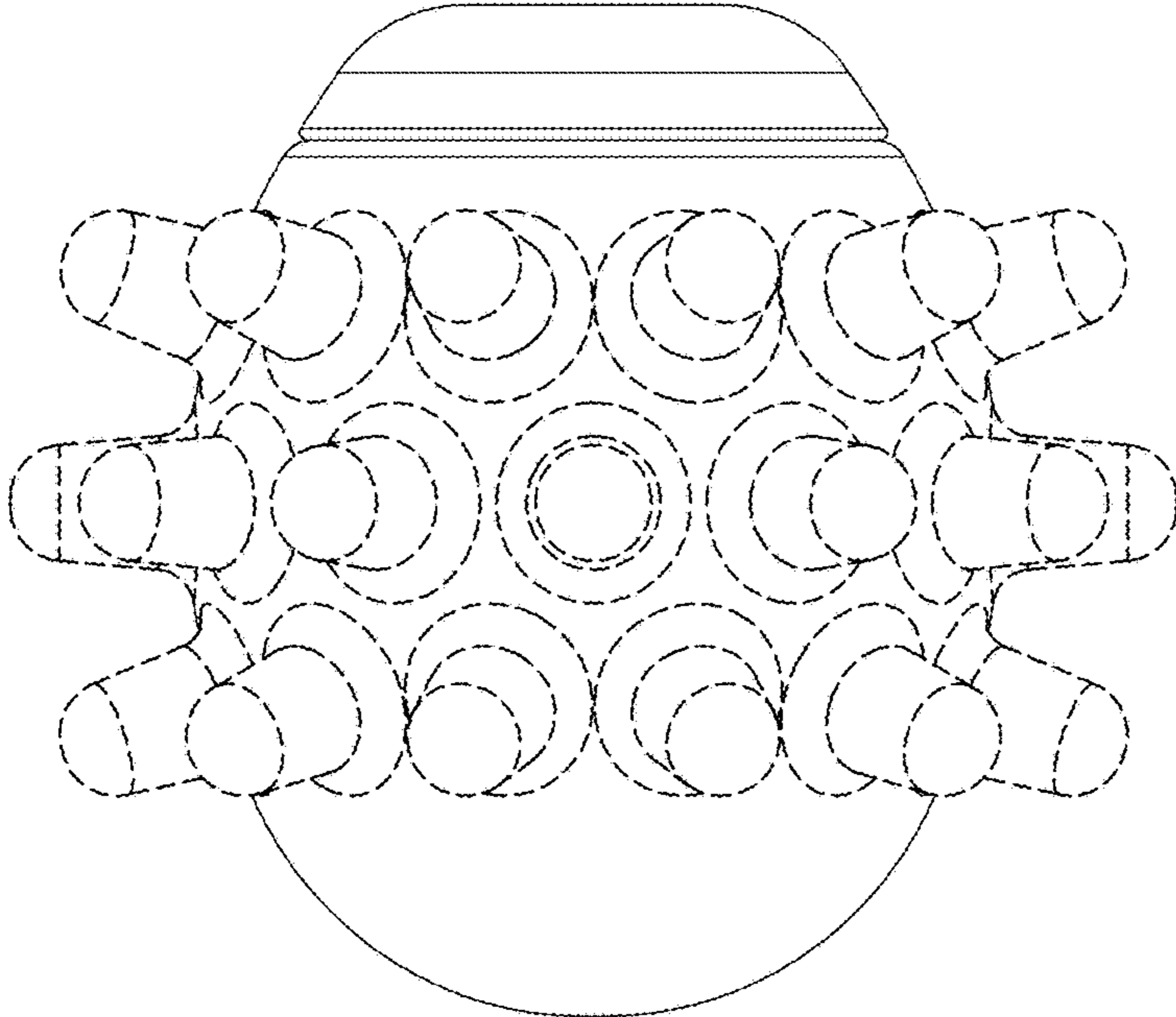

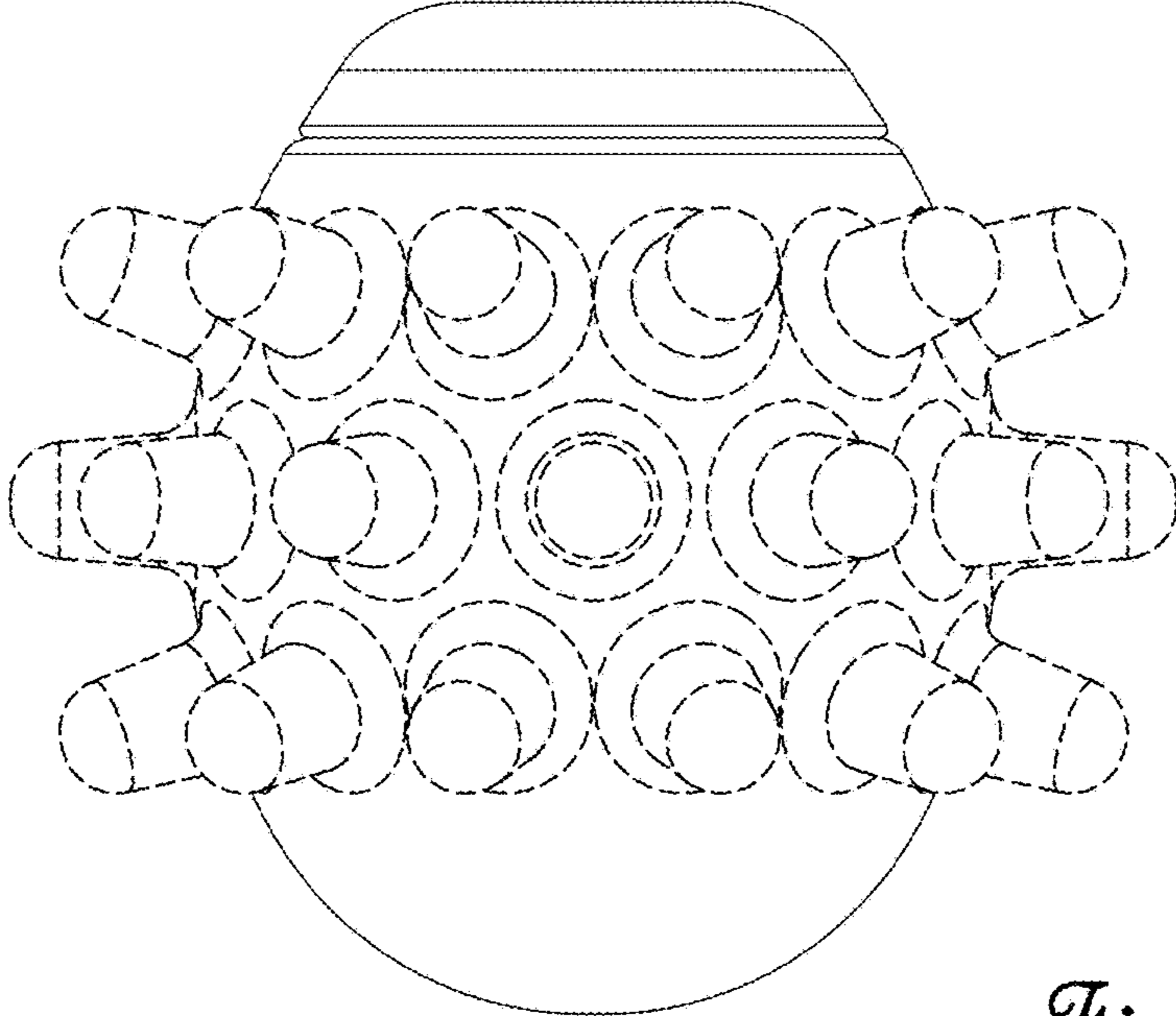

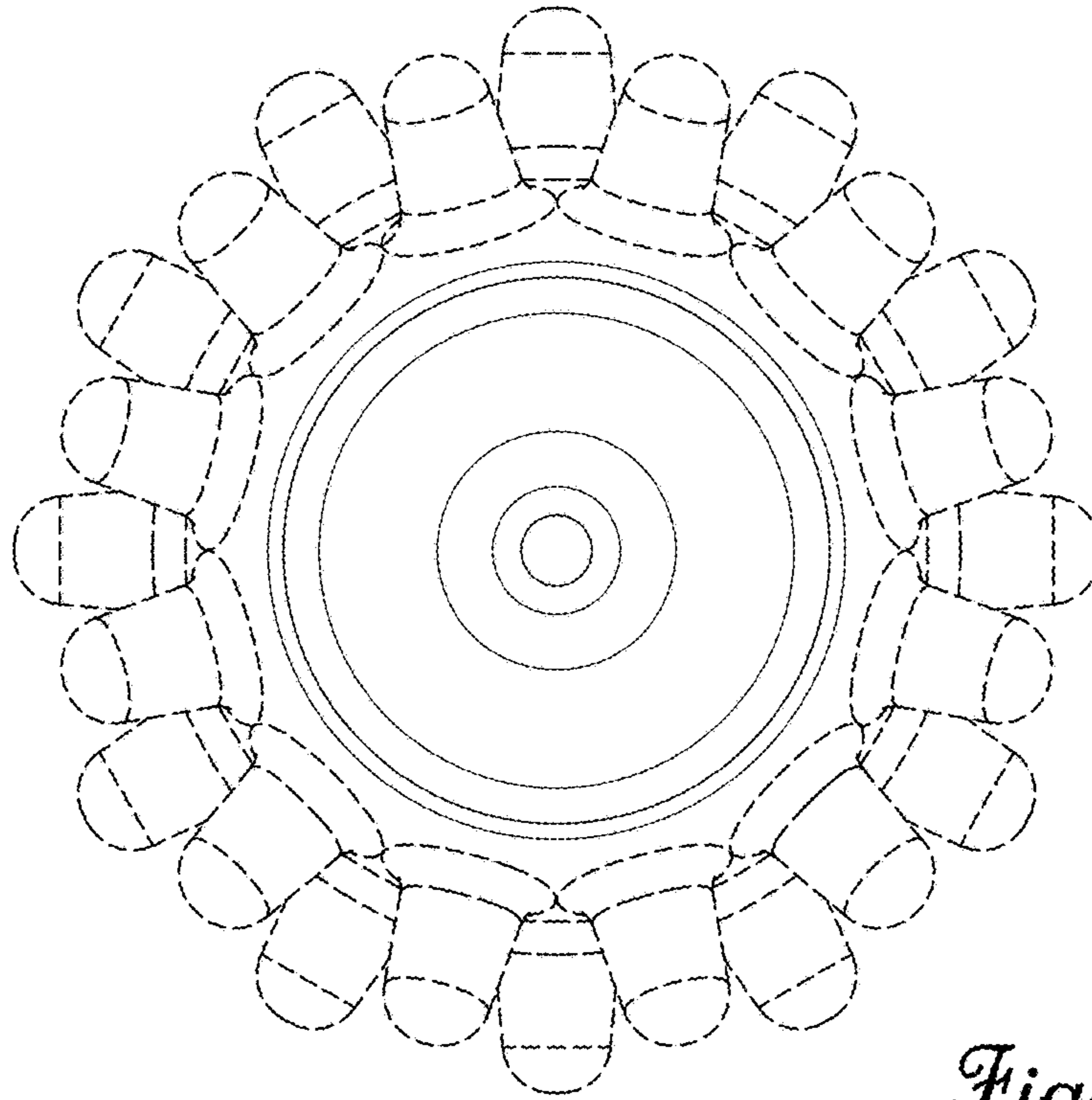

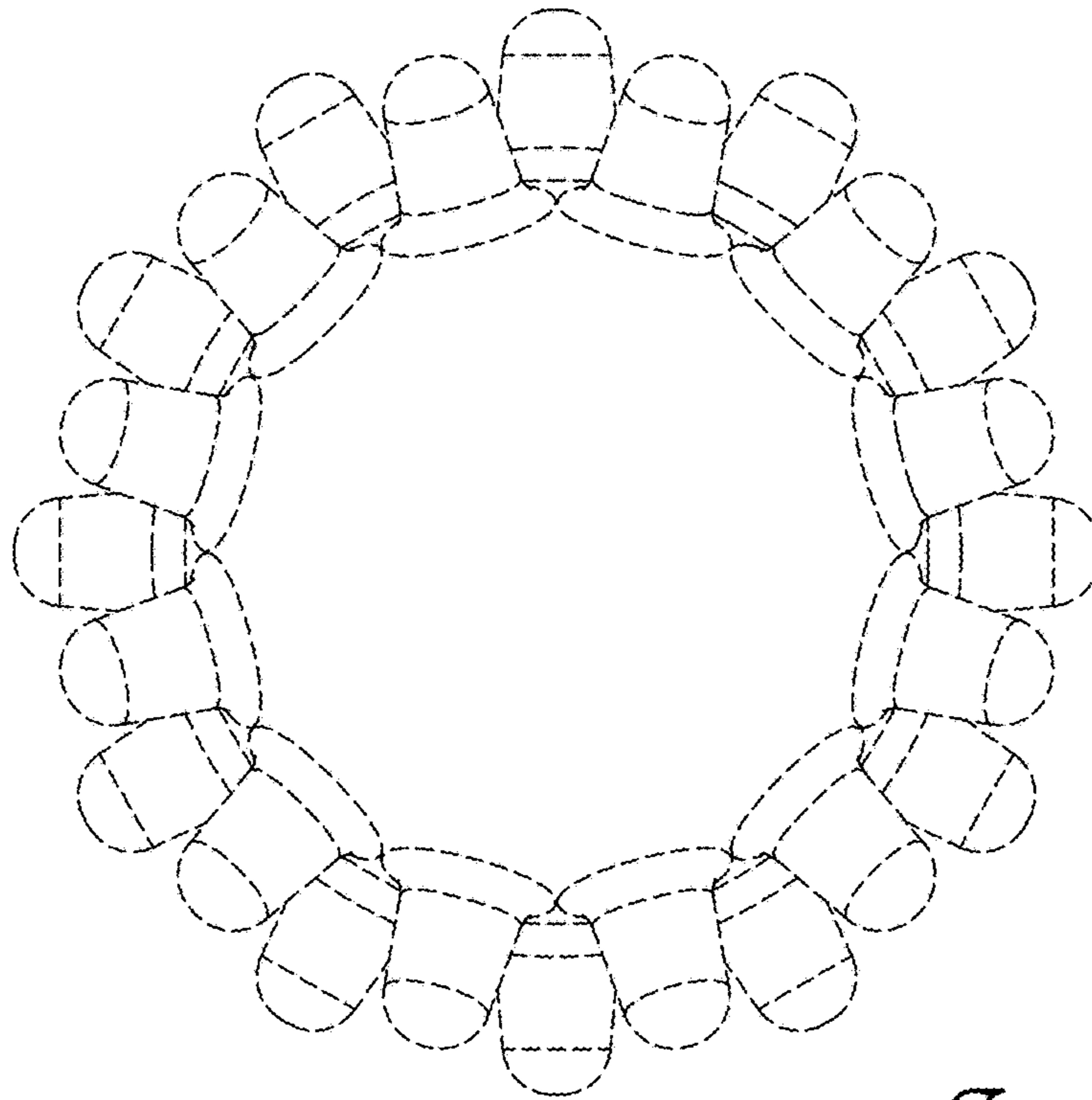
