FIG. 3 is a rear view of the design of FIG. 1;

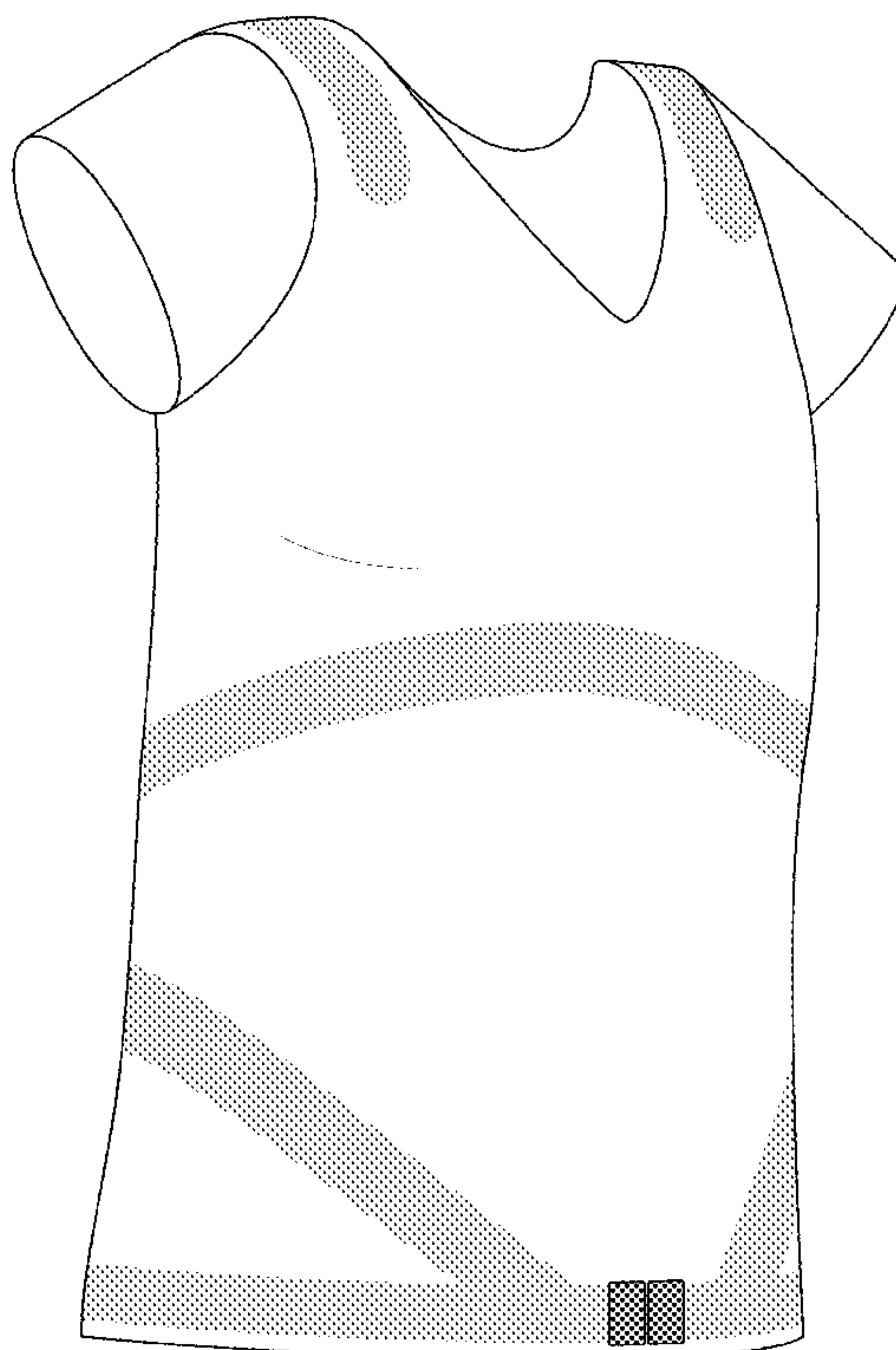
FIG. 4 is a rear isomeric view of the design of FIG. 1;

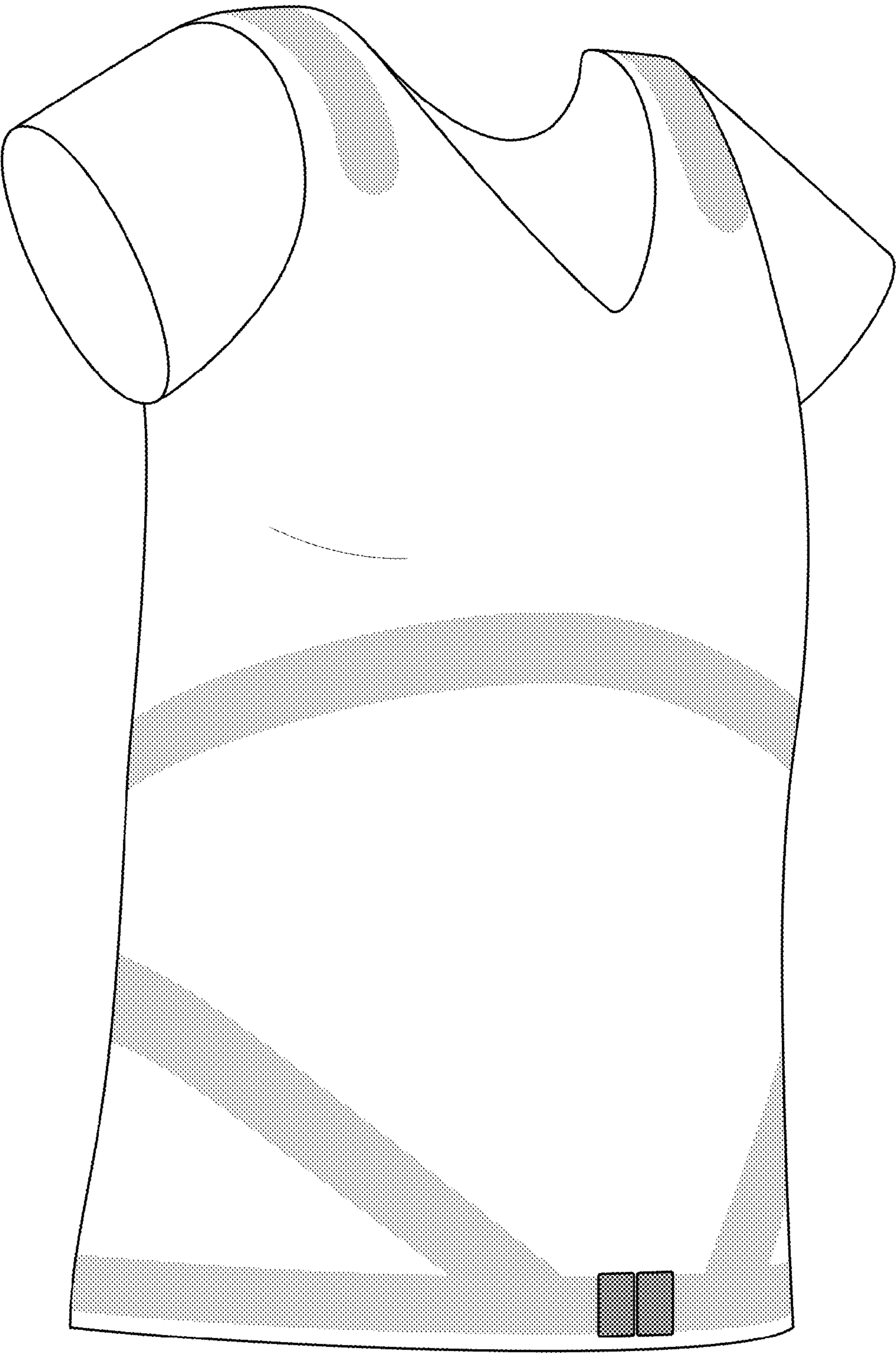

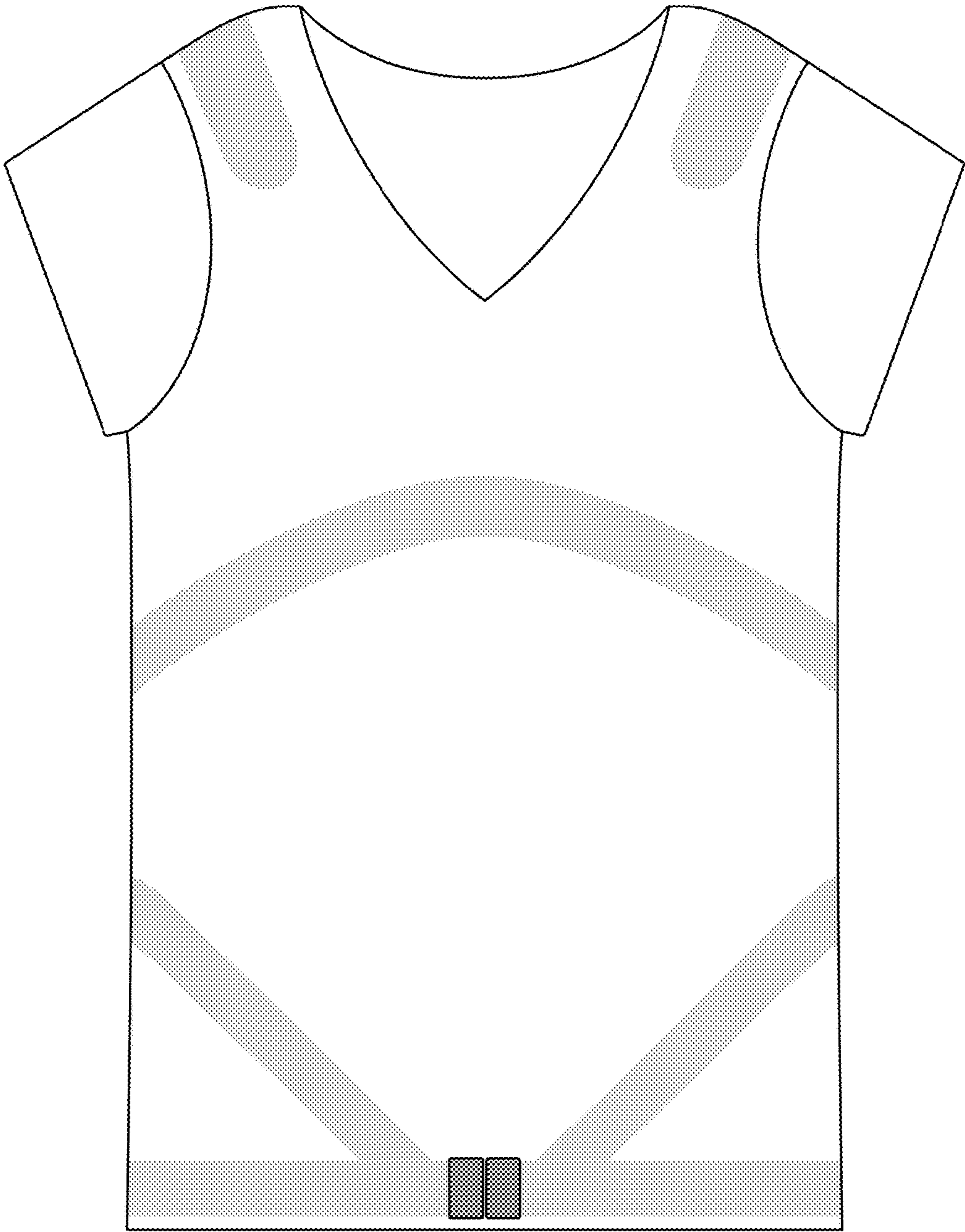

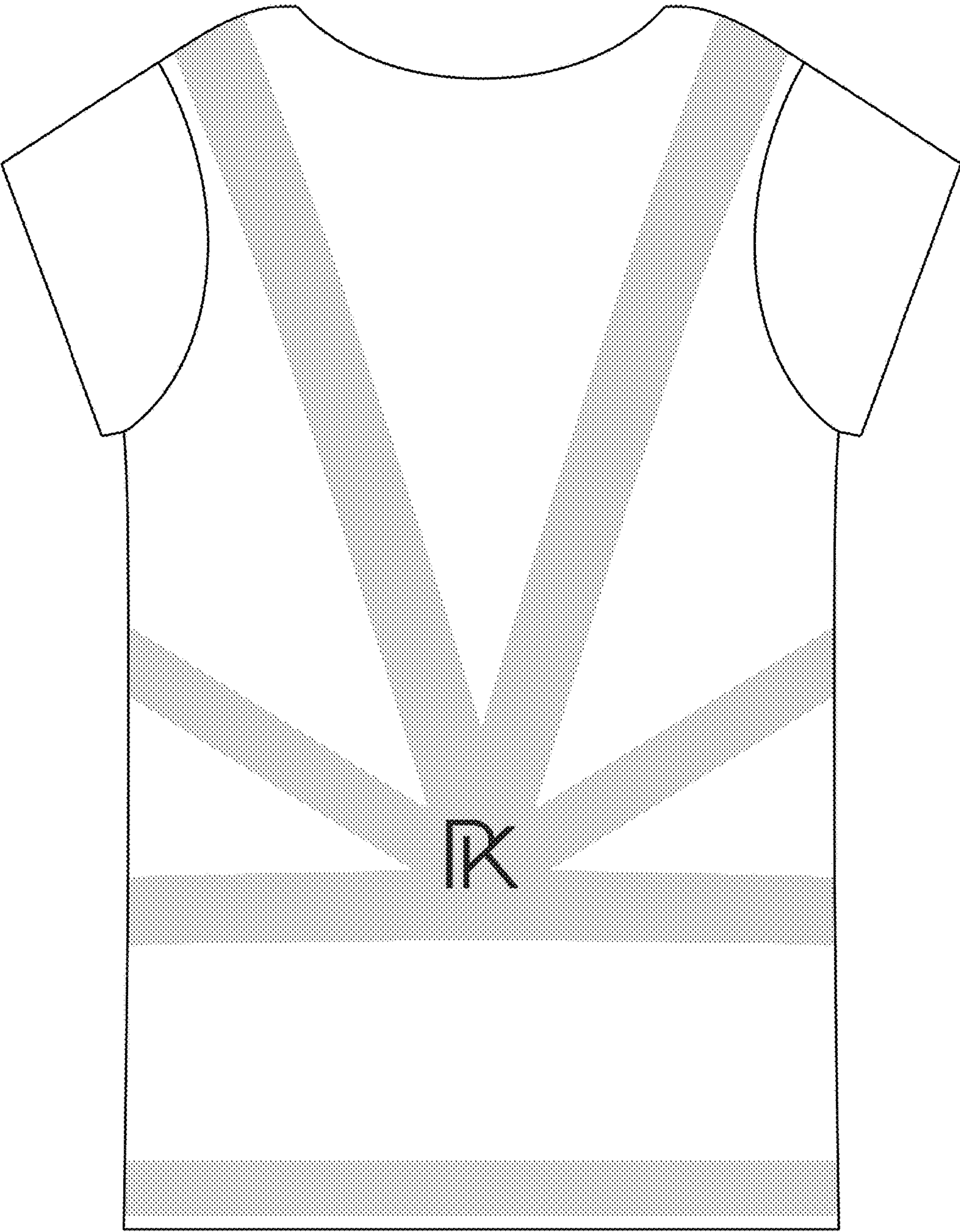

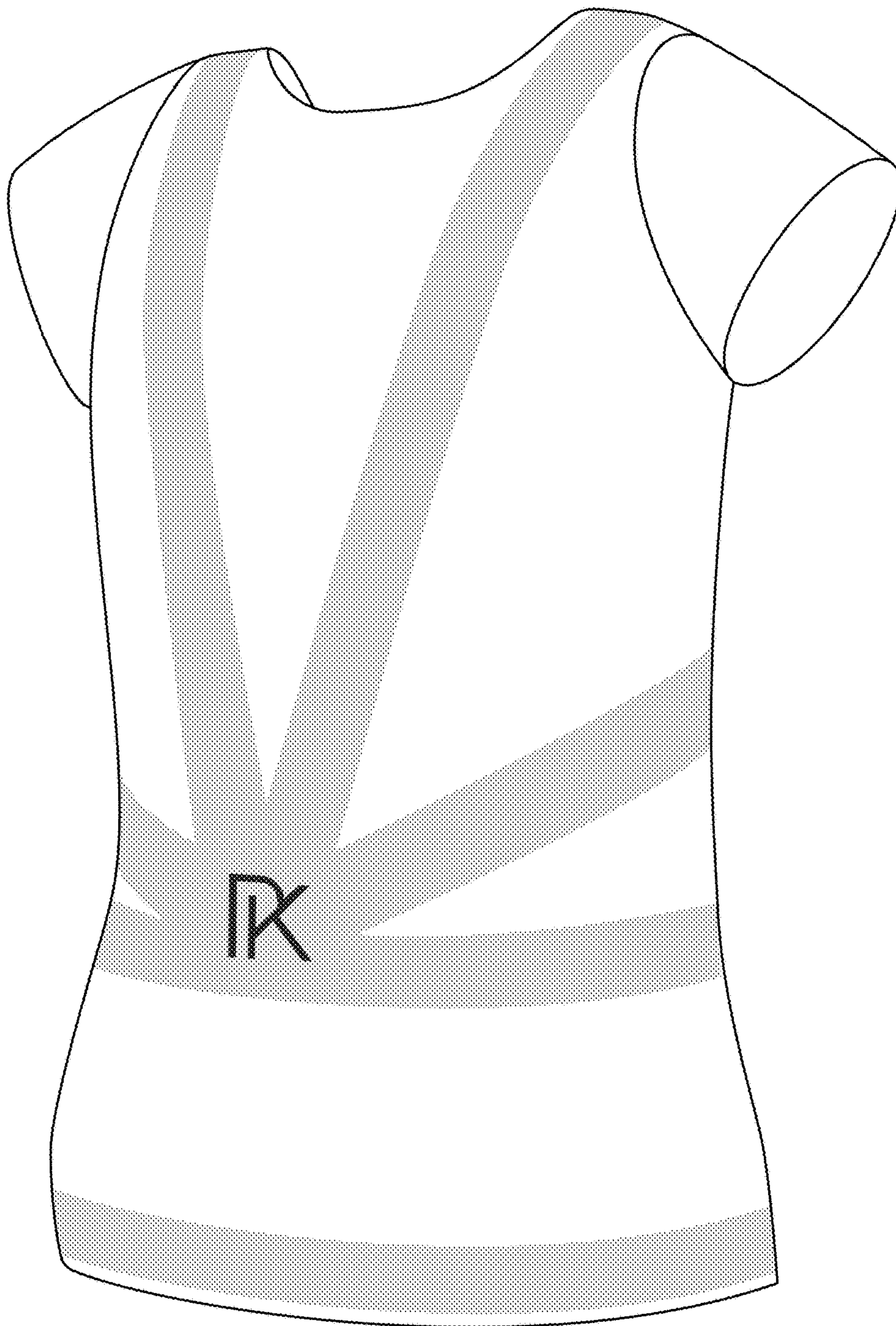

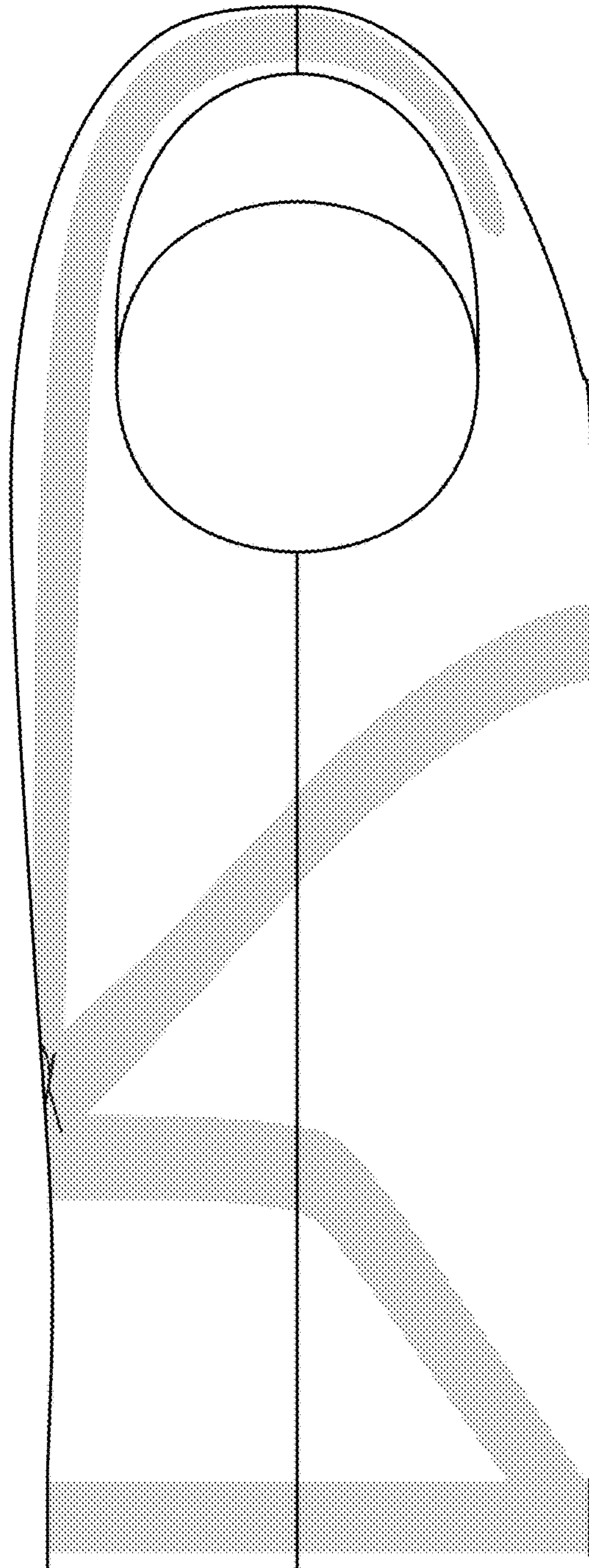

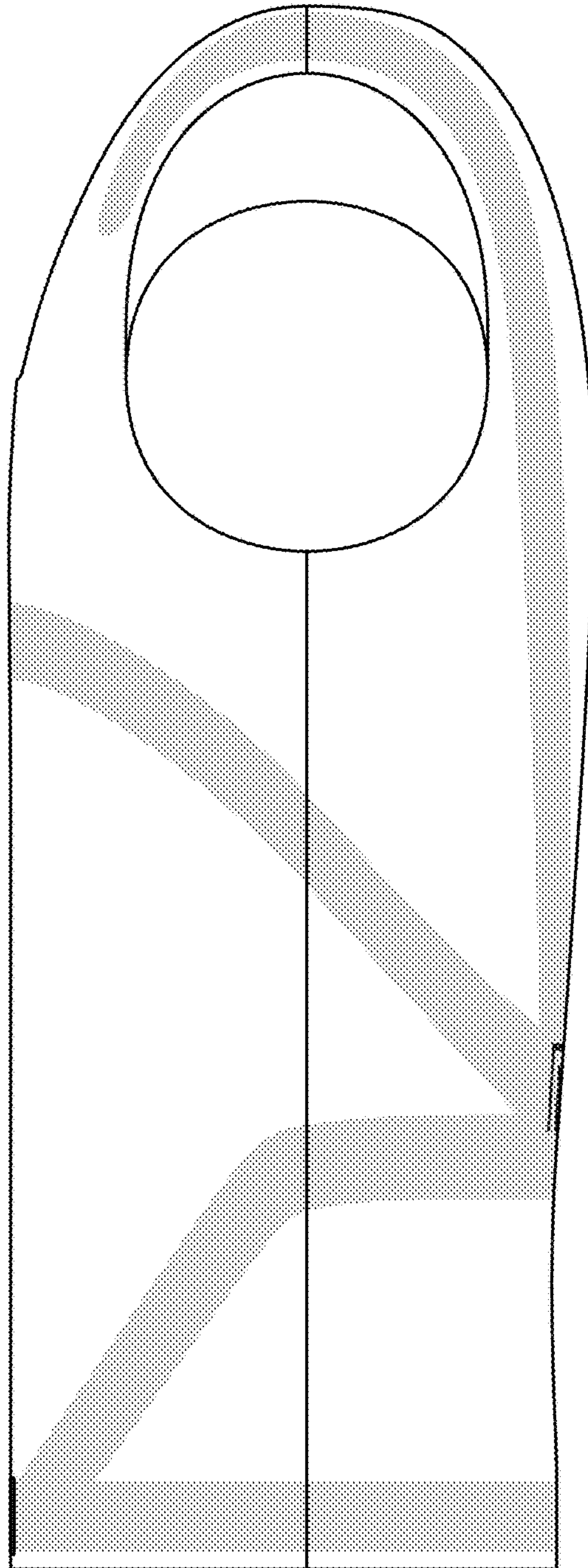

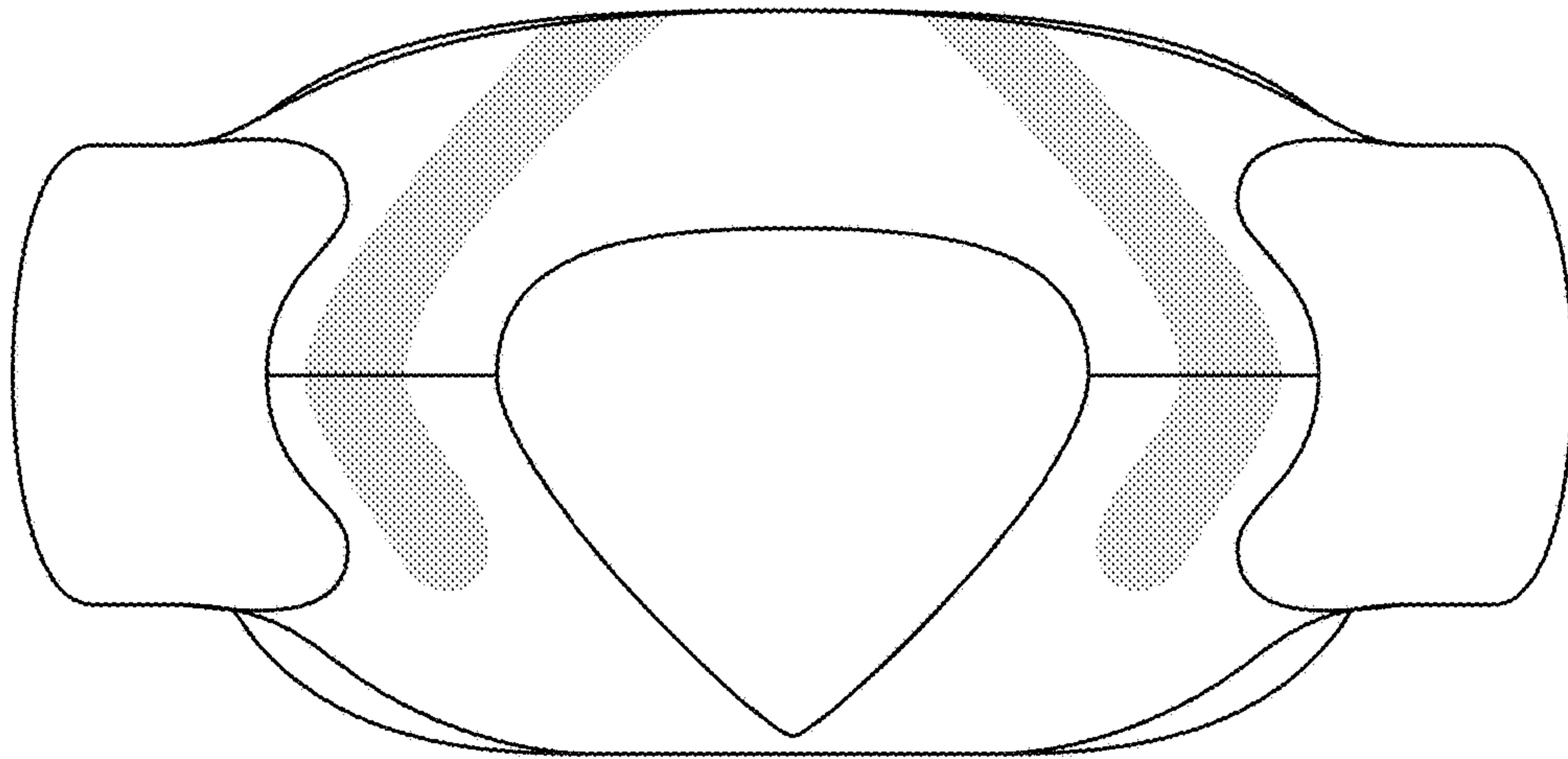
