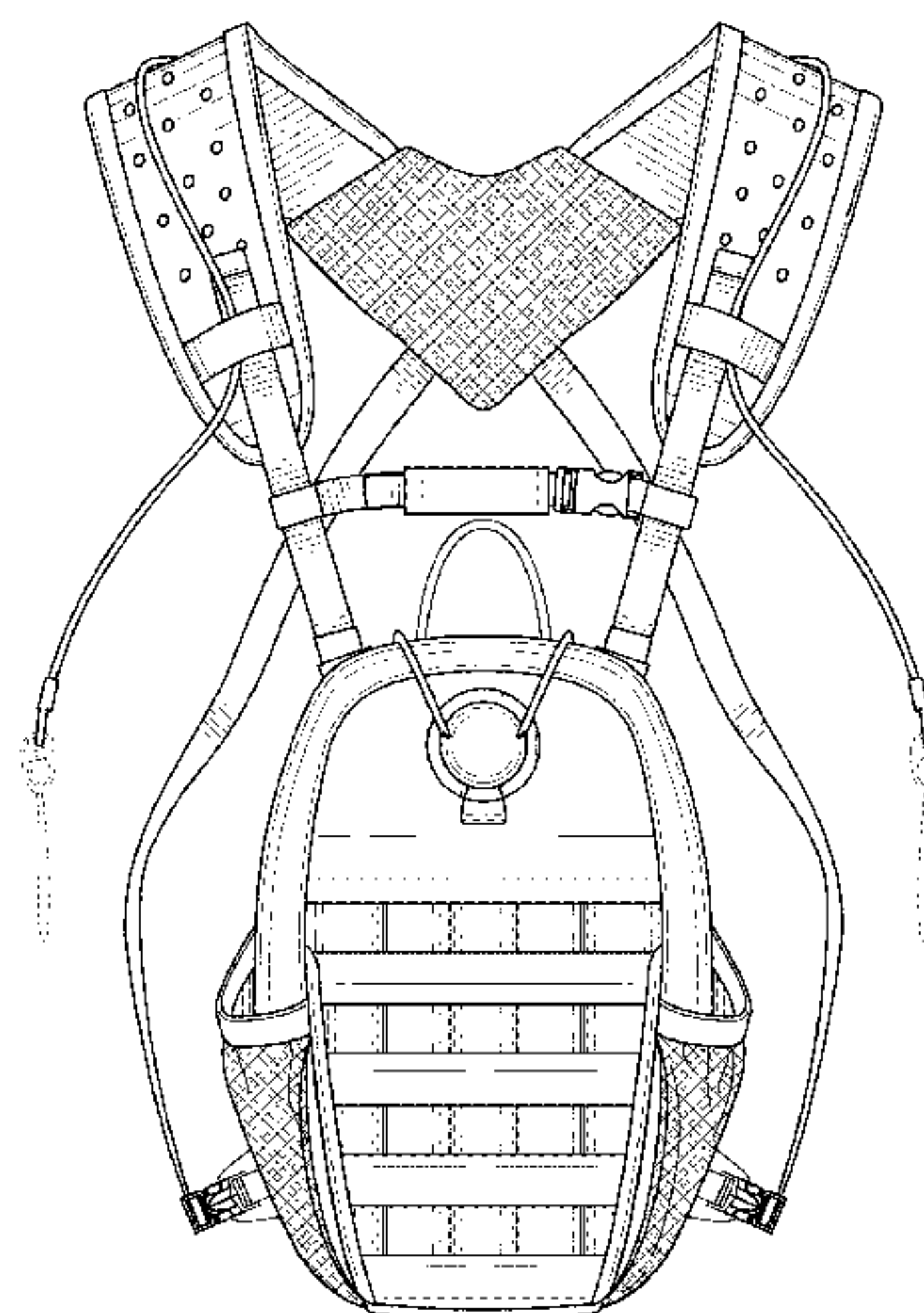
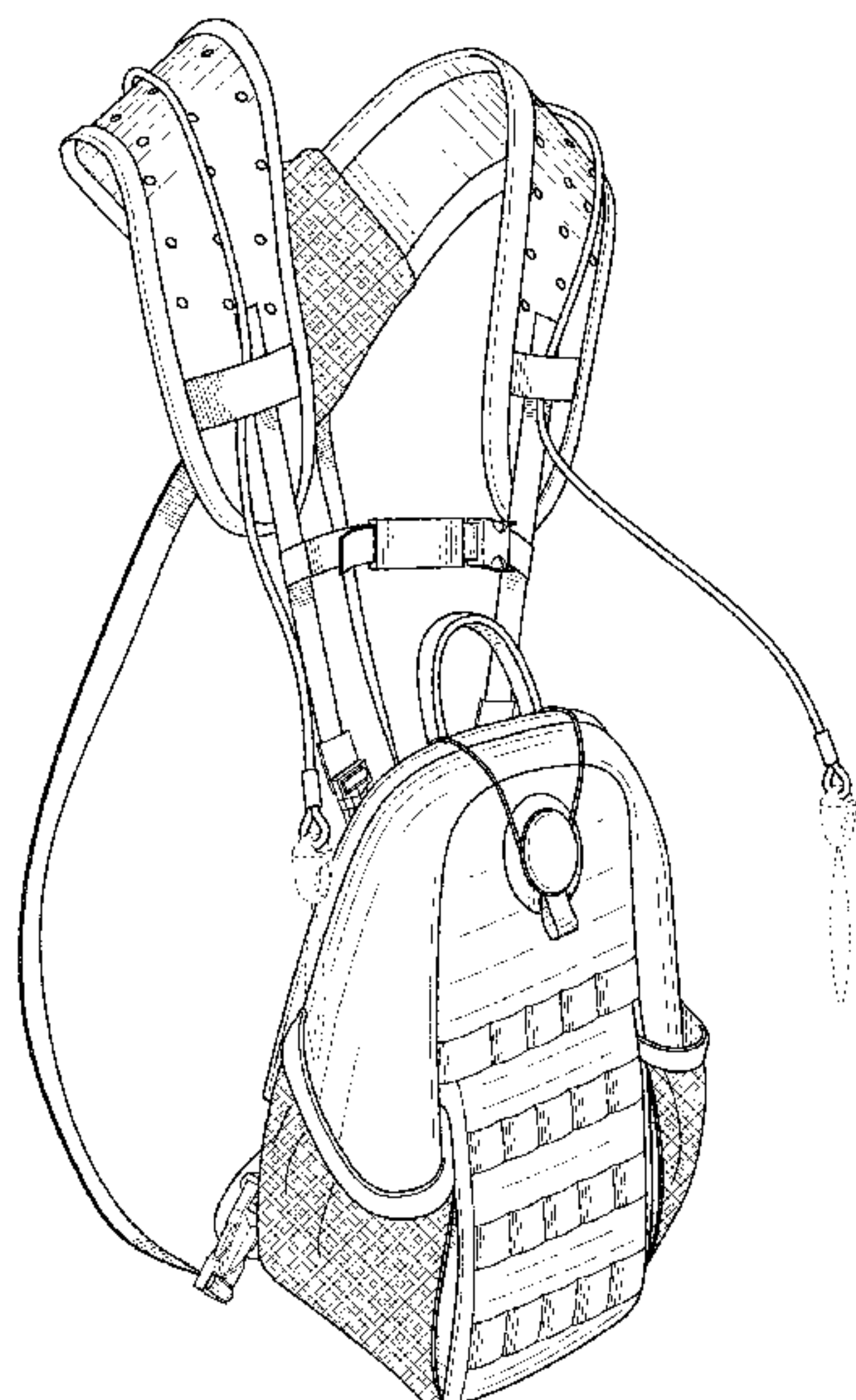
(57) **CLAIM**

The ornamental design for a binocular case, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, left-side perspective view of the binocular case;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a right-side elevational view thereof;  
FIG. 5 is a left-side elevational view thereof;  
FIG. 6 is a rear elevational view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is a front, top, left-side perspective view thereof in an open state; and,  
FIG. 9 is a rear elevational view thereof in a state of being worn with an auxiliary pouch deployed.  
The broken lines depict either unclaimed parts of the binocular case or environmental subject matter, and thus form no part of the claimed design.

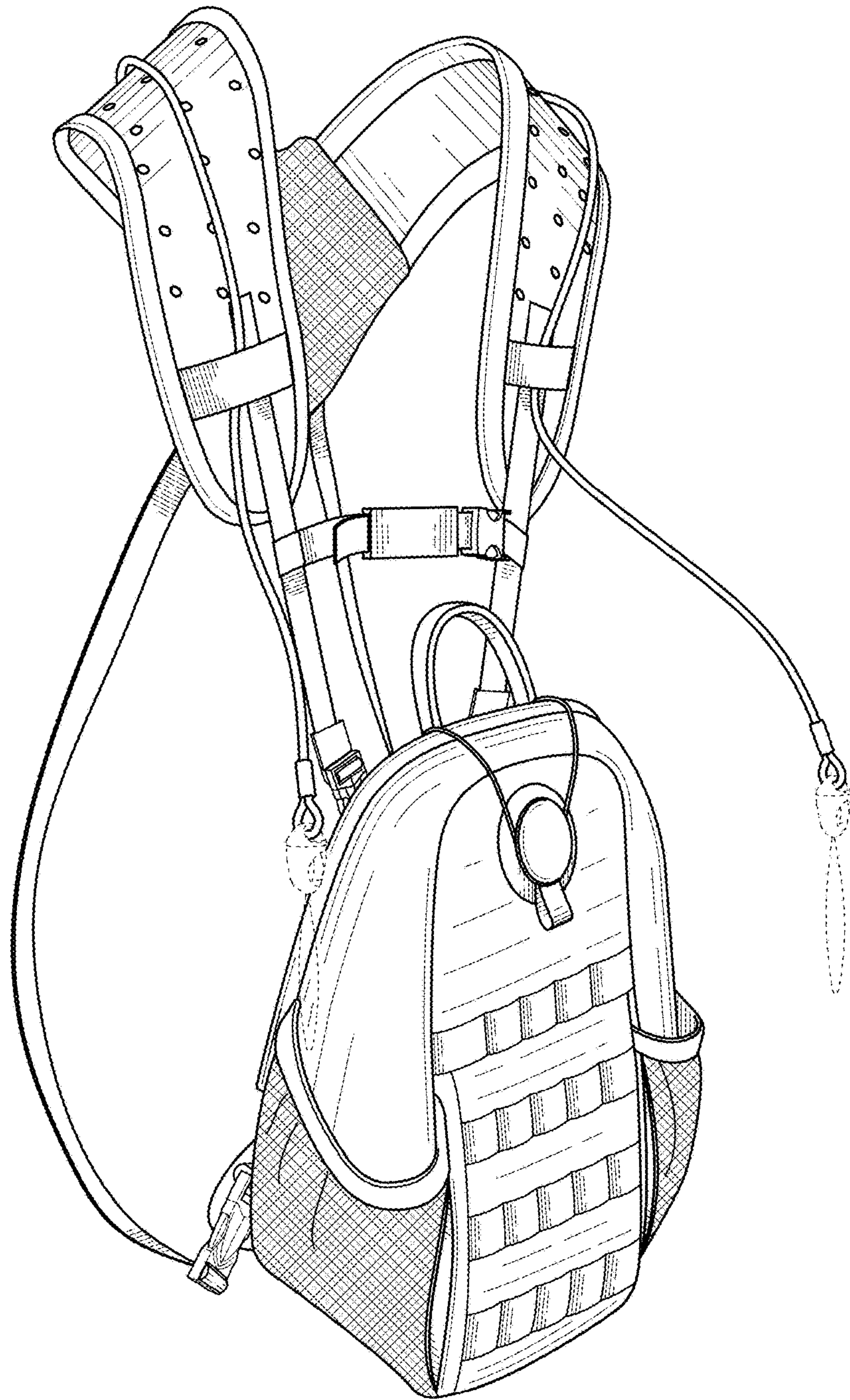

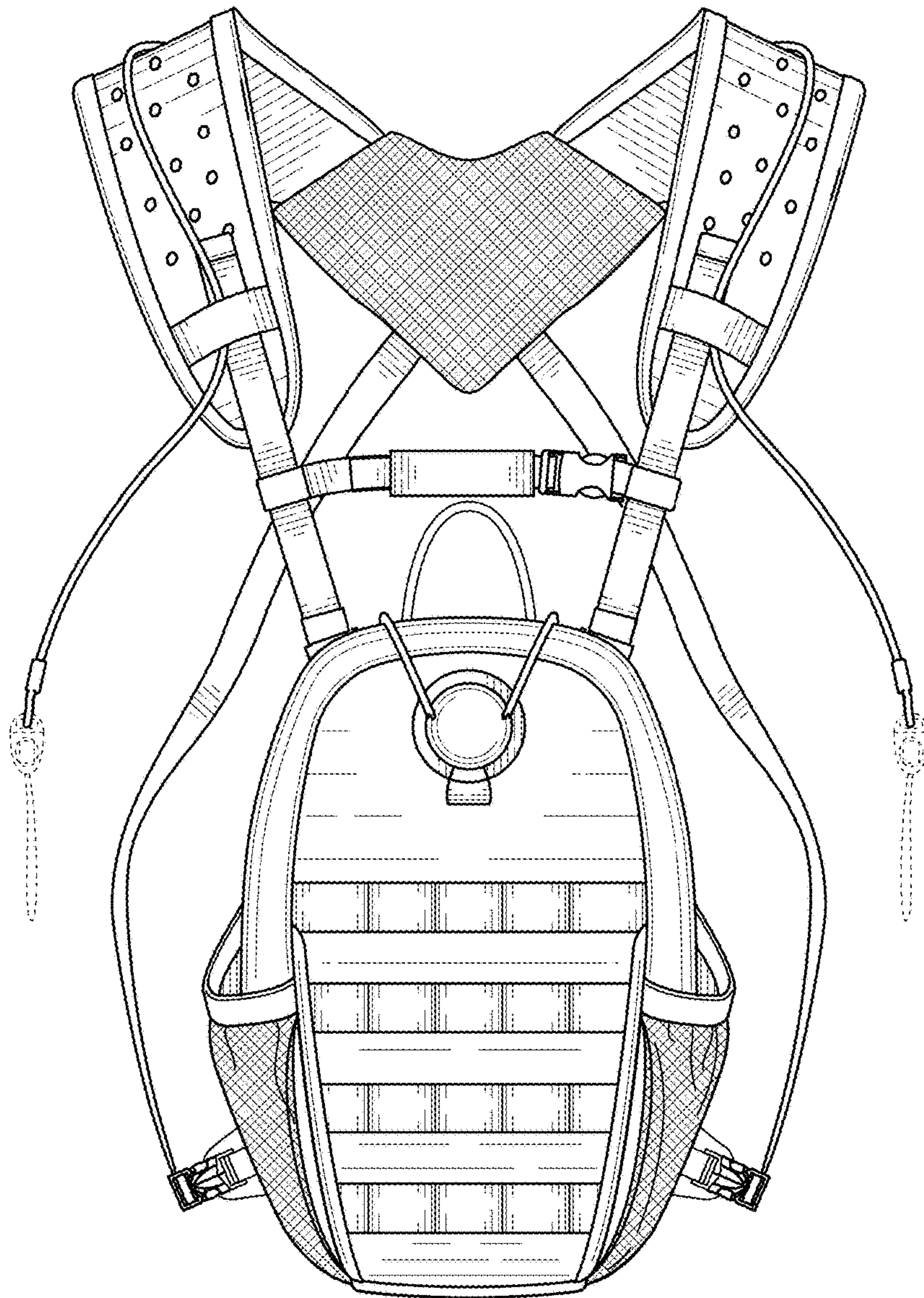

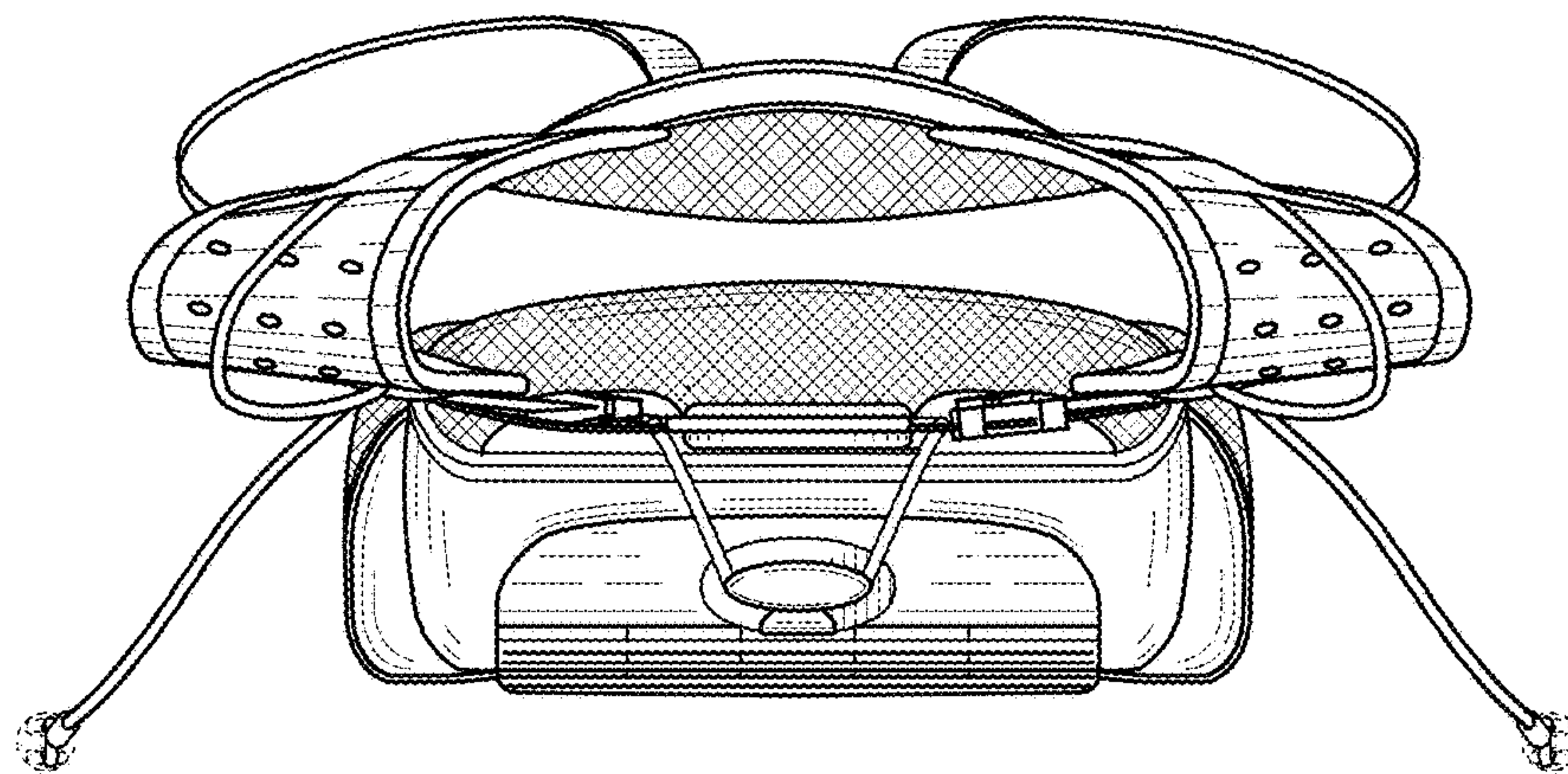

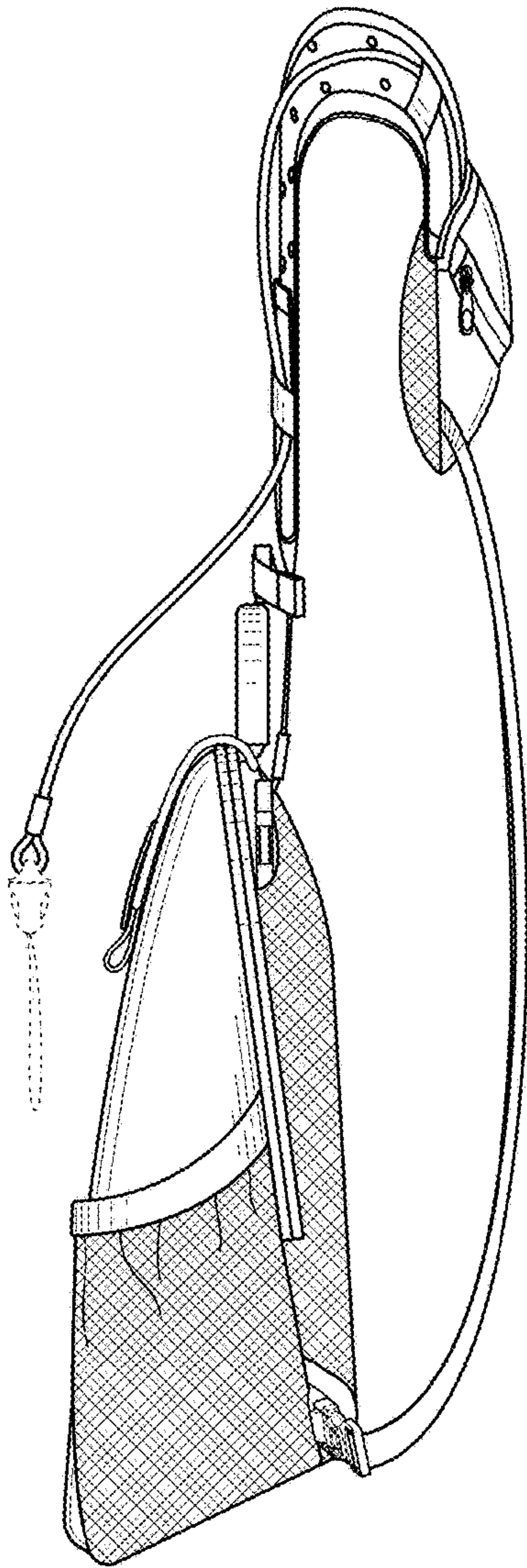

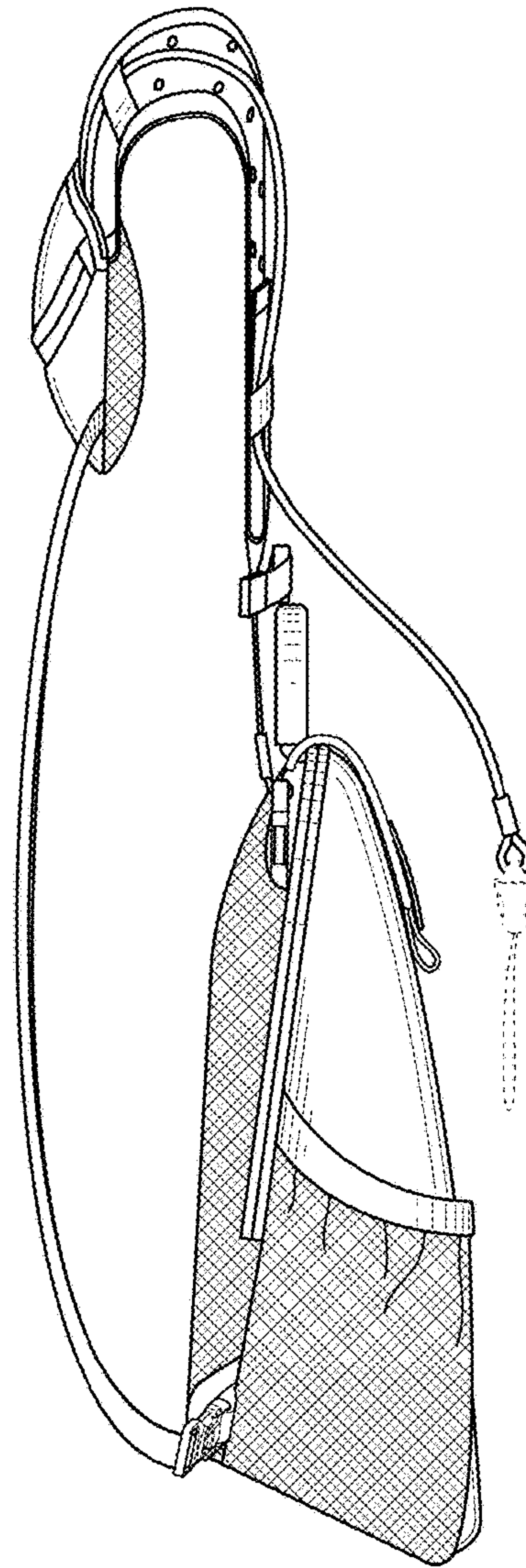

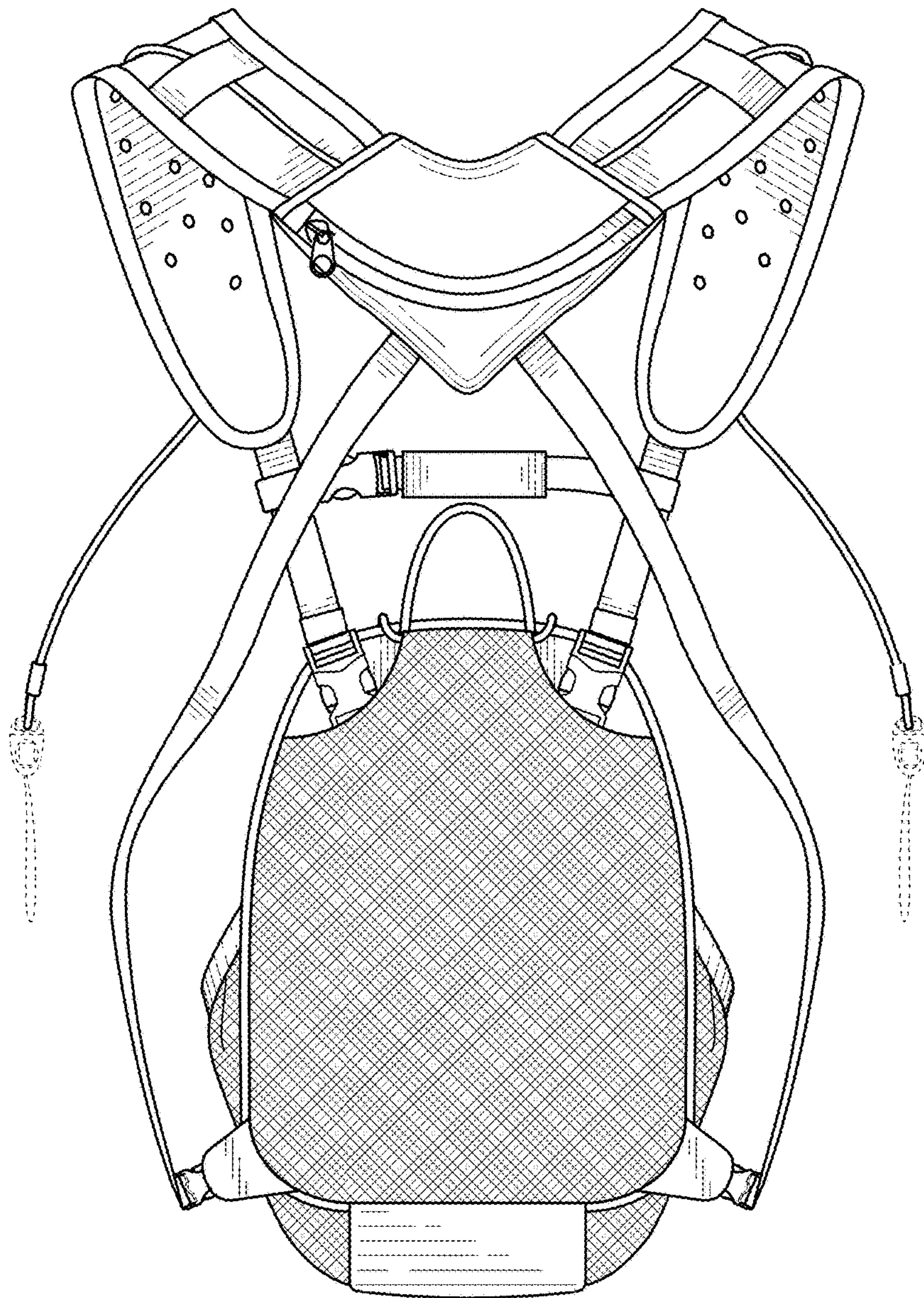

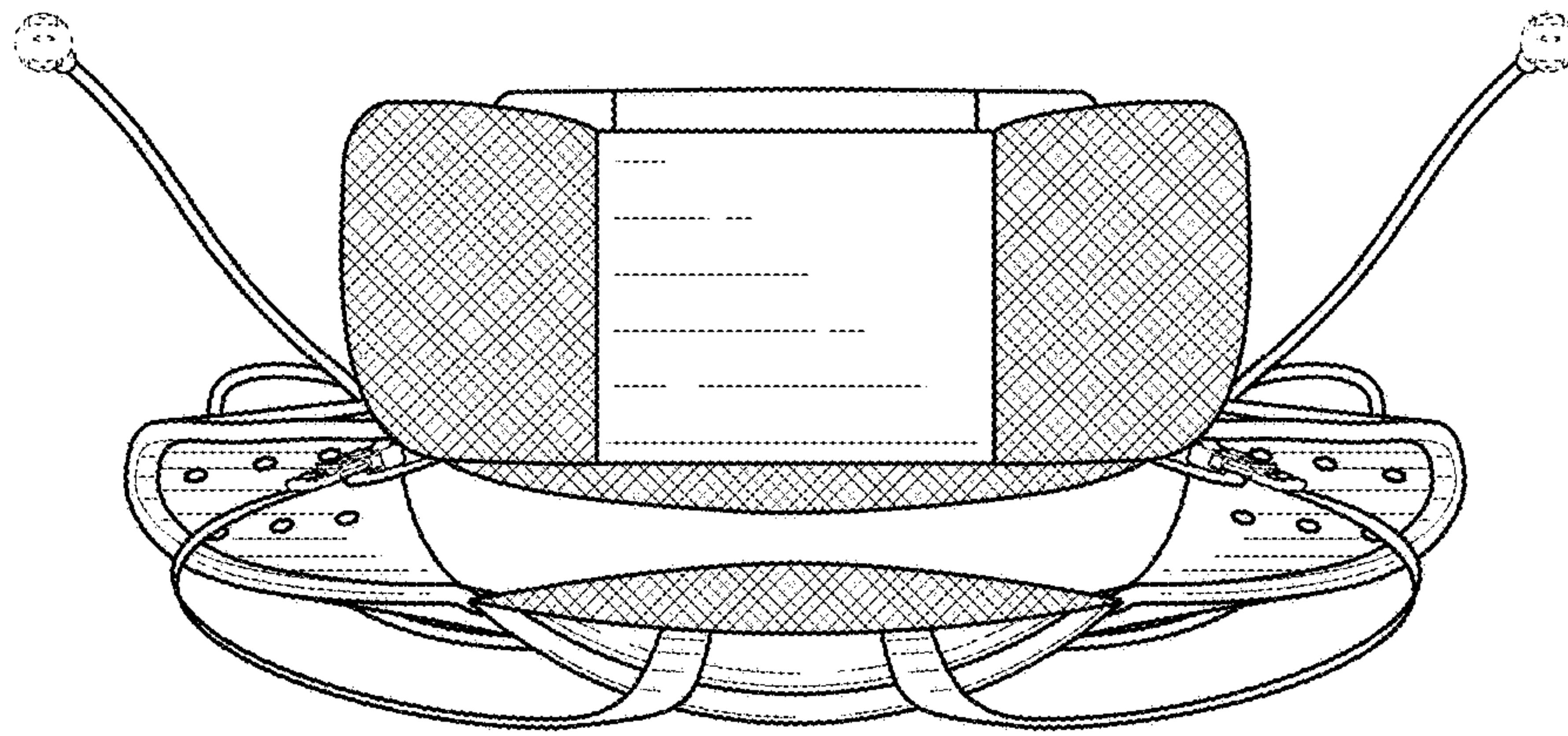

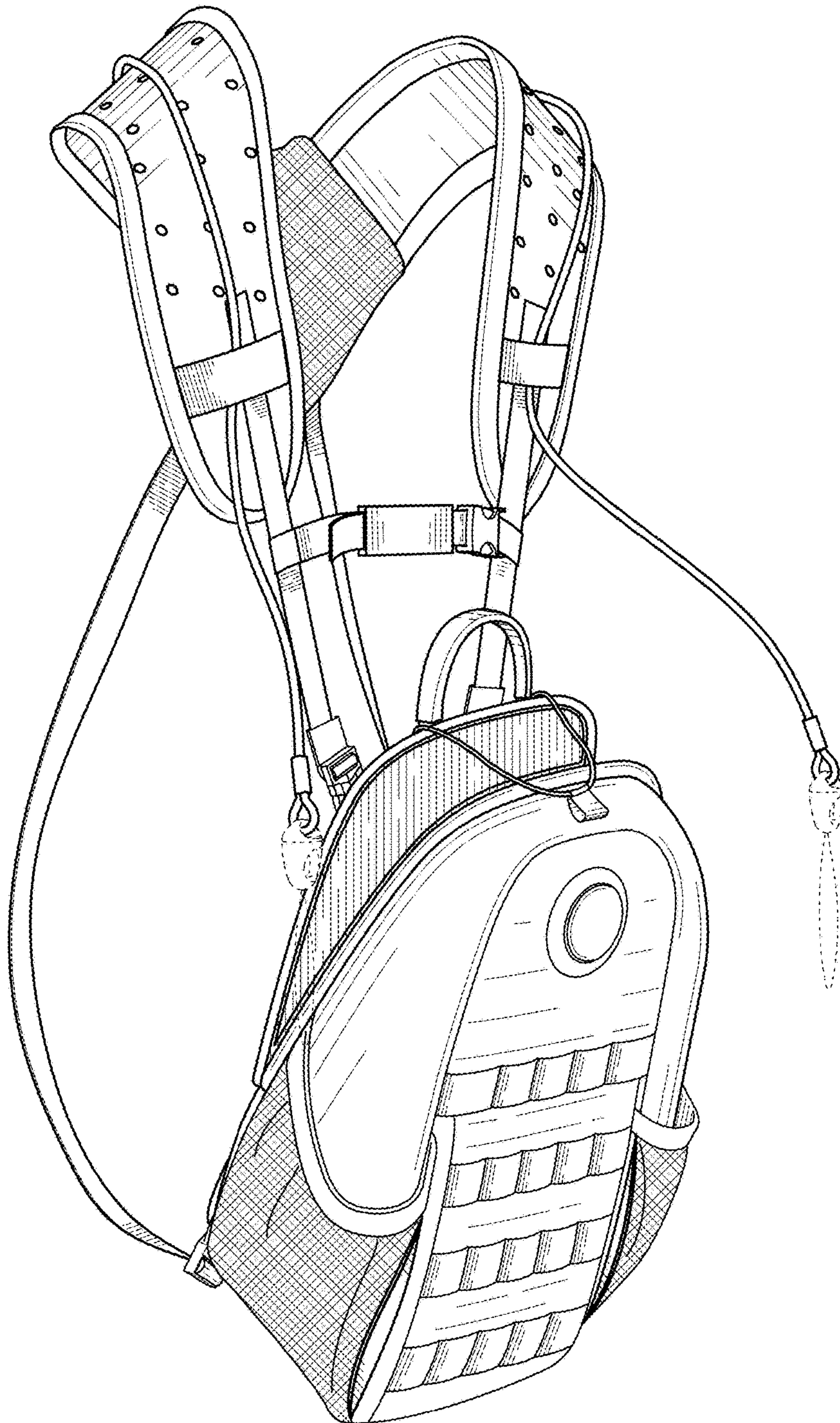

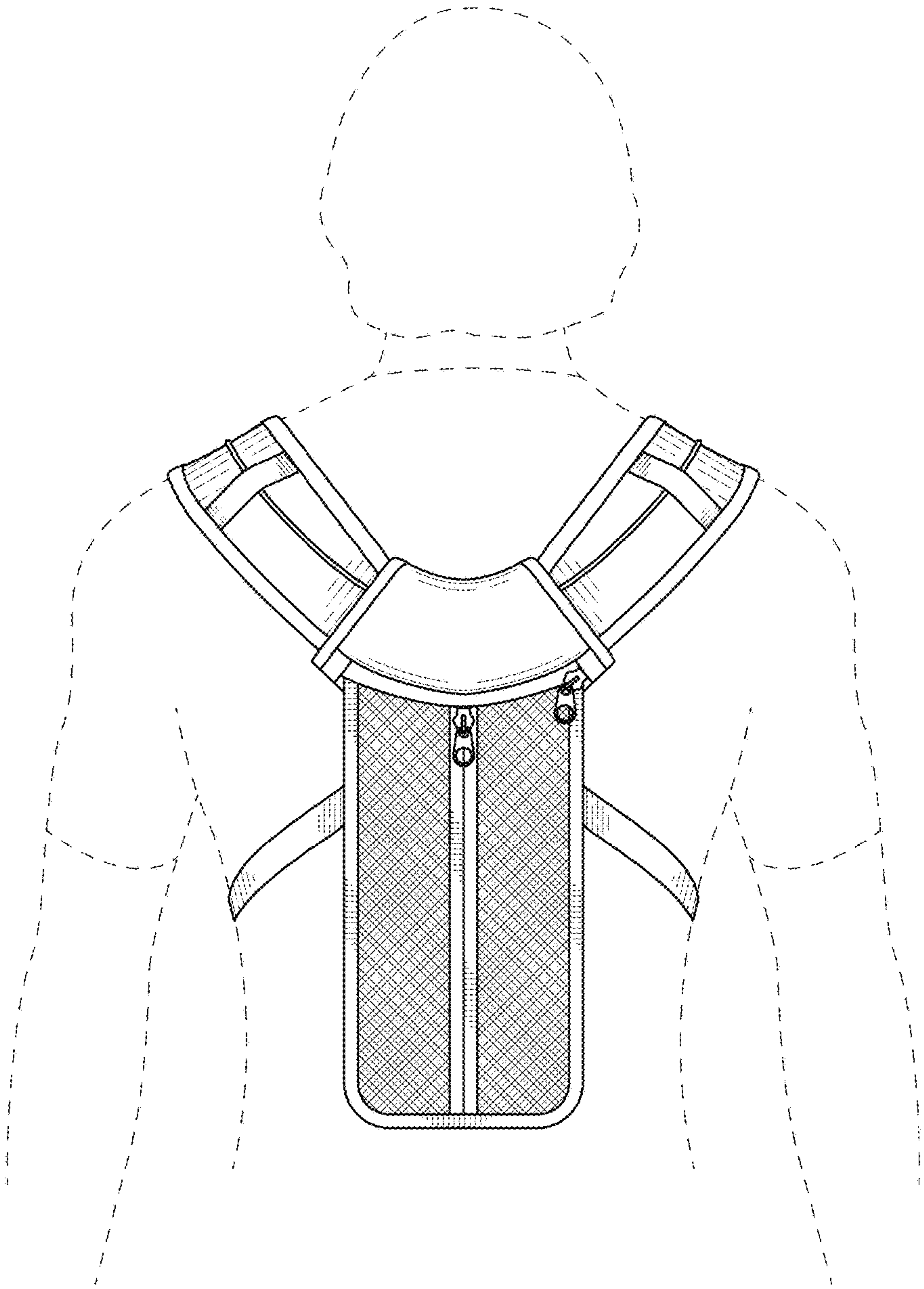
