DESCRIPTION

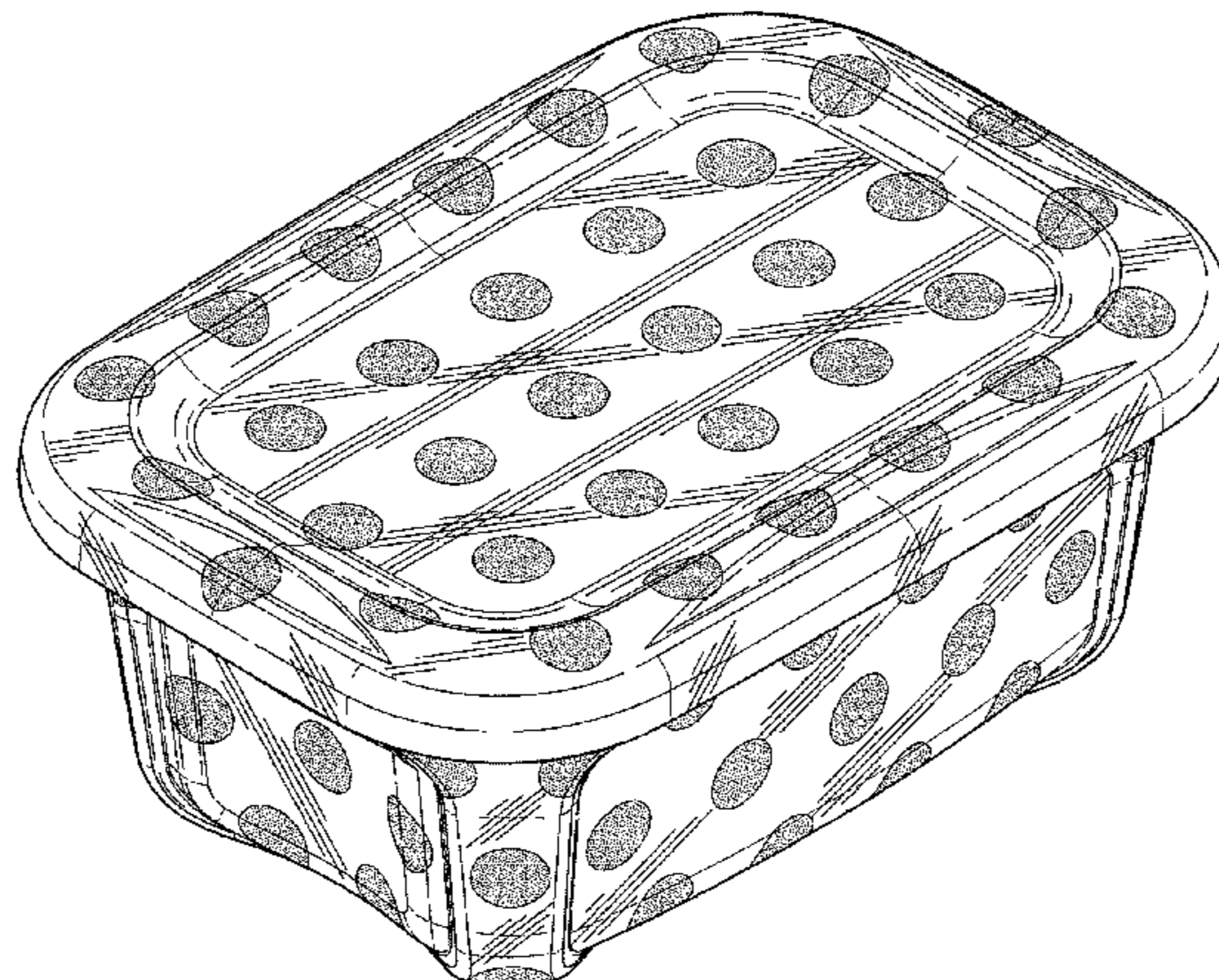
FIG. 1 is a perspective view of the plastic storage container. FIG. 2 is a front view of the plastic storage container; the rear view is a mirror image thereof.

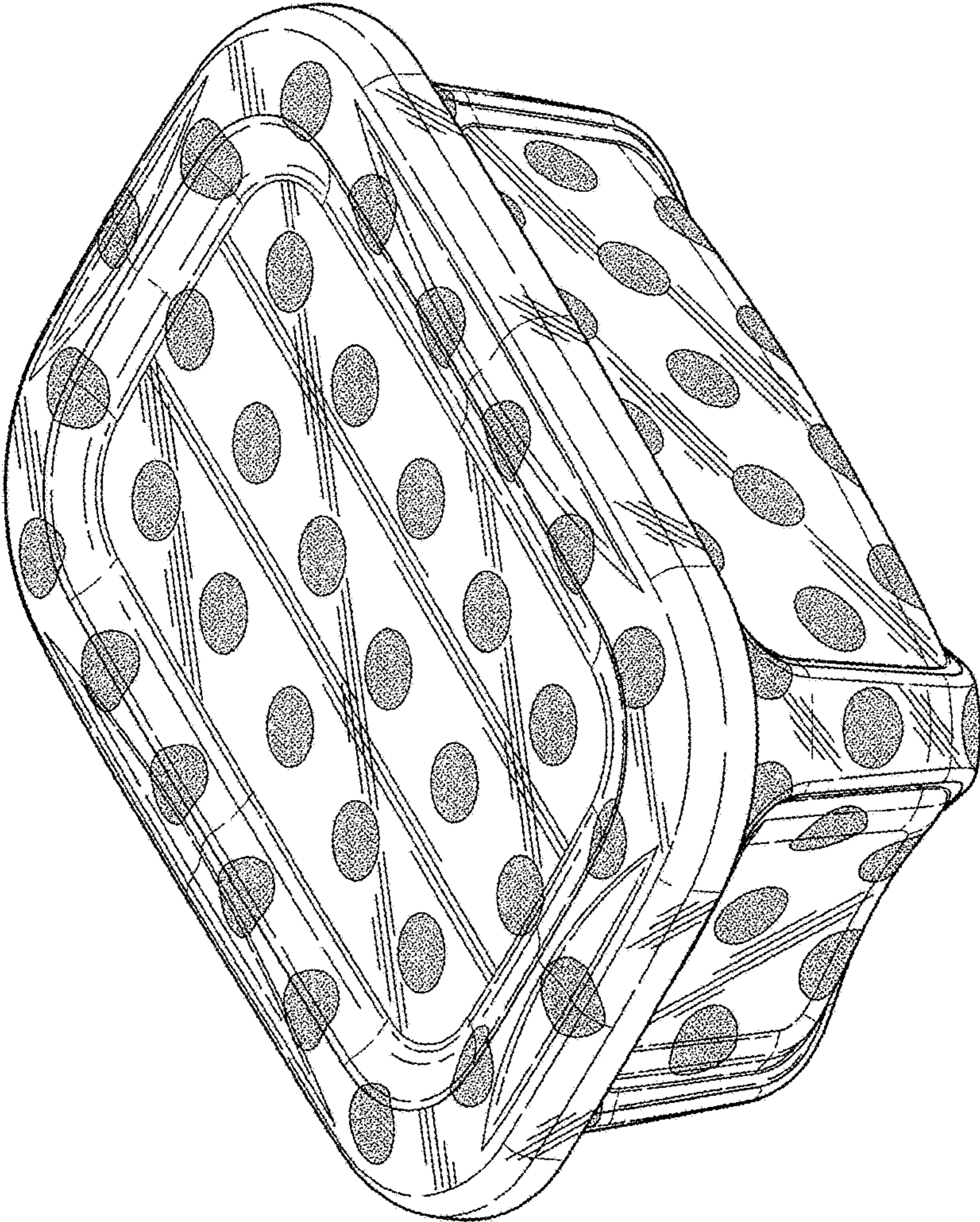

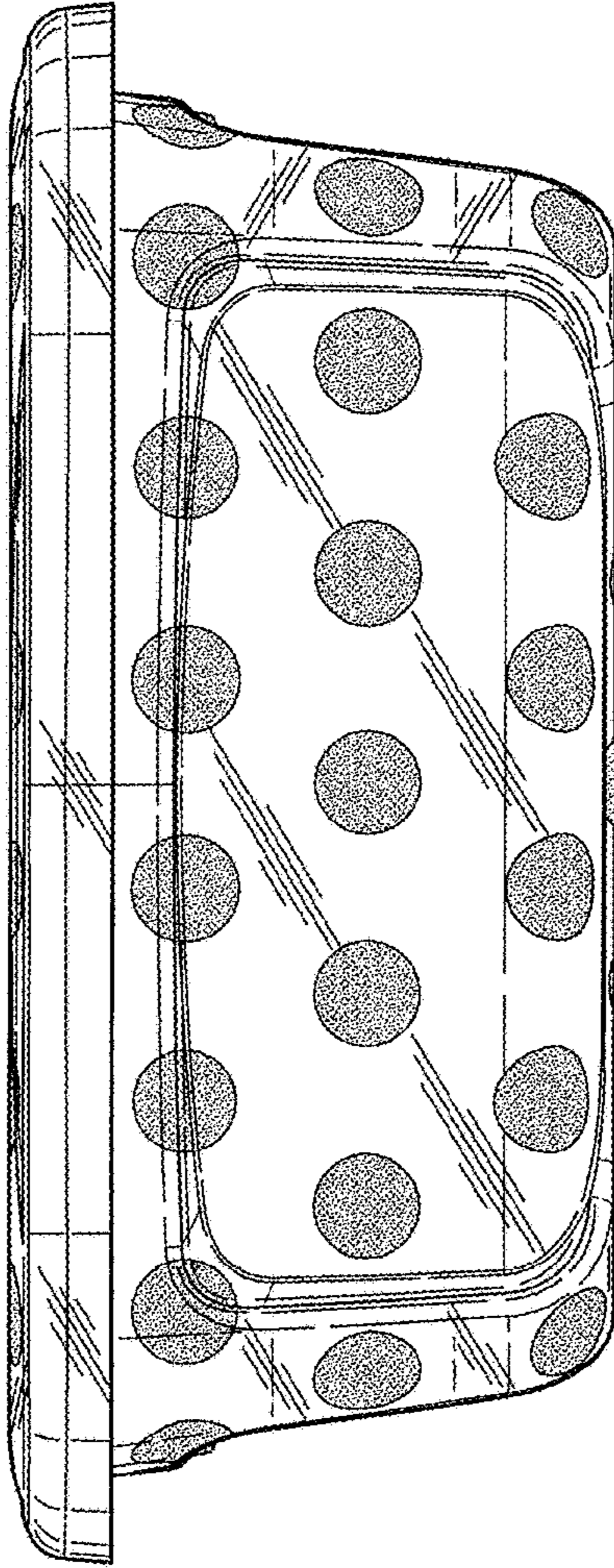

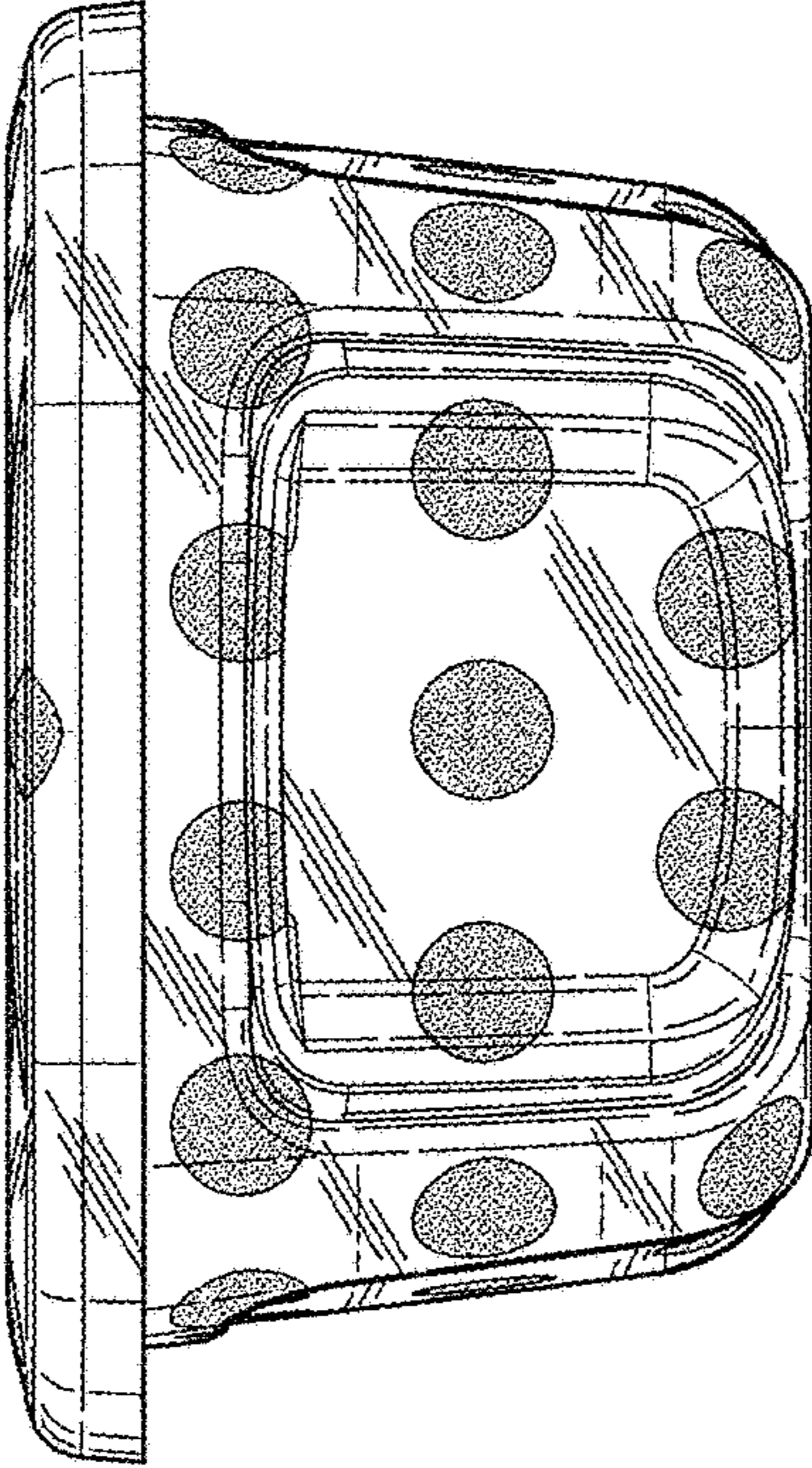

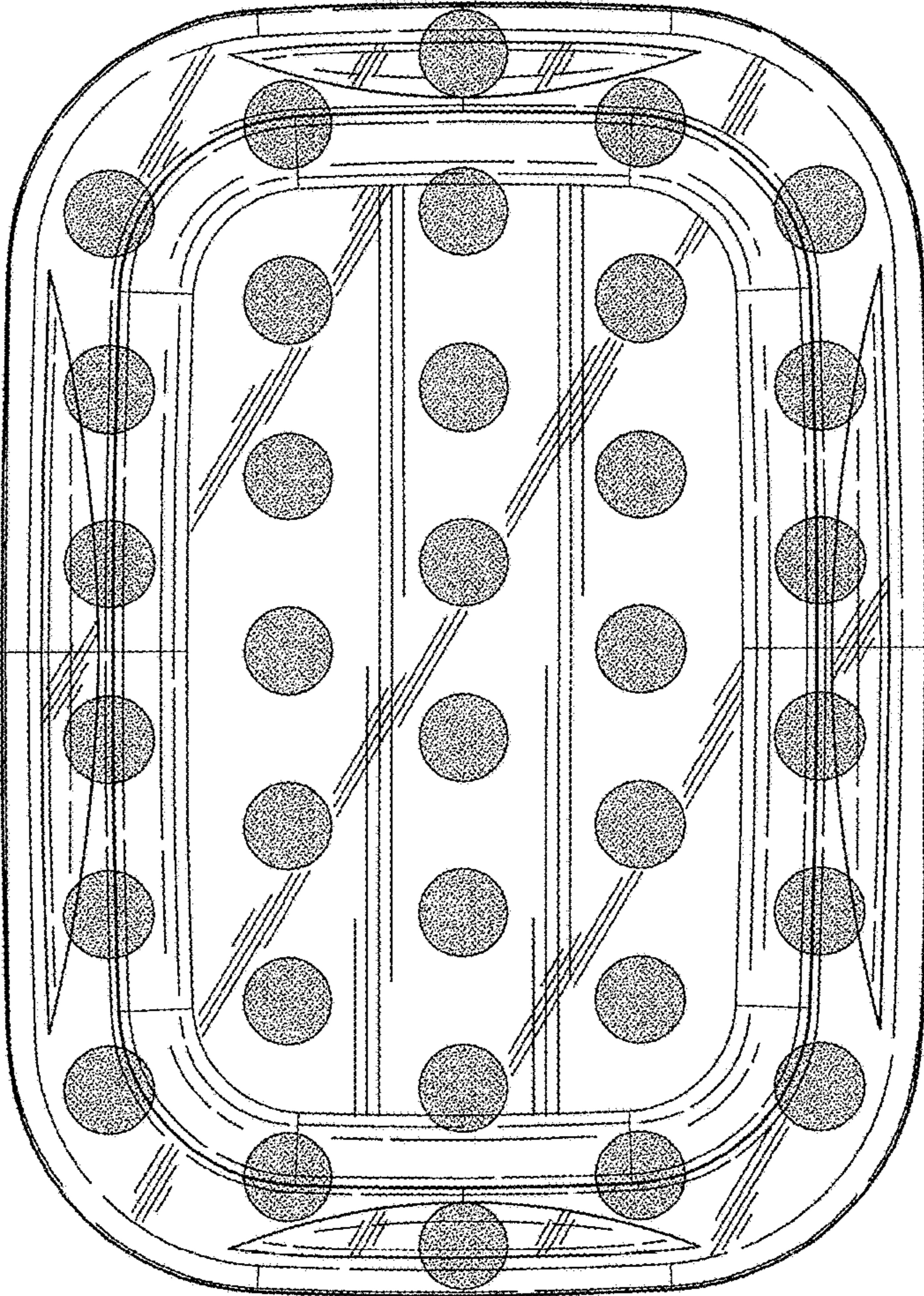

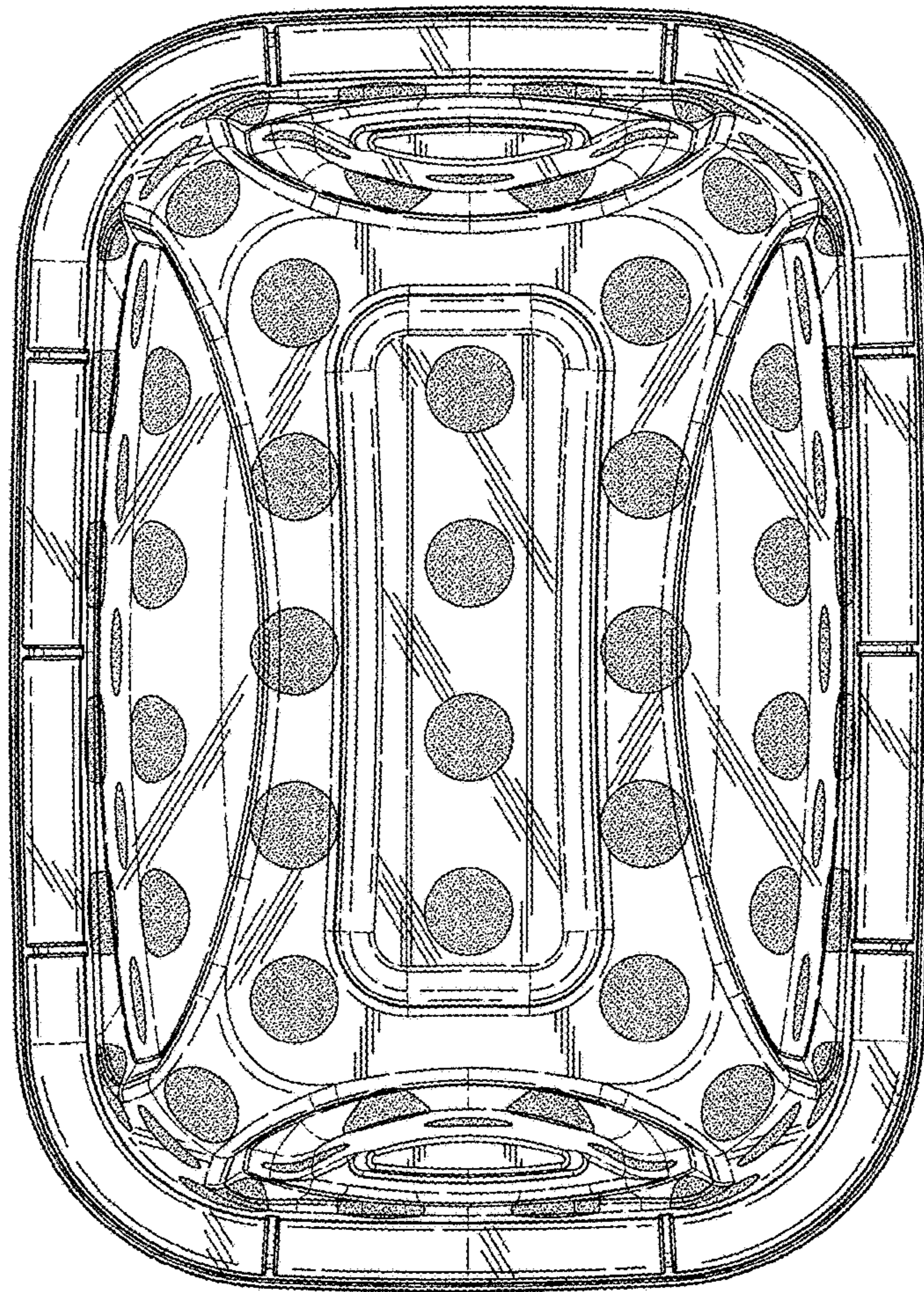
