(57) **CLAIM**

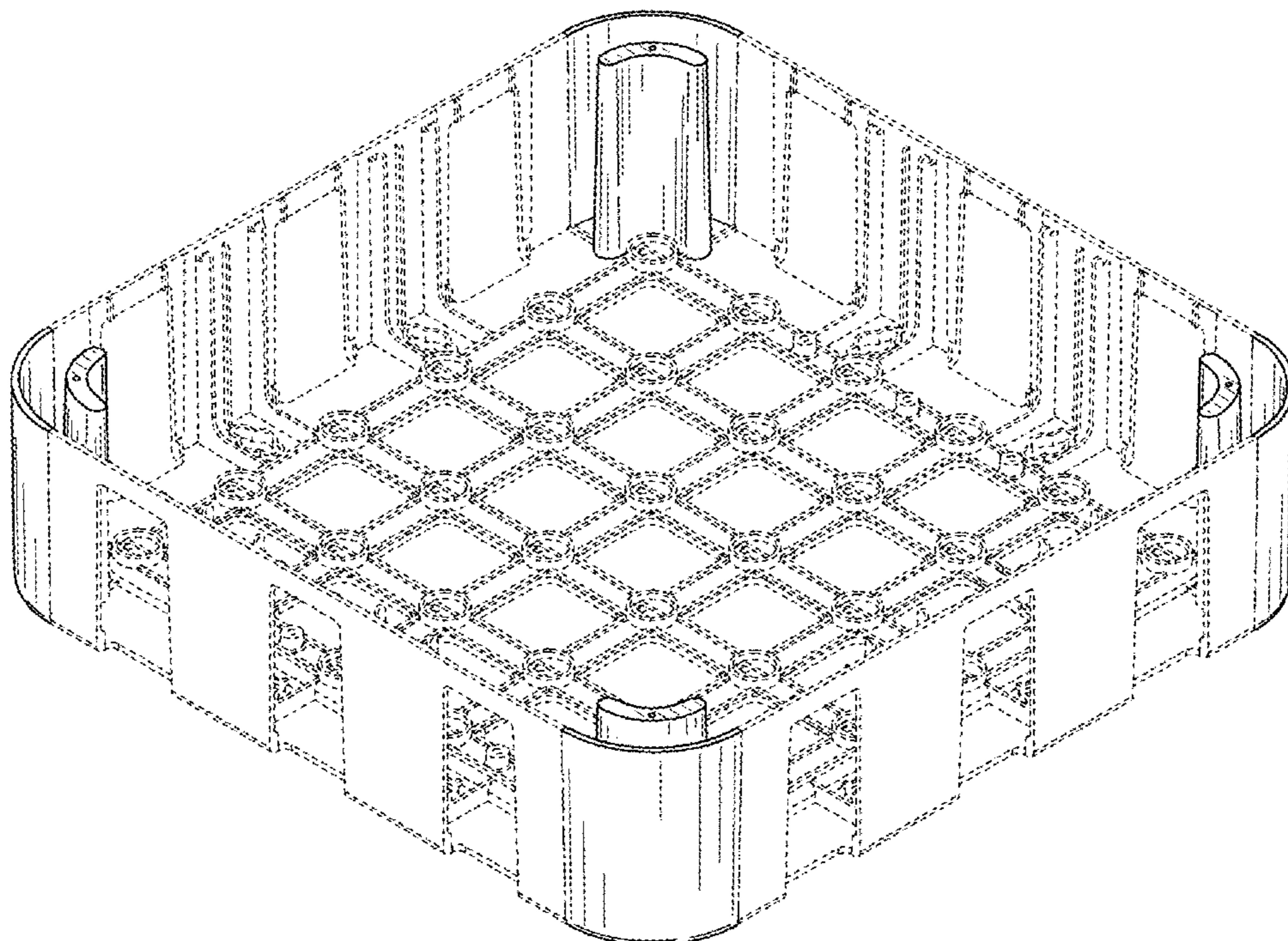
The ornamental design for a cable organizer box, as shown and described.

DESCRIPTION

FIG. 1 is a front side perspective view of a first embodiment of the cable organizer box showing my new design; FIG. 2 is a right side view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a top side view thereof; FIG. 5 is a bottom side view thereof; FIG. 6 is a front side view; and, FIG. 7 is a bottom side view thereof.

The broken lines in portions of the cable organizer box depict environmental subject matter only and form no part of the claimed design.

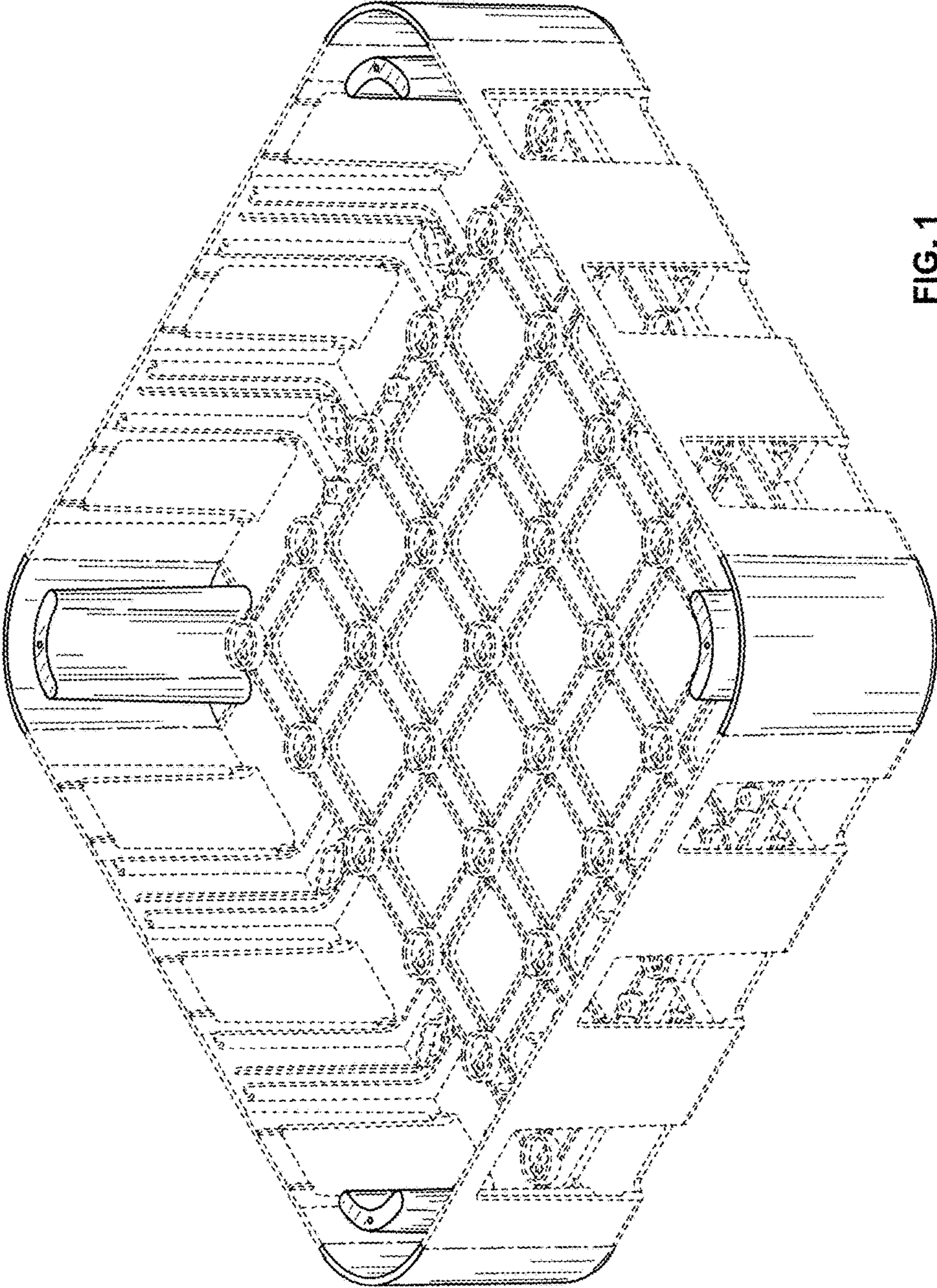

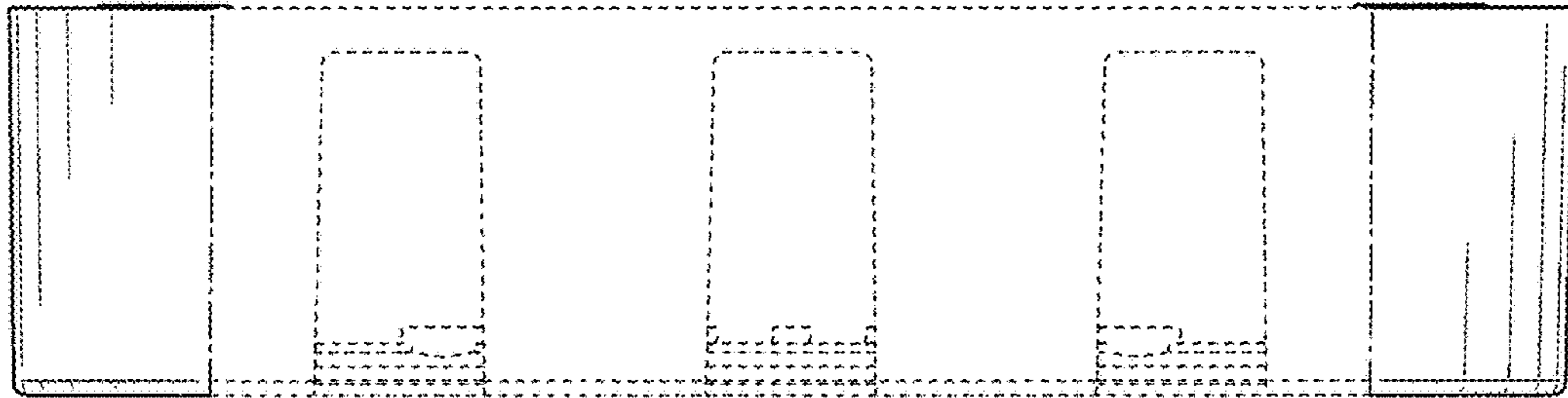

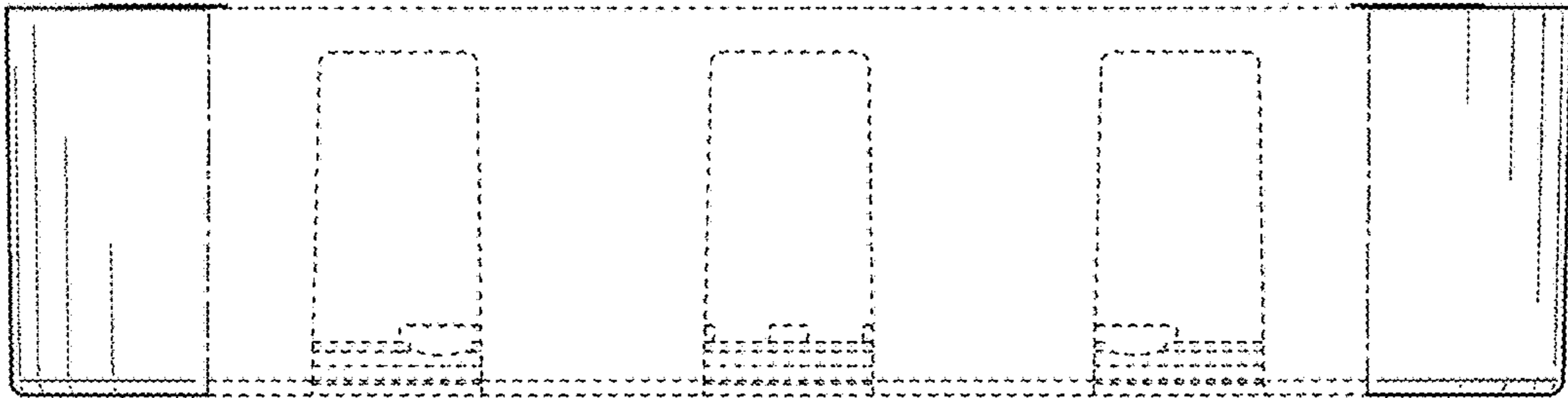

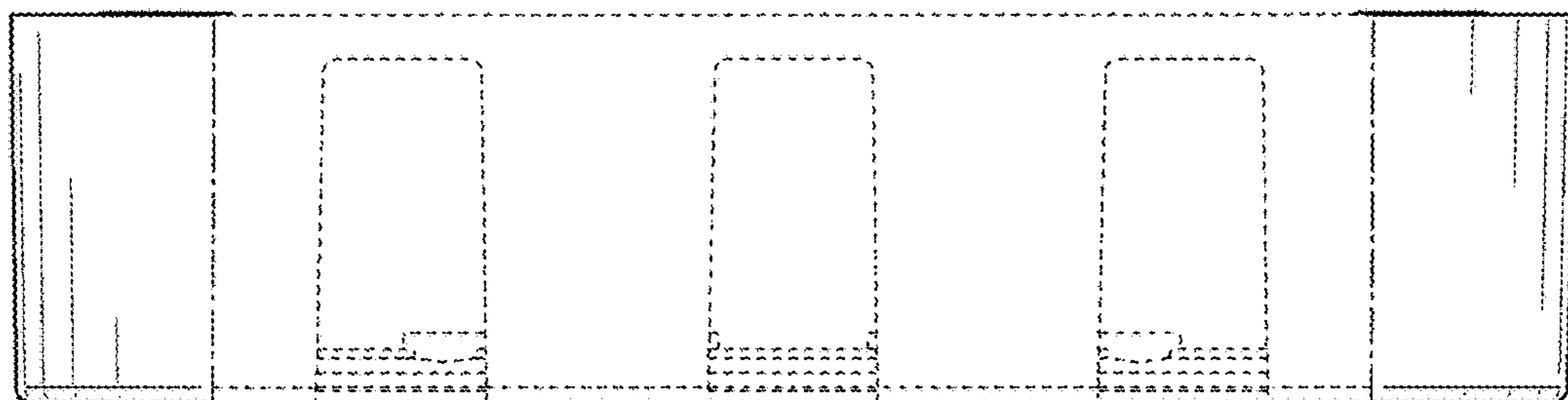

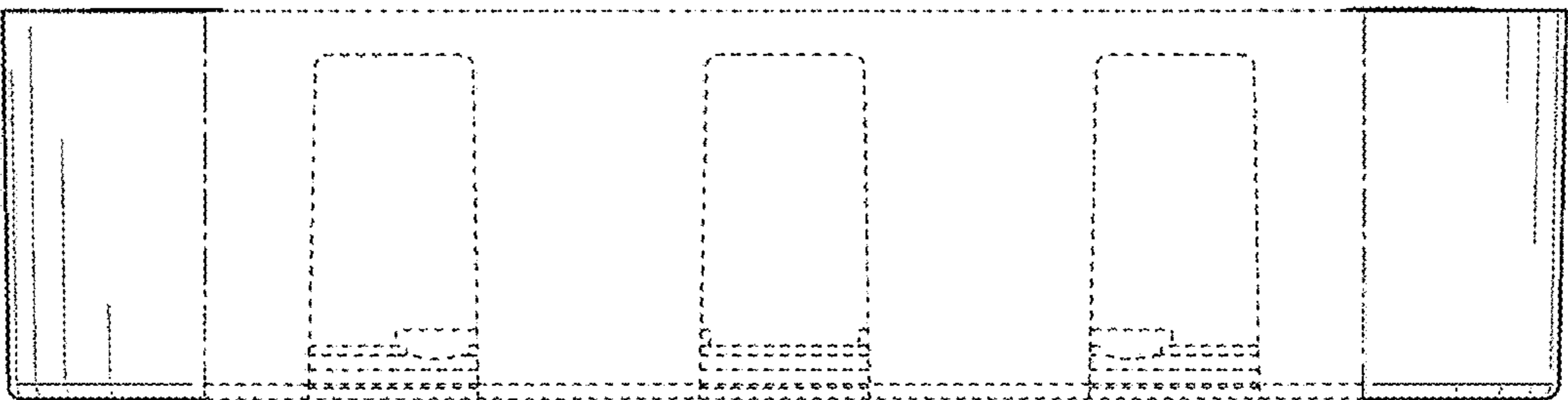

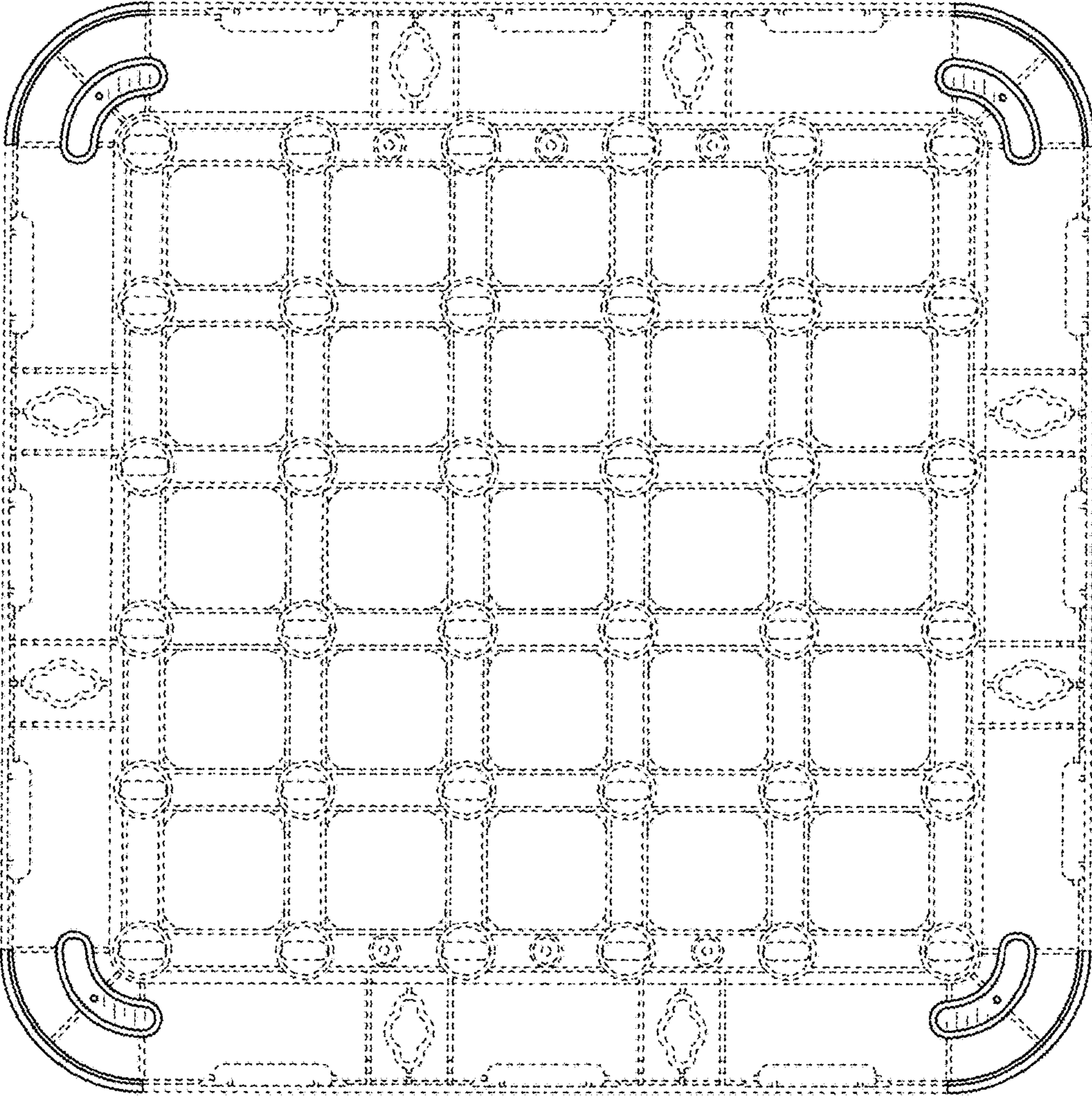

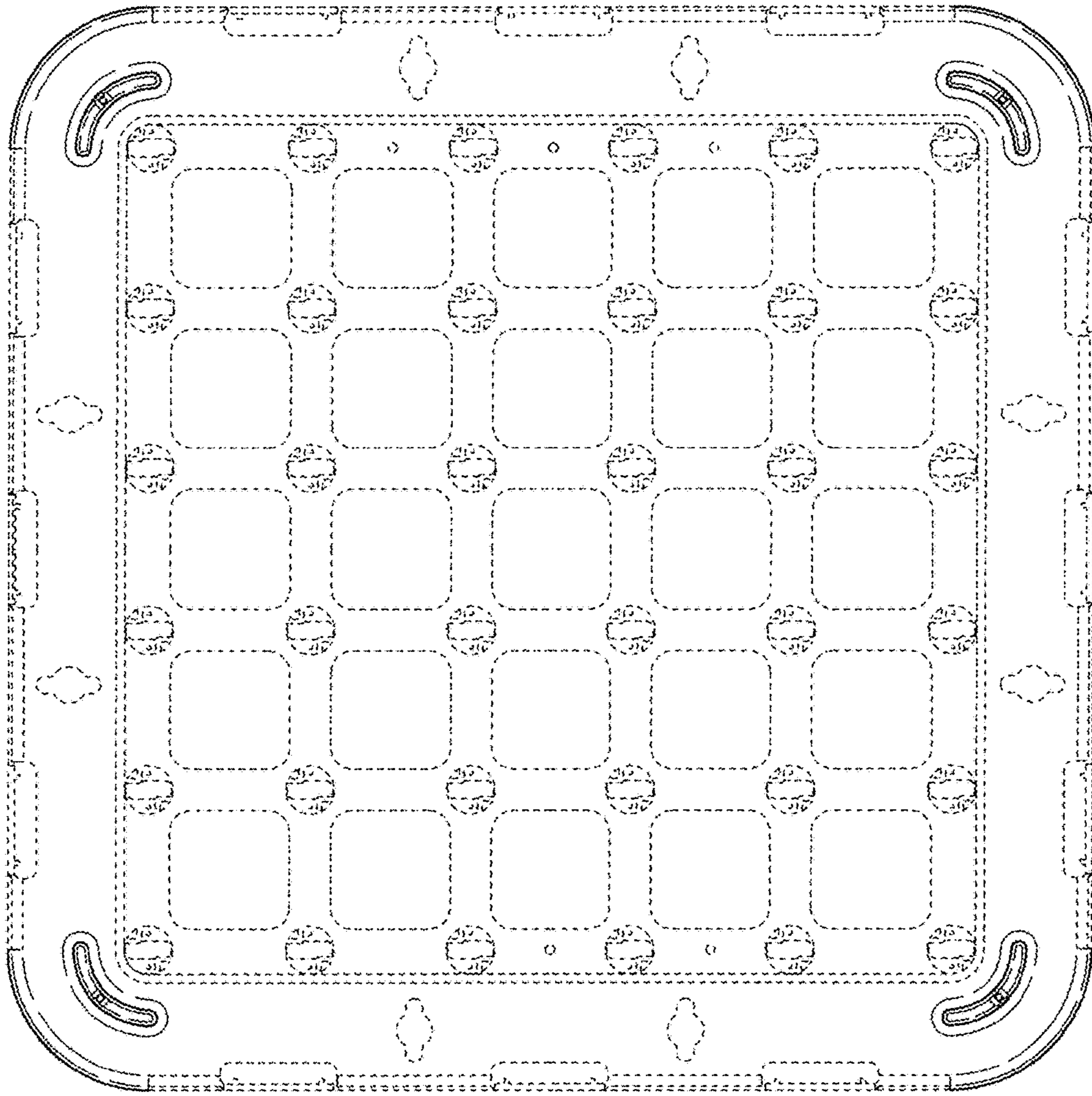
