The ornamental design for a toothbrush, as shown and described.

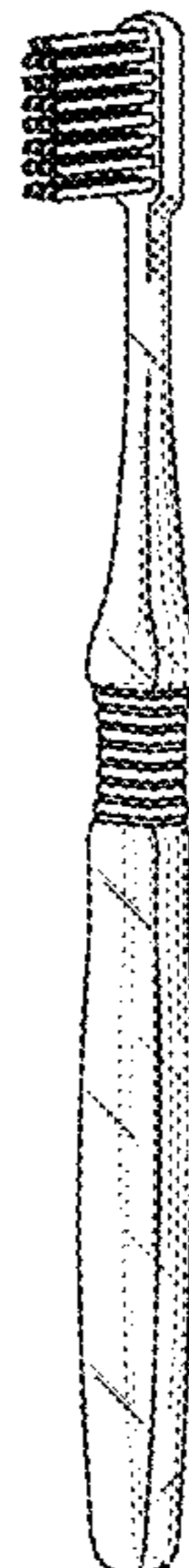
DESCRIPTION

- 1.7 : Bottom

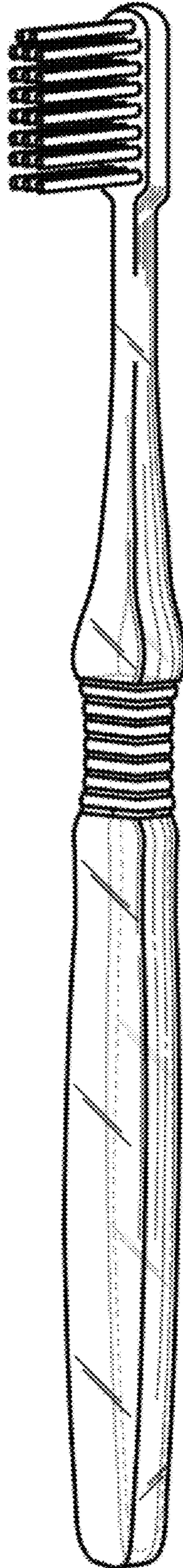
The body of the toothbrush is transparent. The shading shown in the reproductions represents the surfaces of the claimed design and does not represent surface ornamentation.

In the reproductions, the broken lines are for the purpose of illustrating environment only and form no part of the claimed design.

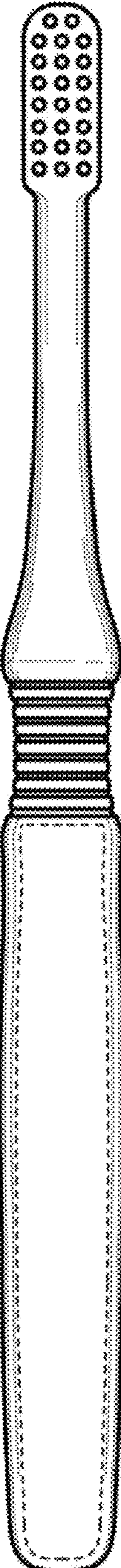

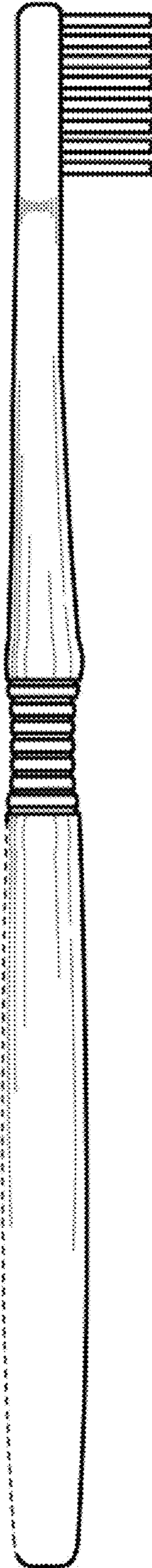

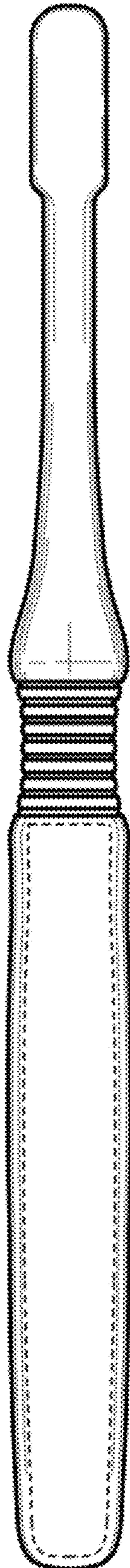

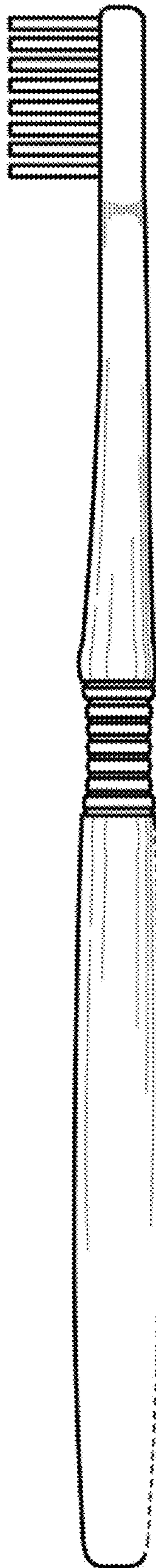
