FIG. 8 is a bottom view thereof.

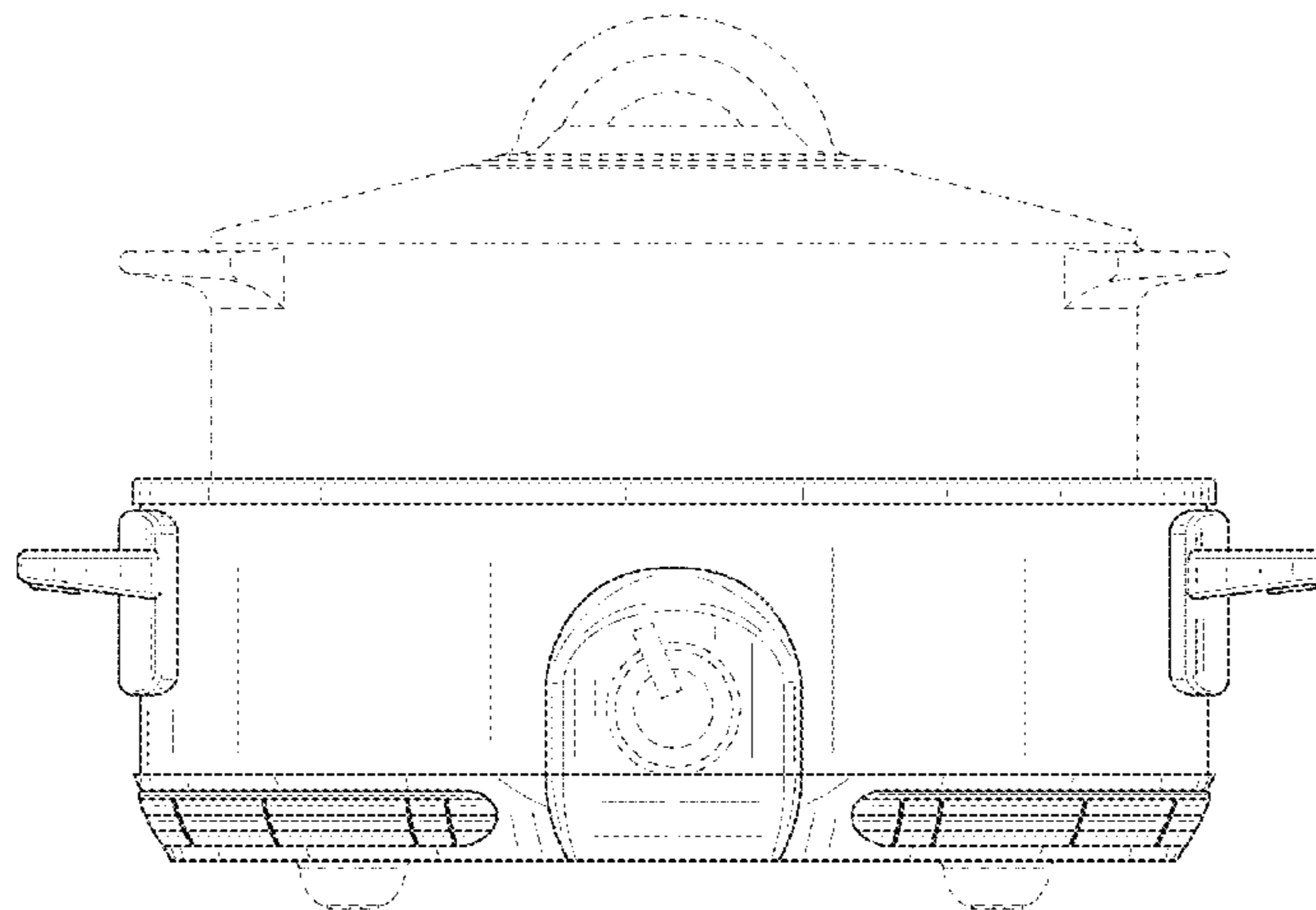
The broken lines shown illustrate portions of the slow

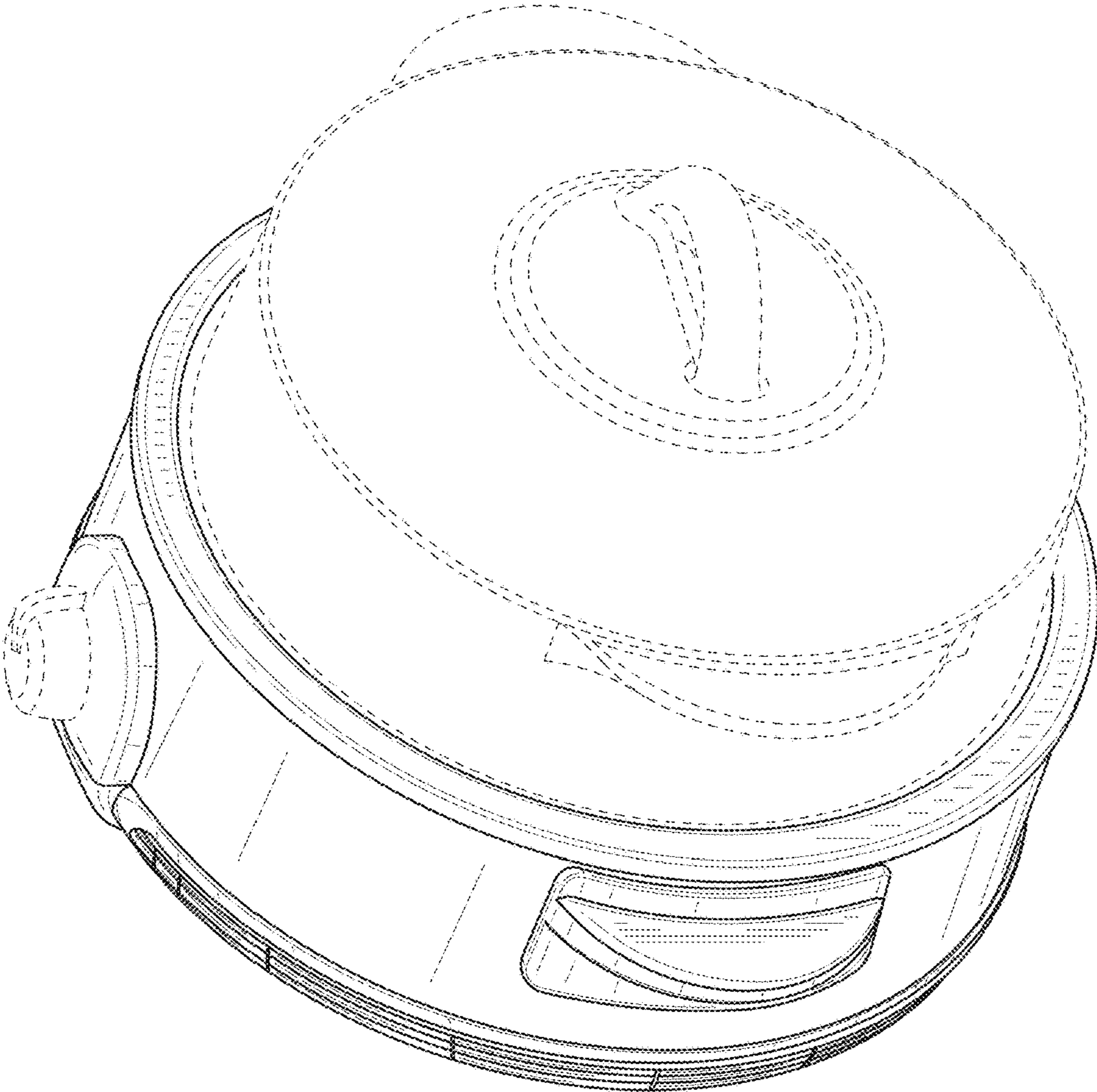

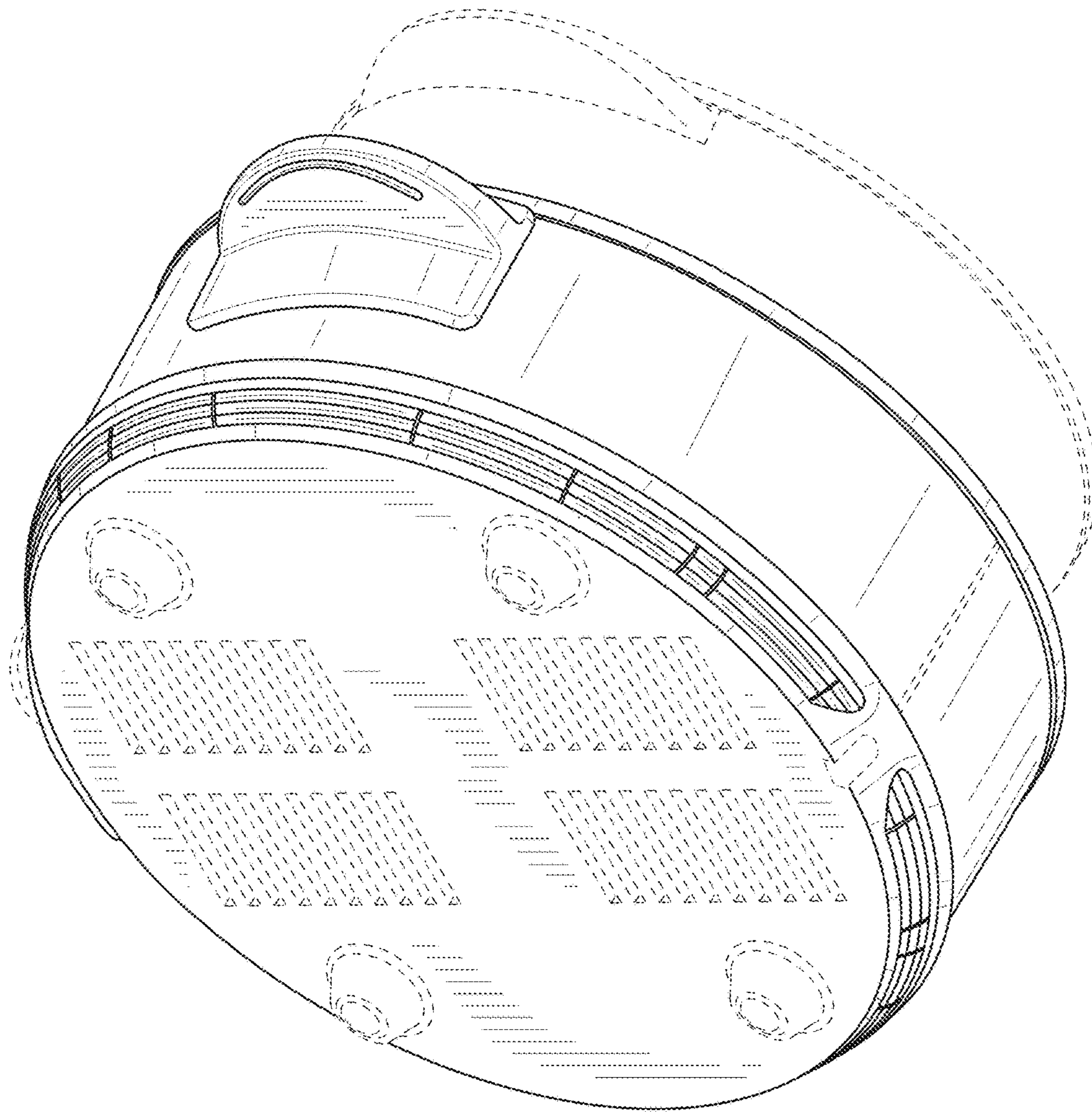

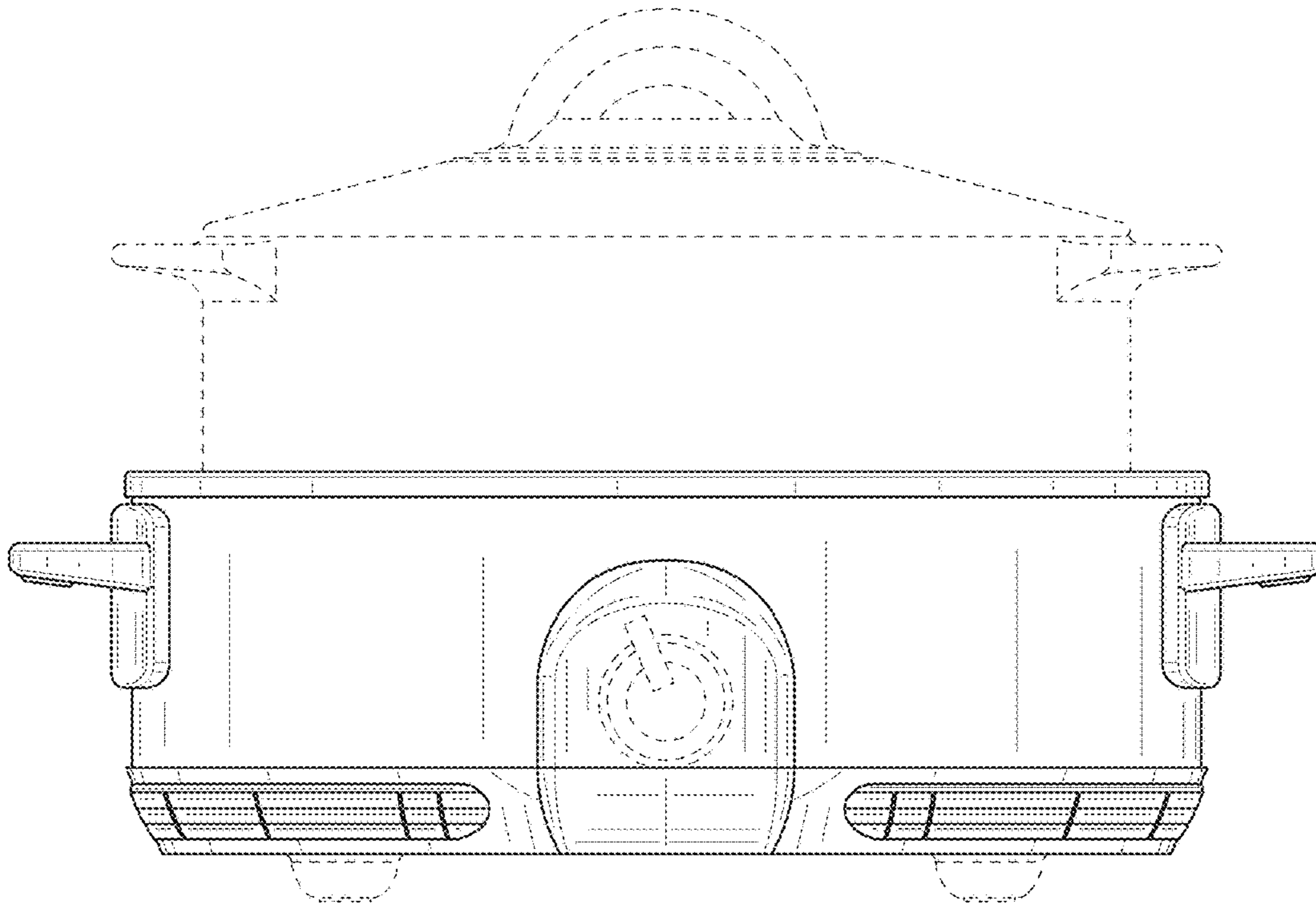

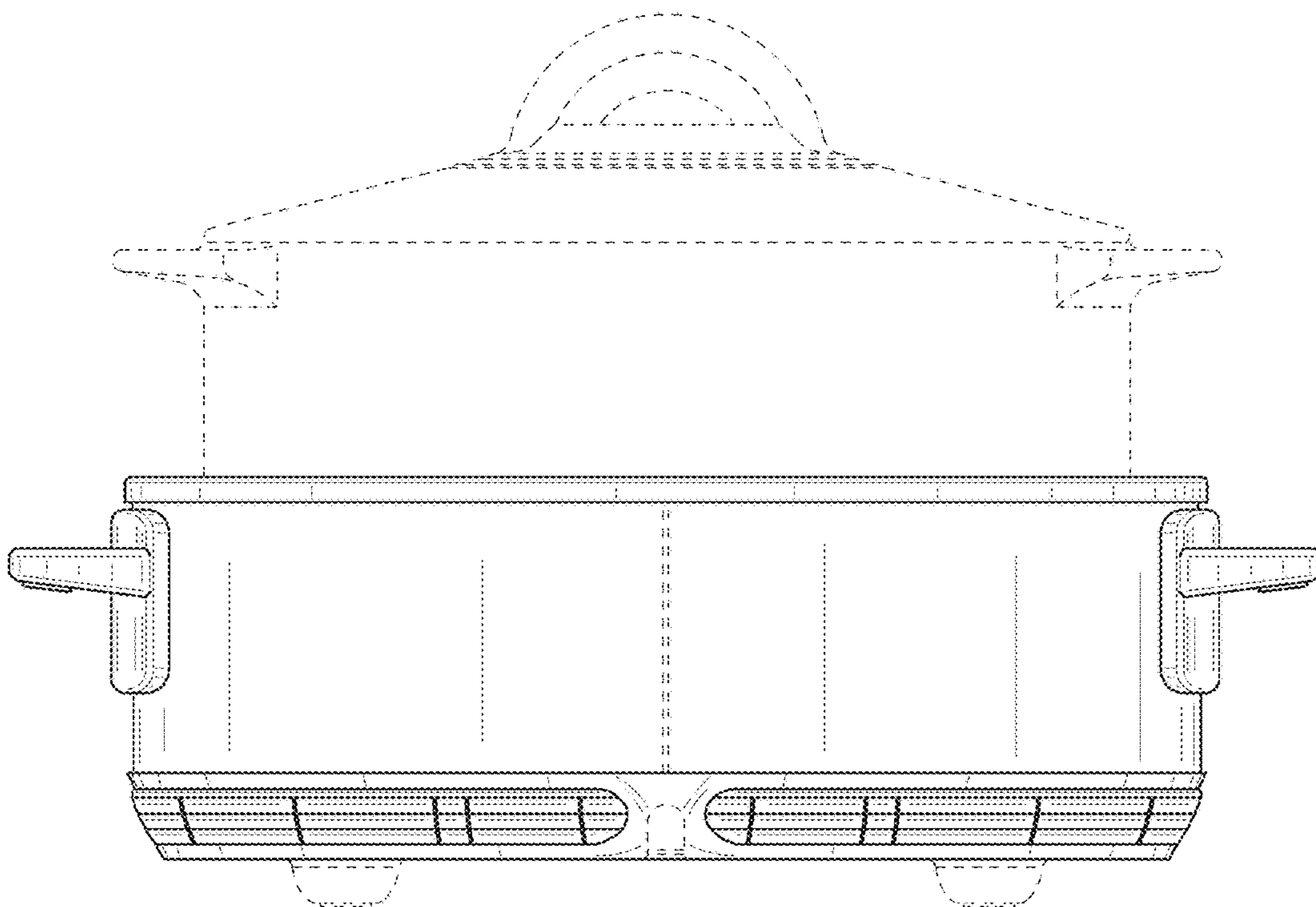

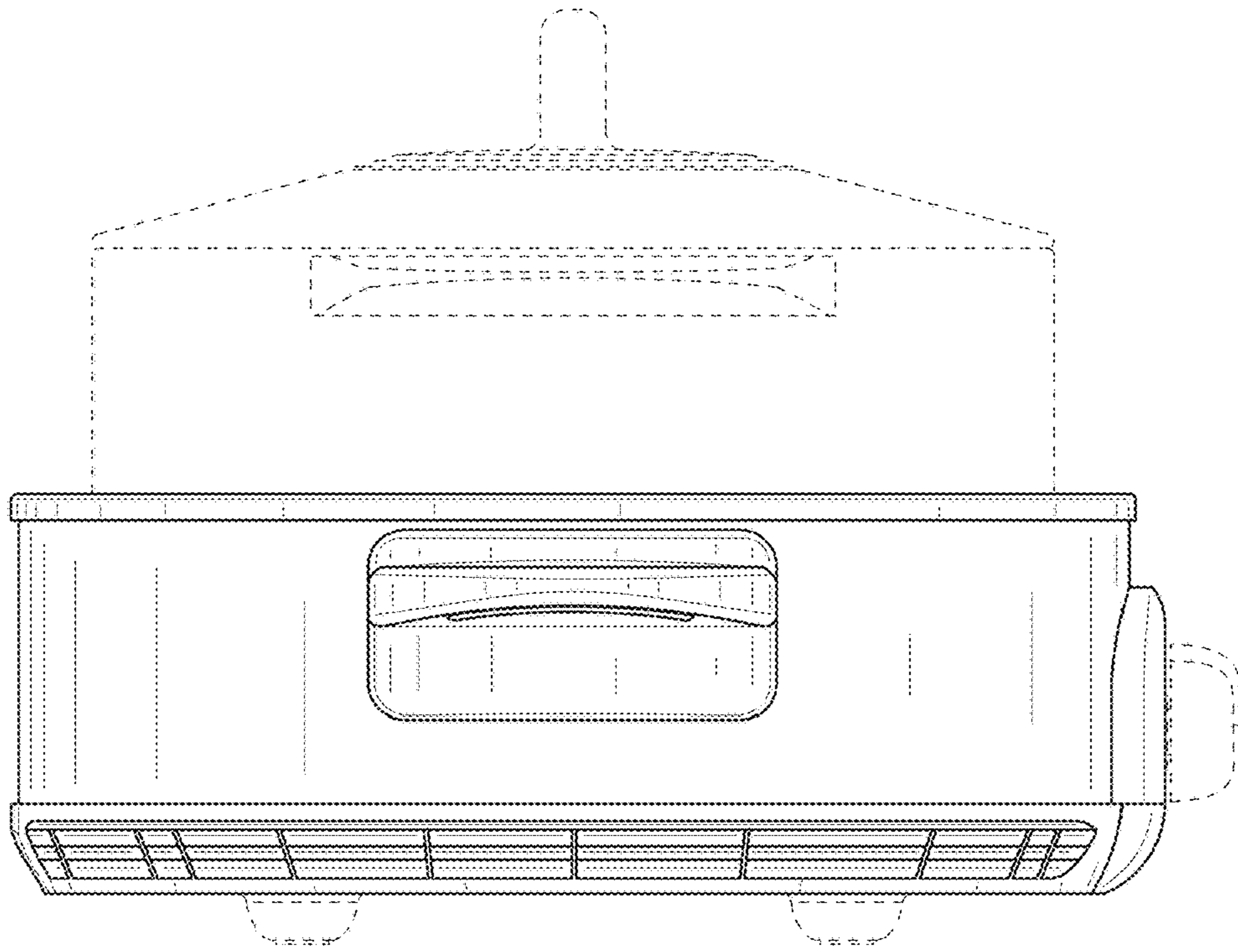

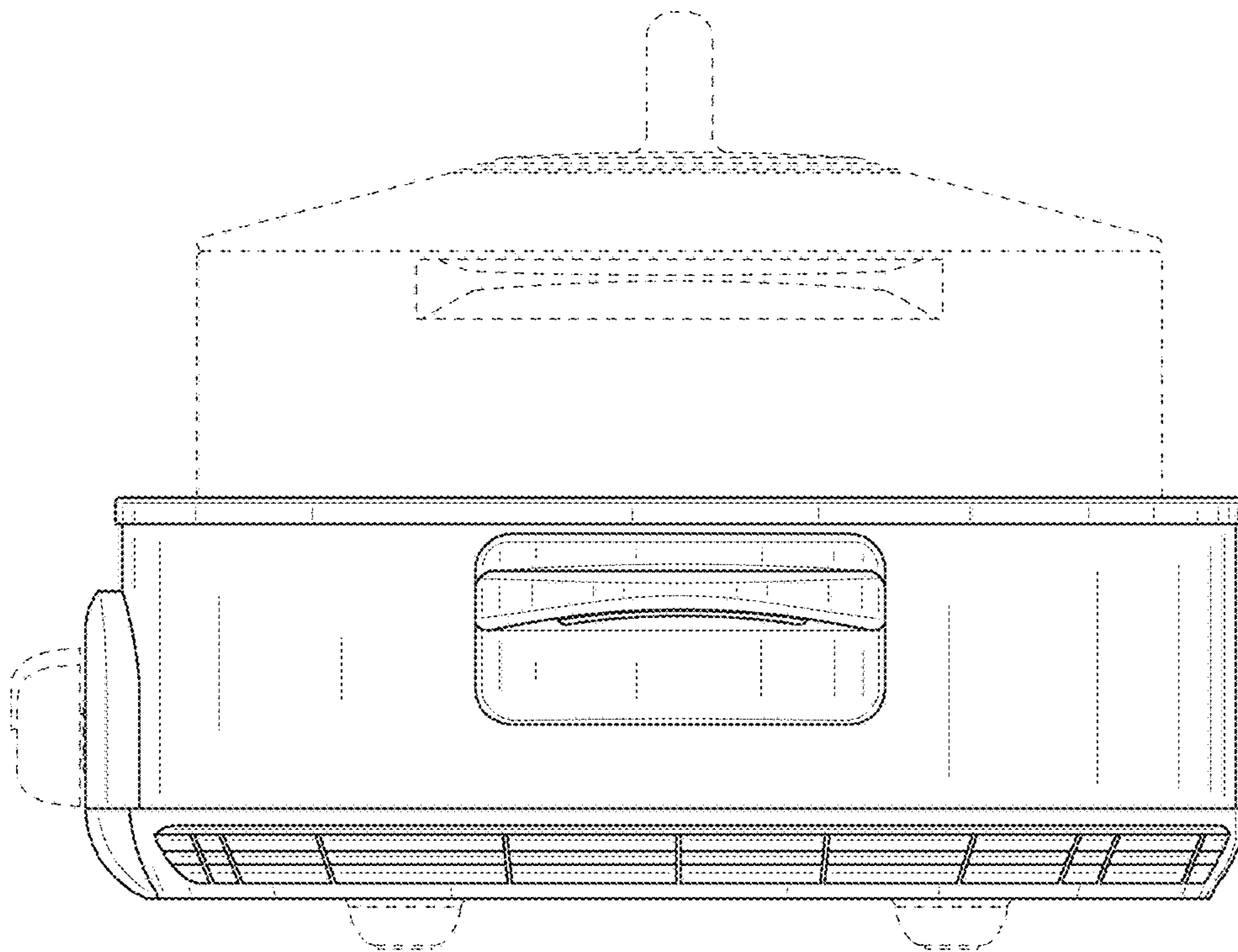

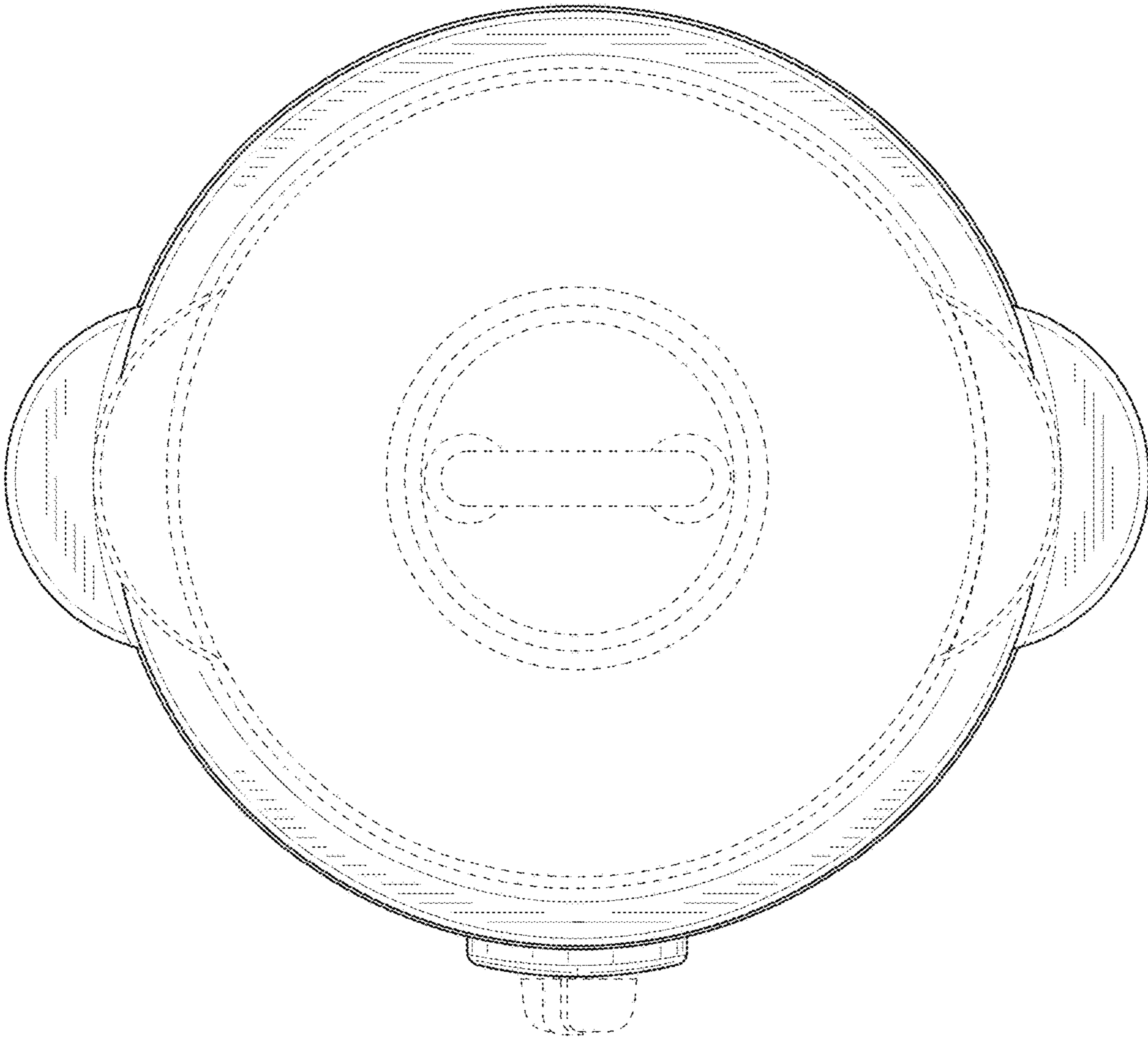

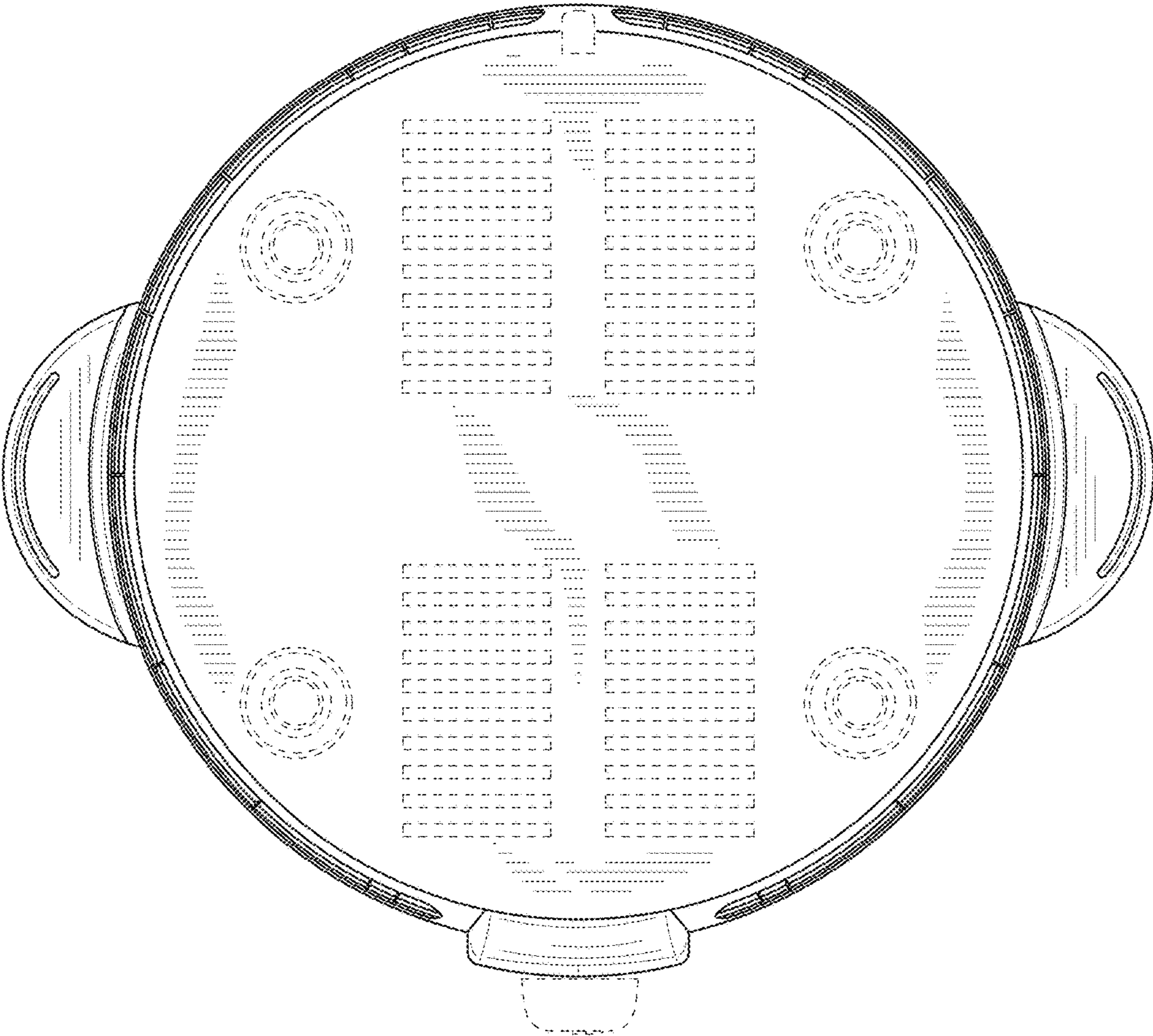
