The ornamental design for a package for a wax article, as shown and described.

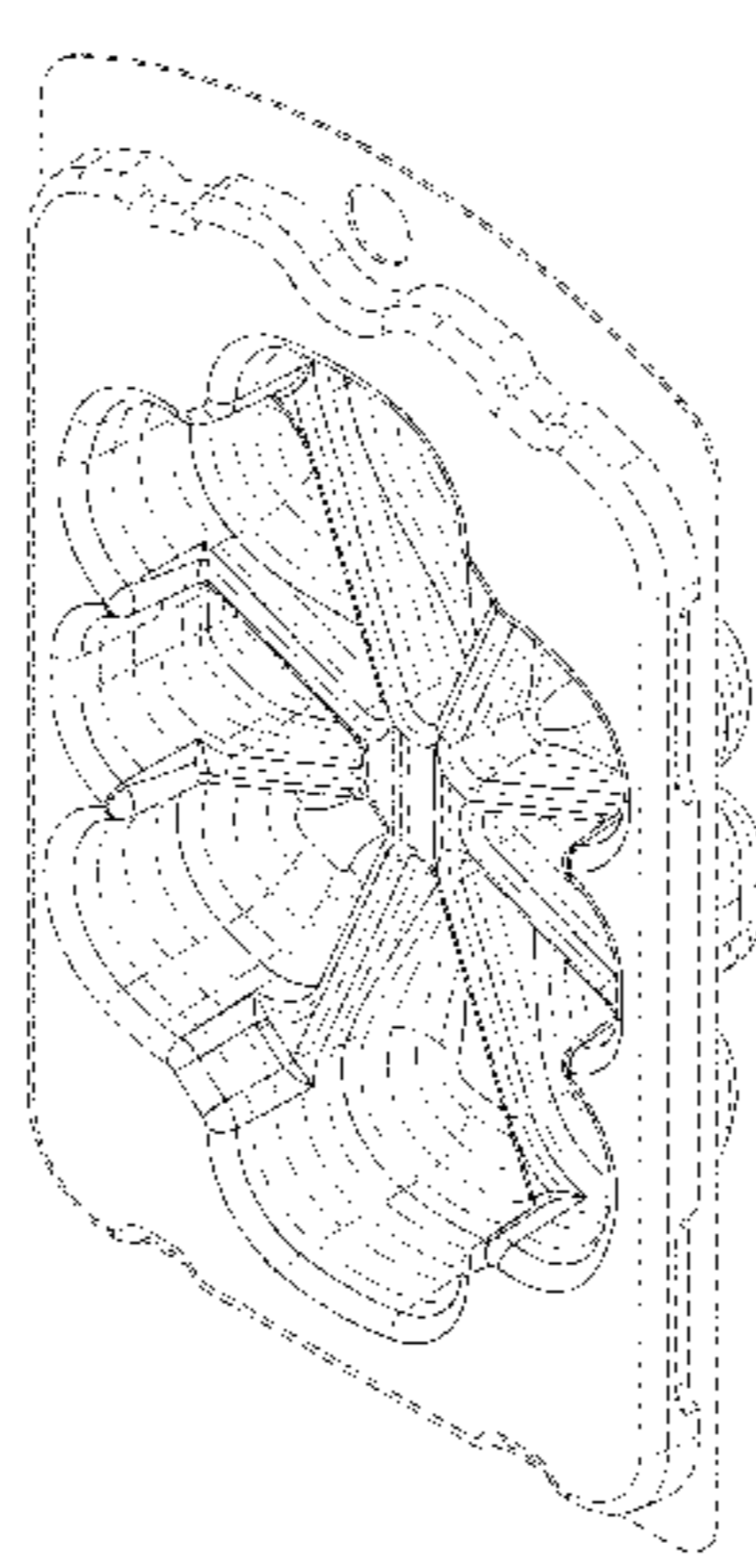
DESCRIPTION

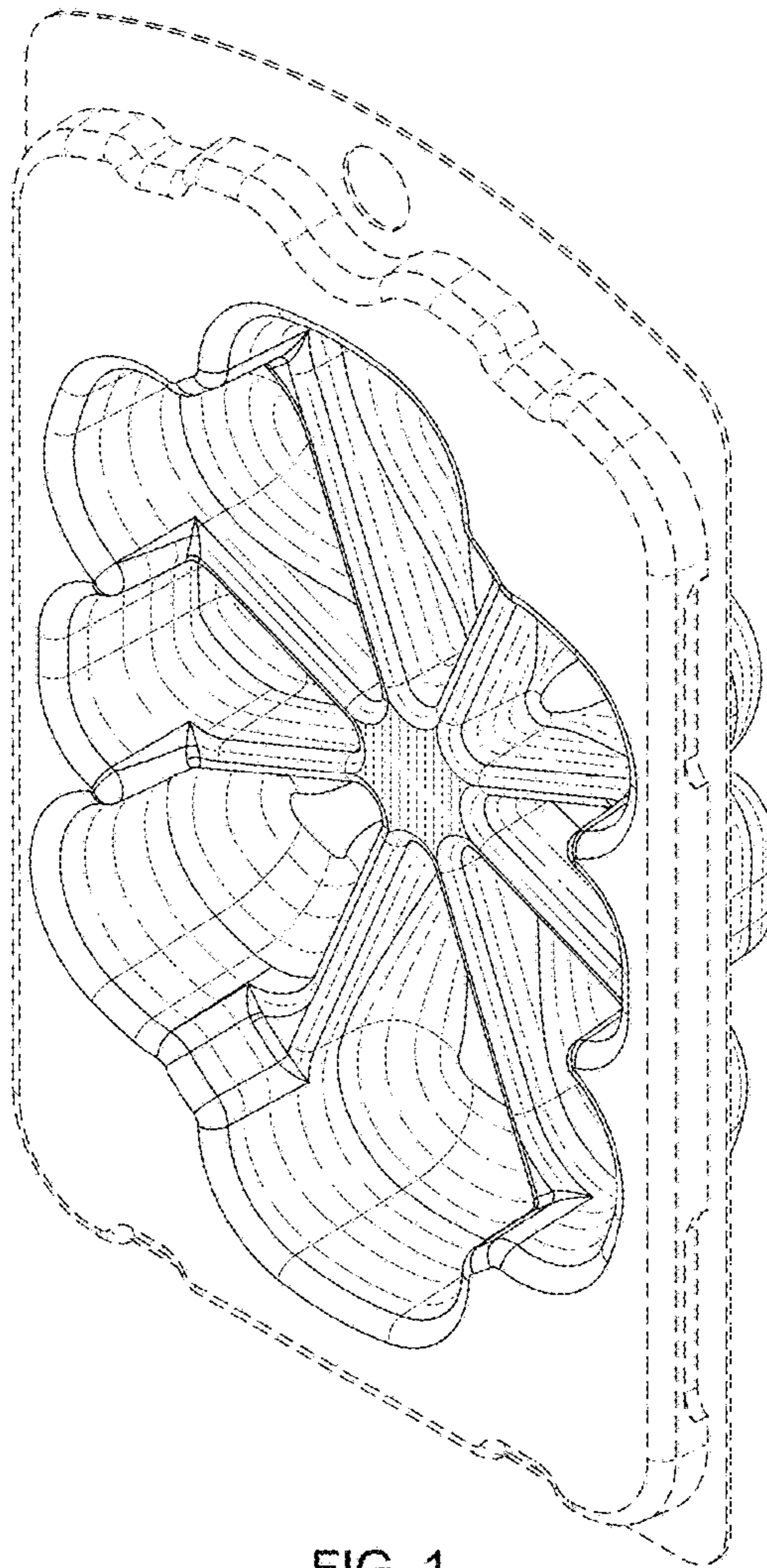

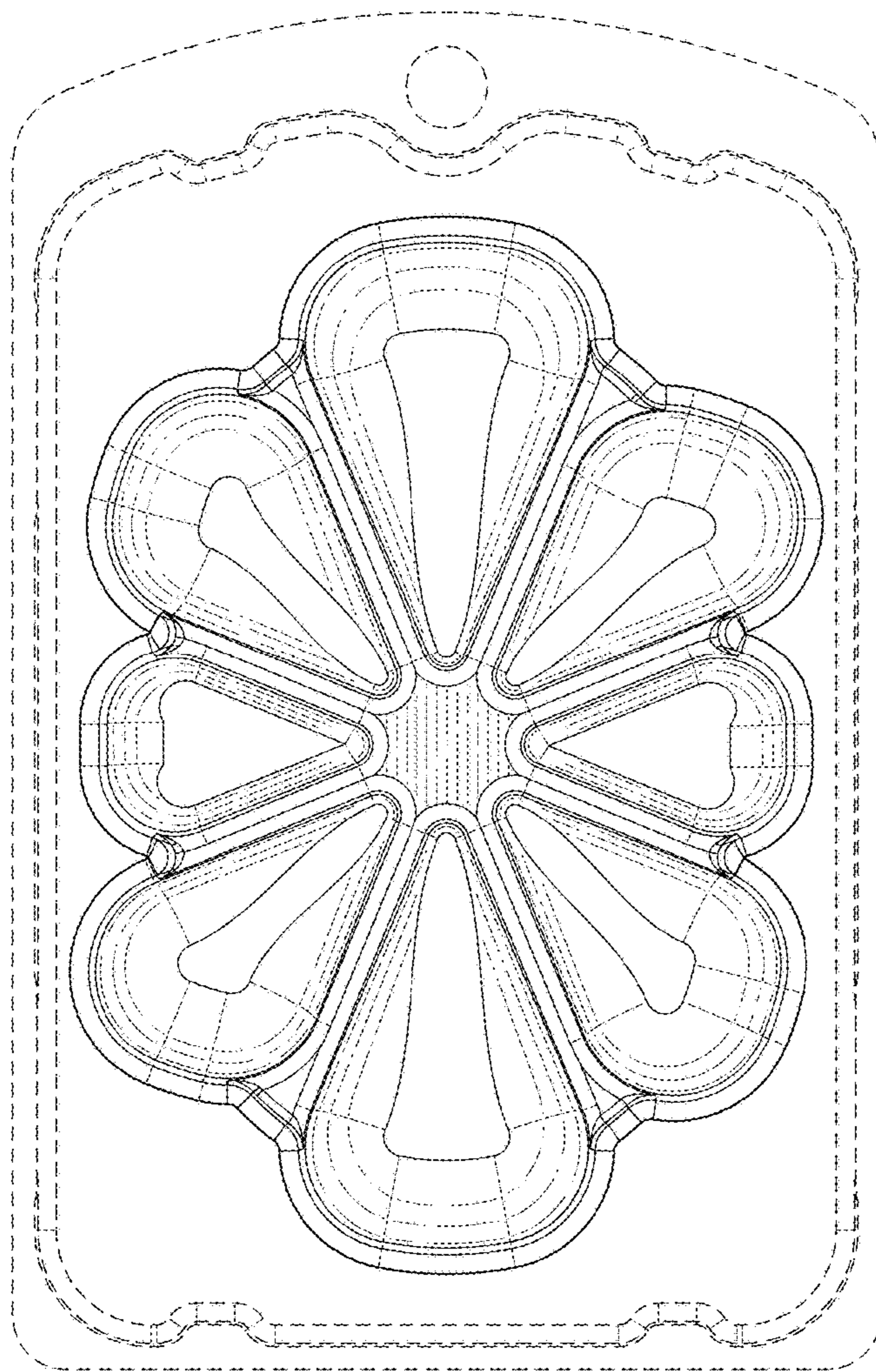

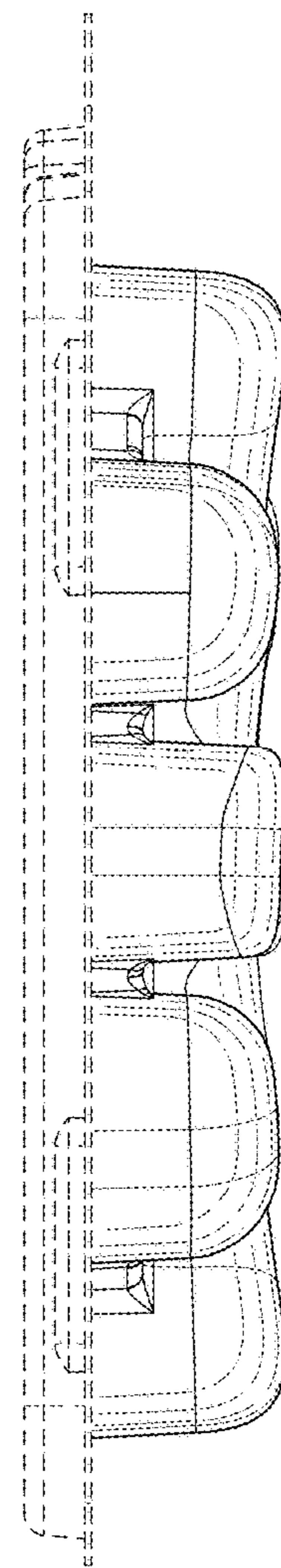

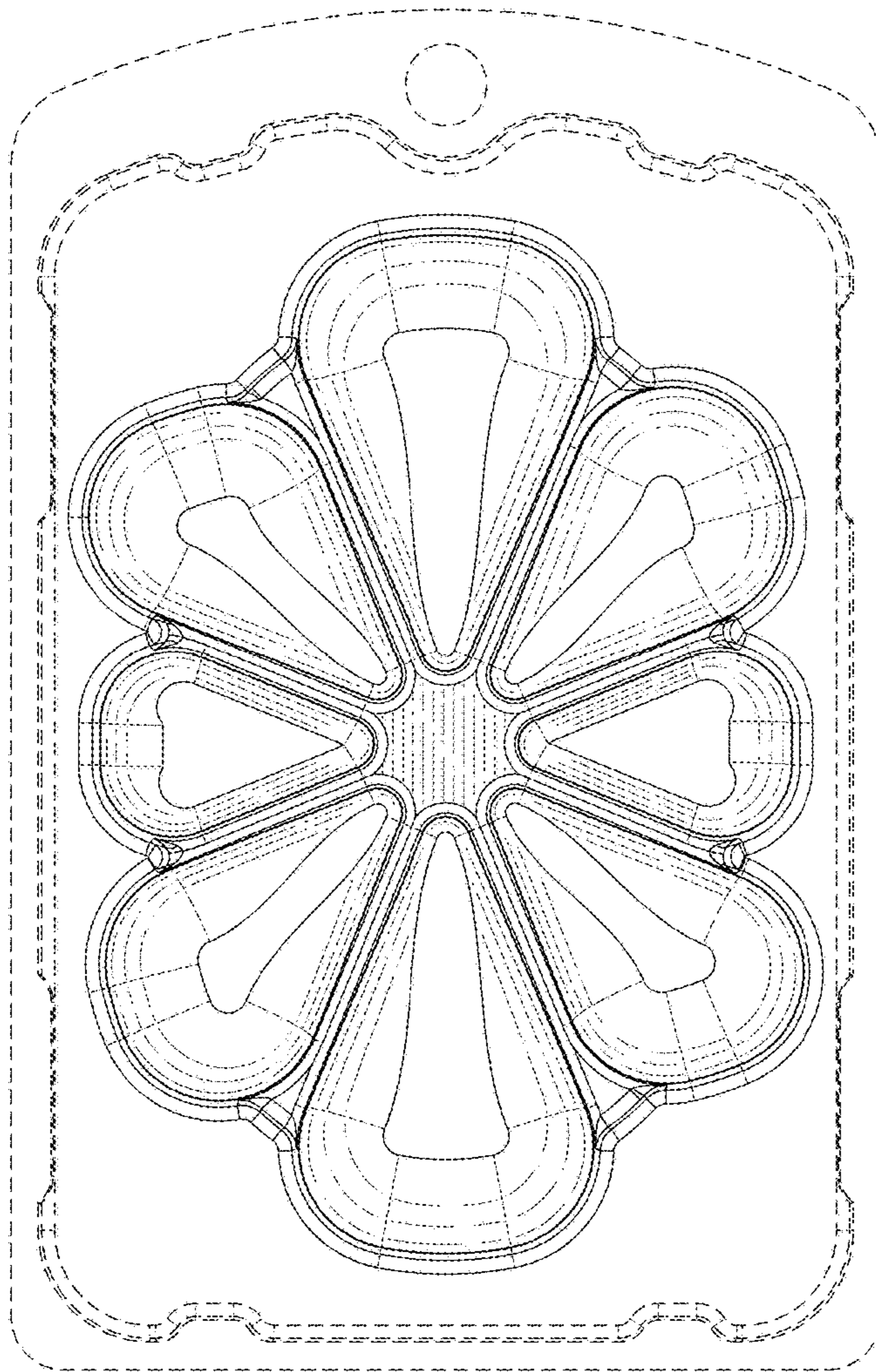

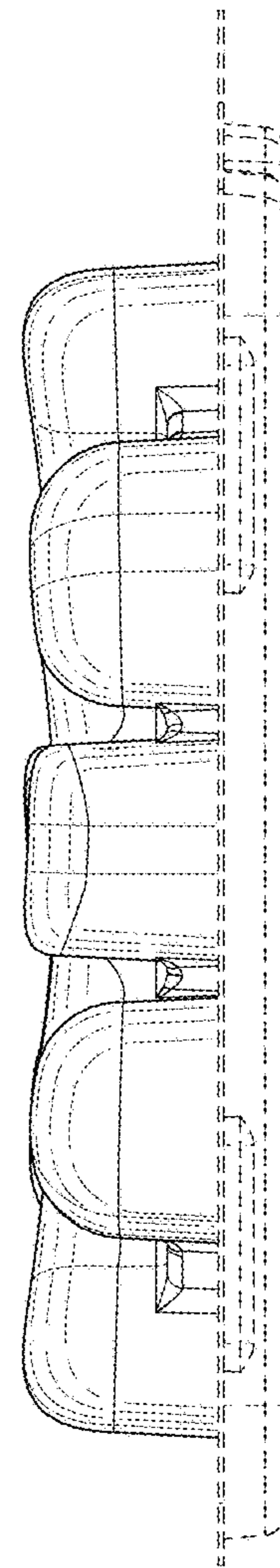

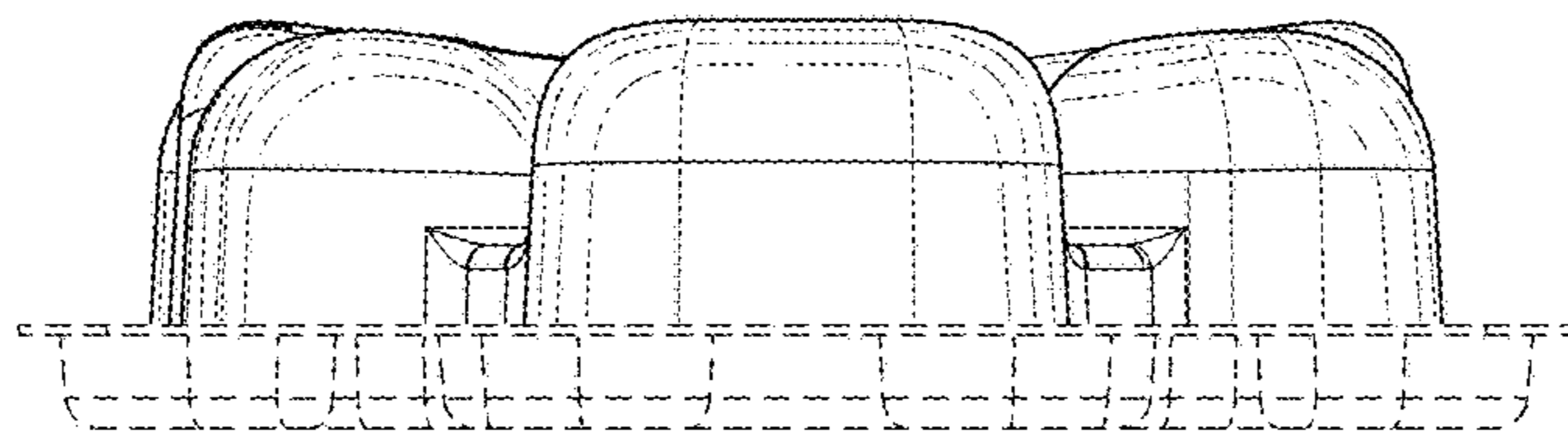

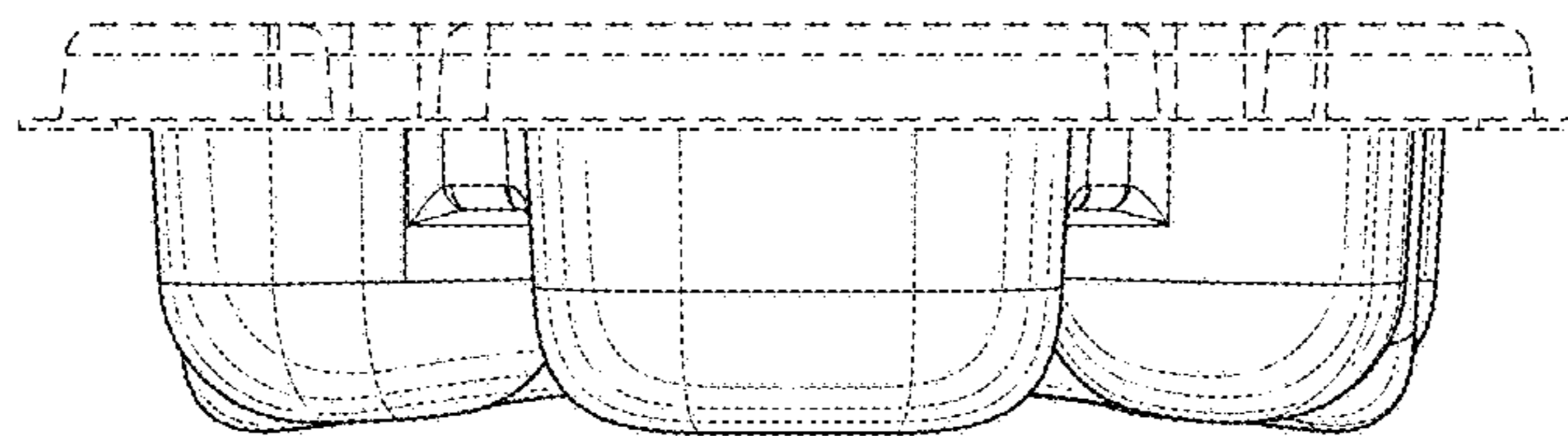
