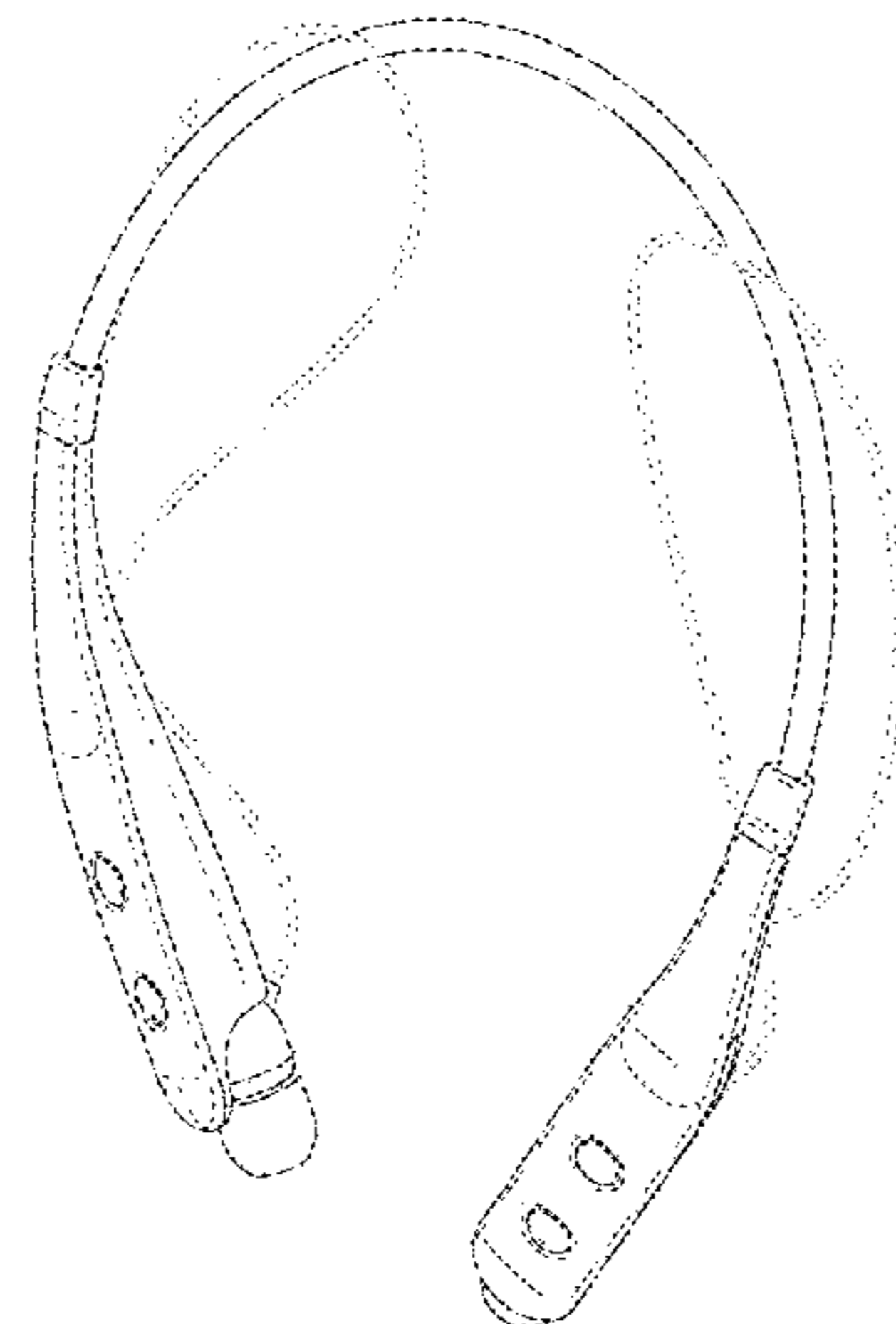
The ornamental design for a wireless headset, as shown and described.

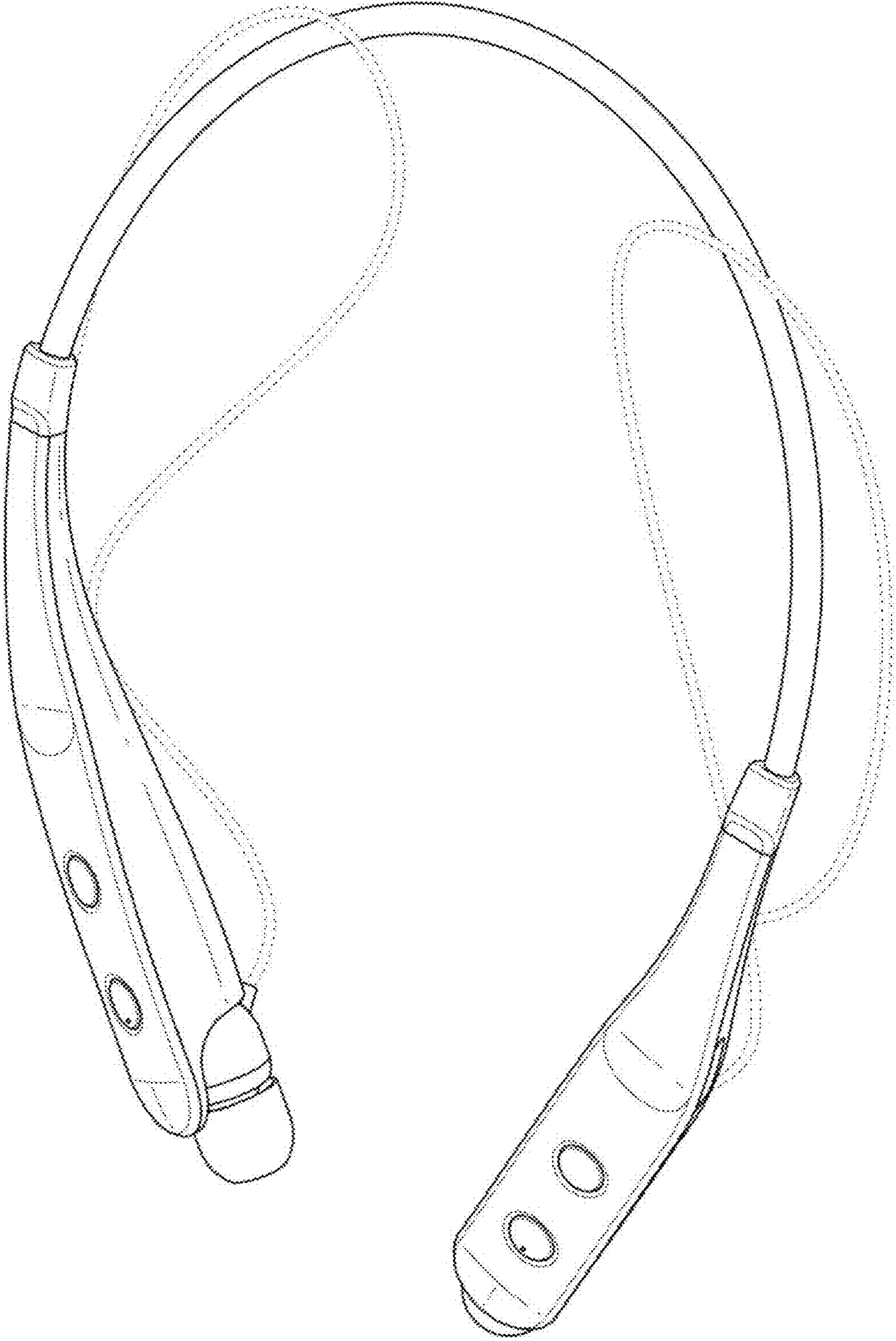

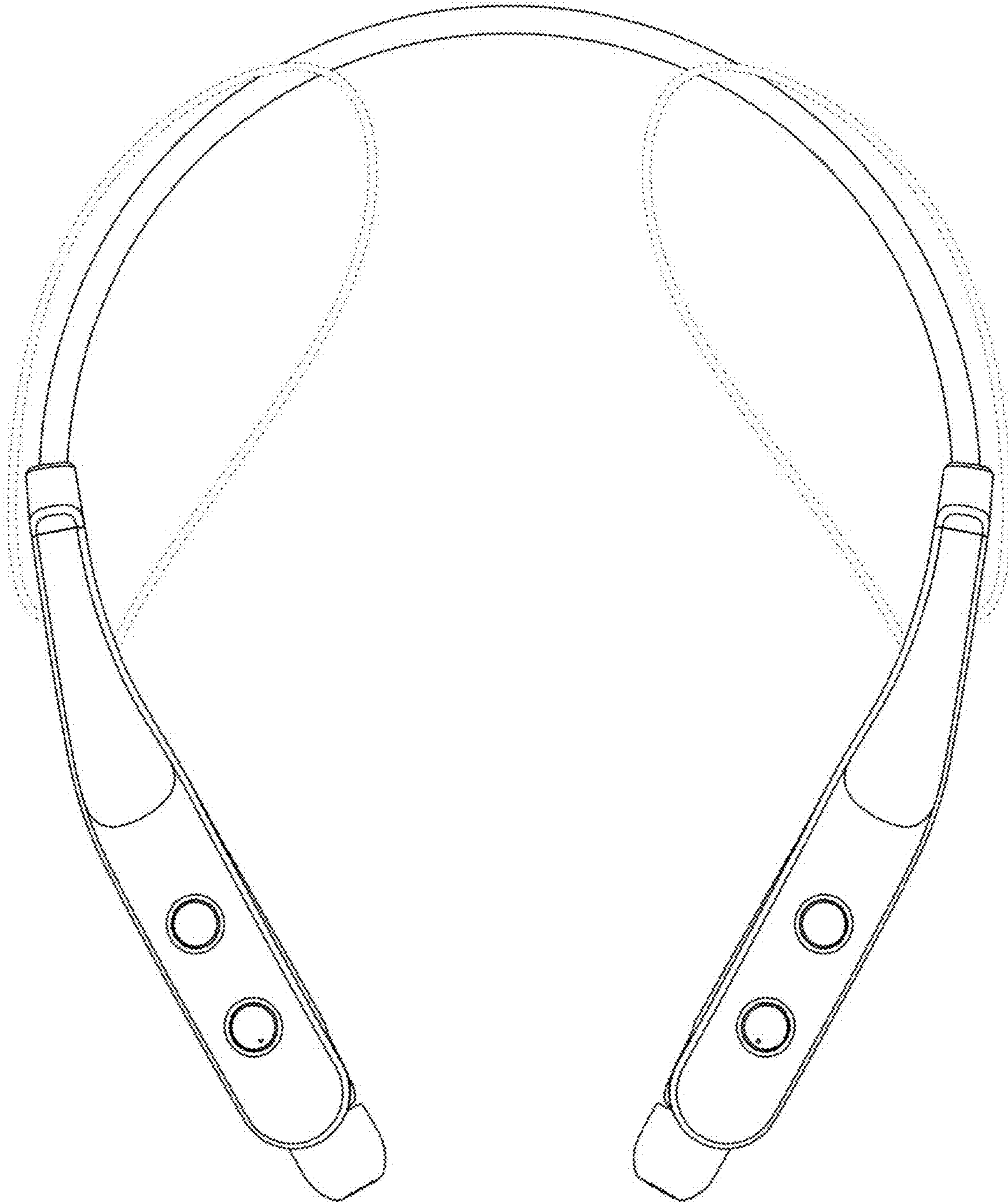

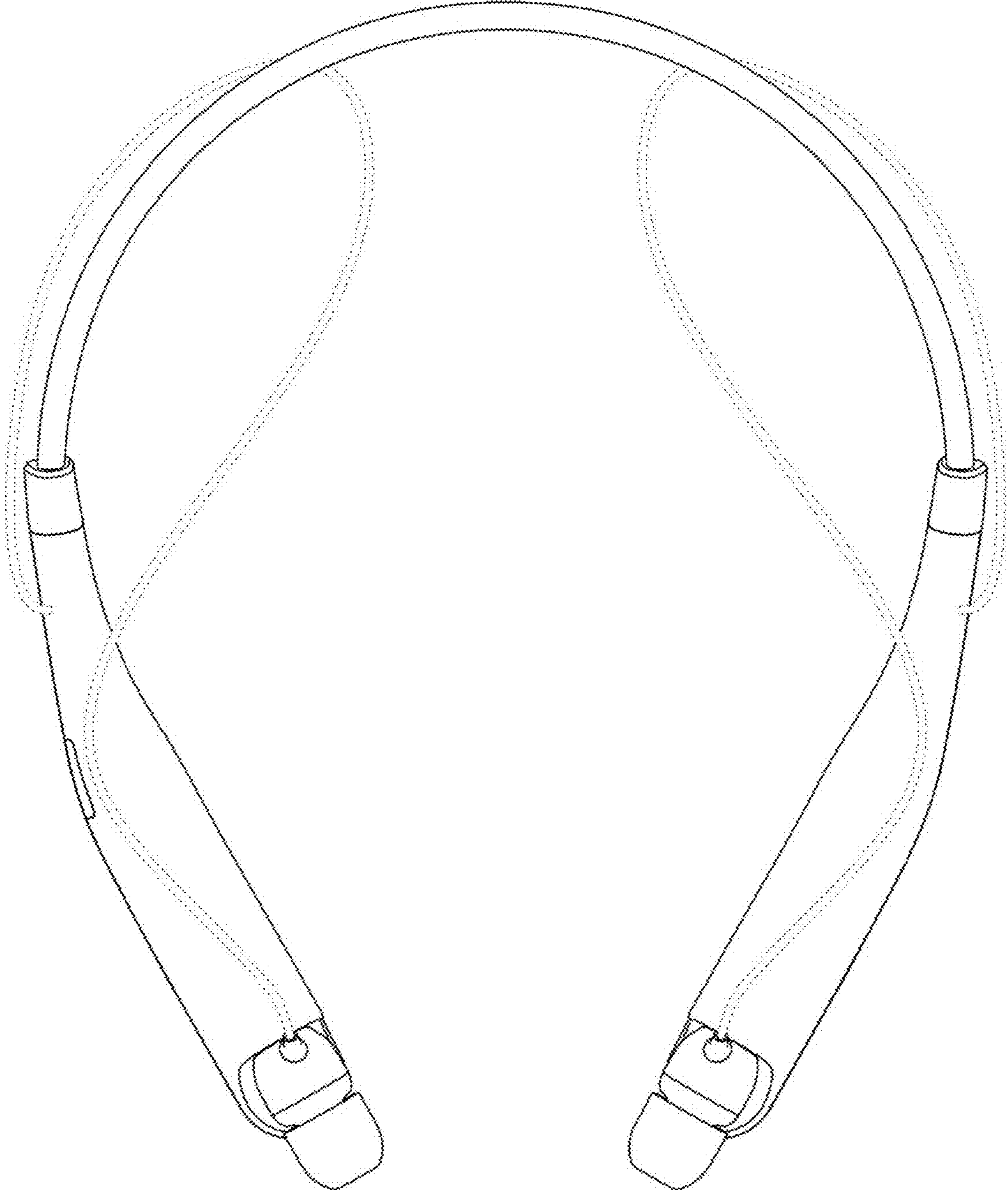

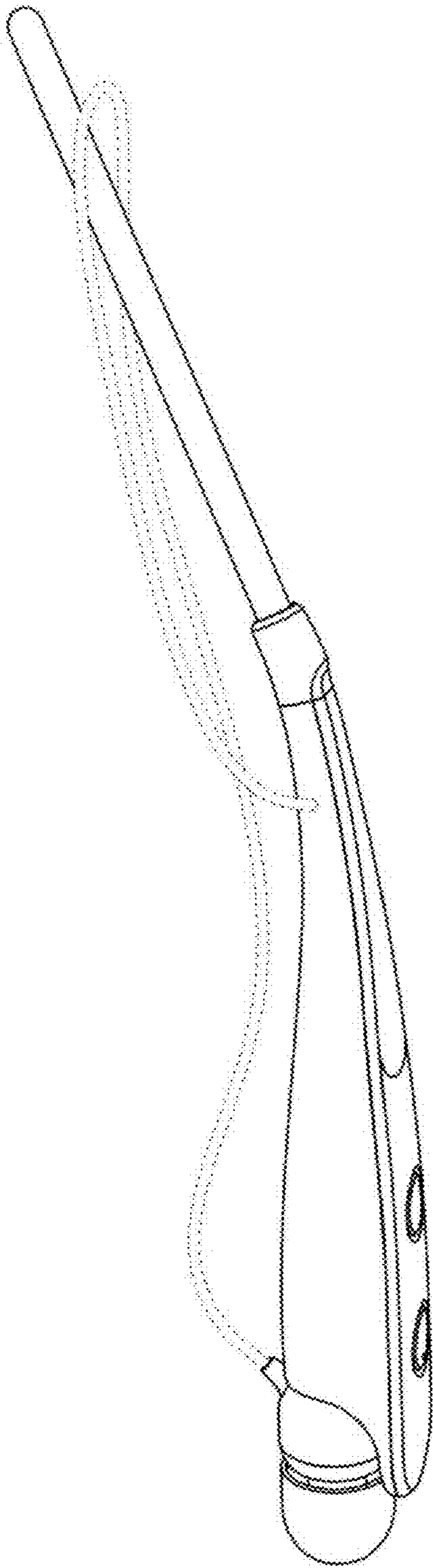

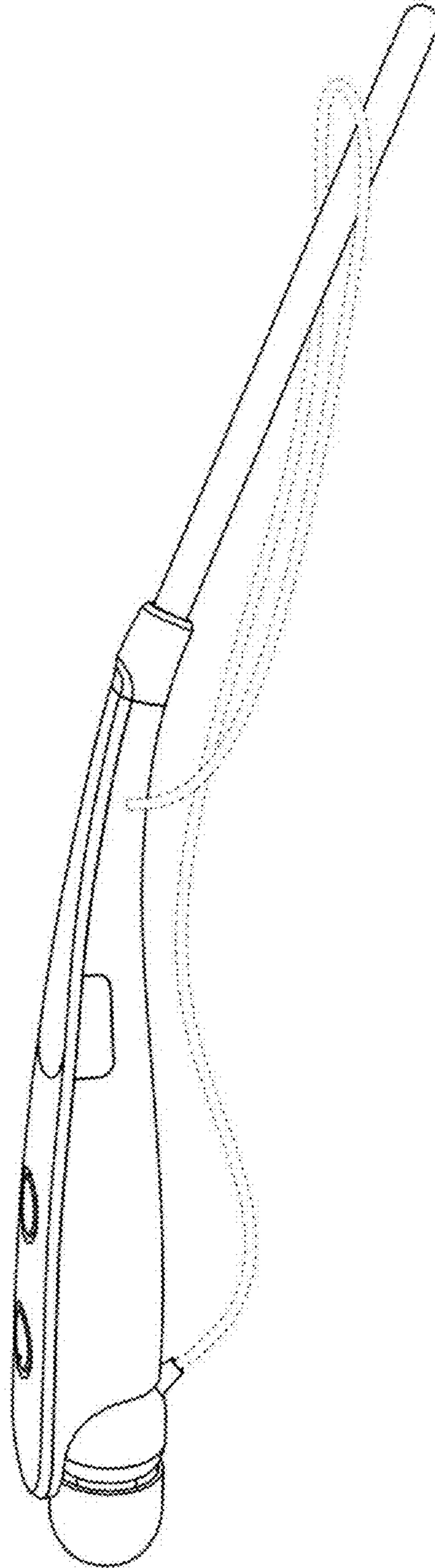

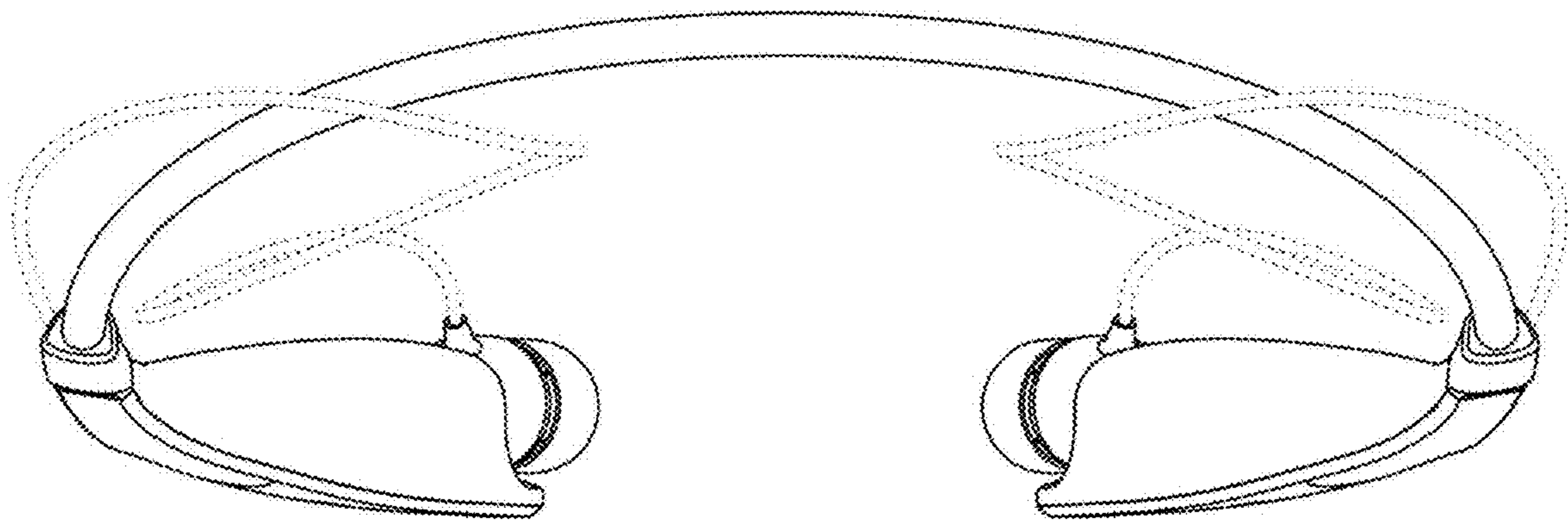
