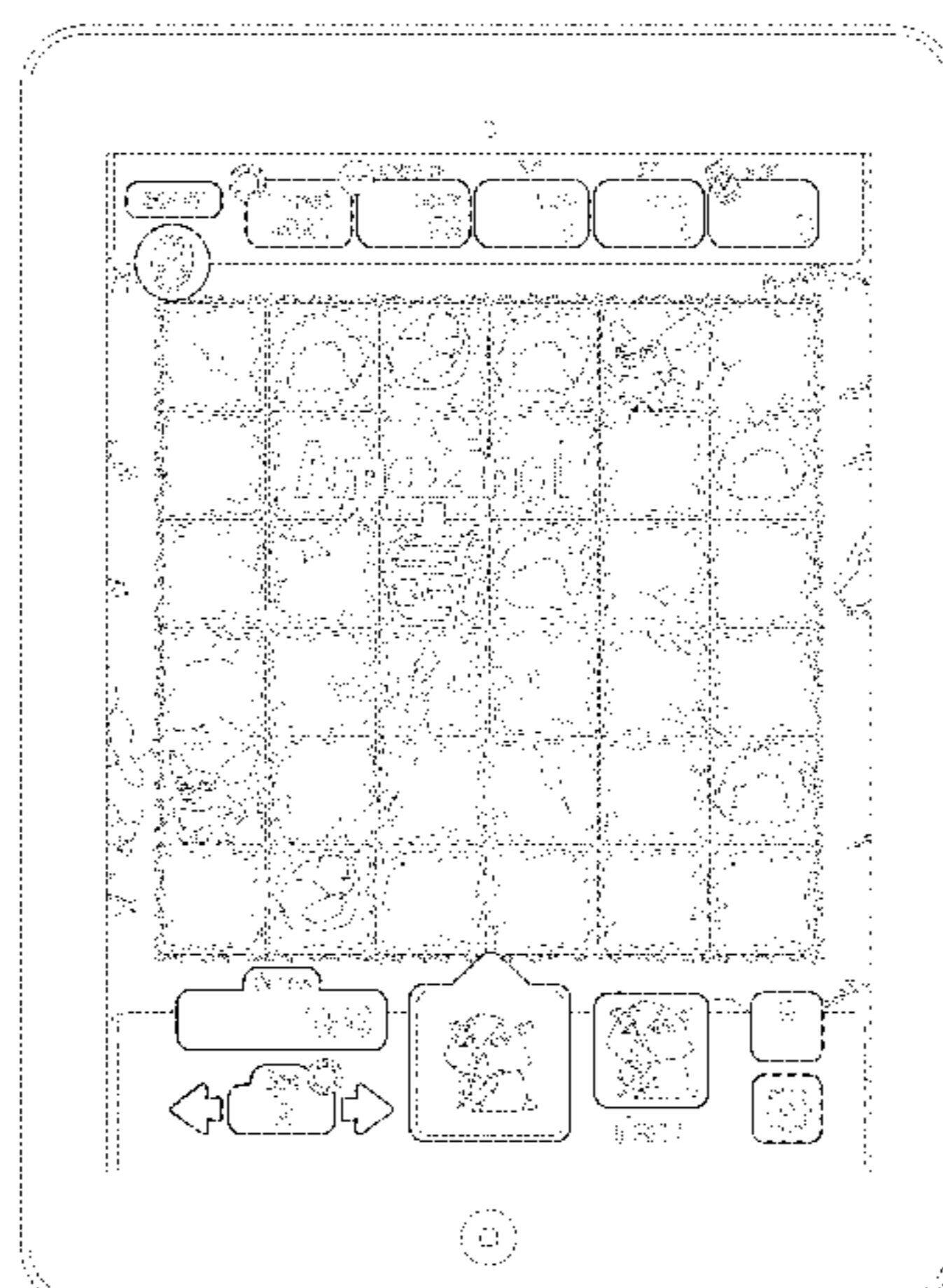


FIG. 12 is another front view of the second embodiment of a display screen with graphical user interface, showing our new design.

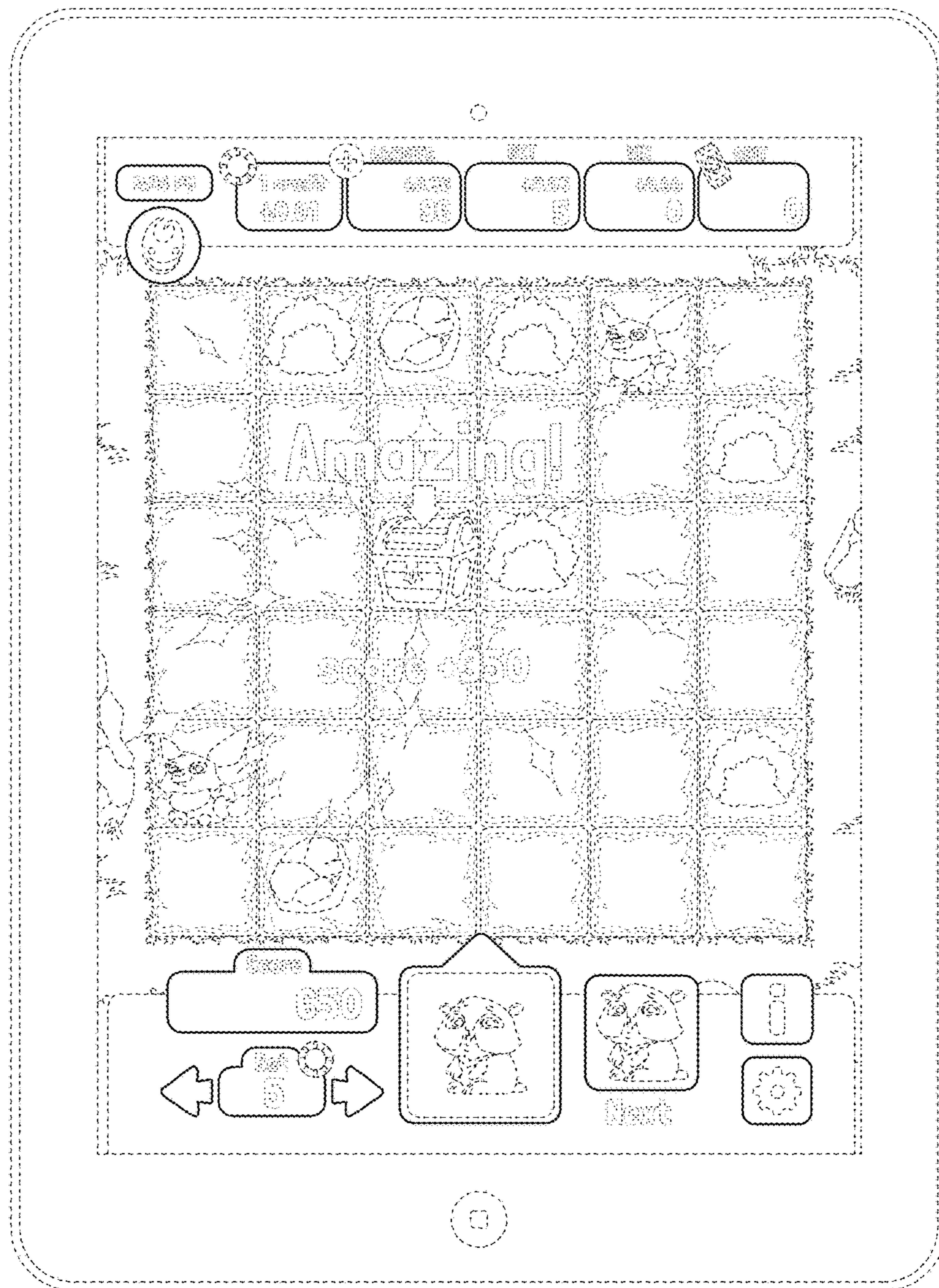

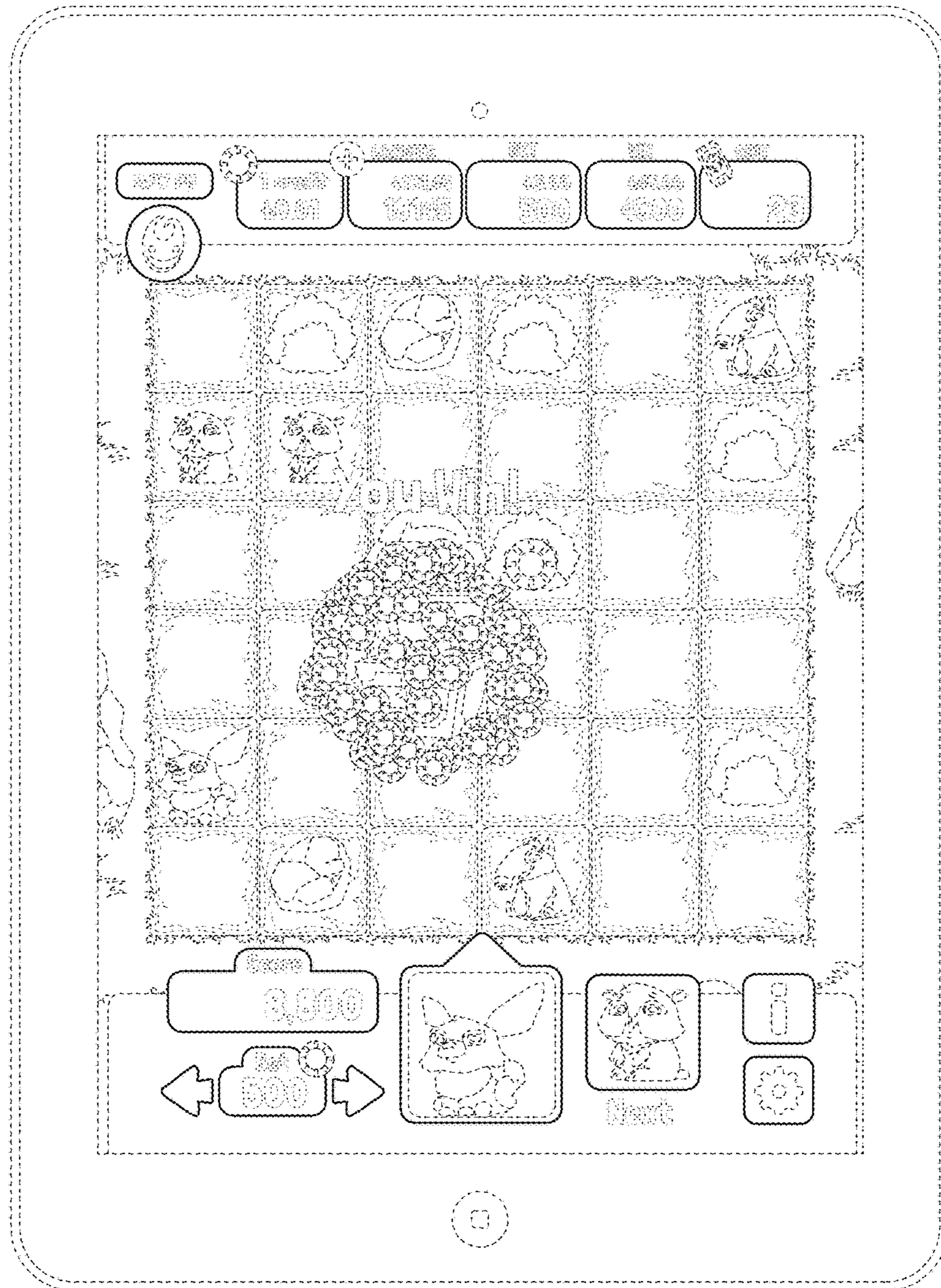

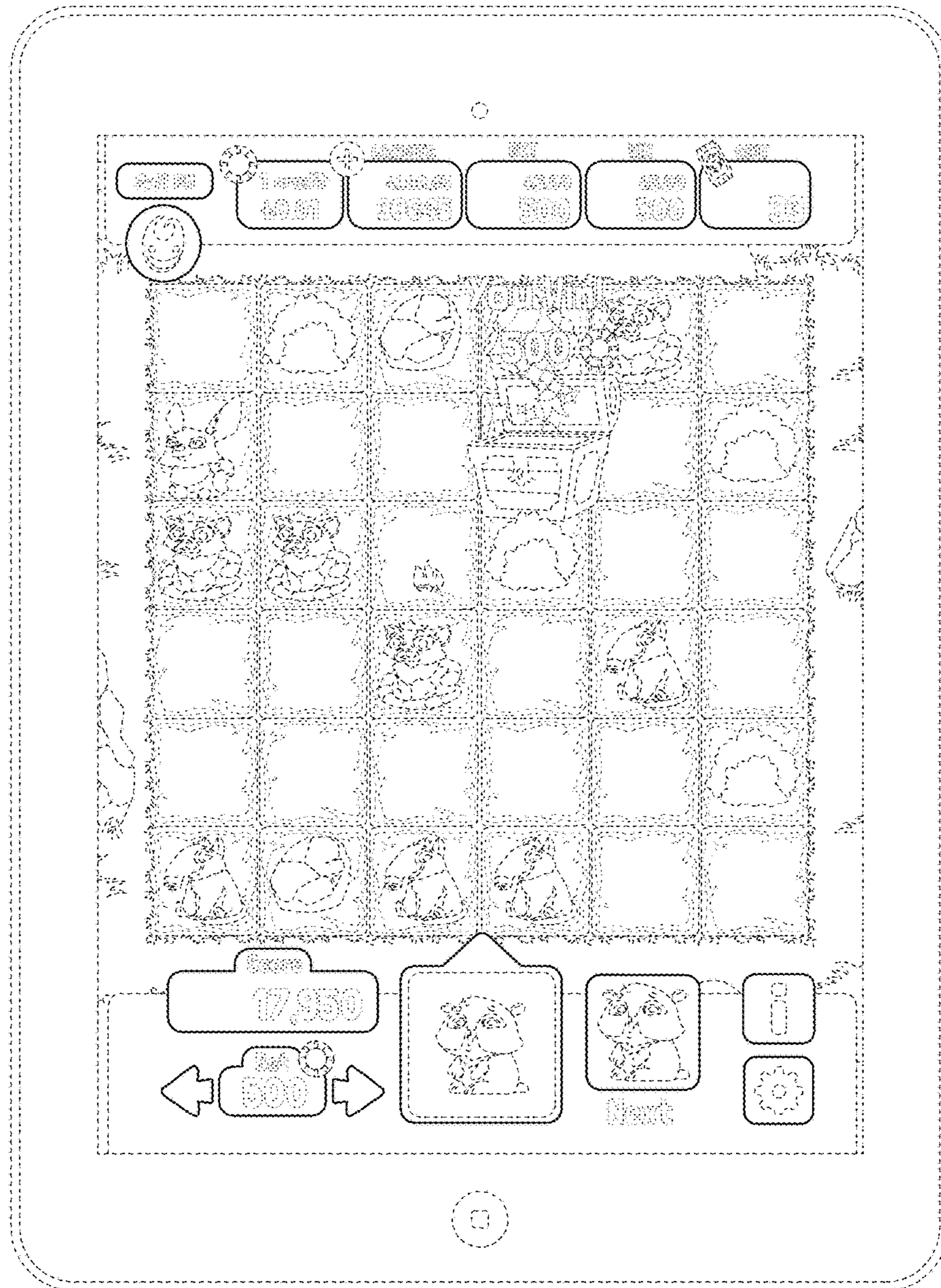

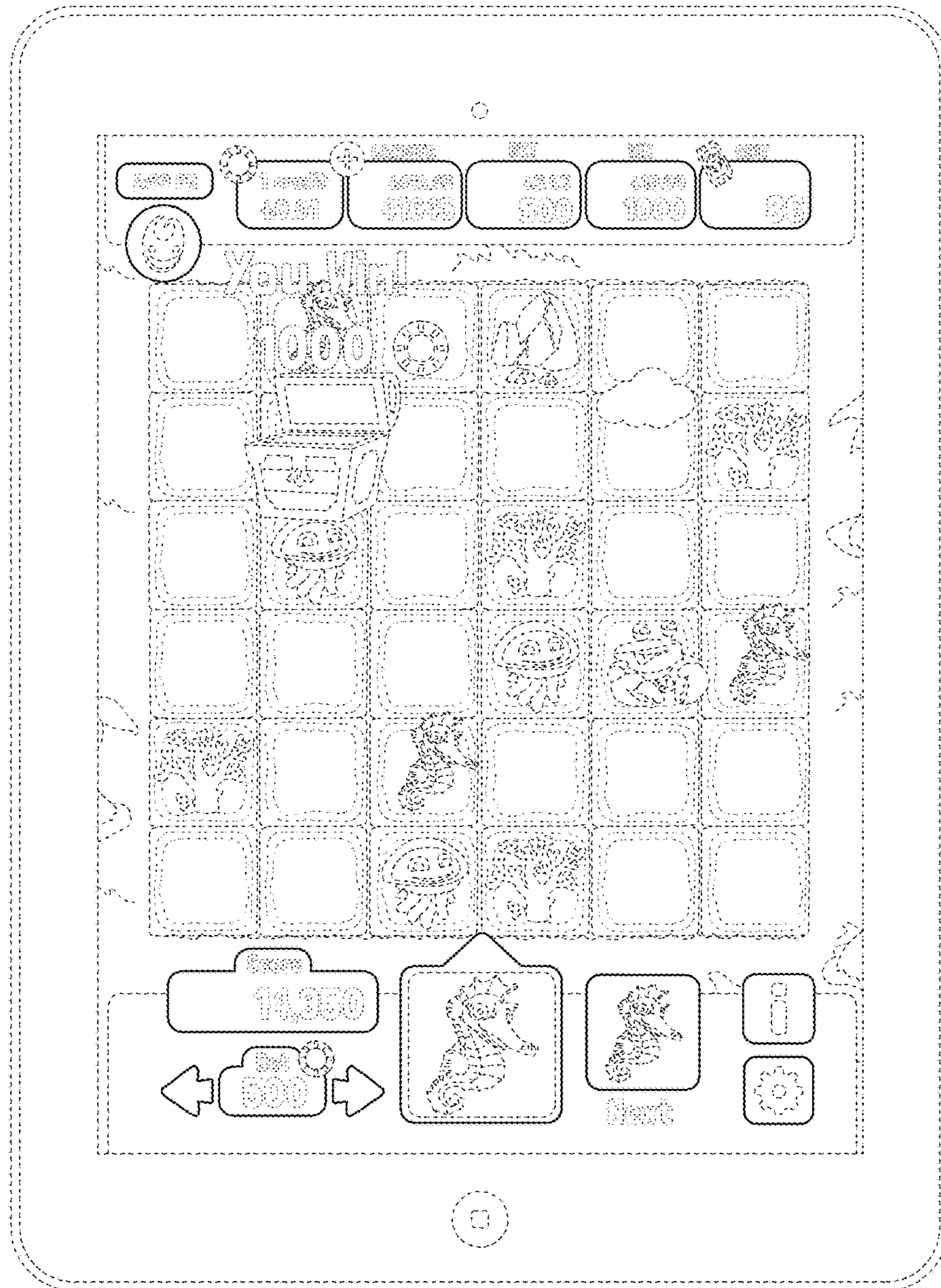

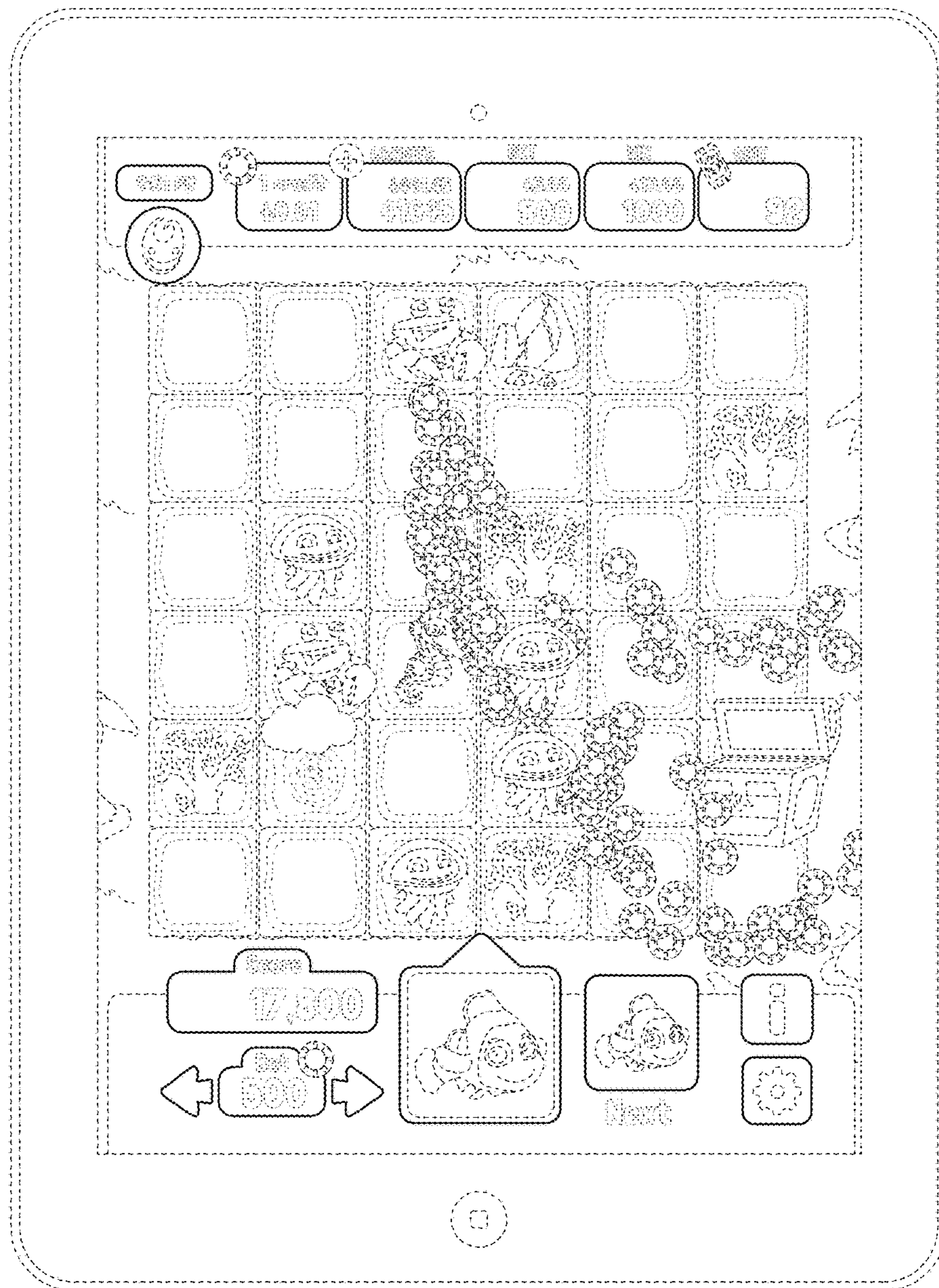

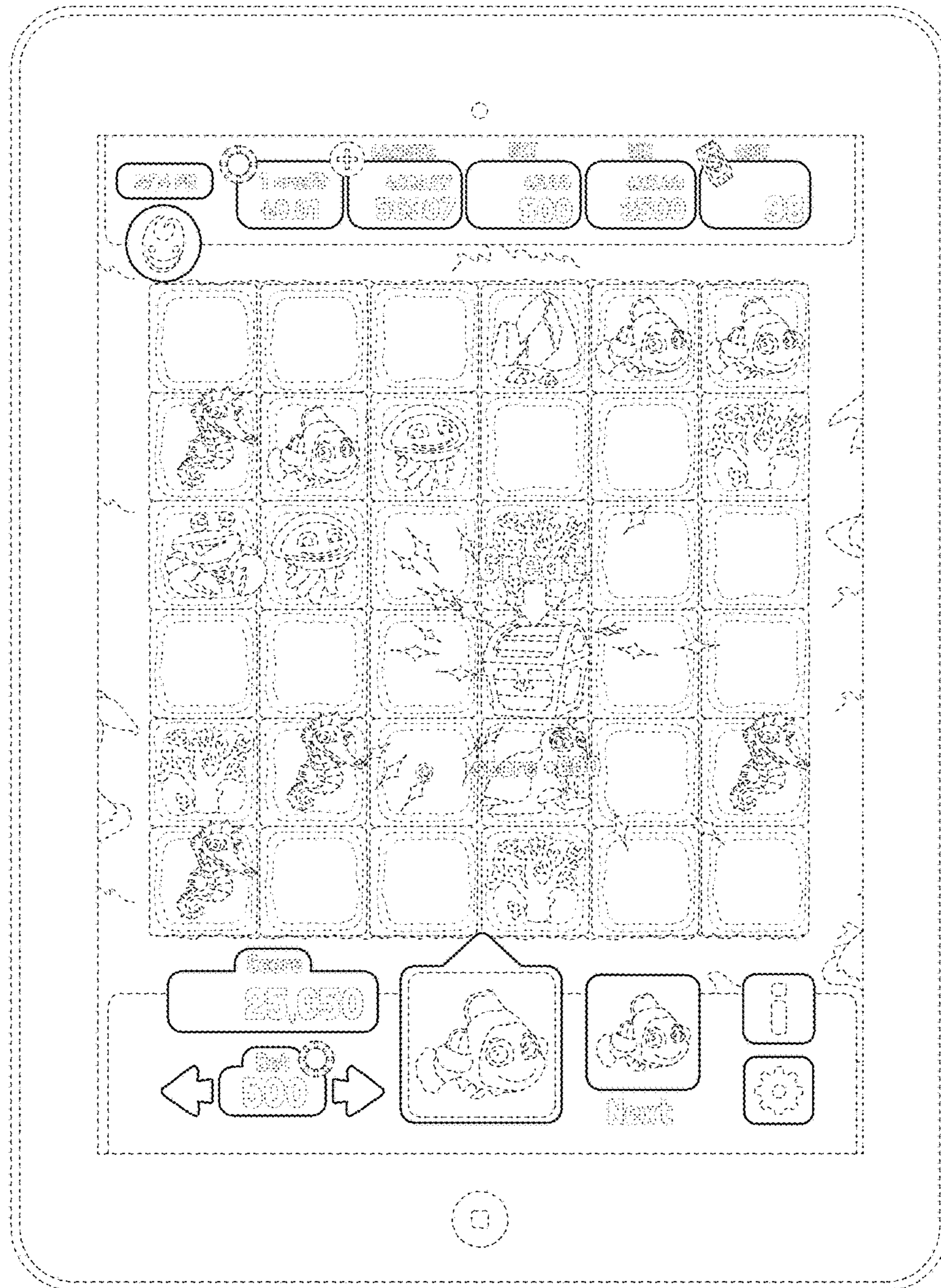

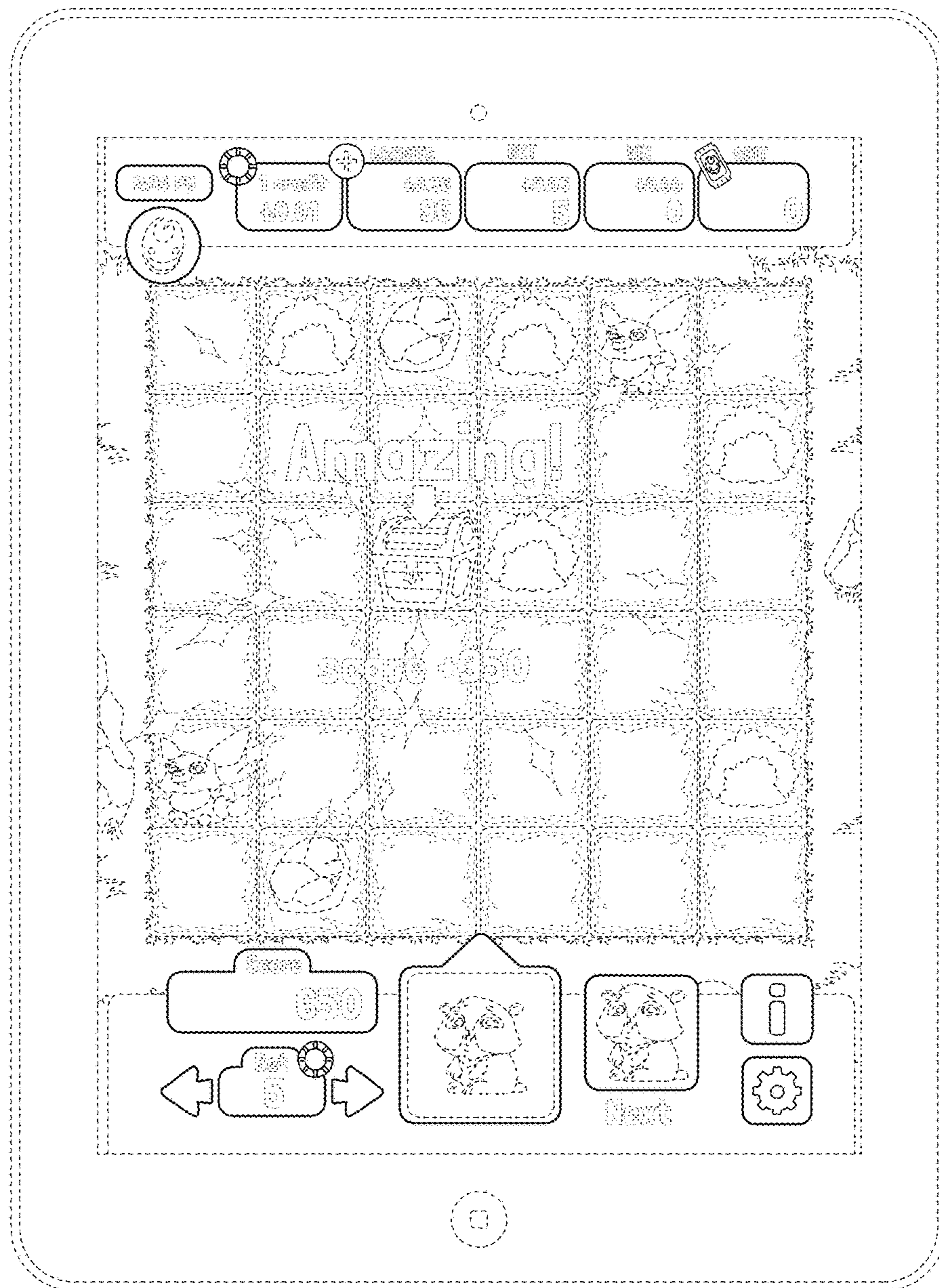

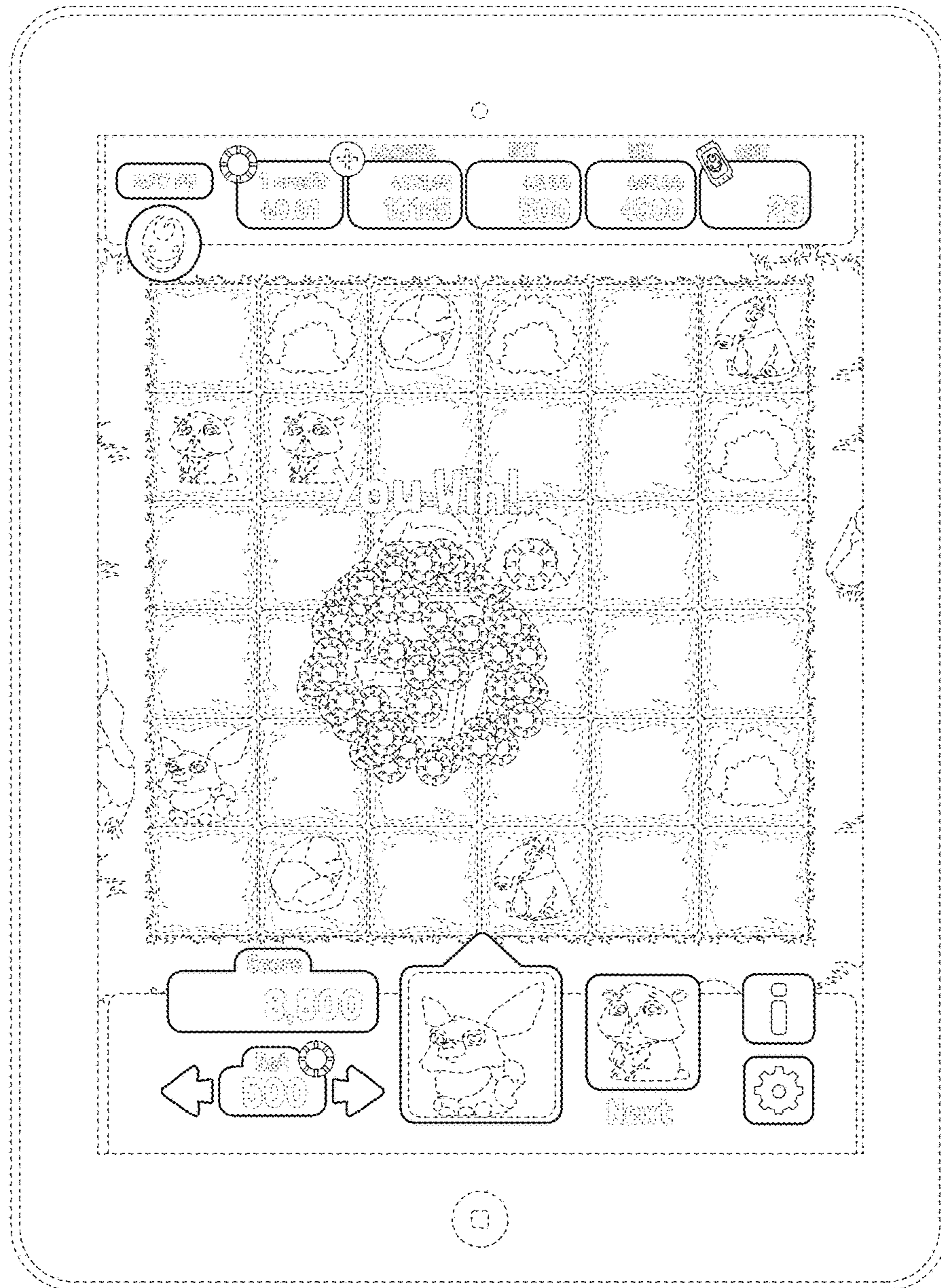

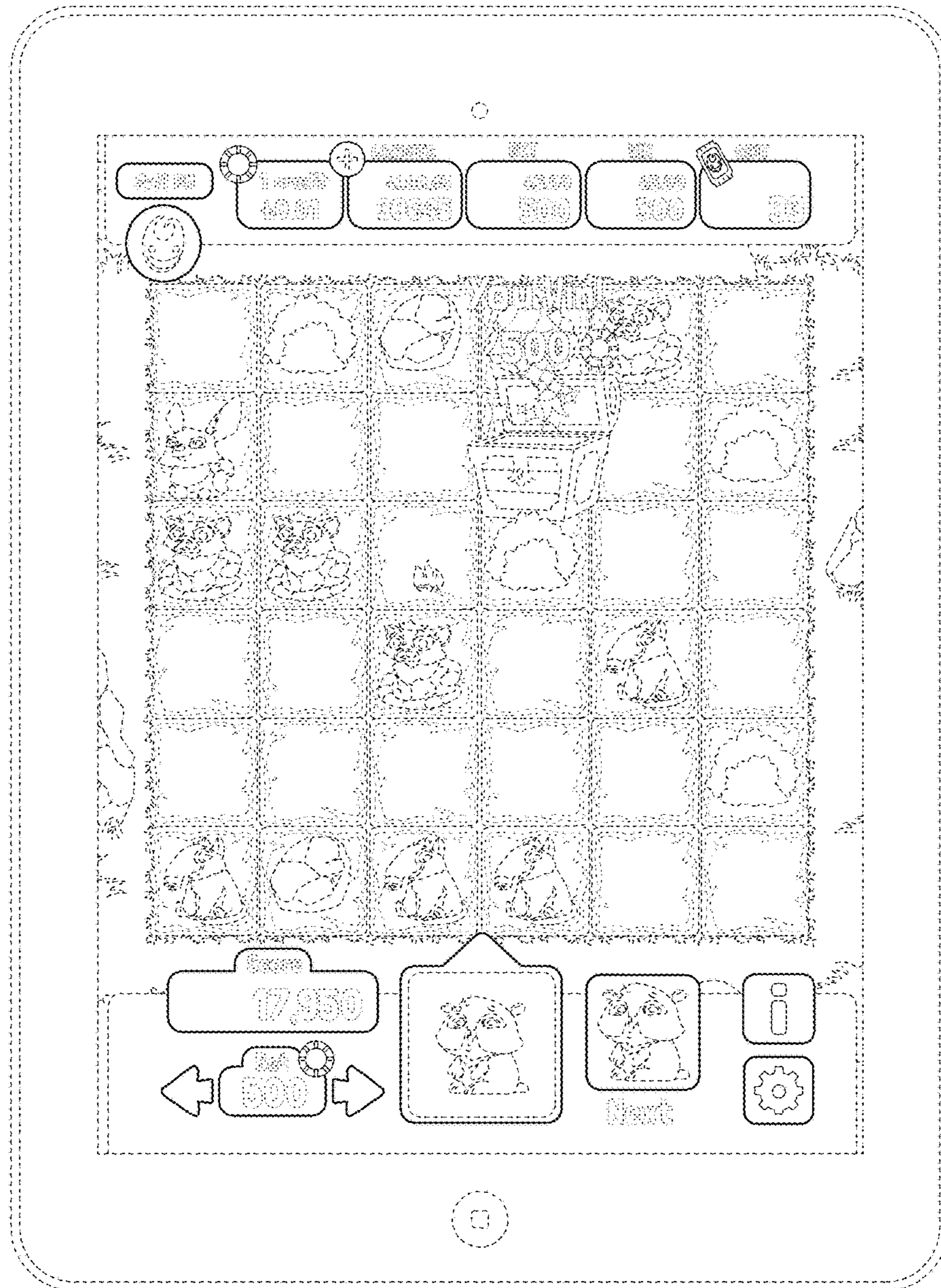

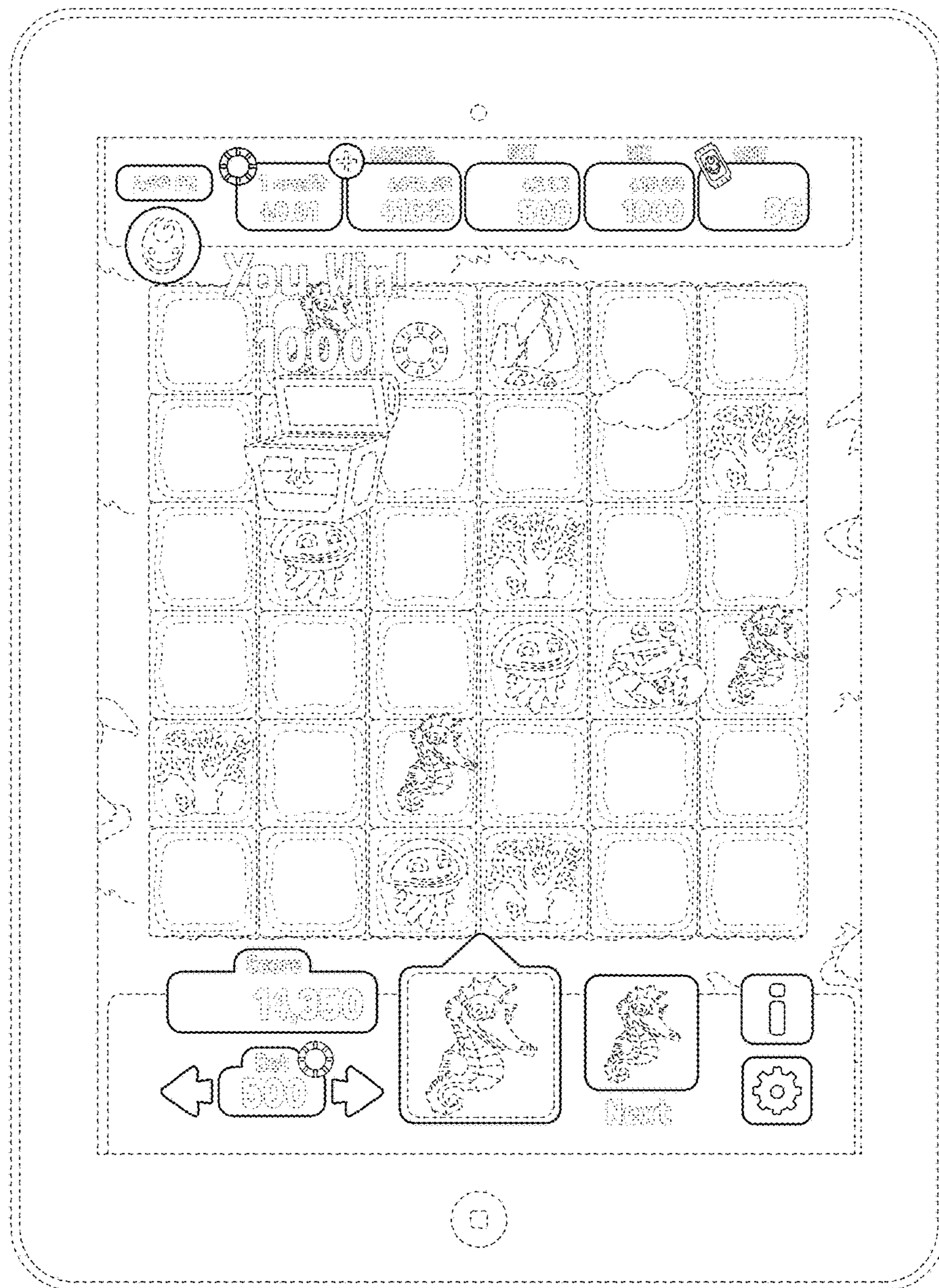

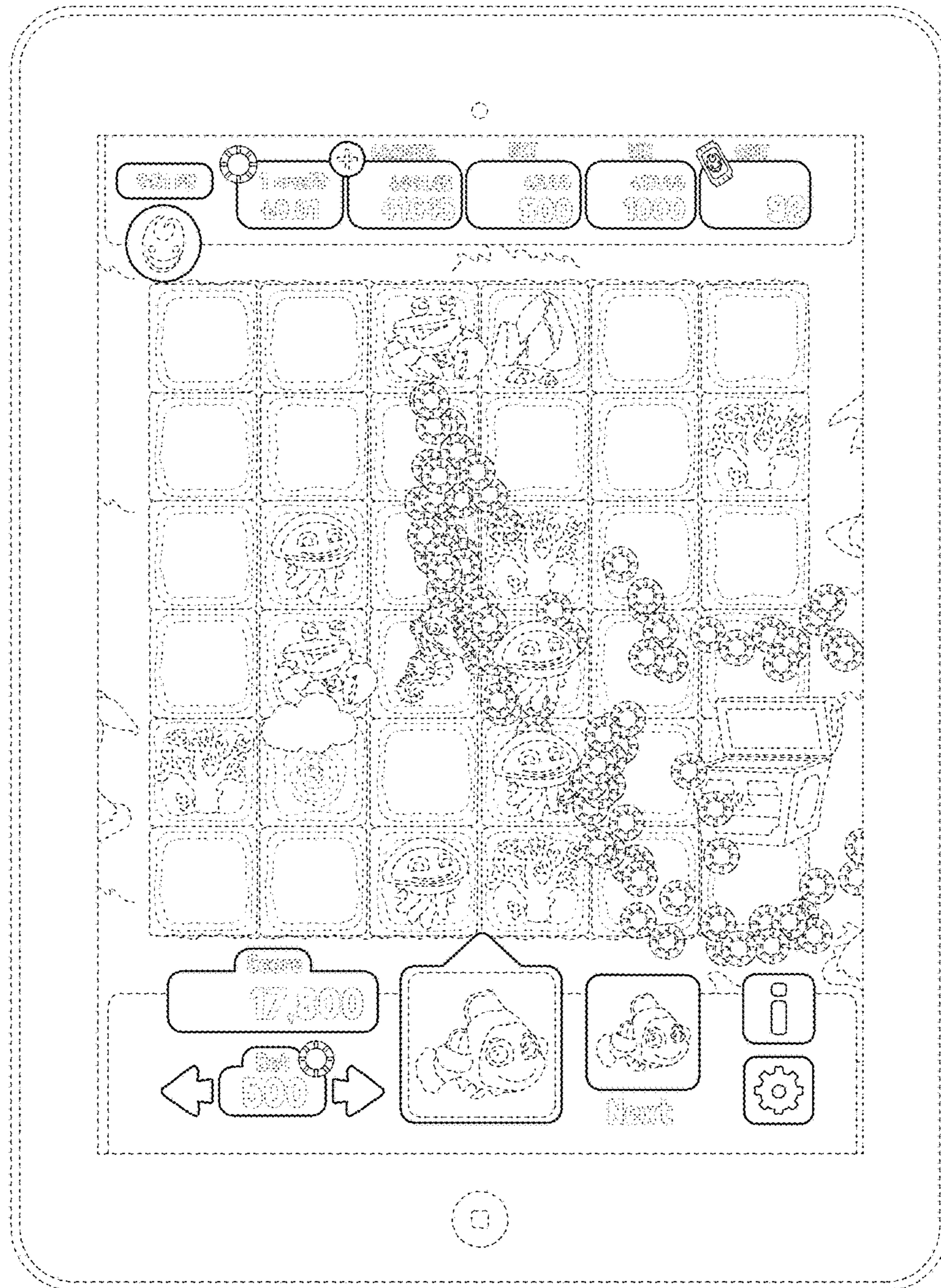

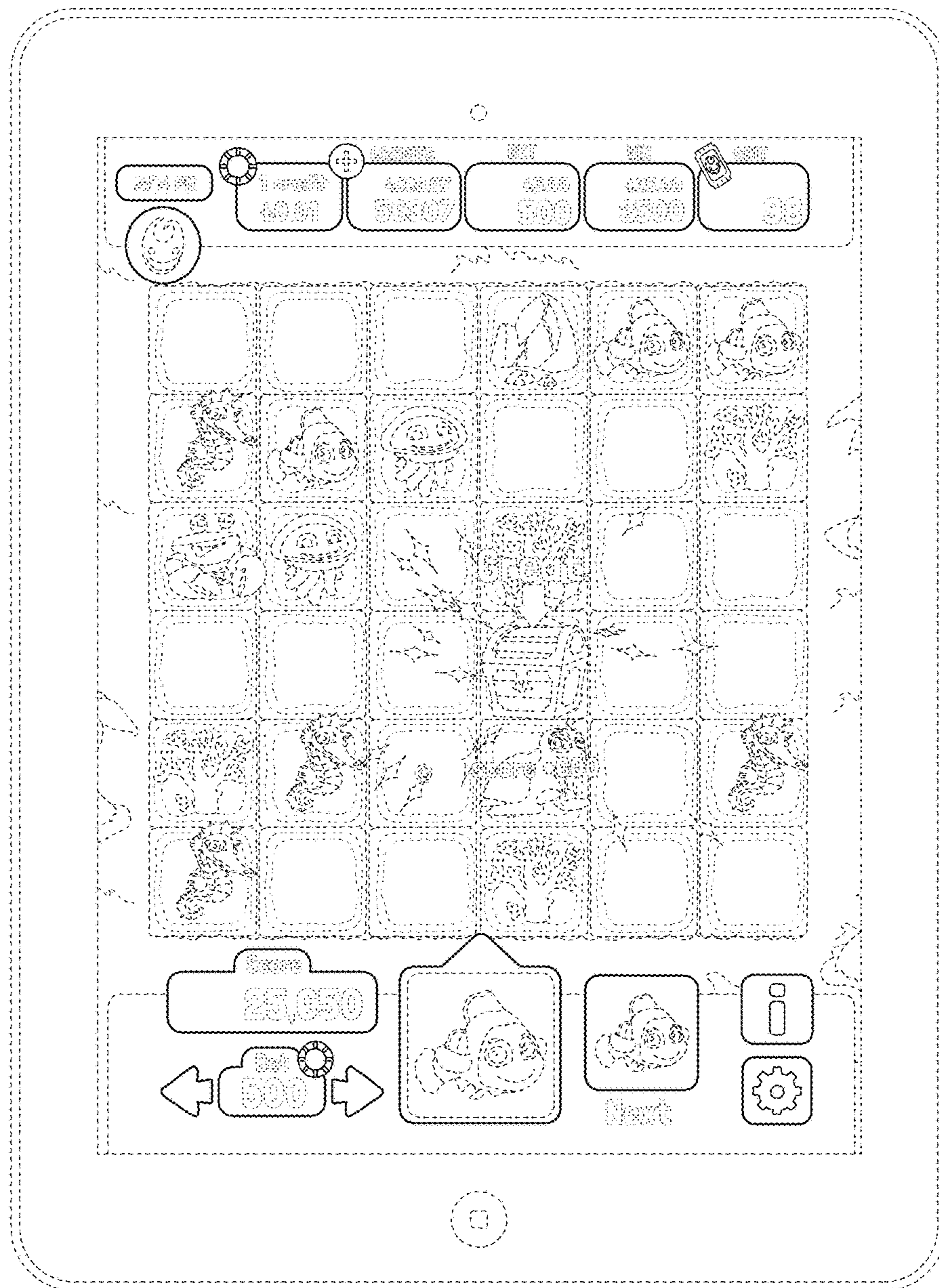
