**DESCRIPTION**

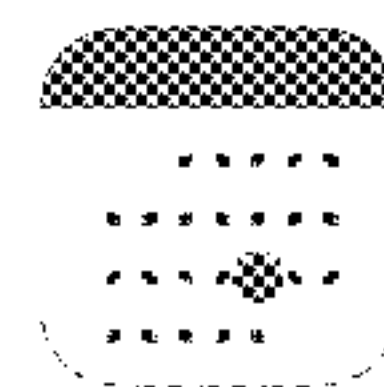
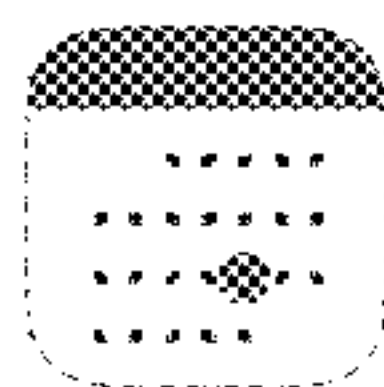

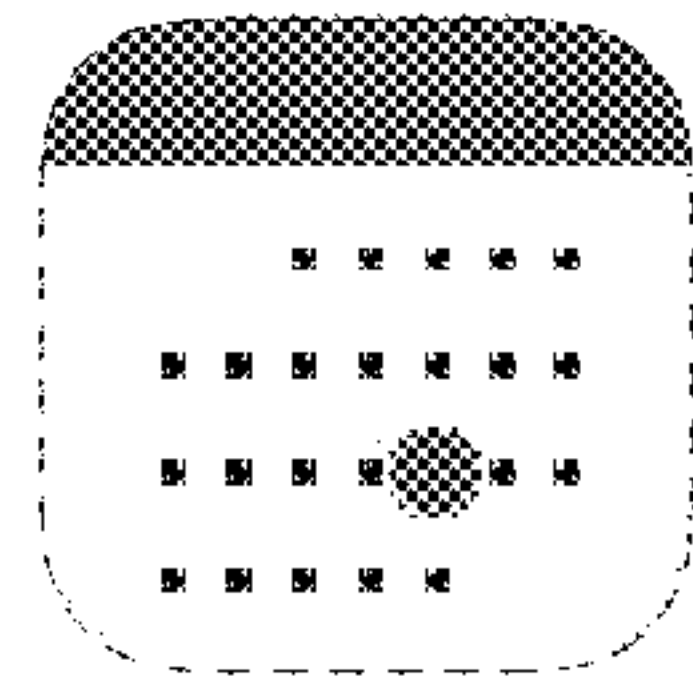

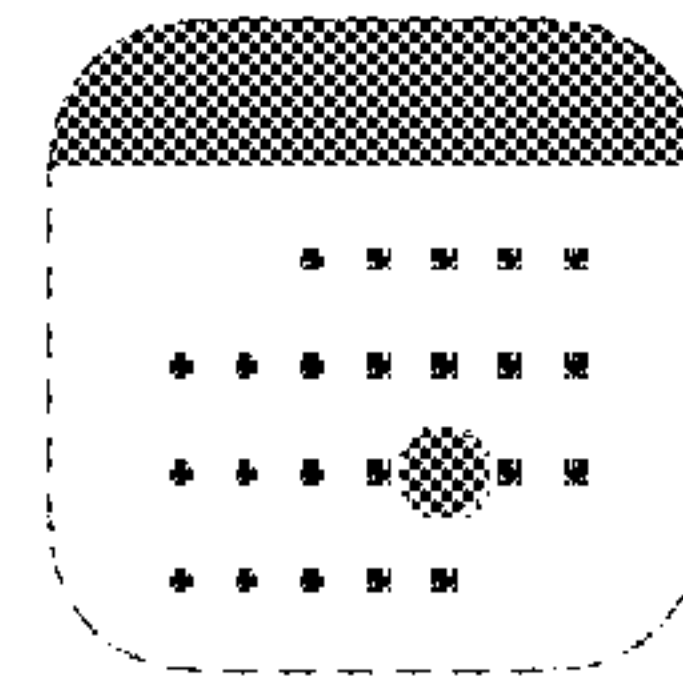
