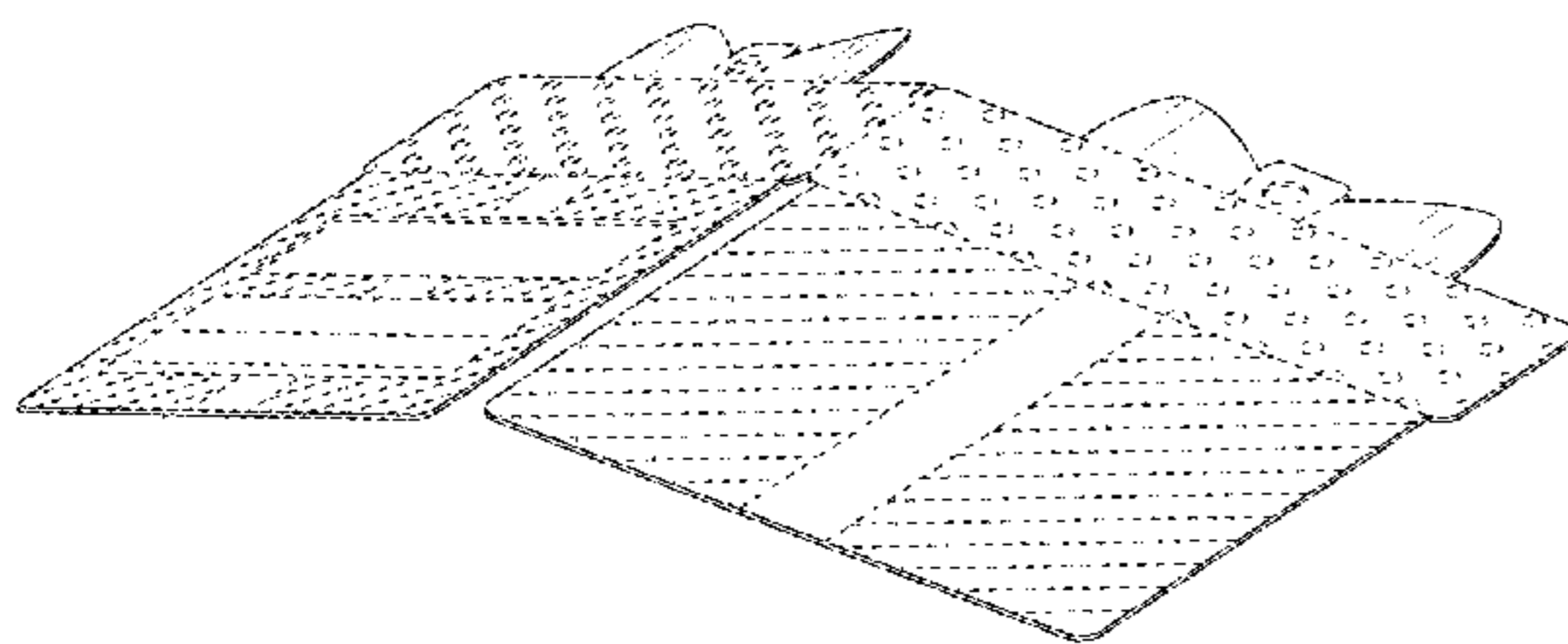

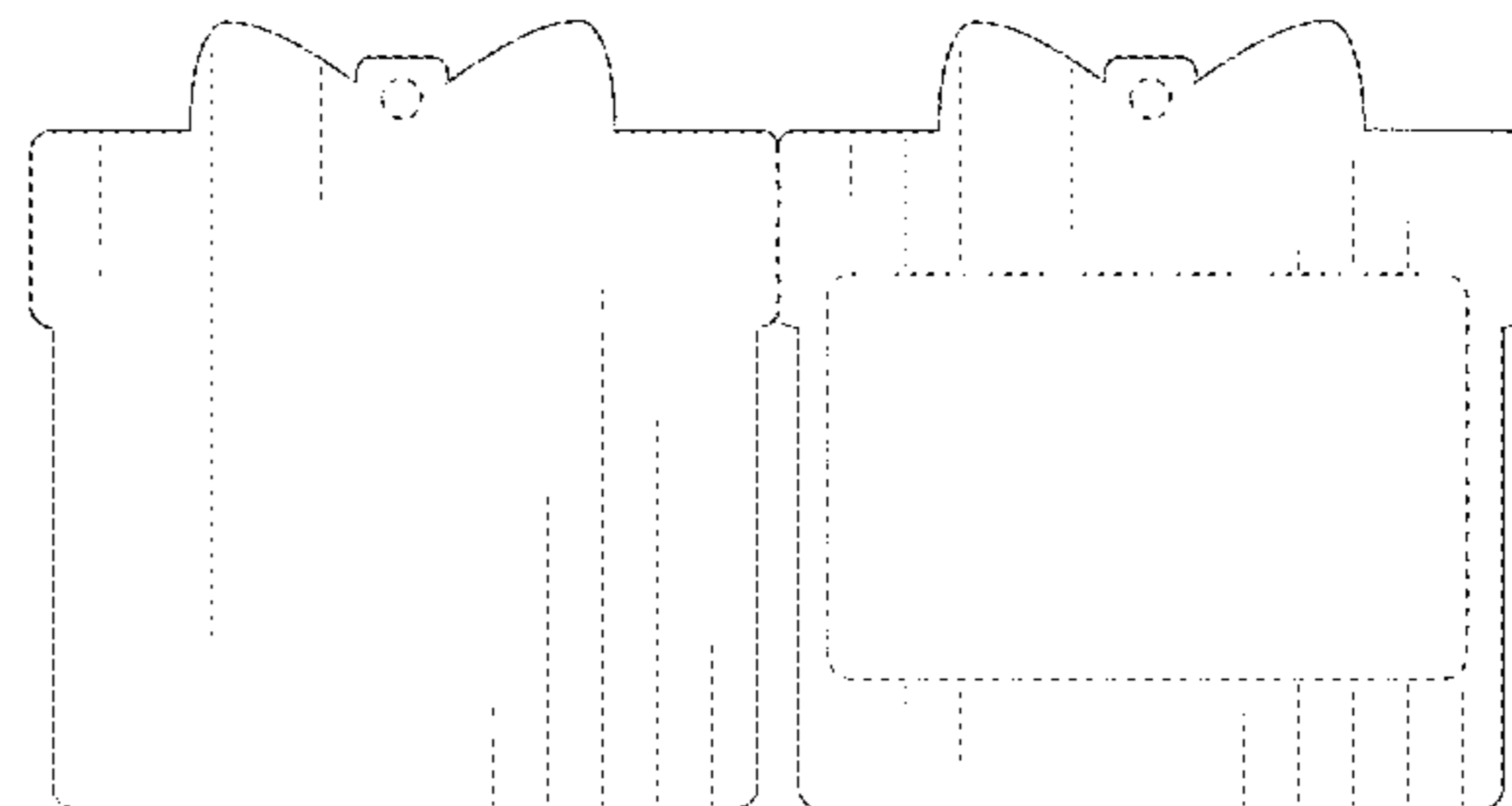
(57) **CLAIM**

The ornamental design for a card holder, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a card holder in a partially closed position, taken from the front.
FIG. 2 is a second perspective view of the card holder in the partially closed position, taken from the back.
FIG. 3 is a front view of the card holder of FIG. 1 shown in an opened position.
FIG. 4 is a first back view of the card holder of FIG. 1 shown in the opened position.
FIG. 5 is a left-side view of the card holder of FIG. 1 shown in the opened position.
FIG. 6 is a right-side view of the card holder of FIG. 1 shown in the opened position.
FIG. 7 is a top view of the card holder of FIG. 1 shown in the opened position.
FIG. 8 is a bottom view of the card holder of FIG. 1 shown in the opened position; and,
FIG. 9 is a second back view of the card holder of FIG. 1 shown in the opened position with a disclaimed card.

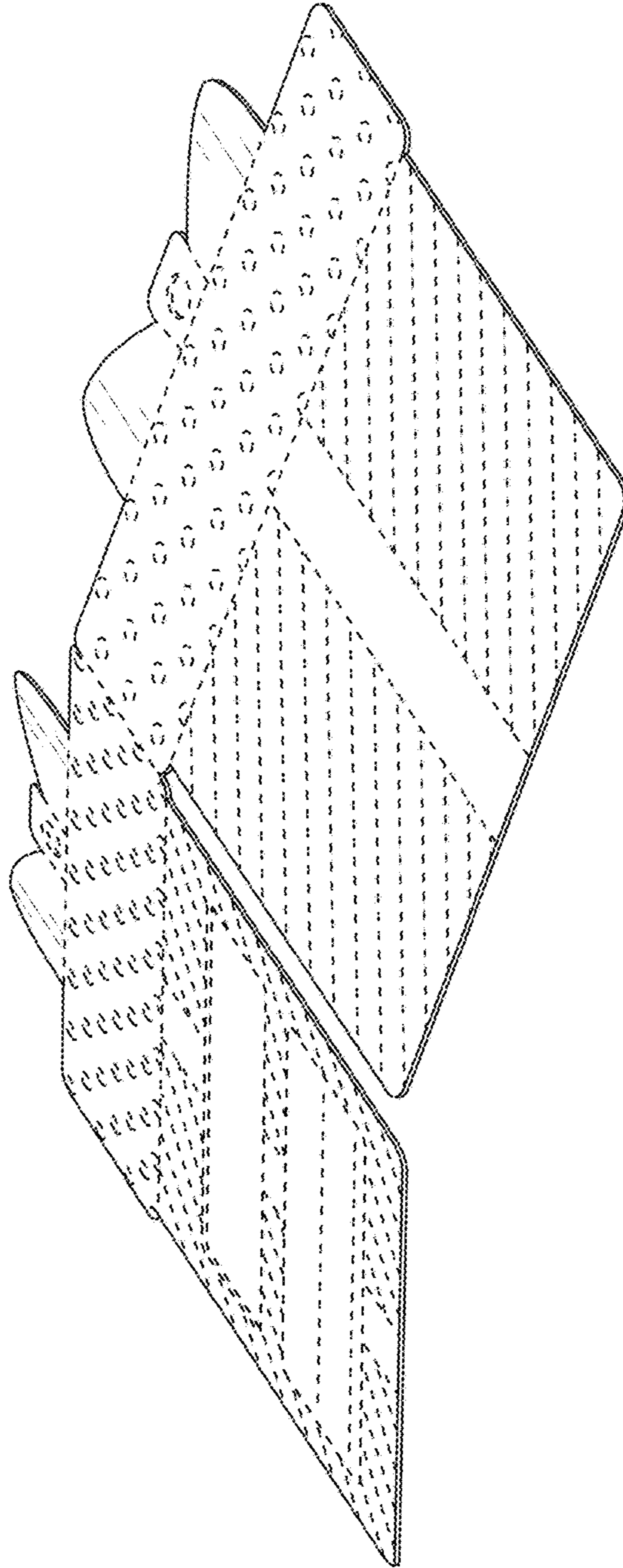

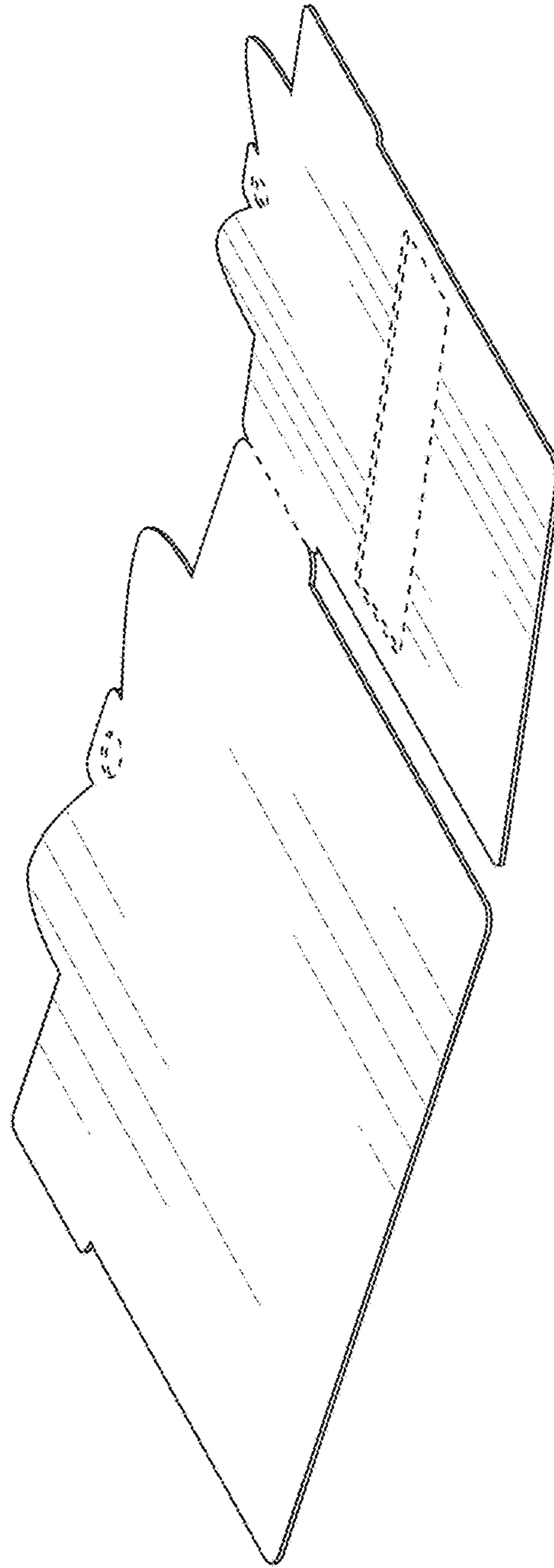

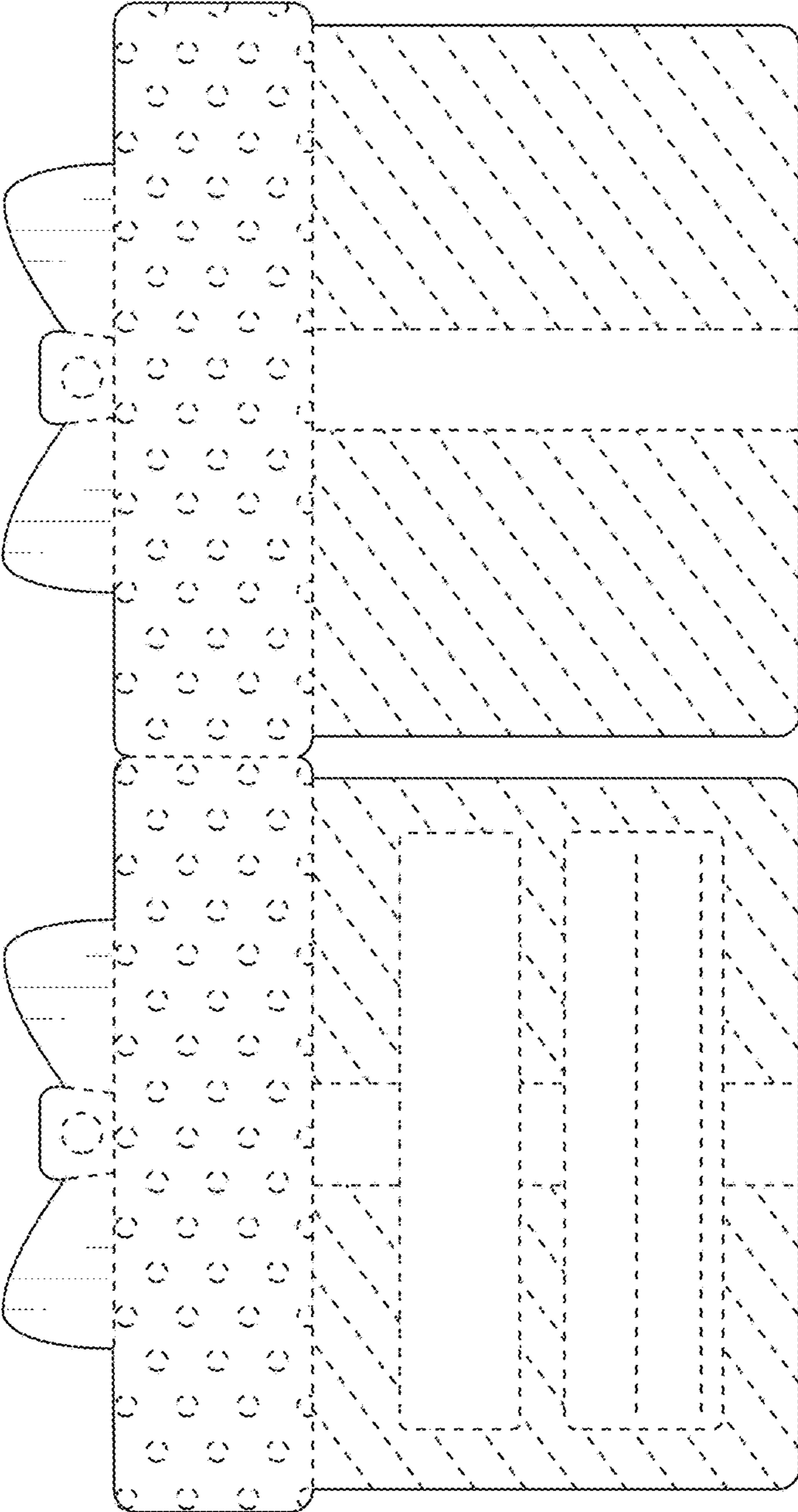

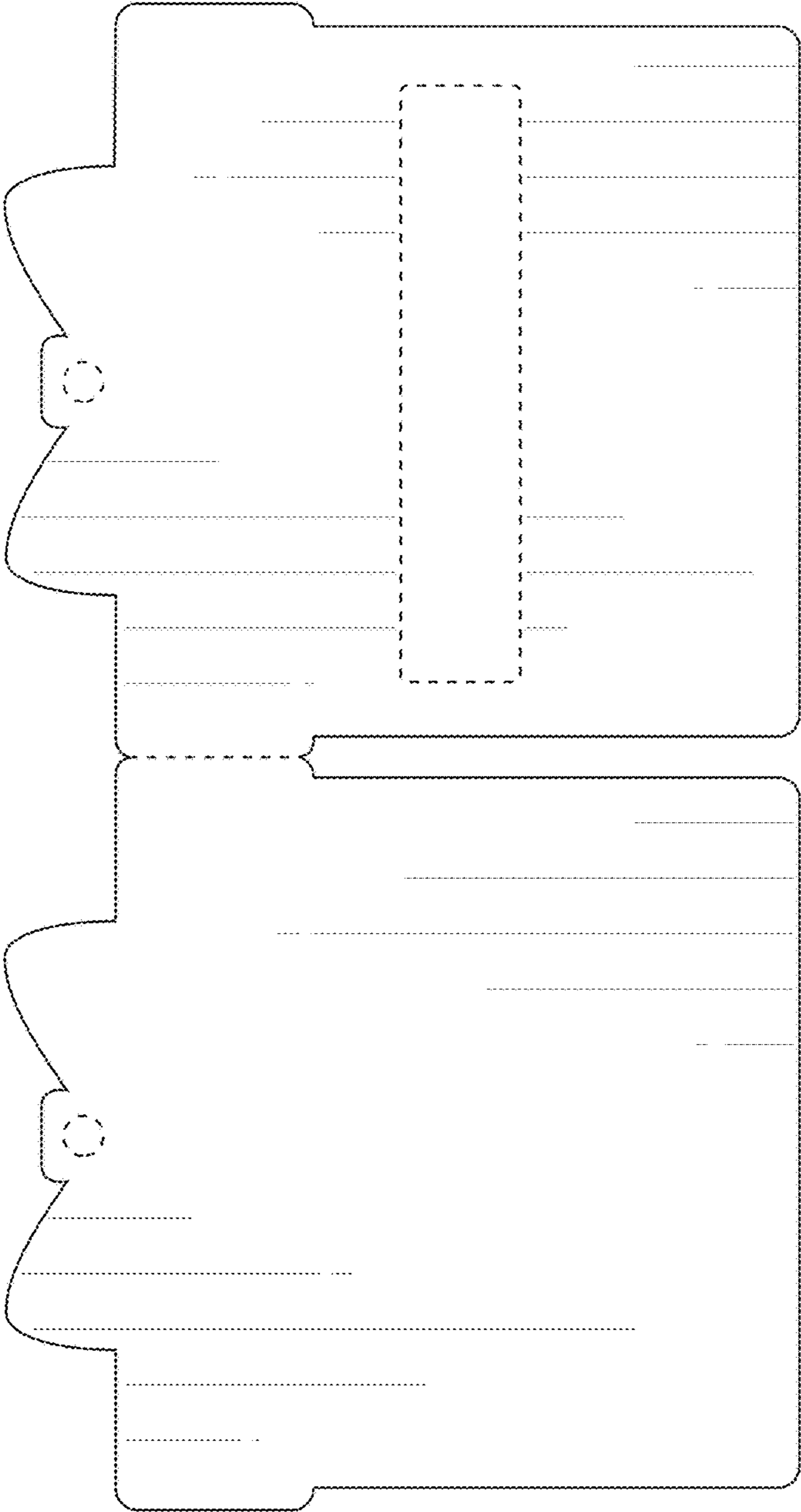

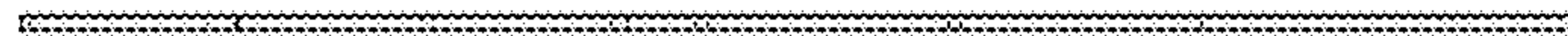

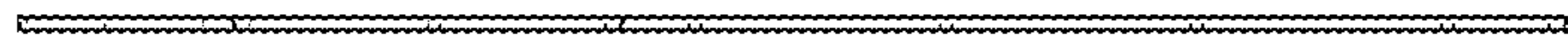

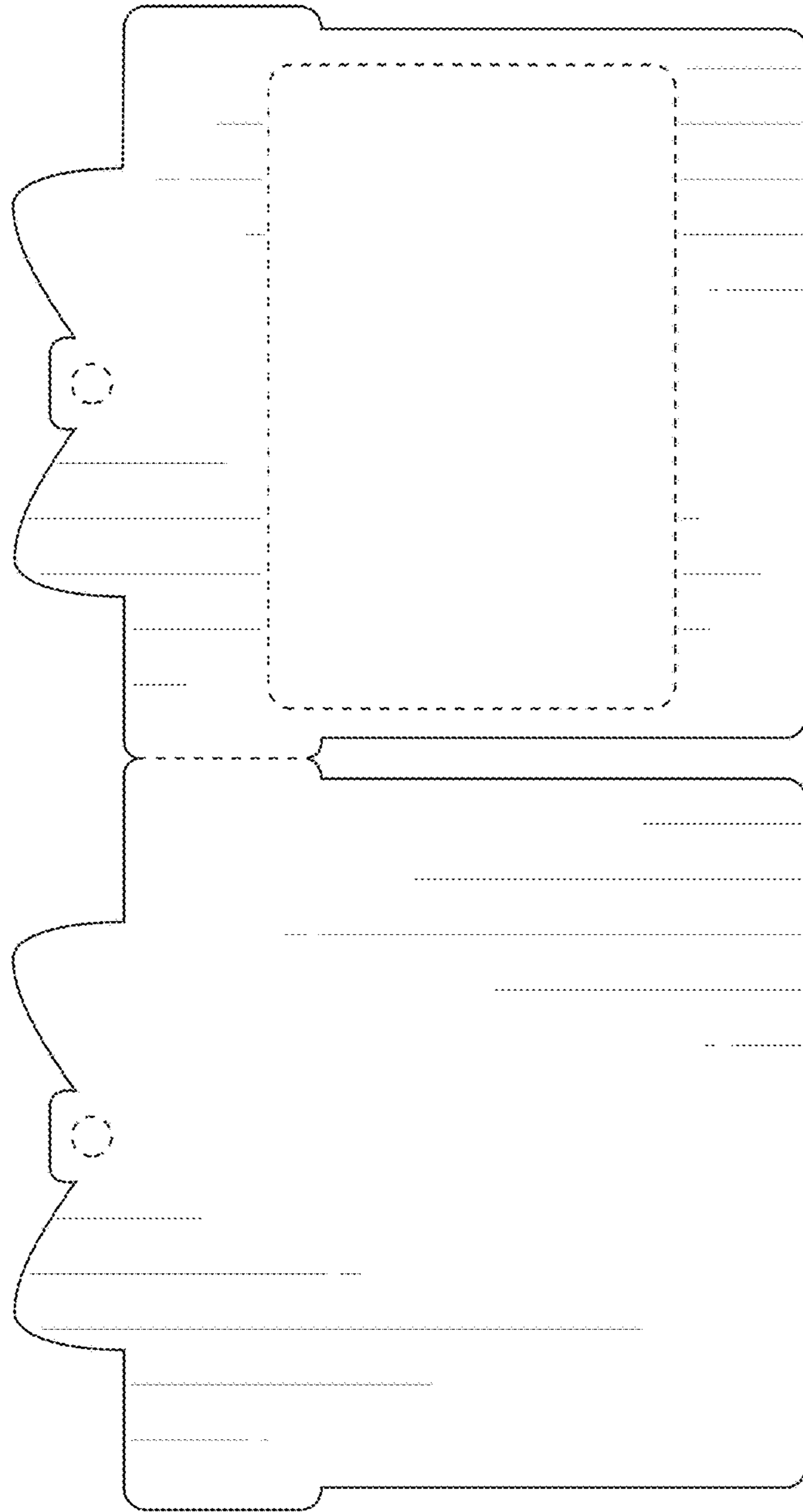
