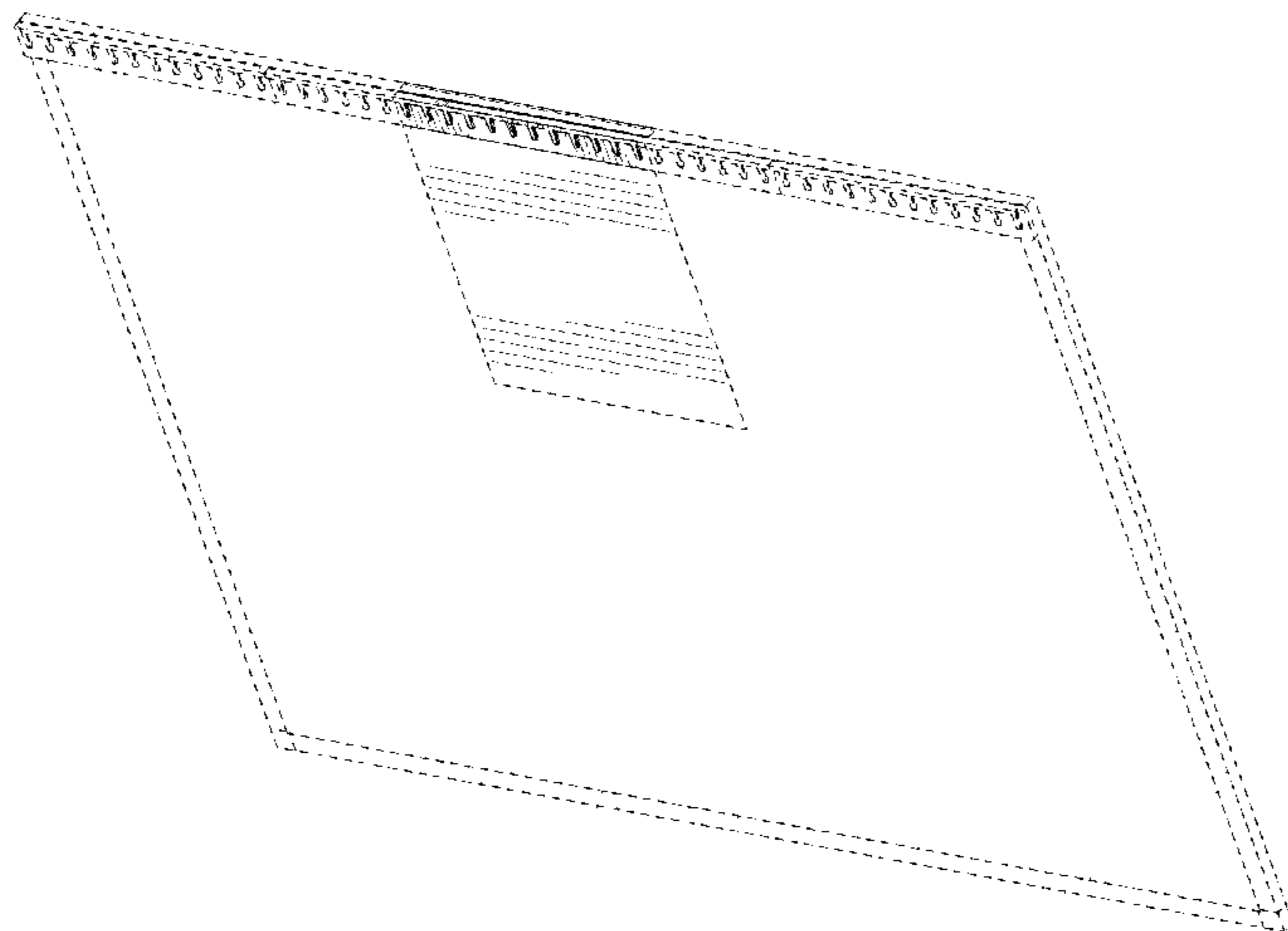
(57) **CLAIM**

The ornamental design for a dry erase board with note holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a dry erase board with note holder showing my new design; FIG. 2 is a front view thereof; FIG. 3 is an enlarged depiction of the claimed region of FIG. 1; and, FIG. 4 is an enlarged depiction of the claimed region of FIG. 2. The broken lines immediately adjacent to the shaded areas of the dry erase board with note holder define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the dry erase board with note holder show features that form no part of the claimed design.

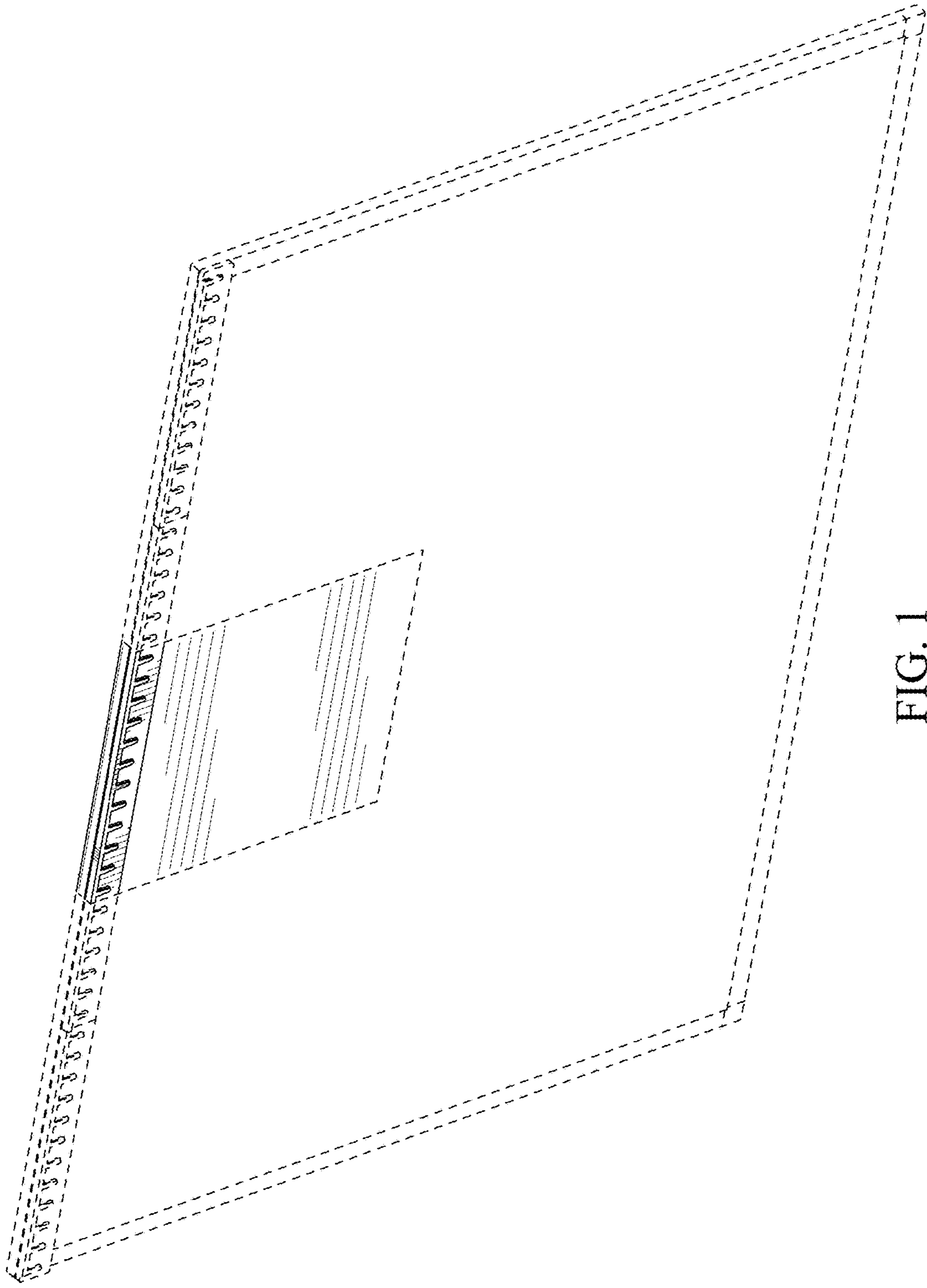

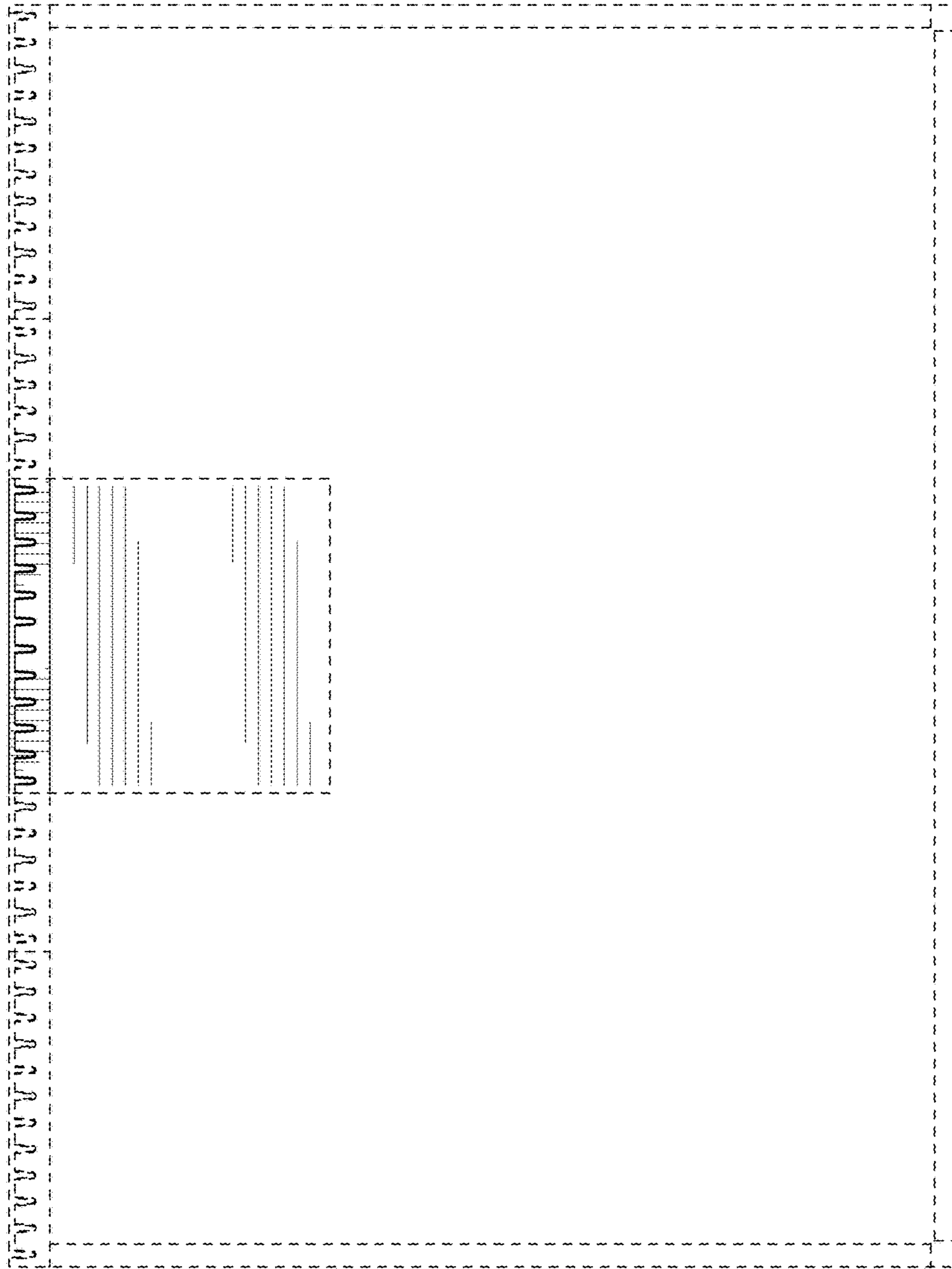

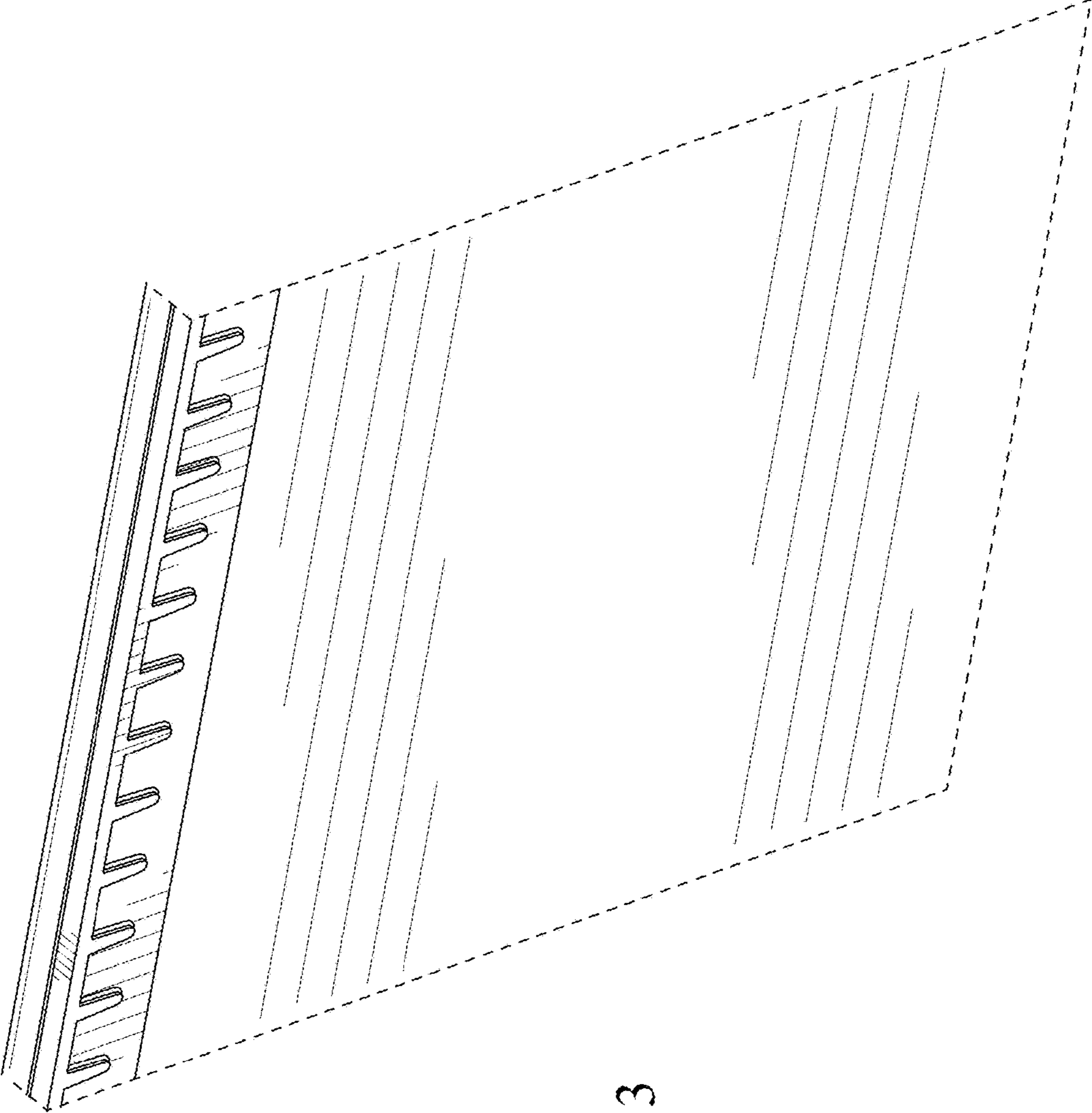

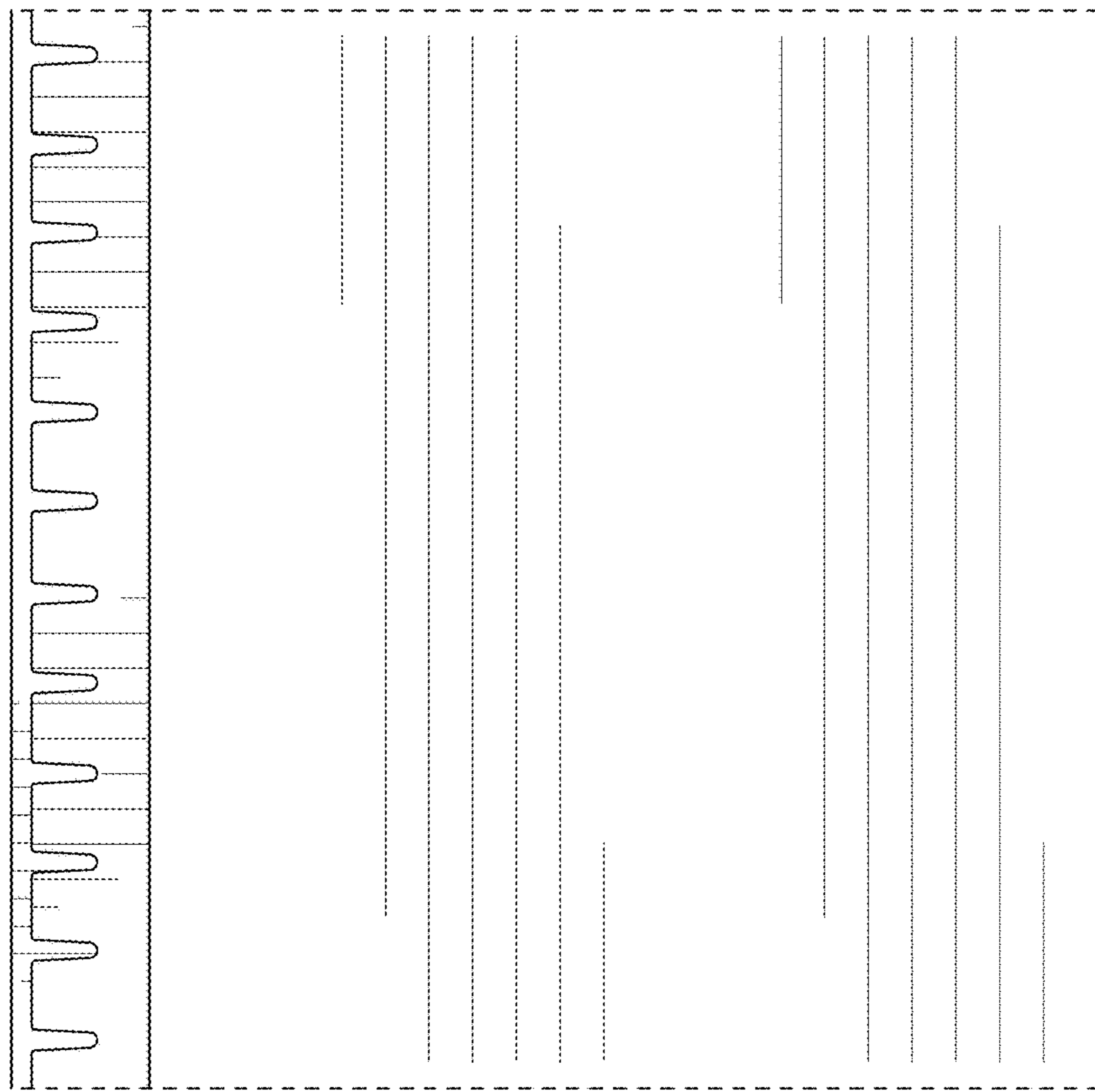
