**DESCRIPTION**

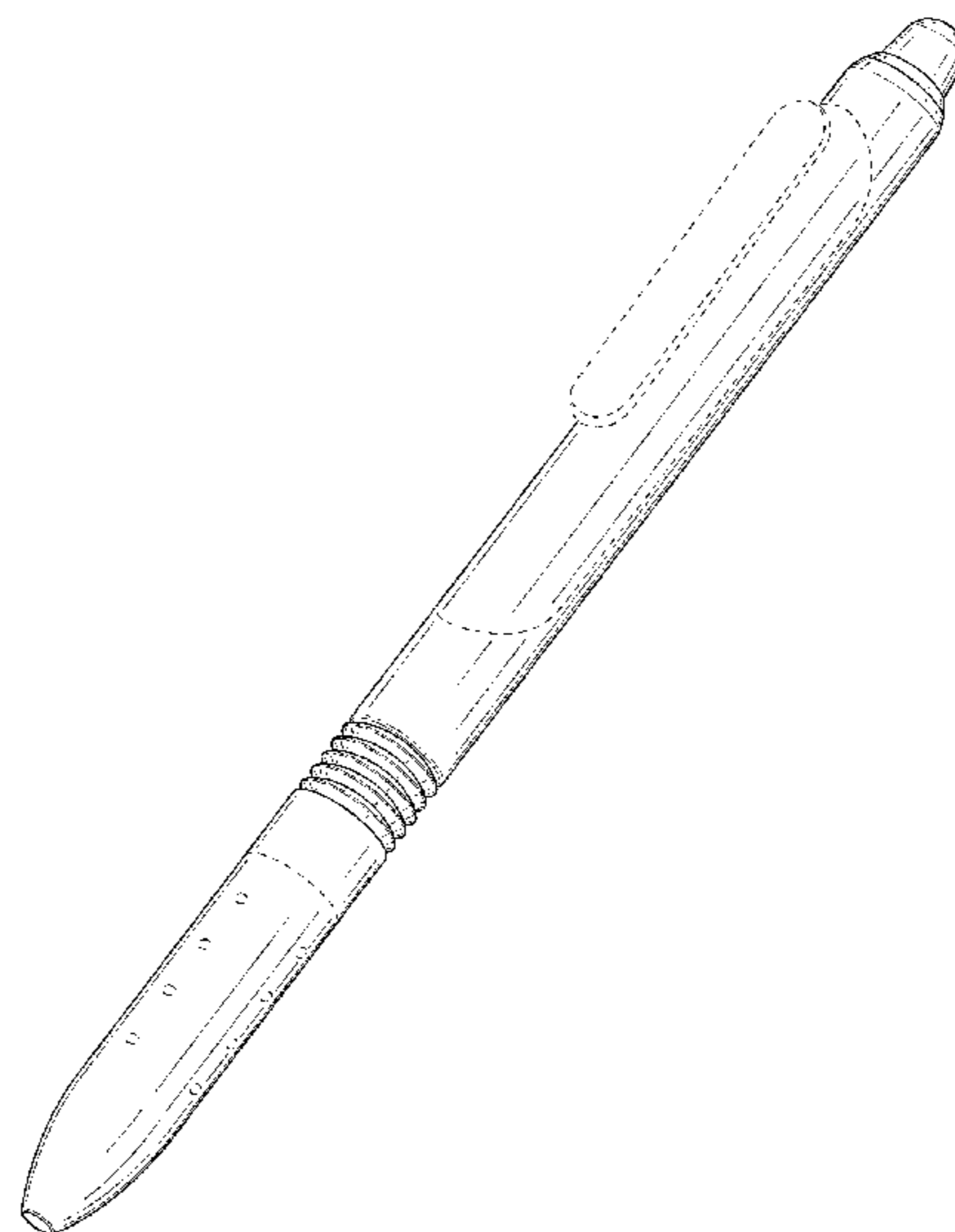
FIG. 1 is a perspective view showing our new design for a pen in an extended position;

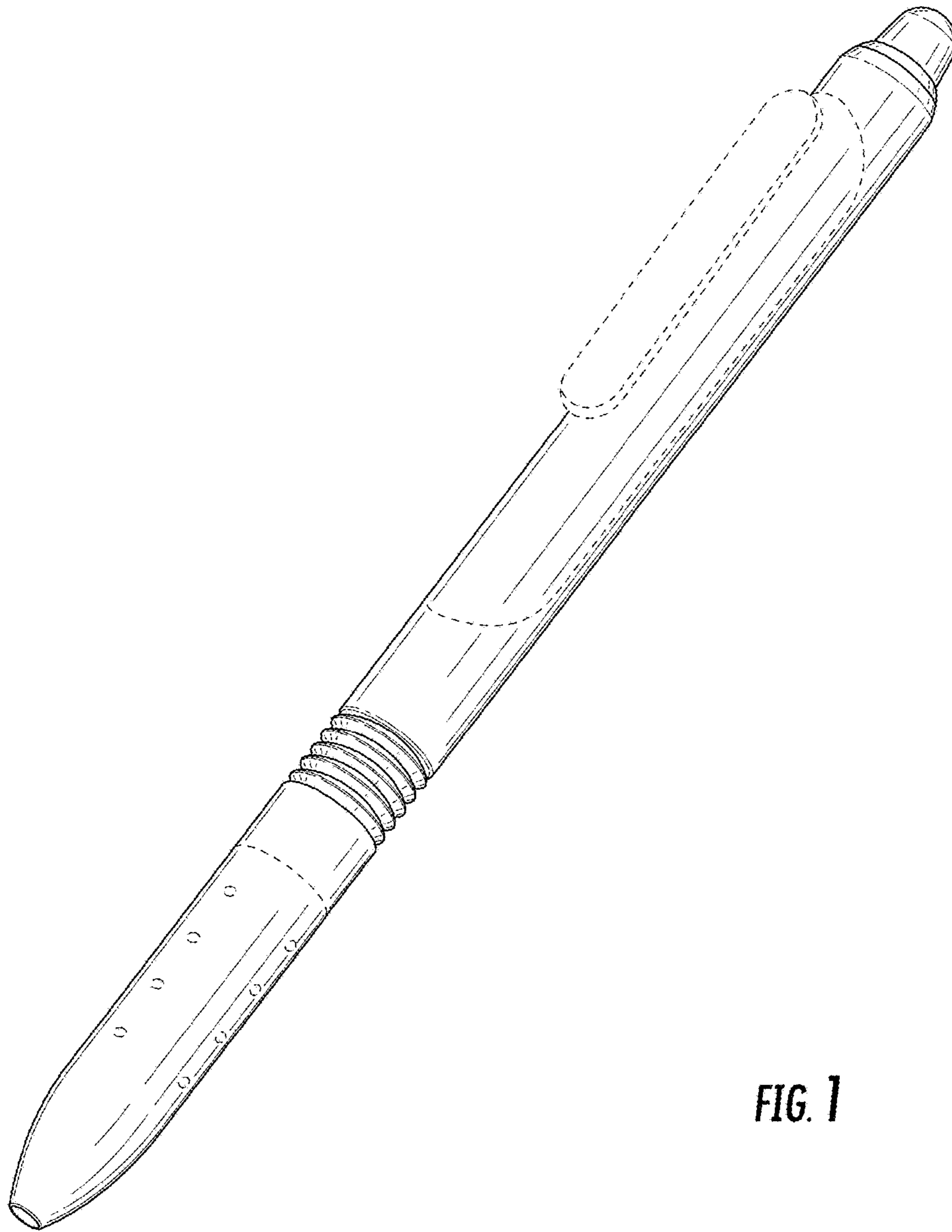

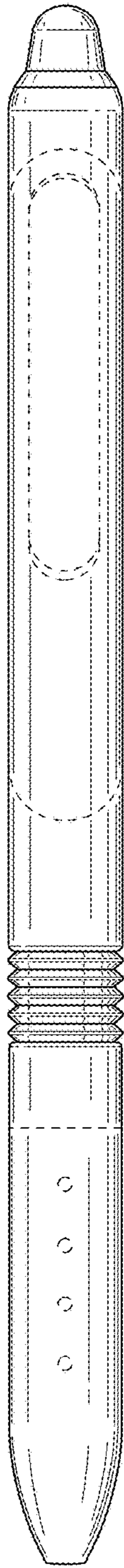

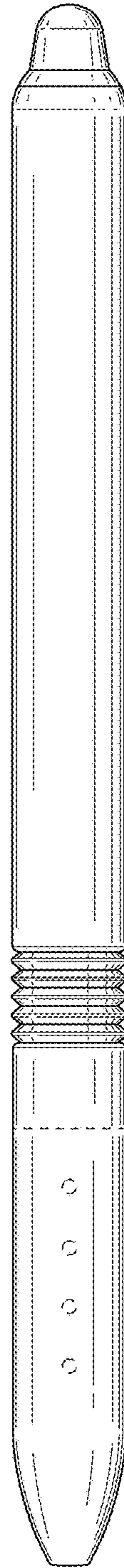

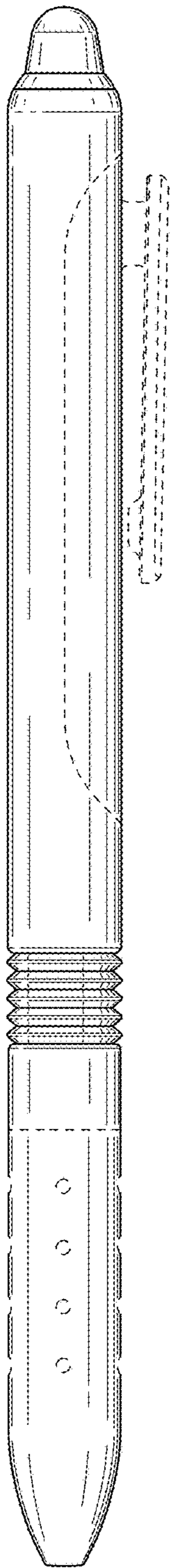

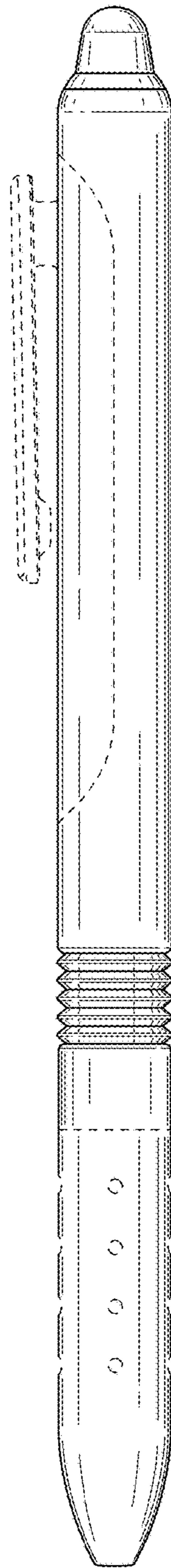
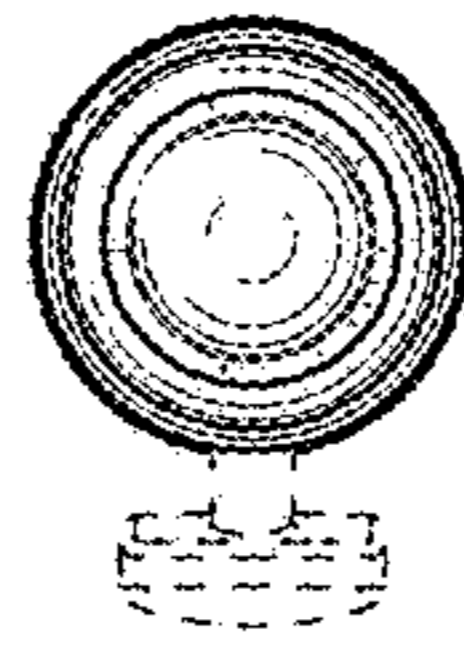
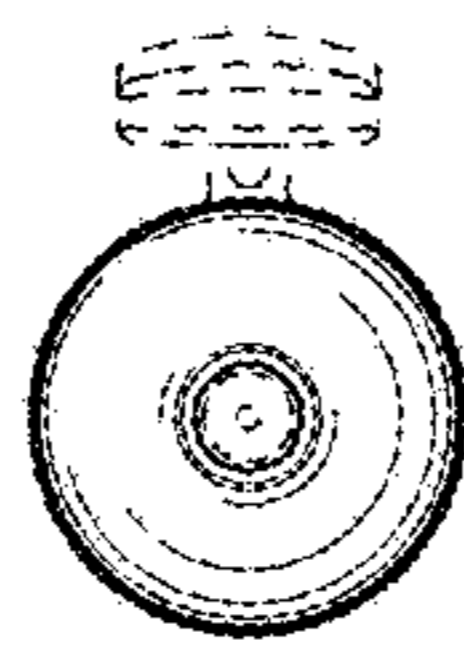

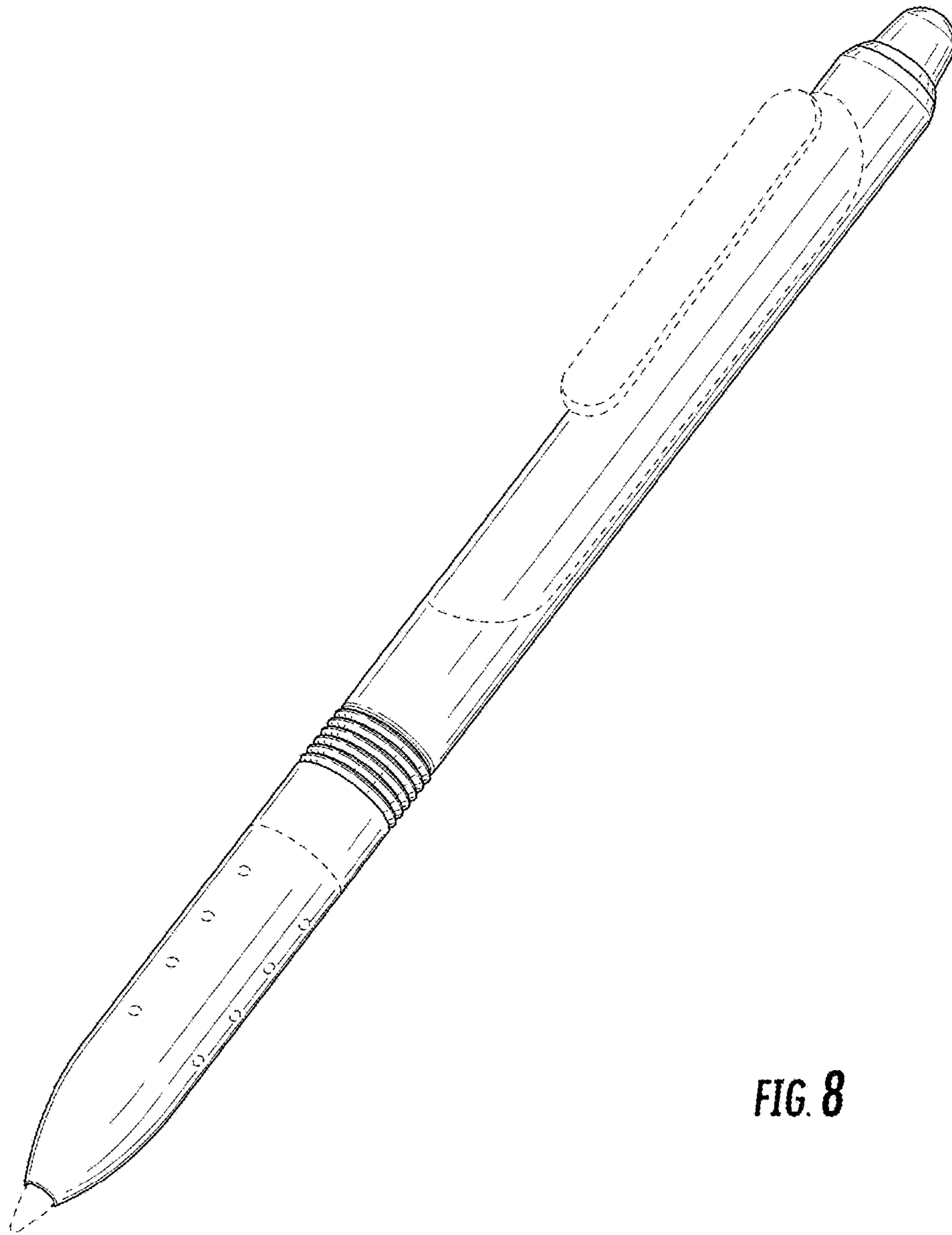

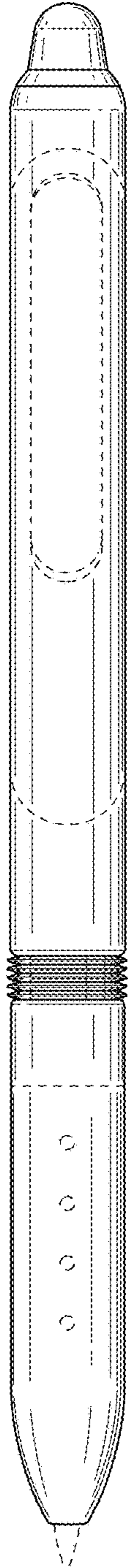

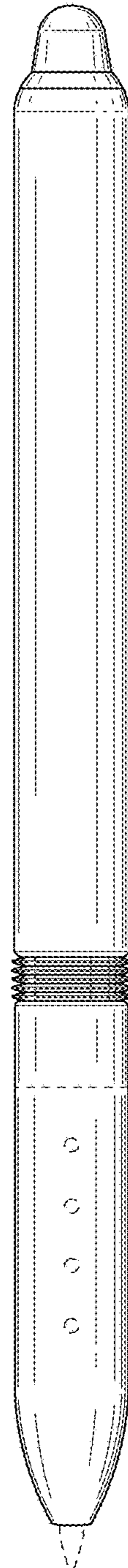

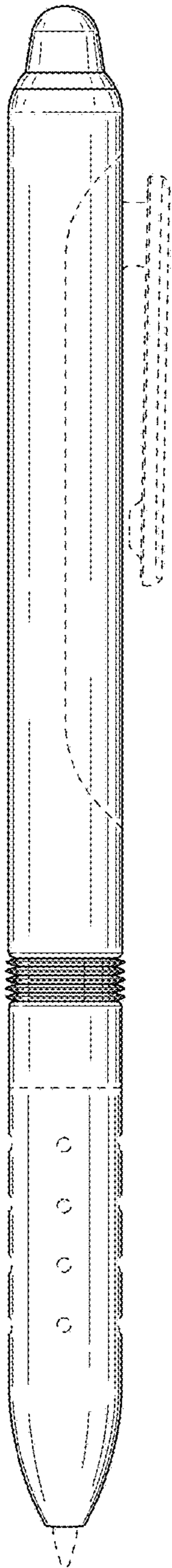

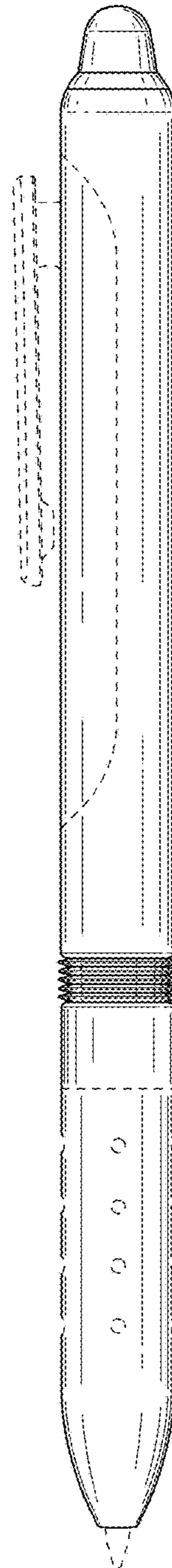
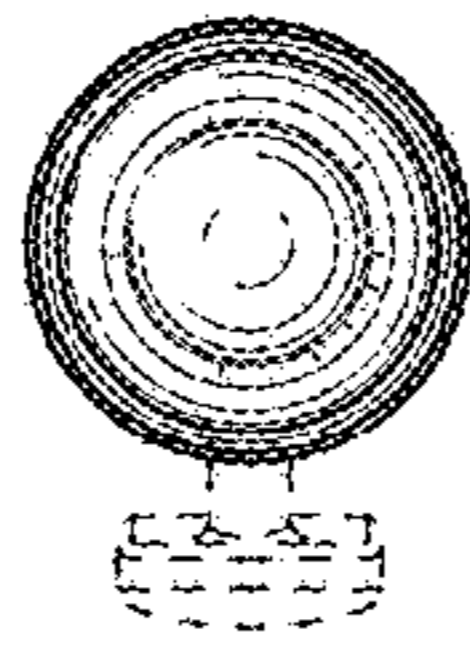
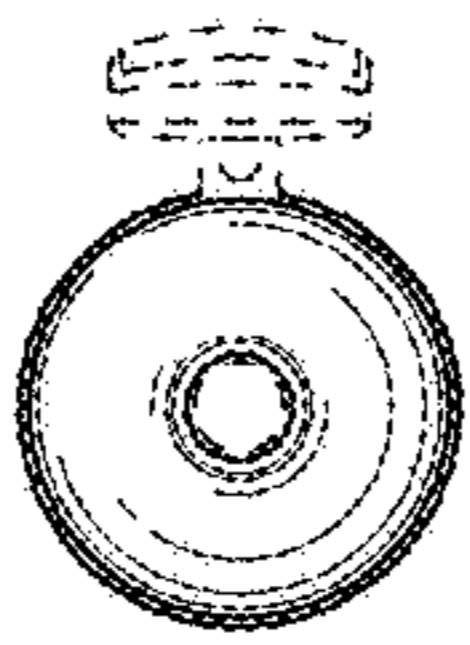
