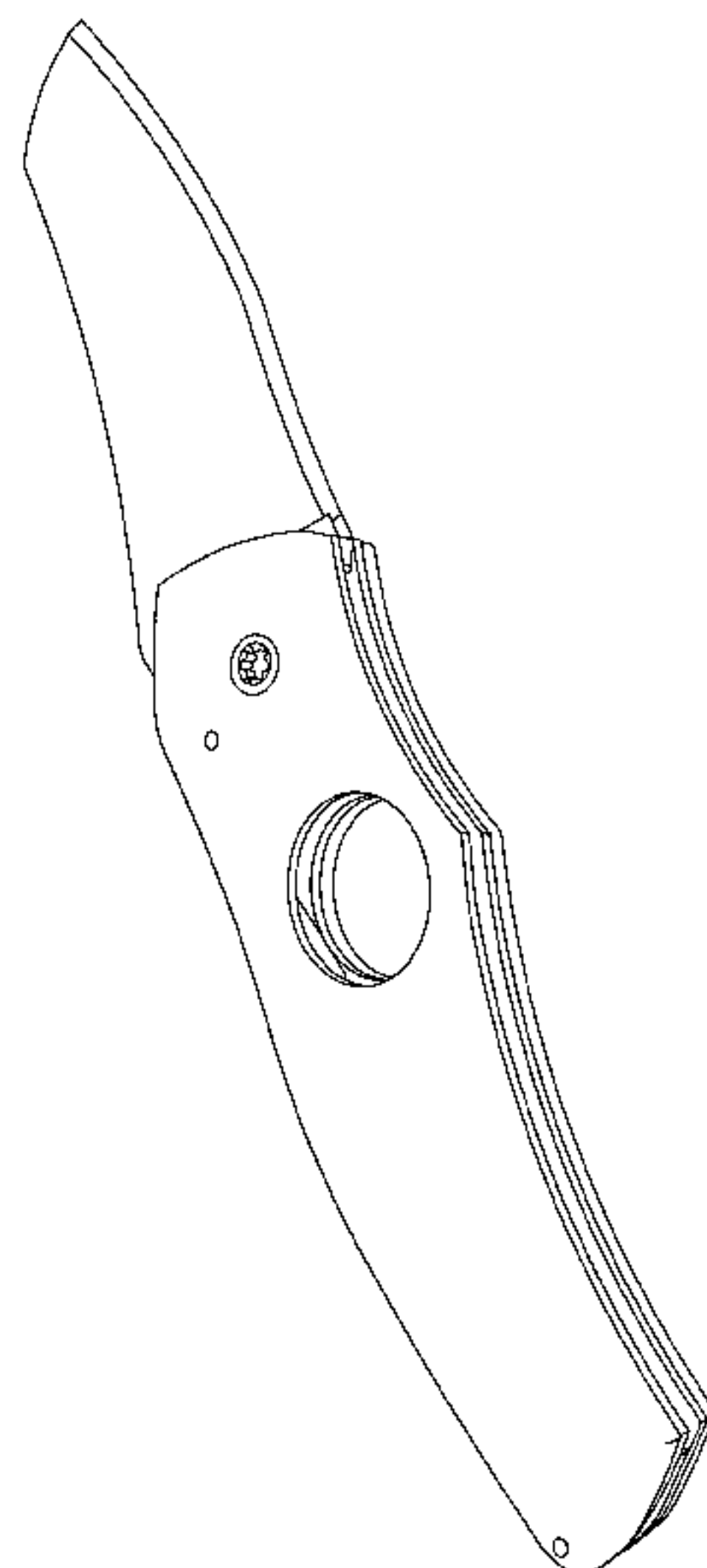

We claim the ornamental design for cigar cutter, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a cigar cutter in an open configuration showing our new design;

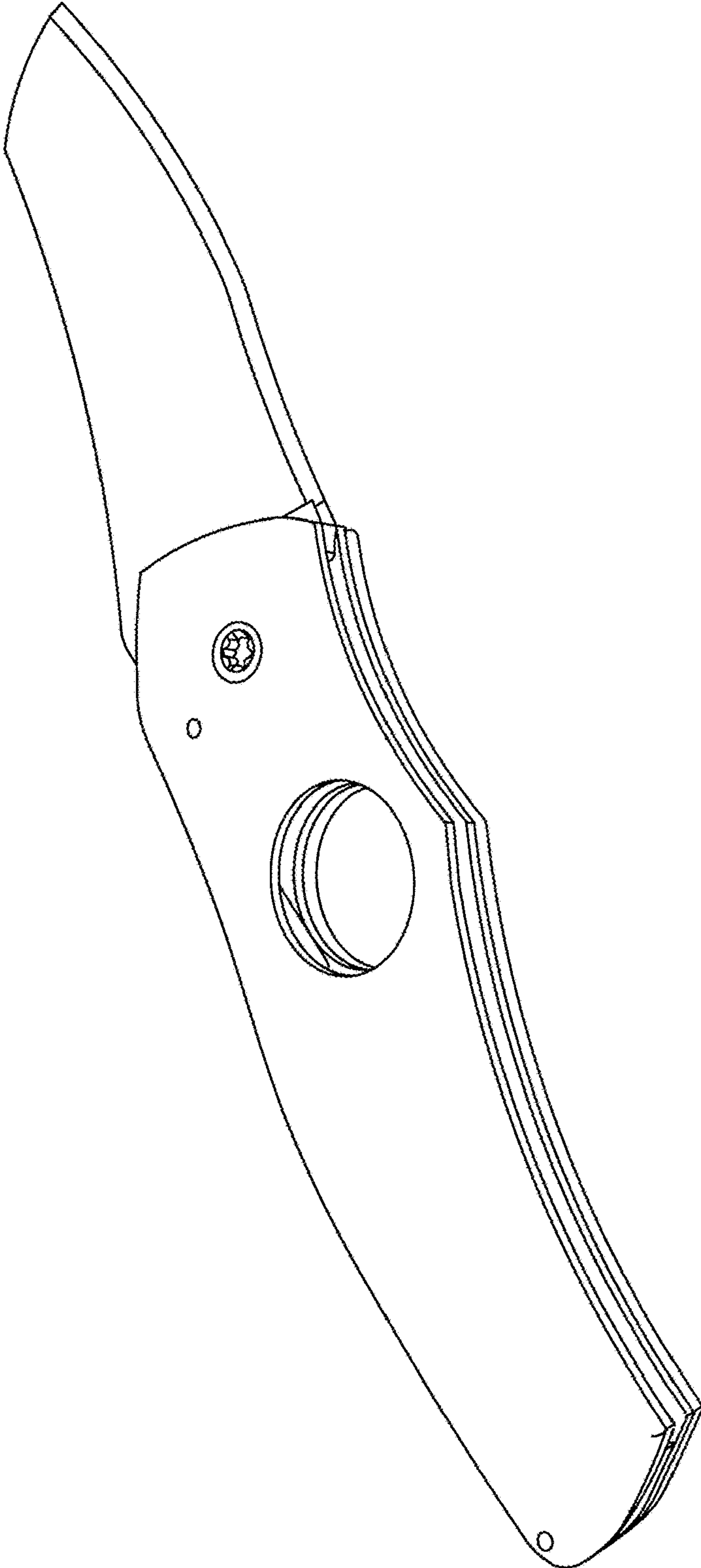

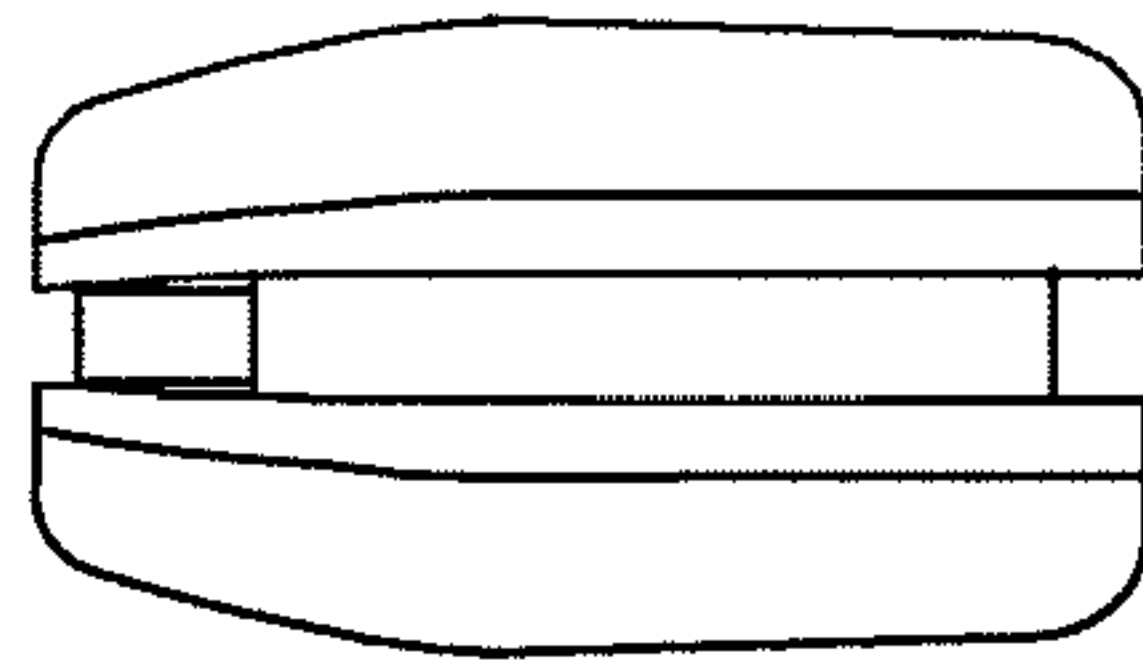

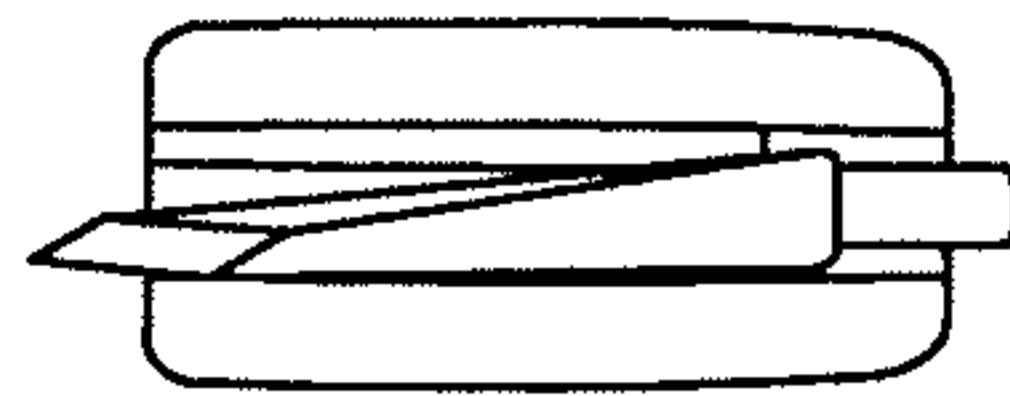

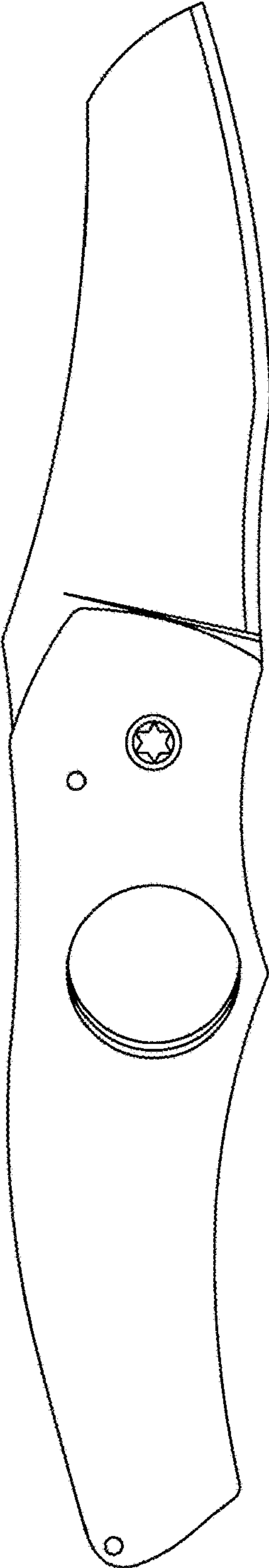

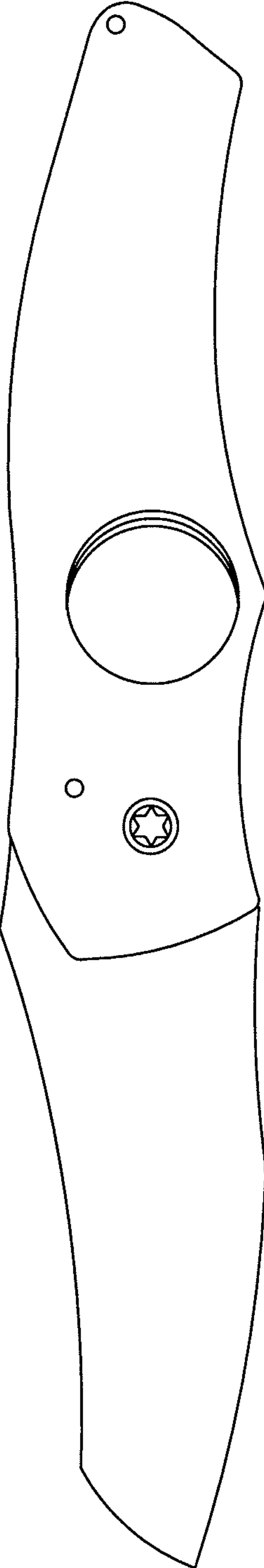

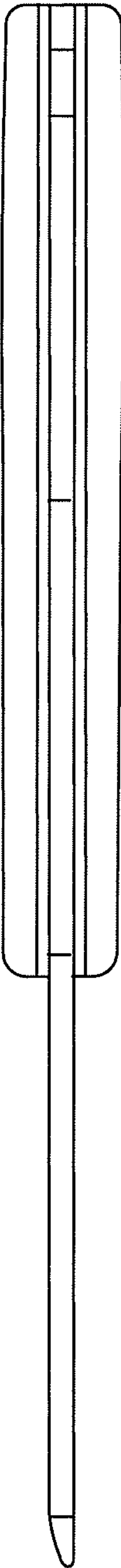

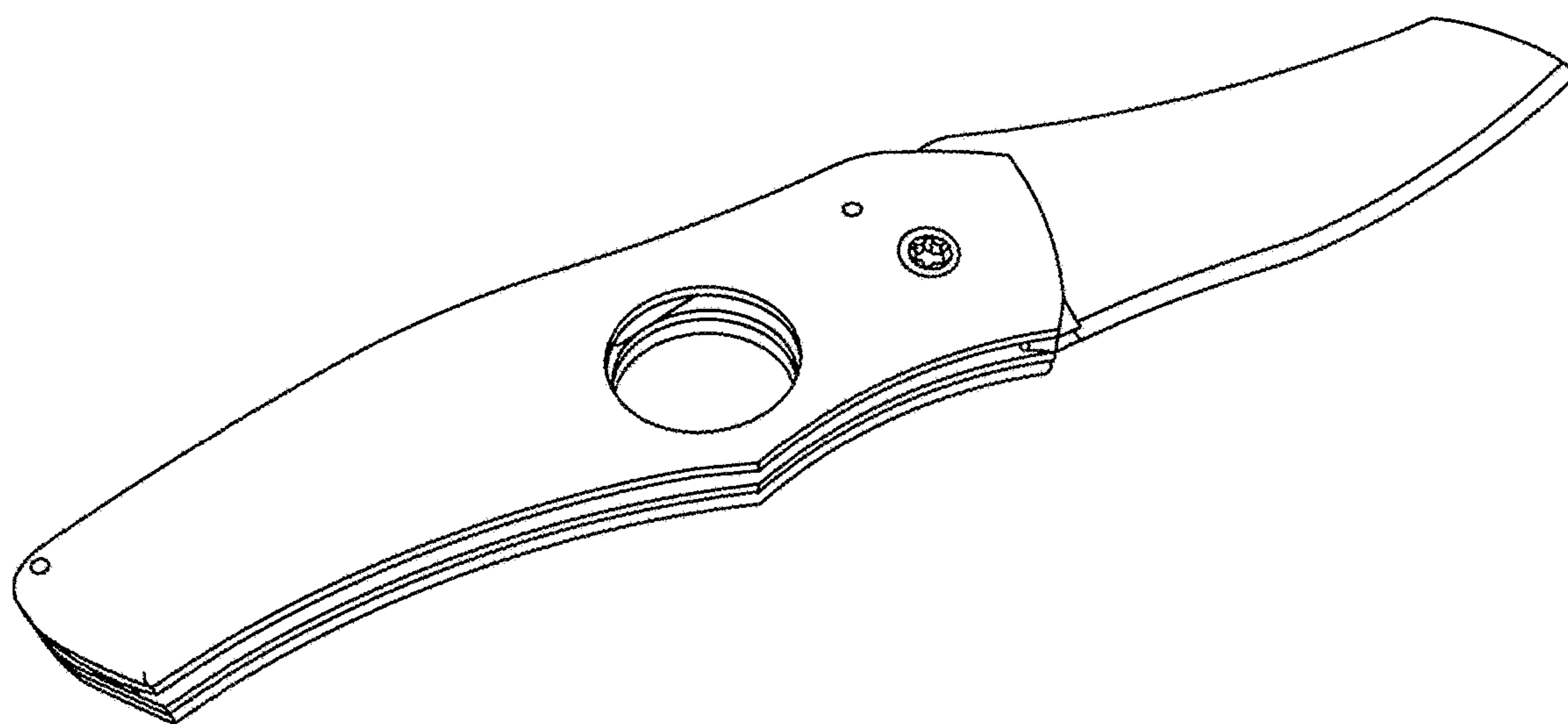

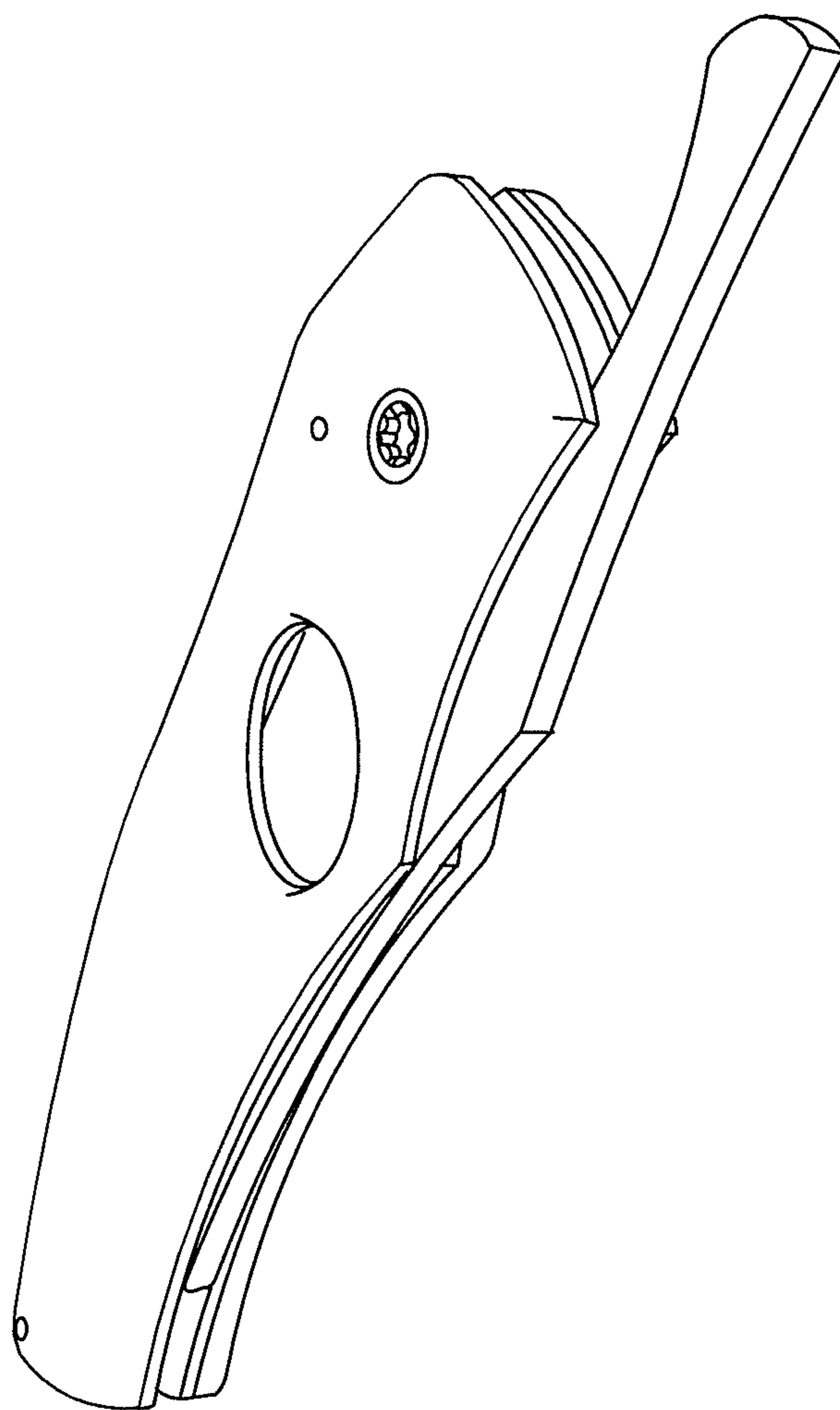

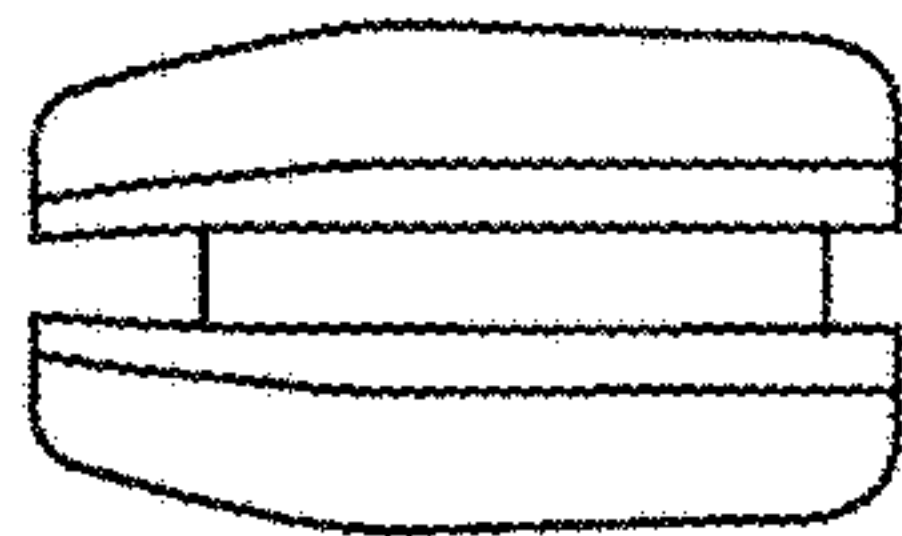

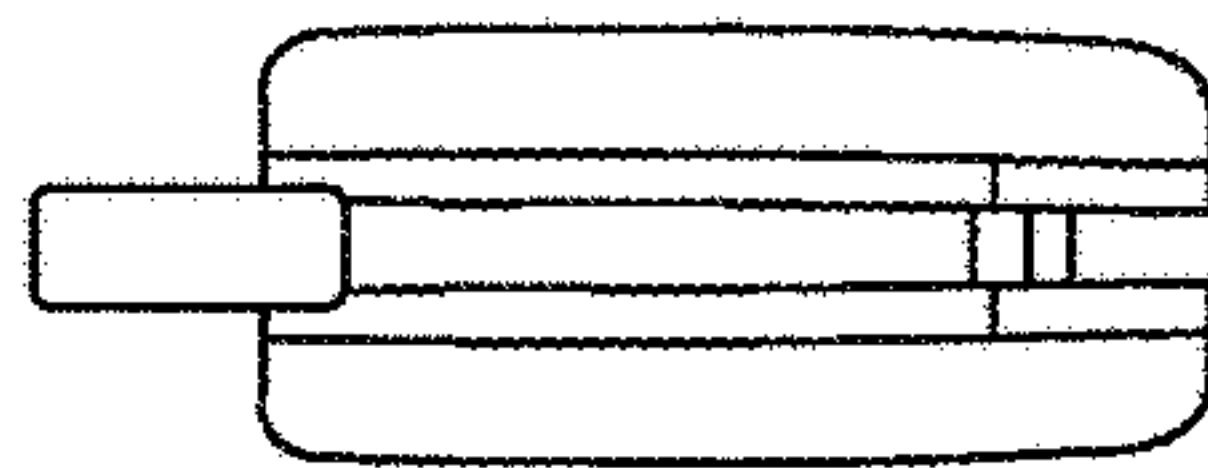

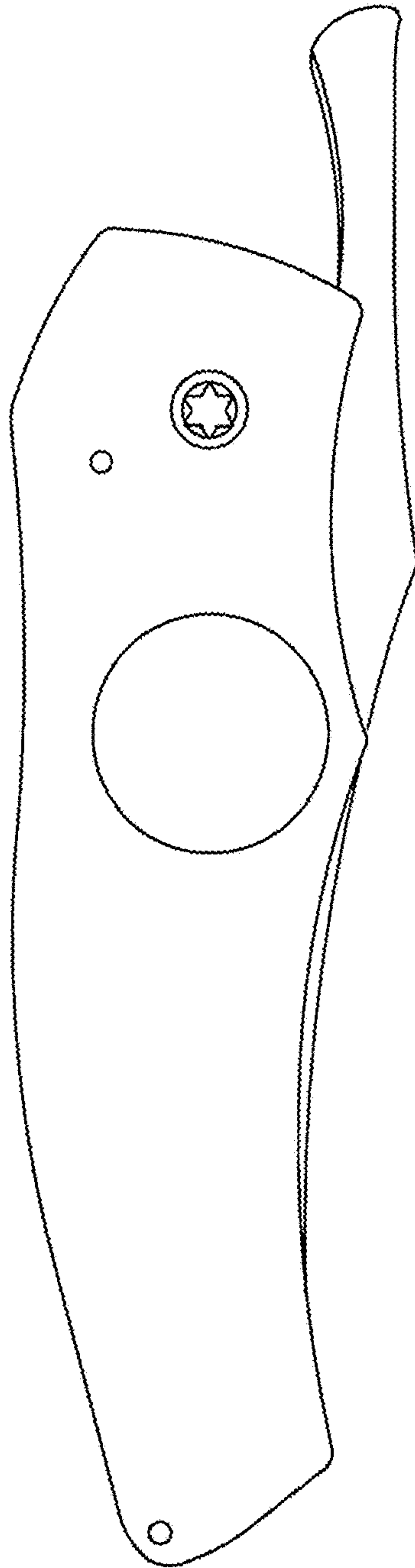

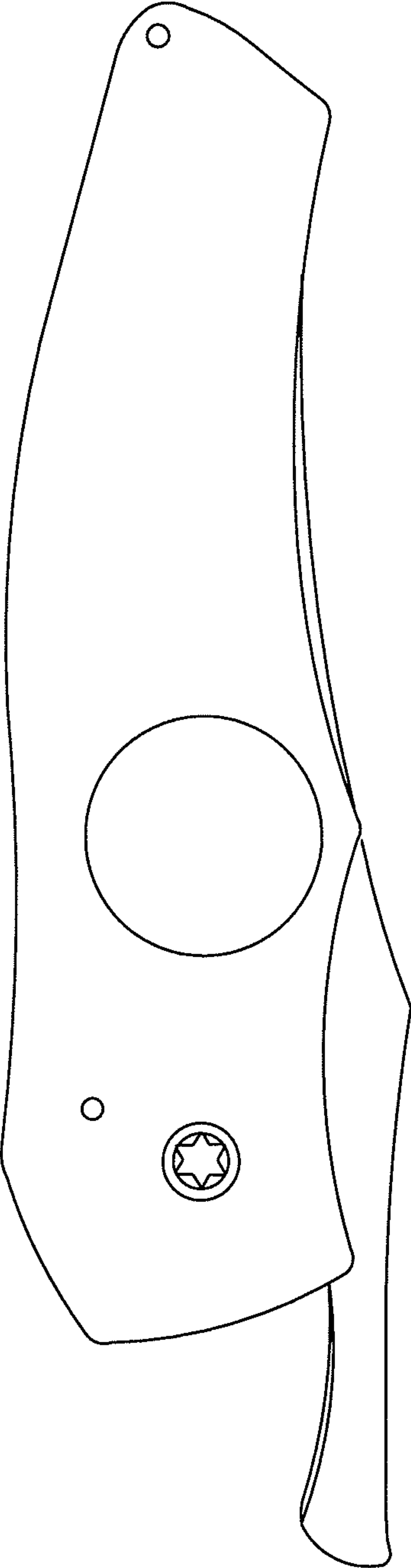

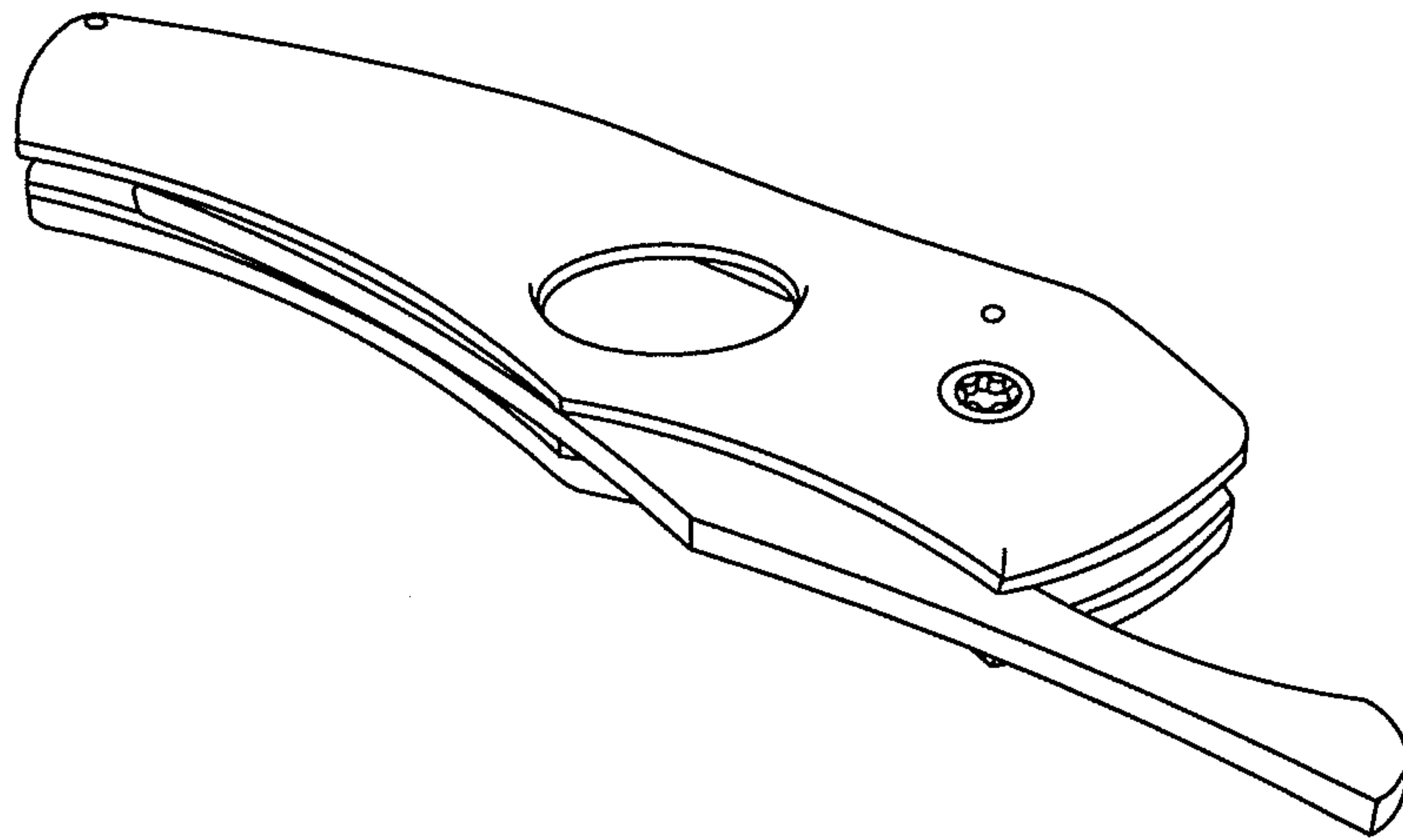
