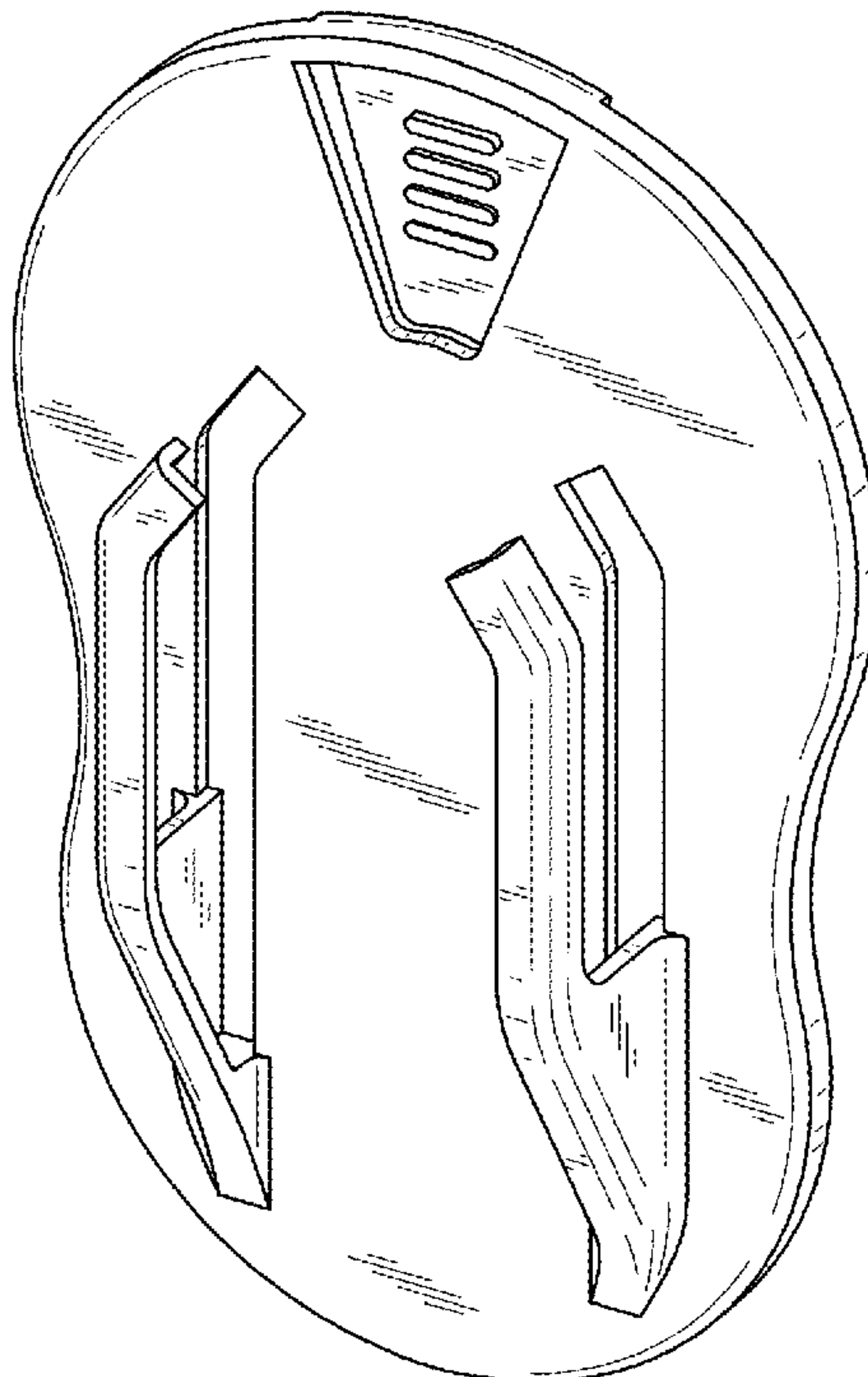
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a sandal tote showing
my new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevation view thereof, the right side
elevation view being a mirror image thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a perspective view of the sandal tote in use.

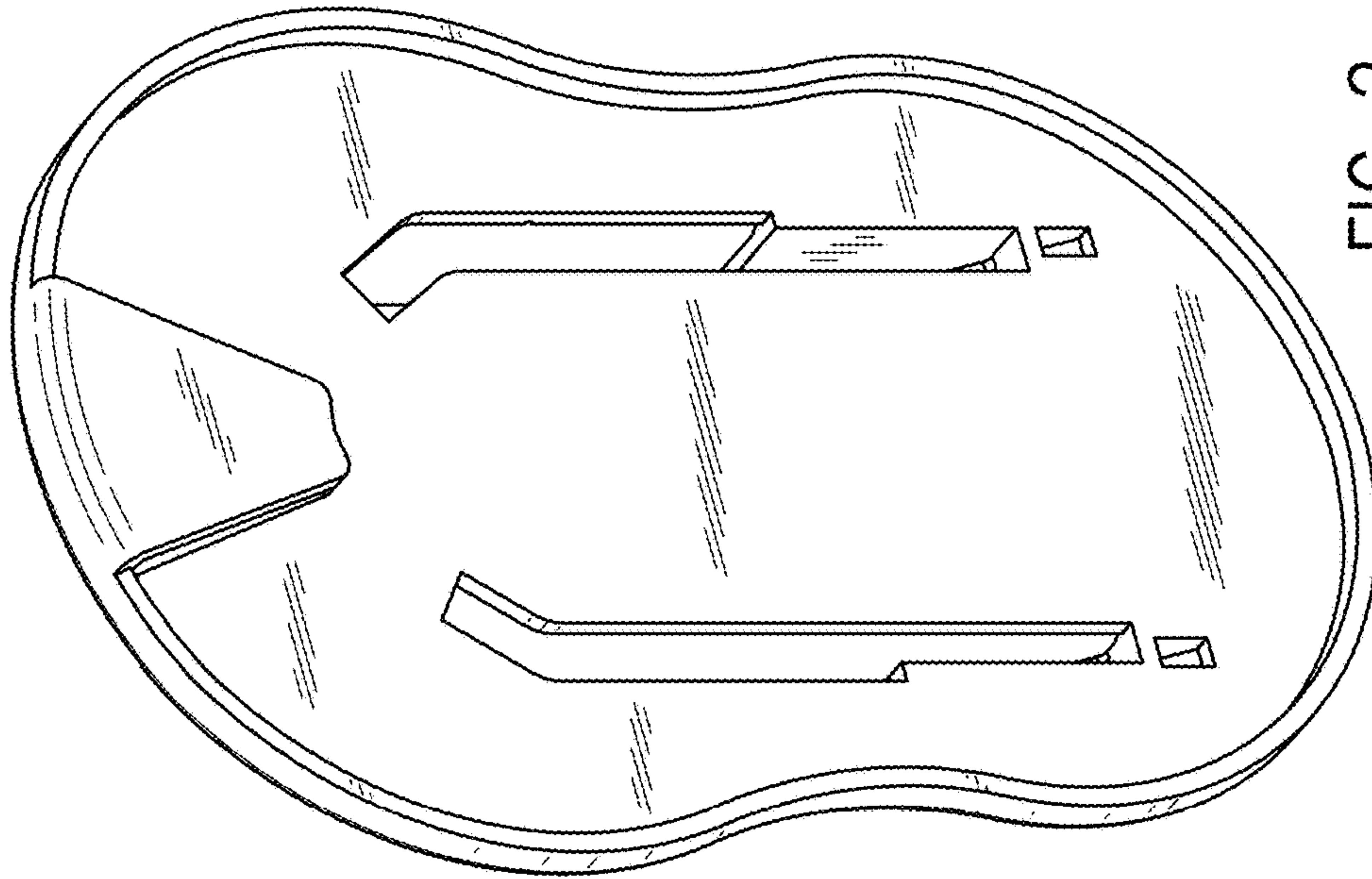

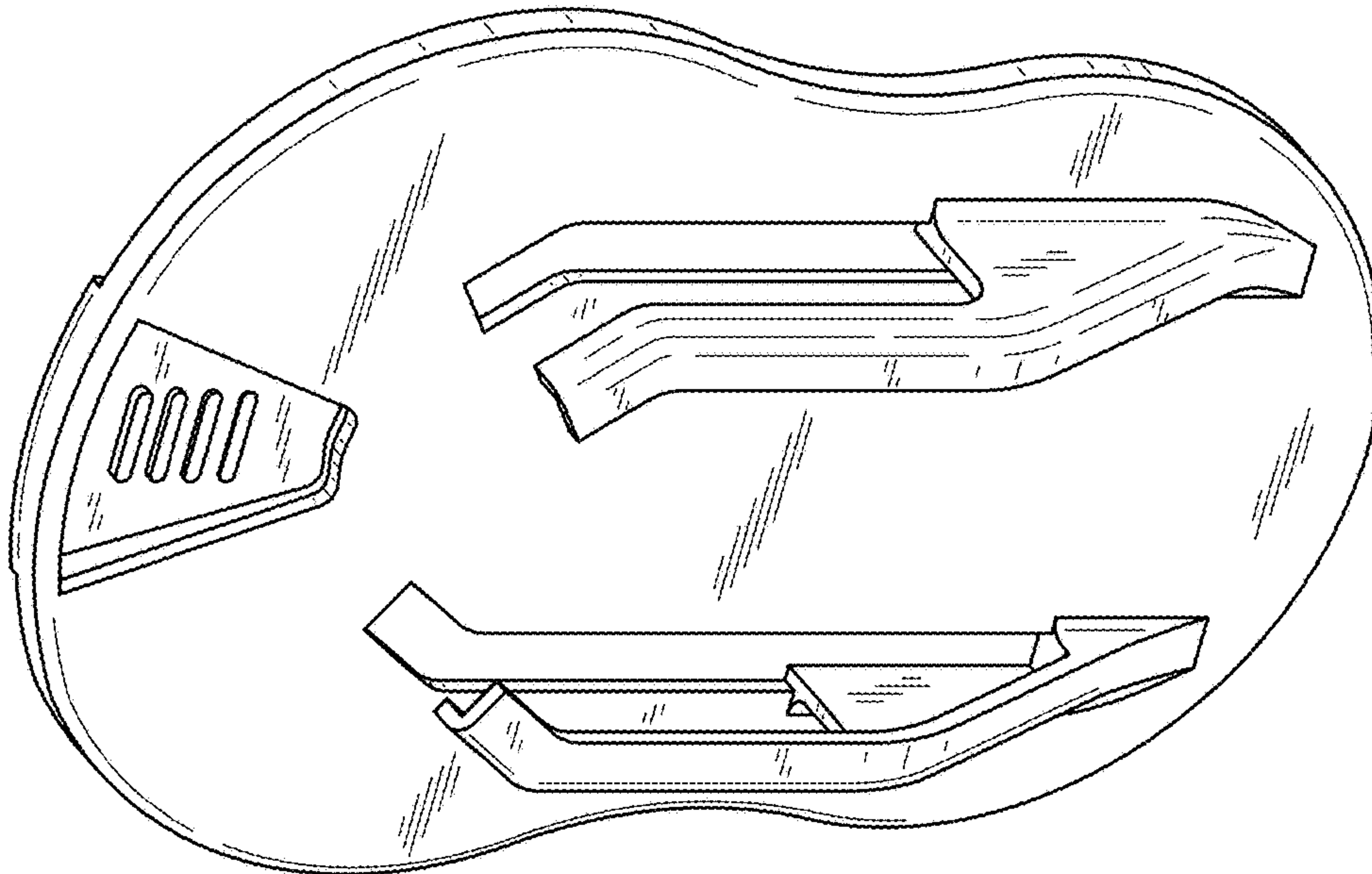

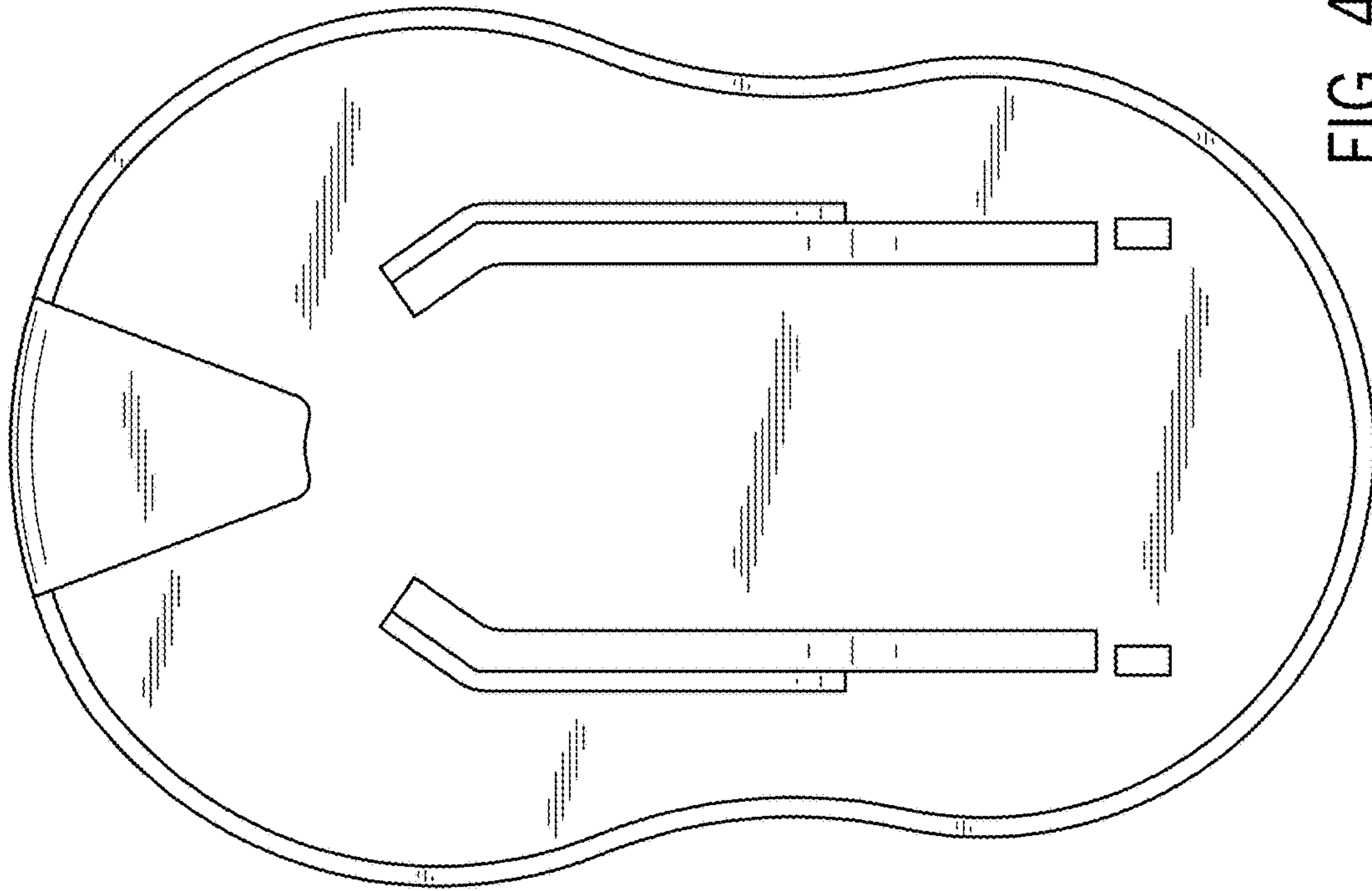

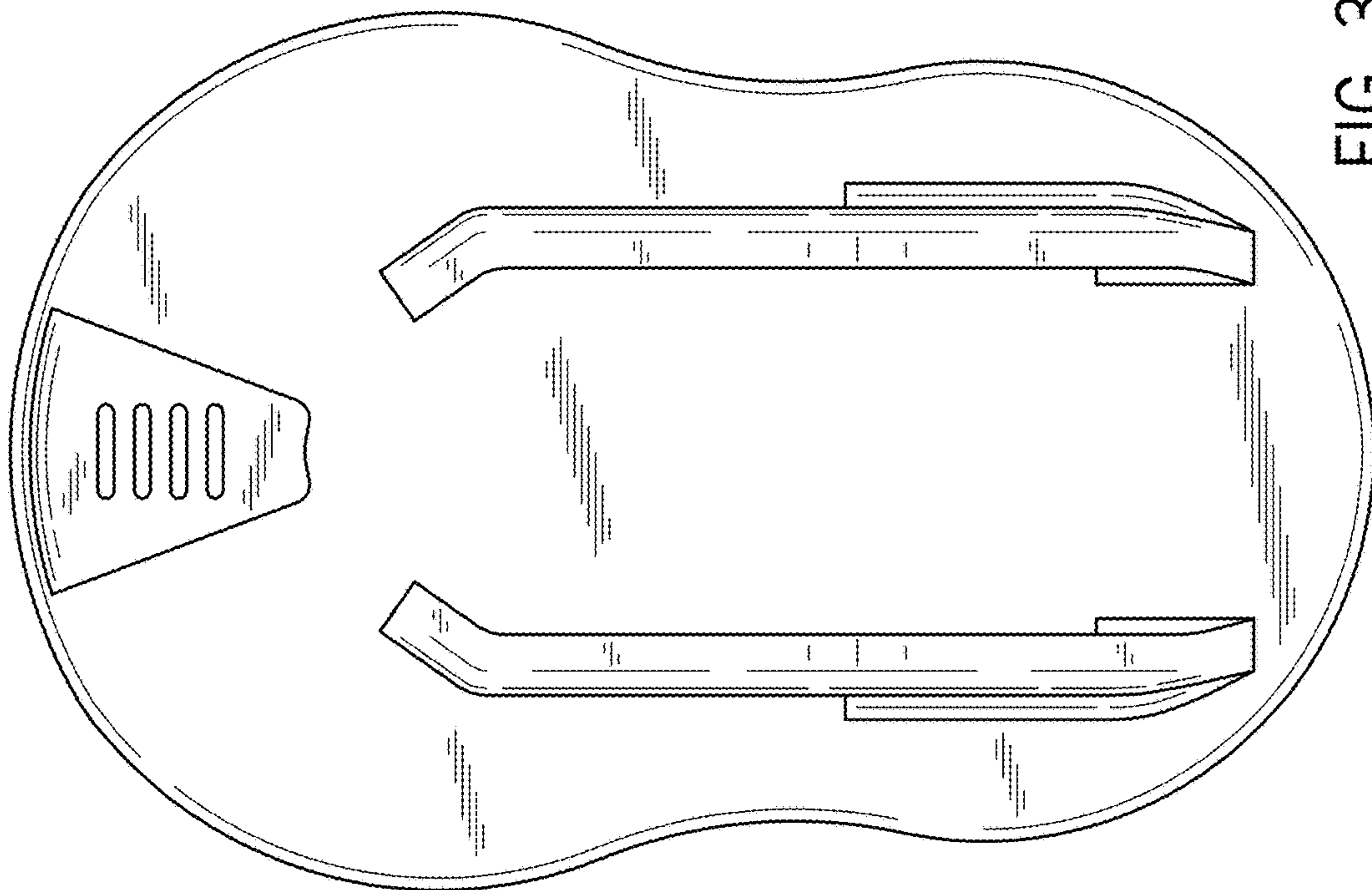

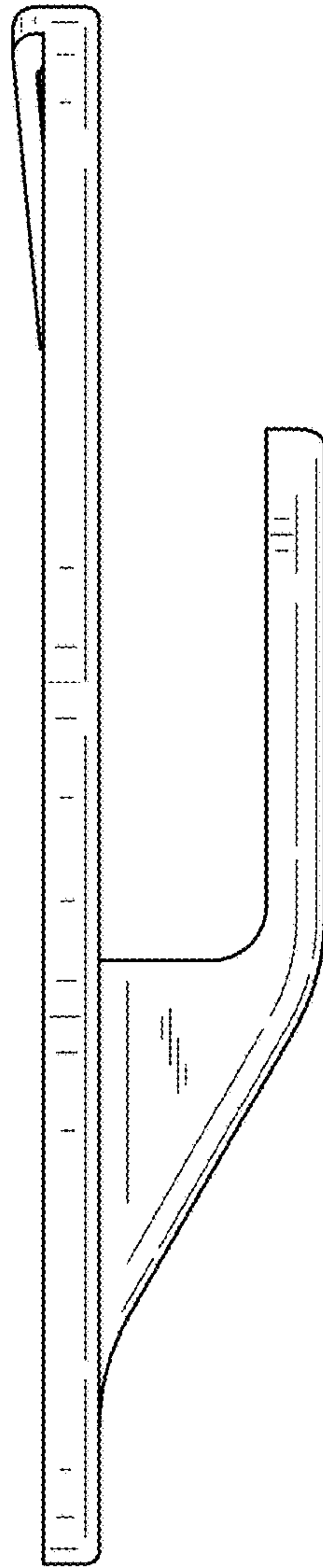

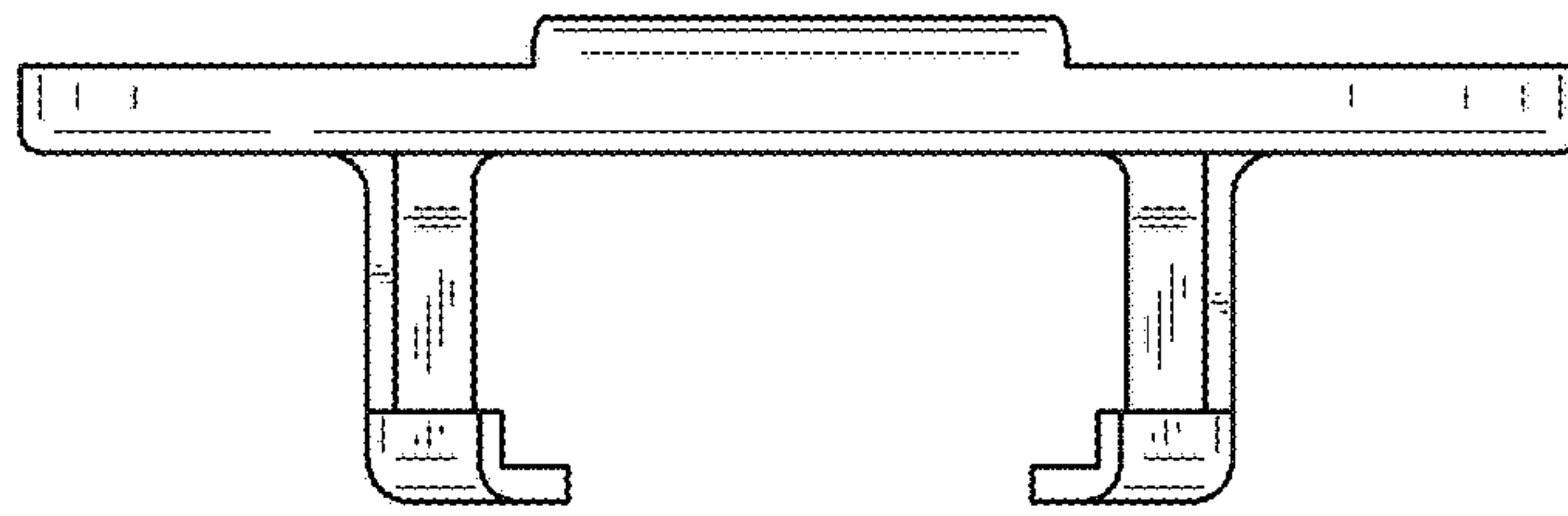

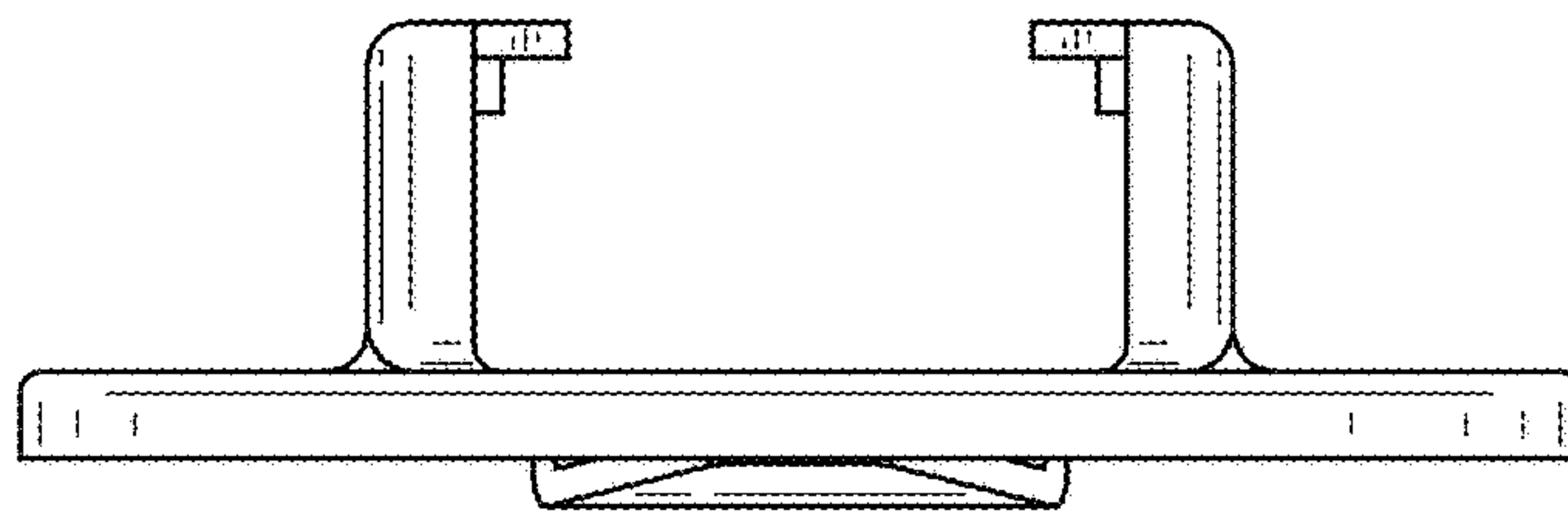

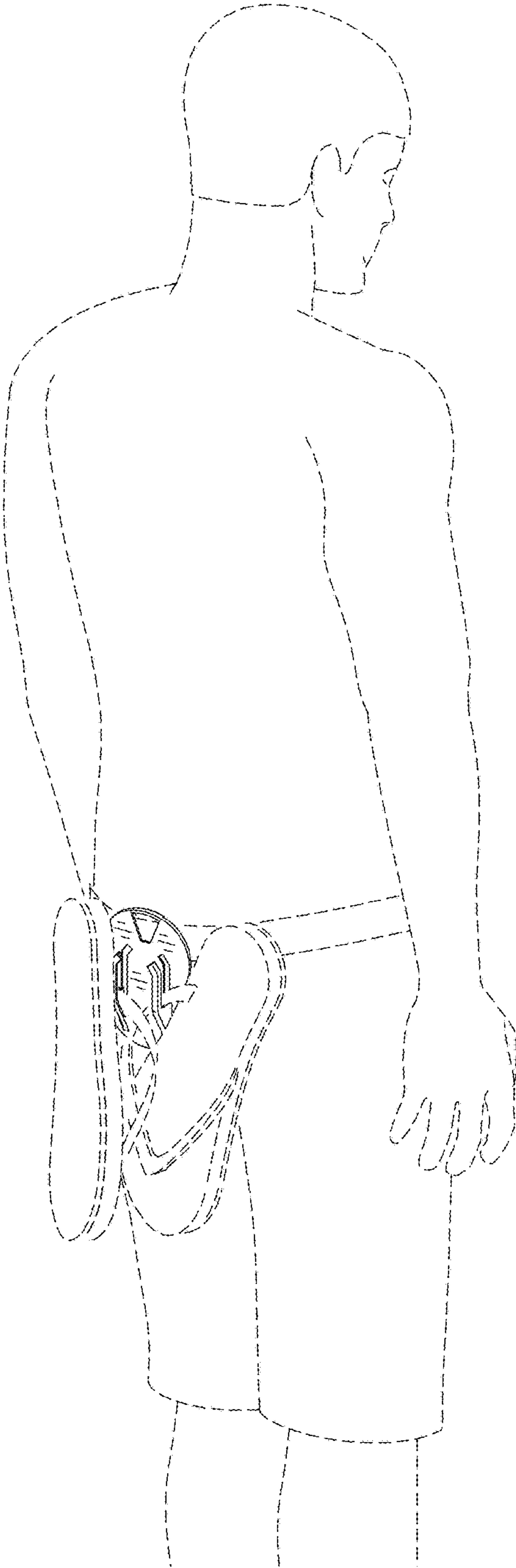
