**DESCRIPTION**

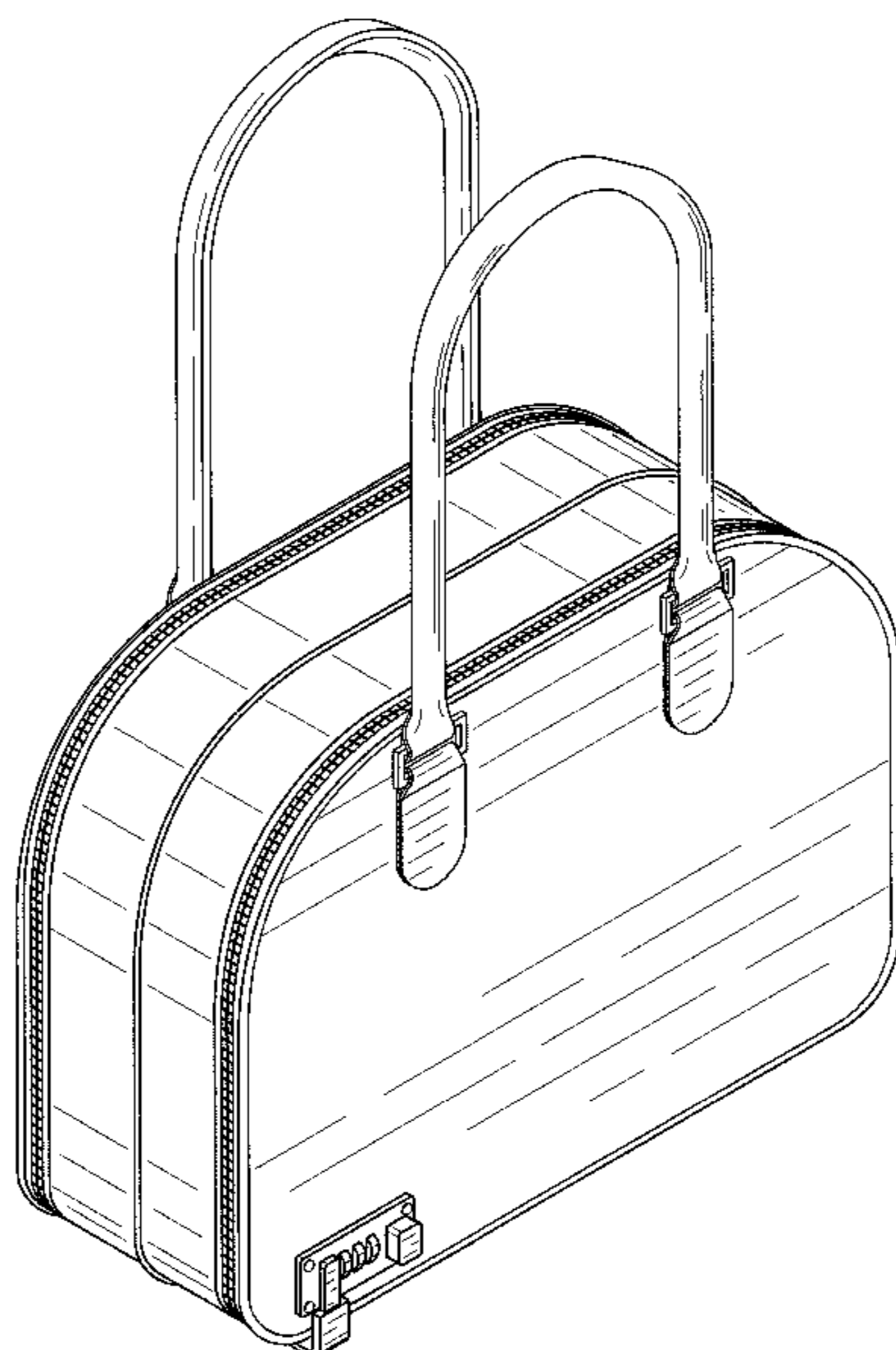
FIG. 1 is a front perspective view of a locking bag of the present application;

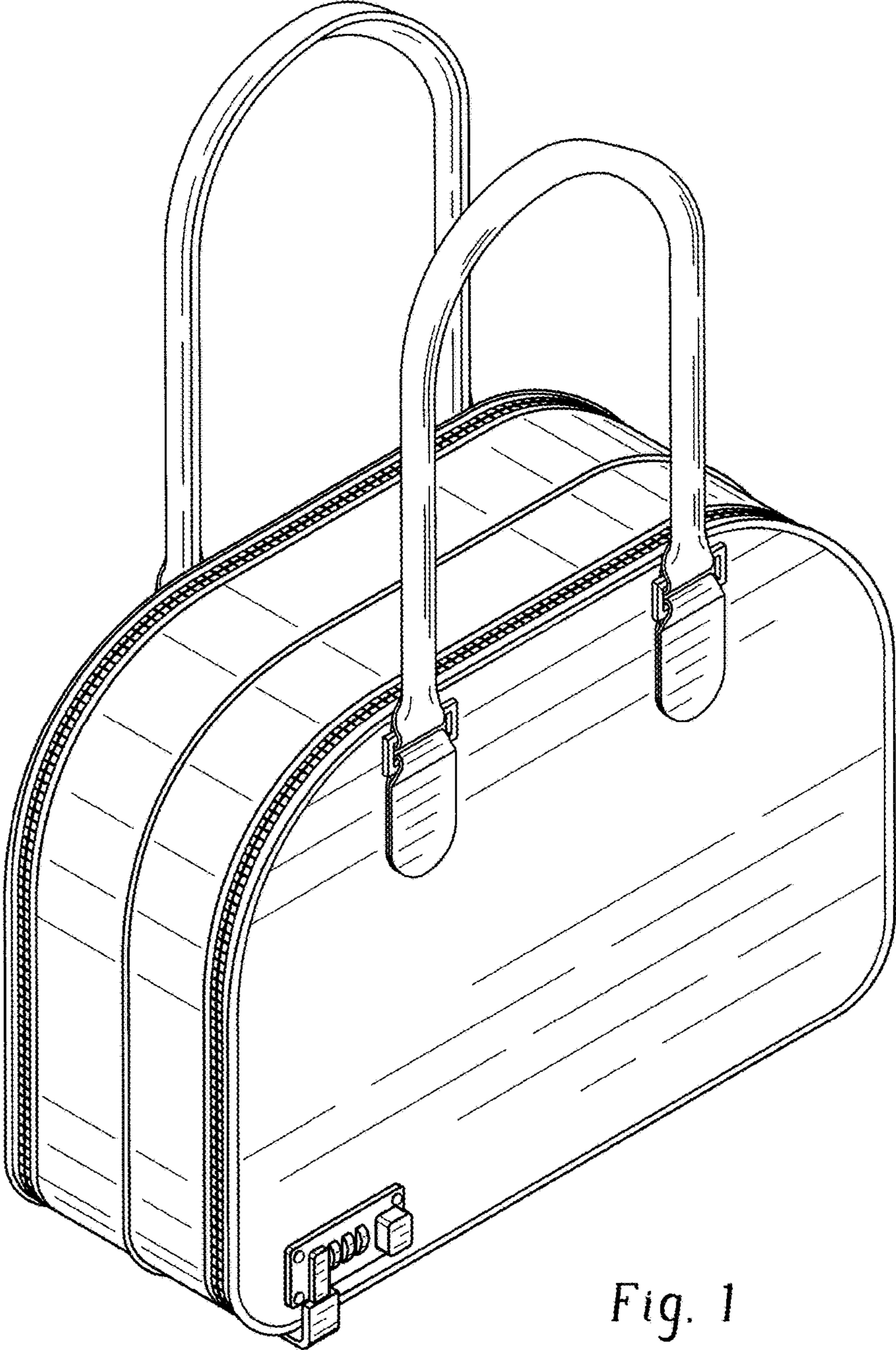

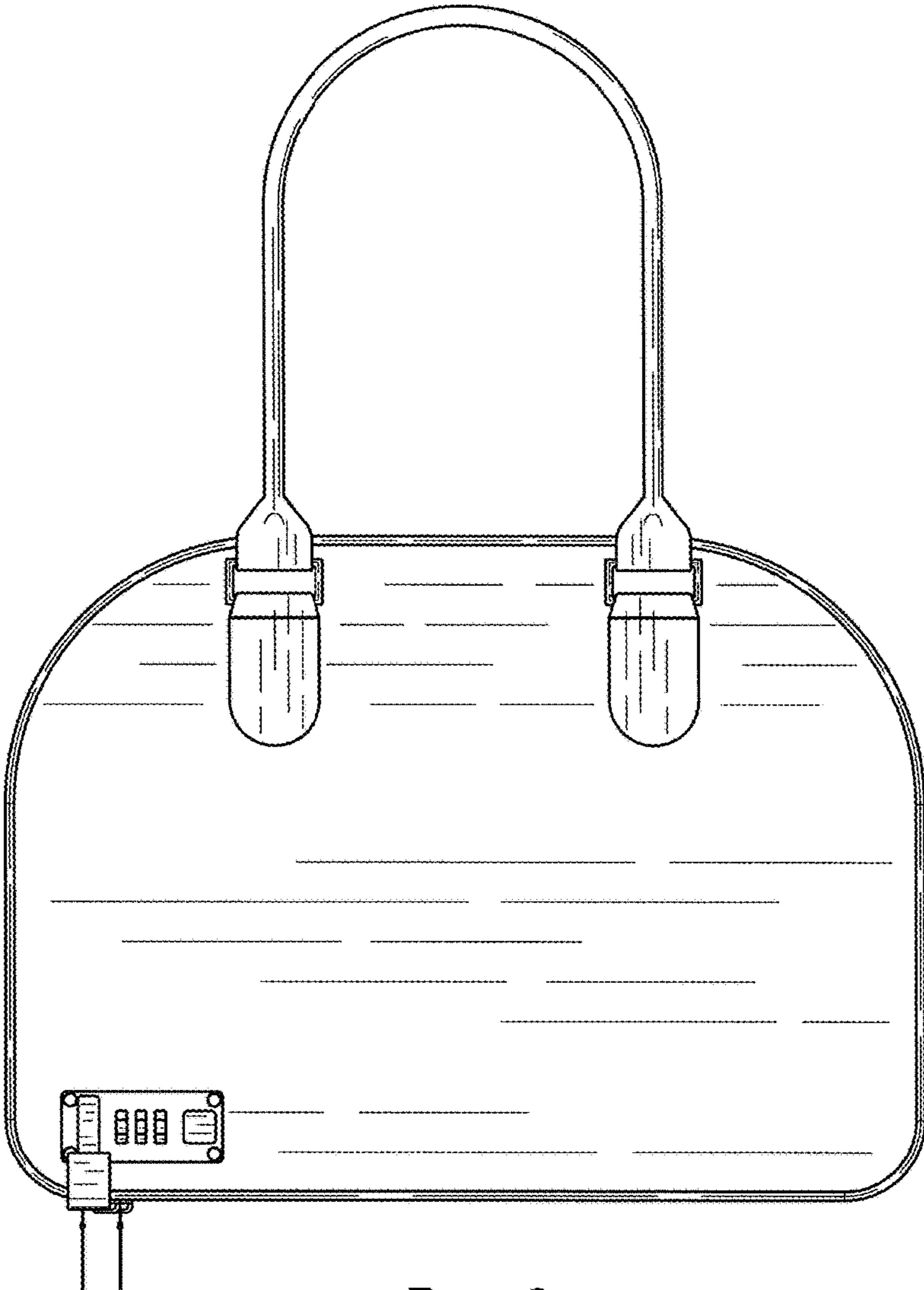
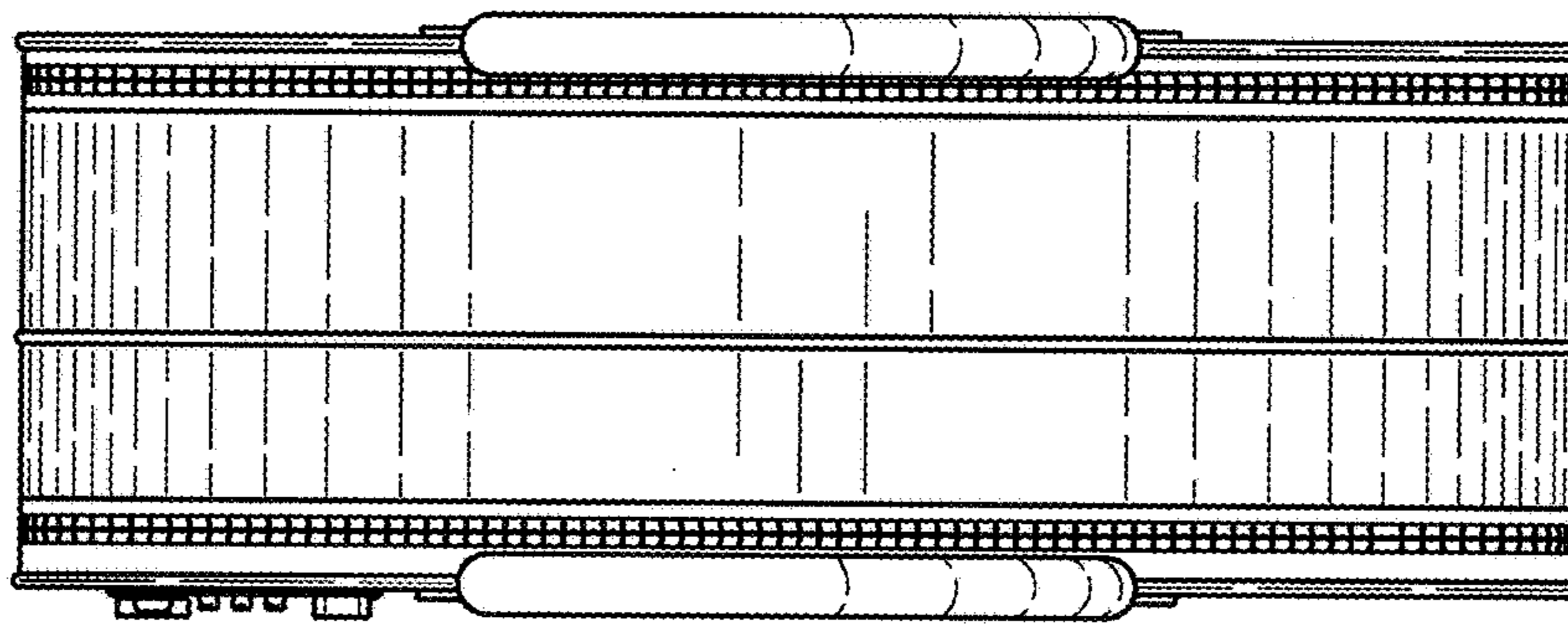
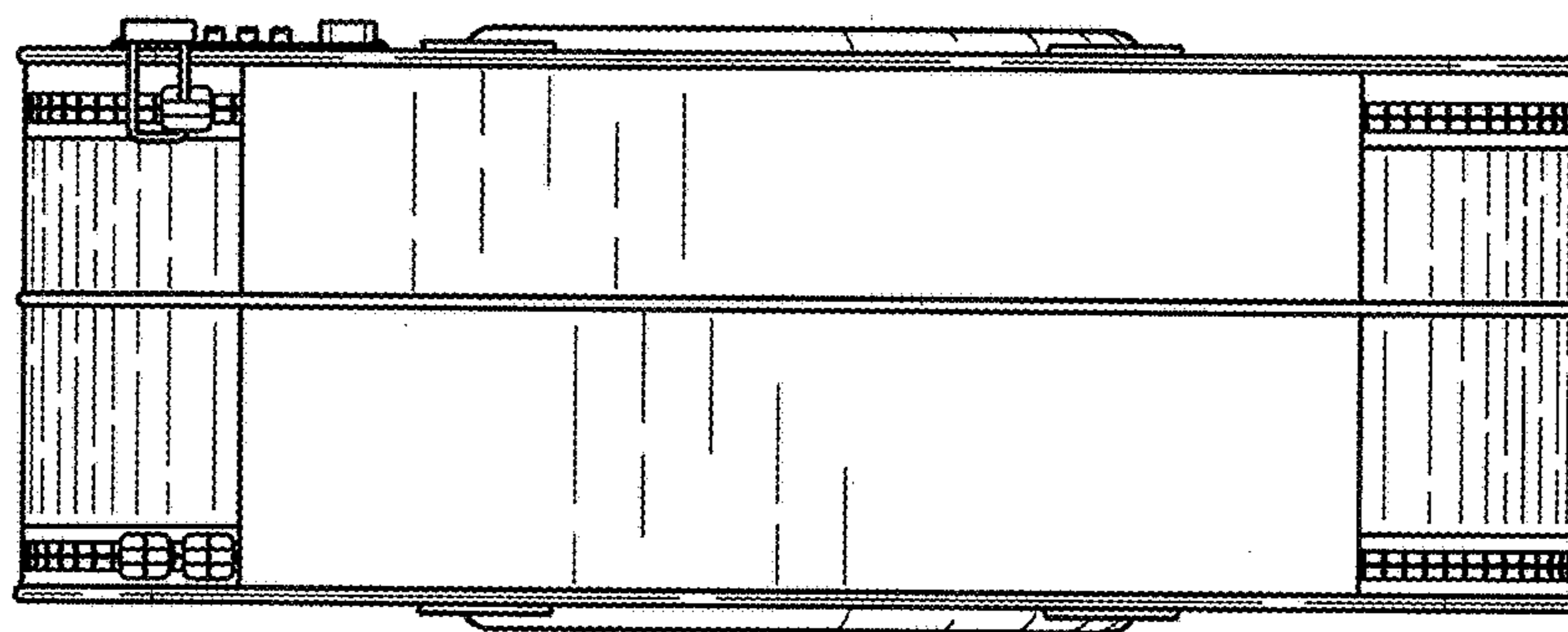


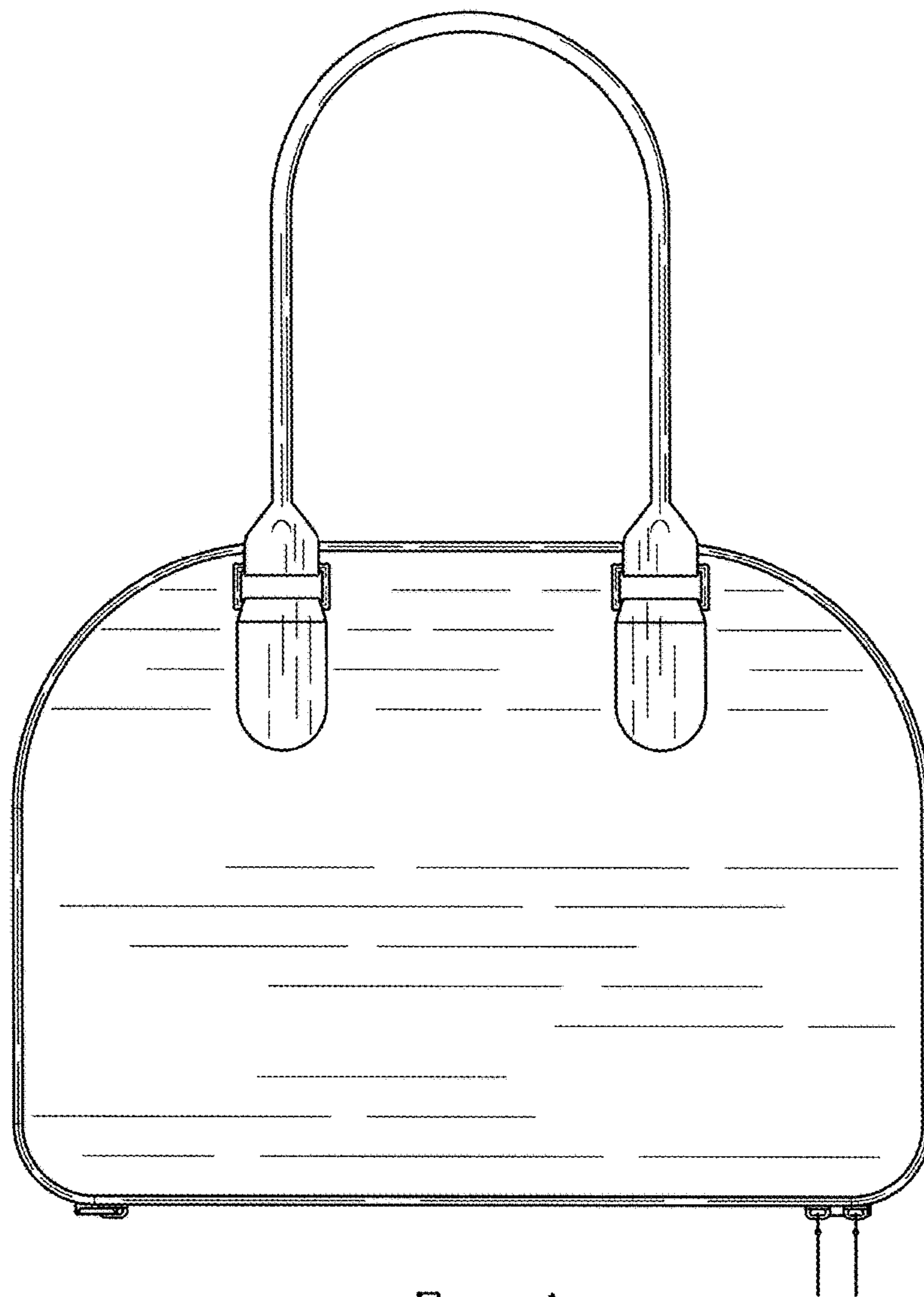

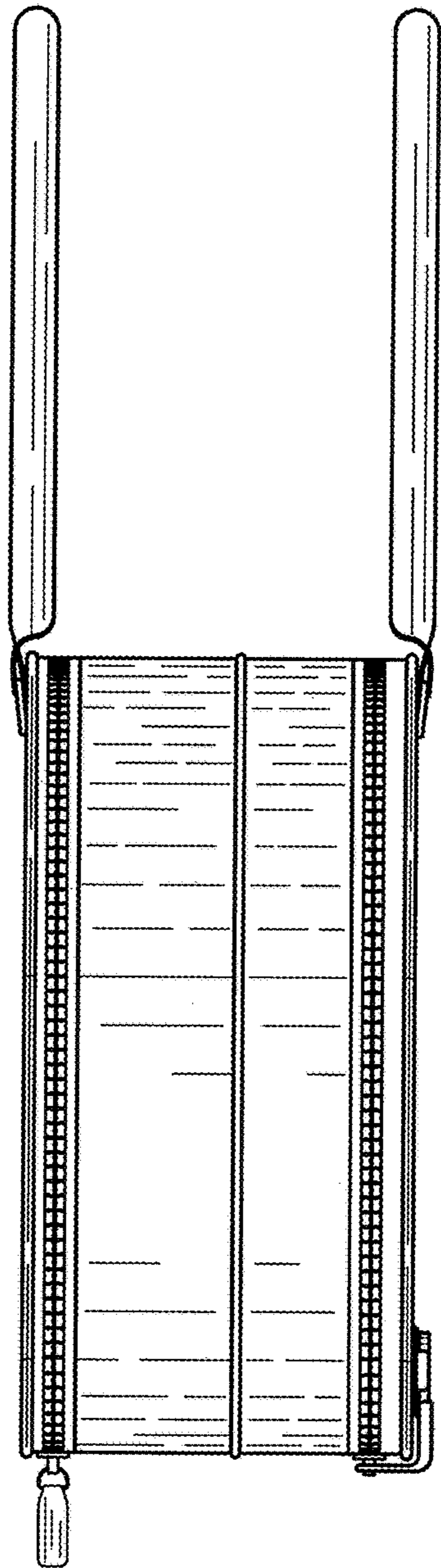

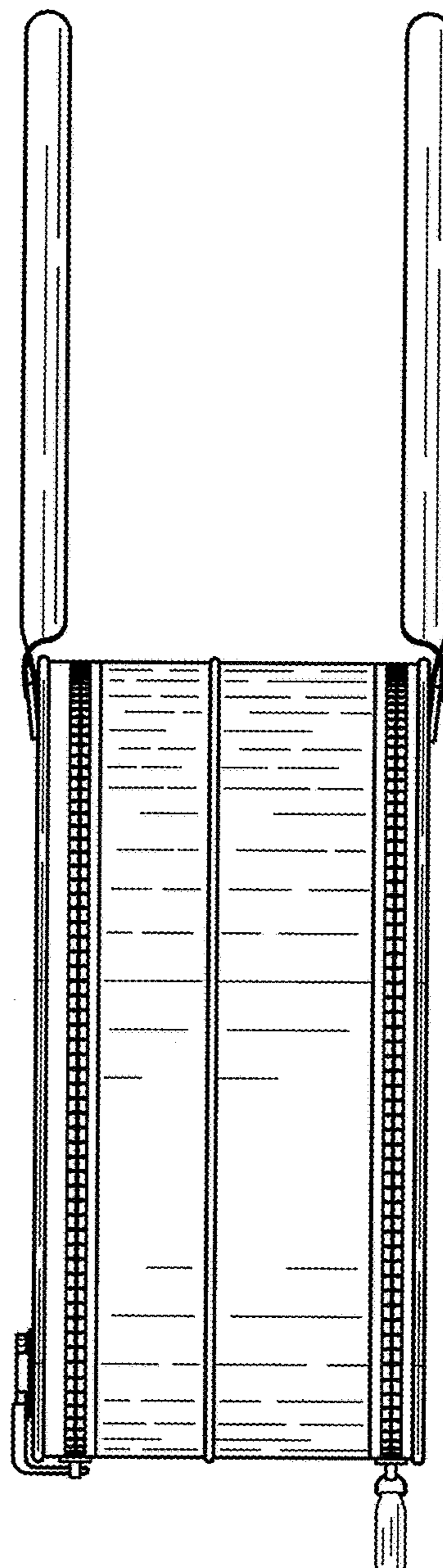
