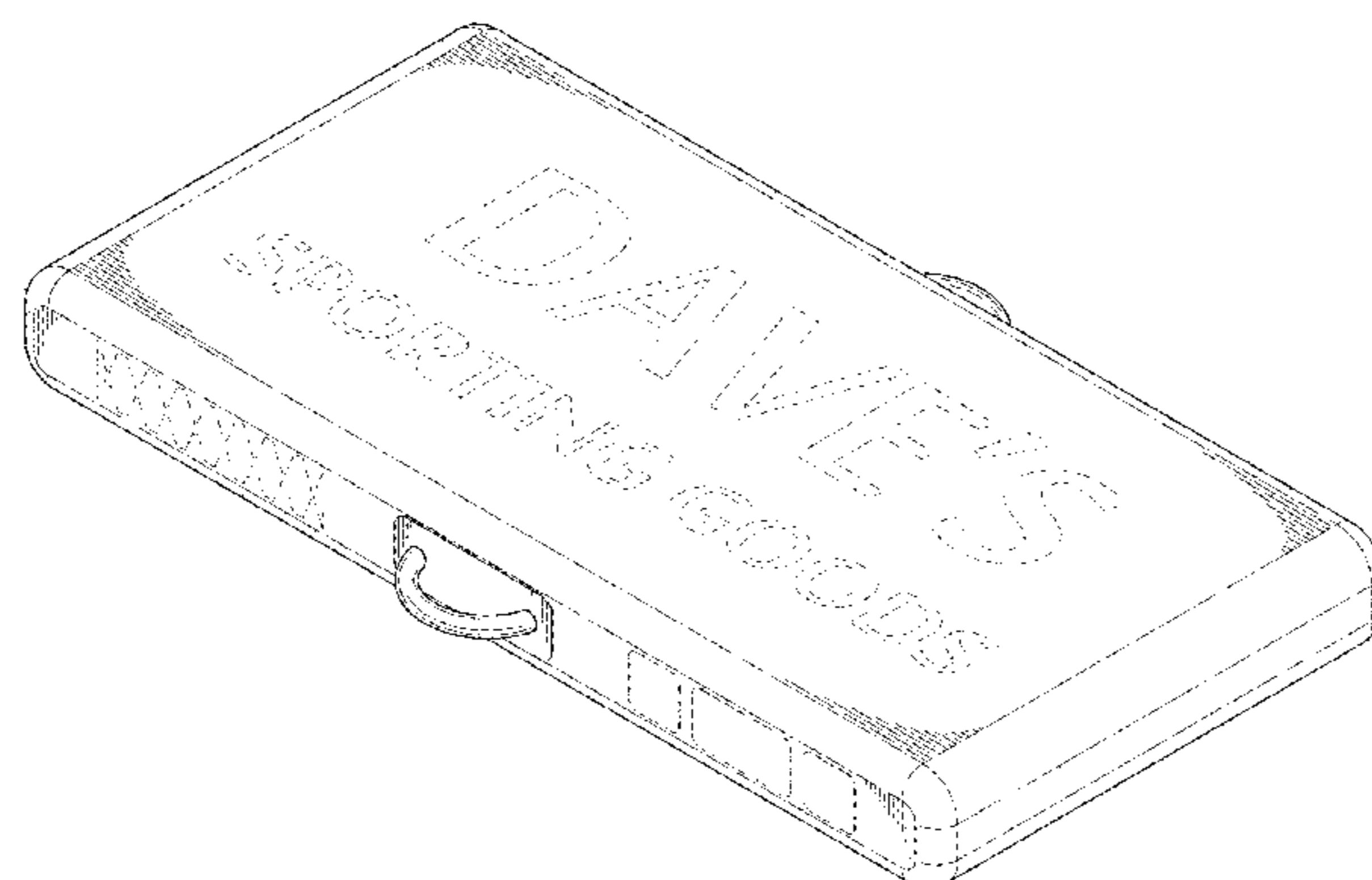
(57) **CLAIM**

The ornamental design for an inflatable activity bed, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an inflatable activity bed according to my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof; and,
FIG. 6 is a right side view thereof.

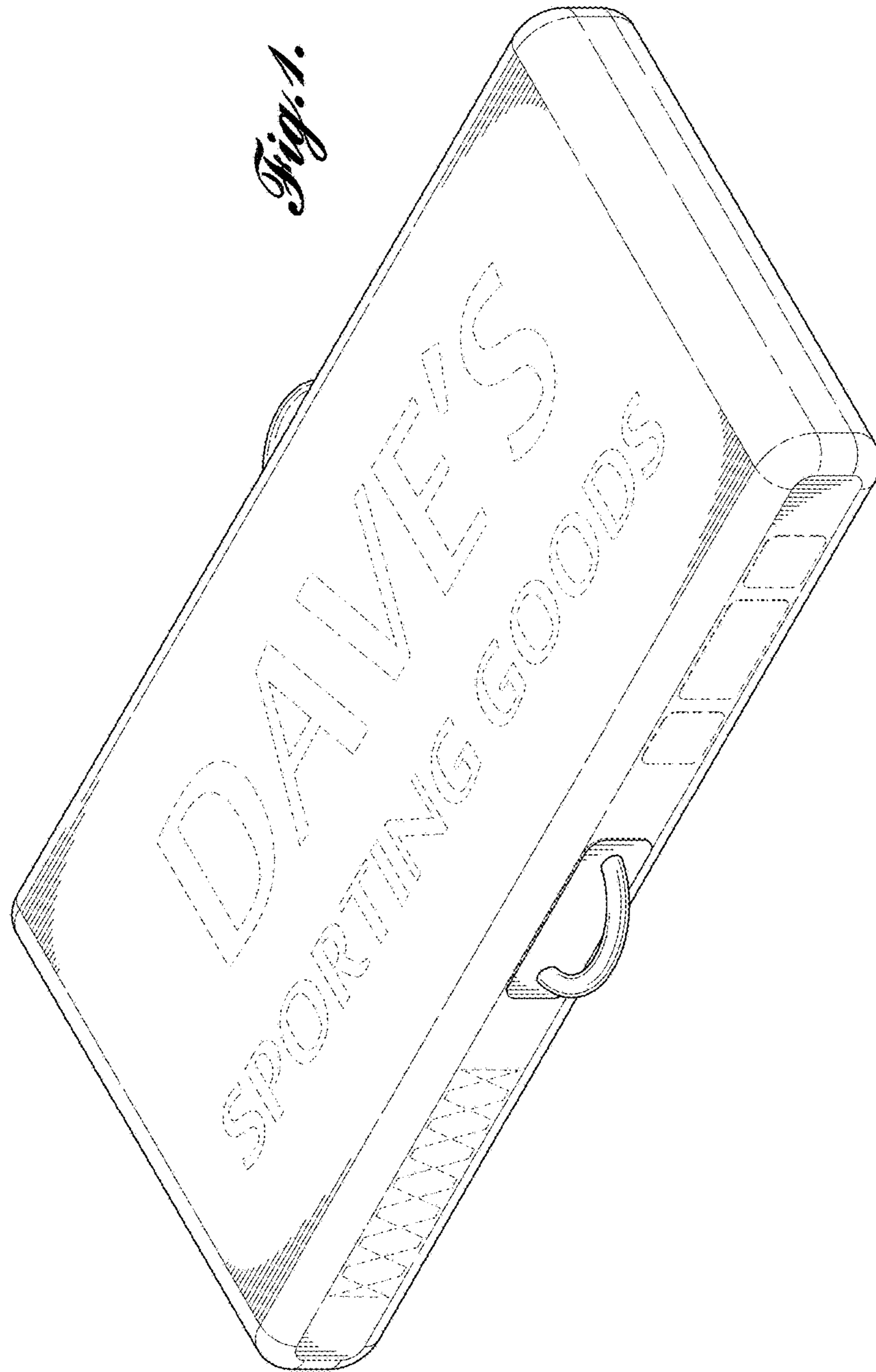

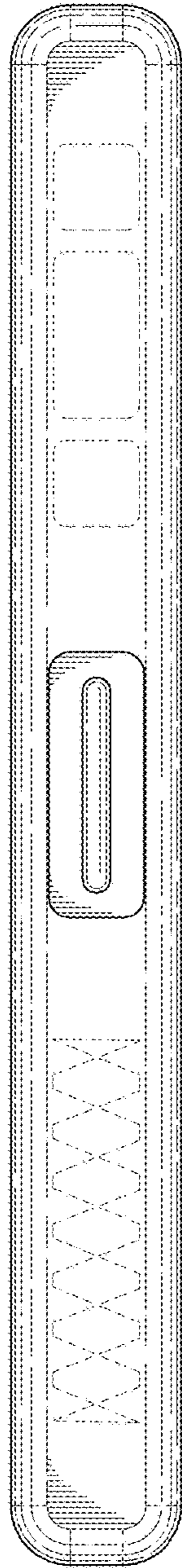

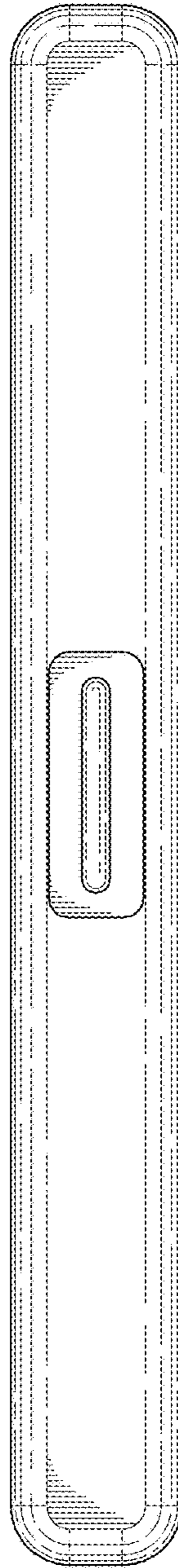

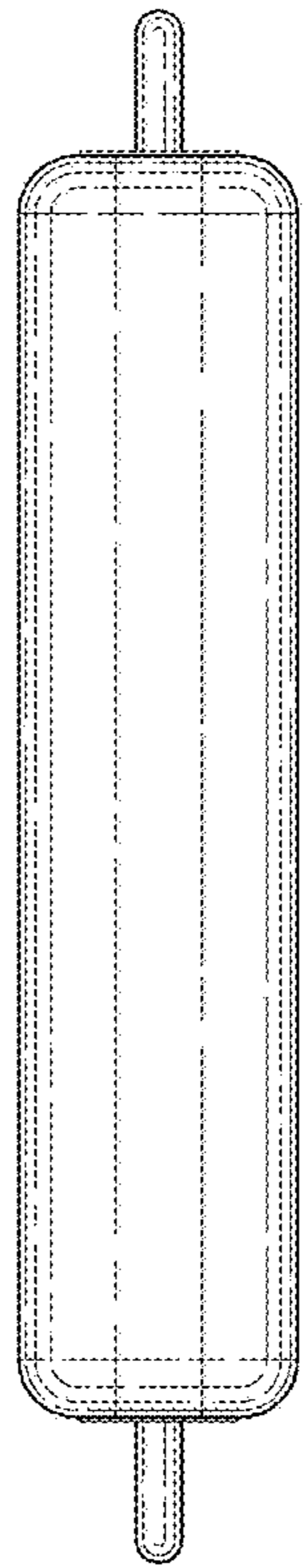

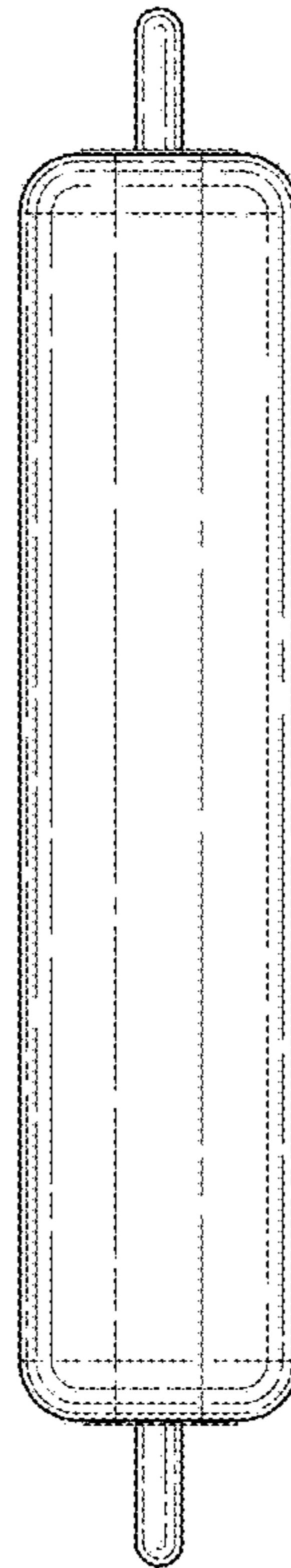
