FIG. 2 : is a left view thereof;

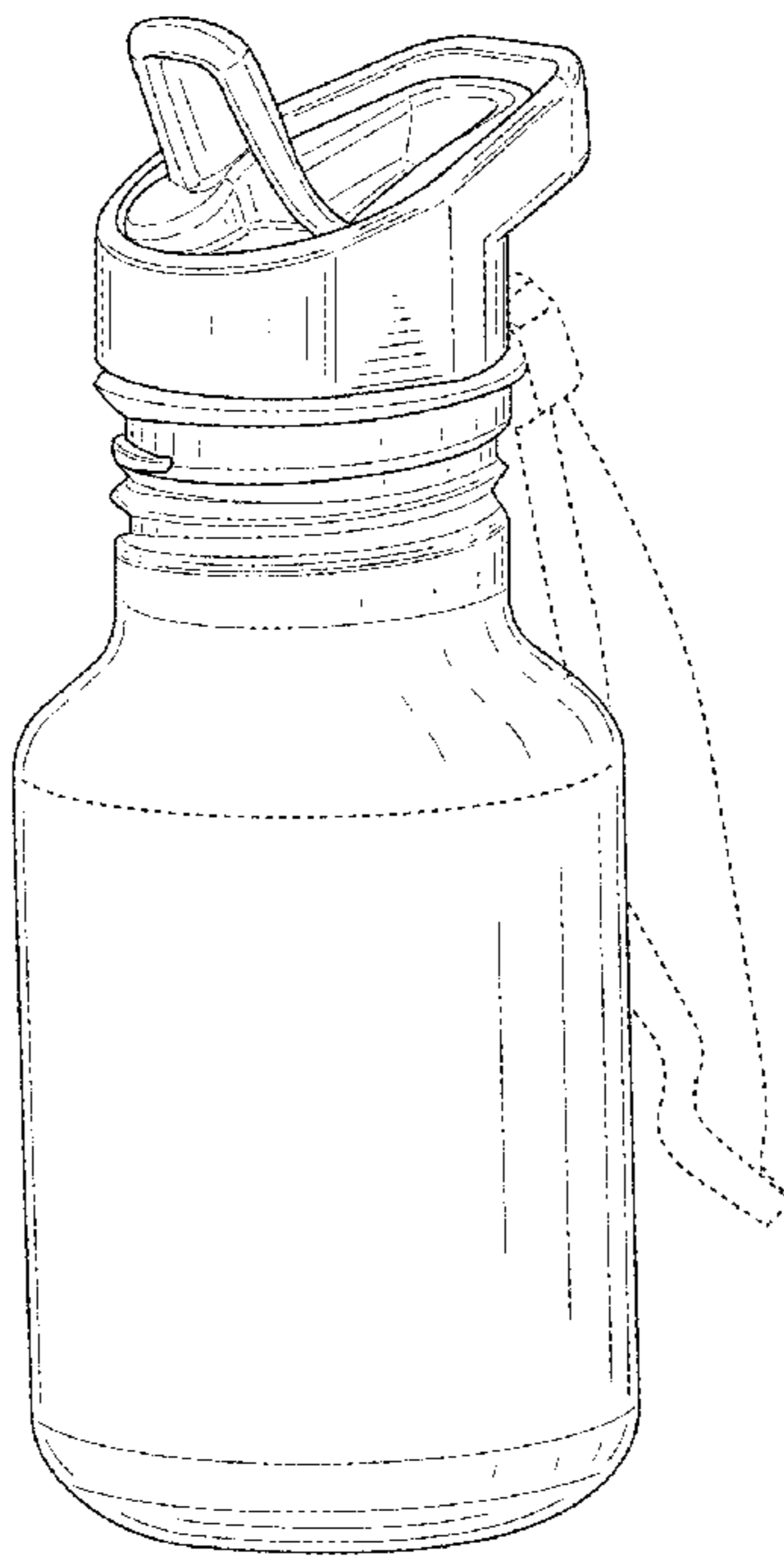
FIG. 3 : is a front view thereof;

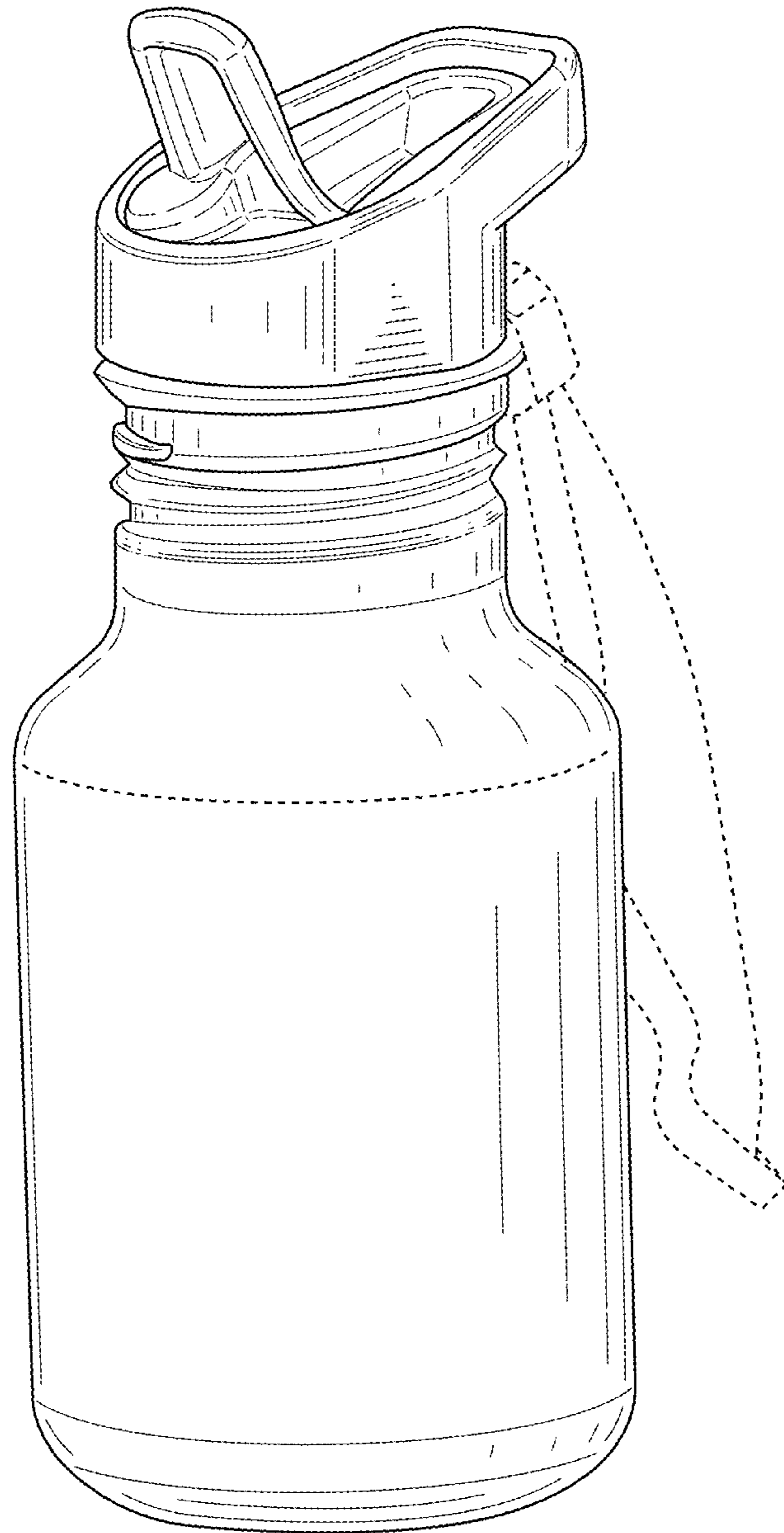

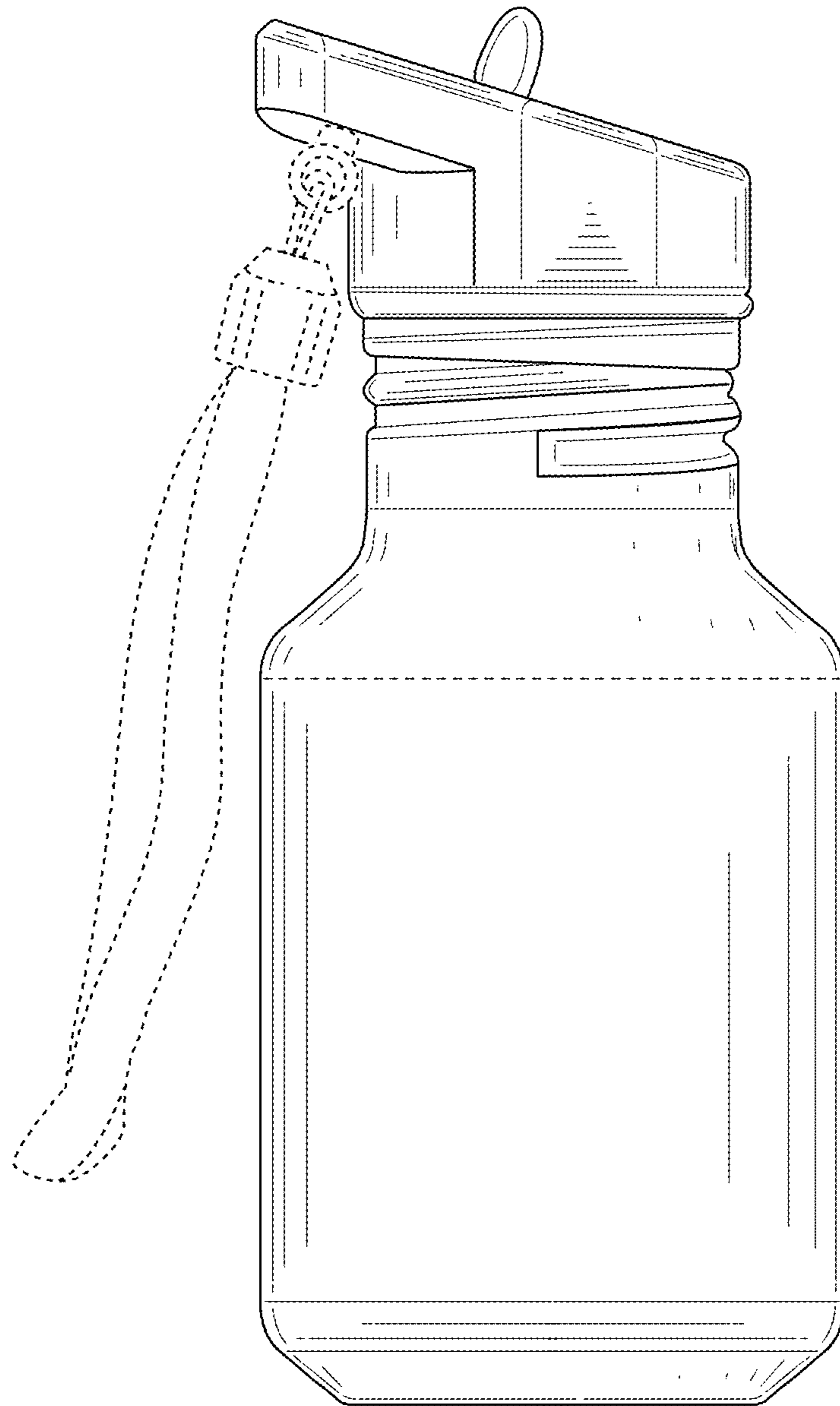

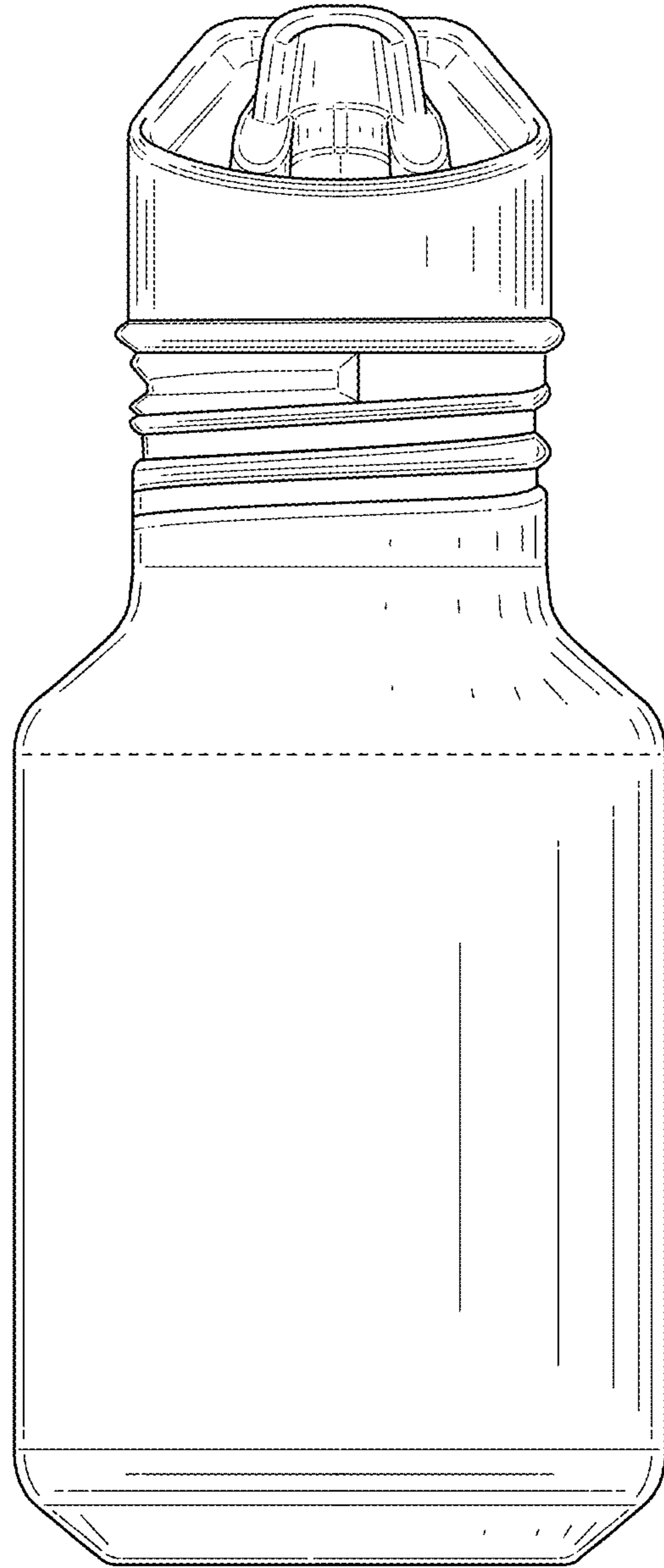

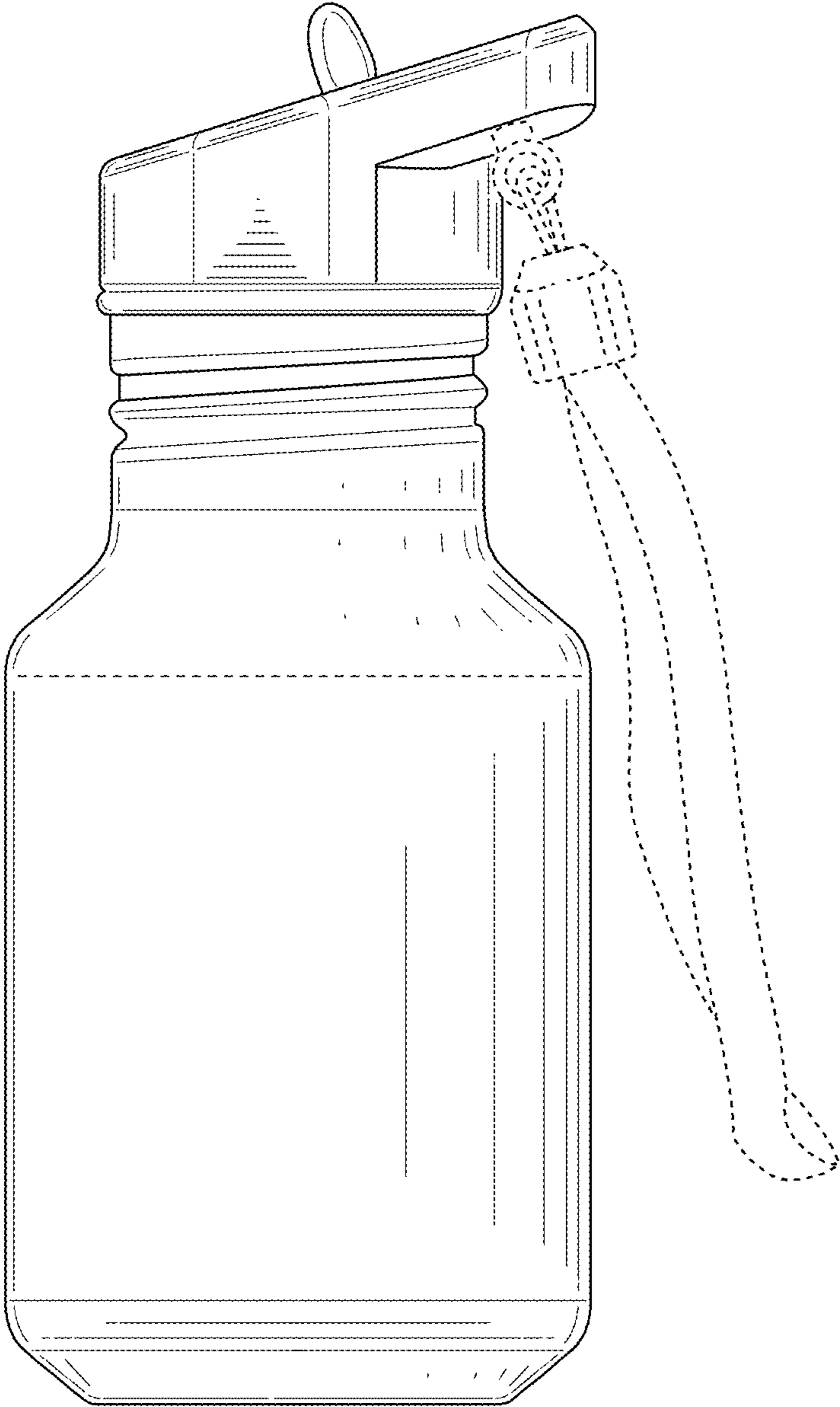

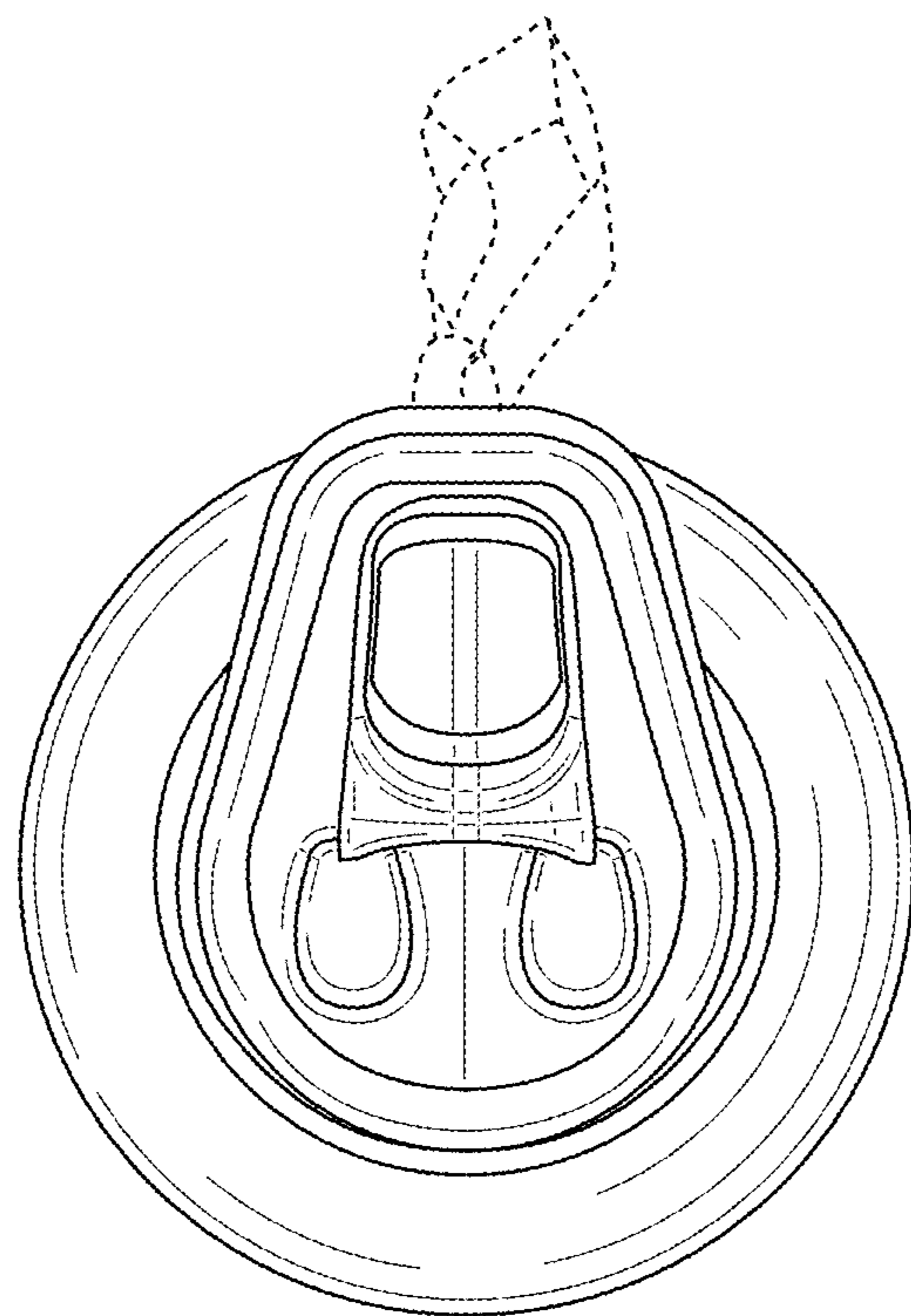
