(57) **CLAIM**

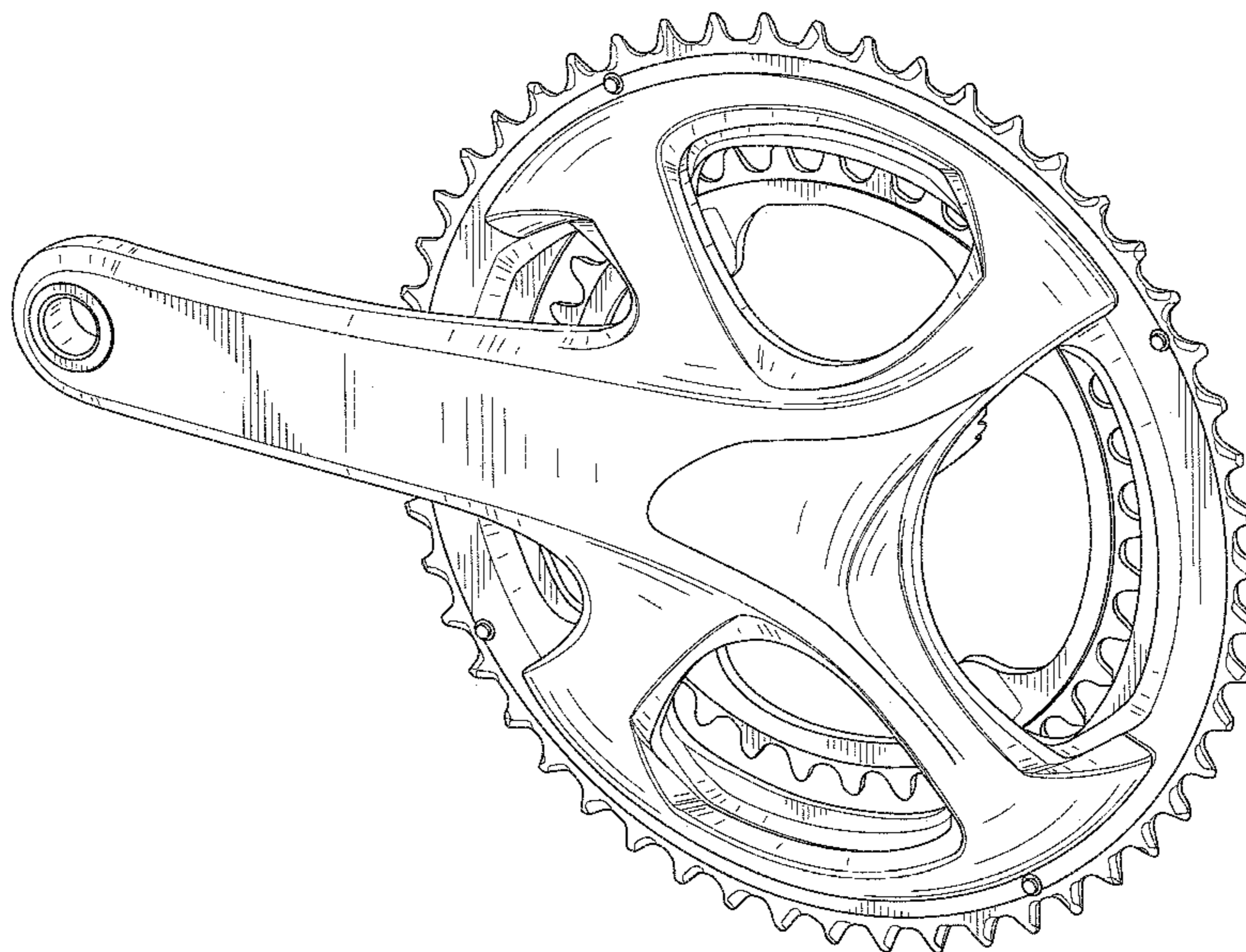
The ornamental design for a pedal crank assembly for cycles or motorcycles, as shown and described.

DESCRIPTION

FIG. 1 is a top and front perspective view of a pedal crank assembly for cycles or motorcycles showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a left side elevation view thereof; and, FIG. 7 is a right side elevation view thereof.

The broken lines in the drawings illustrate portions of the pedal crank assembly for cycles and motorcycles that form no part of the claimed design.

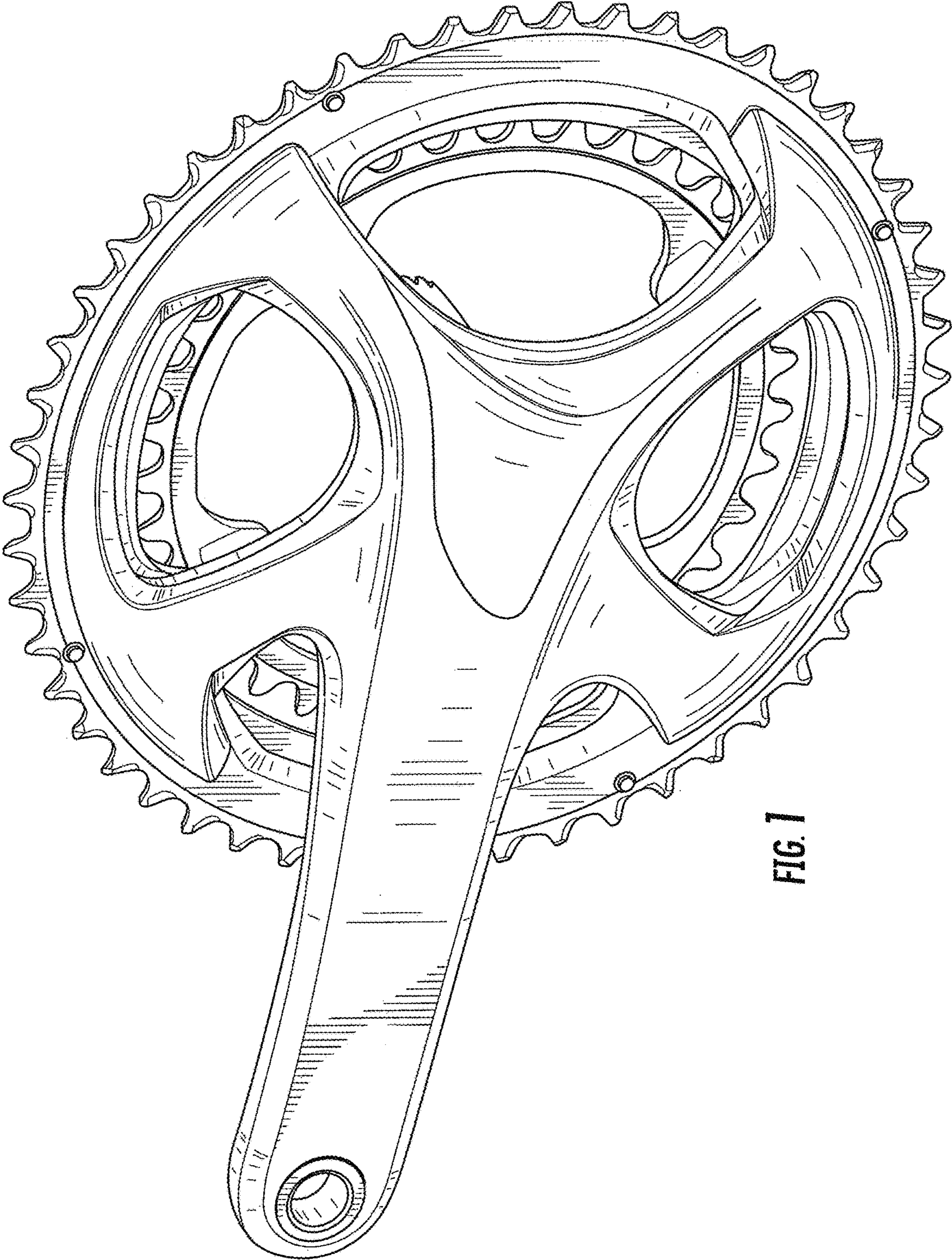

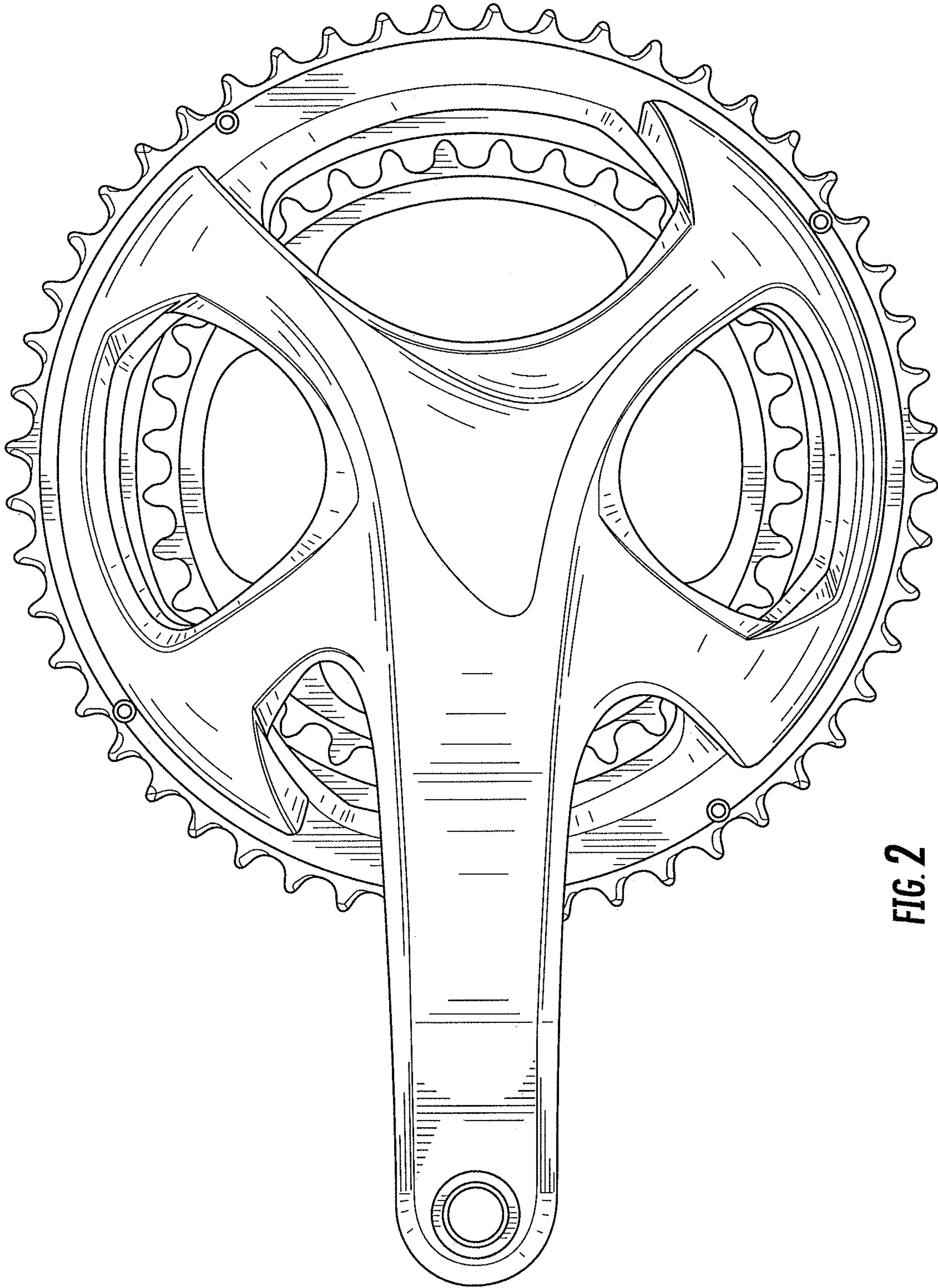

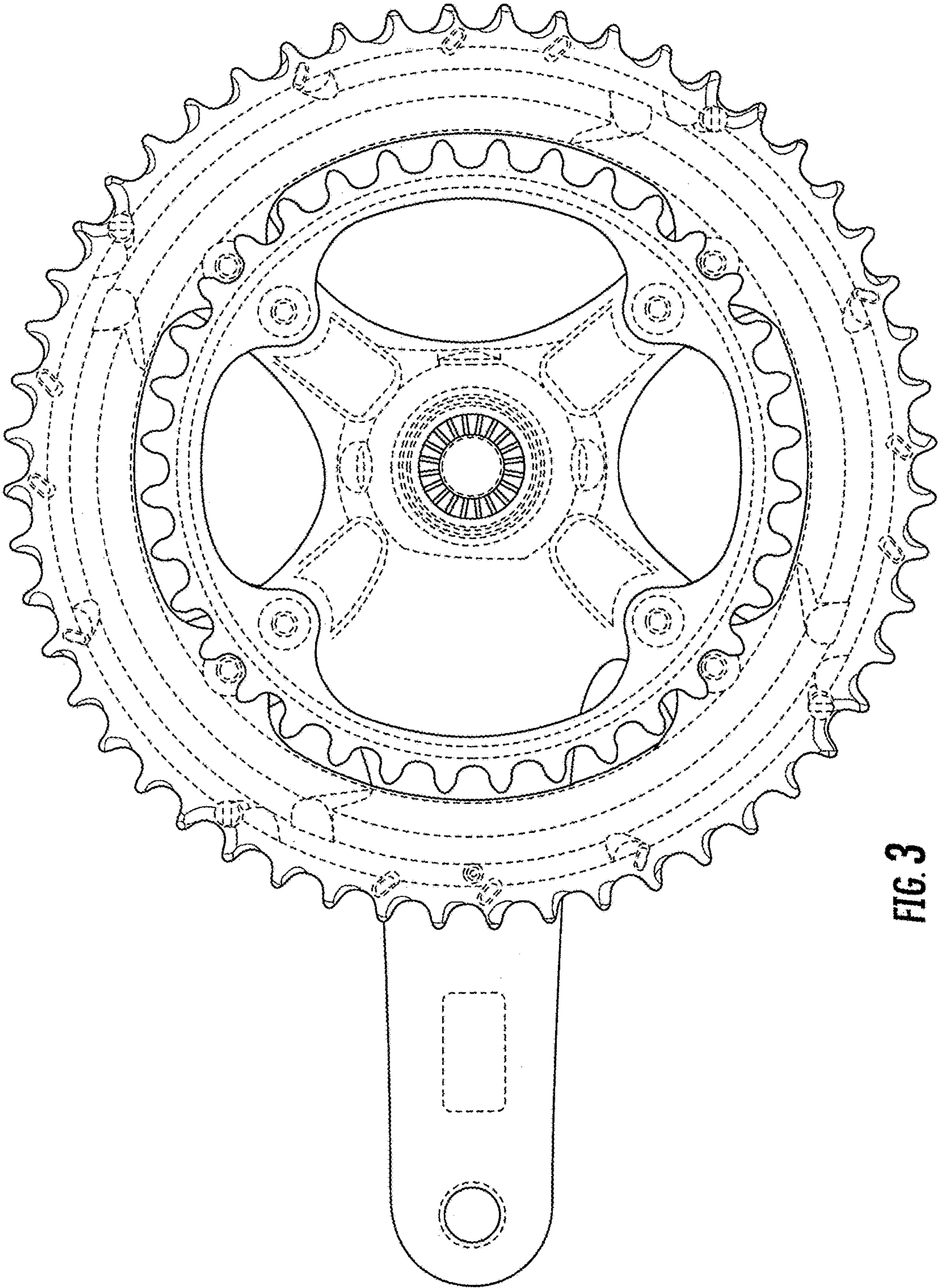

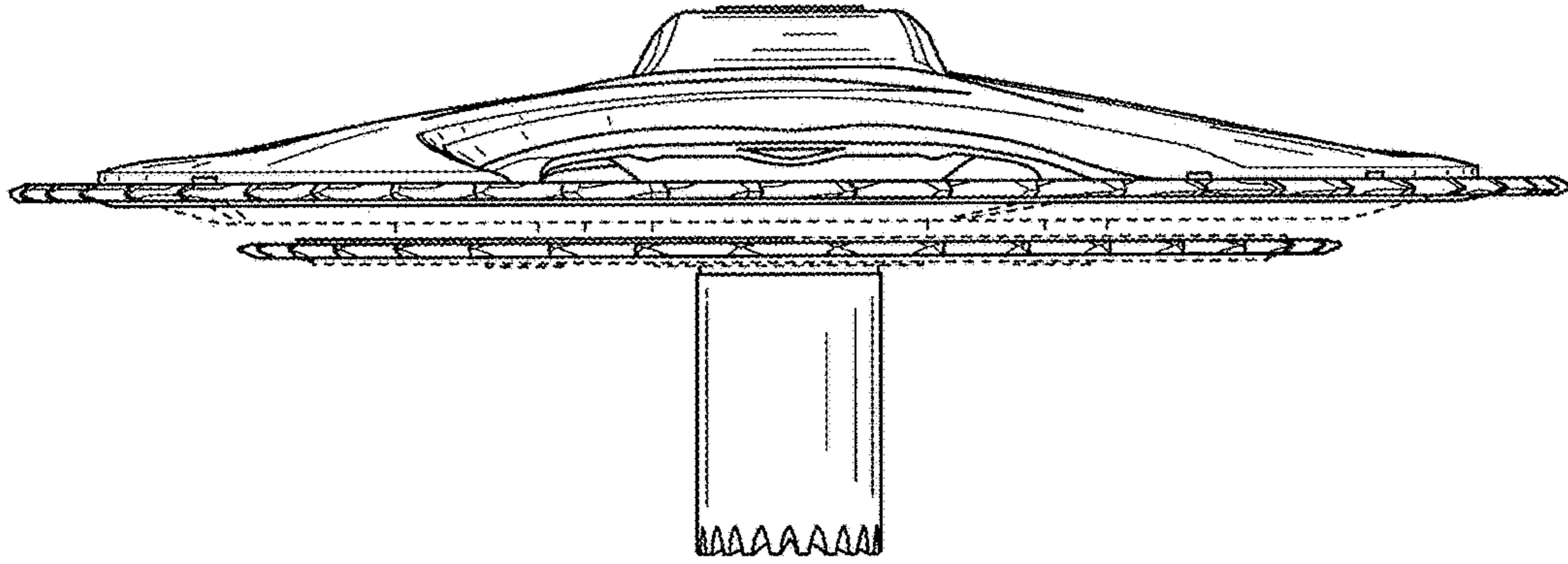

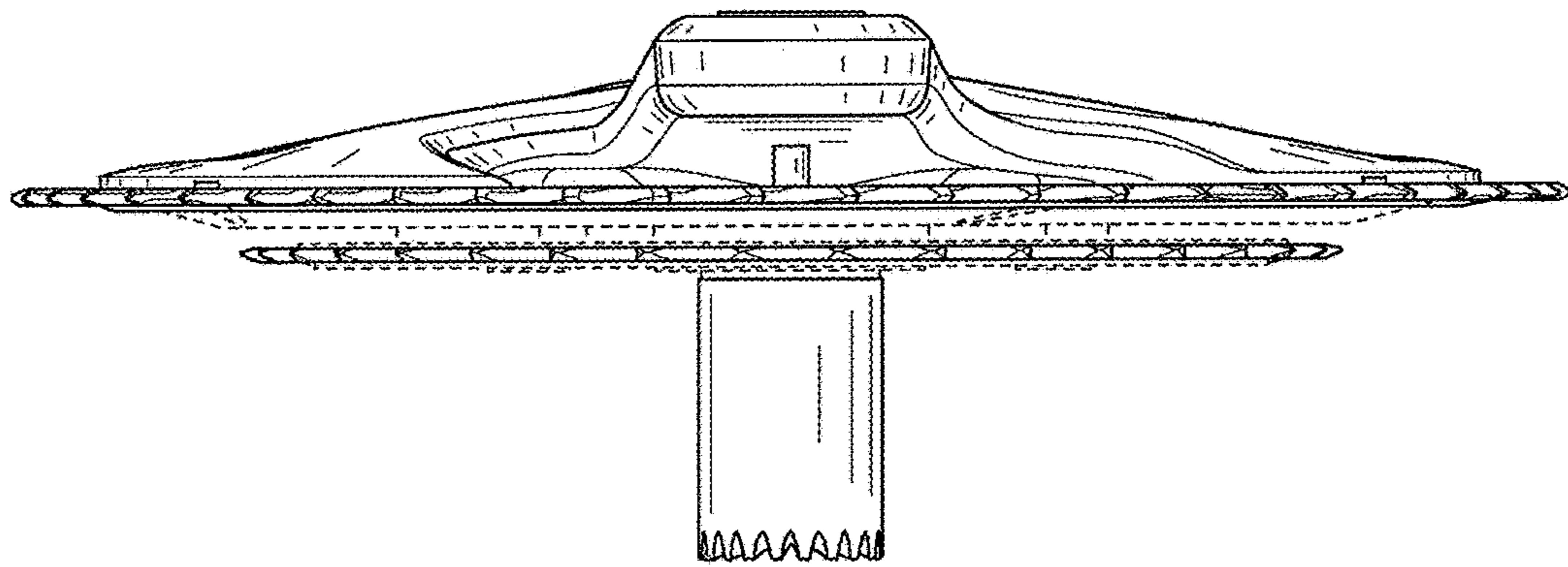

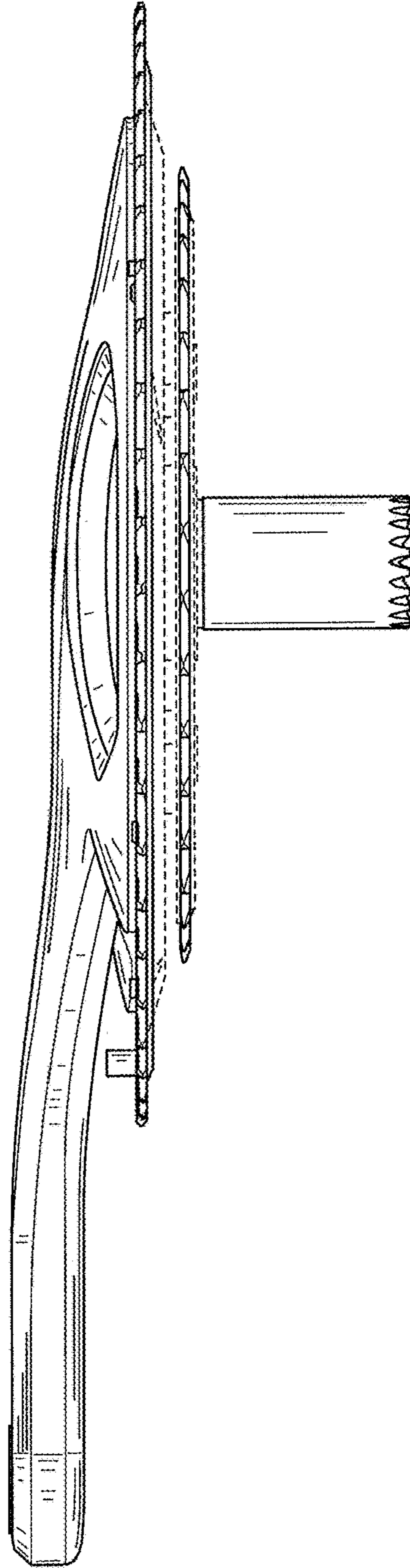

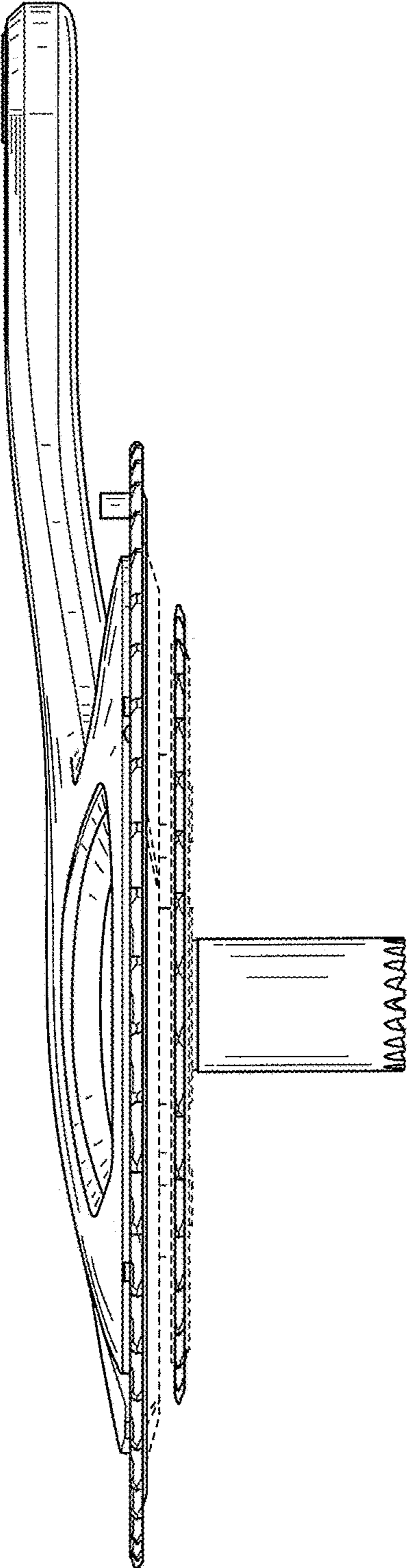
