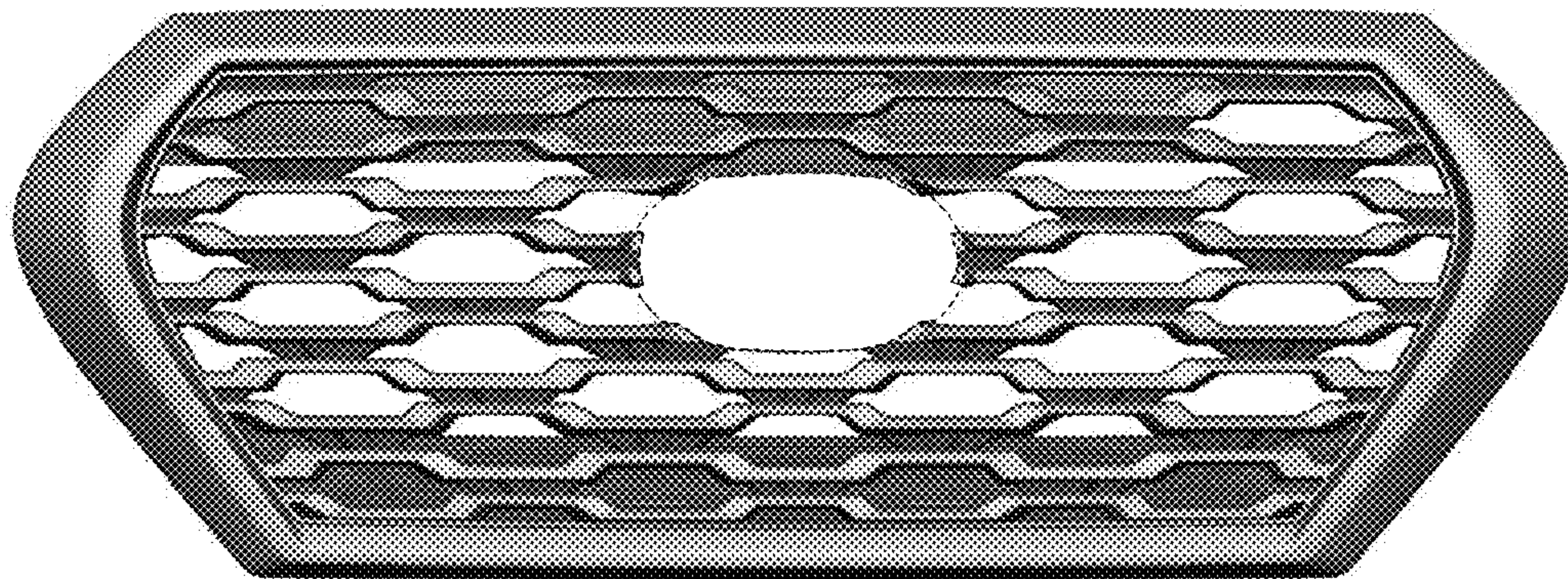
(57) **CLAIM**

The ornamental design for a radiator grille for an automobile, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a radiator grille for an automobile in accordance with our new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a bottom, front and left side perspective view thereof; and,

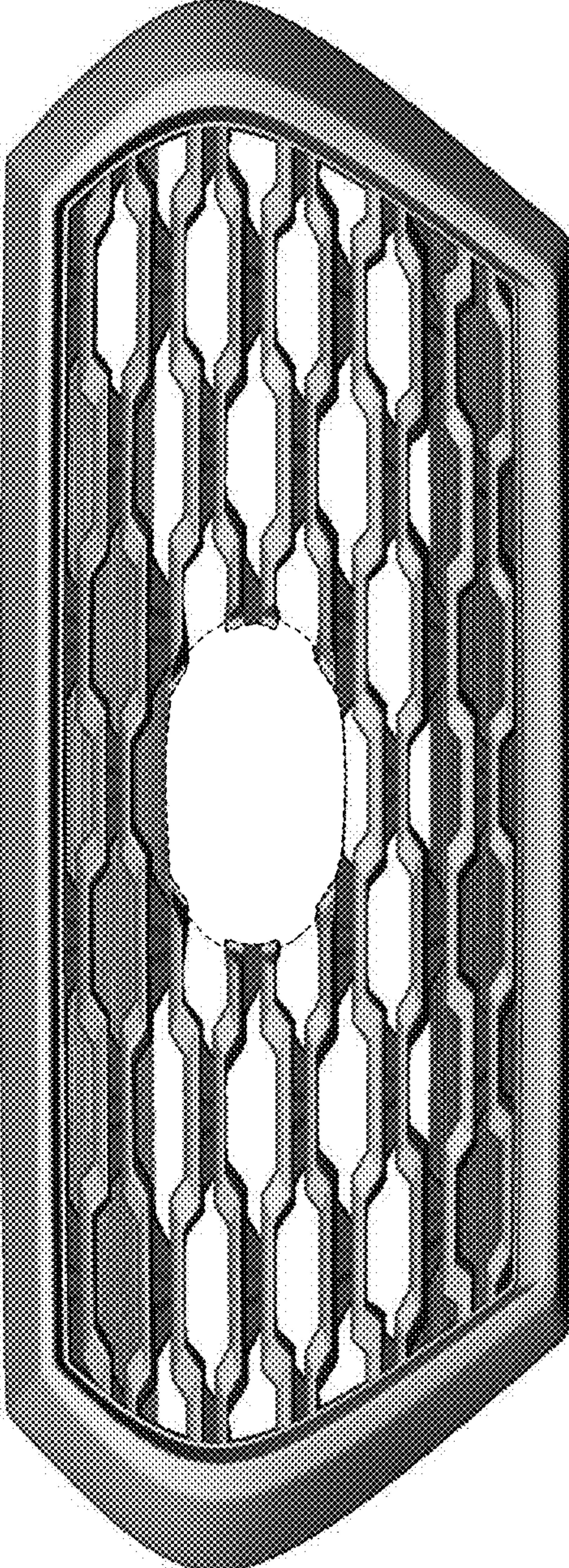

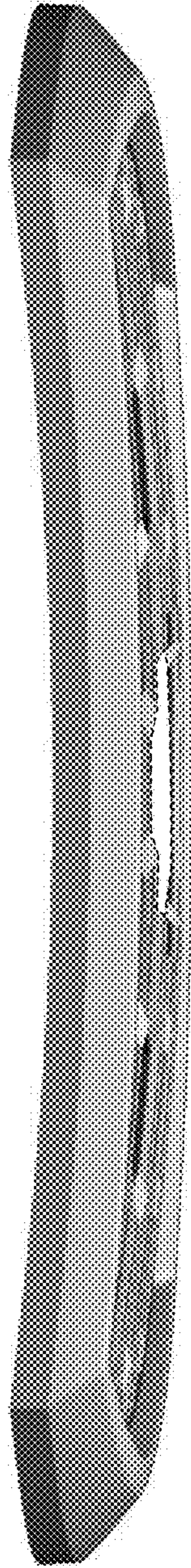

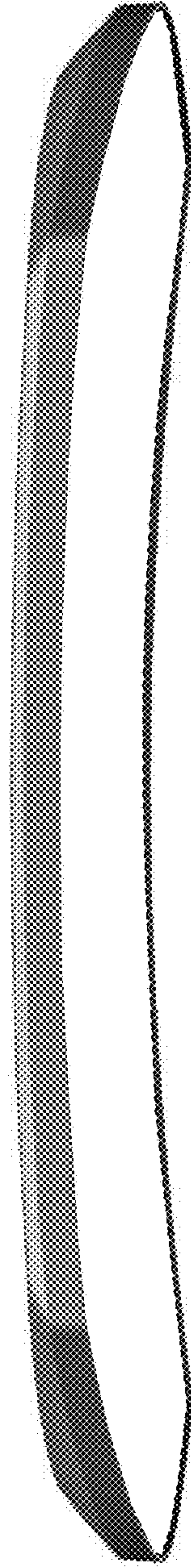

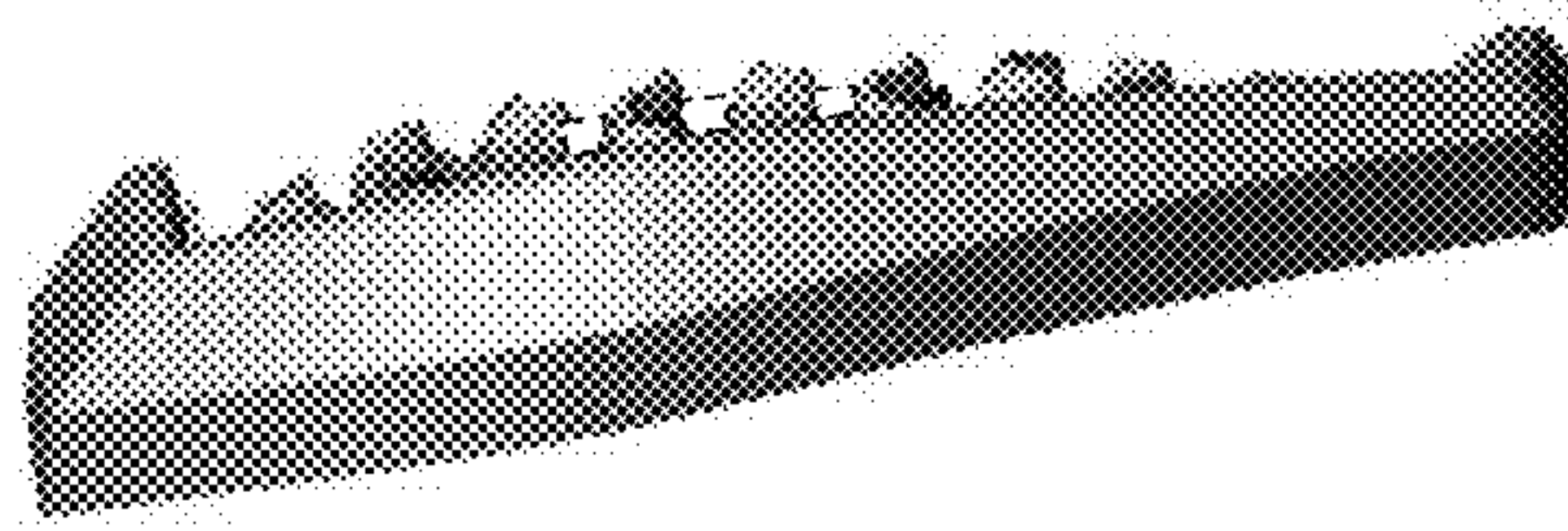

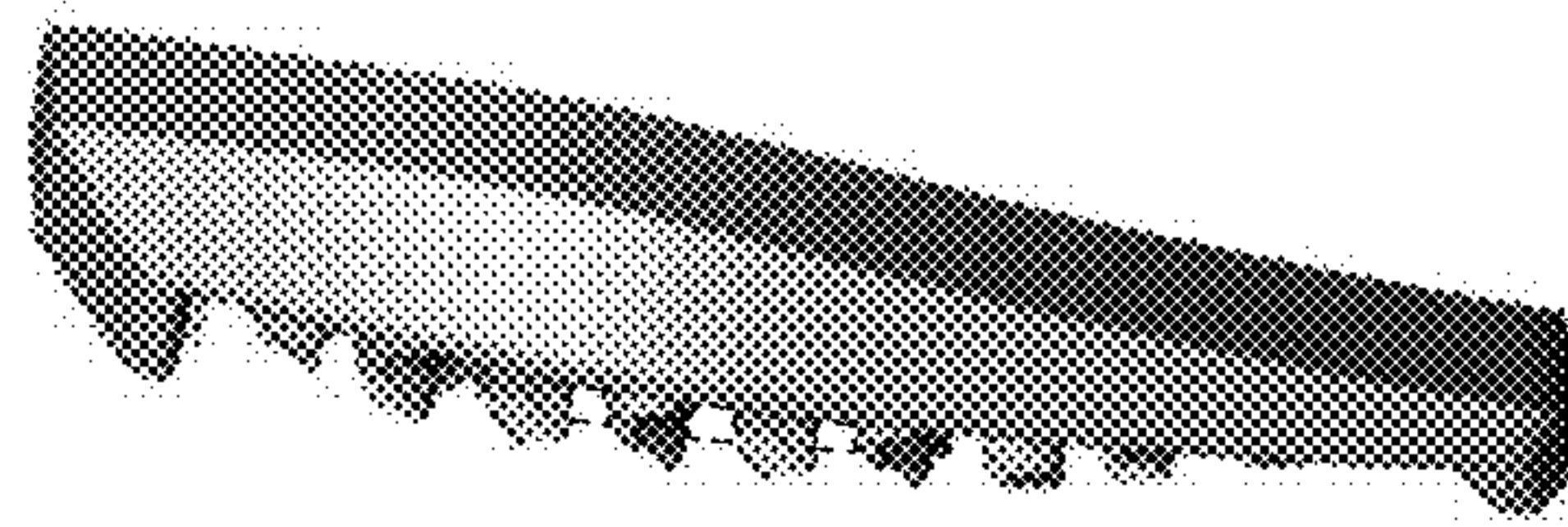

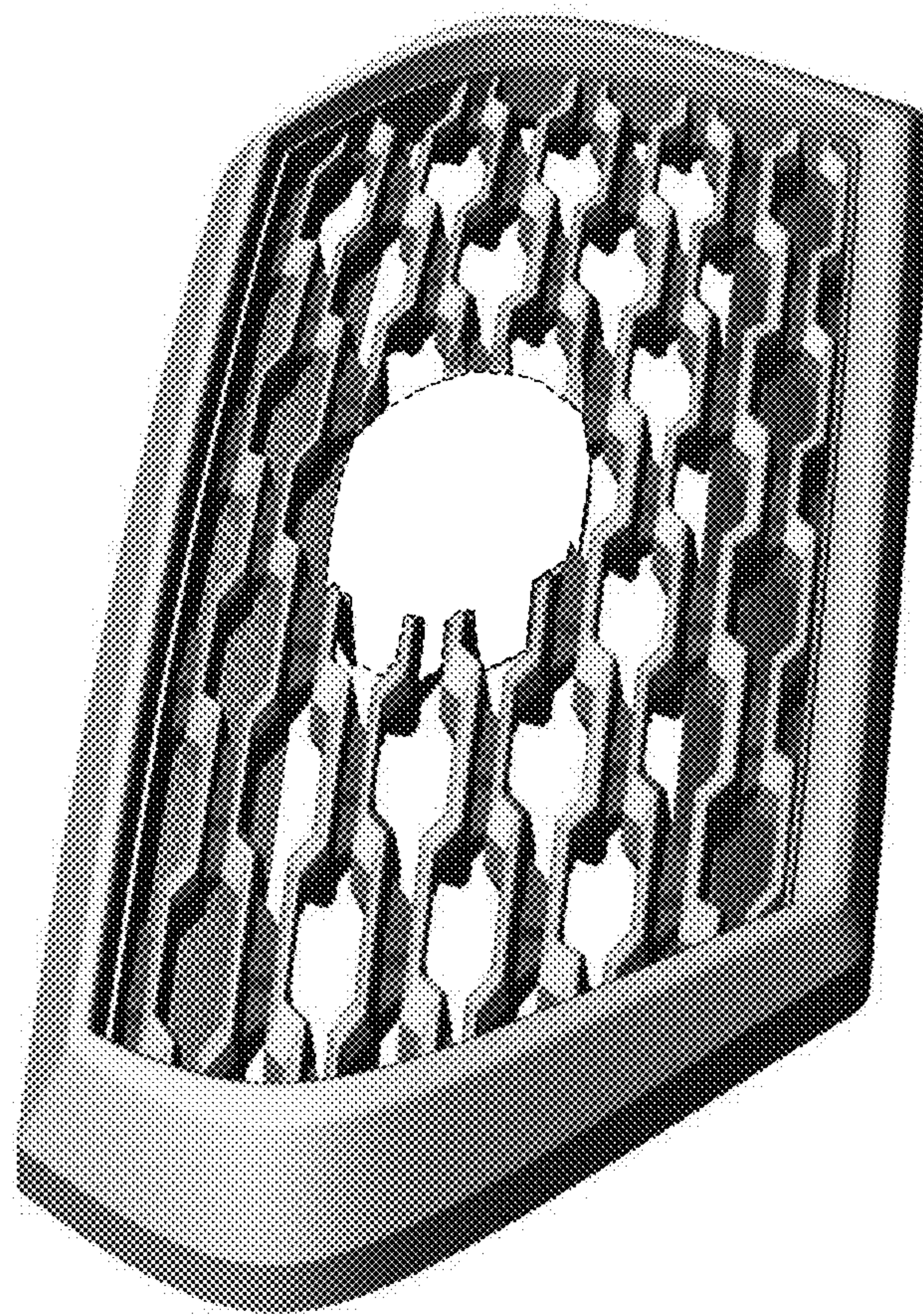

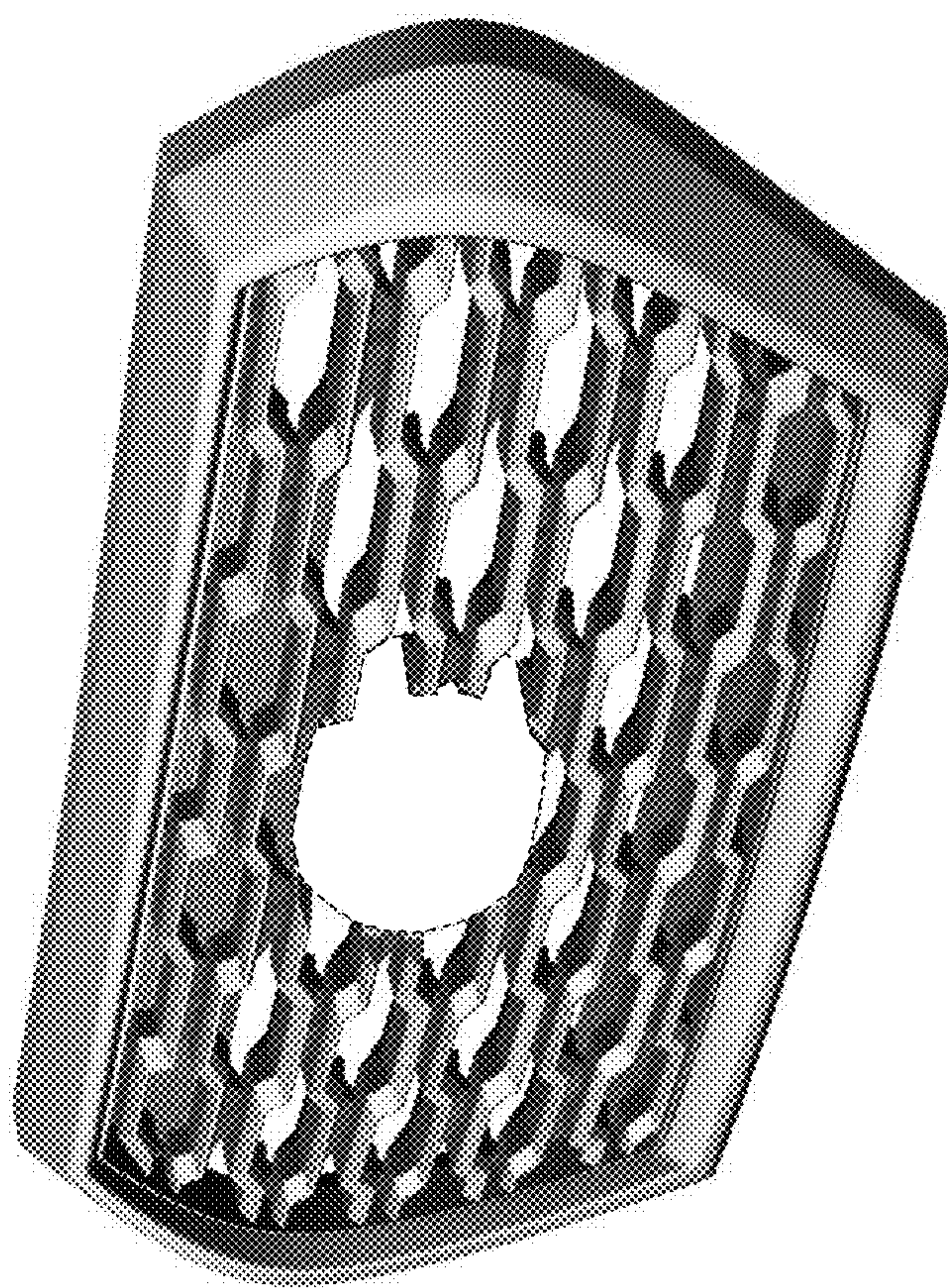
