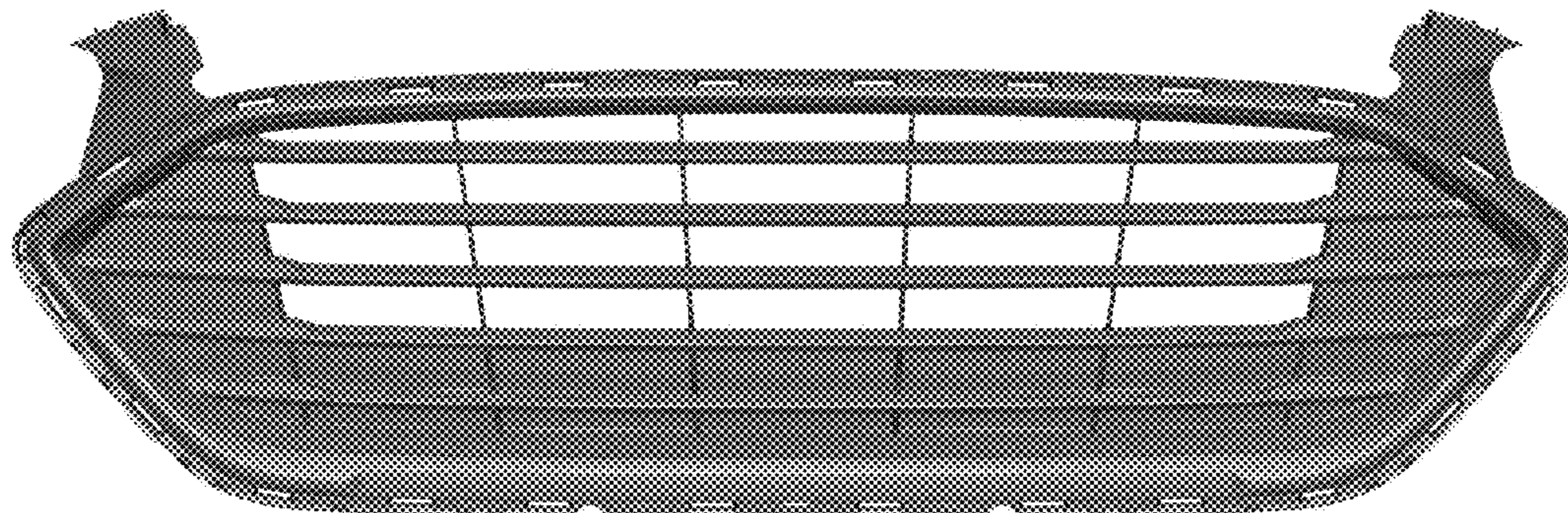
The ornamental design for a vehicle front upper grille, as shown and described.

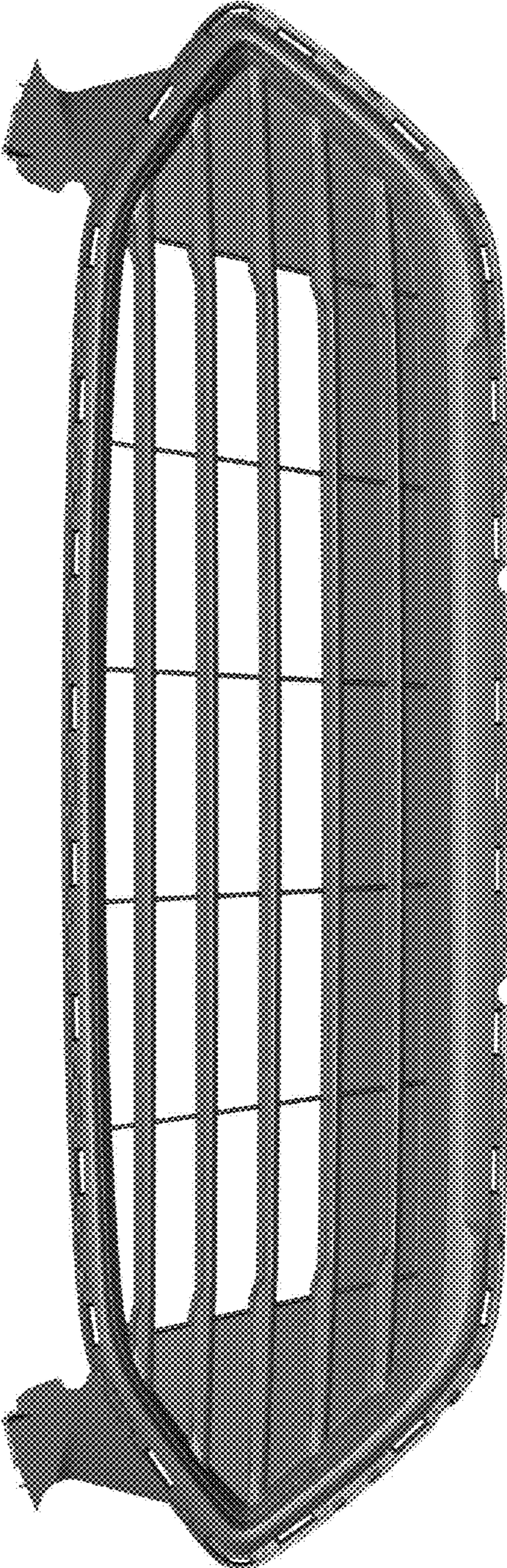

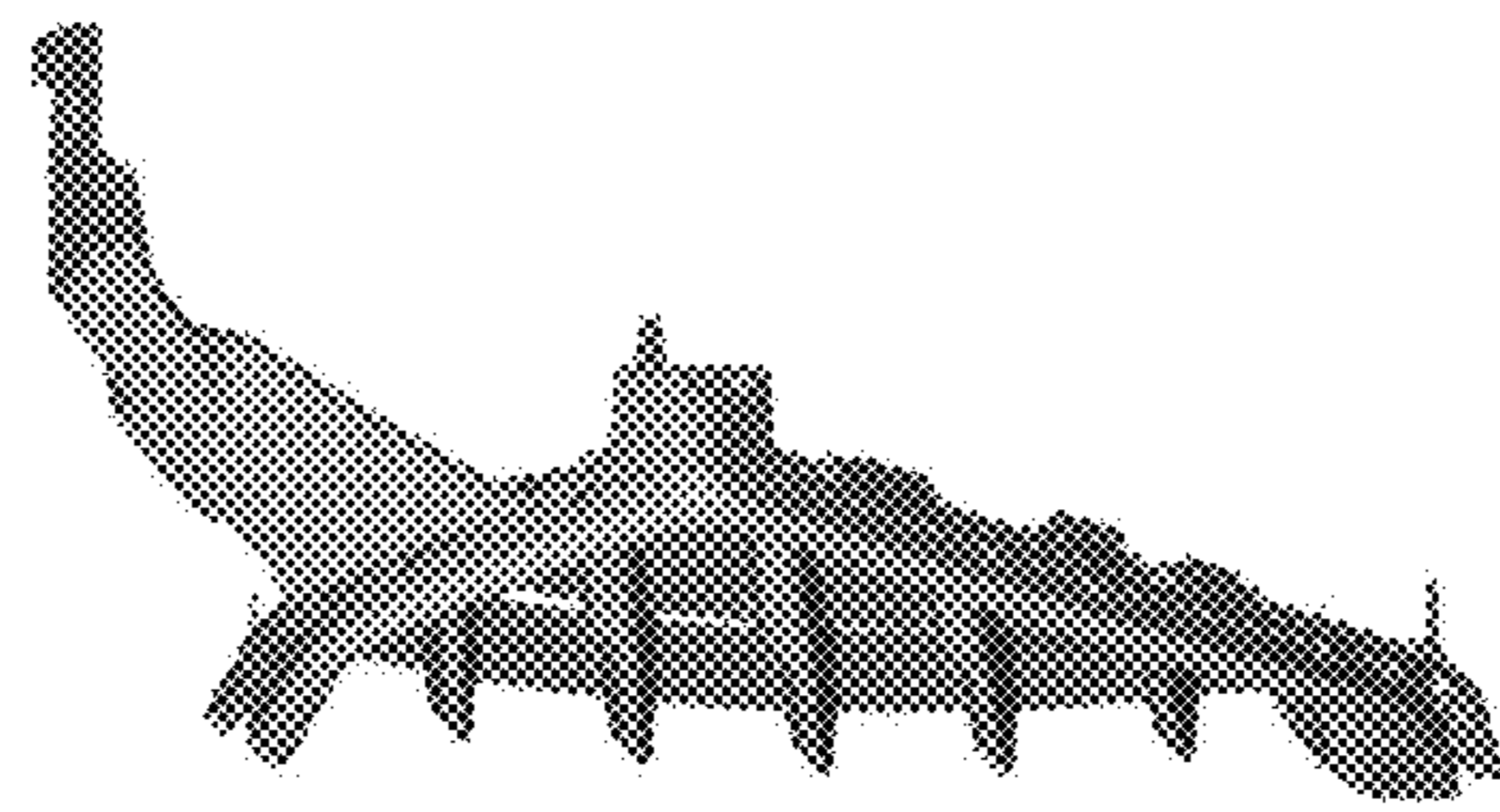

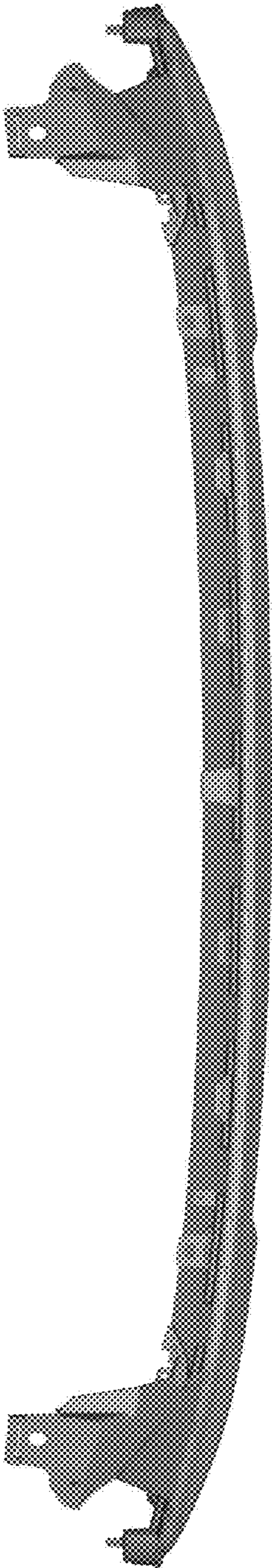
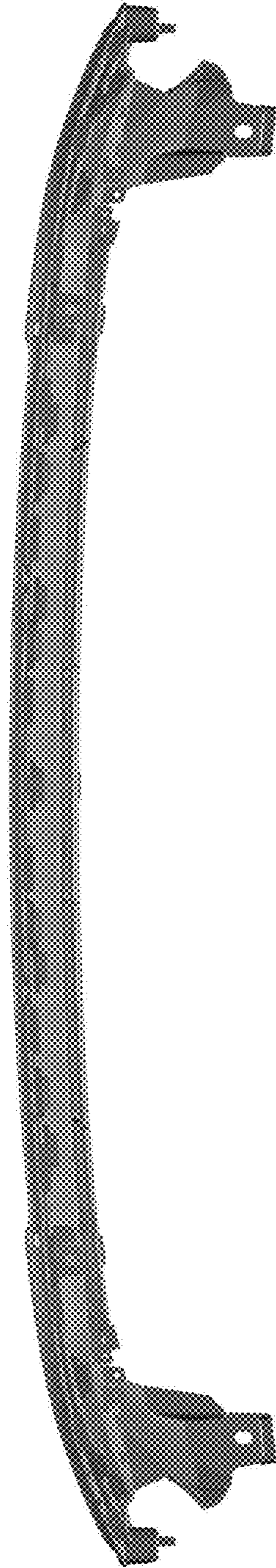

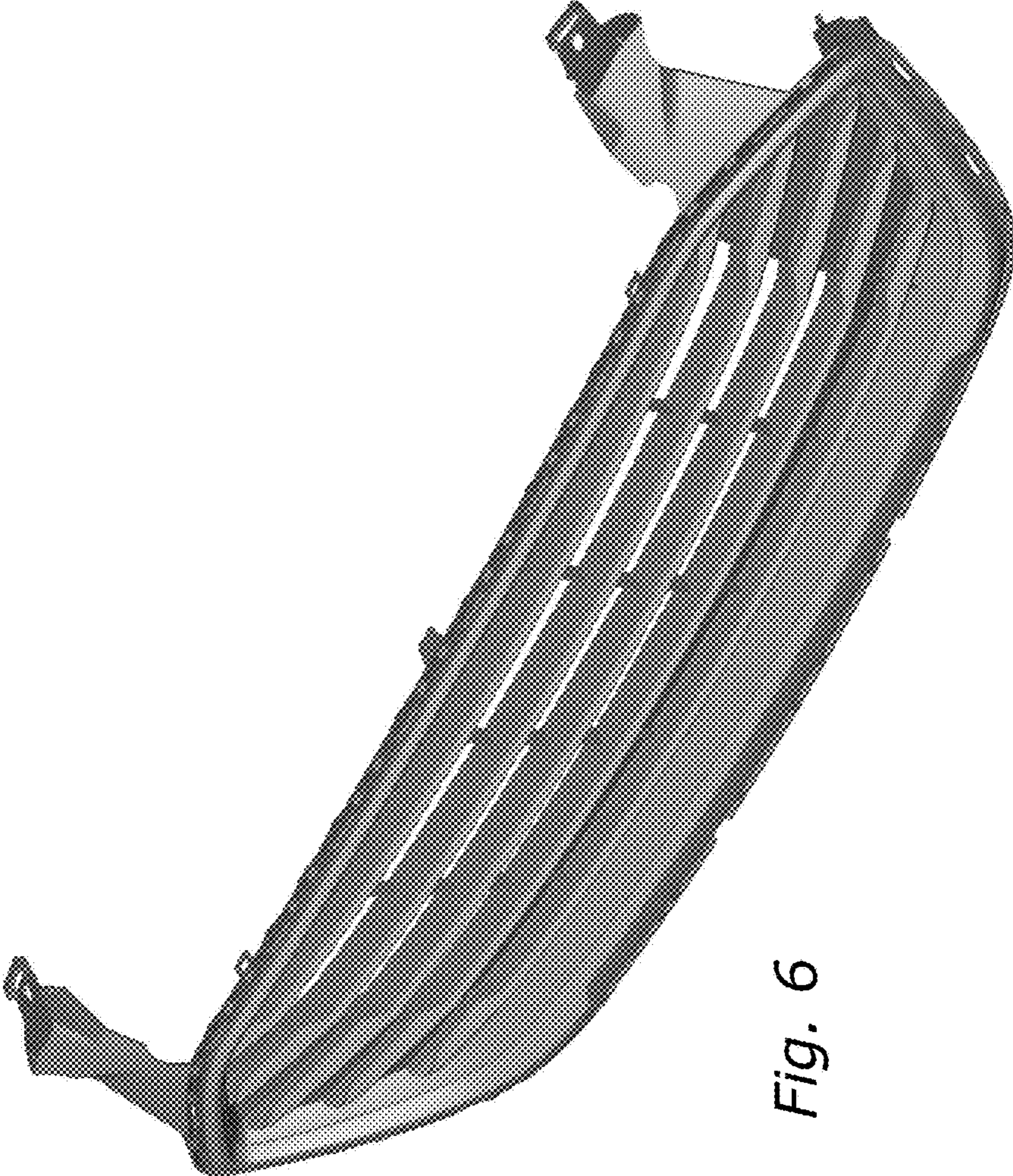

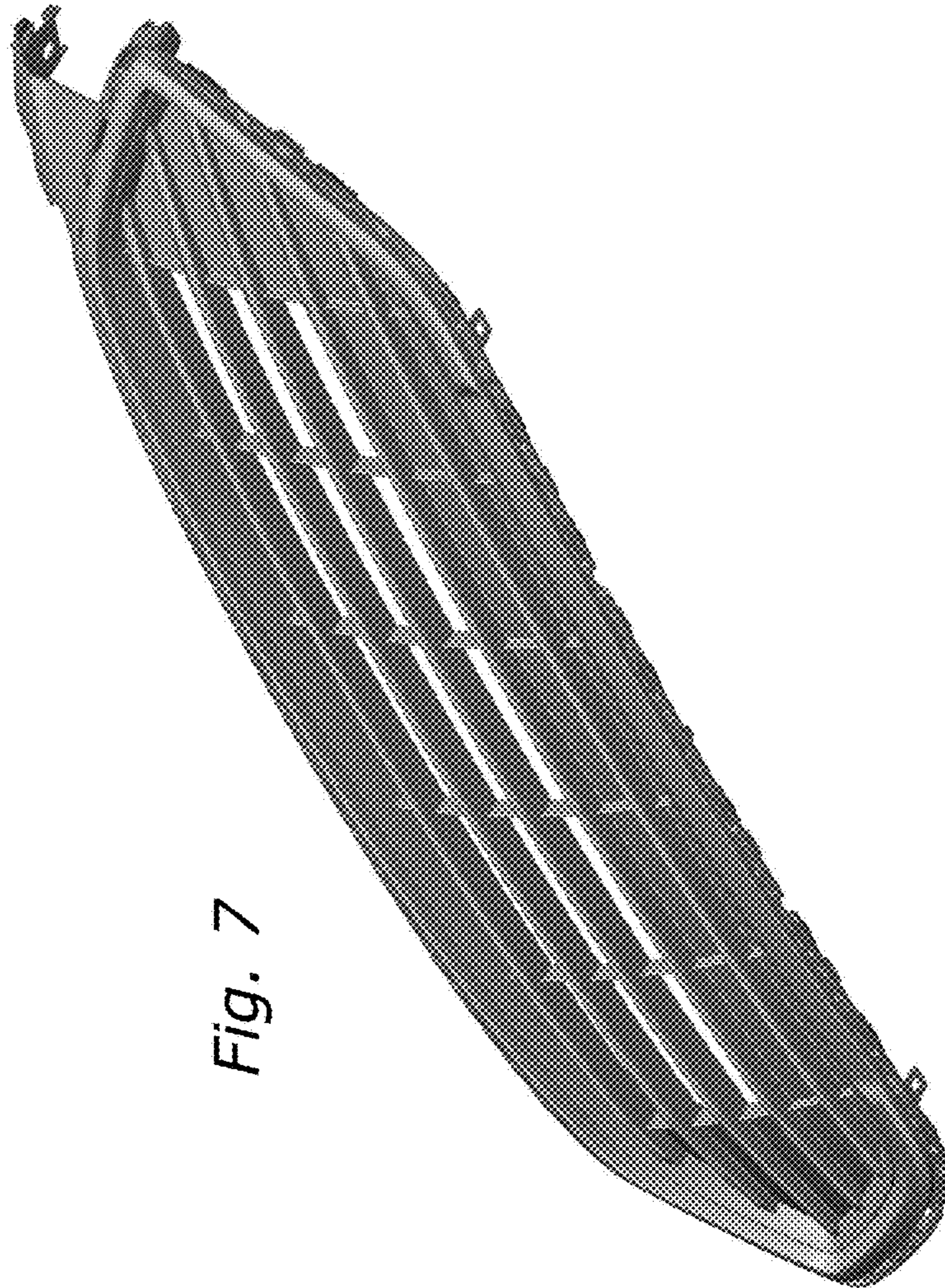
