The ornamental design for an exhaust manifold, as shown and described.

DESCRIPTION

Cross reference is made to U.S. Design patent application Ser. No. 29/605,771, titled Exhaust Manifold, having a filing date of May 30, 2017.

FIG. 1 is a perspective view of a design of an exhaust manifold;

FIG. 2 is a top view of the design of FIG. 1;

FIG. 6 is a front view of the design of FIG. 1;

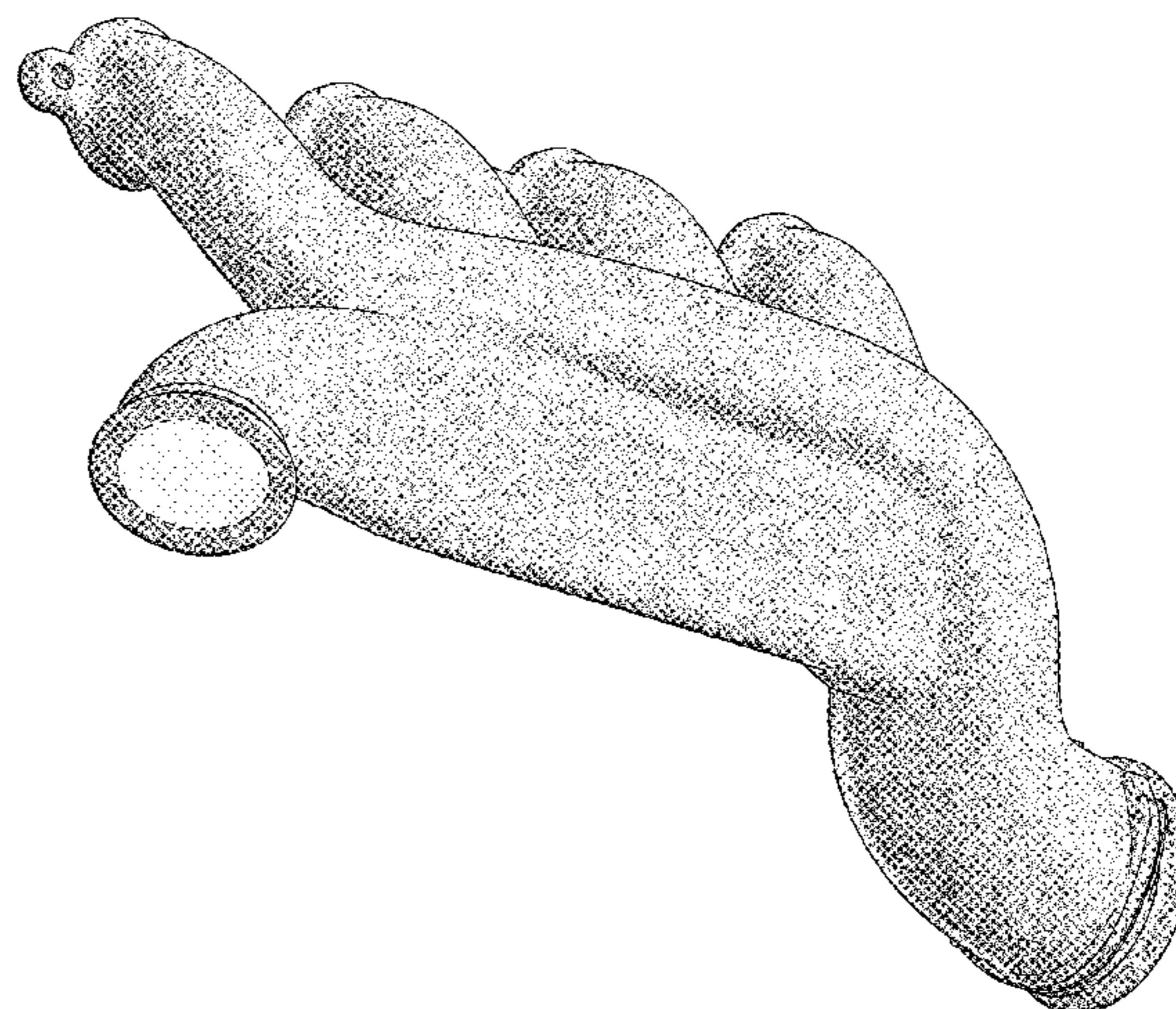
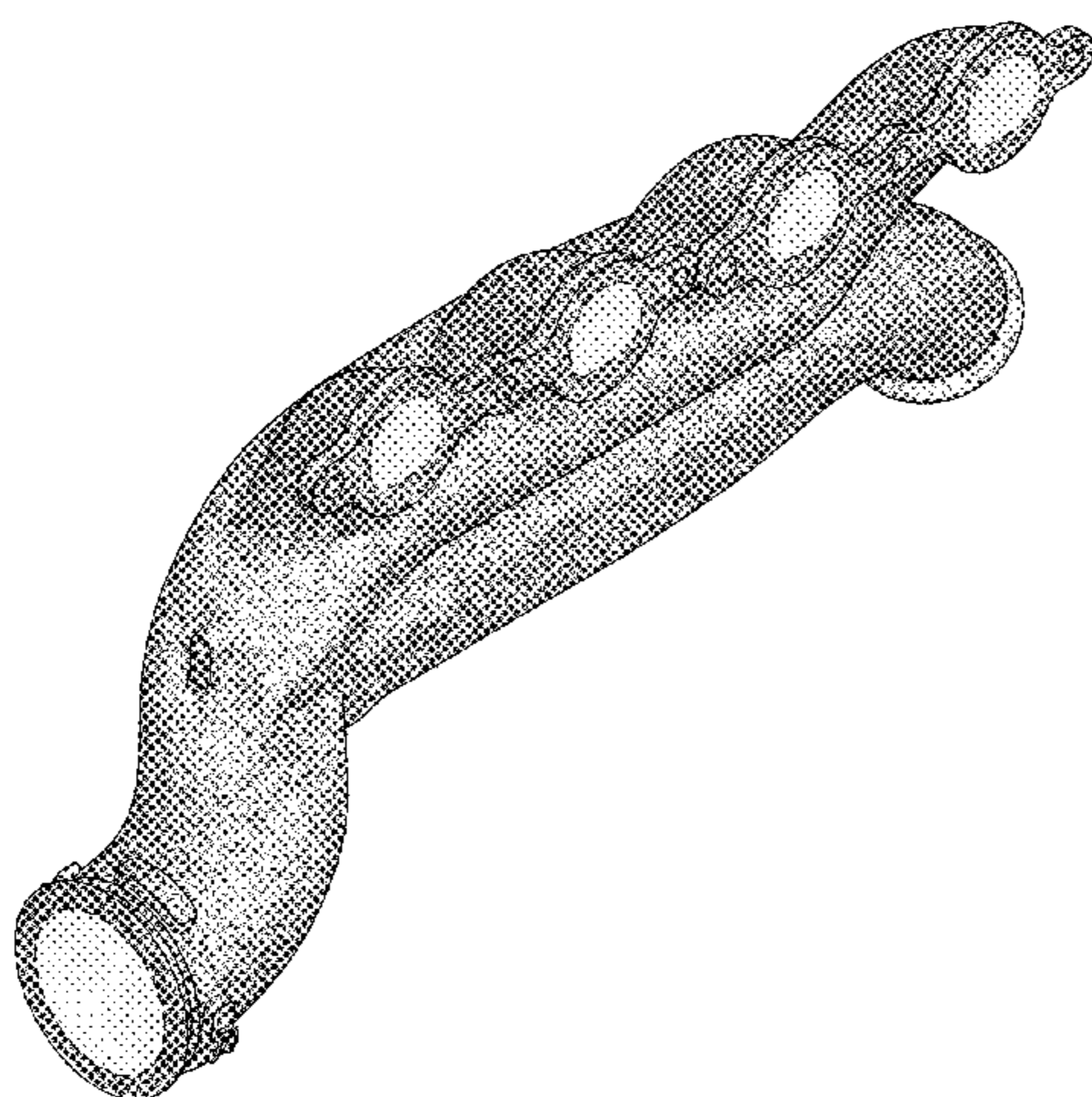
FIG. 7 is a rear view of the design of FIG. 1;

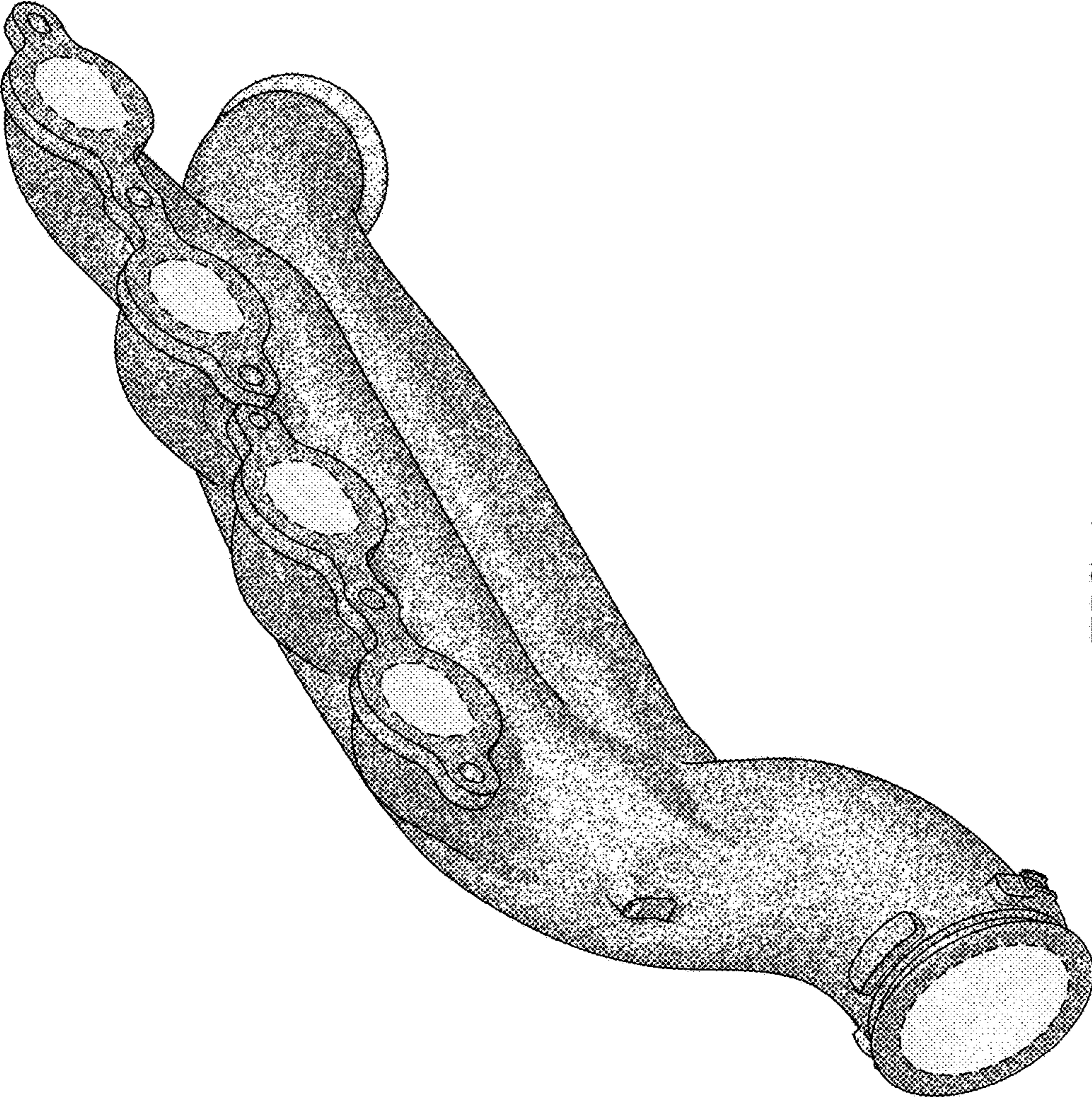

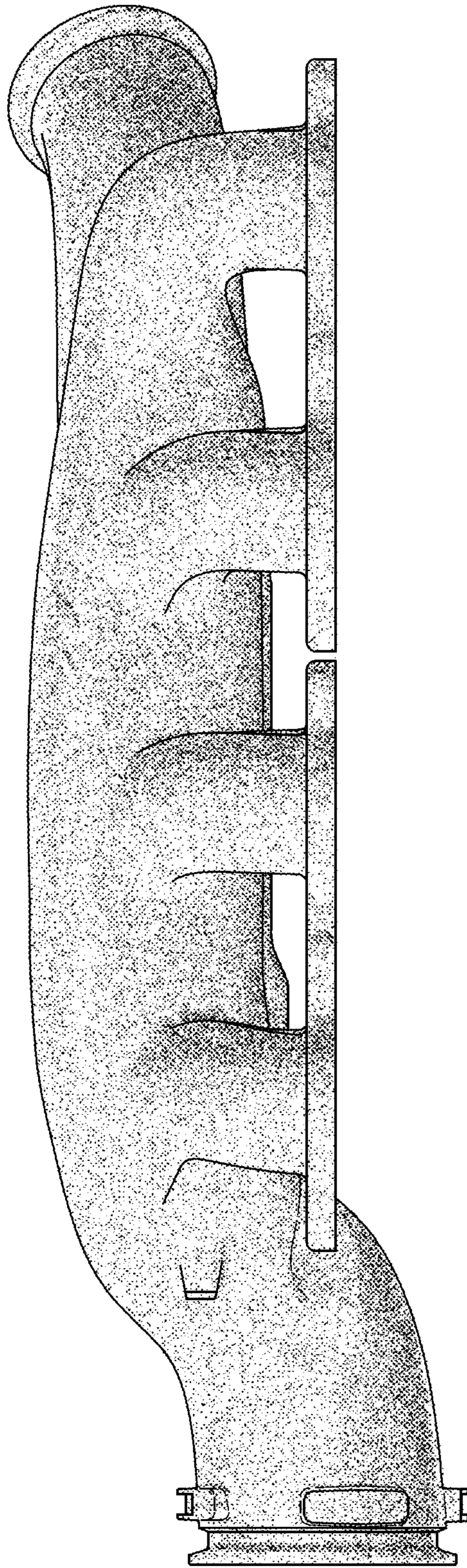

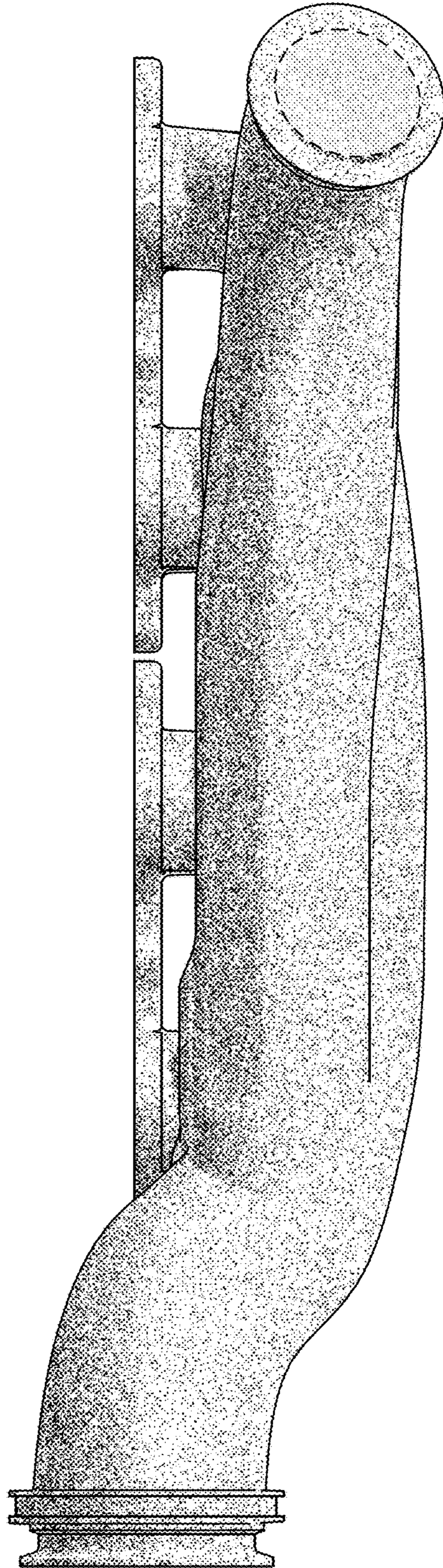

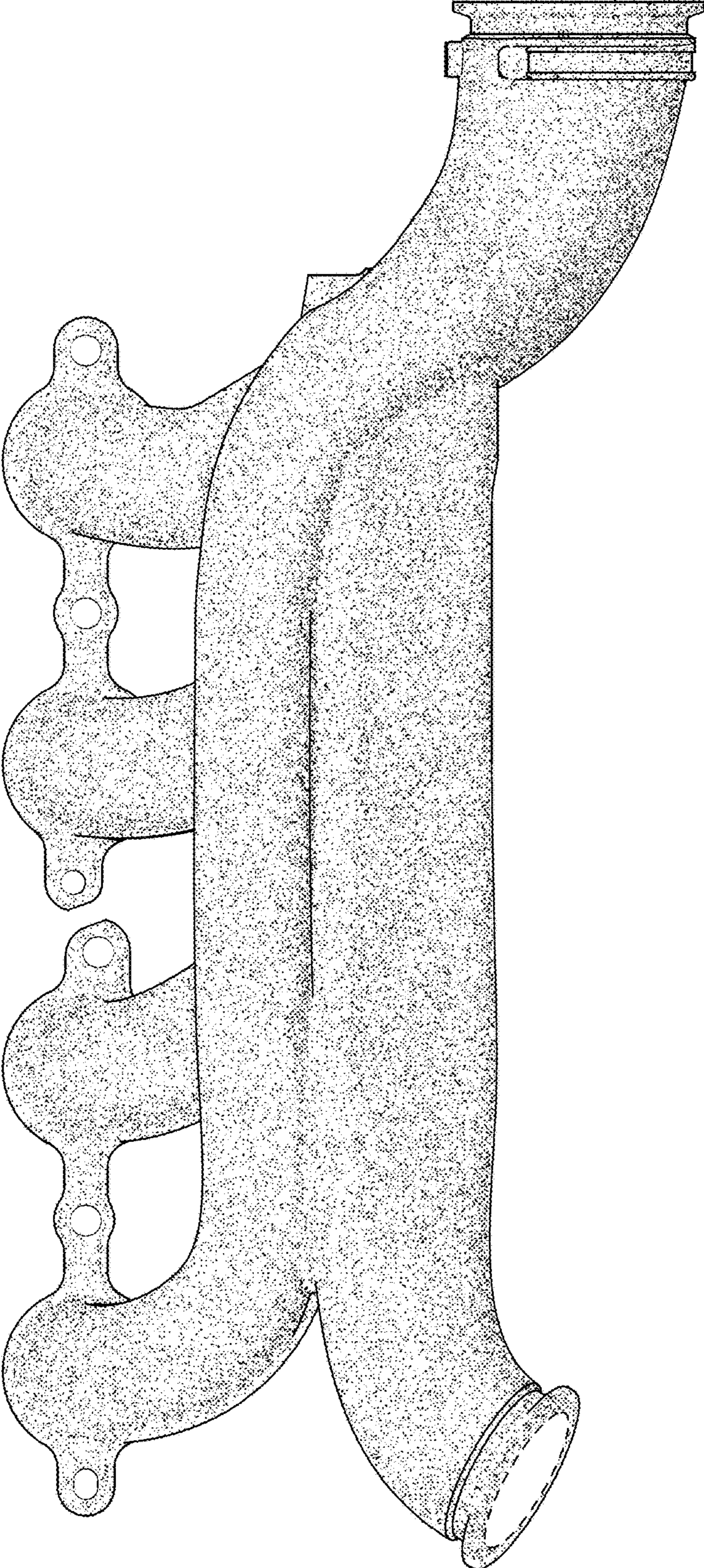

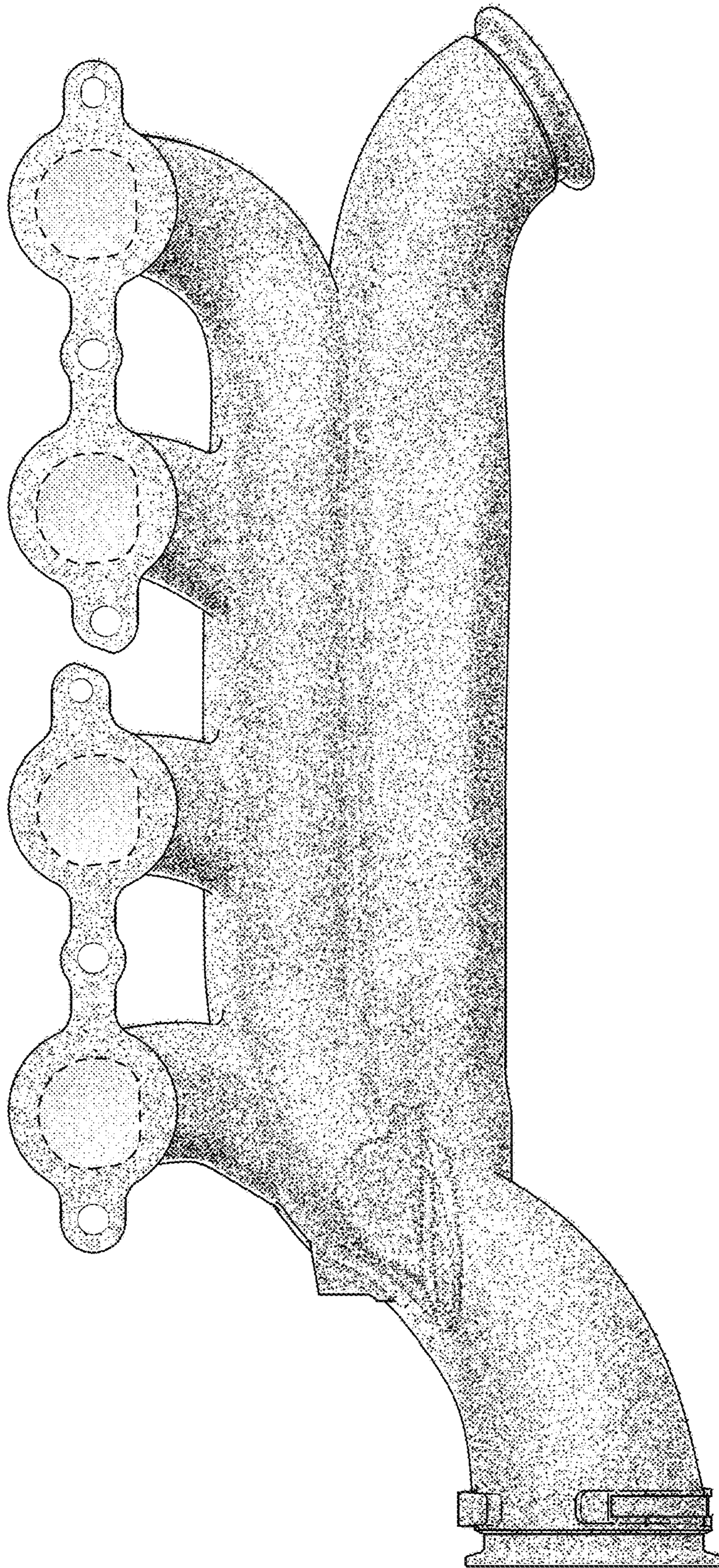

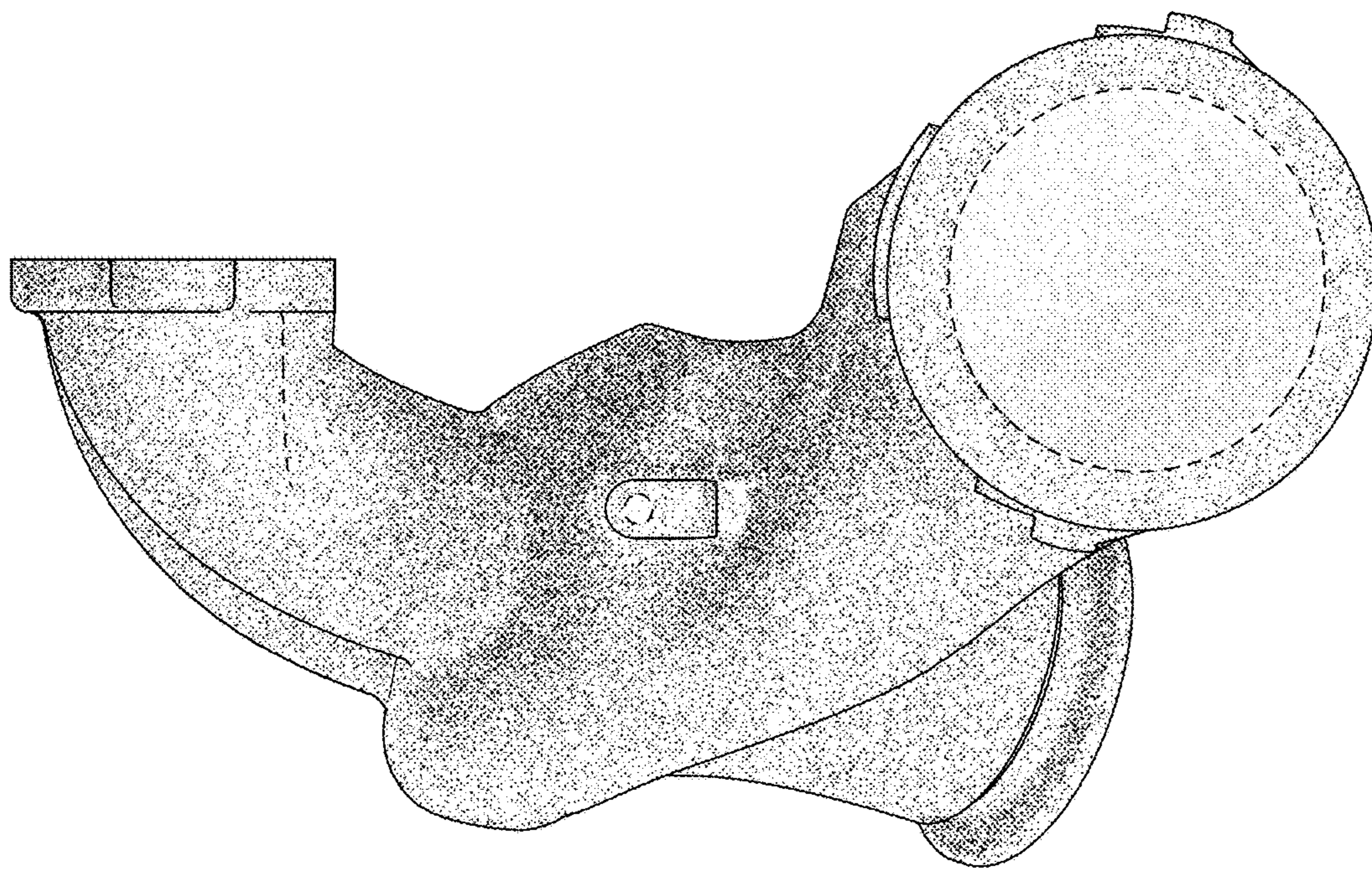

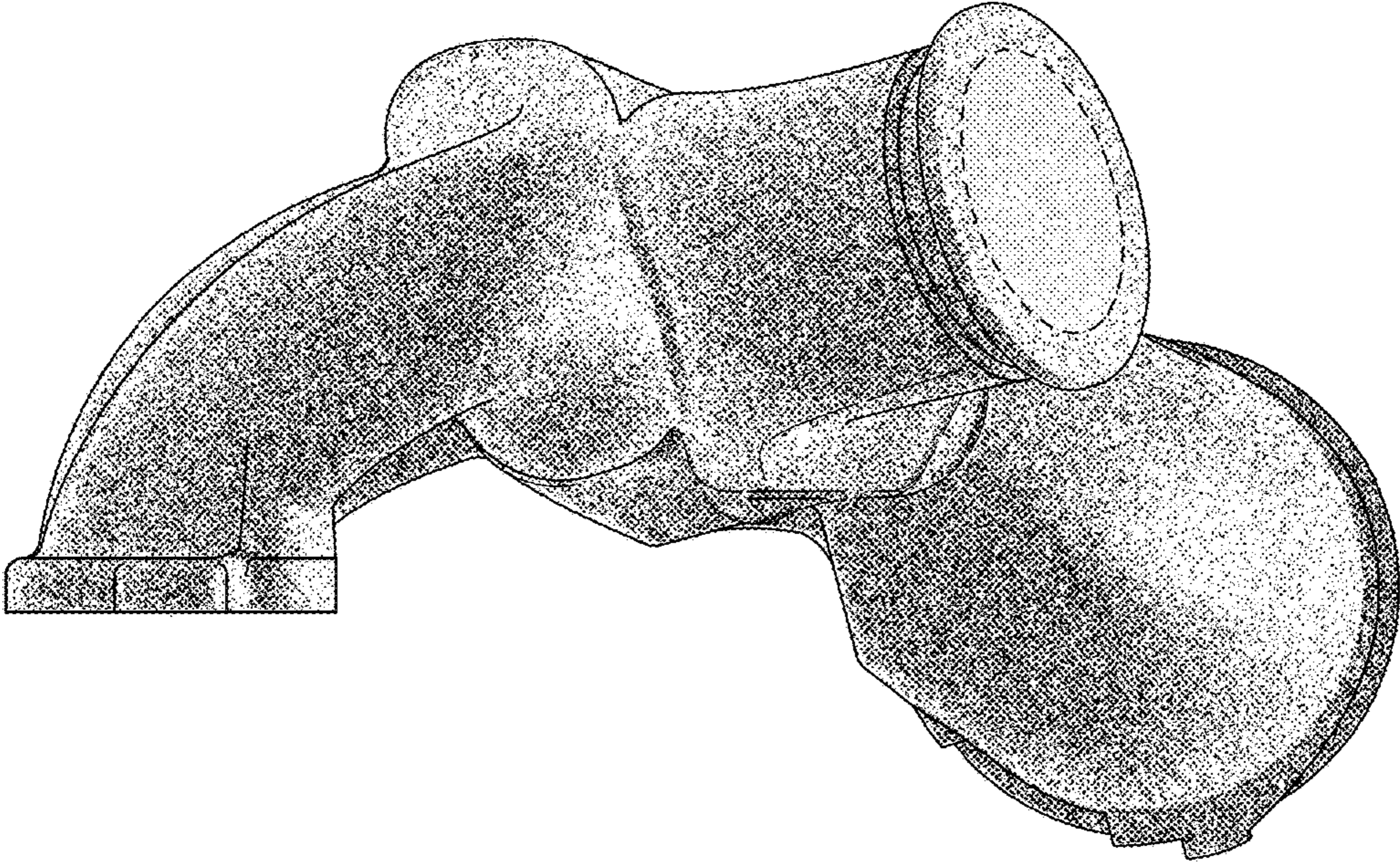

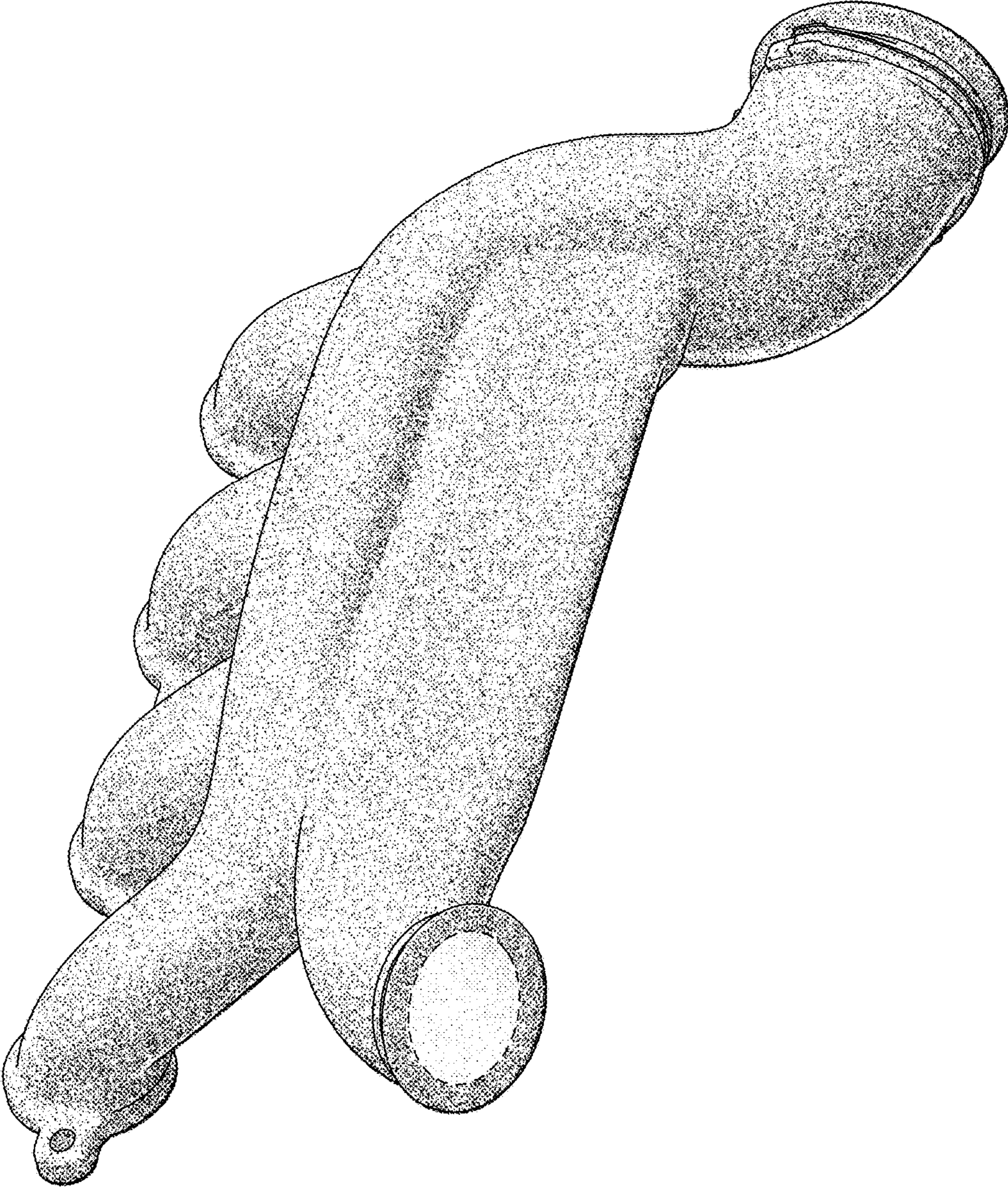

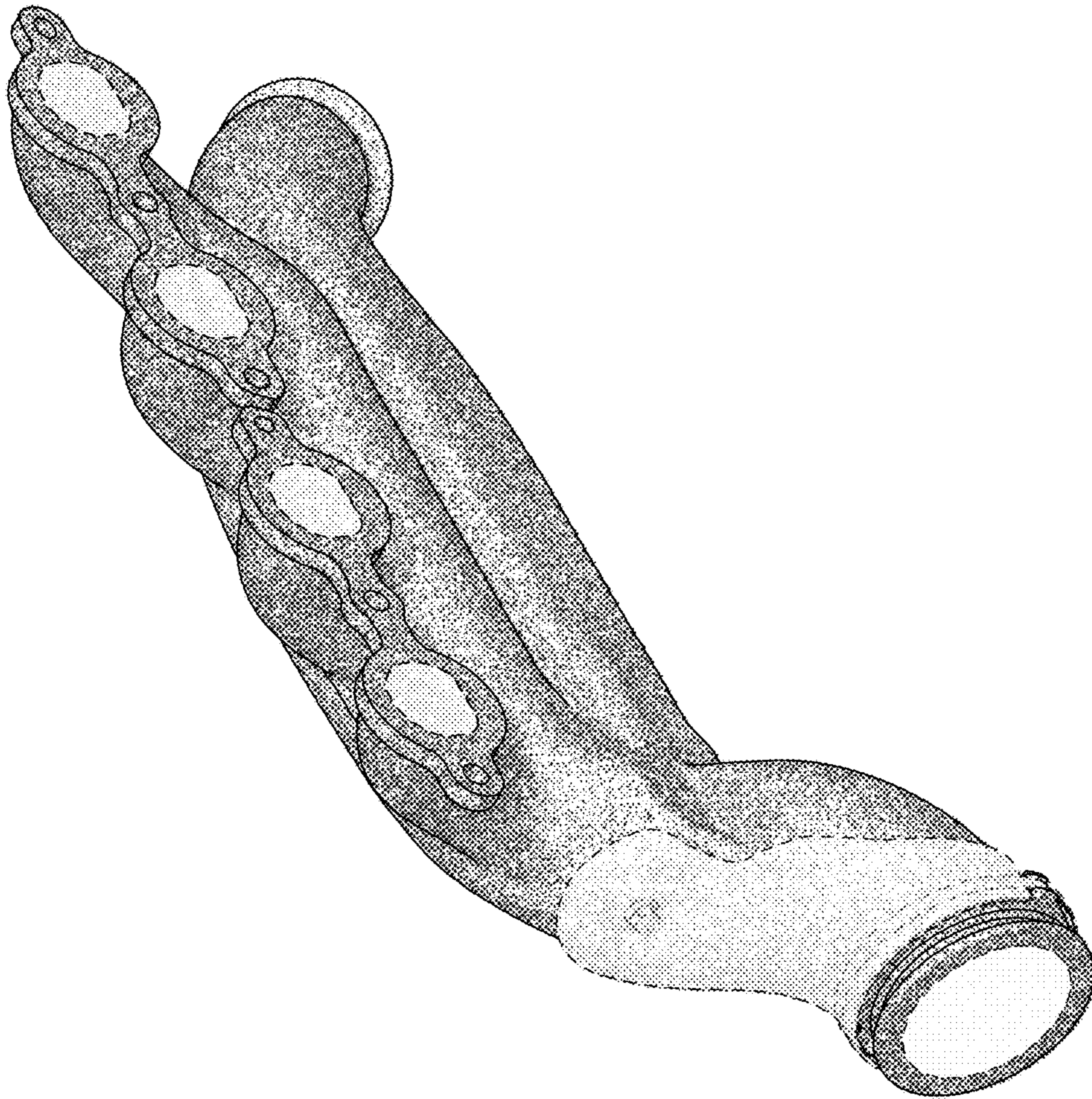
