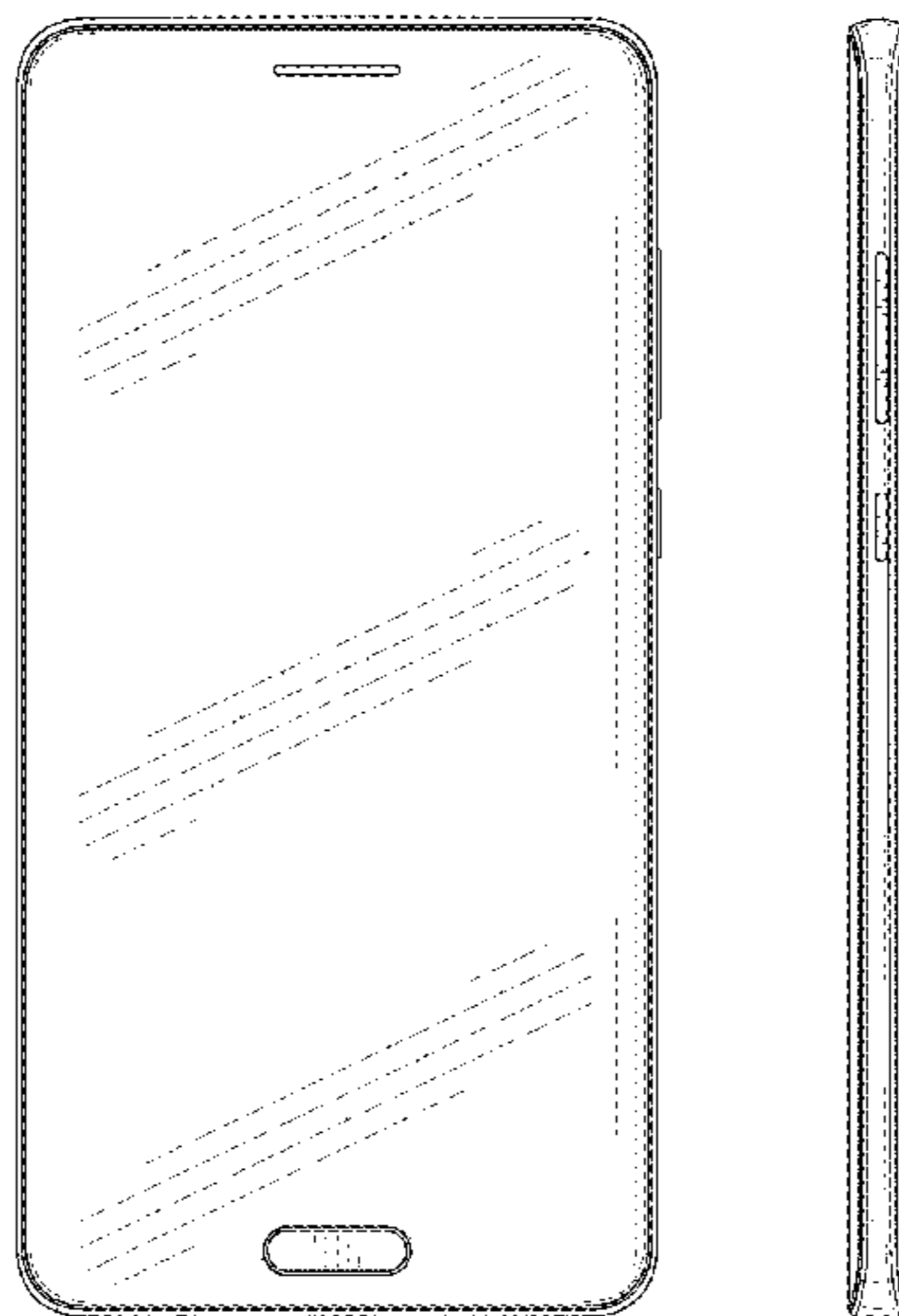
The ornamental design for a terminal device, as shown and described.

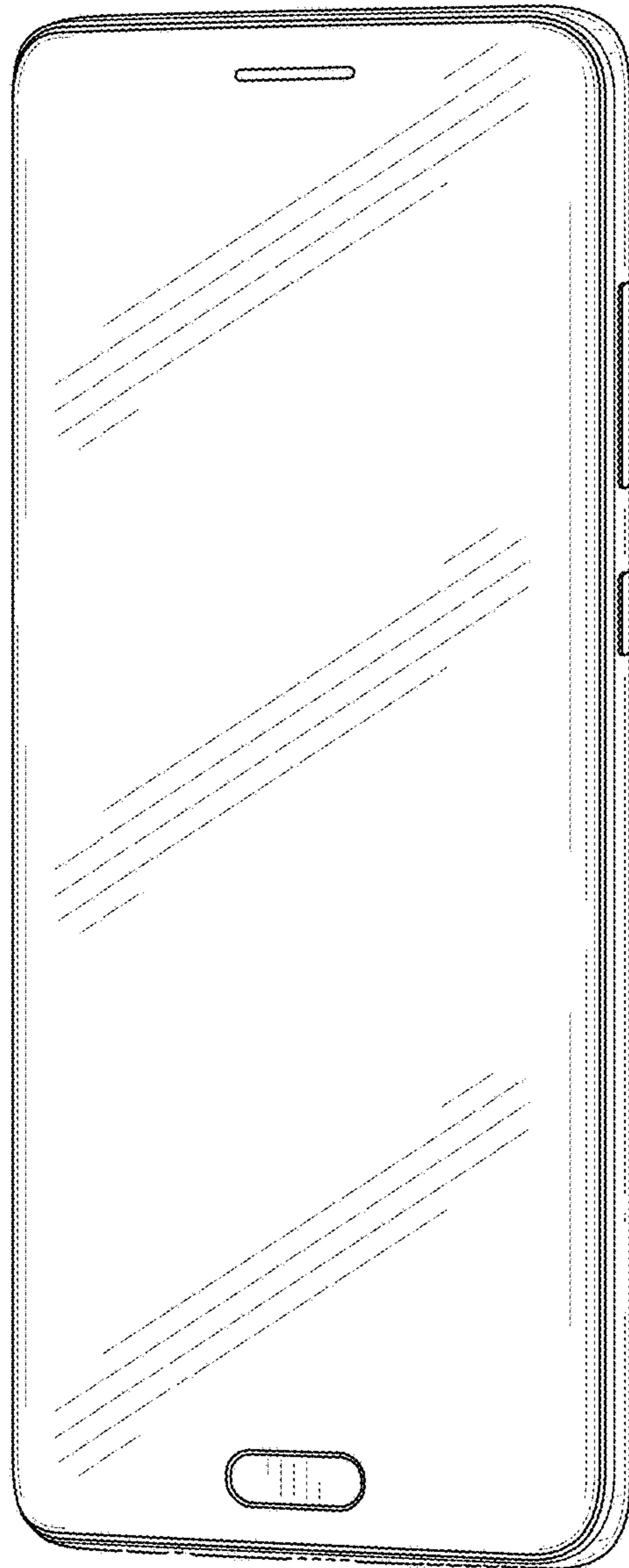

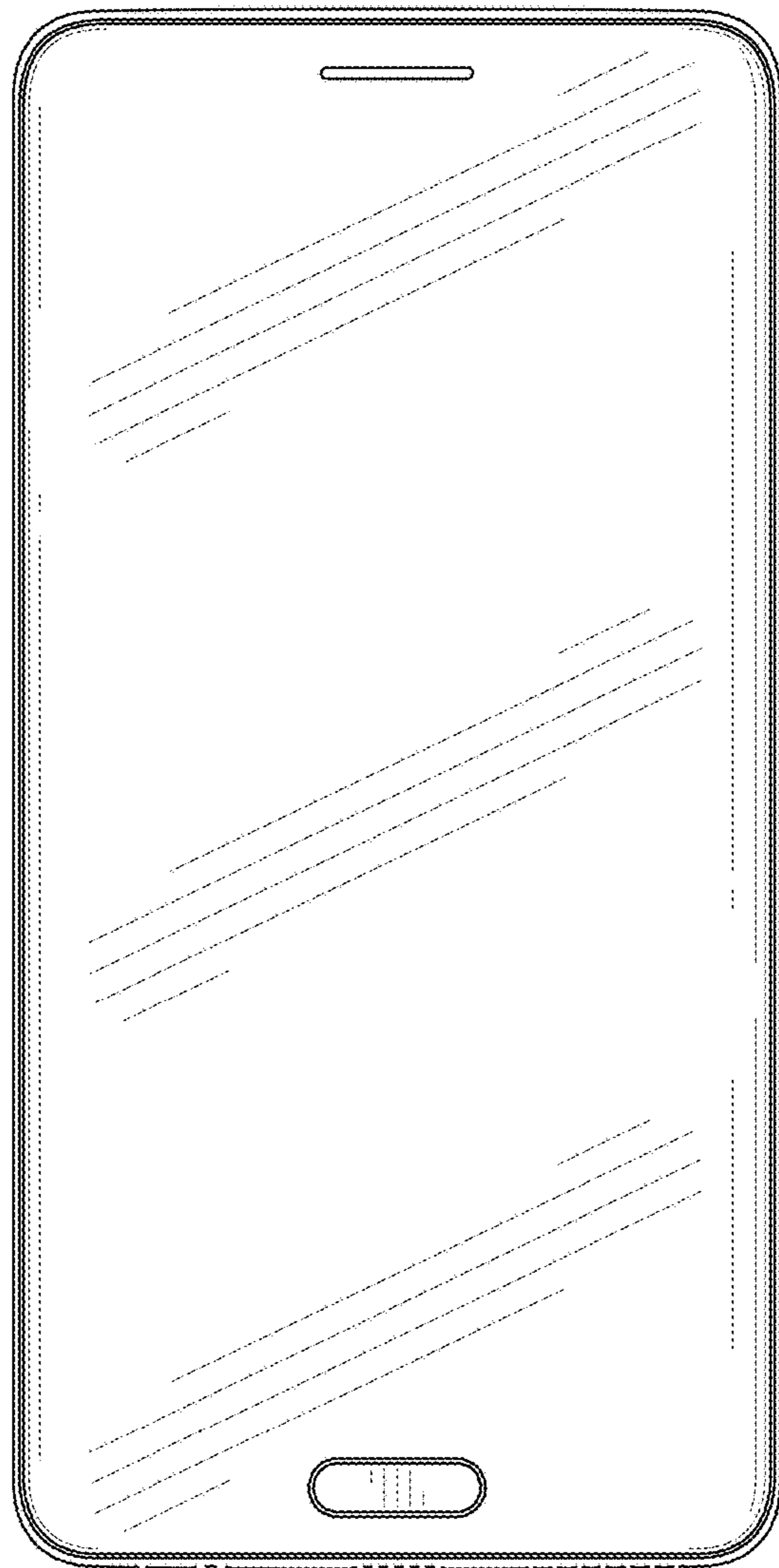

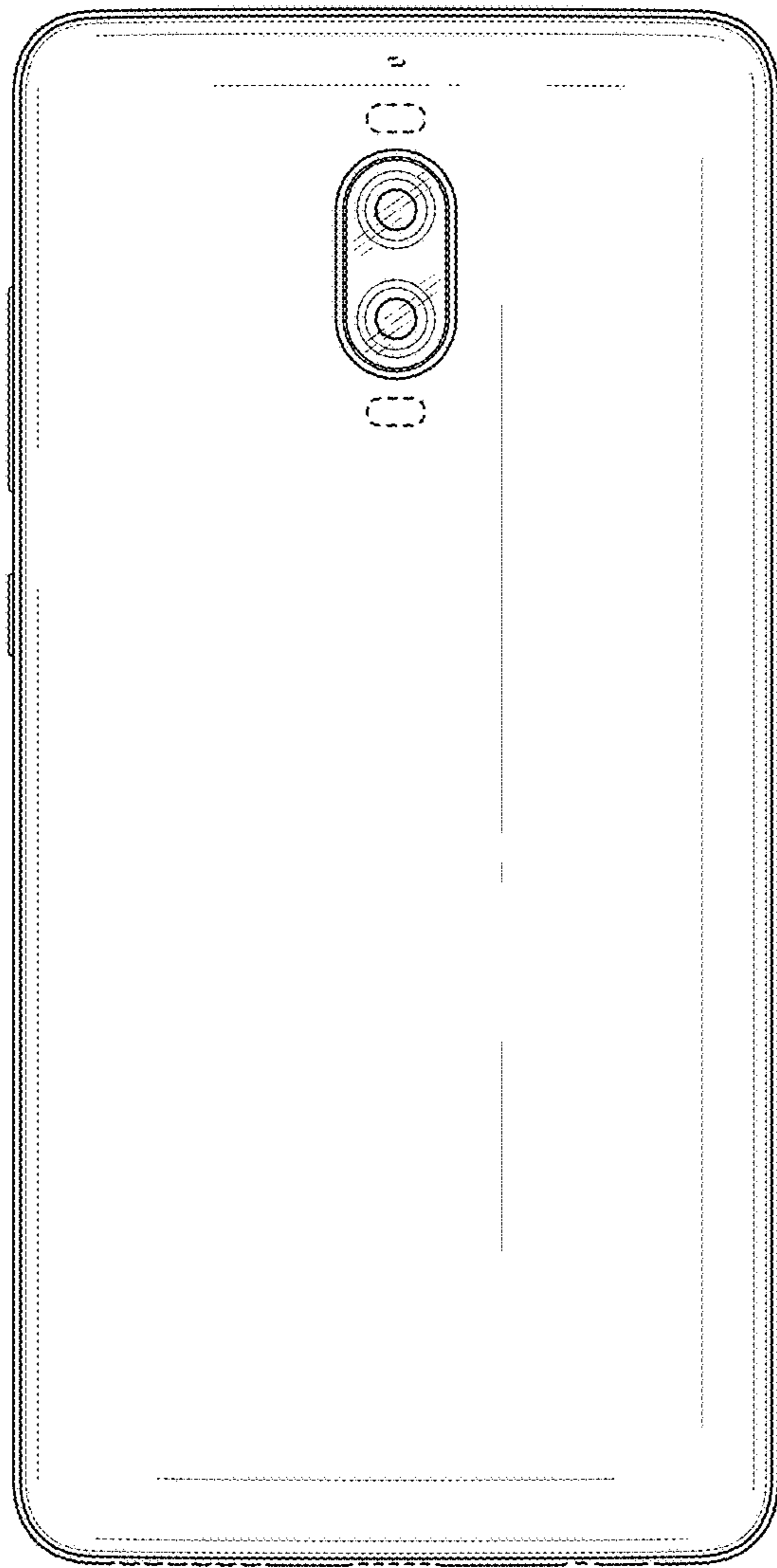

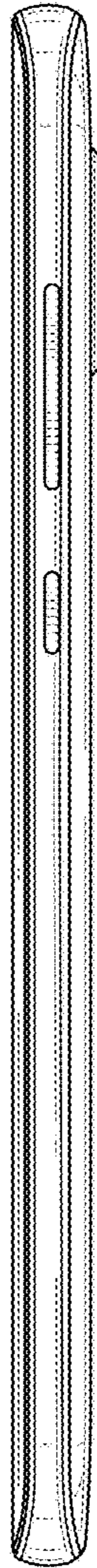

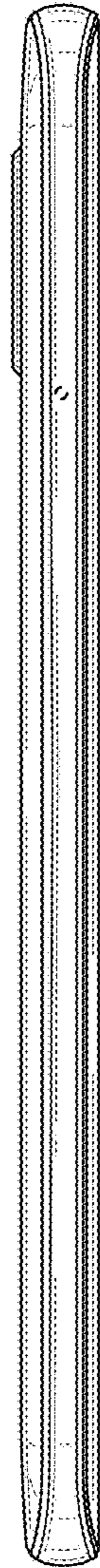
