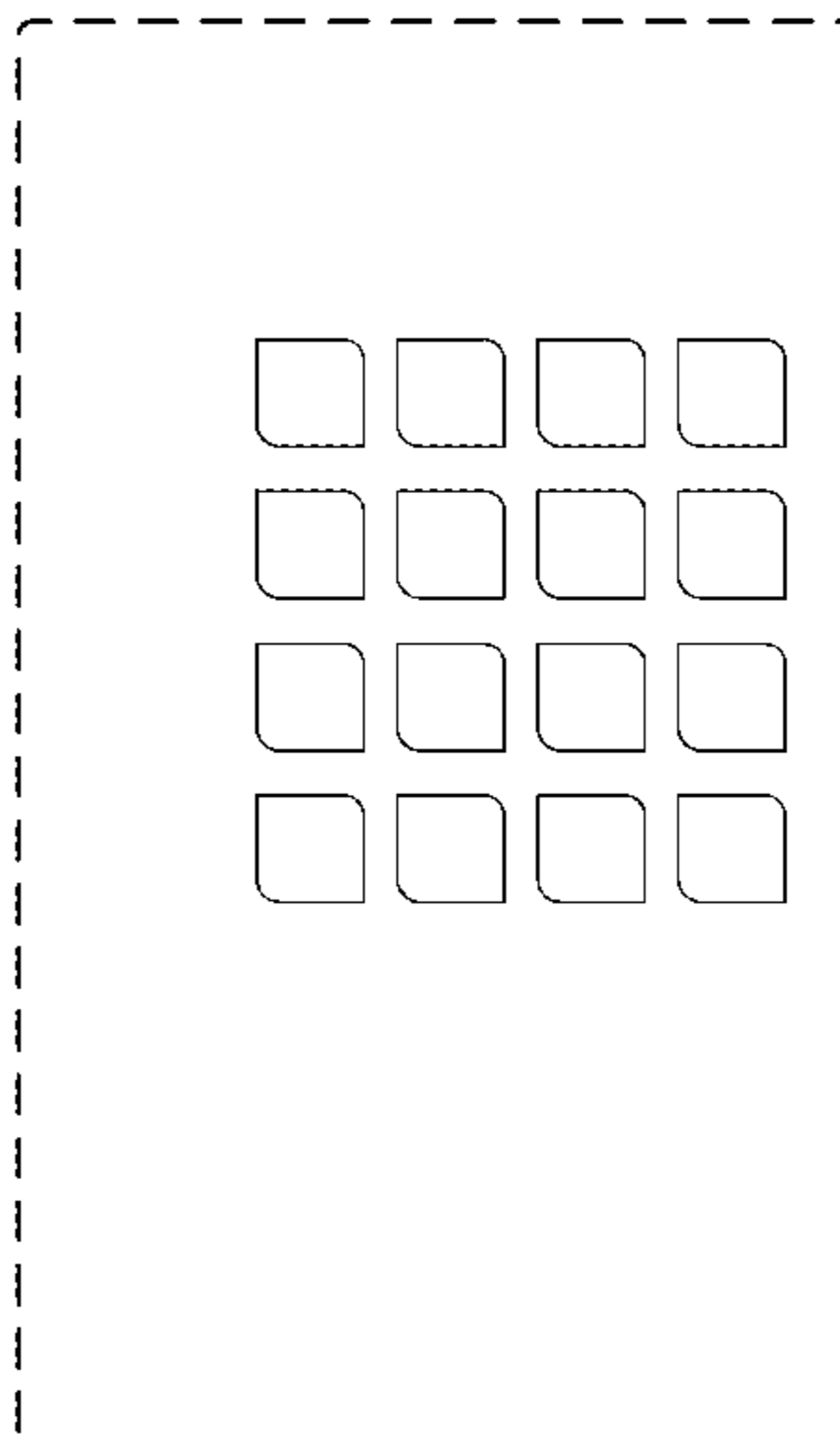
The ornamental design for a computer display screen with graphical user interface for lighting, as shown and described.
