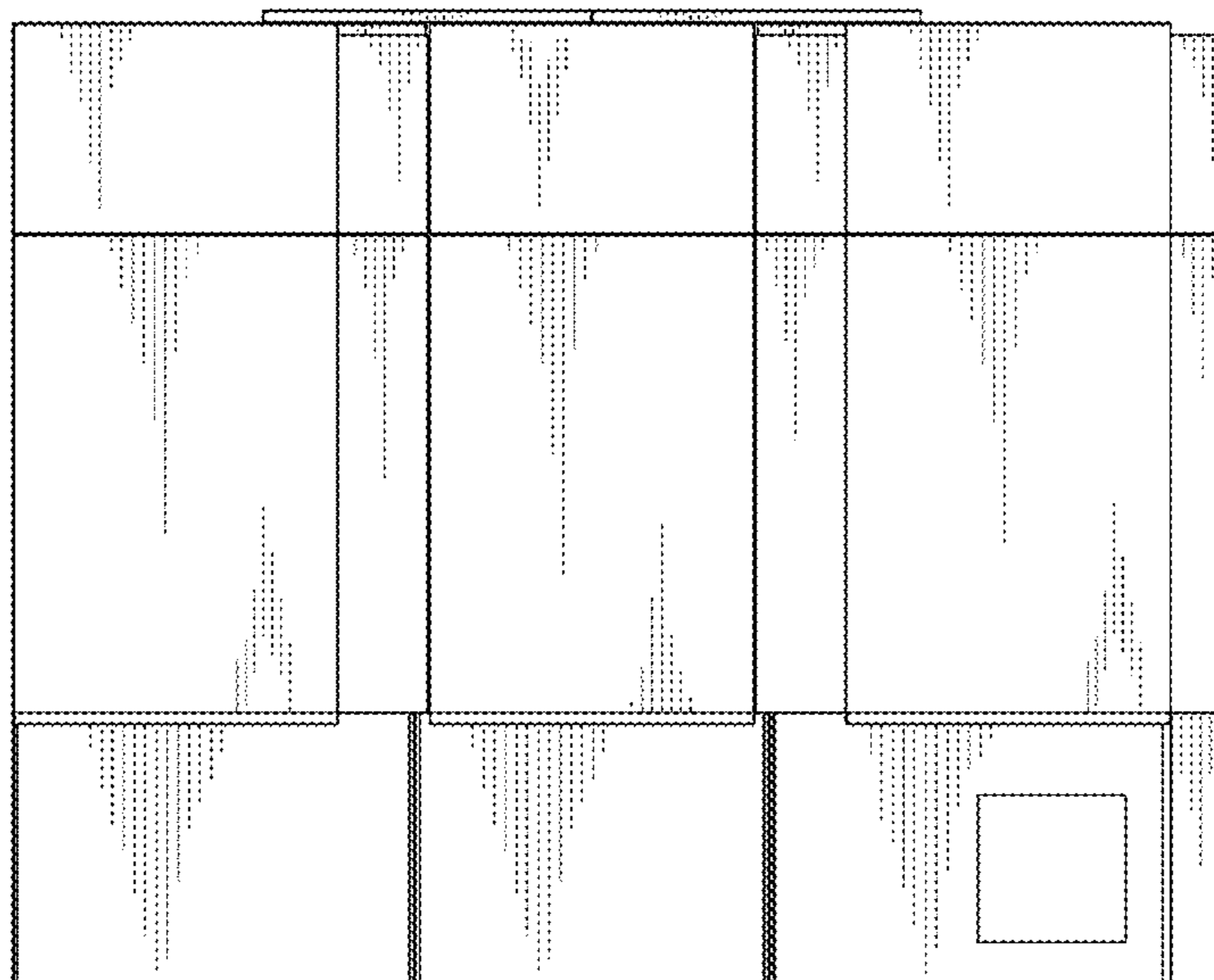

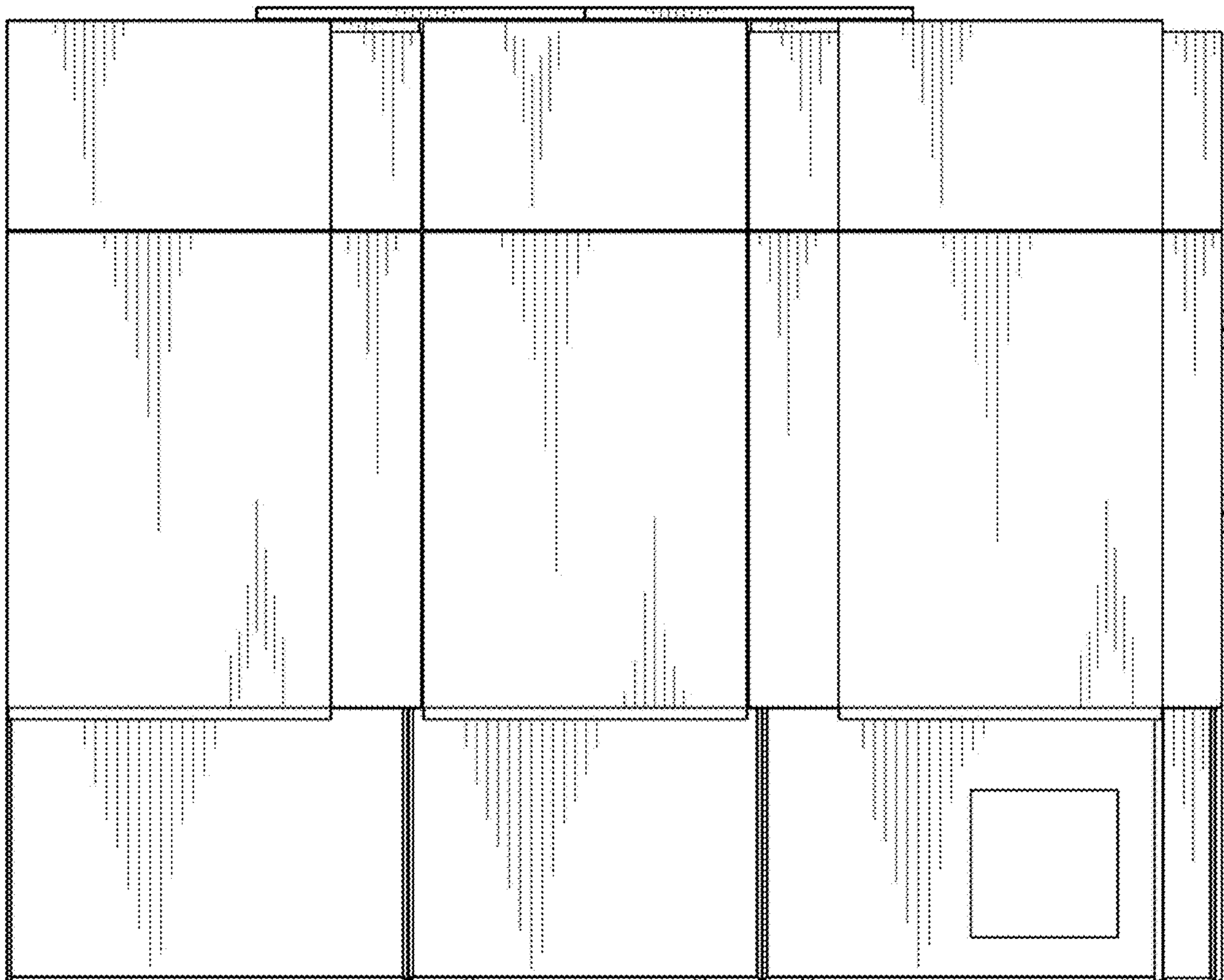

Reproduction no. **1.8** is a vertical sectional view cut along the line between the doors at the upper part of the product in reproduction no. **1.2**.

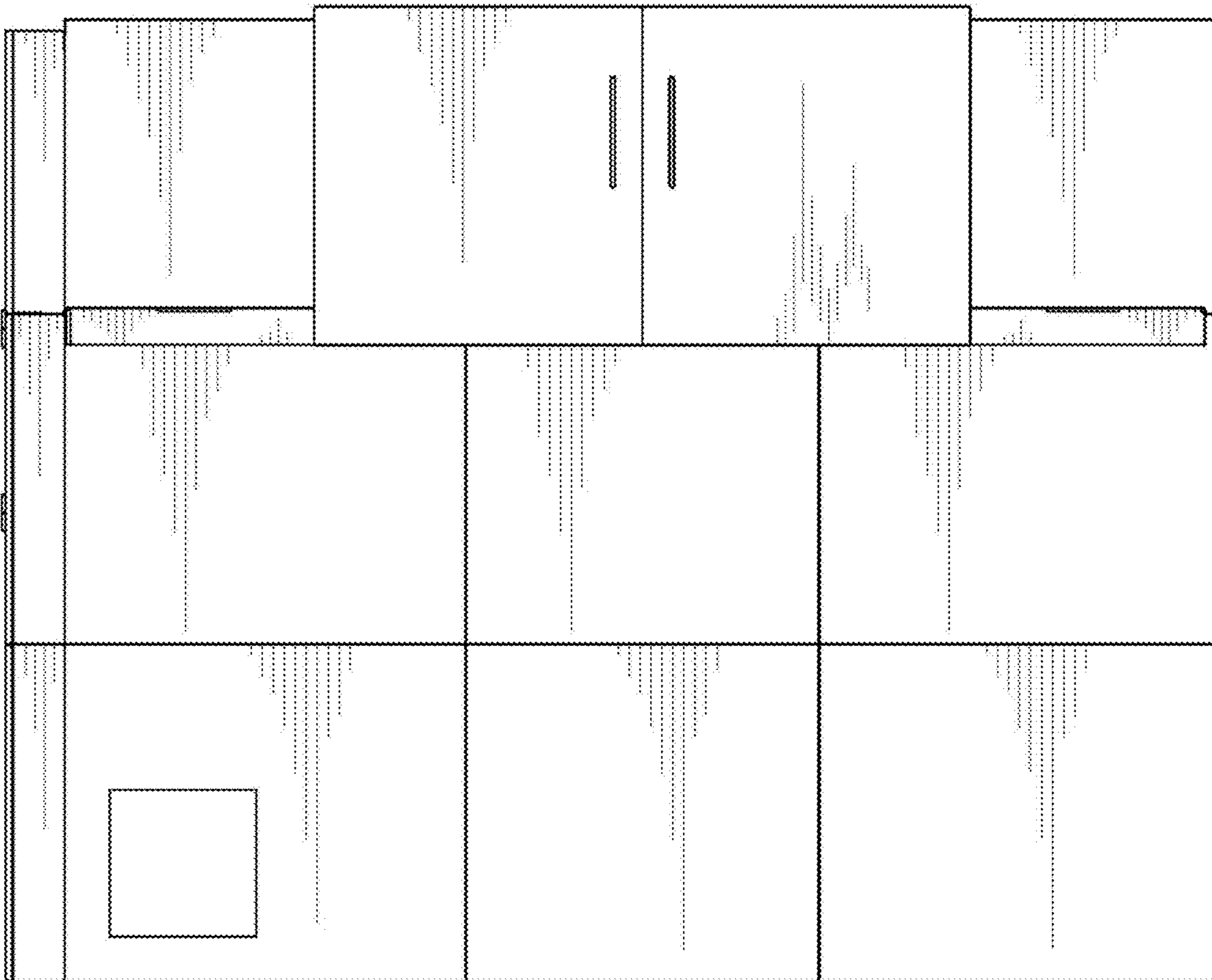

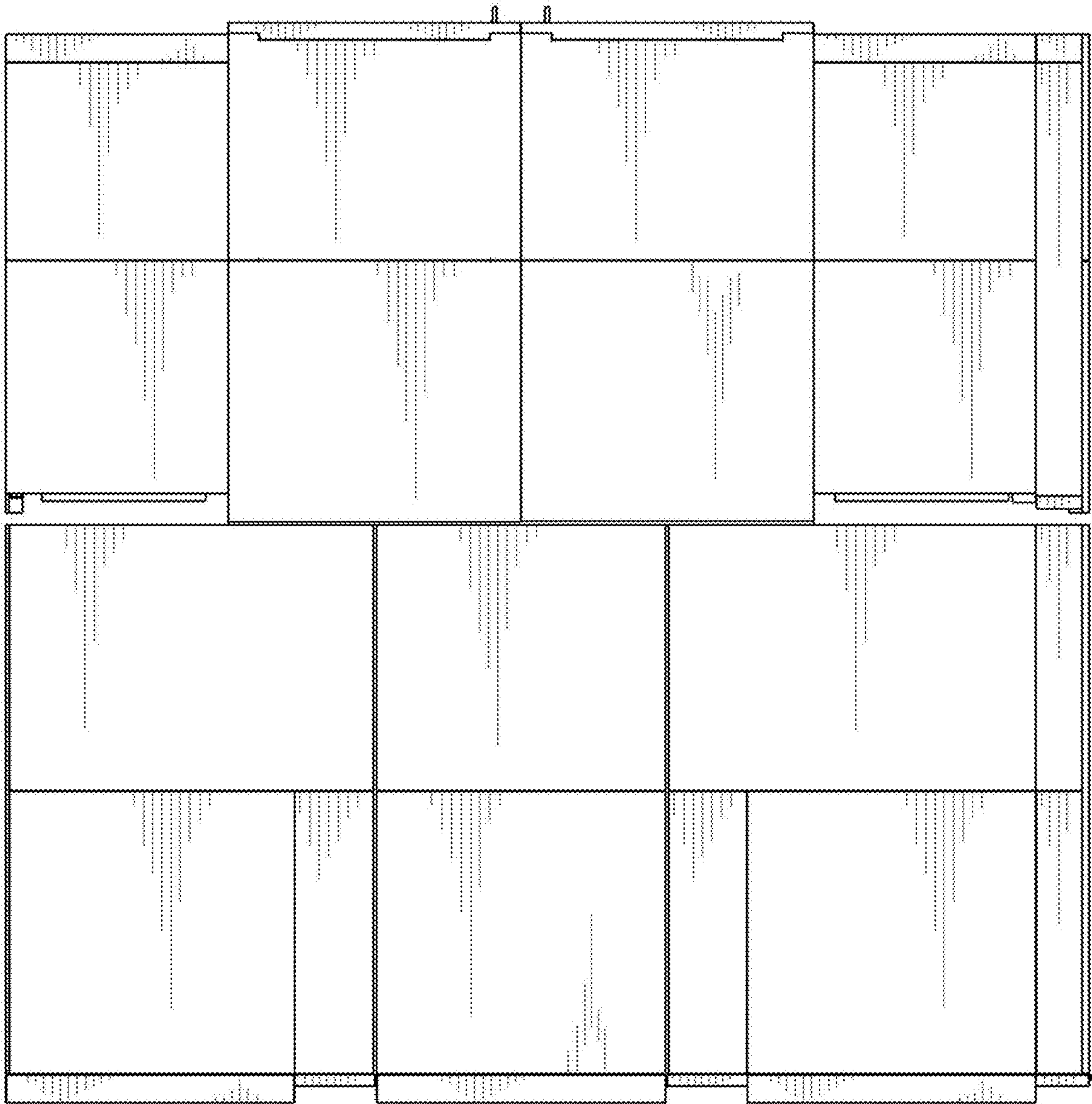

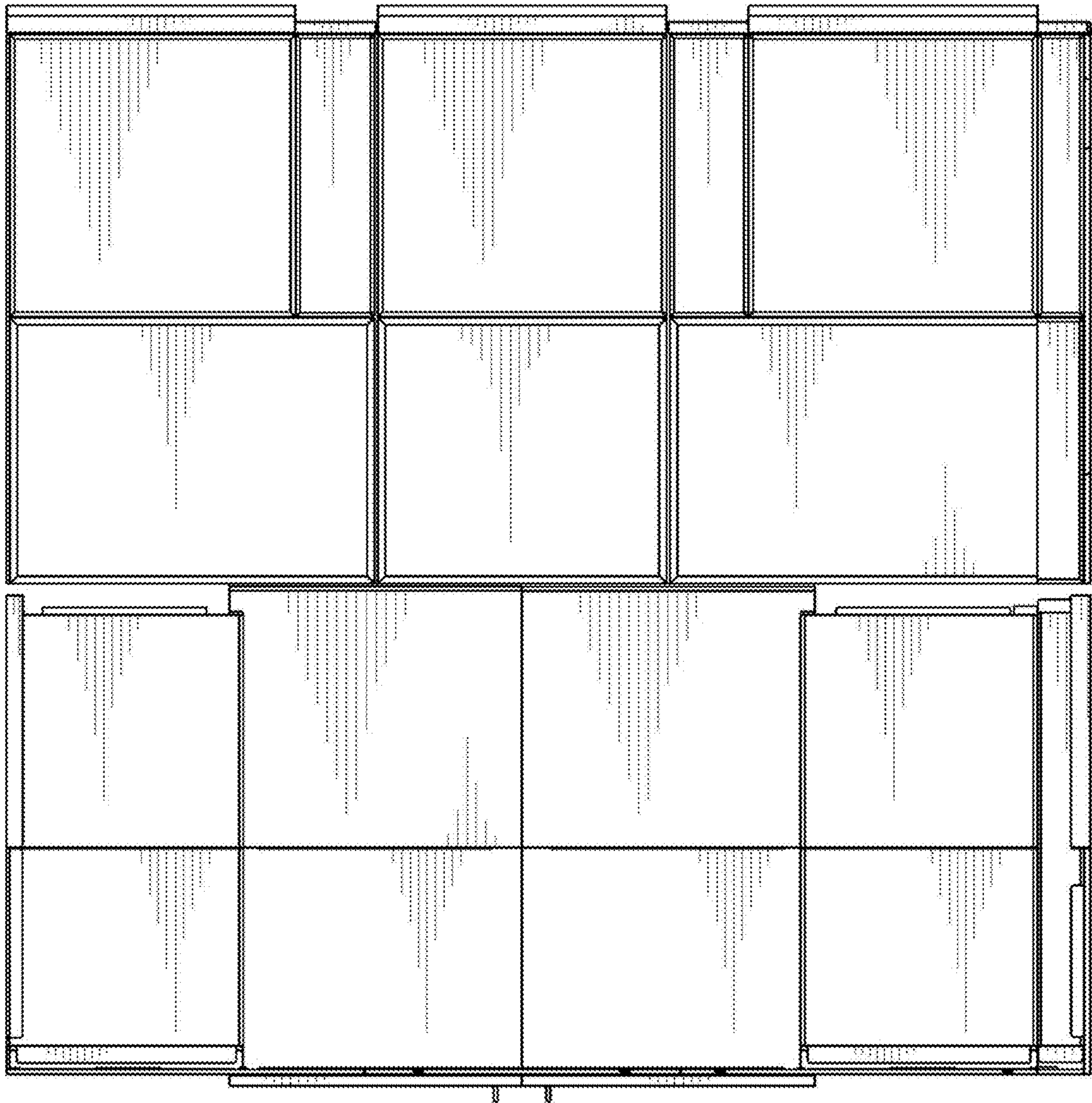

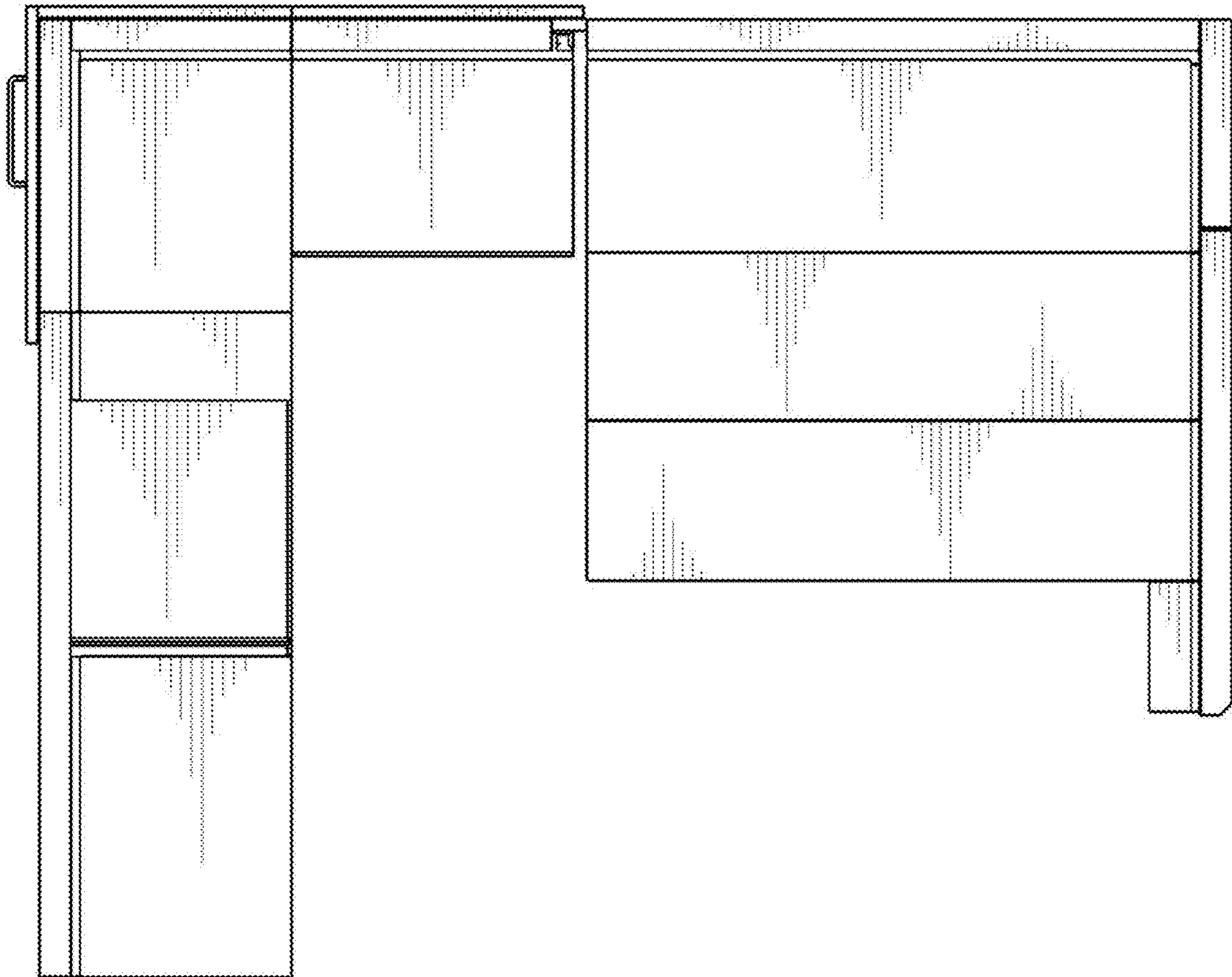

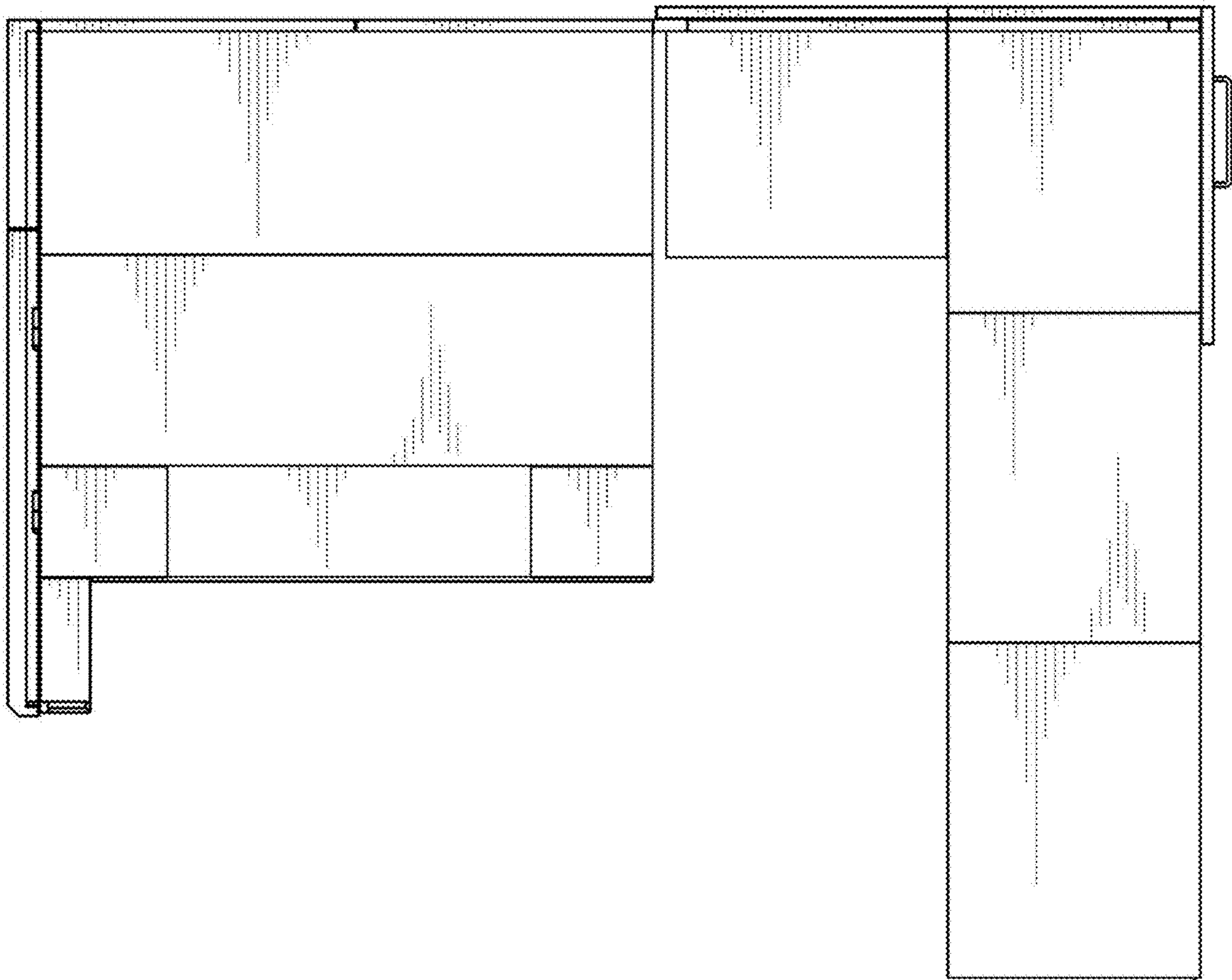

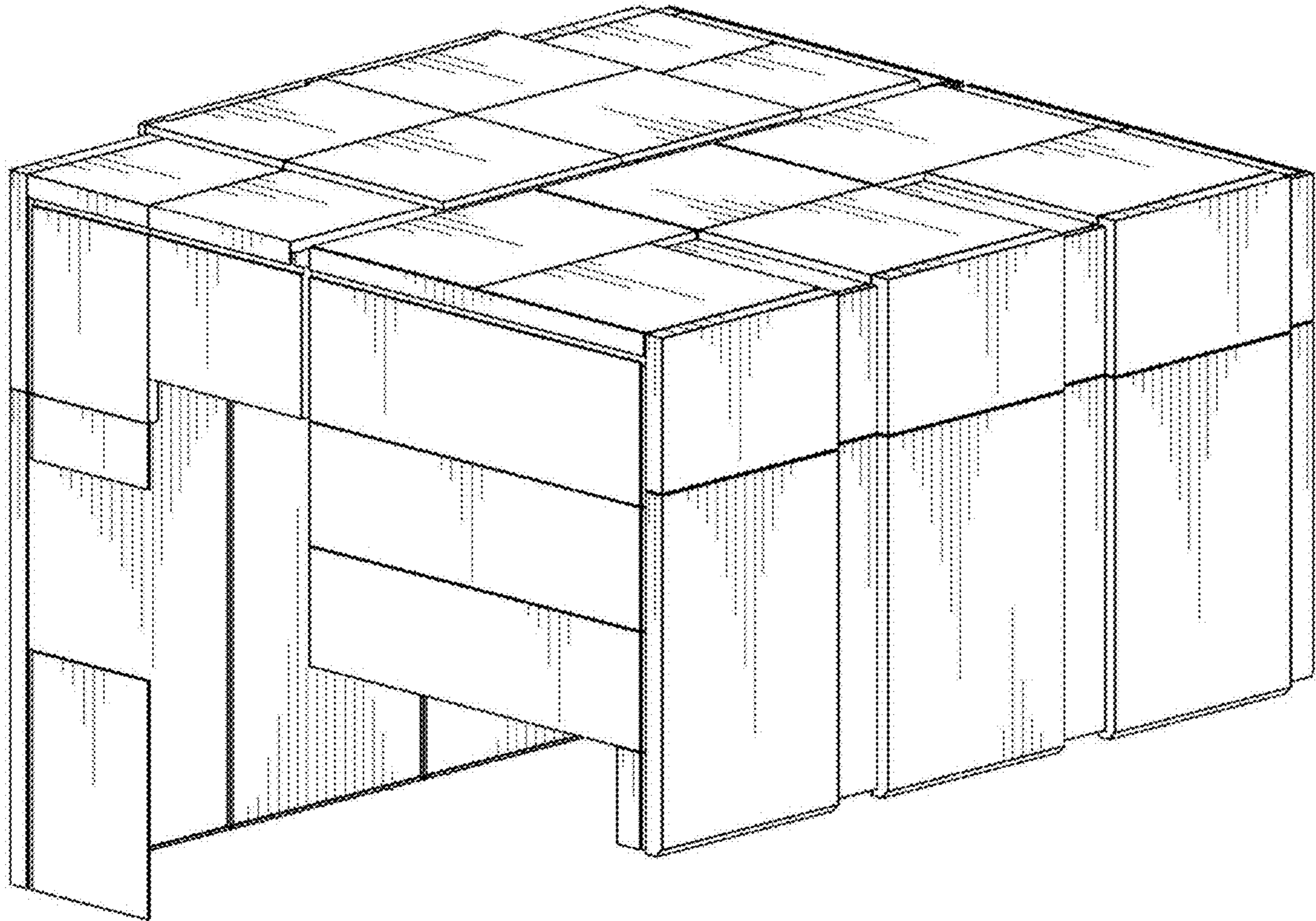
