(57) **CLAIM**

The ornamental design for an ear loop mask, as shown and described.

DESCRIPTION

FIG. 1 is a front, left perspective view of a first embodiment of an ear loop mask depicting my new design;

FIG. 2 is a front view of the ear loop mask depicted in FIG. 1;

FIG. 3 is a back view of the ear loop mask depicted in FIG. 1;

FIG. 4 is a bottom view of the ear loop mask depicted in FIG. 1, the top view being a mirror image of the bottom view;

FIG. 5 is a left end view of the ear loop mask depicted in FIG. 1; and

FIG. 6 is a right end view of the ear loop mask depicted in FIG. 1; and

FIG. 7 is a front, left perspective view of a second embodiment of an ear loop mask depicting our new design;

FIG. 8 is a front view of the ear loop mask depicted in FIG. 7;

FIG. 9 is a back view of the ear loop mask depicted in FIG. 7;

FIG. 10 is a bottom view of the ear loop mask depicted in FIG. 7, the top view being a mirror image of the bottom view;

FIG. 11 is a left end view of the ear loop mask depicted in FIG. 7; and

FIG. 12 is a right end view of the ear loop mask depicted in FIG. 7; and

FIG. 13 is a front, left perspective view of a third embodiment of an ear loop mask depicting our new design;

FIG. 14 is a front view of the ear loop mask depicted in FIG. 13;

FIG. 15 is a back view of the ear loop mask depicted in FIG. 13;

FIG. 16 is a bottom view of the ear loop mask depicted in FIG. 13, the top view being a mirror image of the bottom view;

FIG. 17 is a left end view of the ear loop mask depicted in FIG. 13; and

FIG. 18 is a right end view of the ear loop mask depicted in FIG. 13; and

FIG. 19 is a front, left perspective view of a fourth embodiment of an ear loop mask depicting our new design;

FIG. 20 is a front view of the ear loop mask depicted in FIG. 19;

FIG. 21 is a back view of the ear loop mask depicted in FIG. 19;

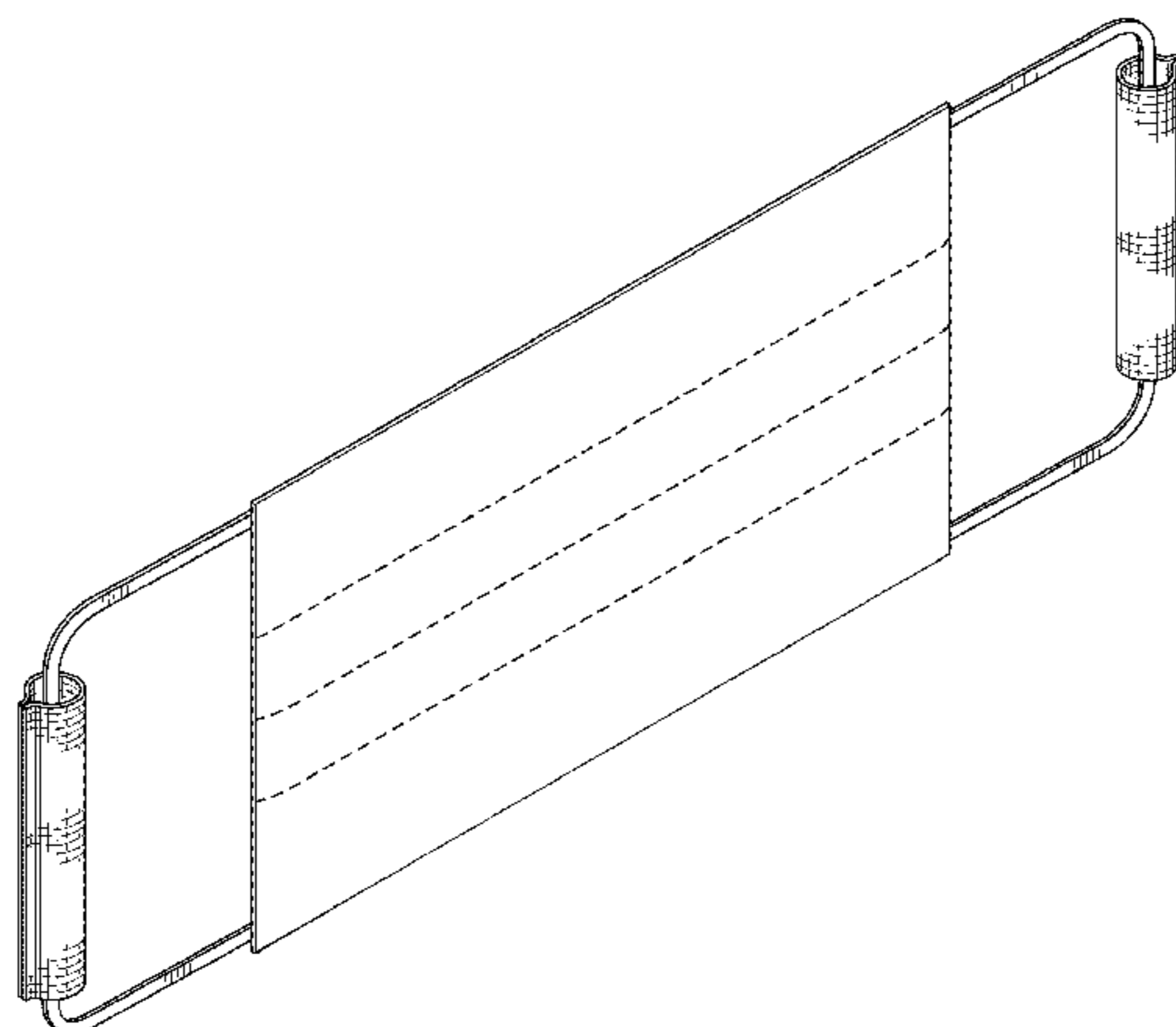


FIG. 22 is a bottom view of the ear loop mask depicted in FIG. 19, the top view being a mirror image of the bottom view;

The broken line showing of pleats in FIGS. 1-4, 7-10, 13-16, and 19-22, and the broken line showing of the inside seam of the sleeves around the ear loops in FIGS. 19 and 22 depict portions of the ear loop mask and form no part of the claimed design. The unshaded surfaces adjacent the broken line showing of the pleats in FIGS. 1-4, 7-10, 13-16, and 19-22 likewise form no part of the claimed design.

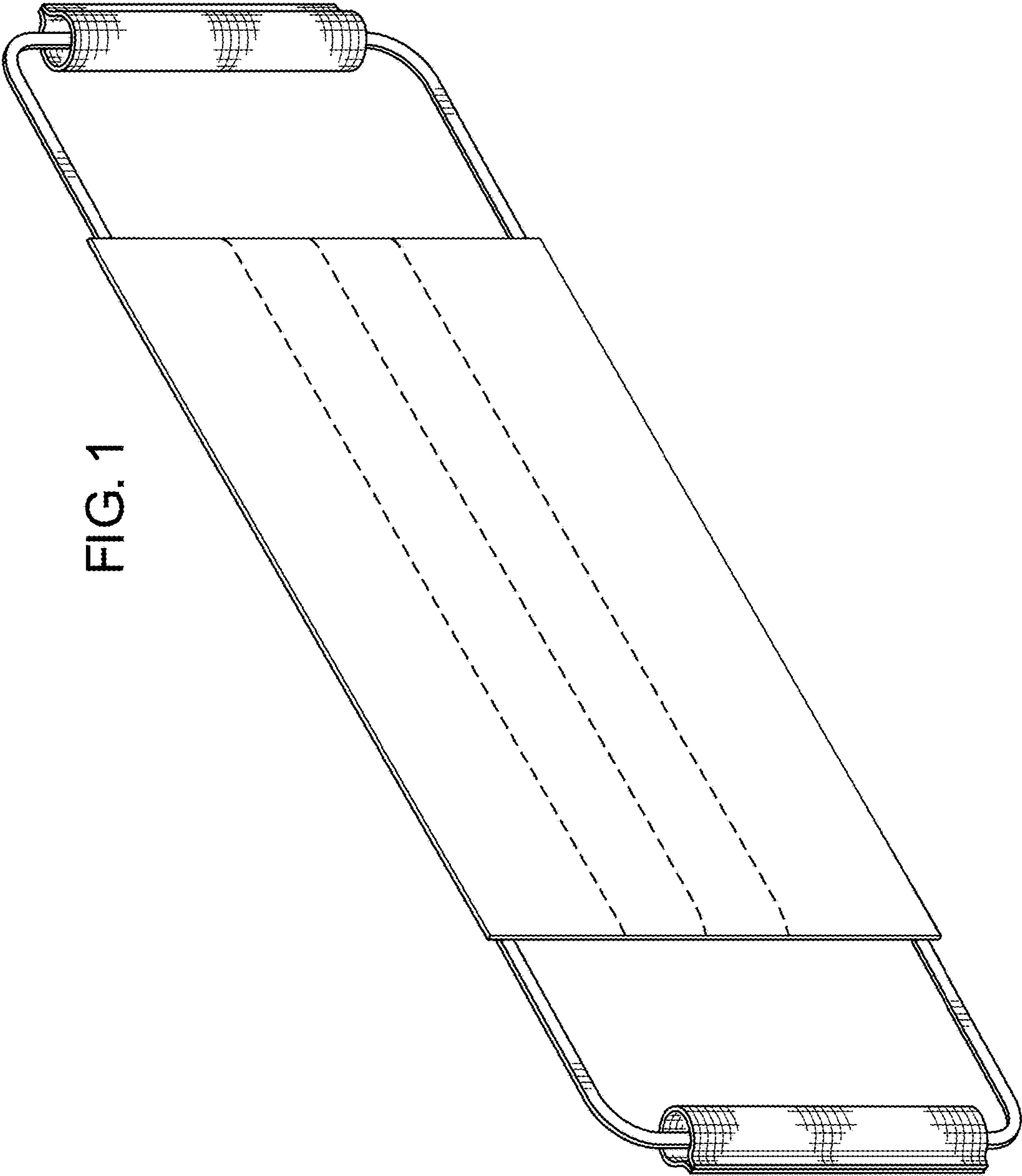

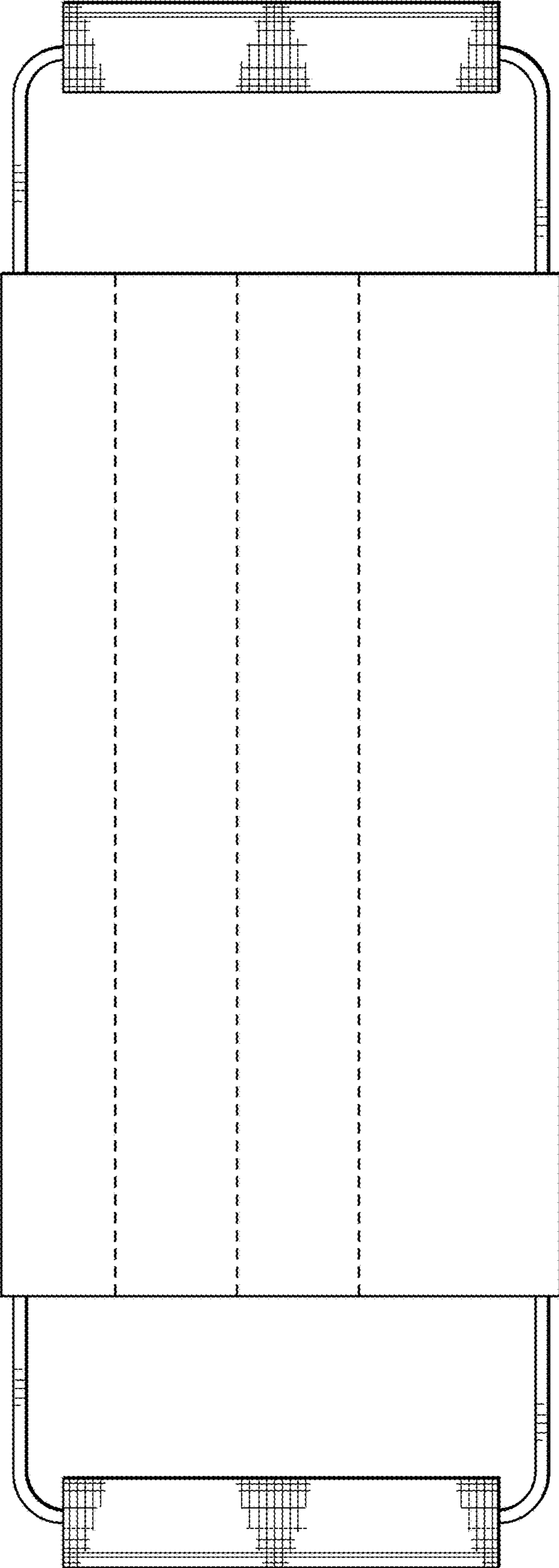

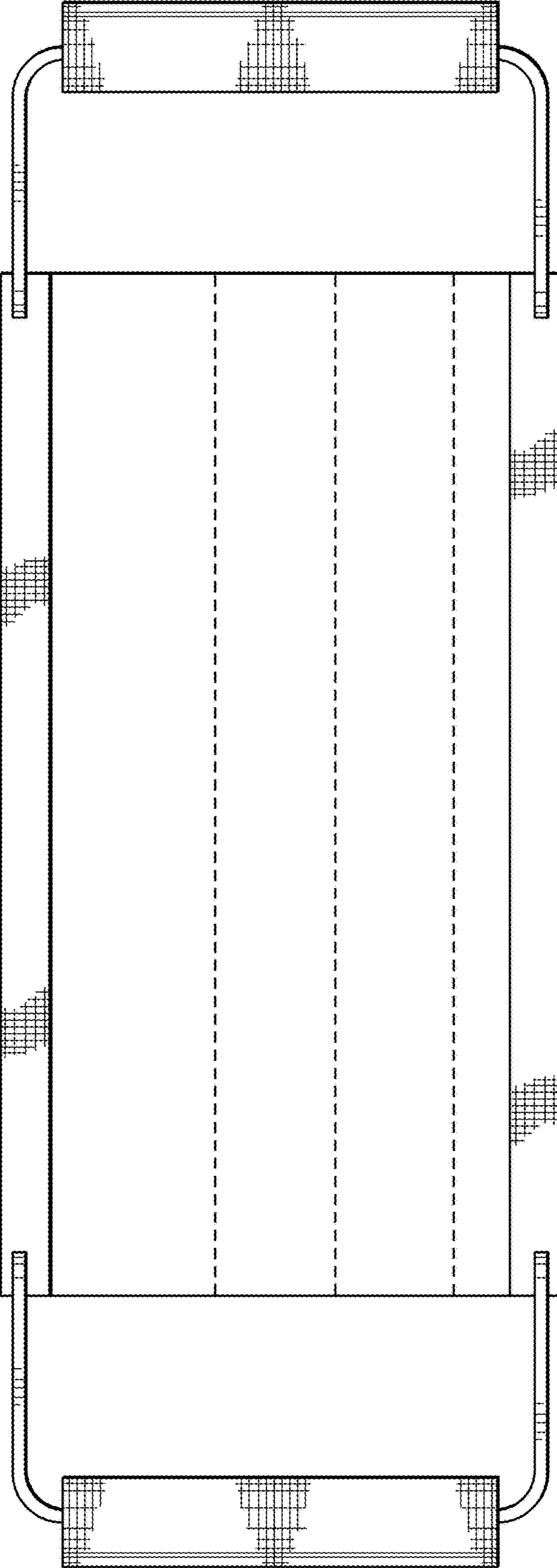

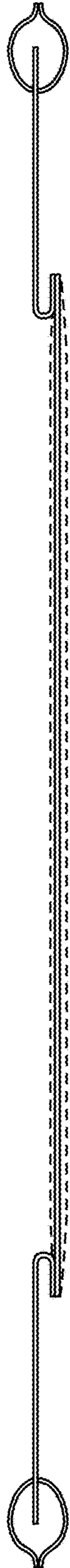

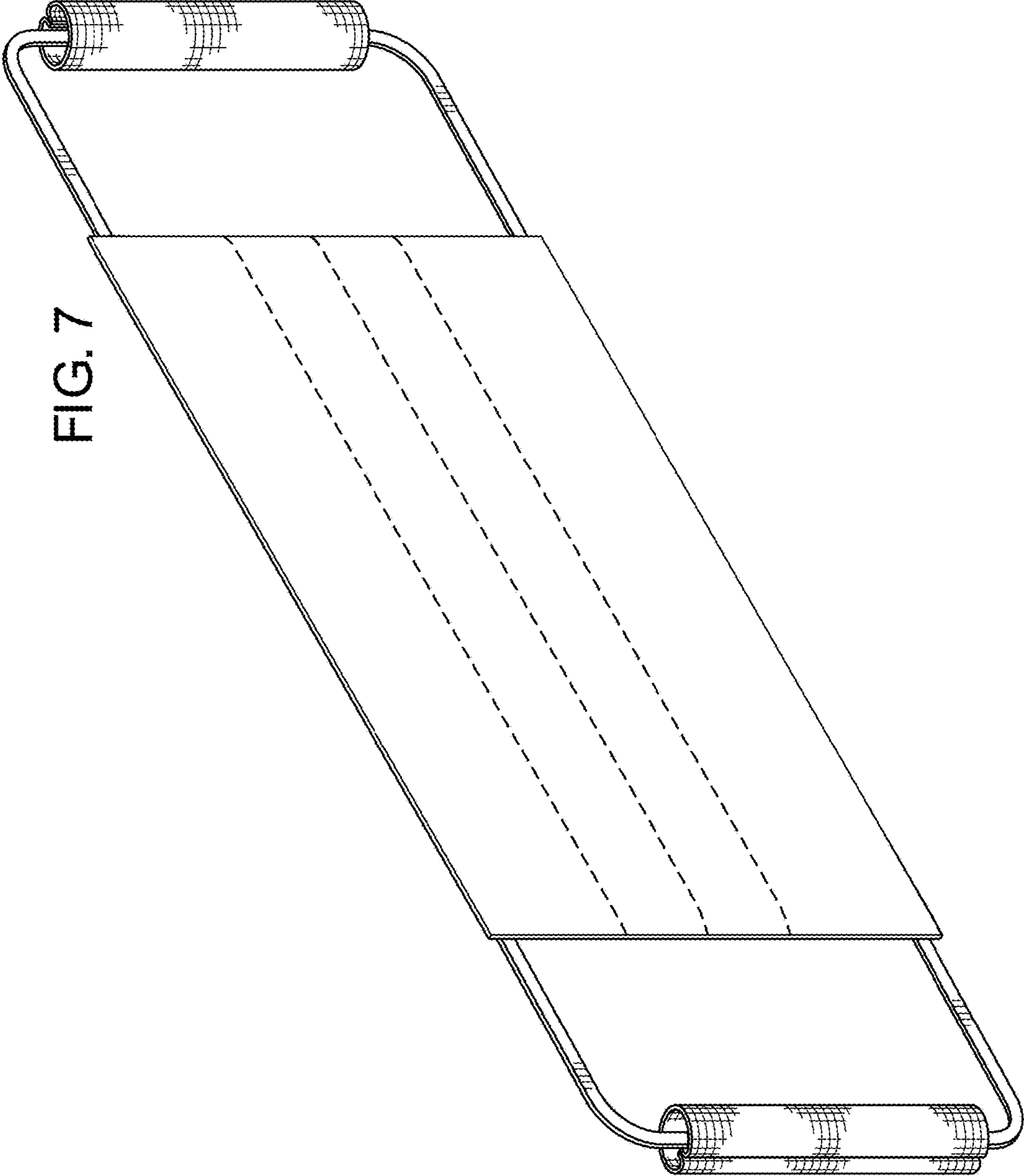

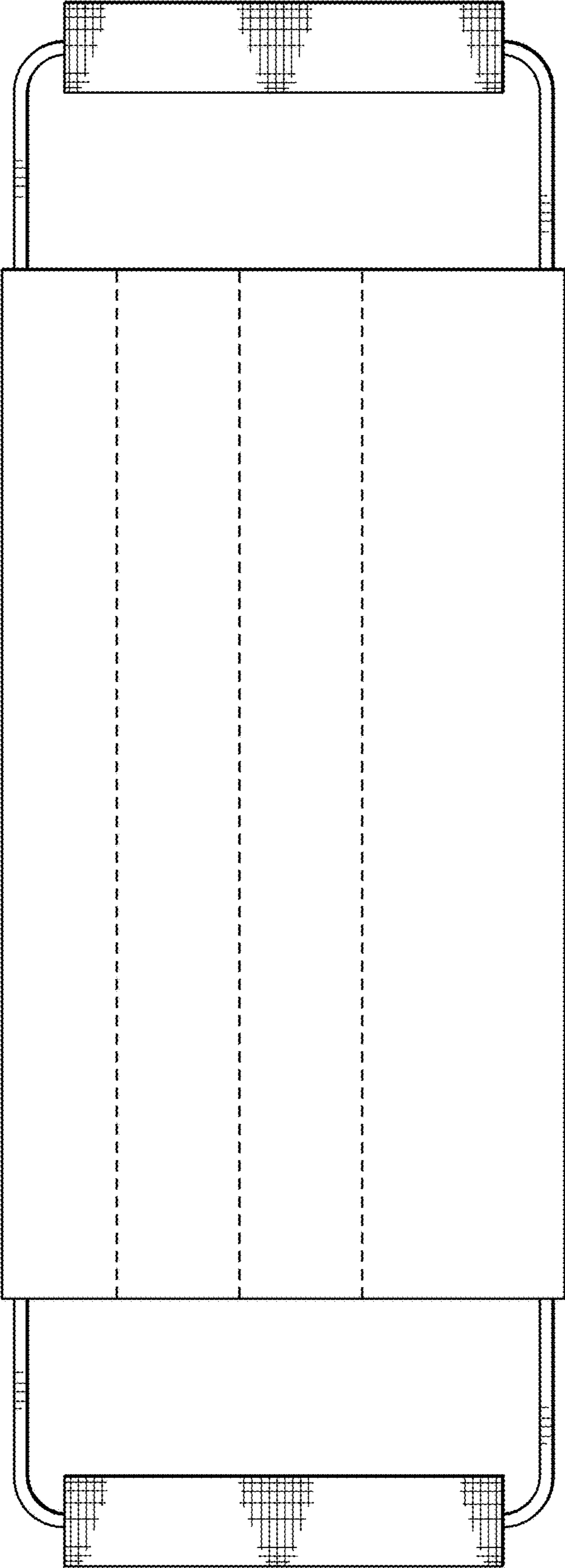

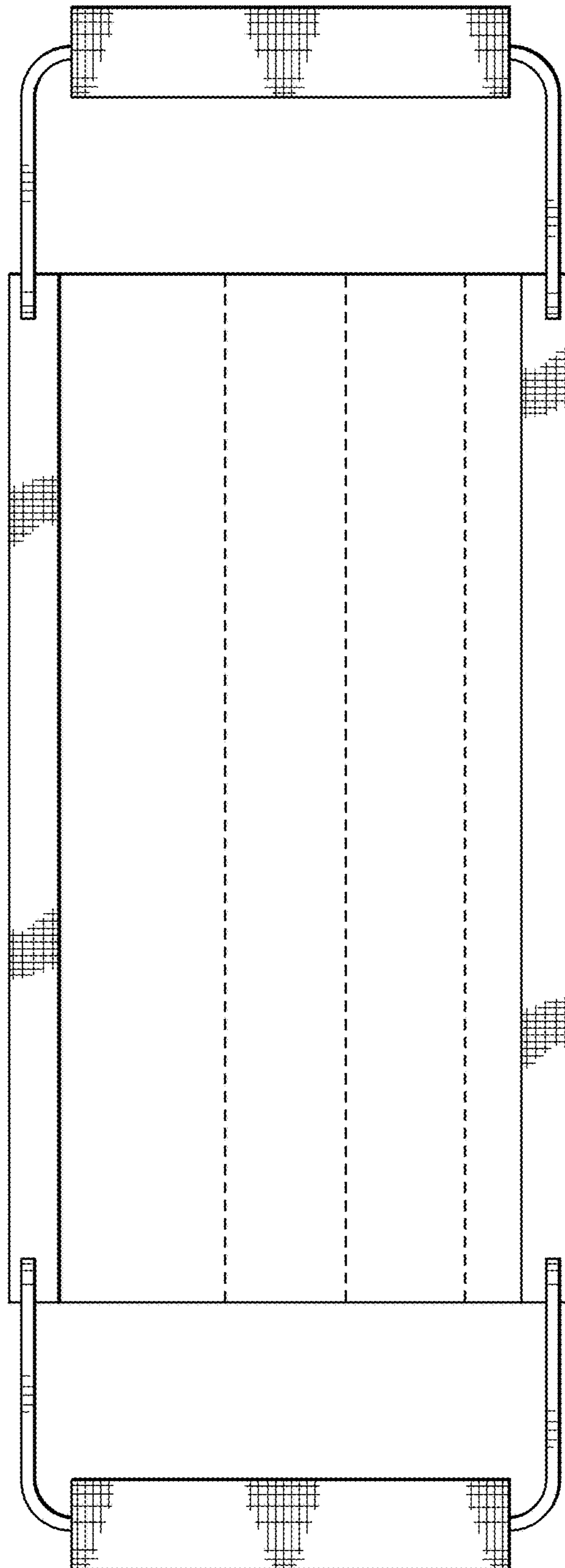

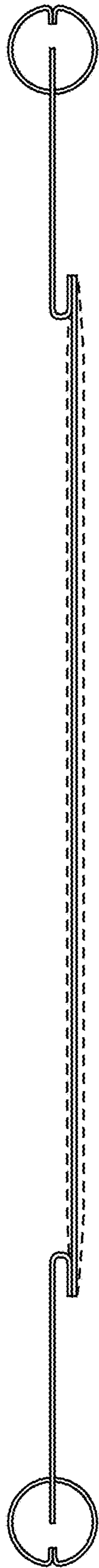

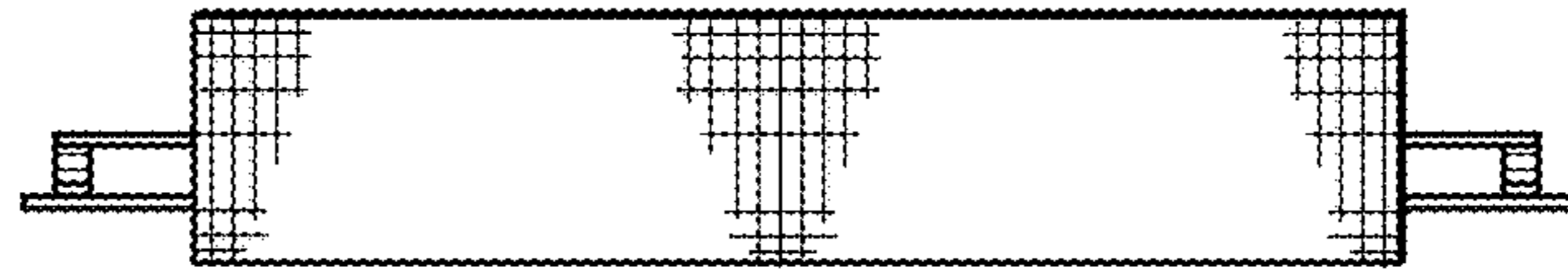
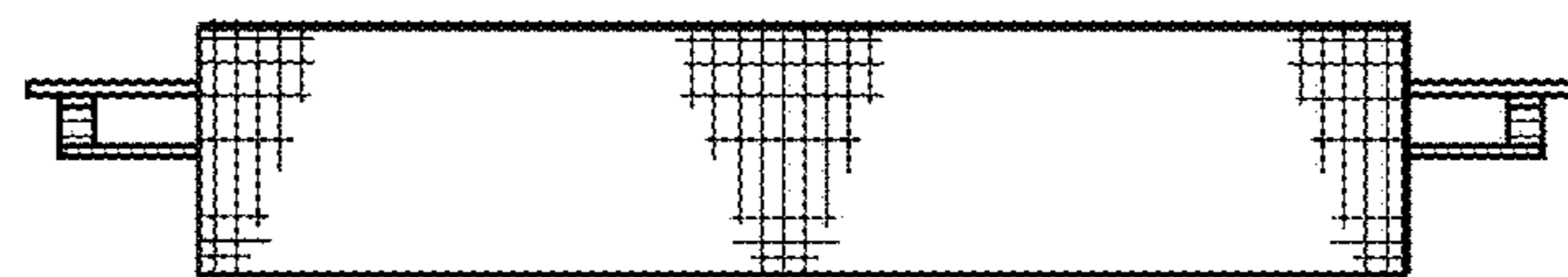

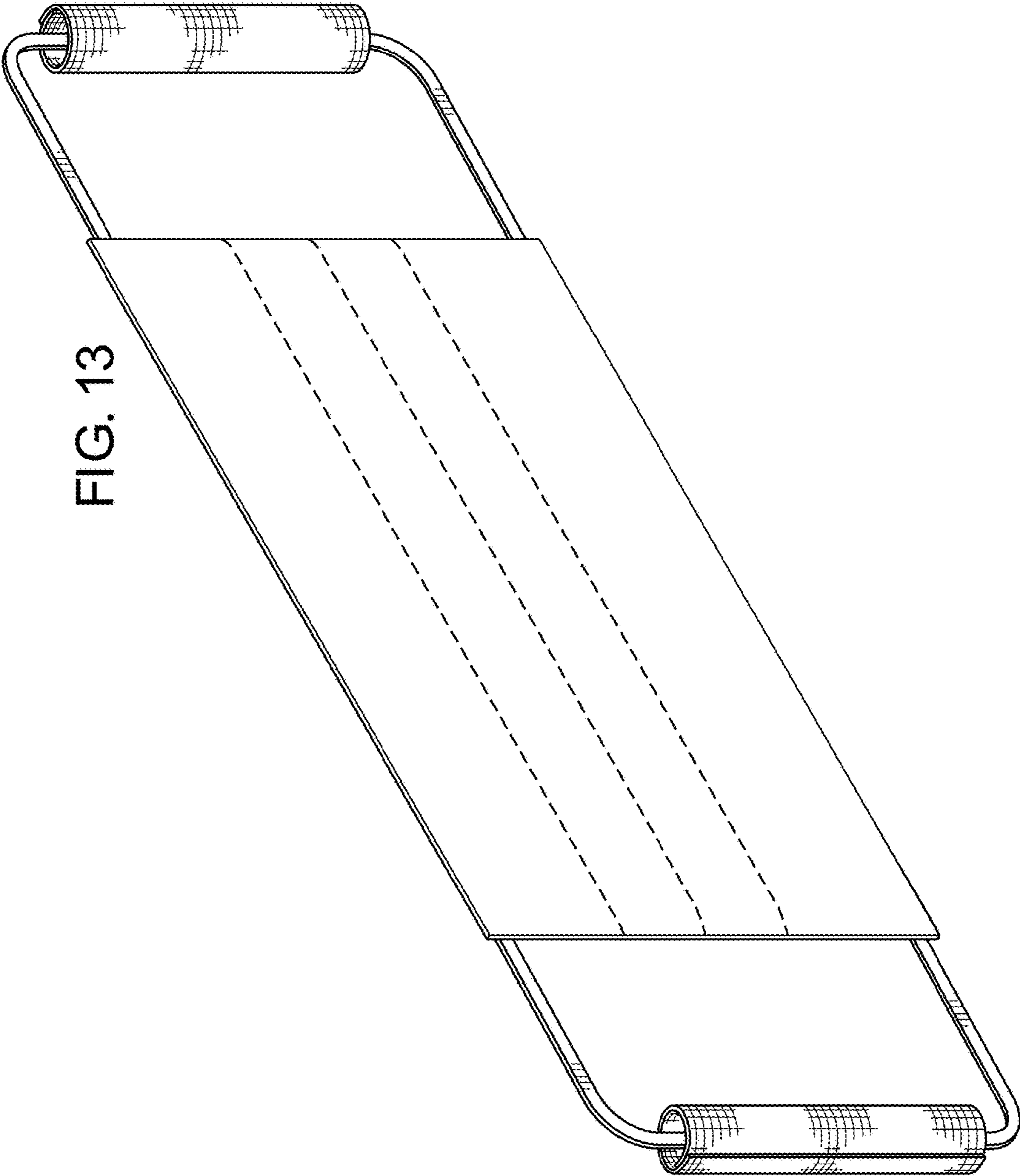

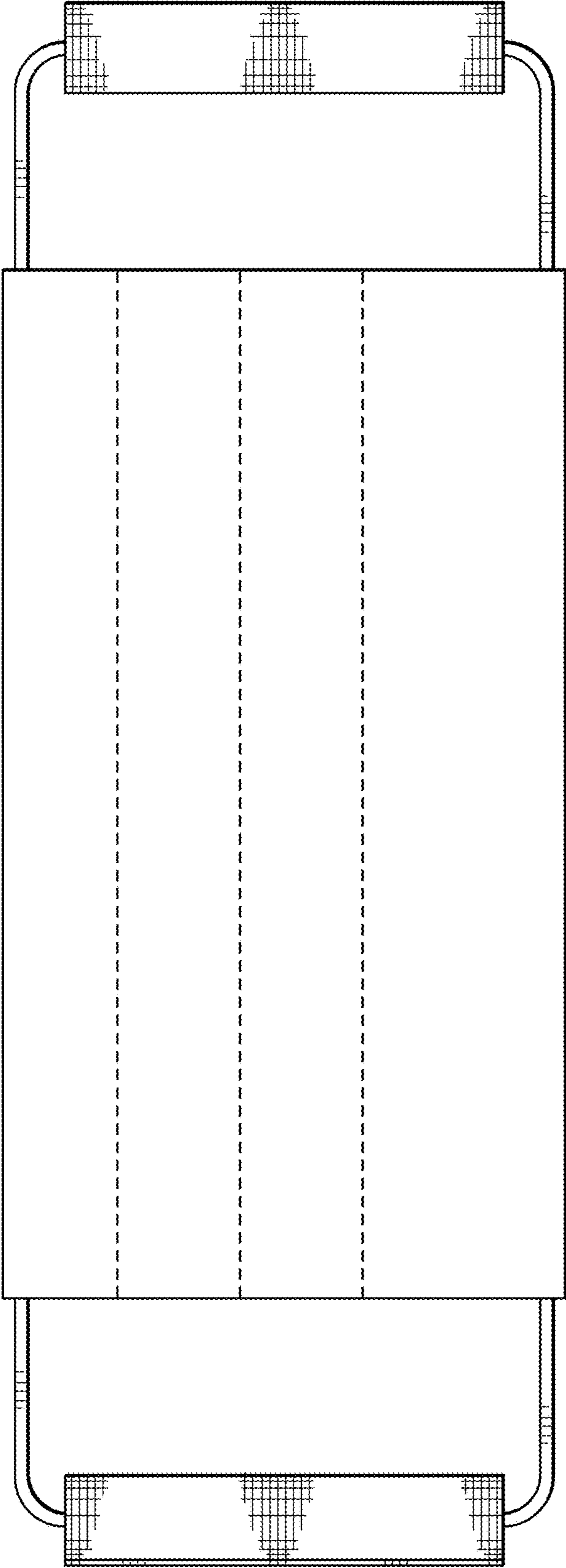

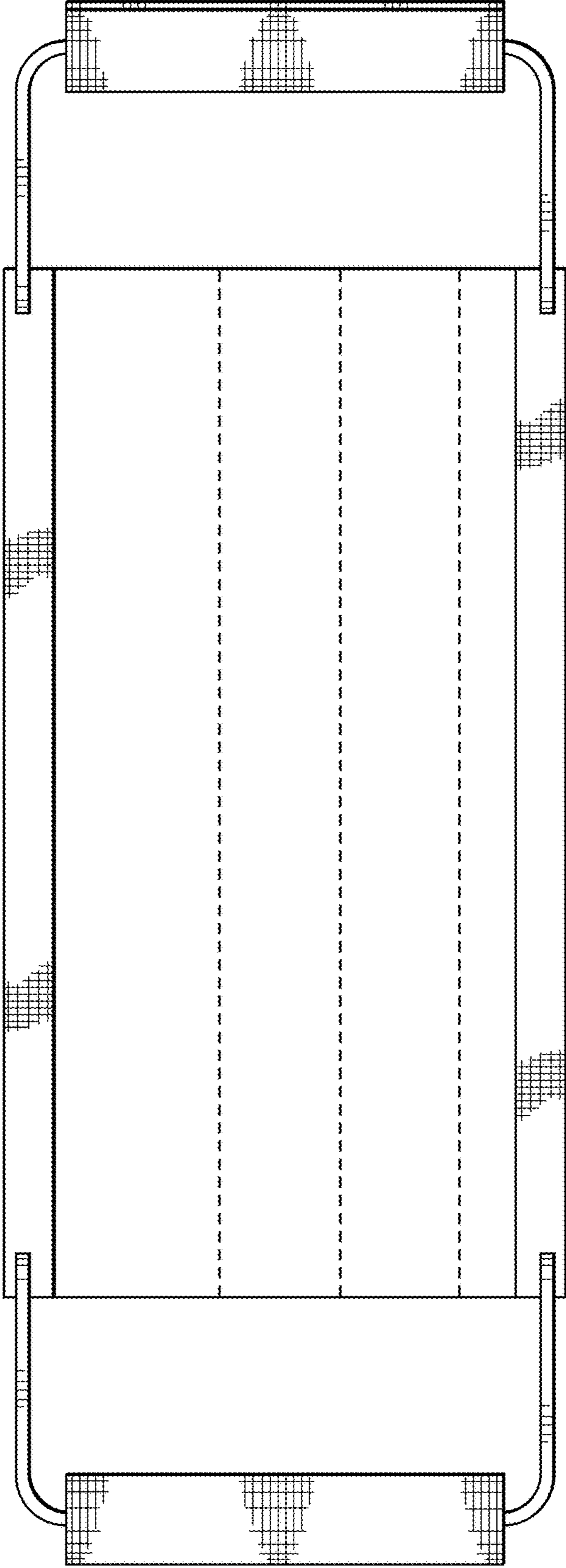

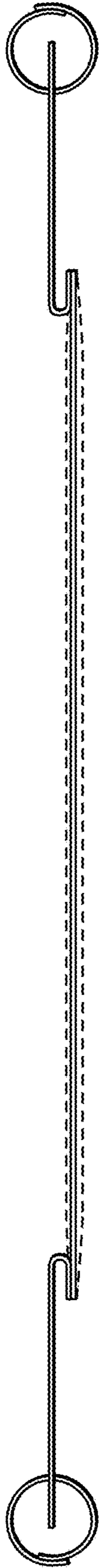

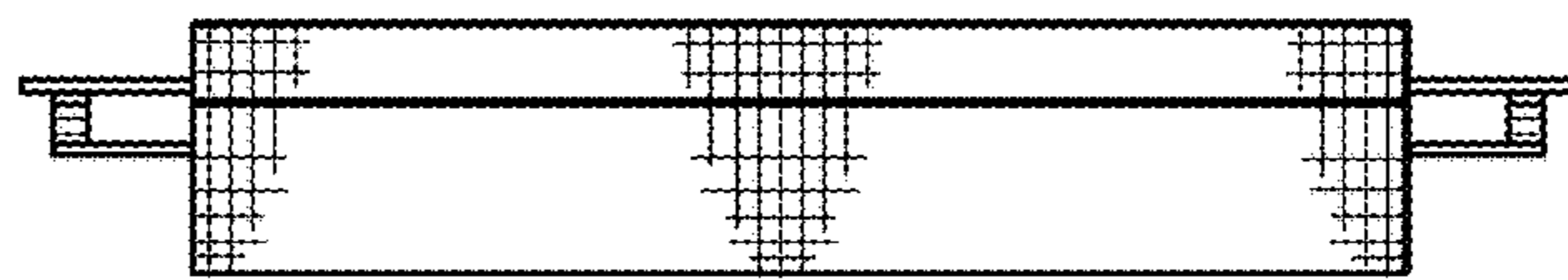
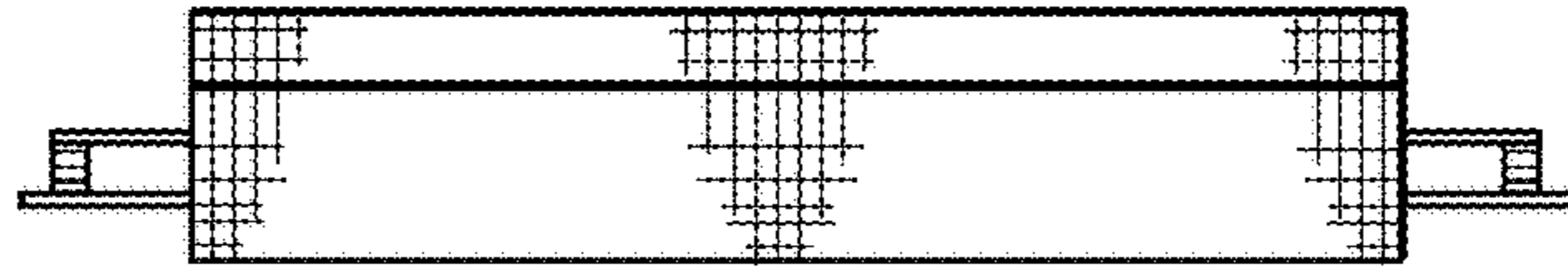

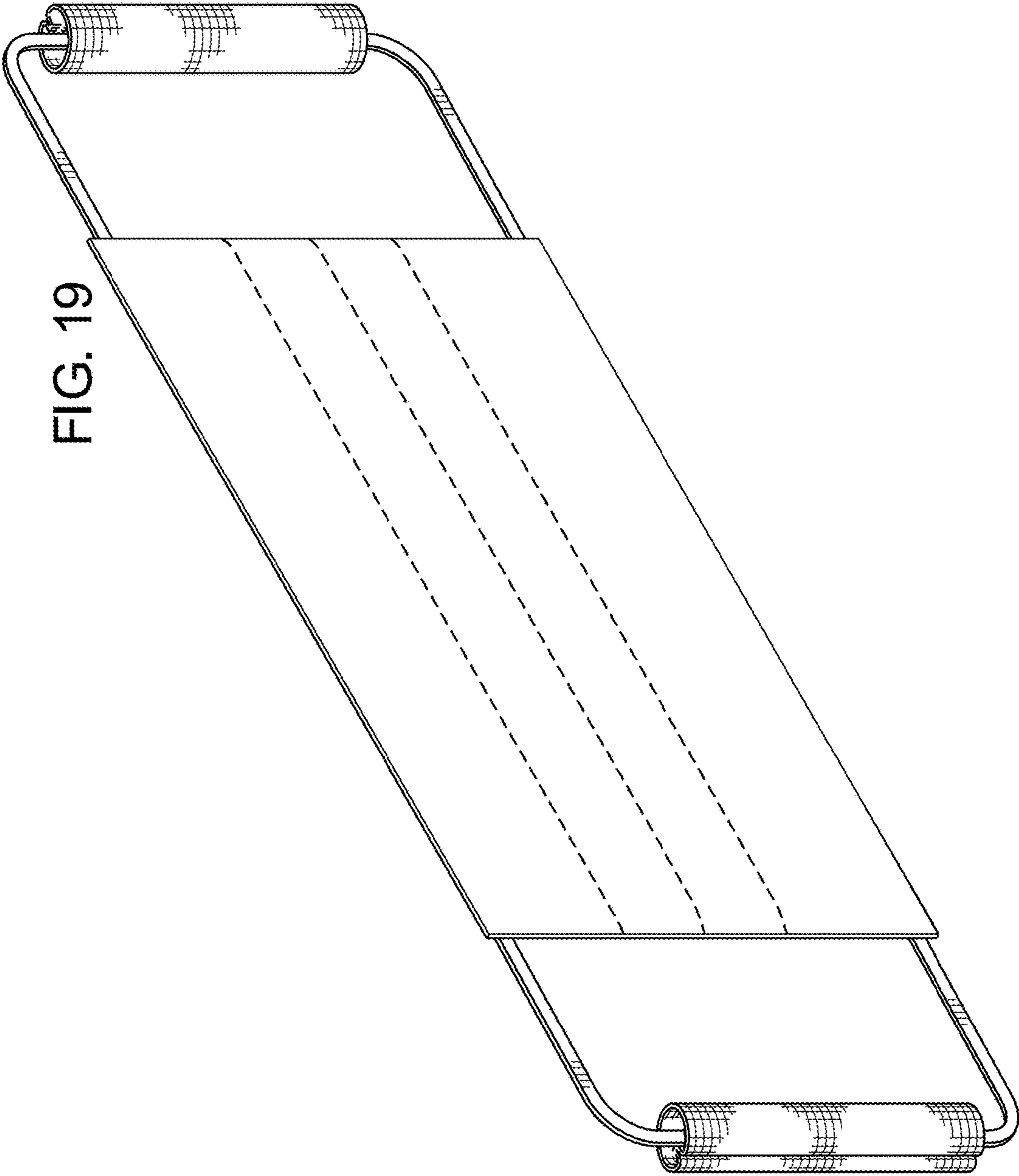

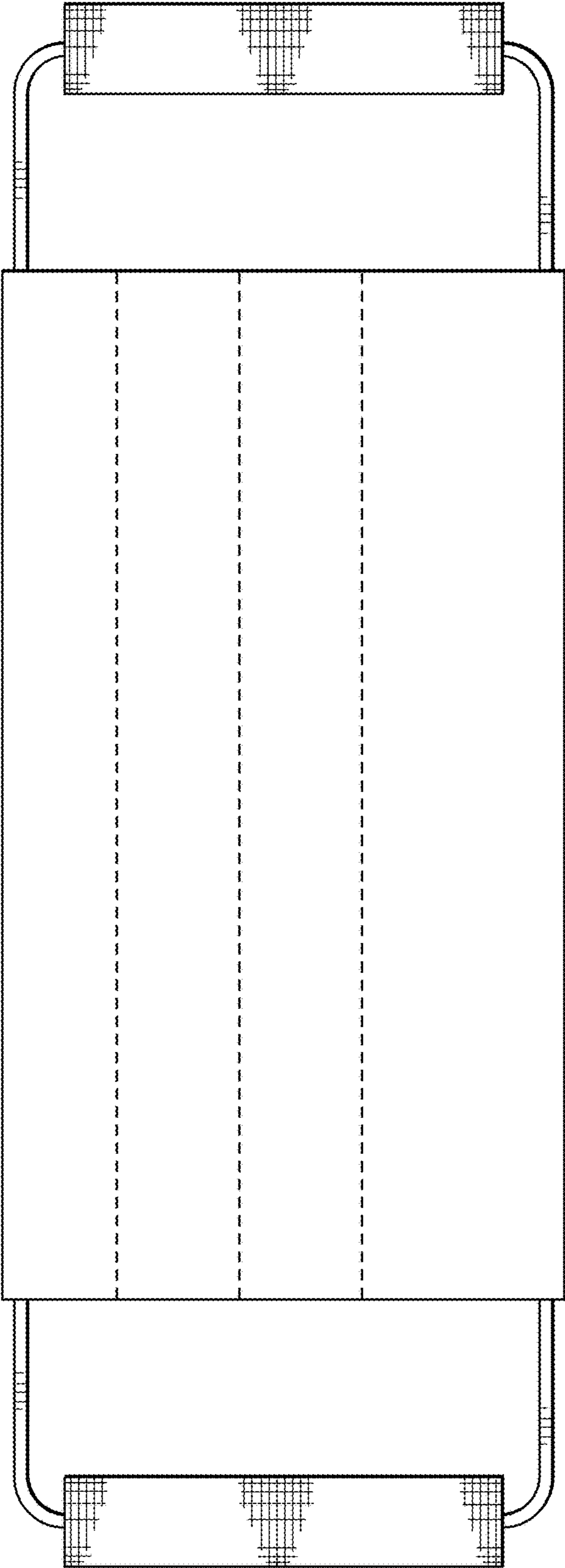

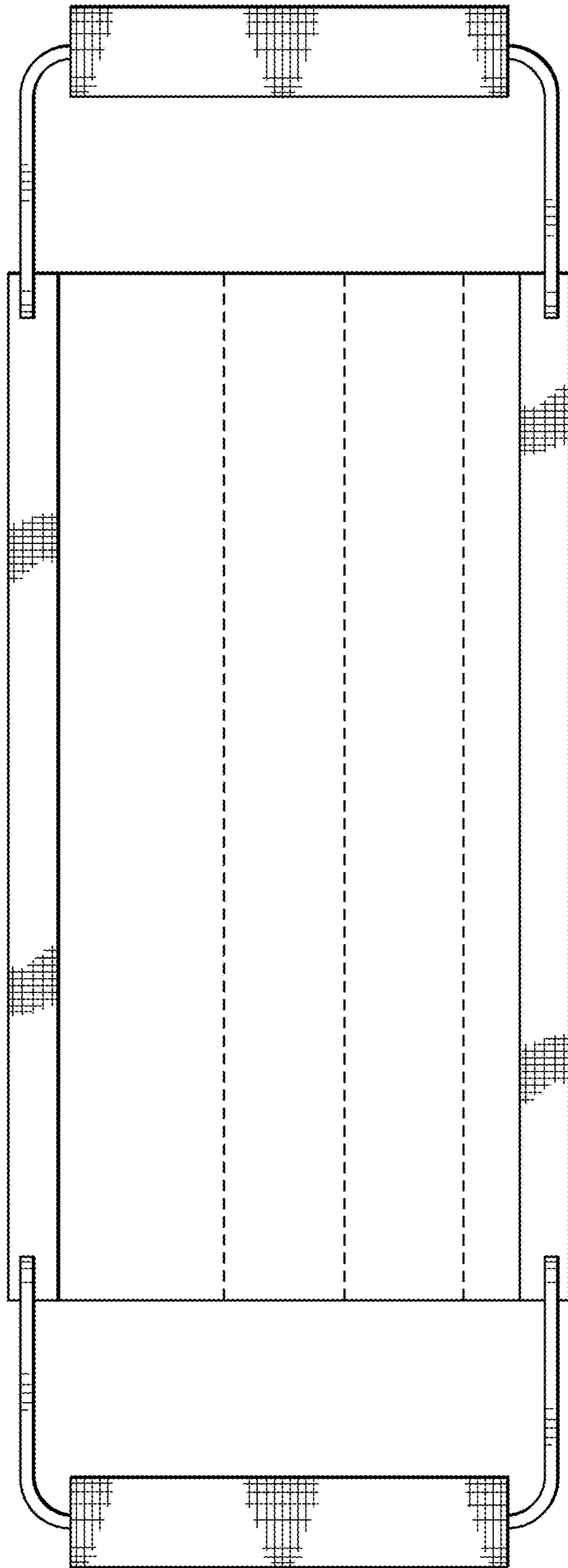

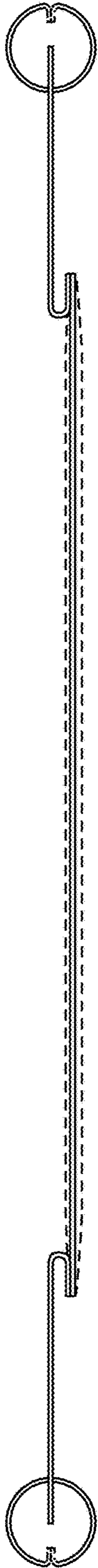

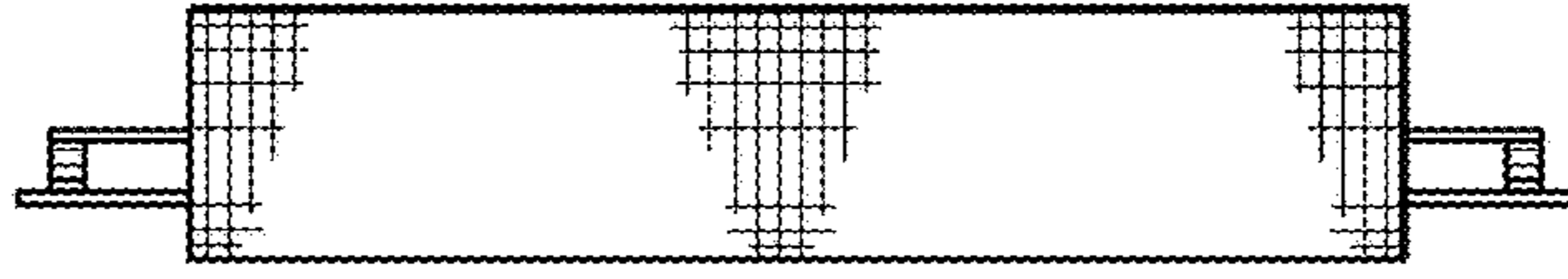
