DESCRIPTION

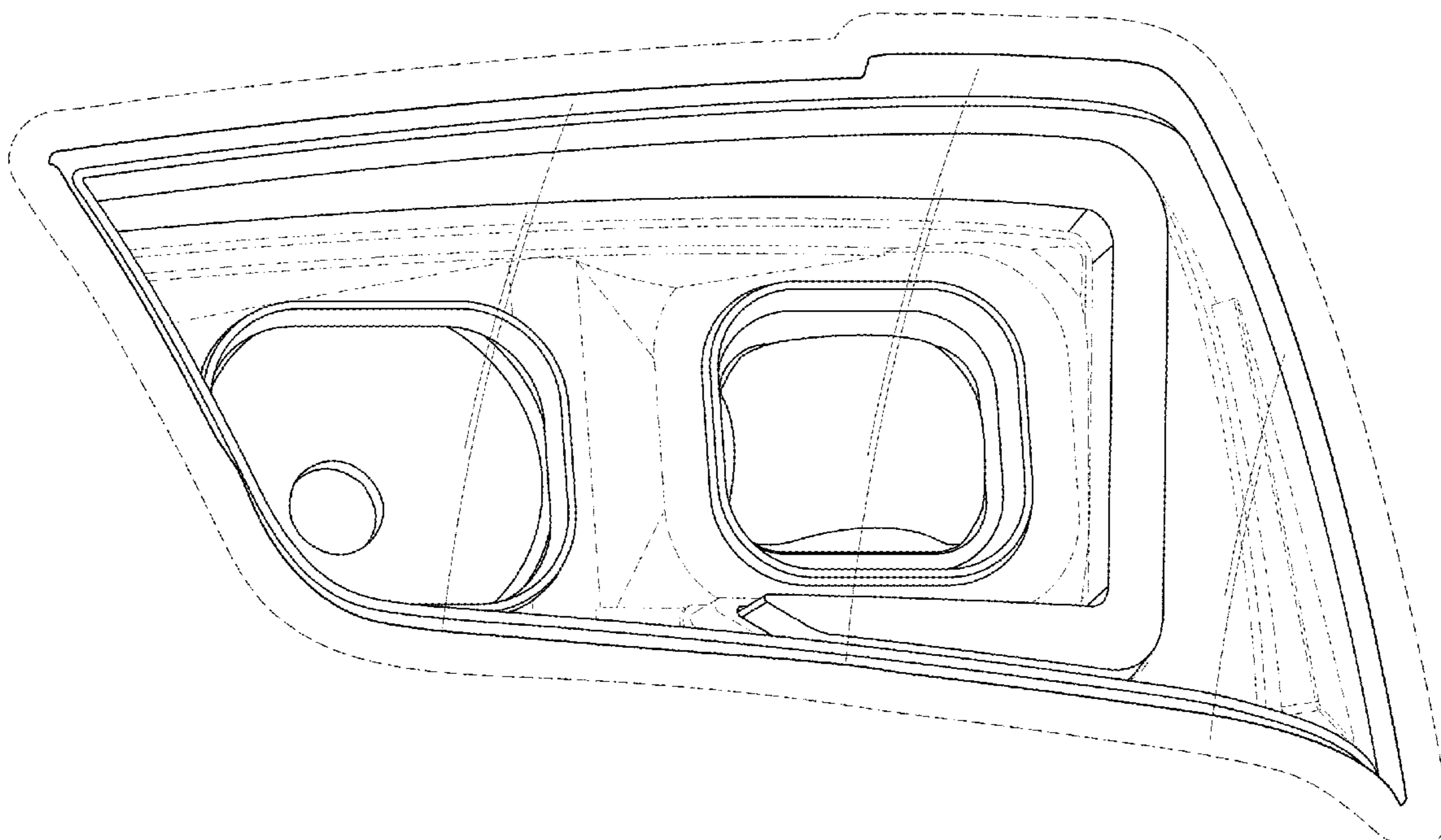
FIG. 1 is a perspective view of a vehicle headlight showing my present design;

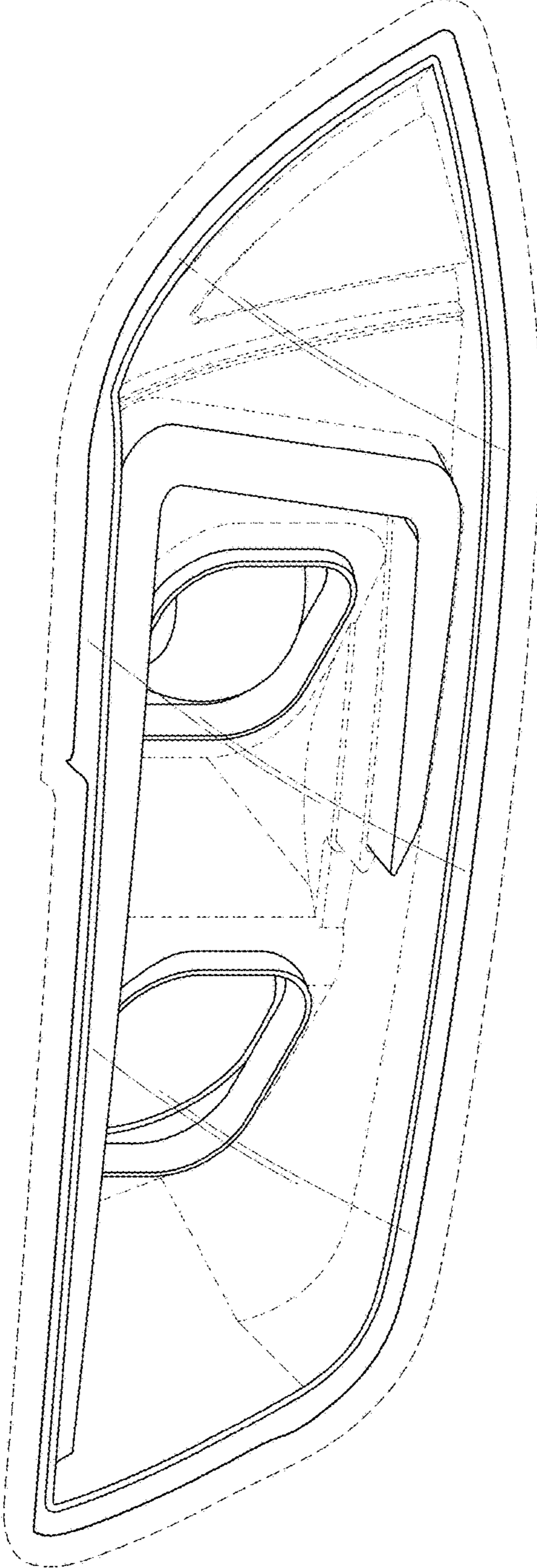

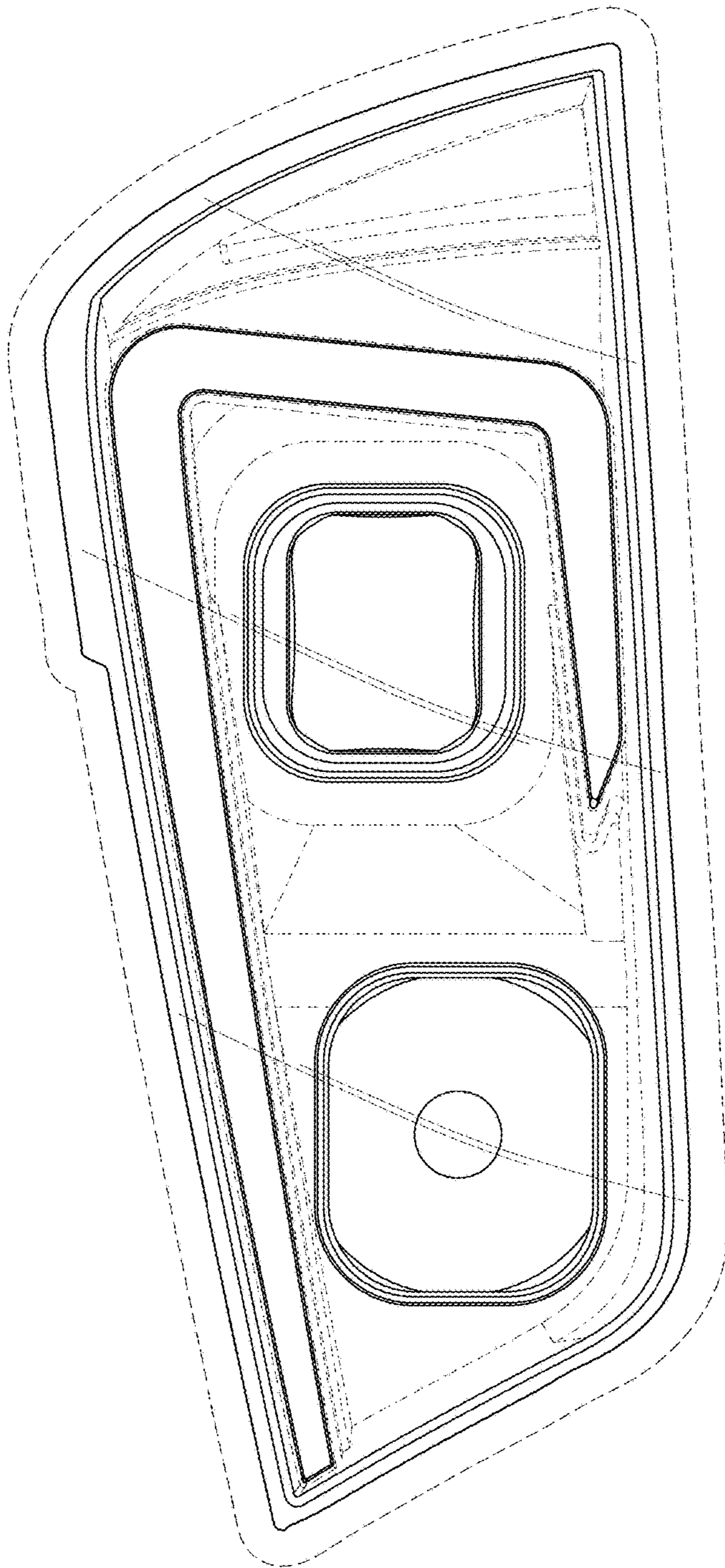

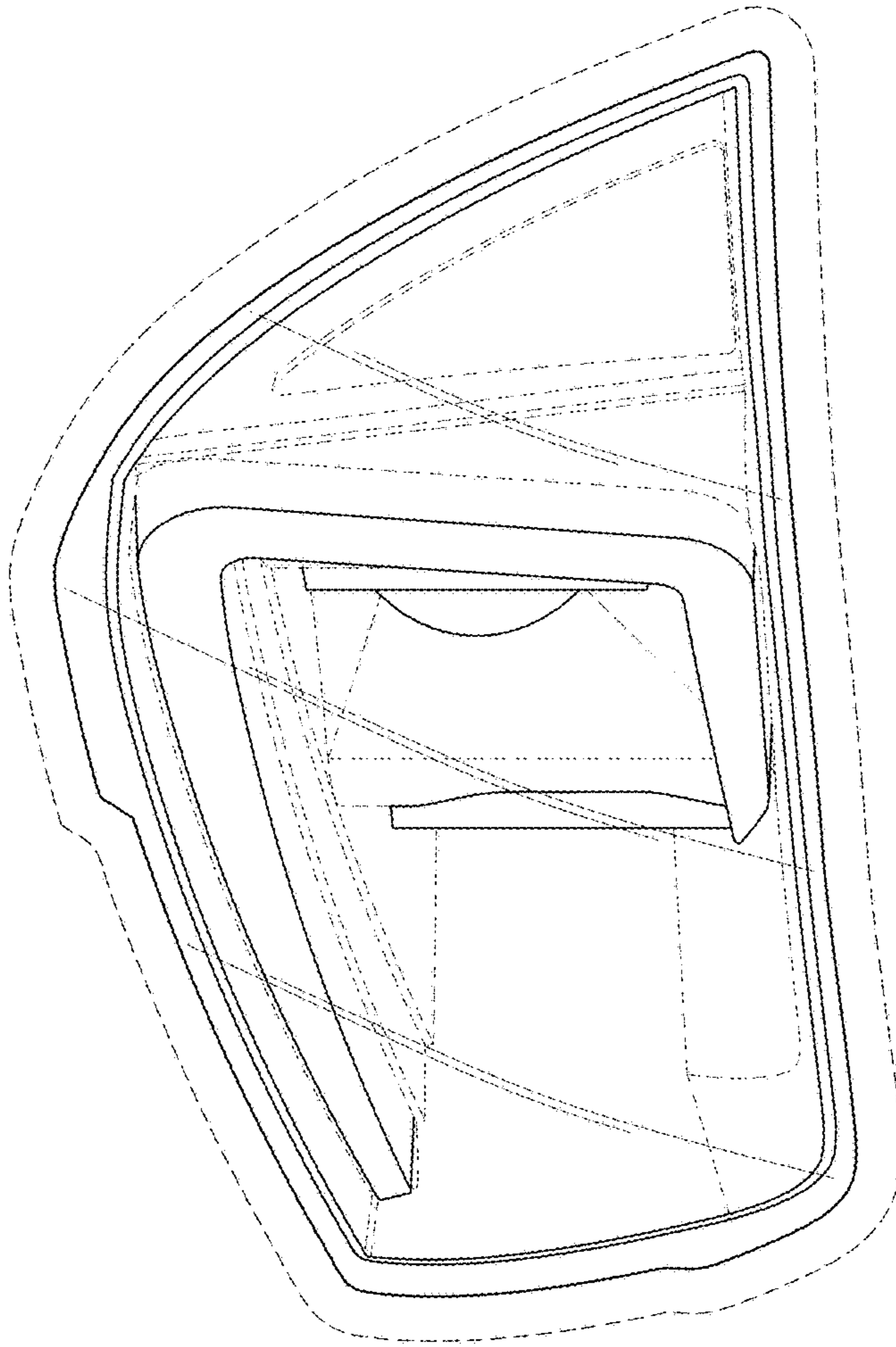

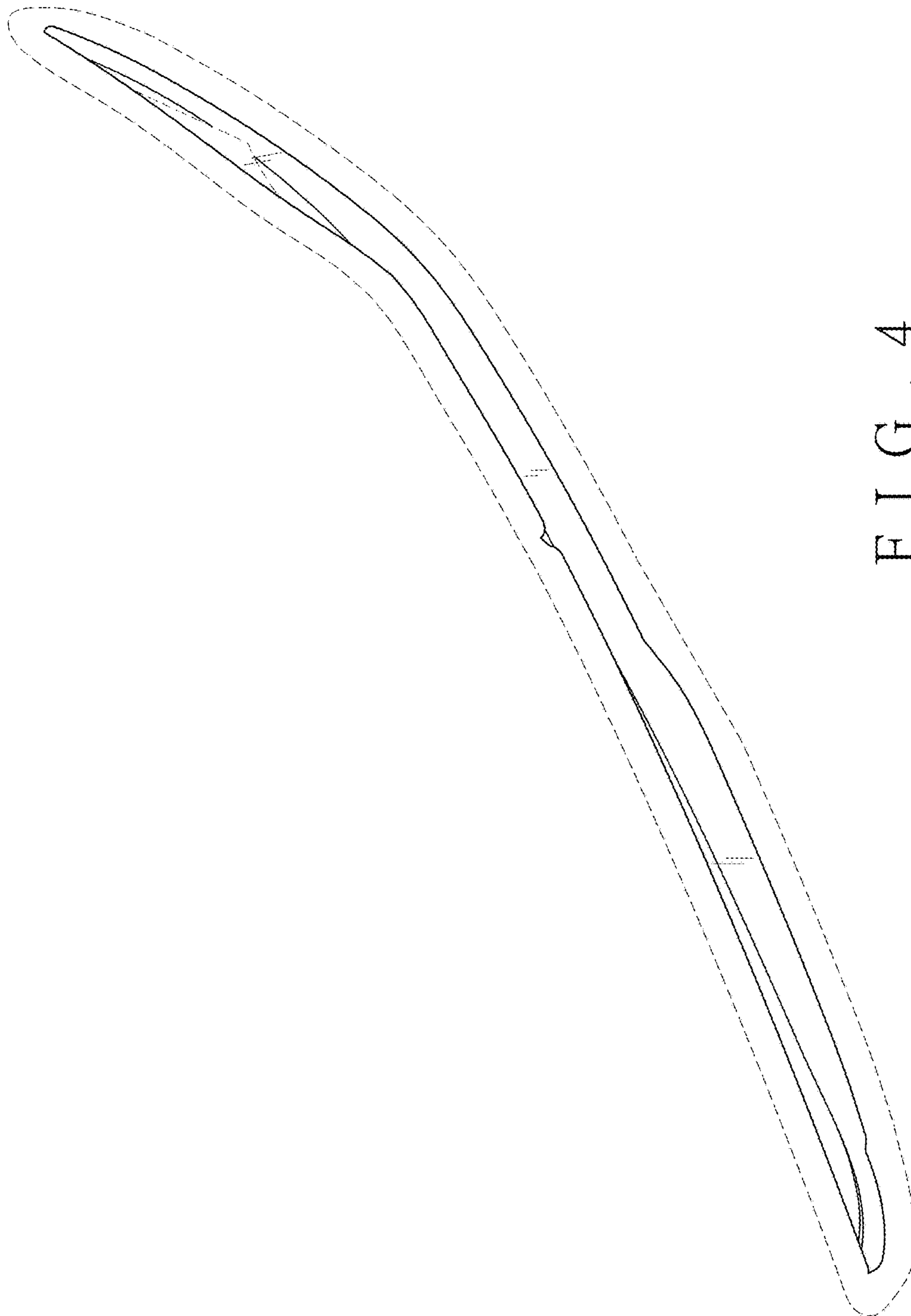

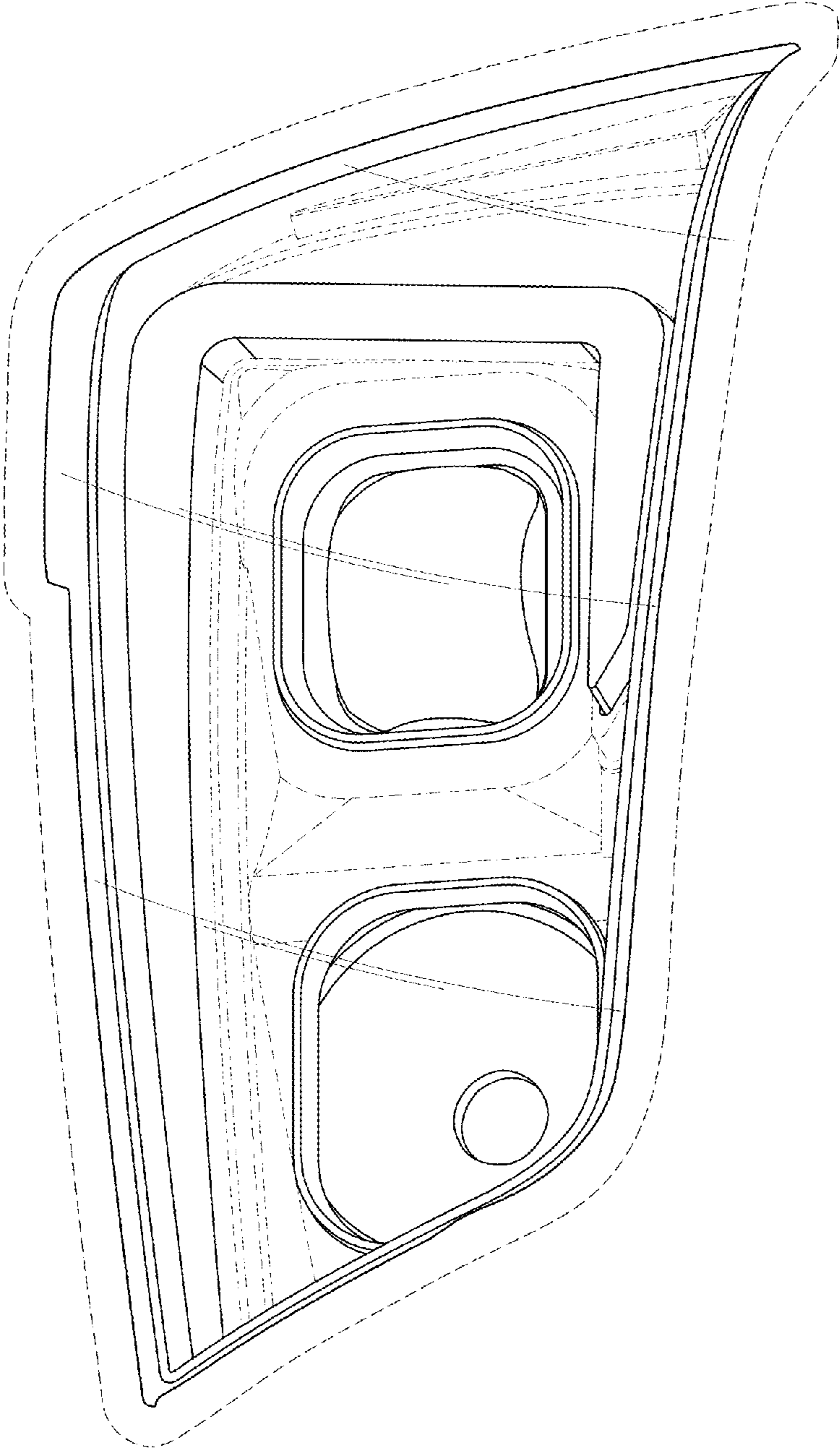
