The ornamental design for a decorative lamp, as shown and described.

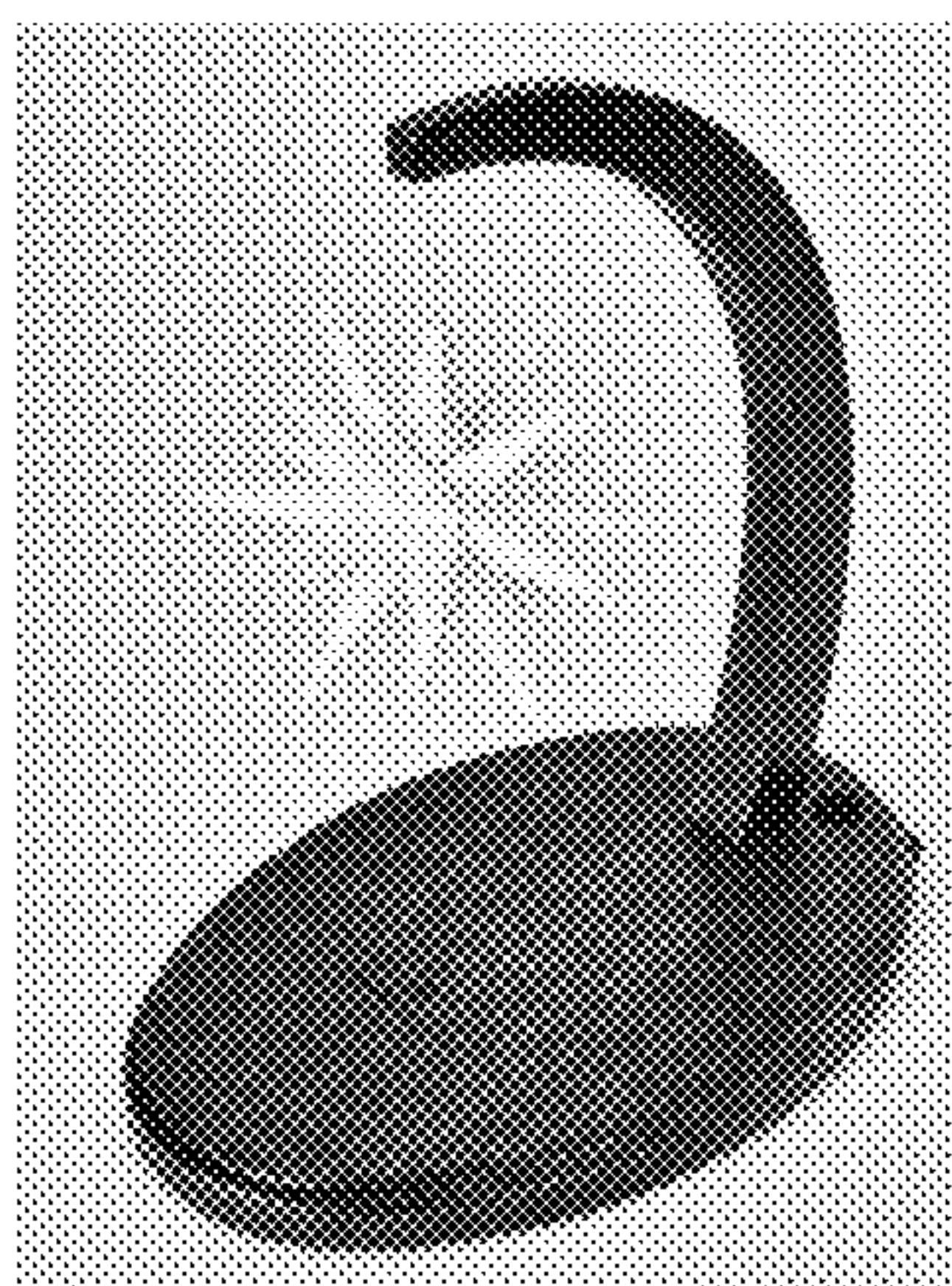

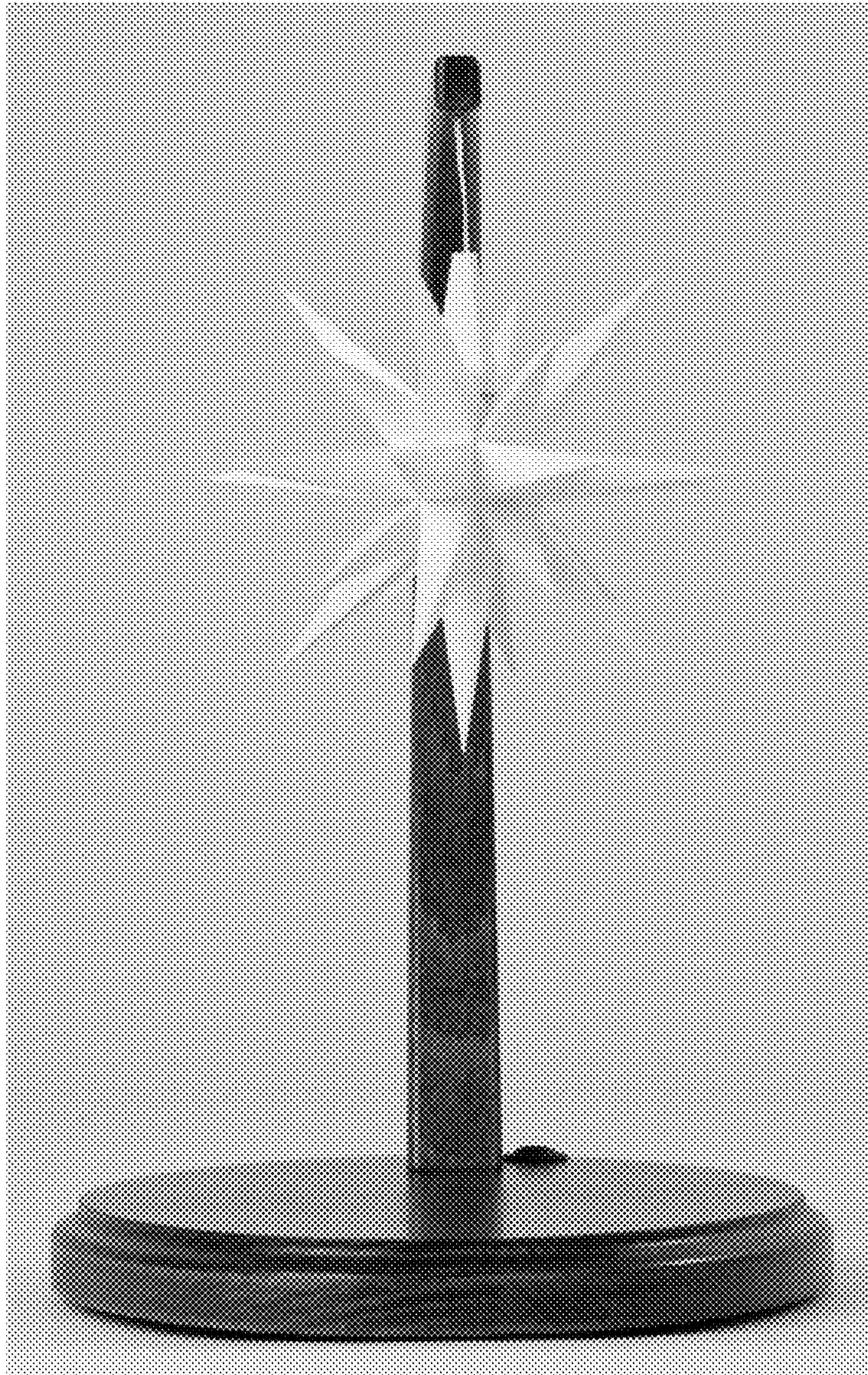

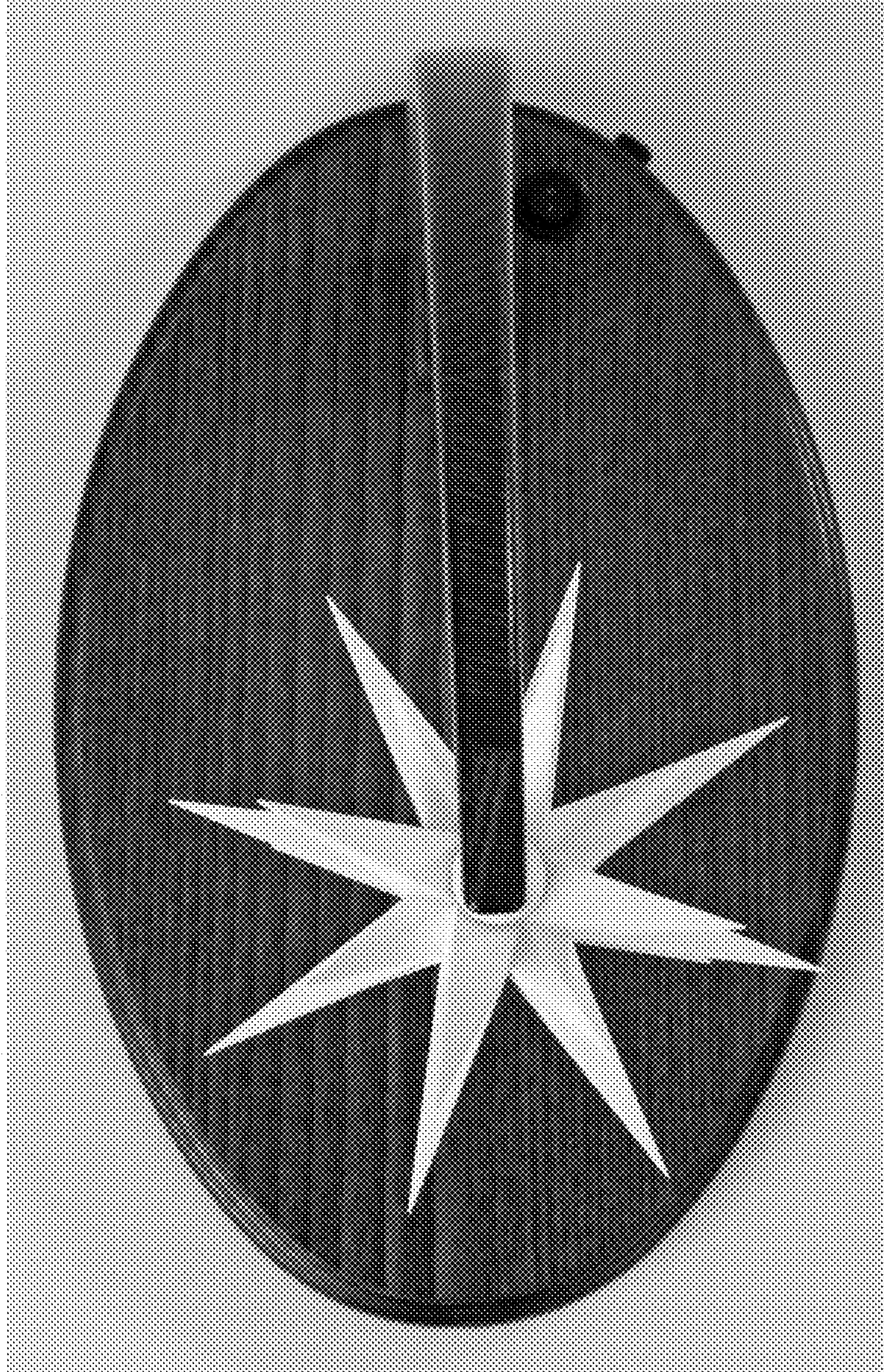
