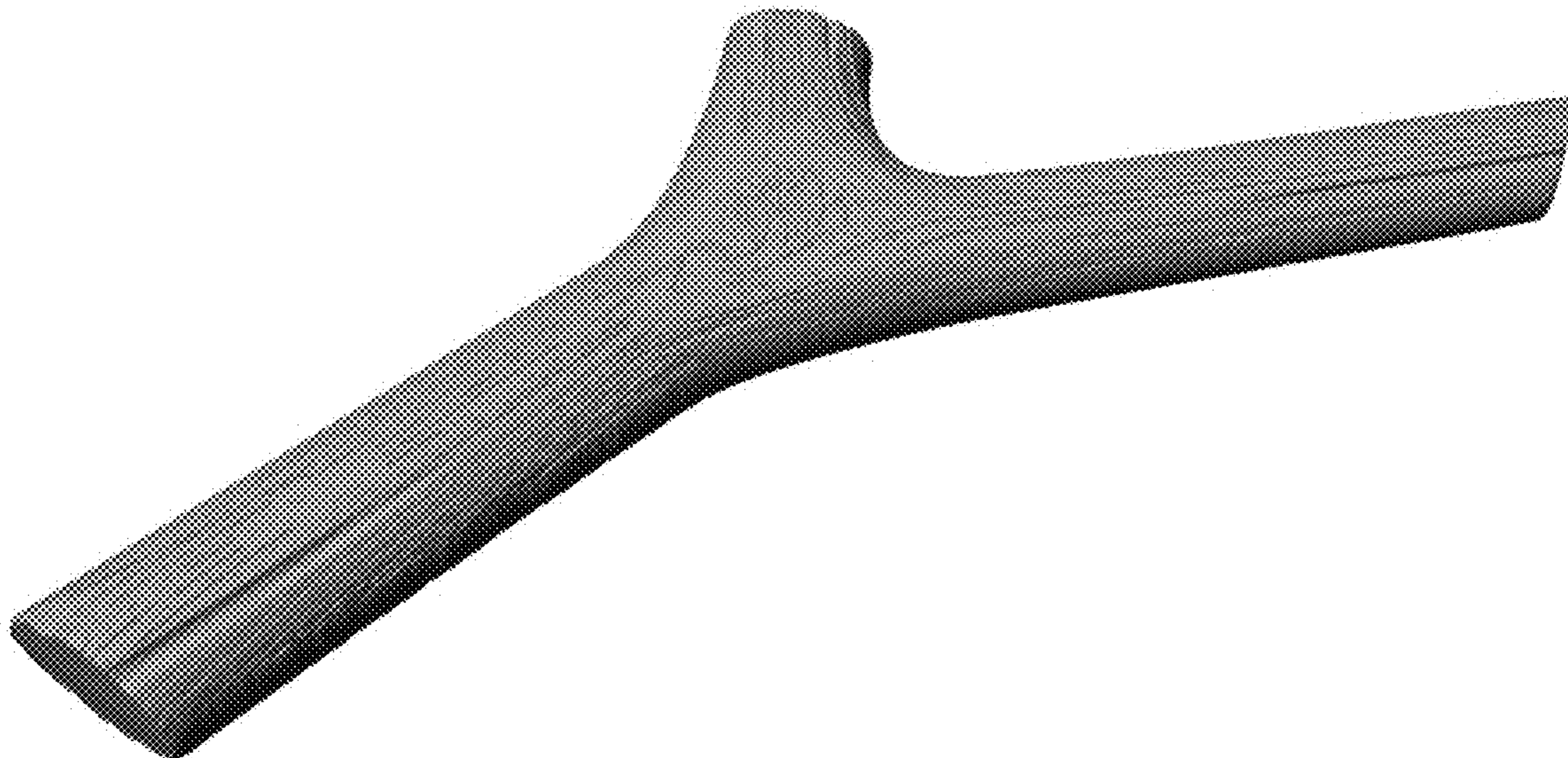

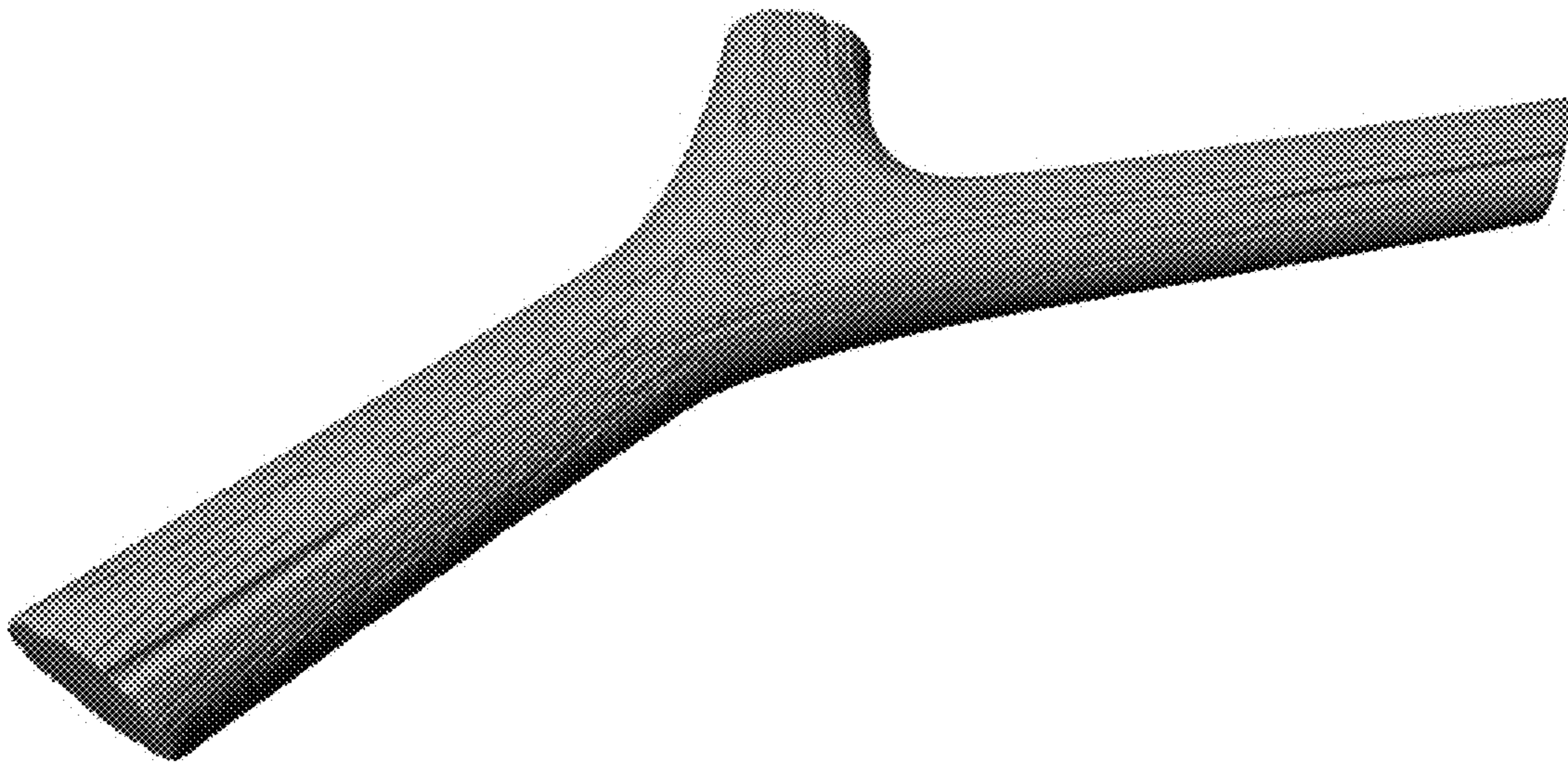

Toy for animals shaped as a tree branch.

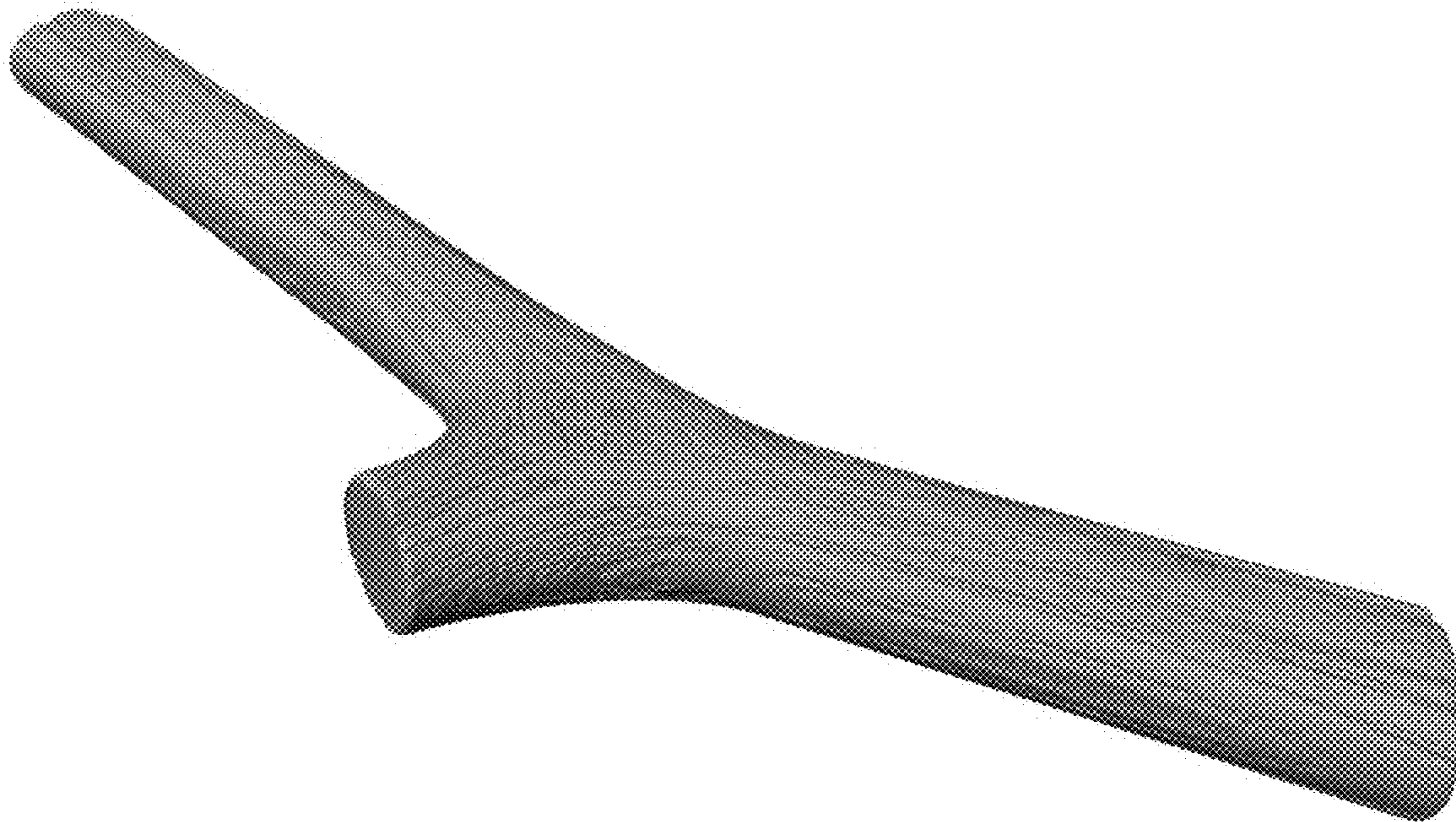
