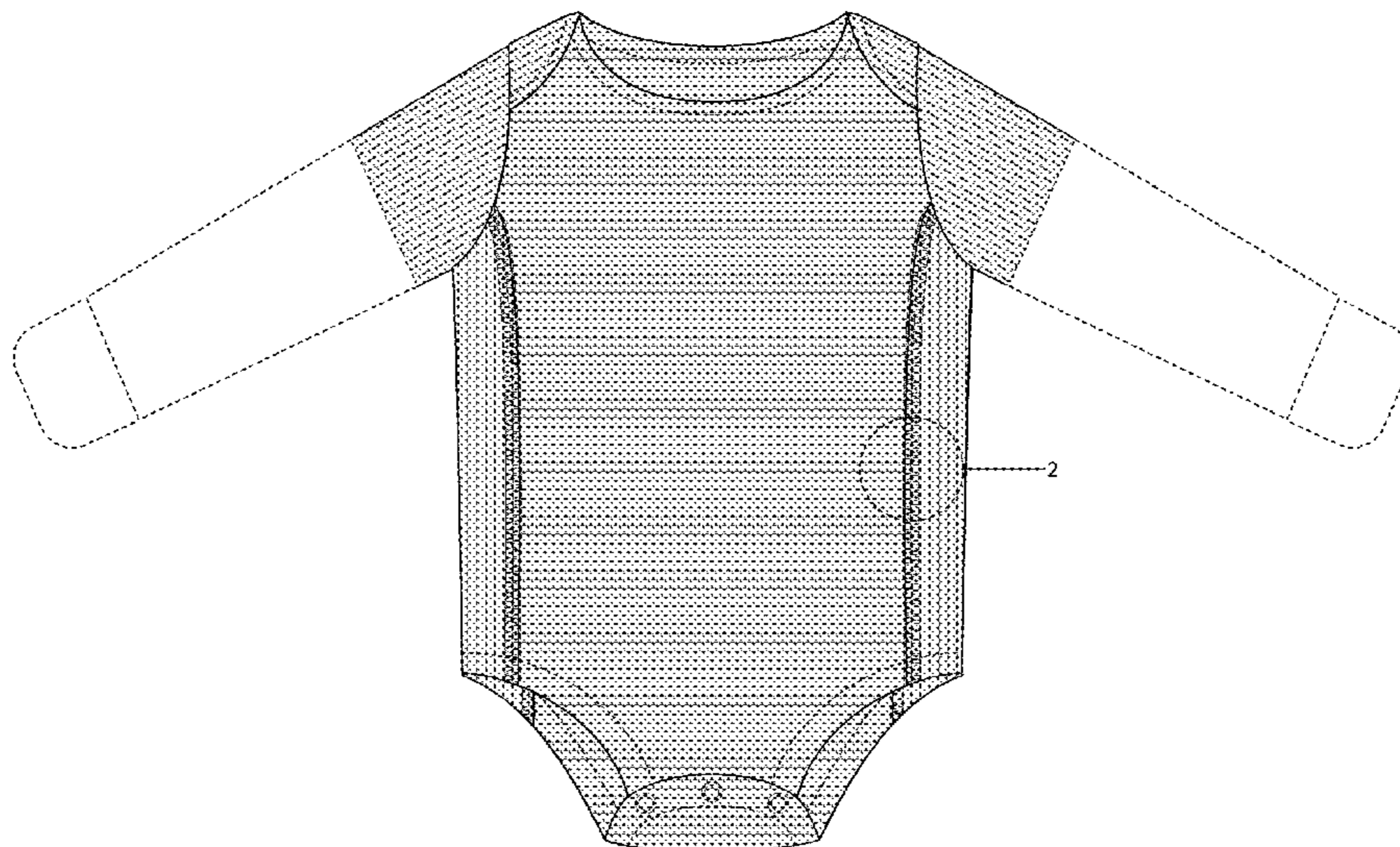
The ornamental design for a infant flex apparel, as shown and described.

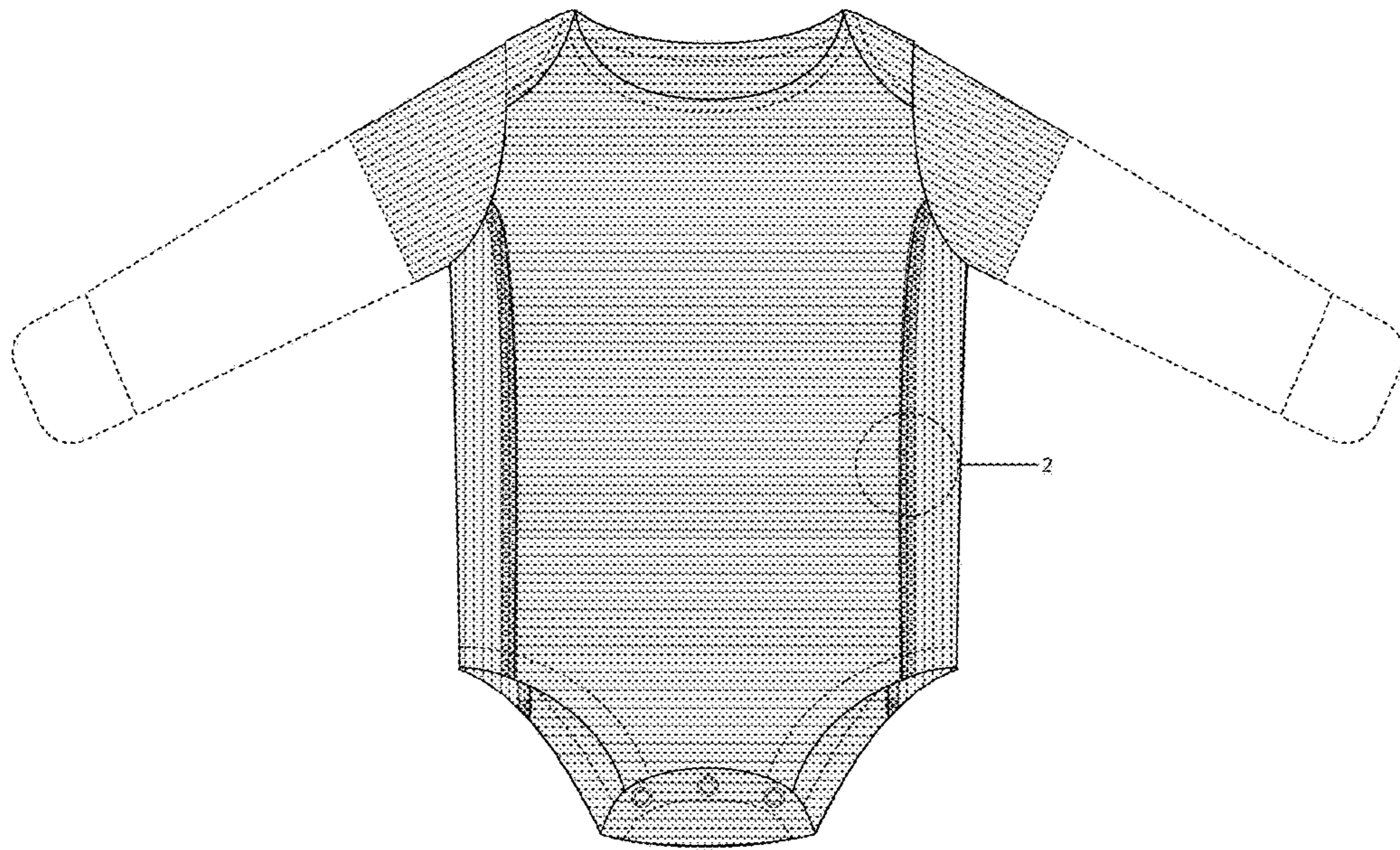

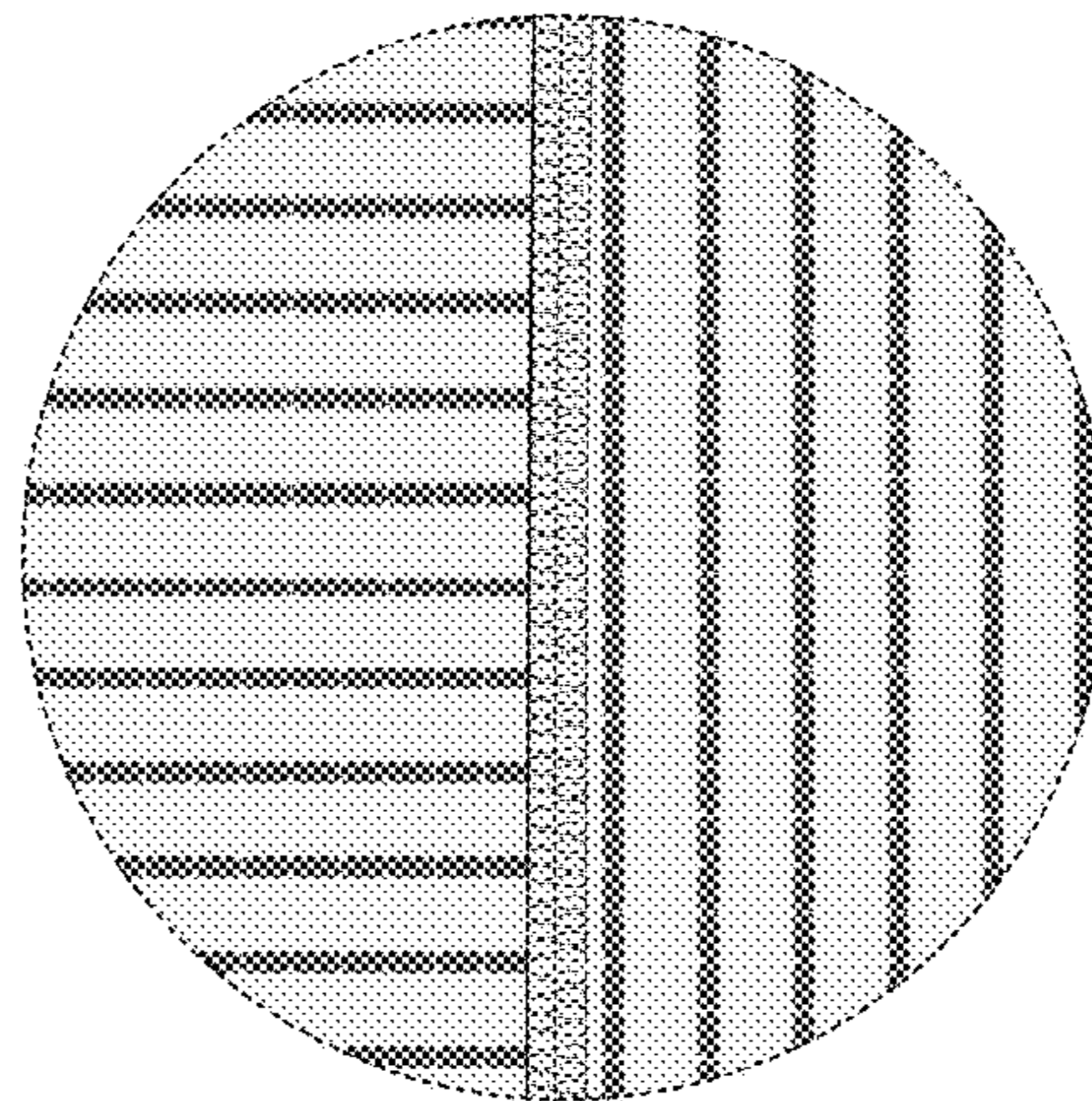

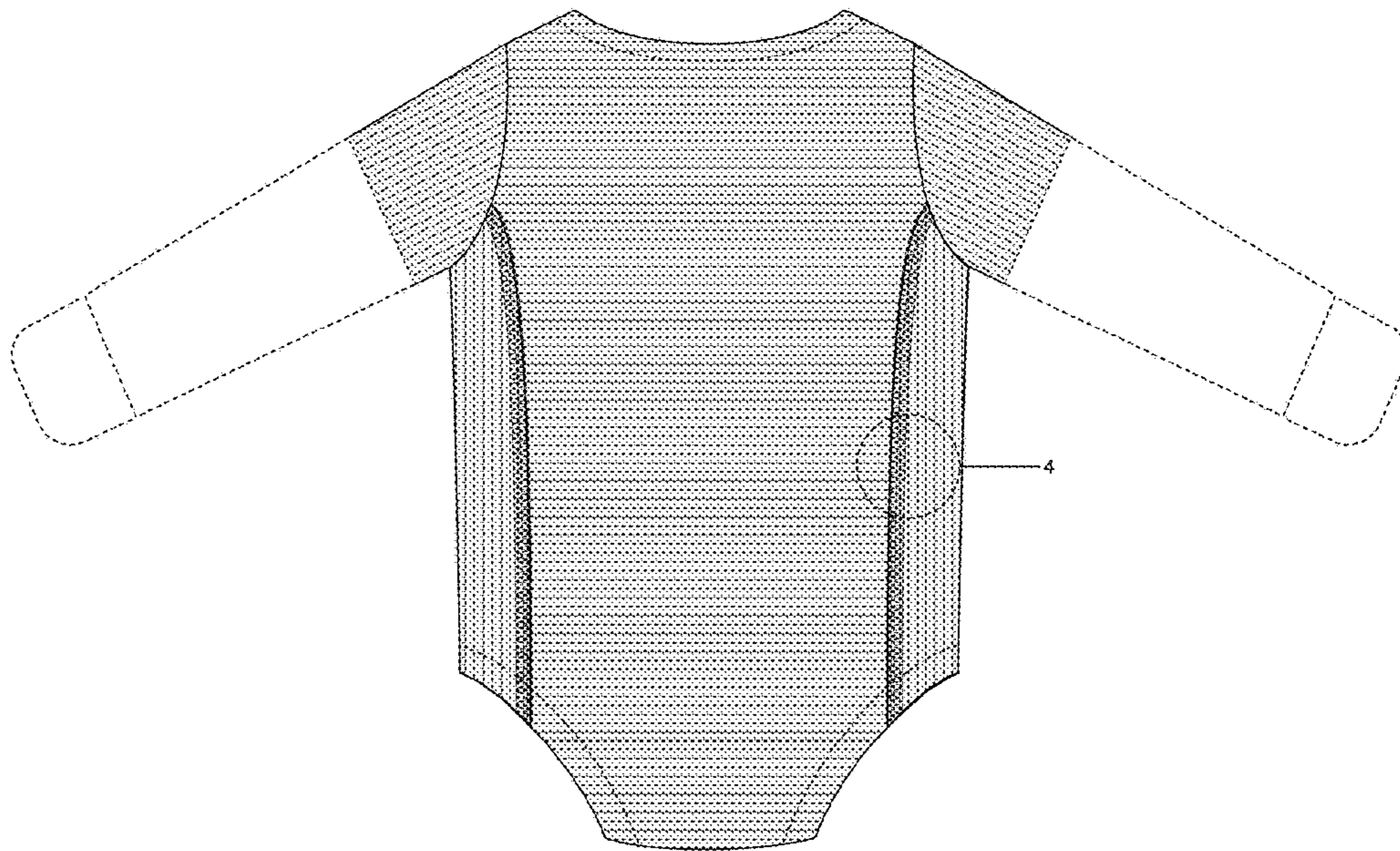

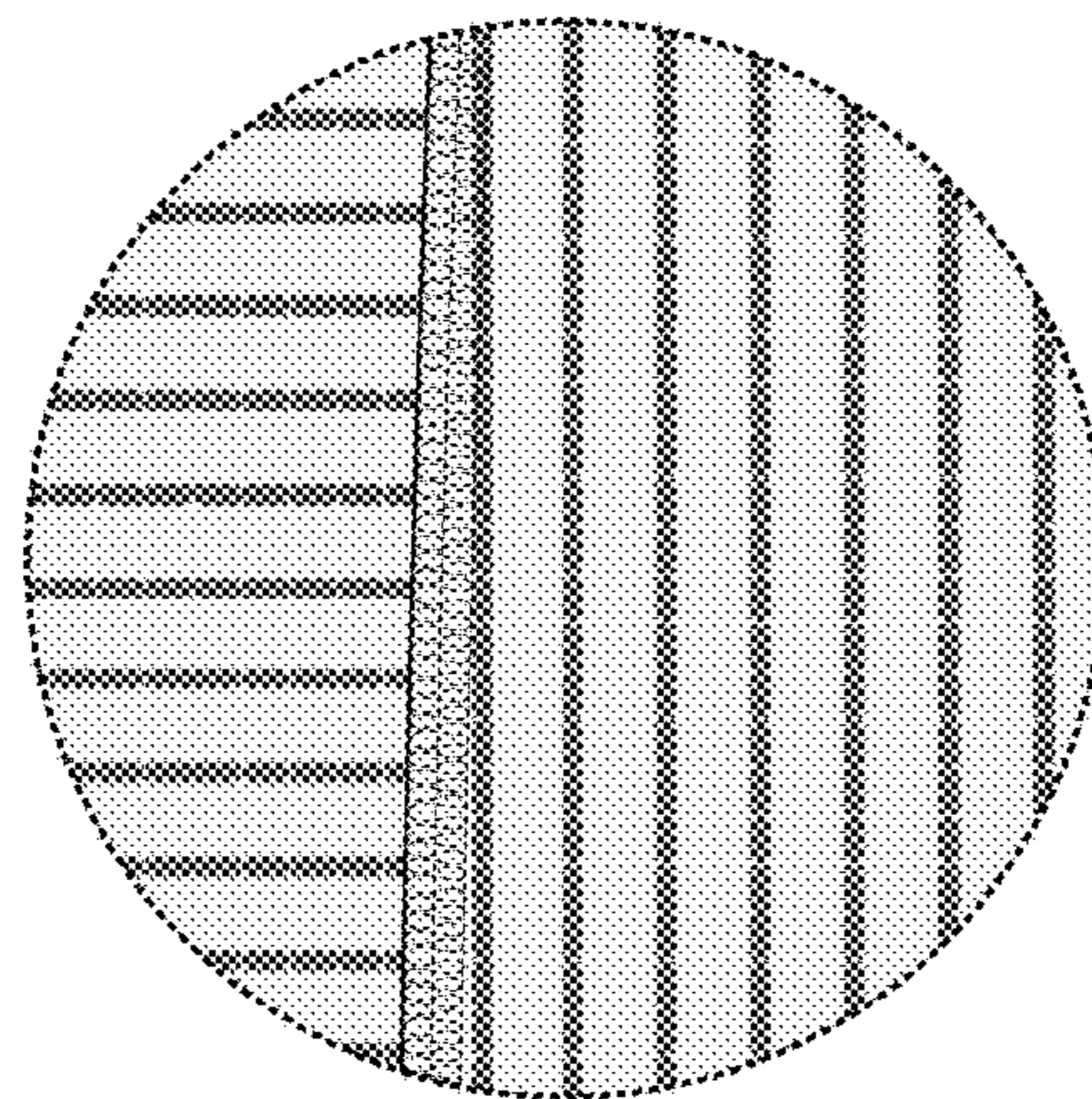

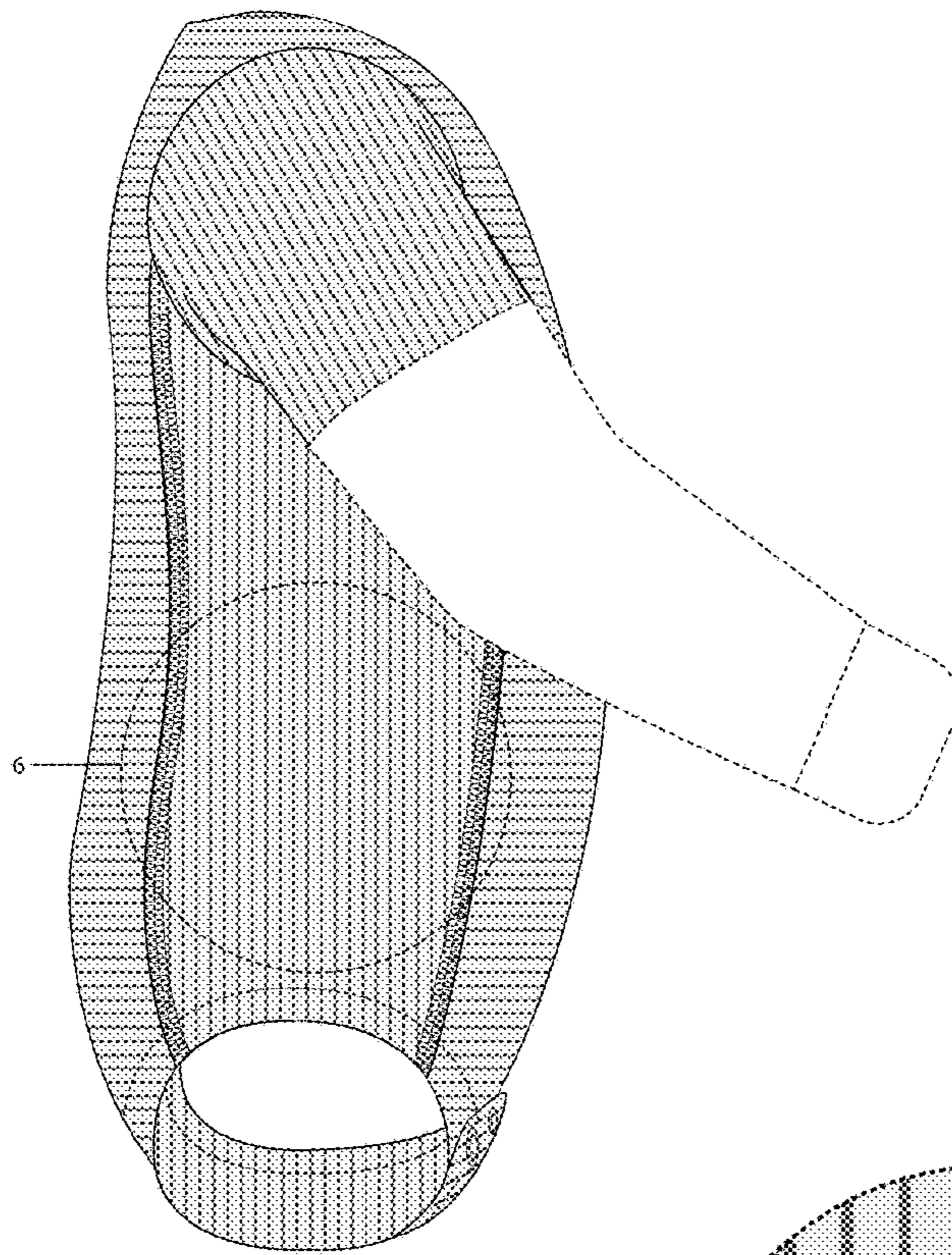

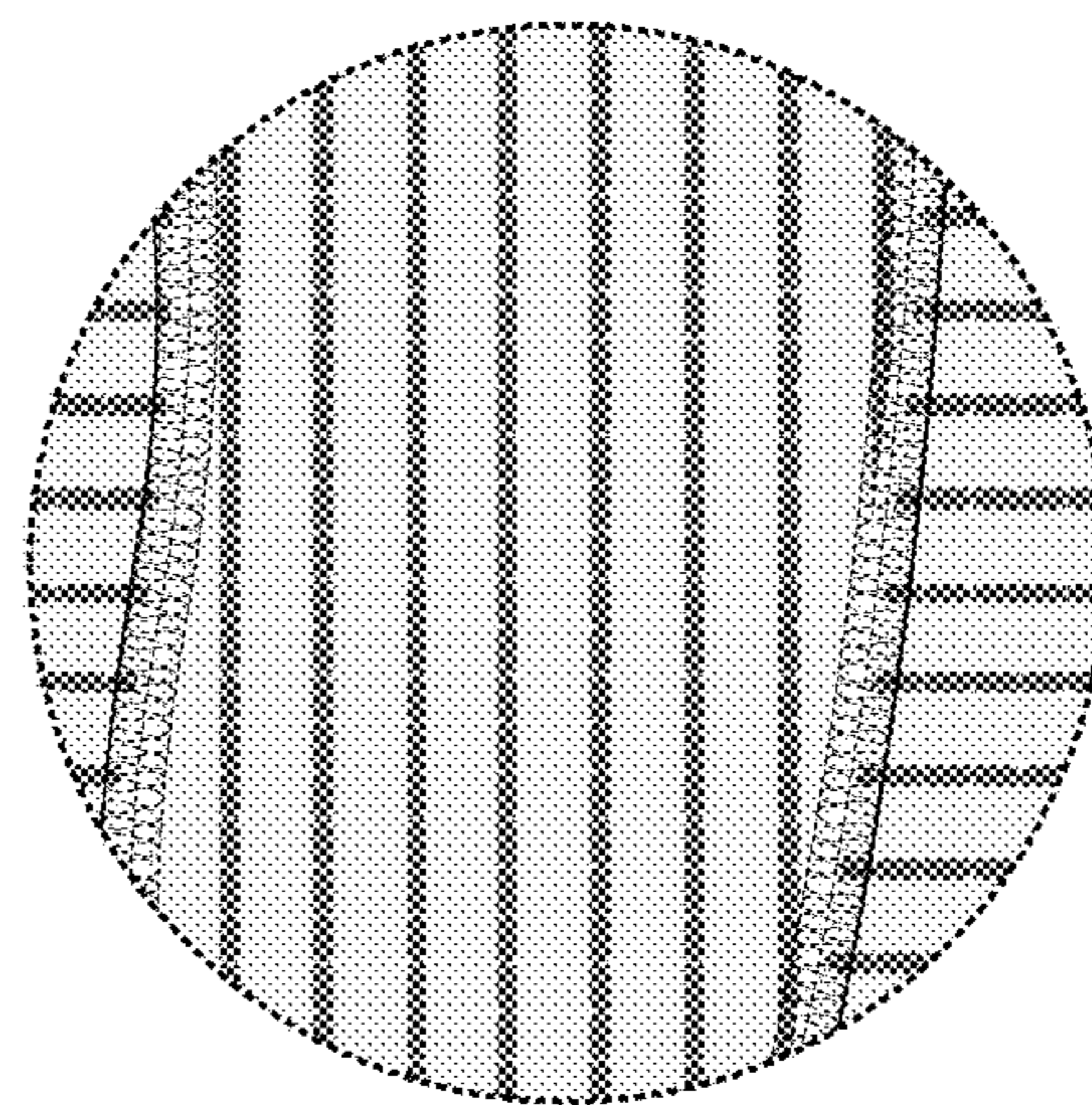

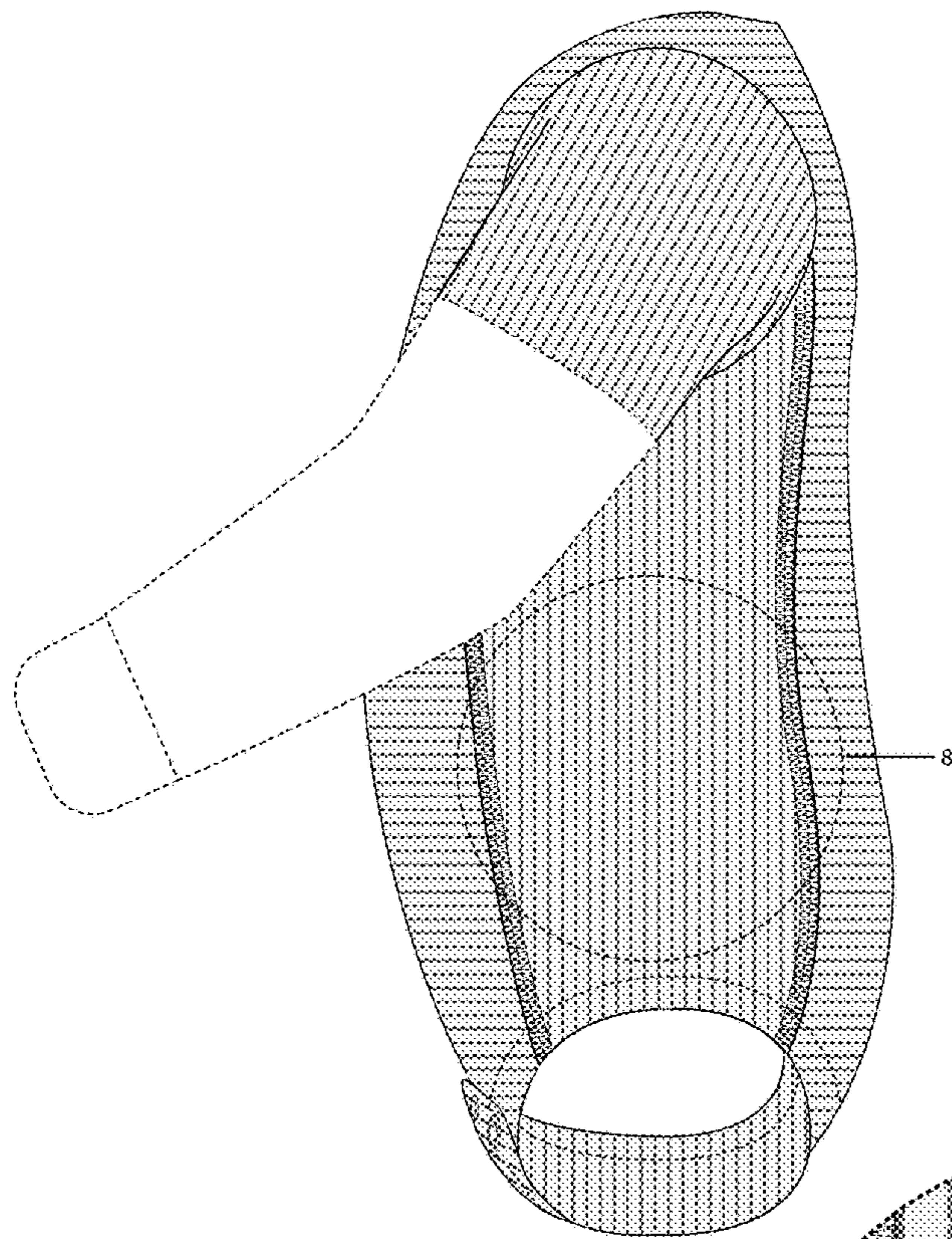

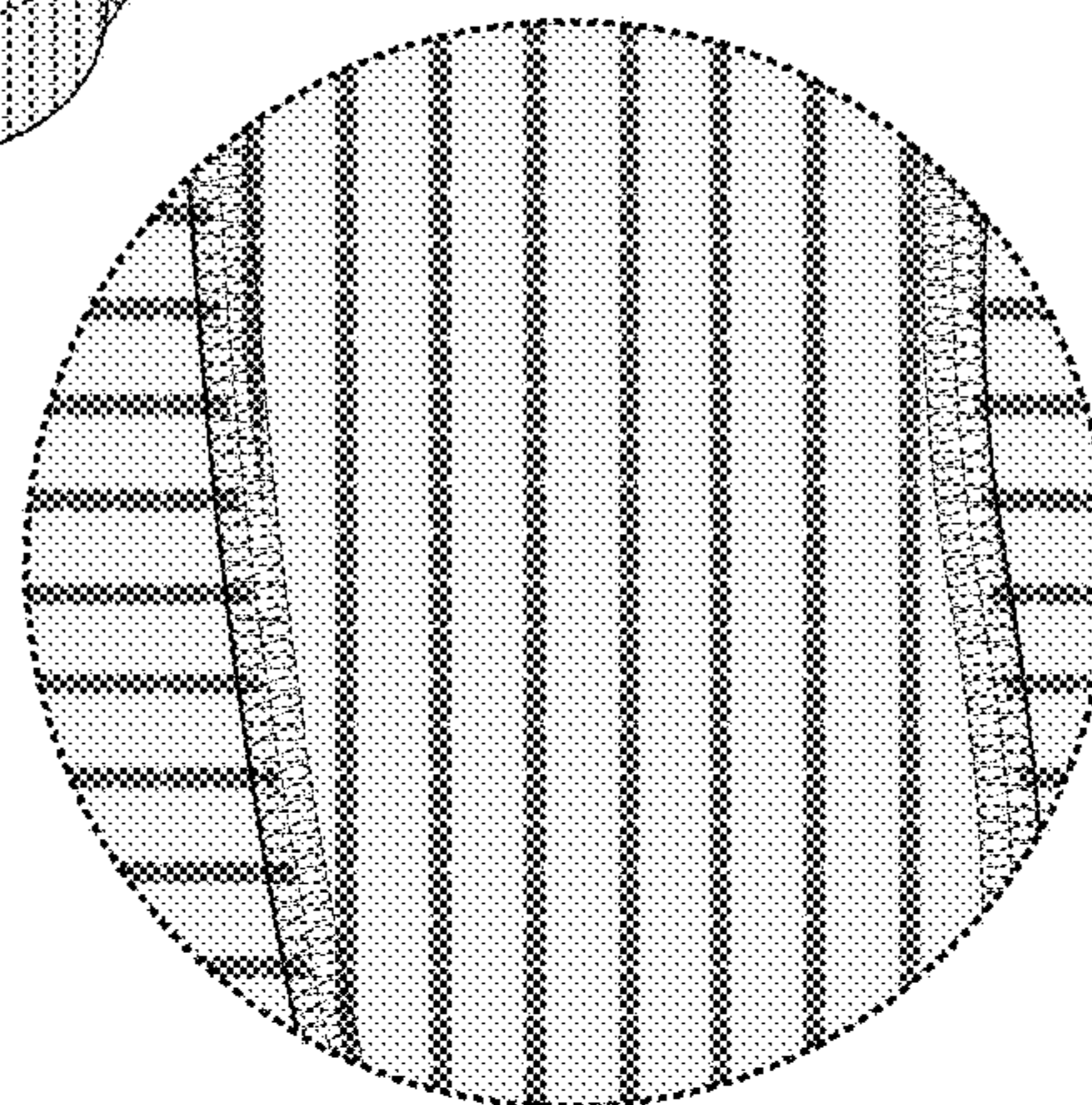

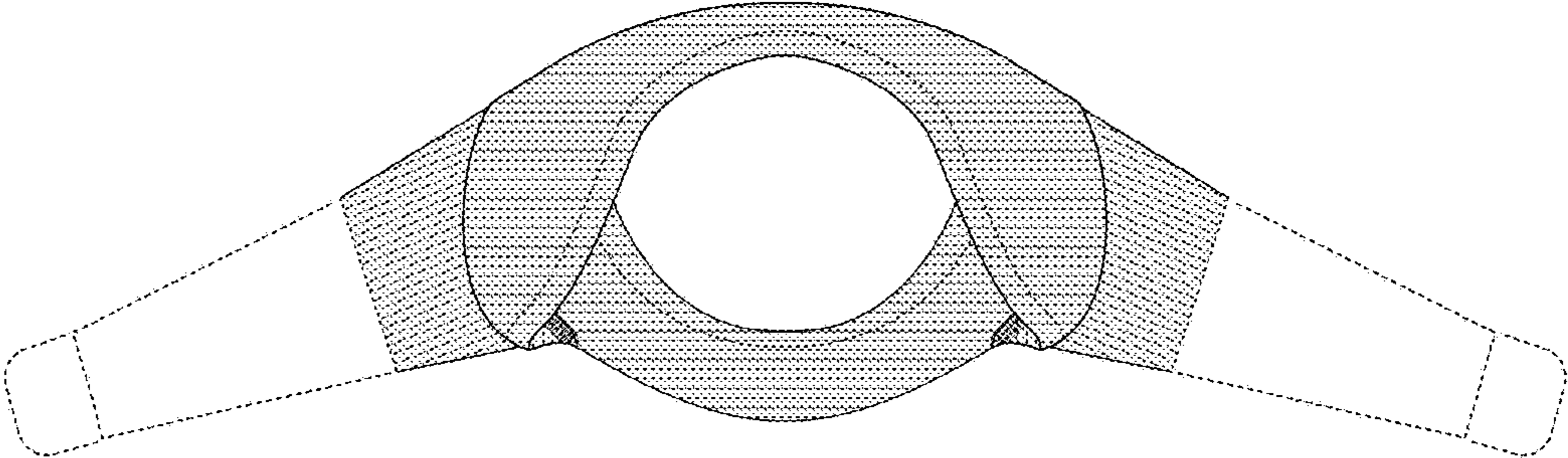

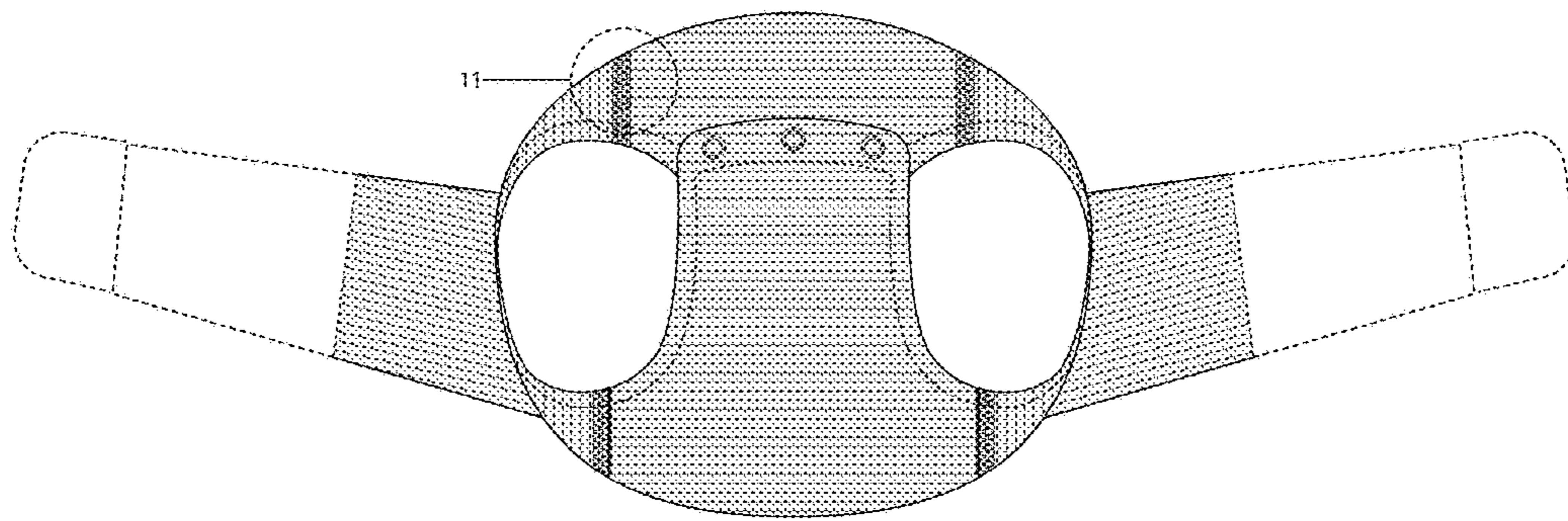

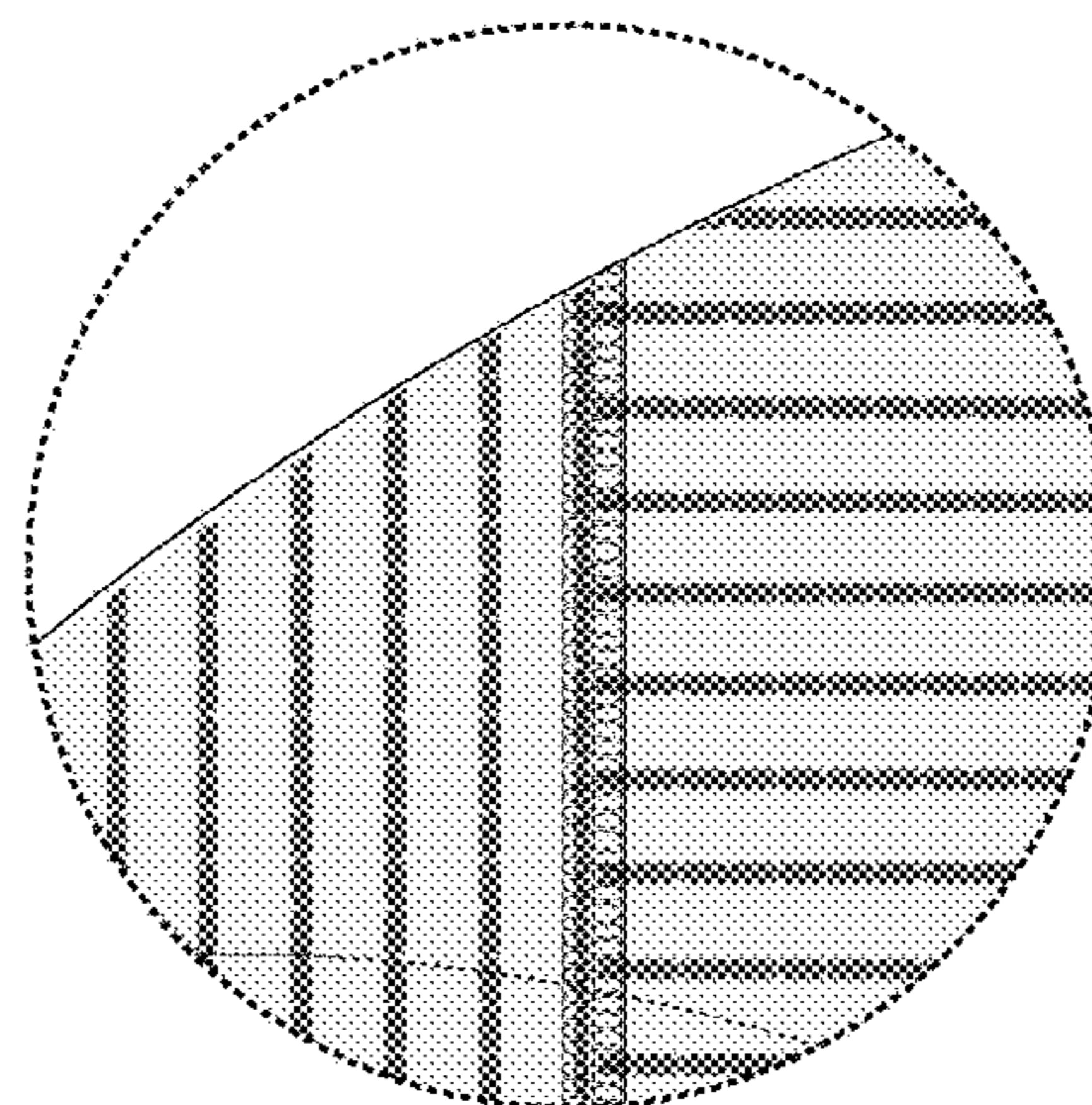

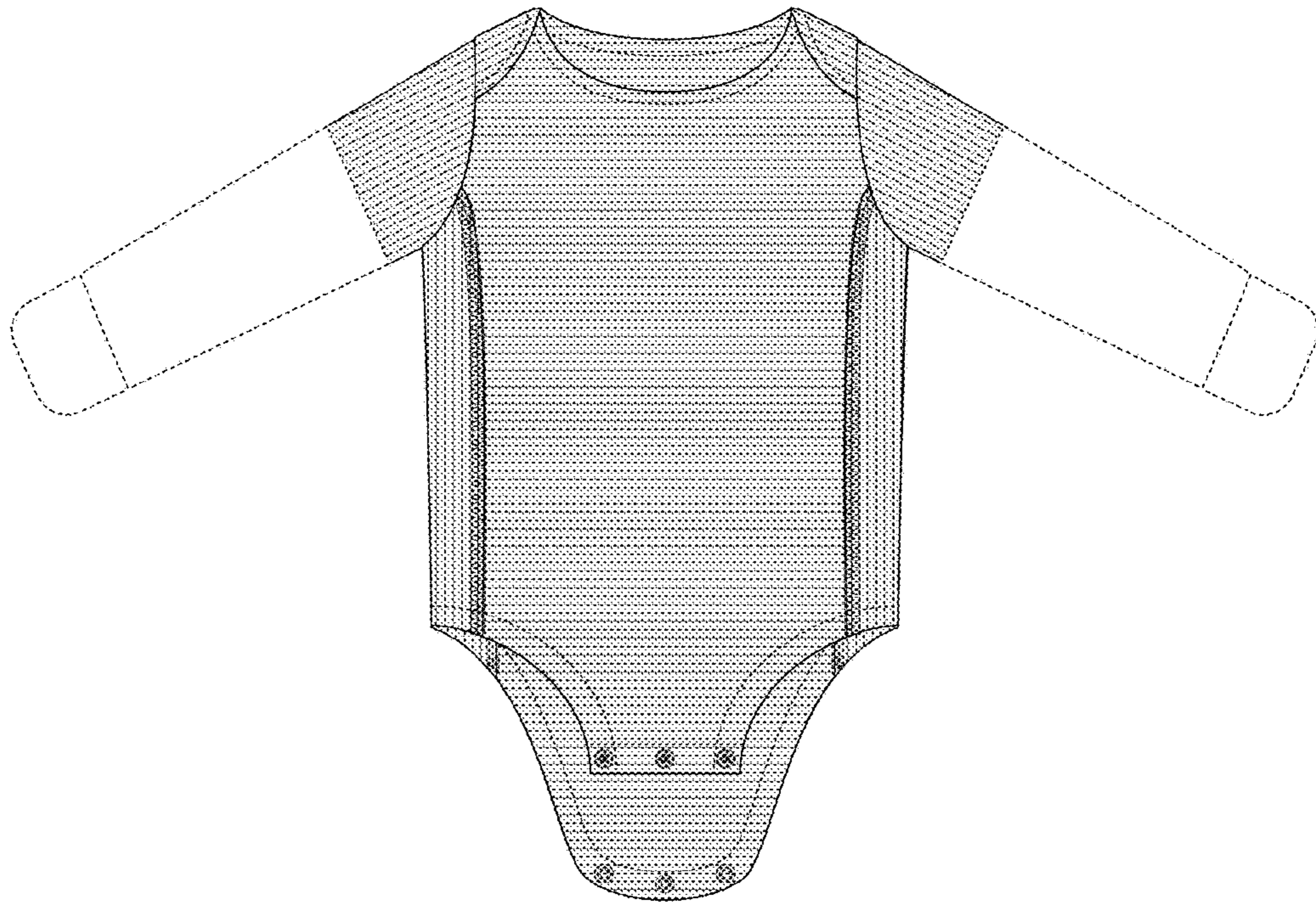
