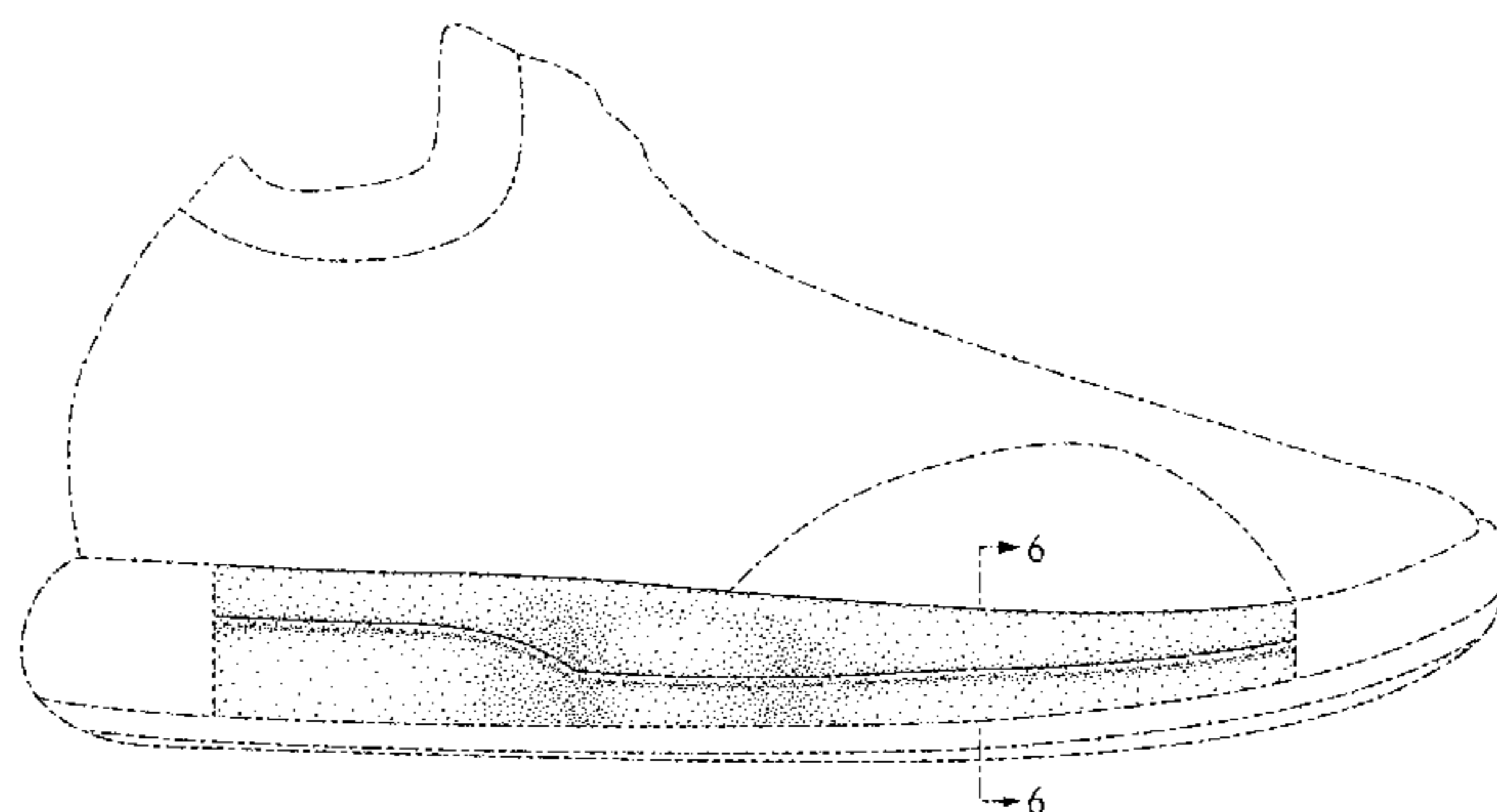
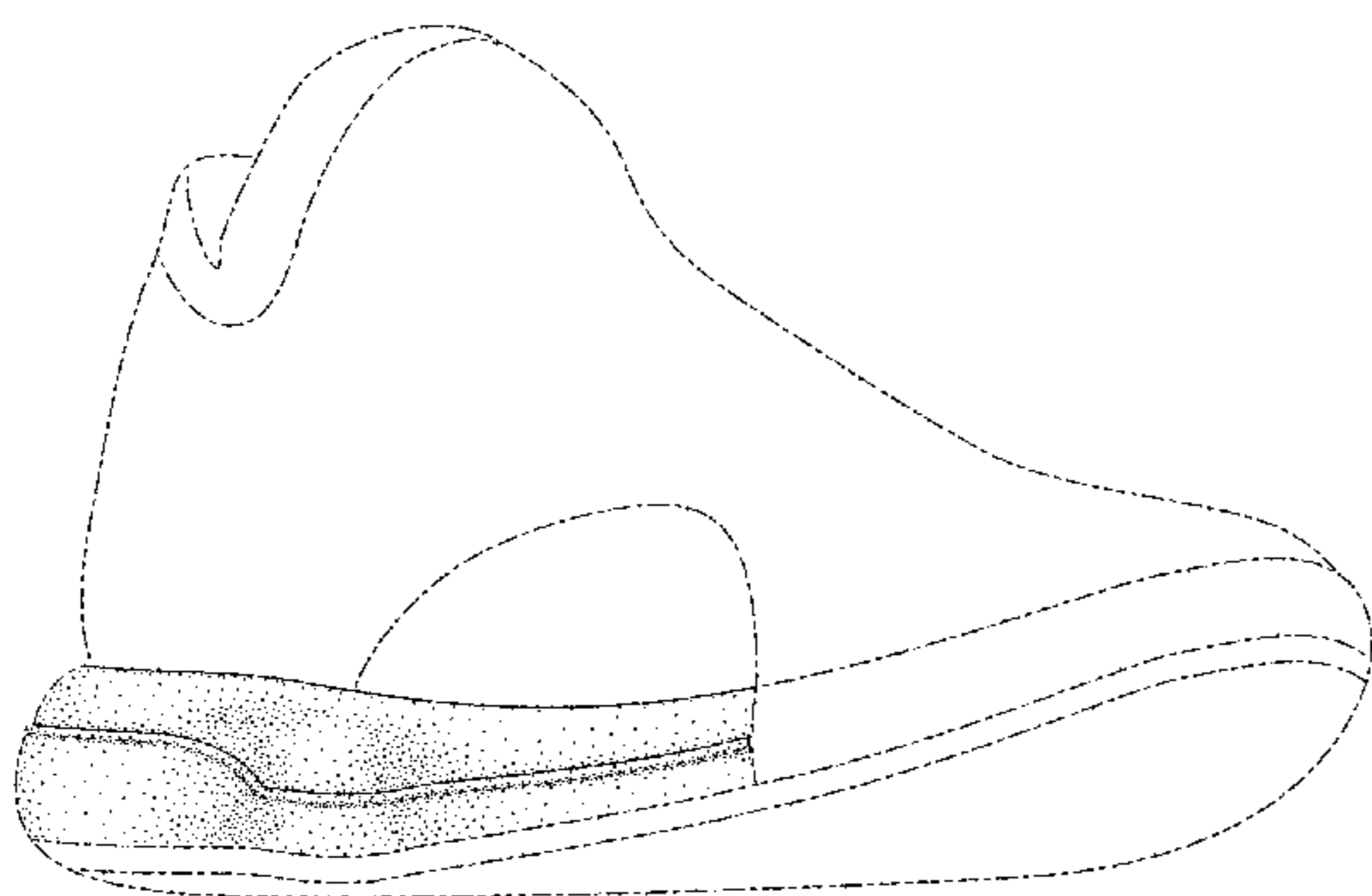
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a rear perspective view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a bottom view thereof; and,
FIG. 6 is a cross section taken through line 6-6 of FIG. 2.
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines showing the remainder of the shoe represent unclaimed environmental subject matter and form no part of the claimed design.

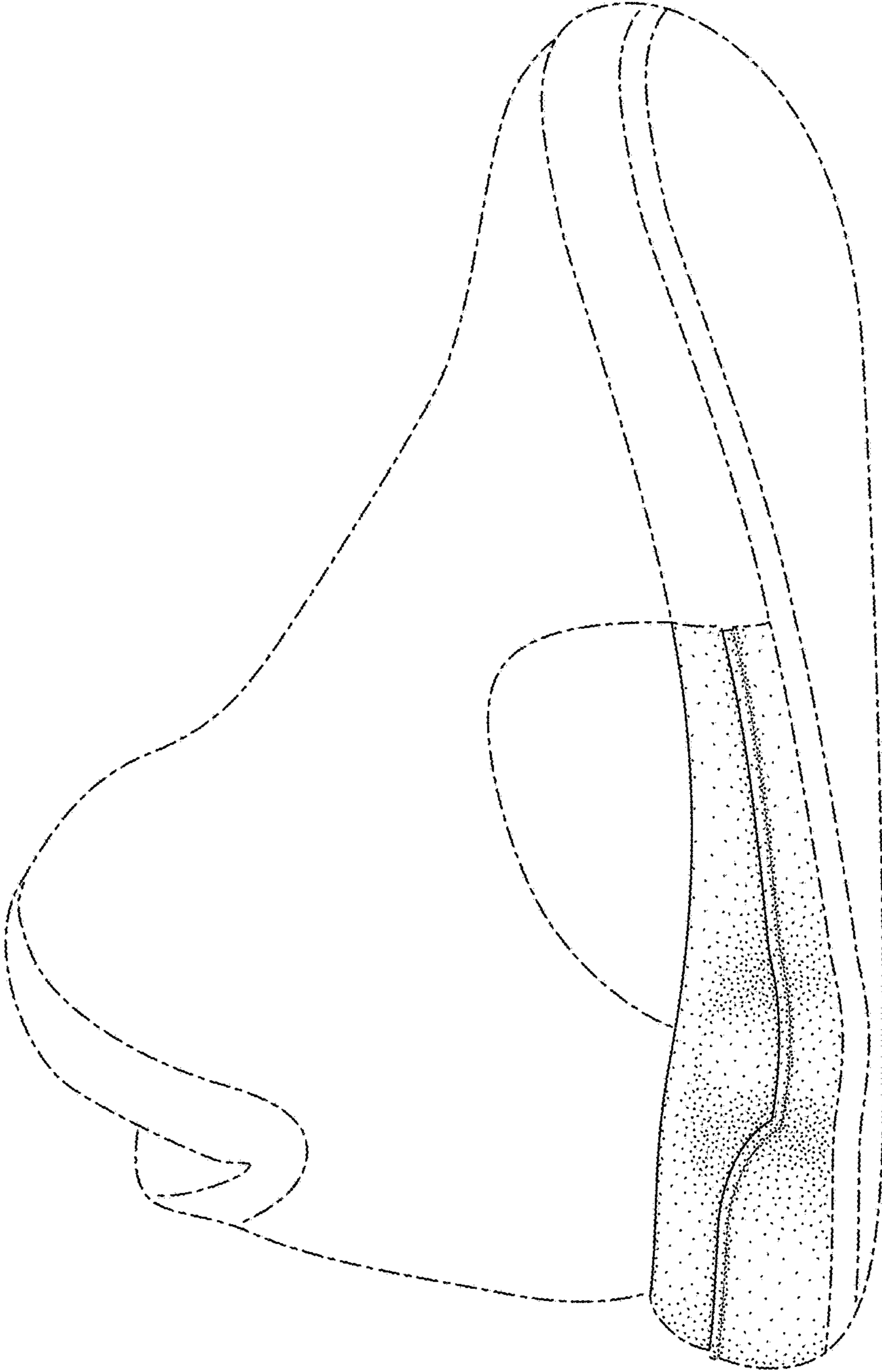

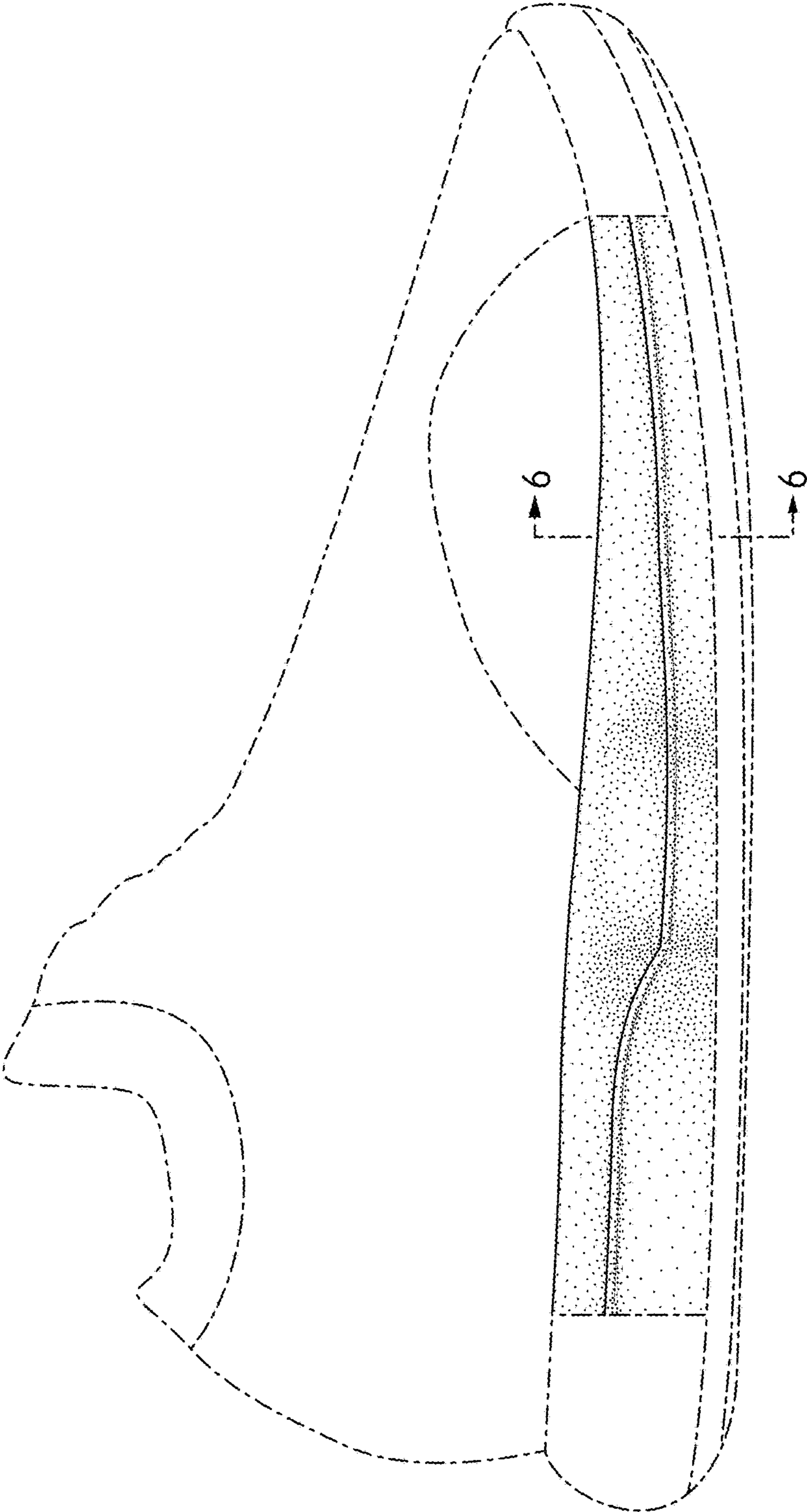

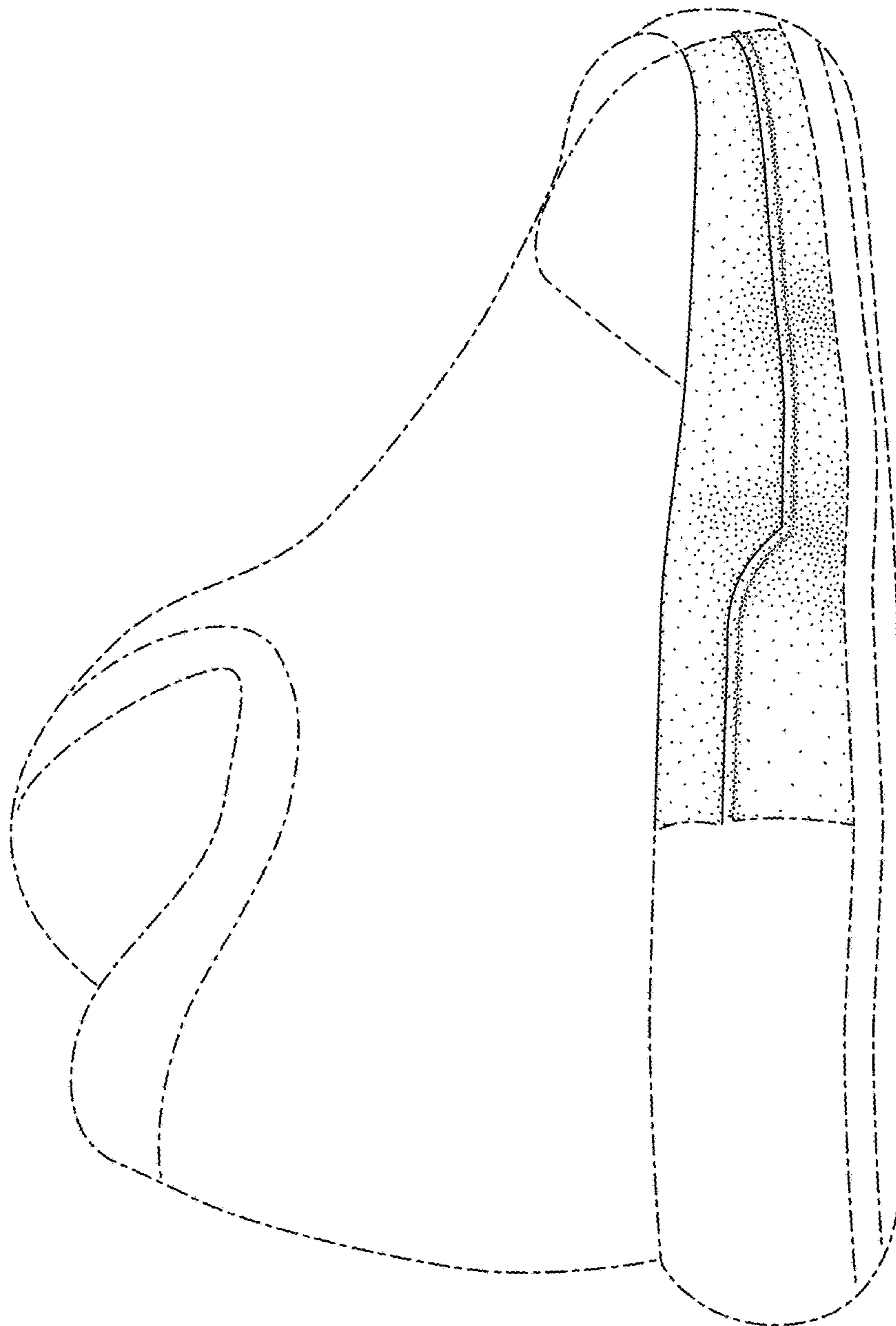

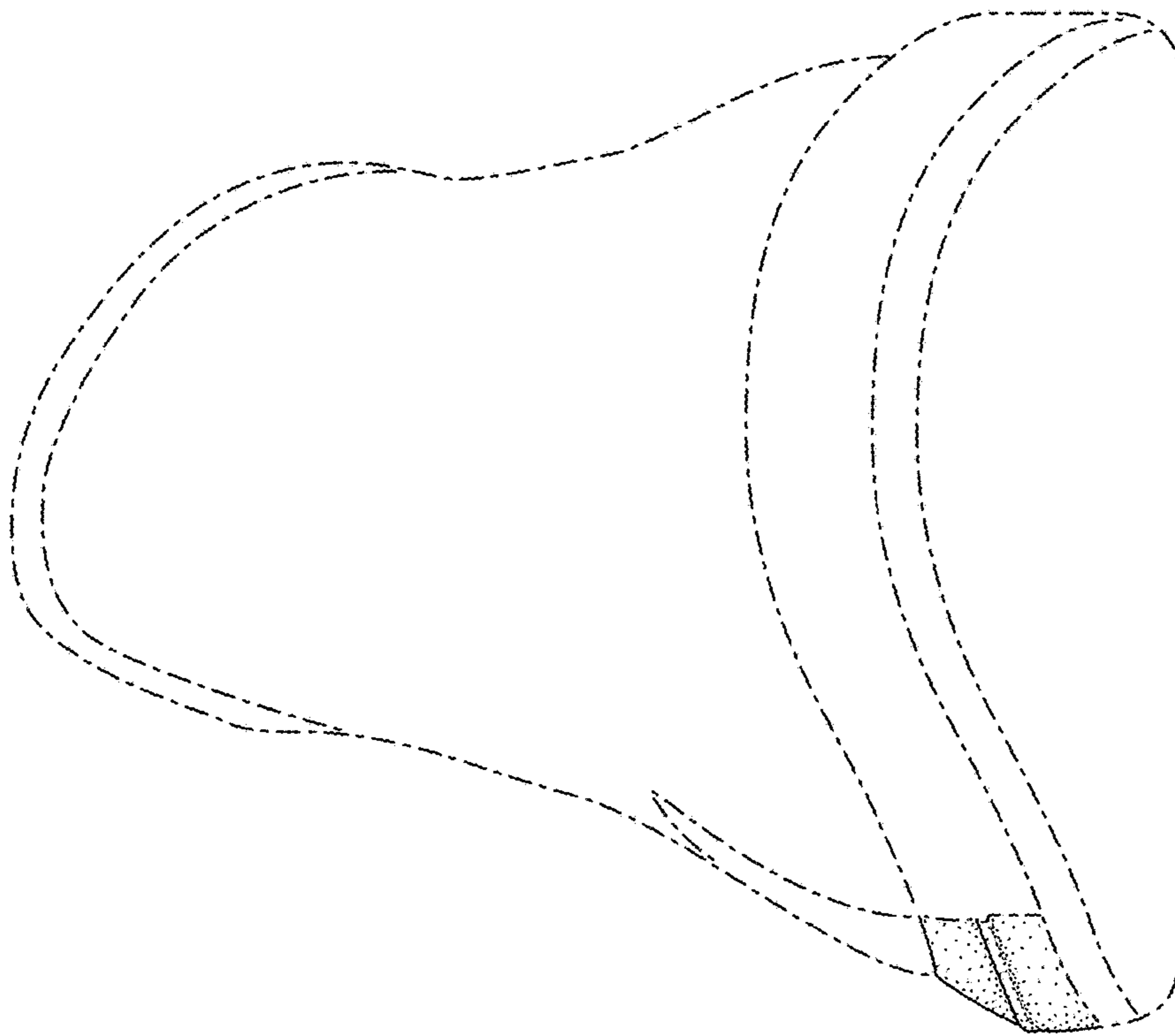

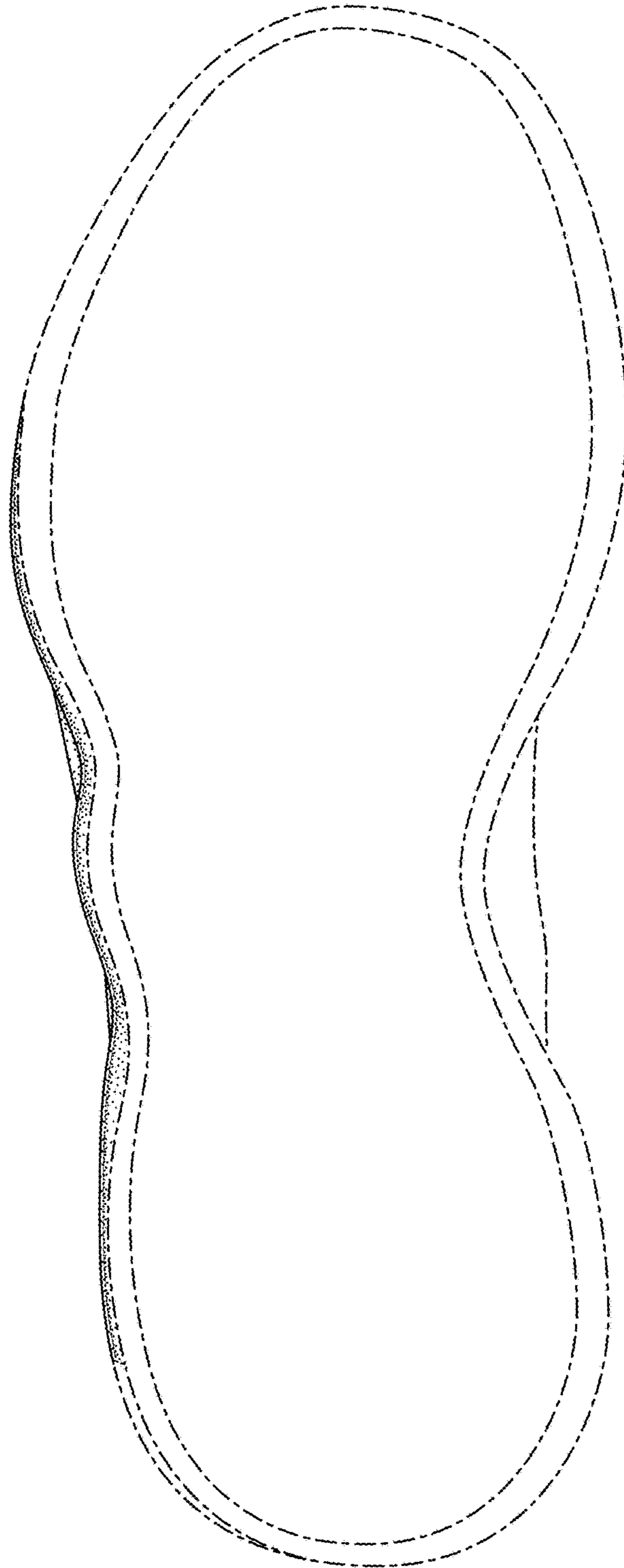

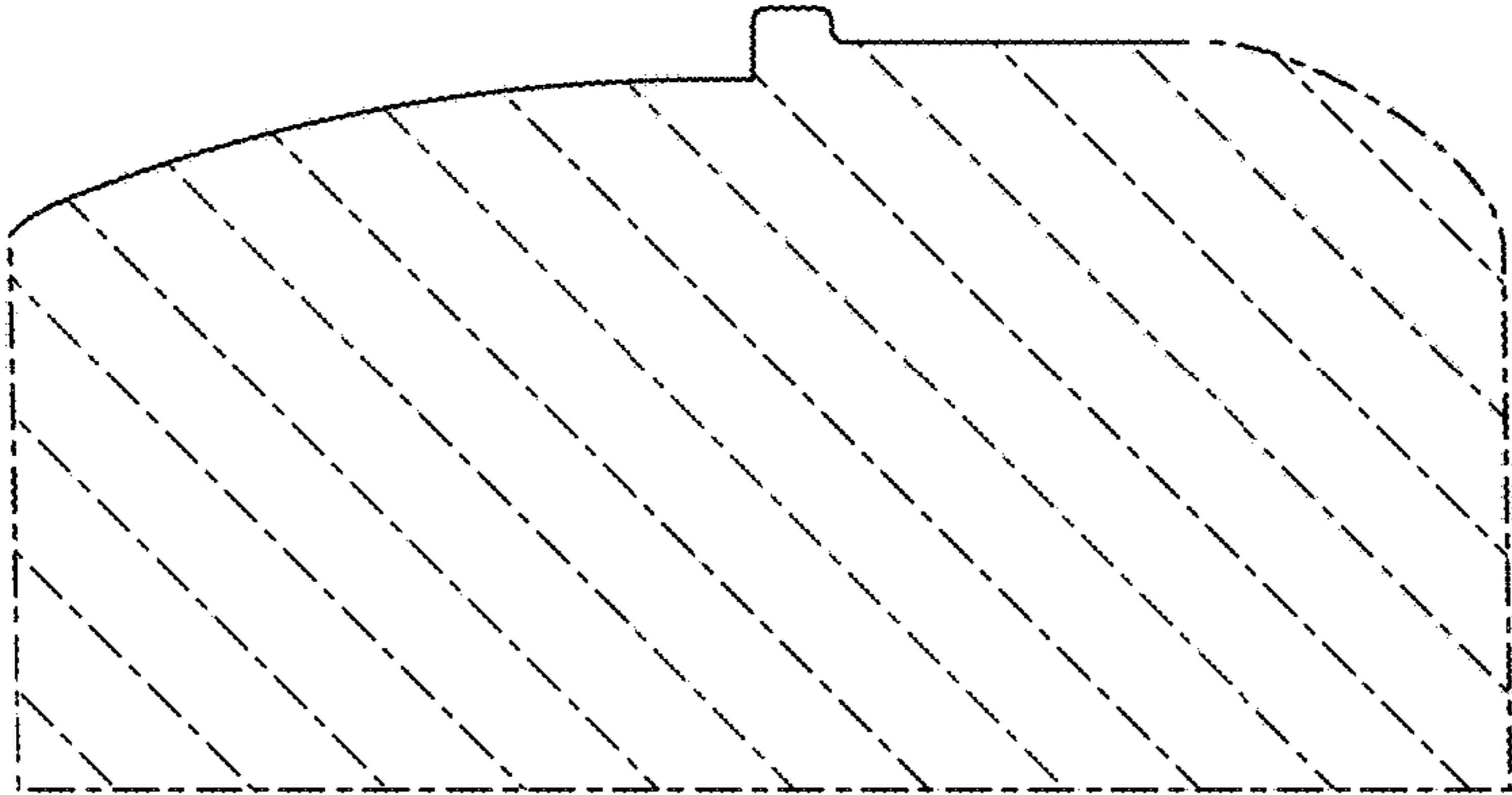
