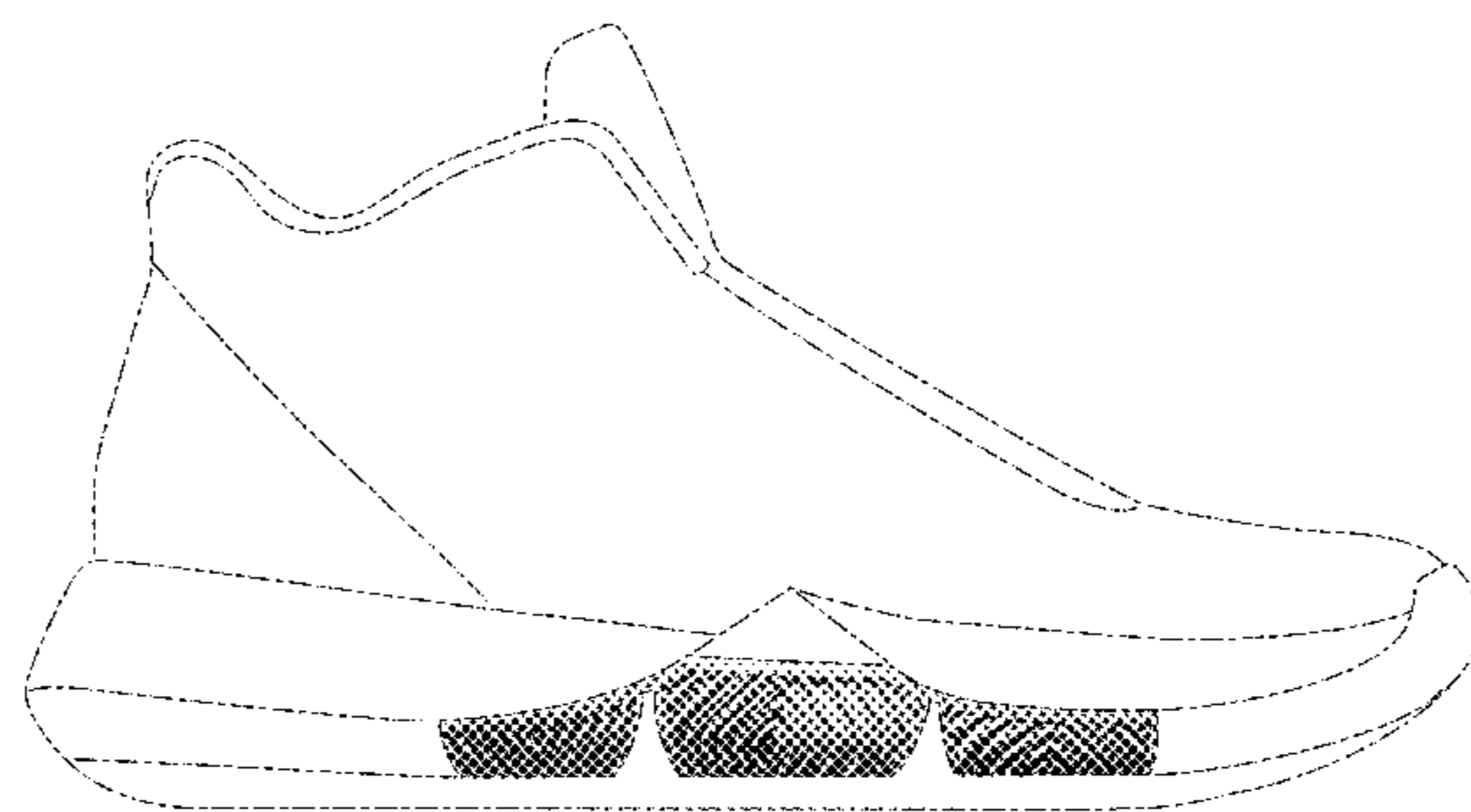
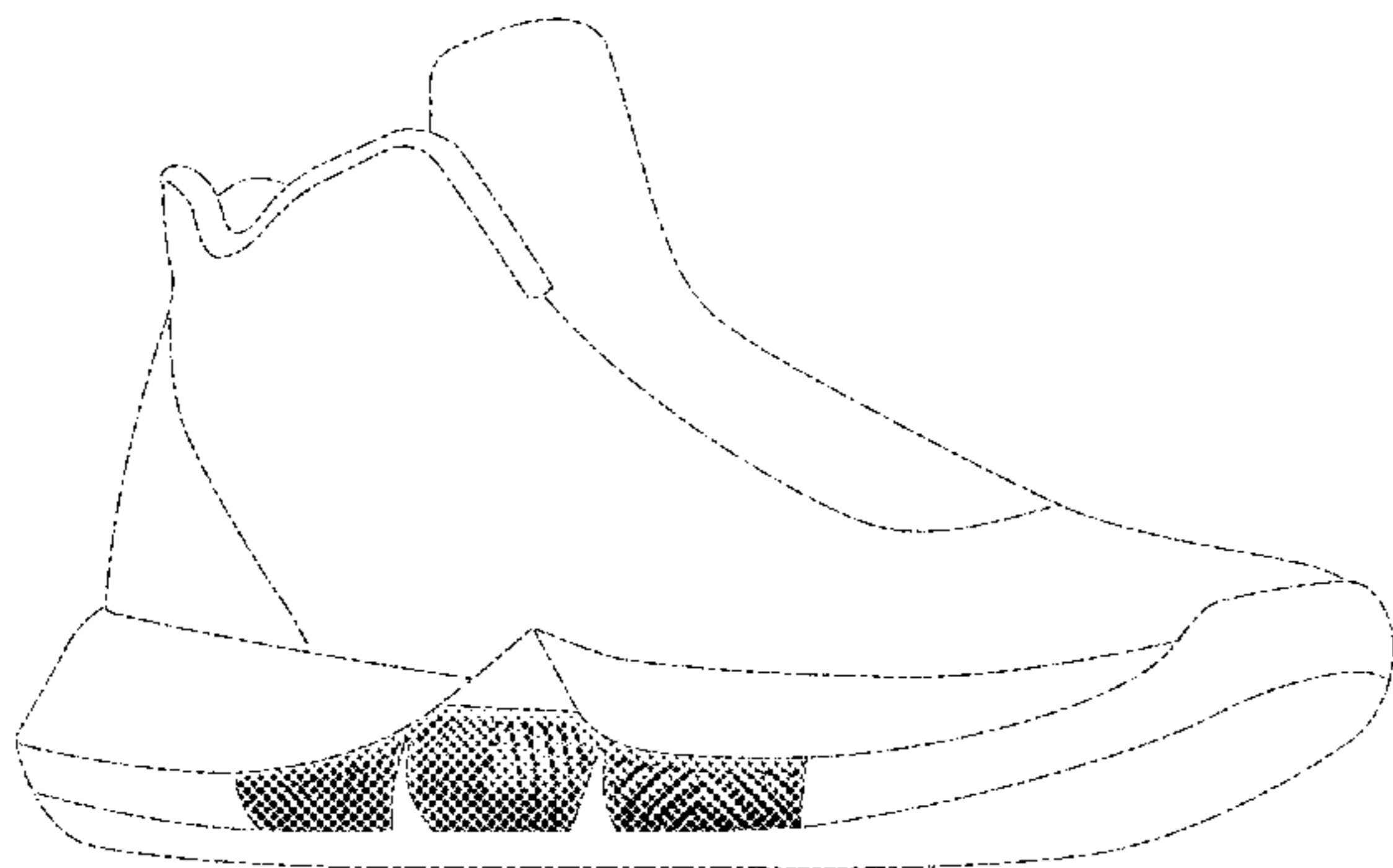
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing my new design;  
 FIG. 2 is a side view thereof;  
 FIG. 3 is a rear perspective view thereof;  
 FIG. 4 is an enlarged view of the claimed area of FIG. 1 shown with environment removed for clarity purposes;  
 FIG. 5 is an enlarged view of the claimed area of FIG. 2 shown with environment removed for clarity purposes; and,  
 FIG. 6 is an enlarged view of the claimed area of FIG. 3 shown with environment removed for clarity purposes.  
 The broken lines immediately adjacent to the photographic area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

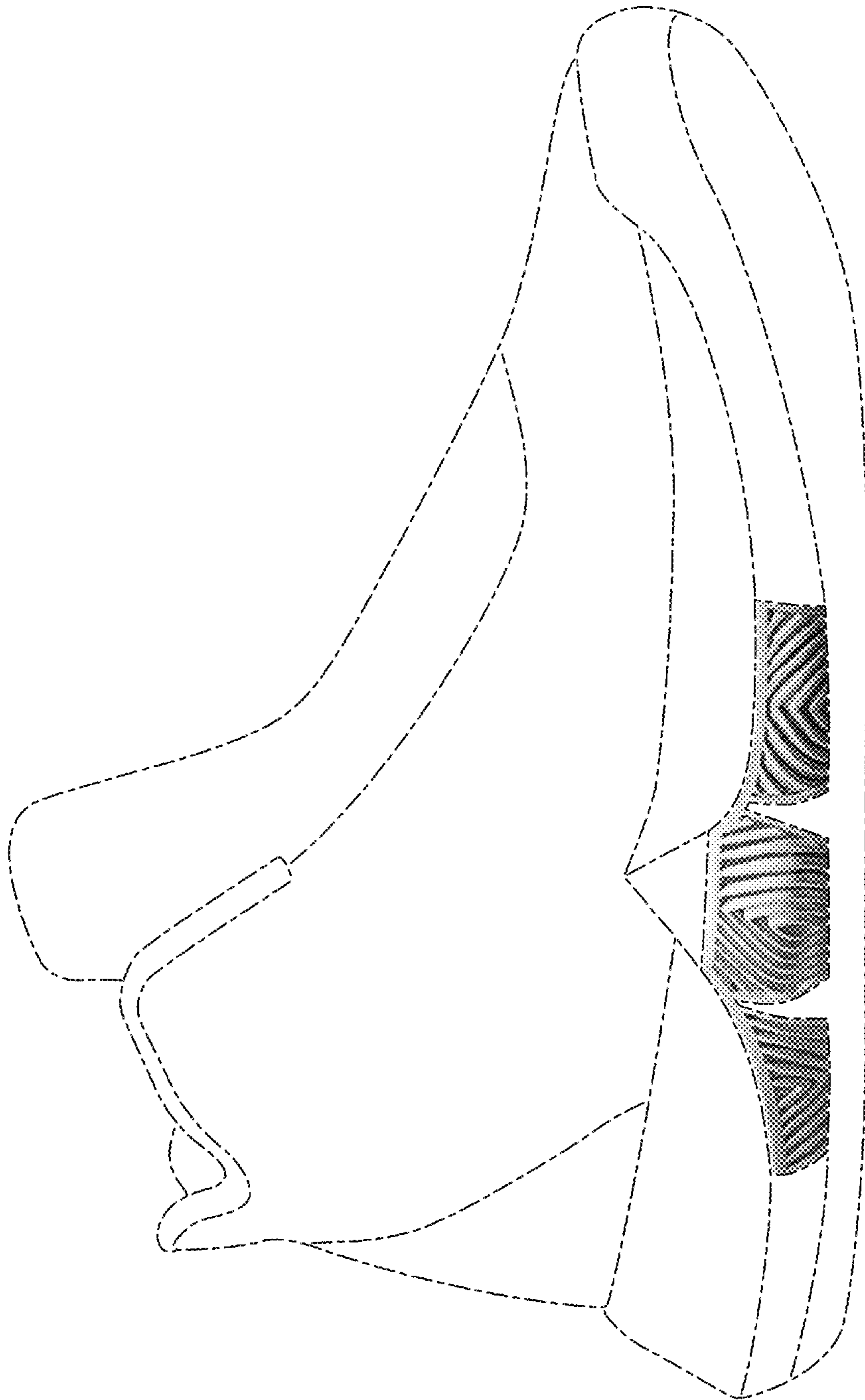

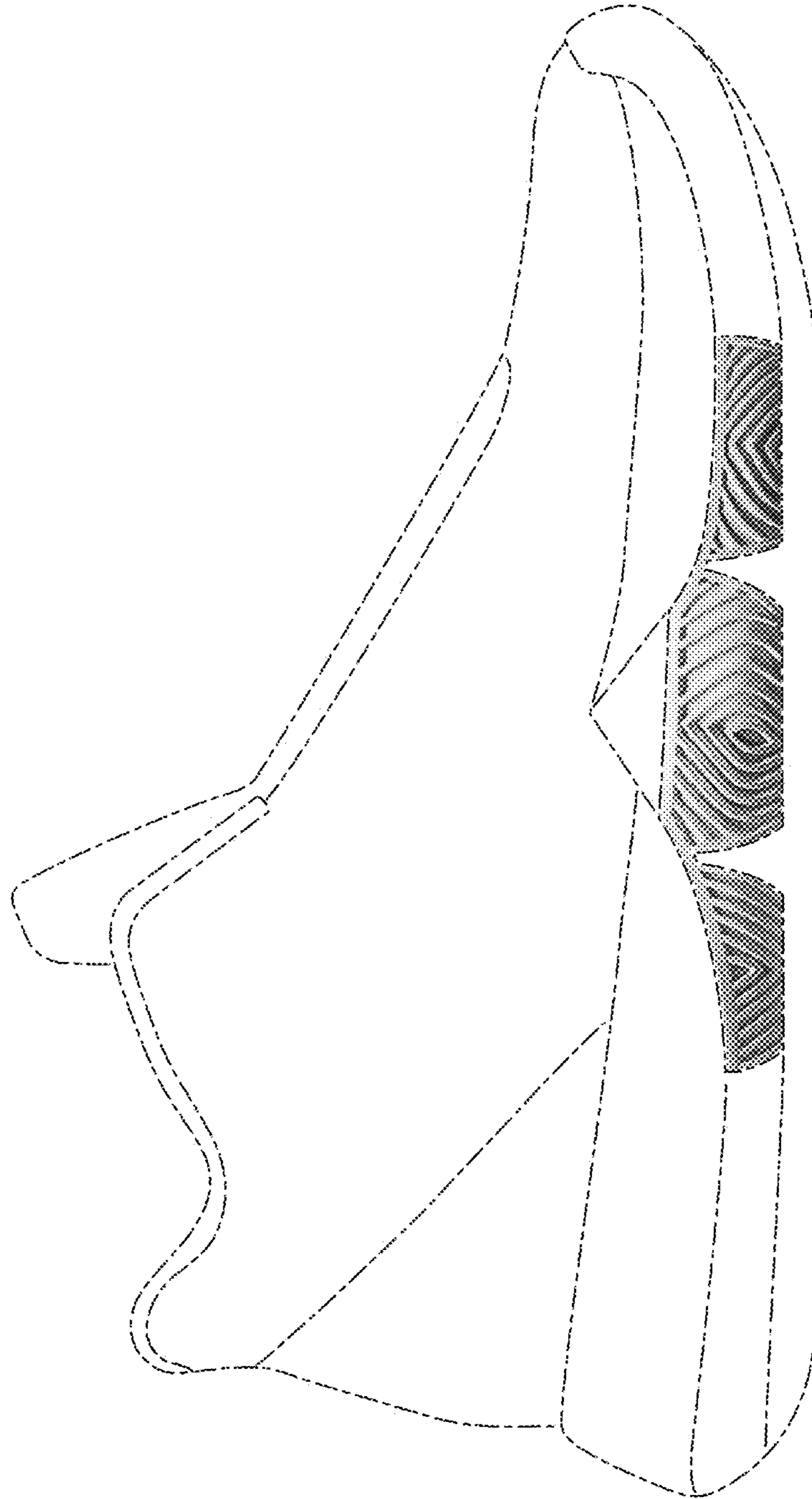

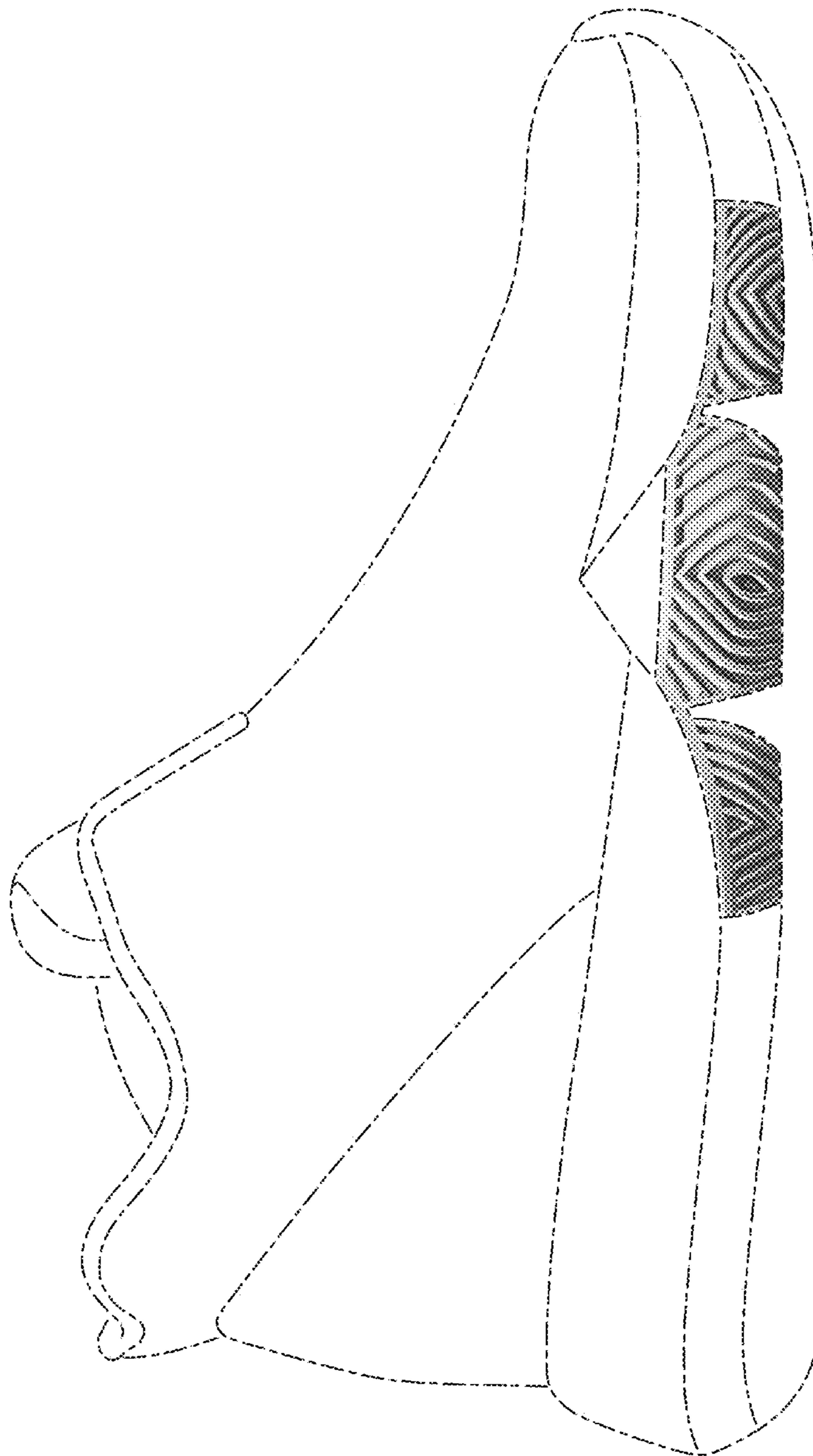

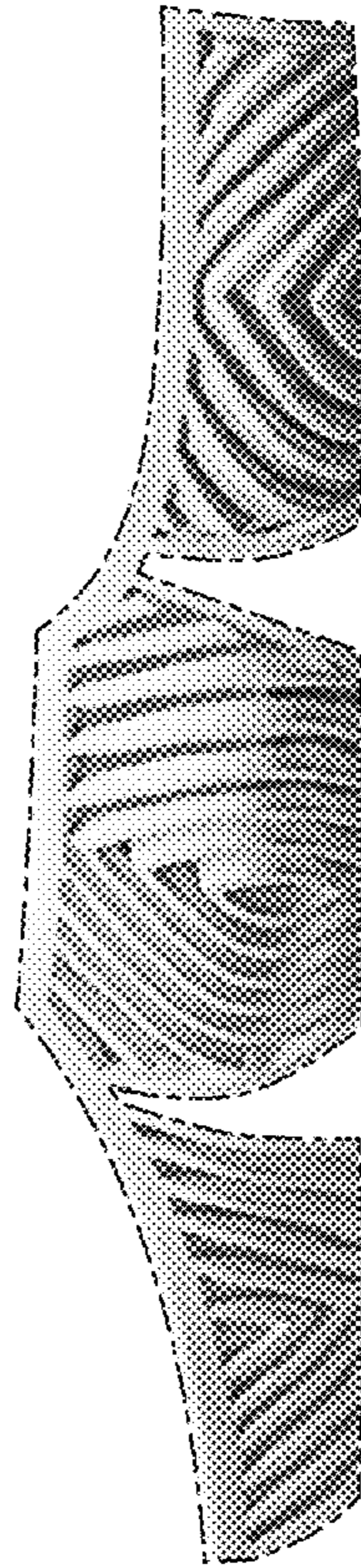

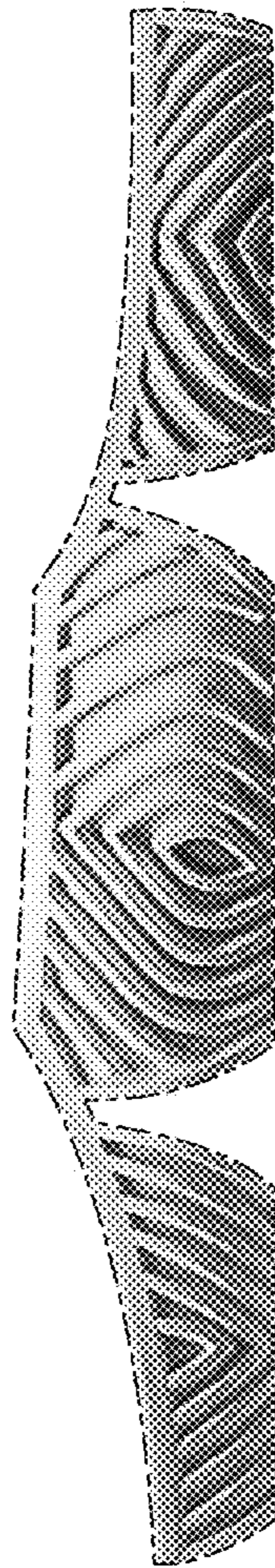

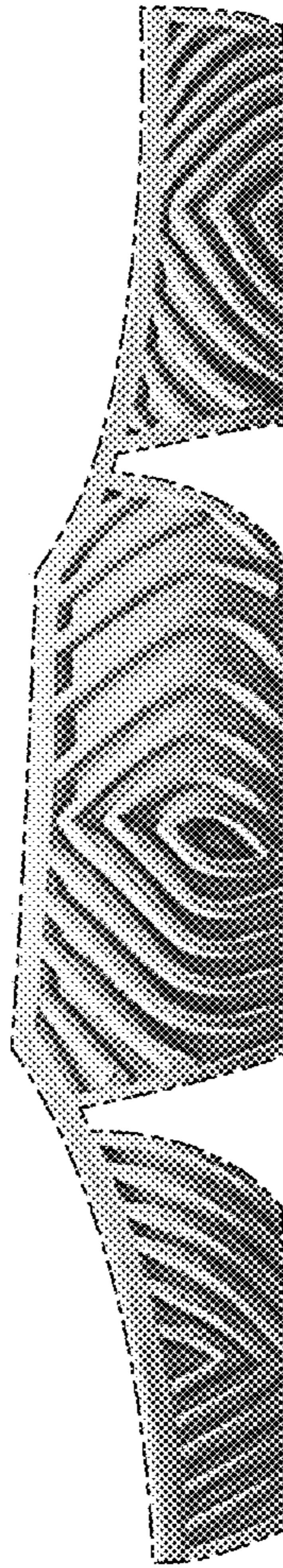
