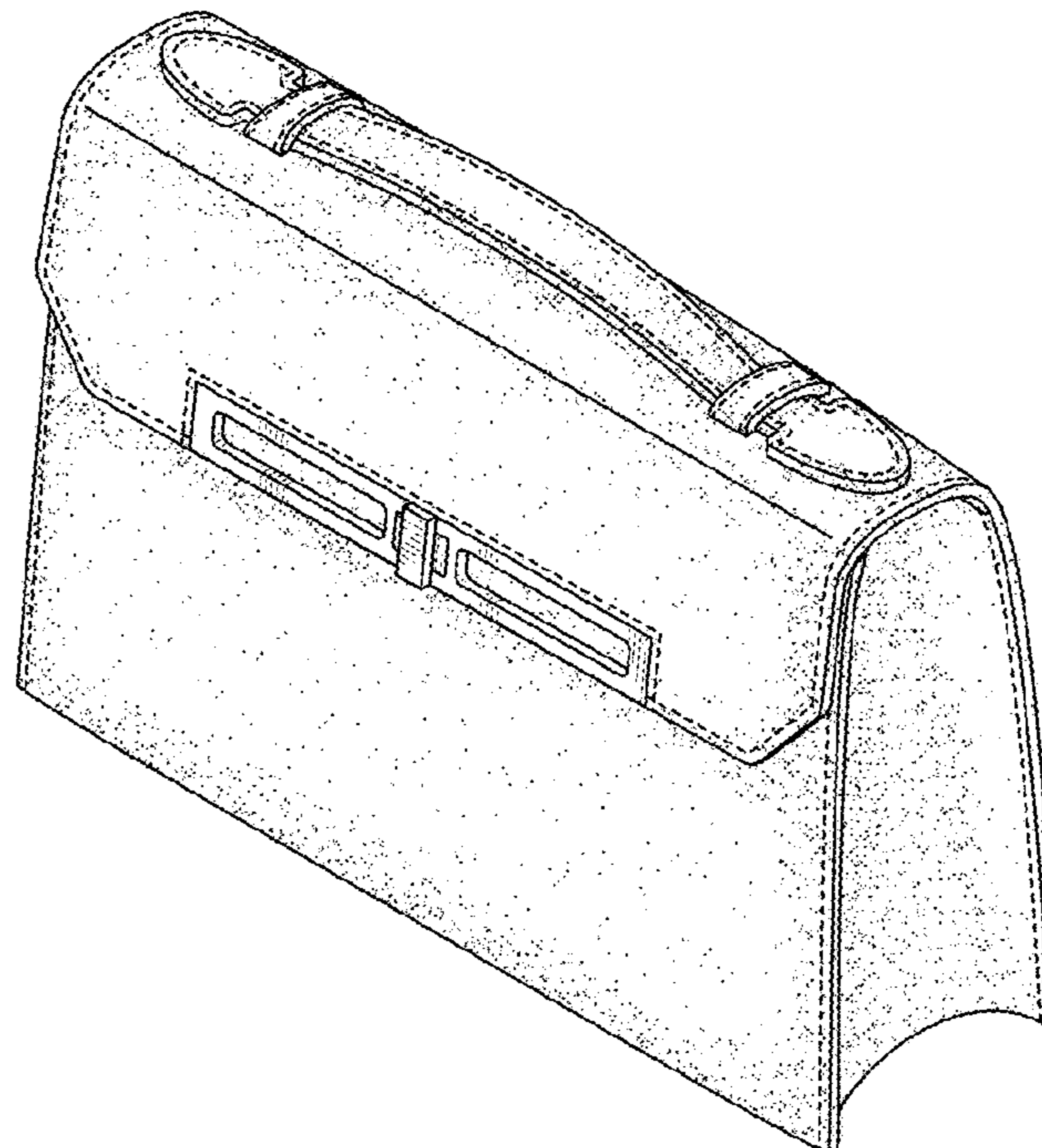
(57) **CLAIM**
The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a handbag showing the new design; FIG. 2 is a top view thereof; FIG. 3 is a front view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a back view thereof; FIG. 6 is a side view thereof; and, FIG. 7 is another side view thereof, shown from the side opposite that shown in FIG. 6. The broken lines showing stitching and clasp are for the purposes of illustrating environment and form no part of the claimed design.

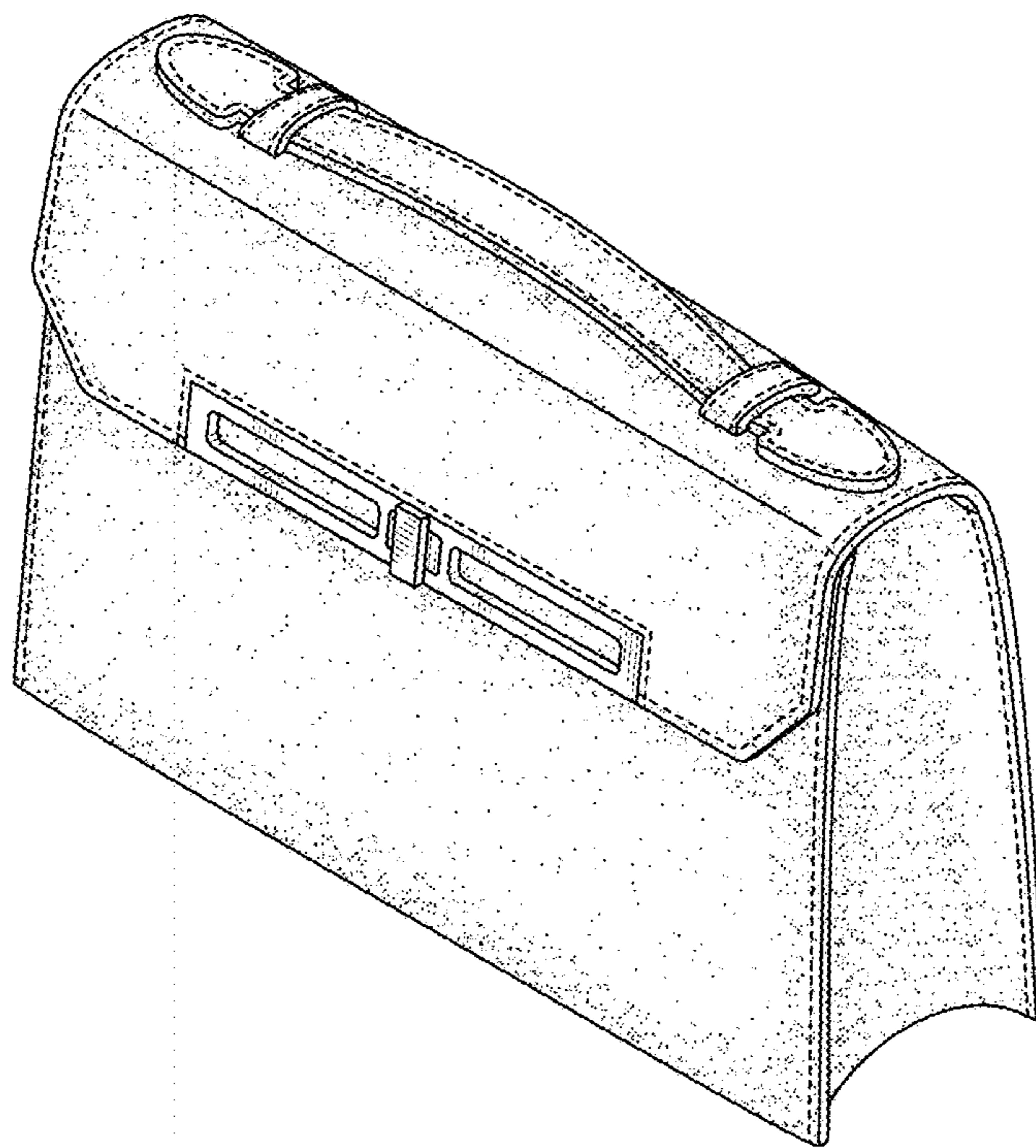

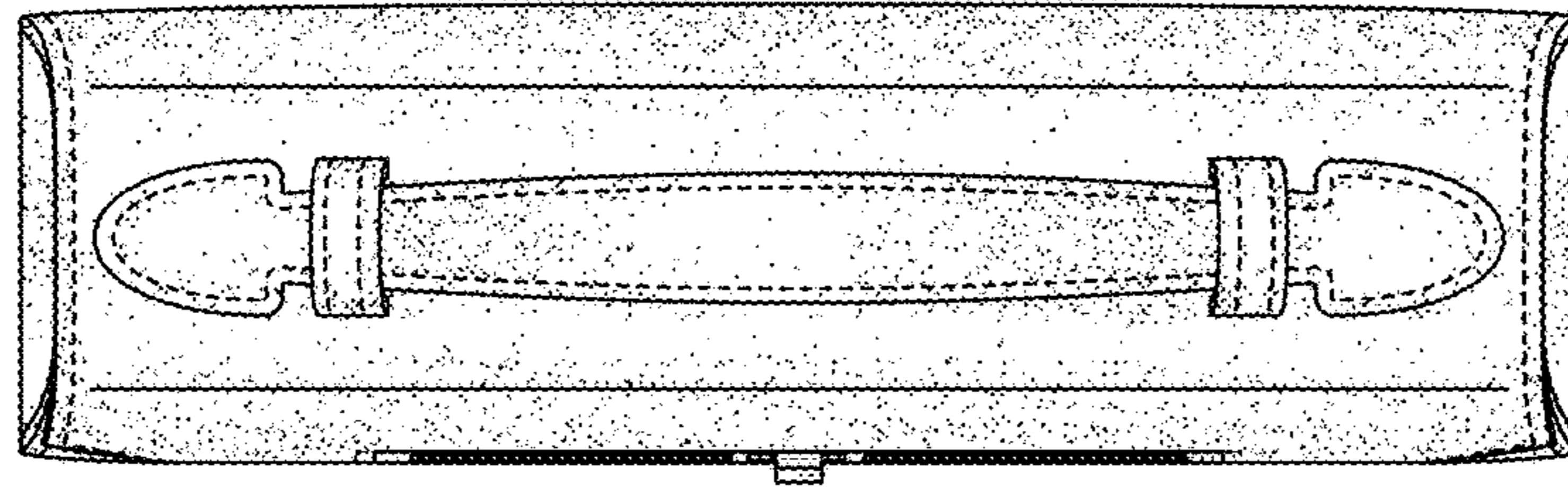

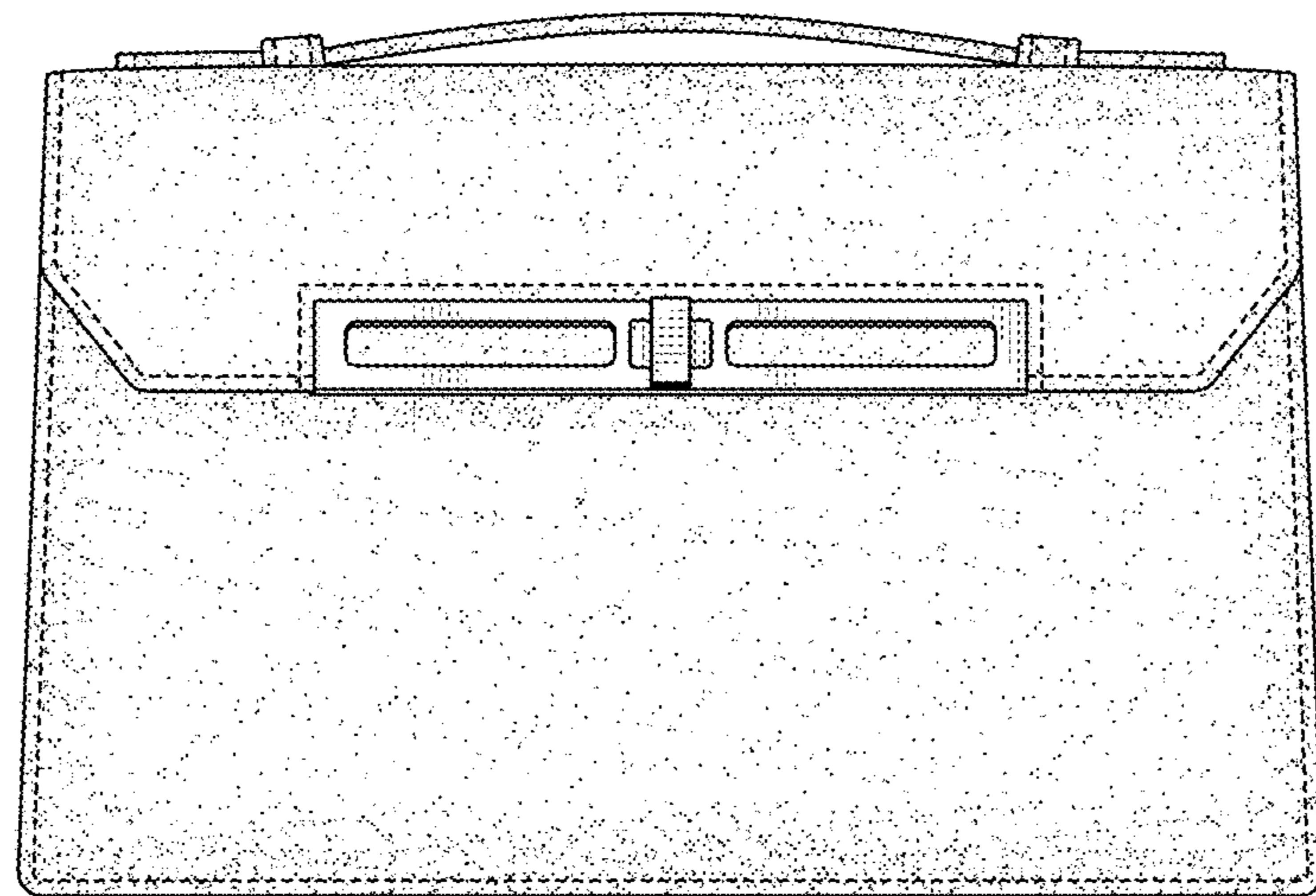

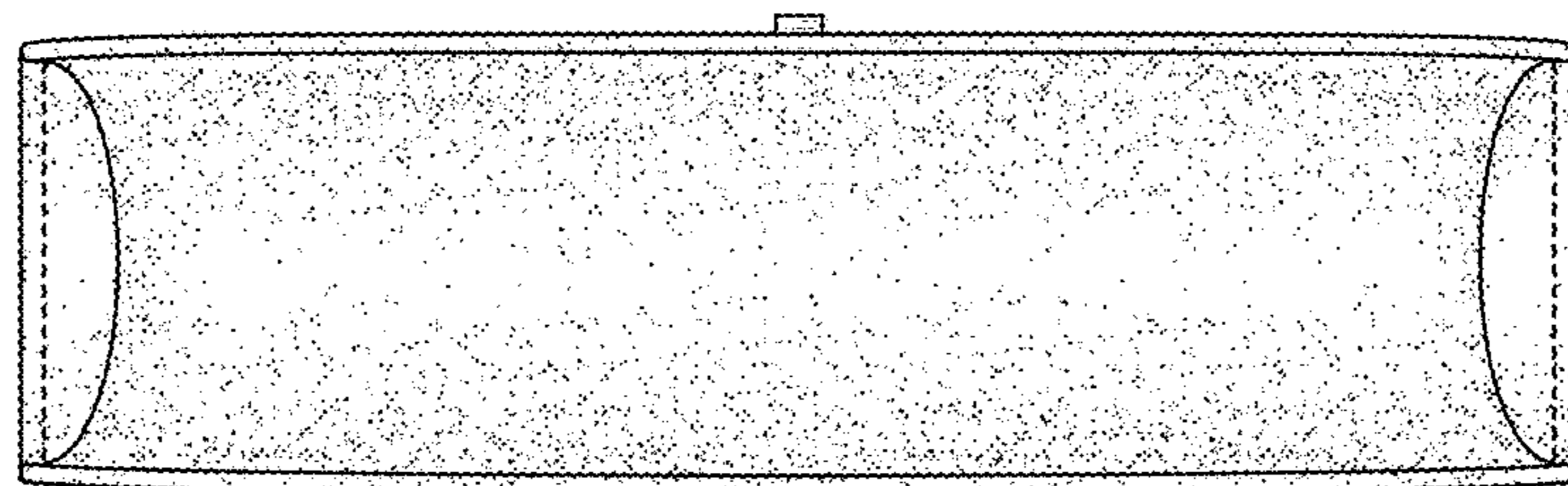

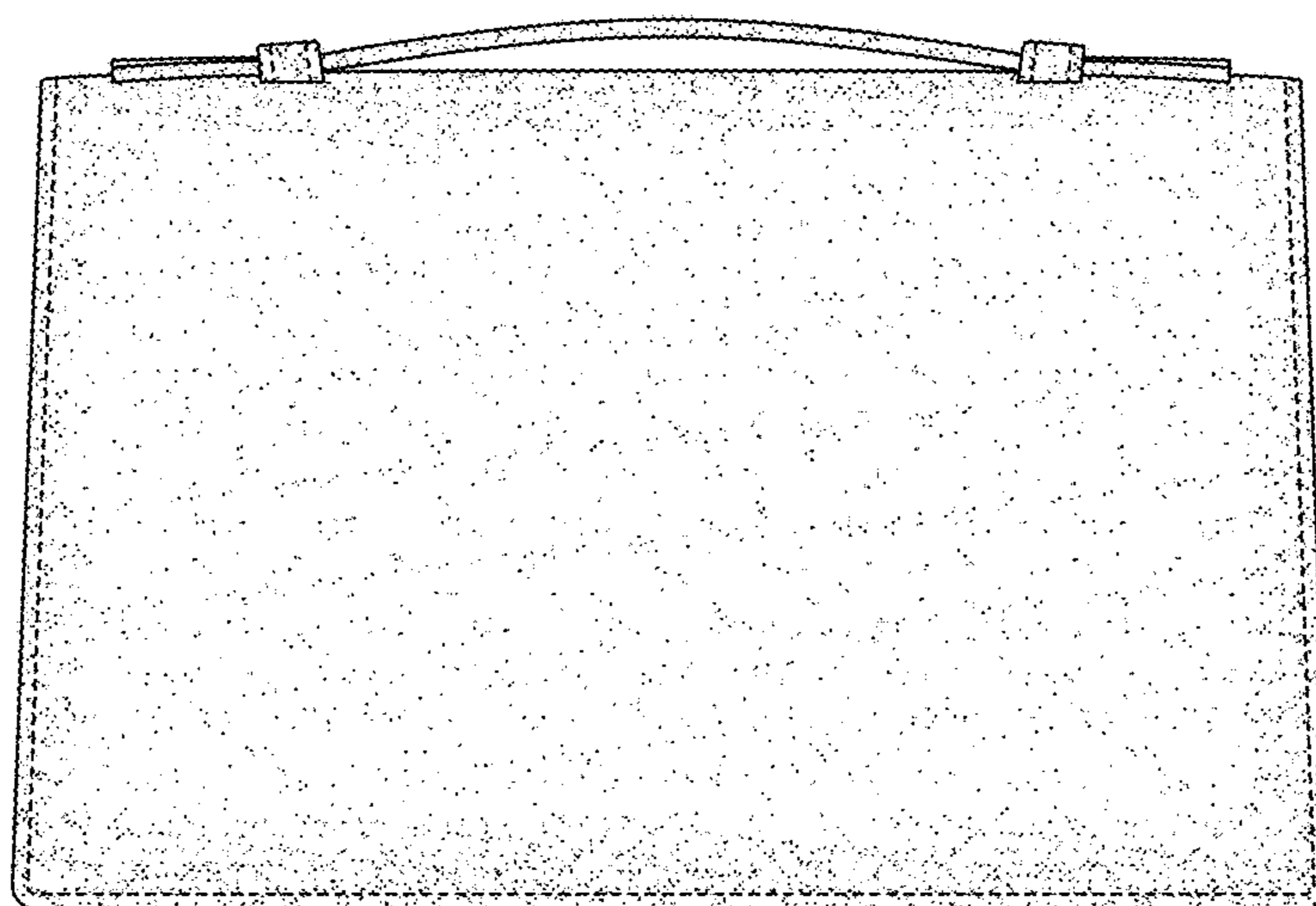

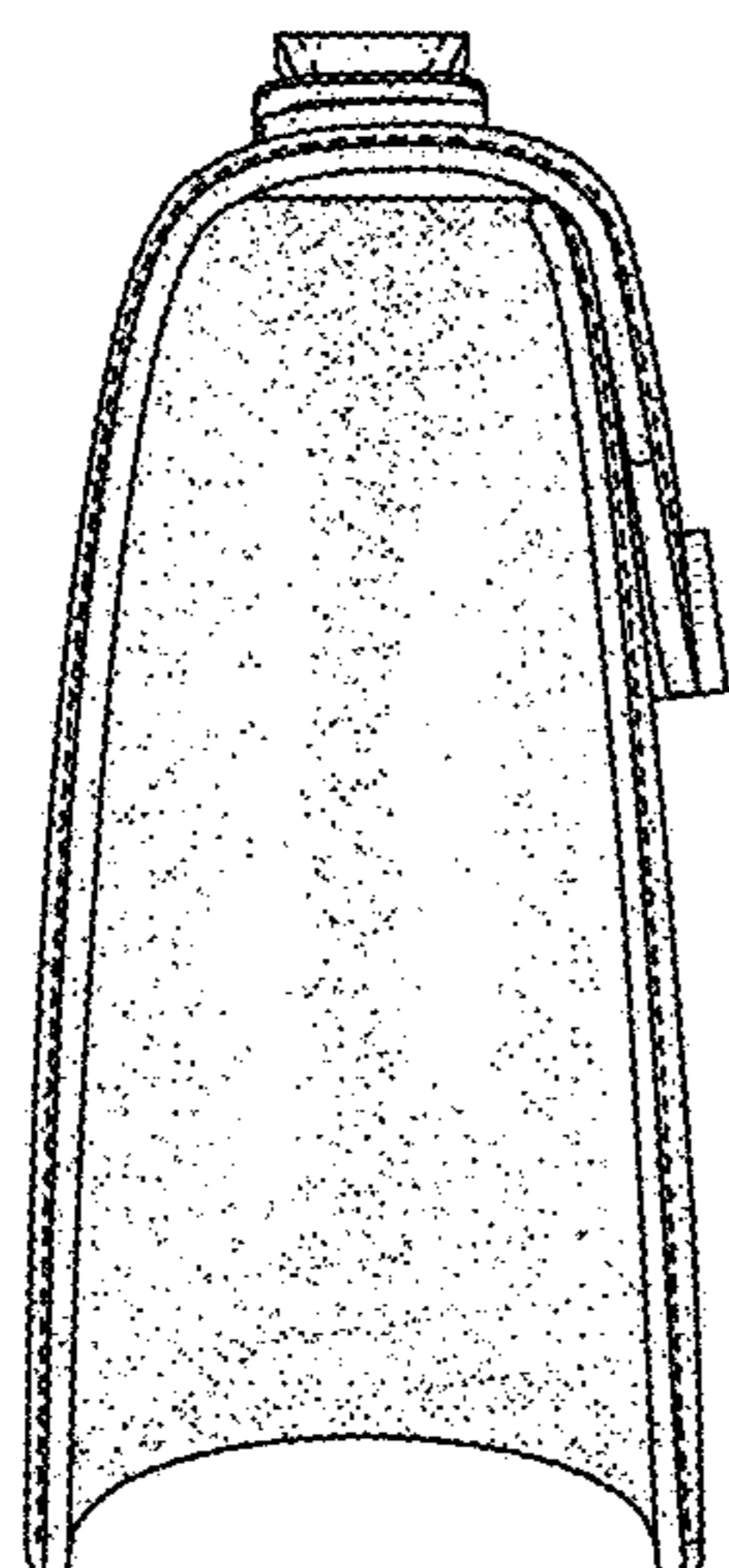

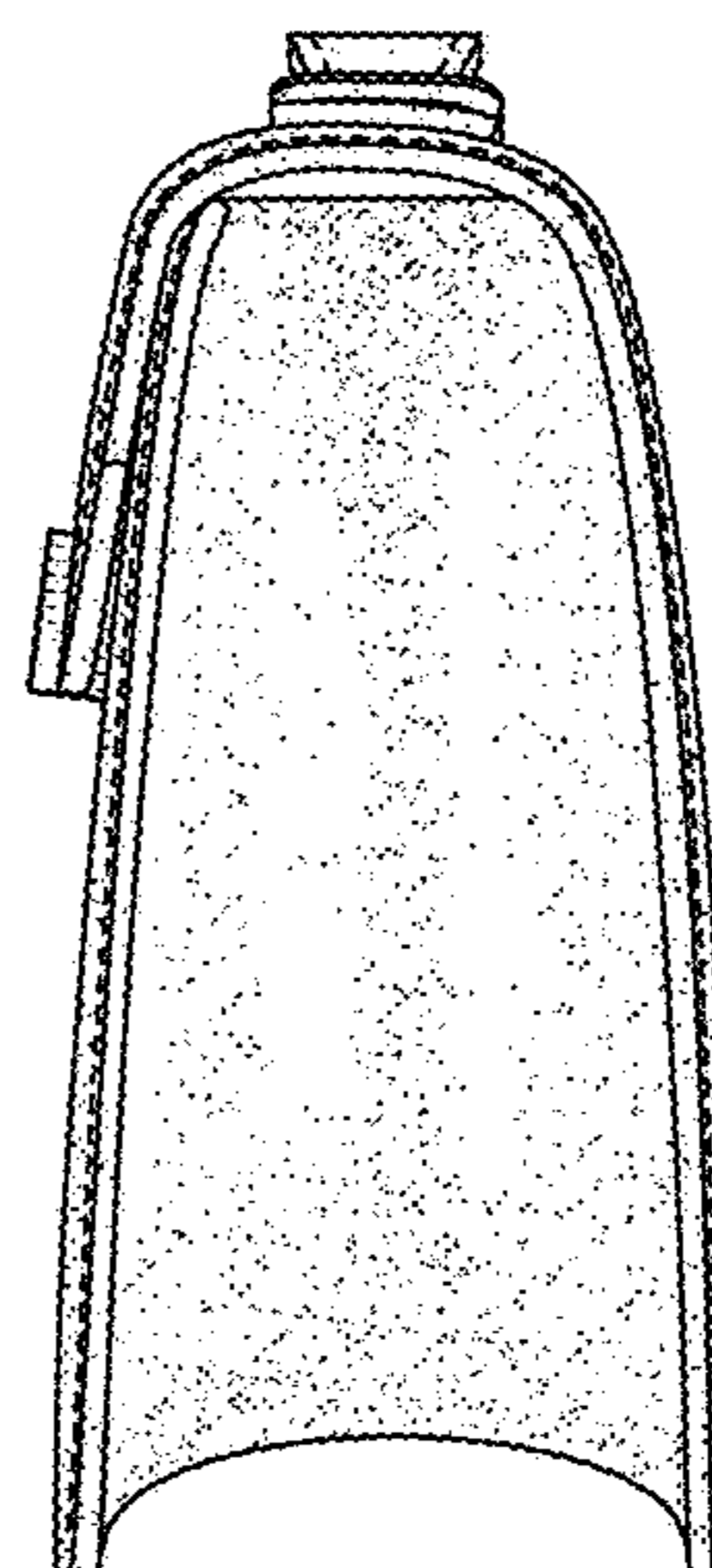
