FIG. 3 is a rear view thereof.

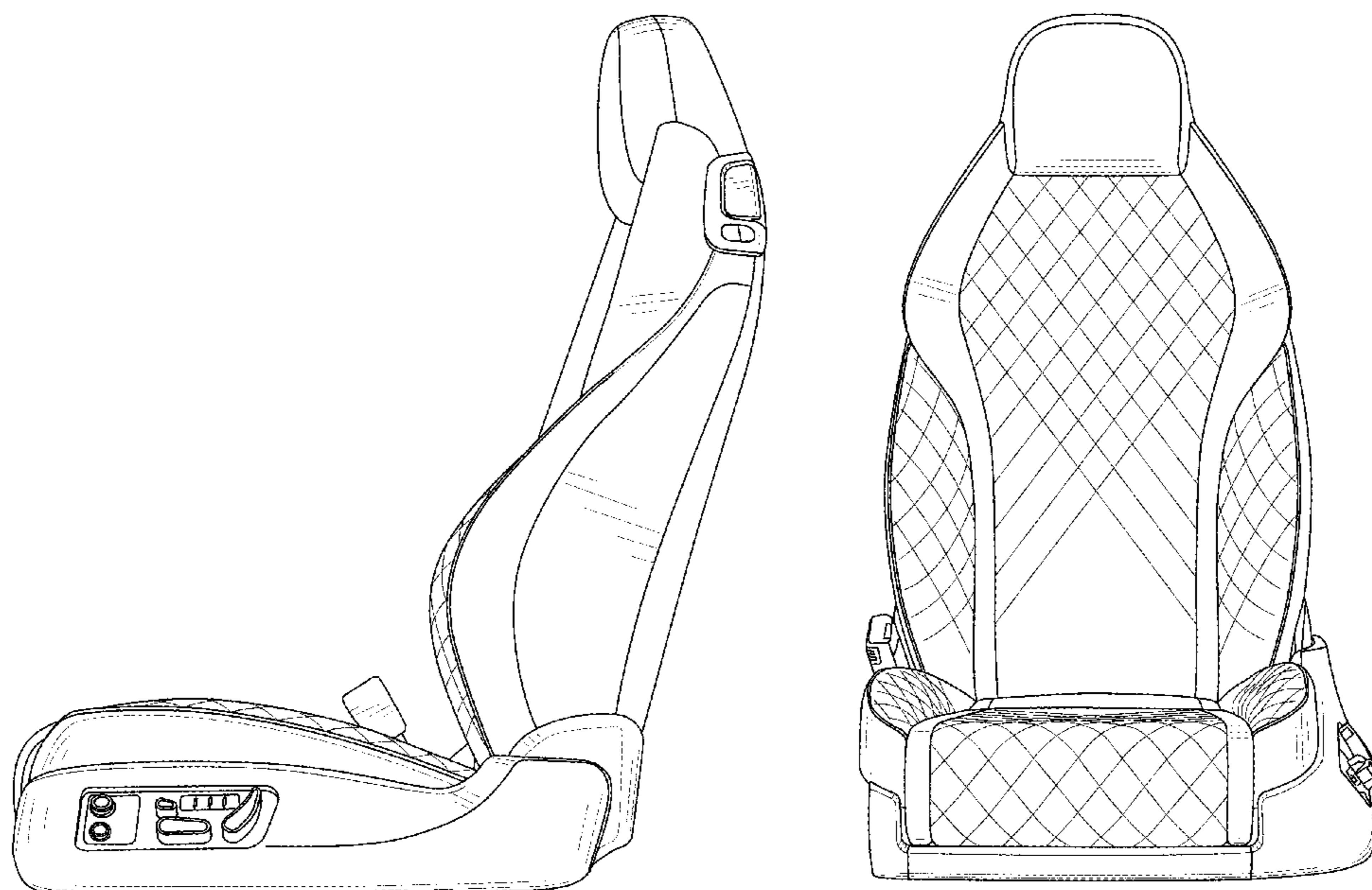
The additional views of the seat not provided herein do not provide any additional claimed features of the design and thus are not represented.

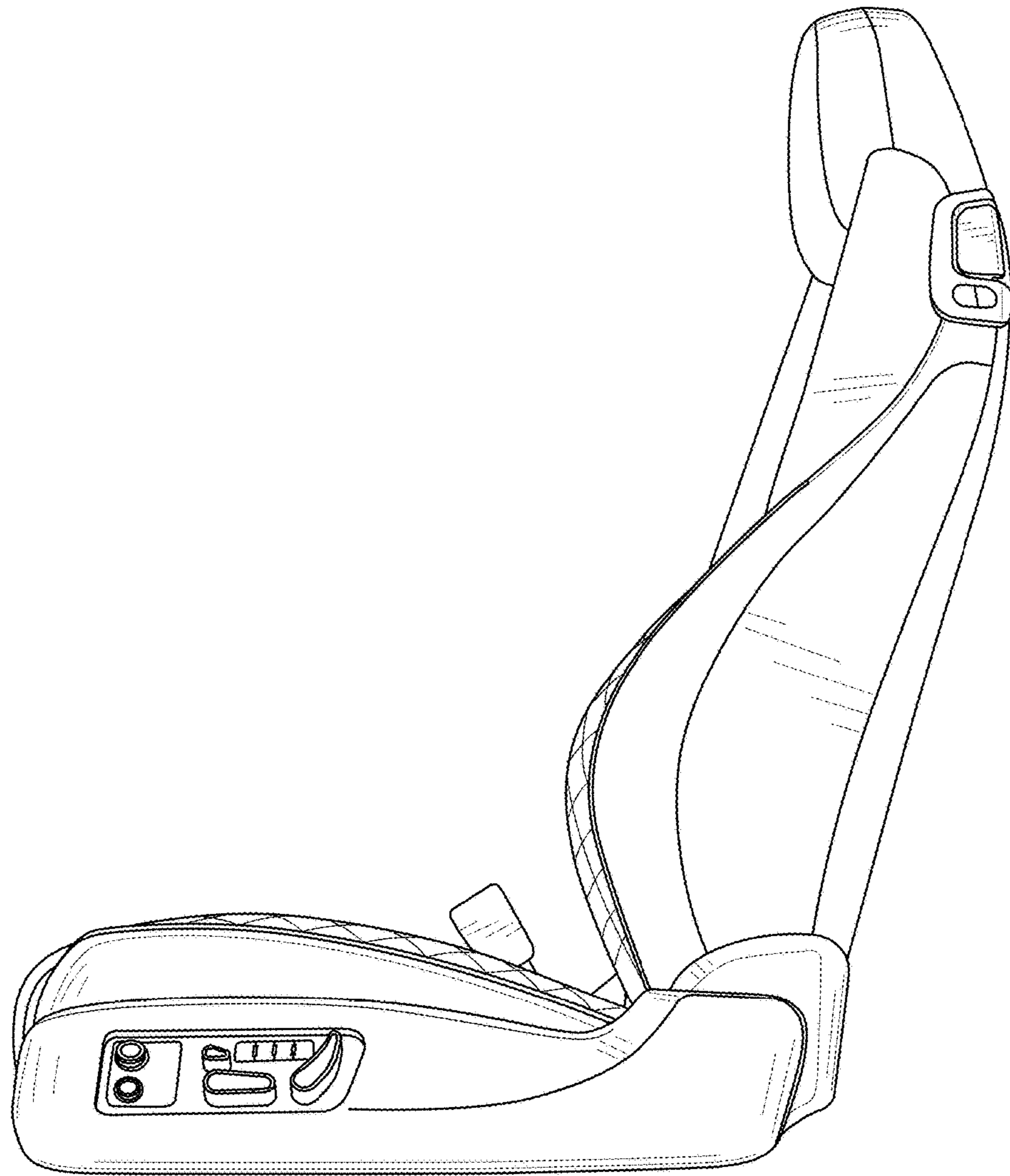

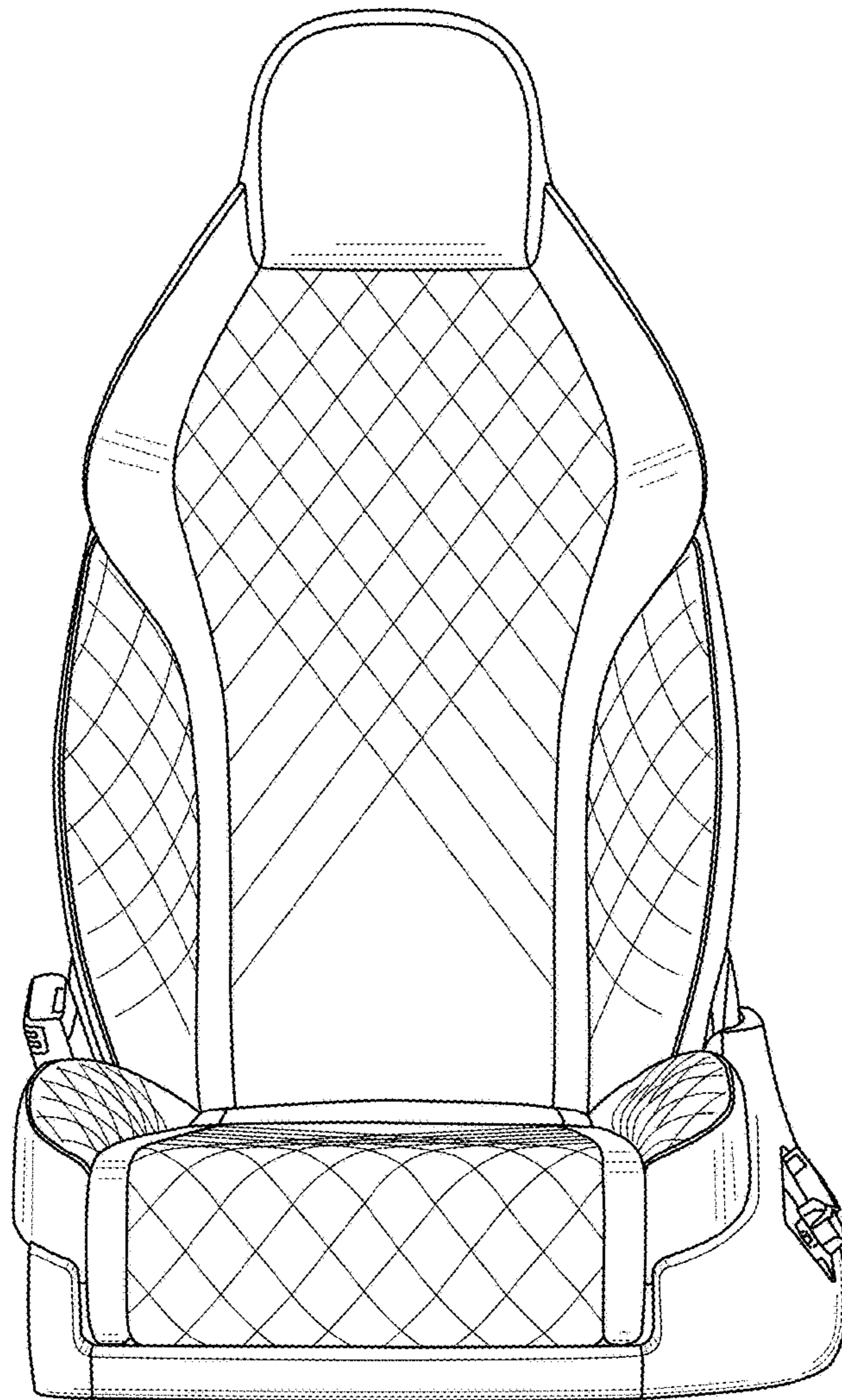

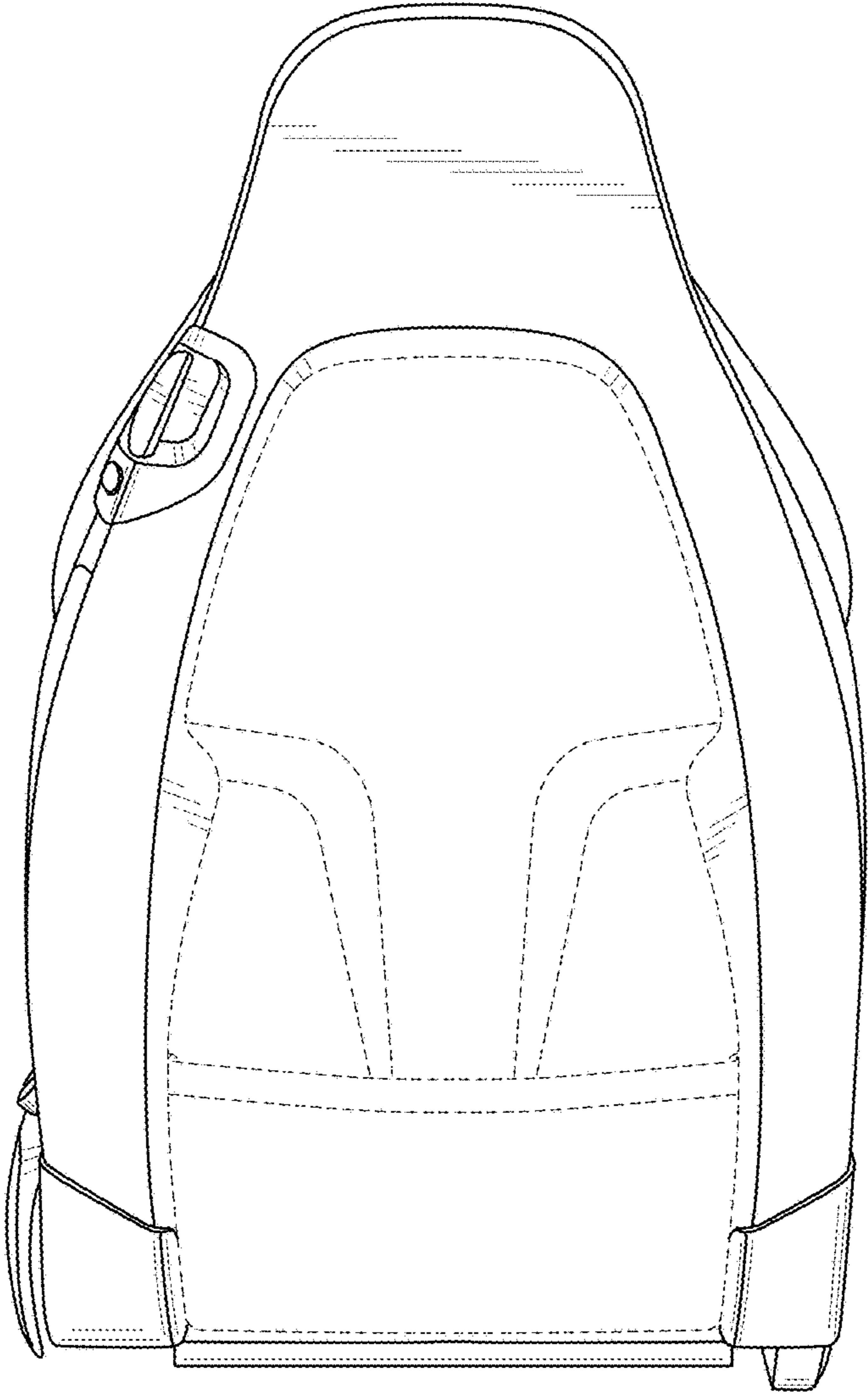
