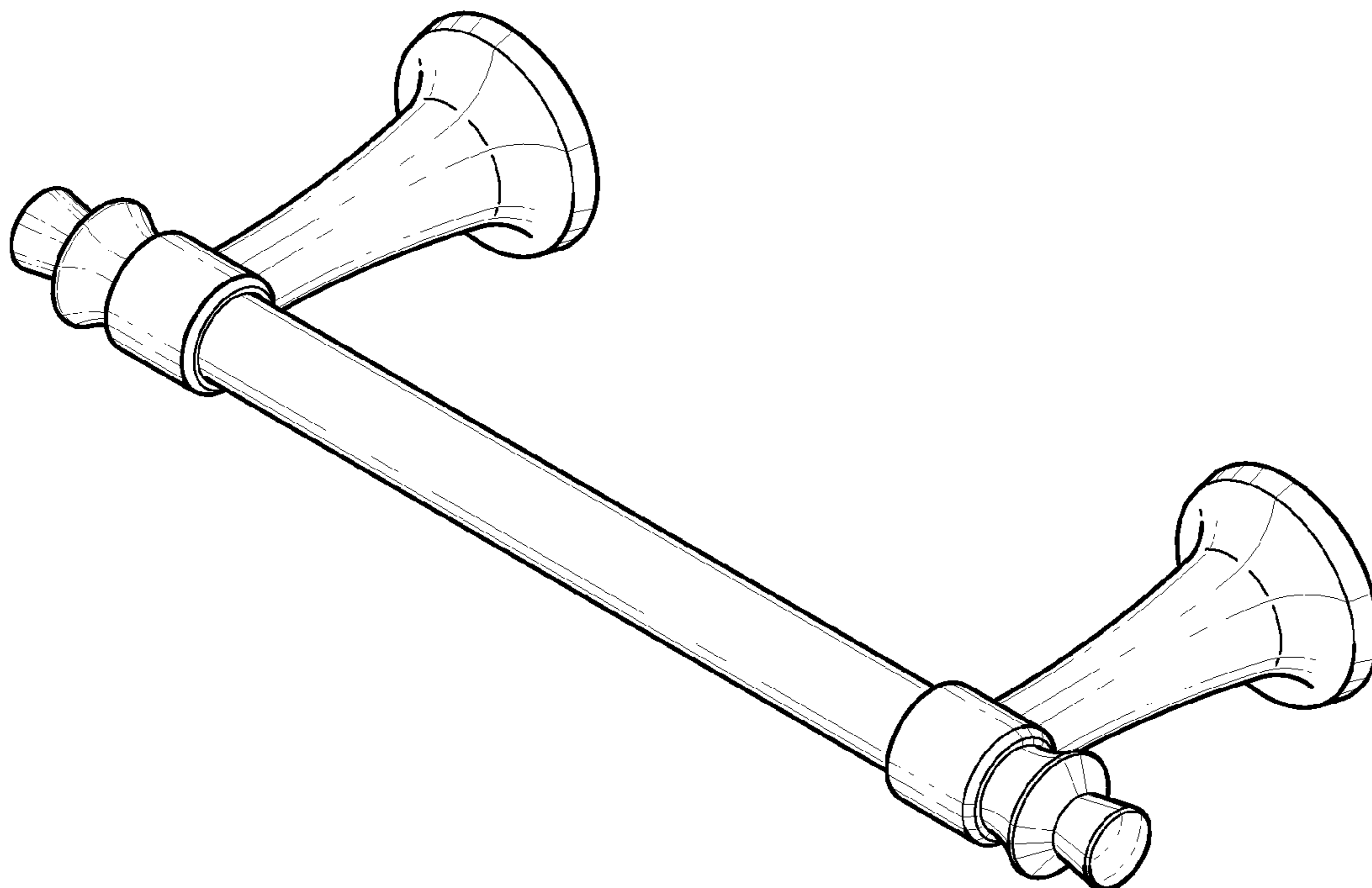
(57) **CLAIM**

The ornamental design for a towel bar, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a perspective view of a towel bar showing my new  
design;  
FIG. 2 is a left end view thereof, the opposite end being a  
mirror image of the end shown;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a top plan view thereof, the bottom being a mirror  
image of the side shown; and,  
FIG. 5 is a front elevational view thereof.  
The broken lines show portions of the design that form no  
part of the claimed design.

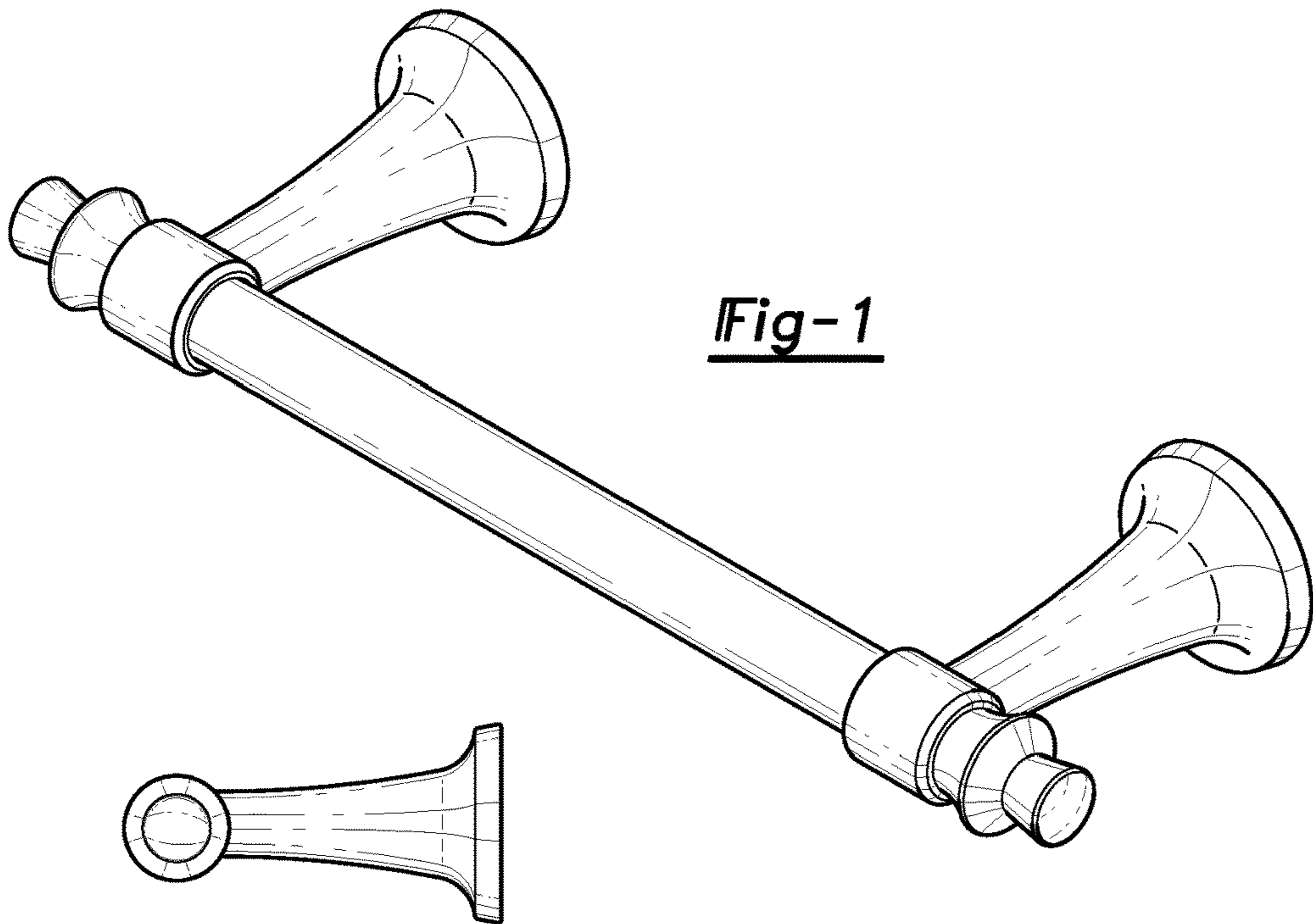

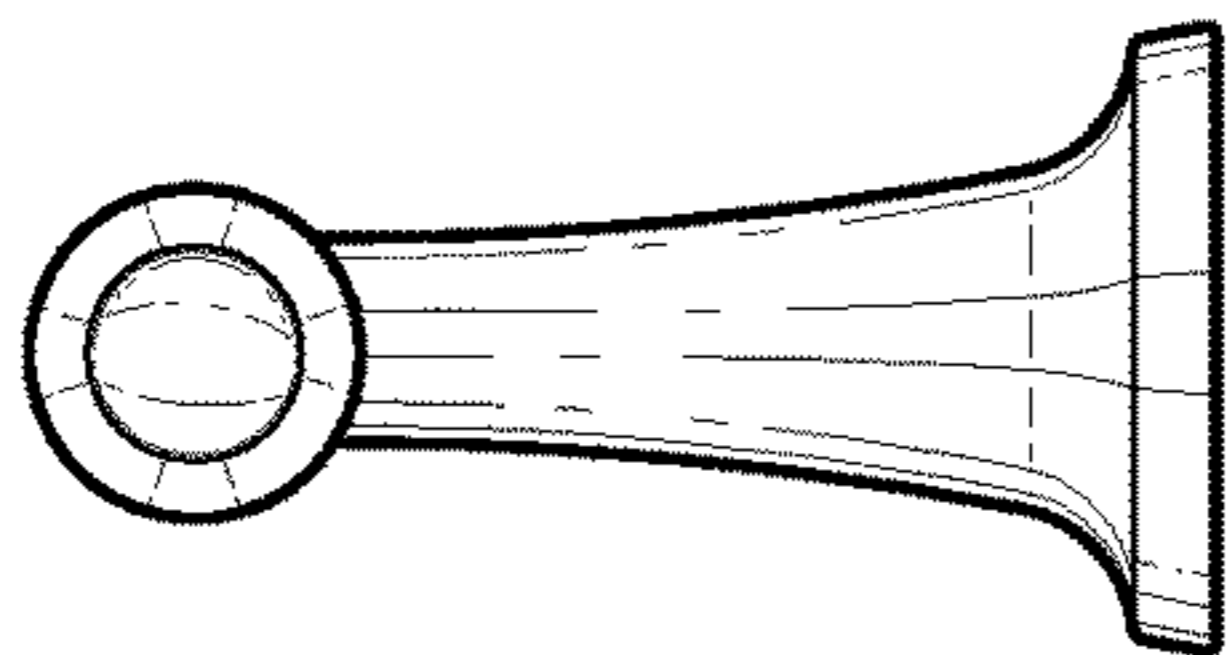

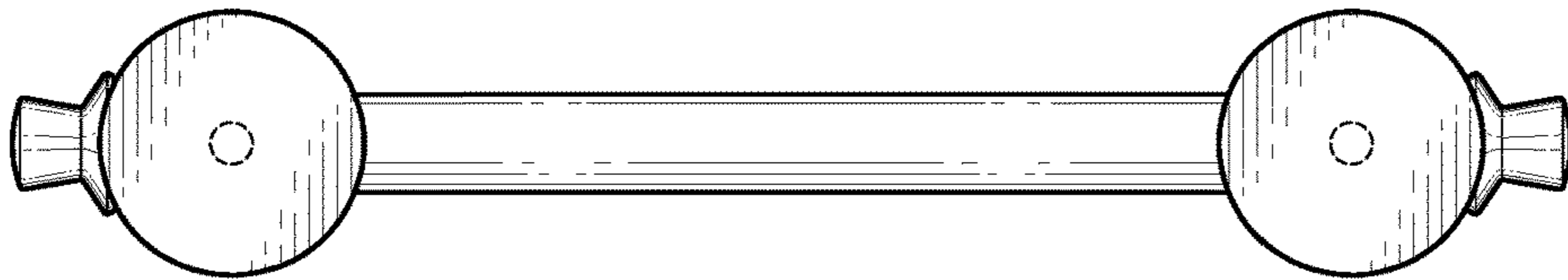

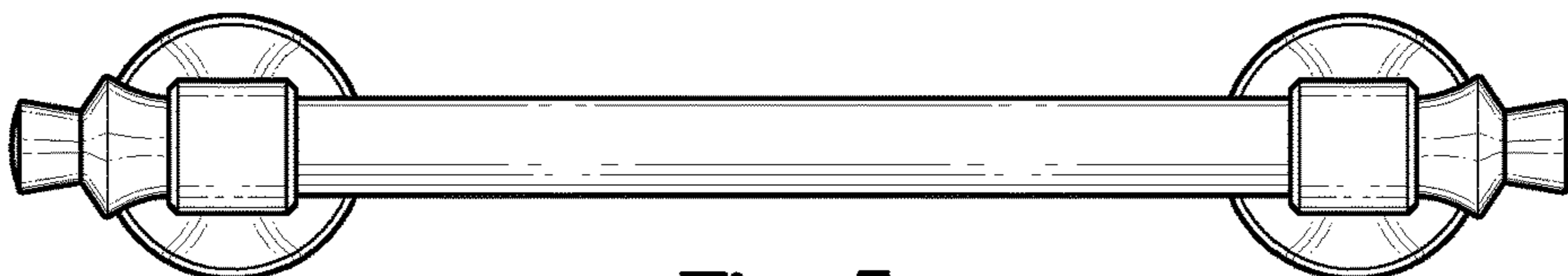
