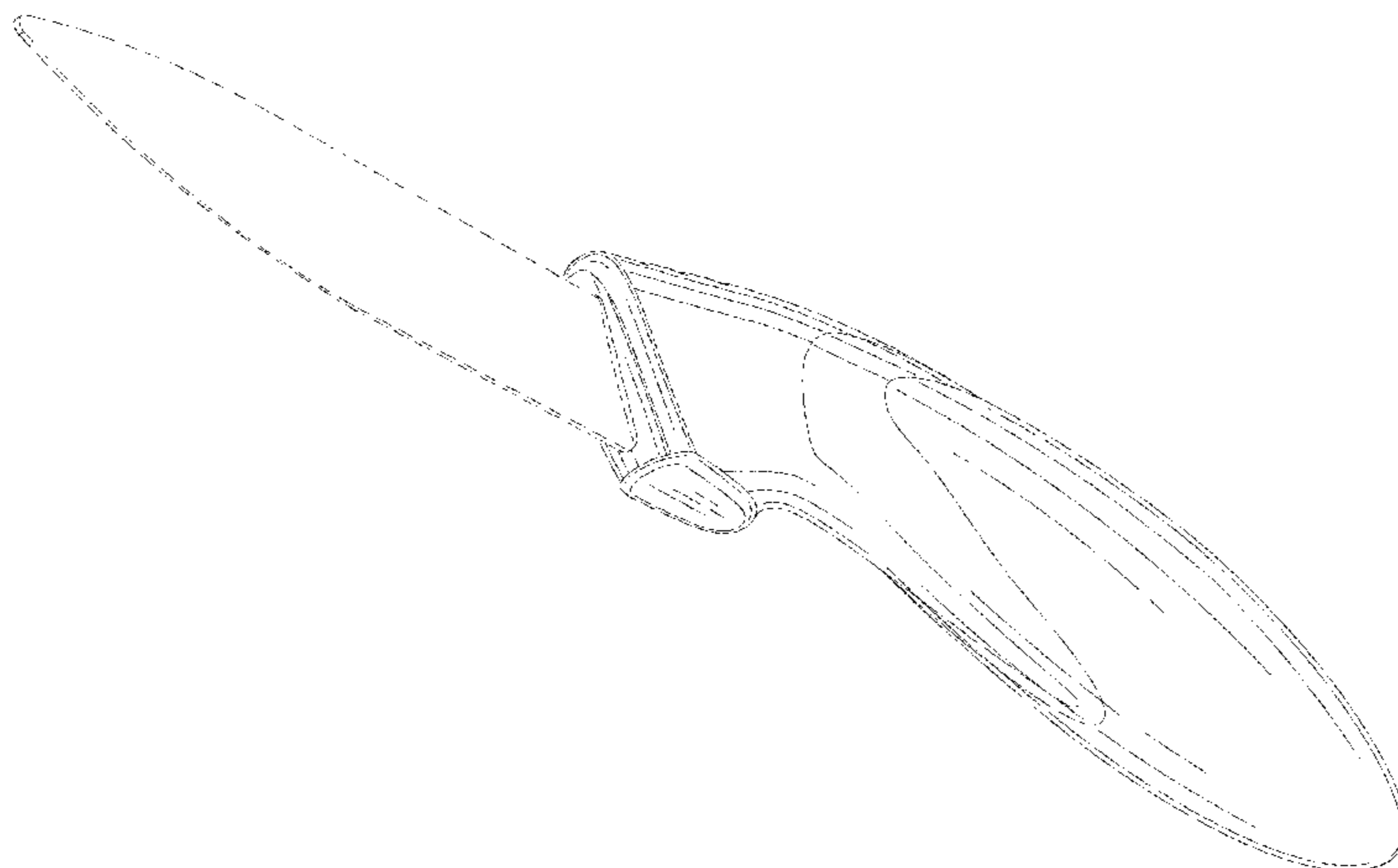
(57) **CLAIM**

The ornamental design for a knife handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a right front bottom perspective view of a knife handle, showing our new design;  
FIG. 2 is a left rear bottom perspective view thereof;  
FIG. 3 is a left rear top perspective view thereof;  
FIG. 4 is a right front top perspective view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a left side view thereof;  
FIG. 7 is a top perspective view thereof;  
FIG. 8 is a bottom perspective view thereof;  
FIG. 9 is a front magnified view thereof;  
FIG. 10 is a rear magnified view thereof; and,  
FIG. 11 is a right side cross-sectional view, taken along and in the direction of Line 11-11 in FIG. 7.

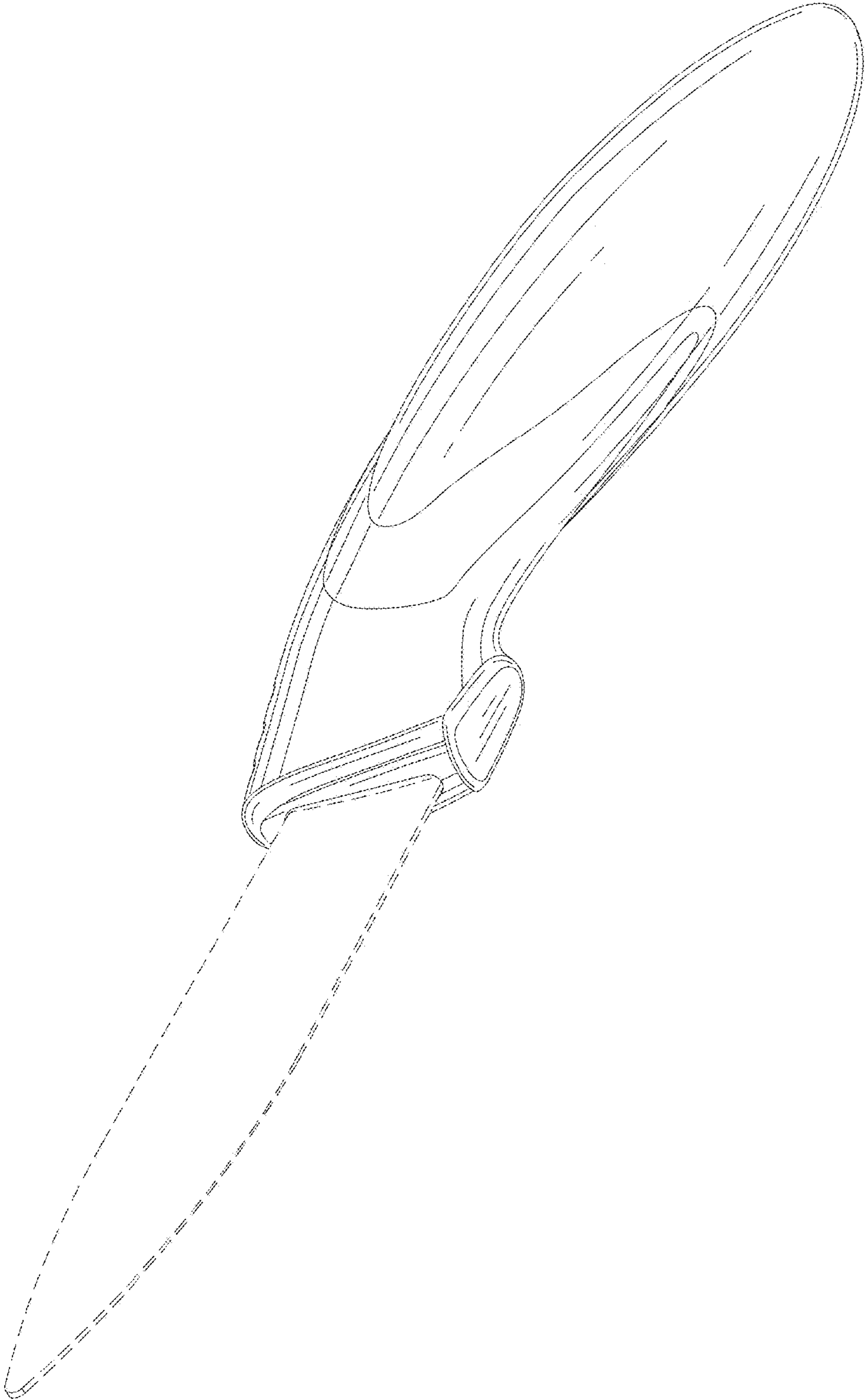

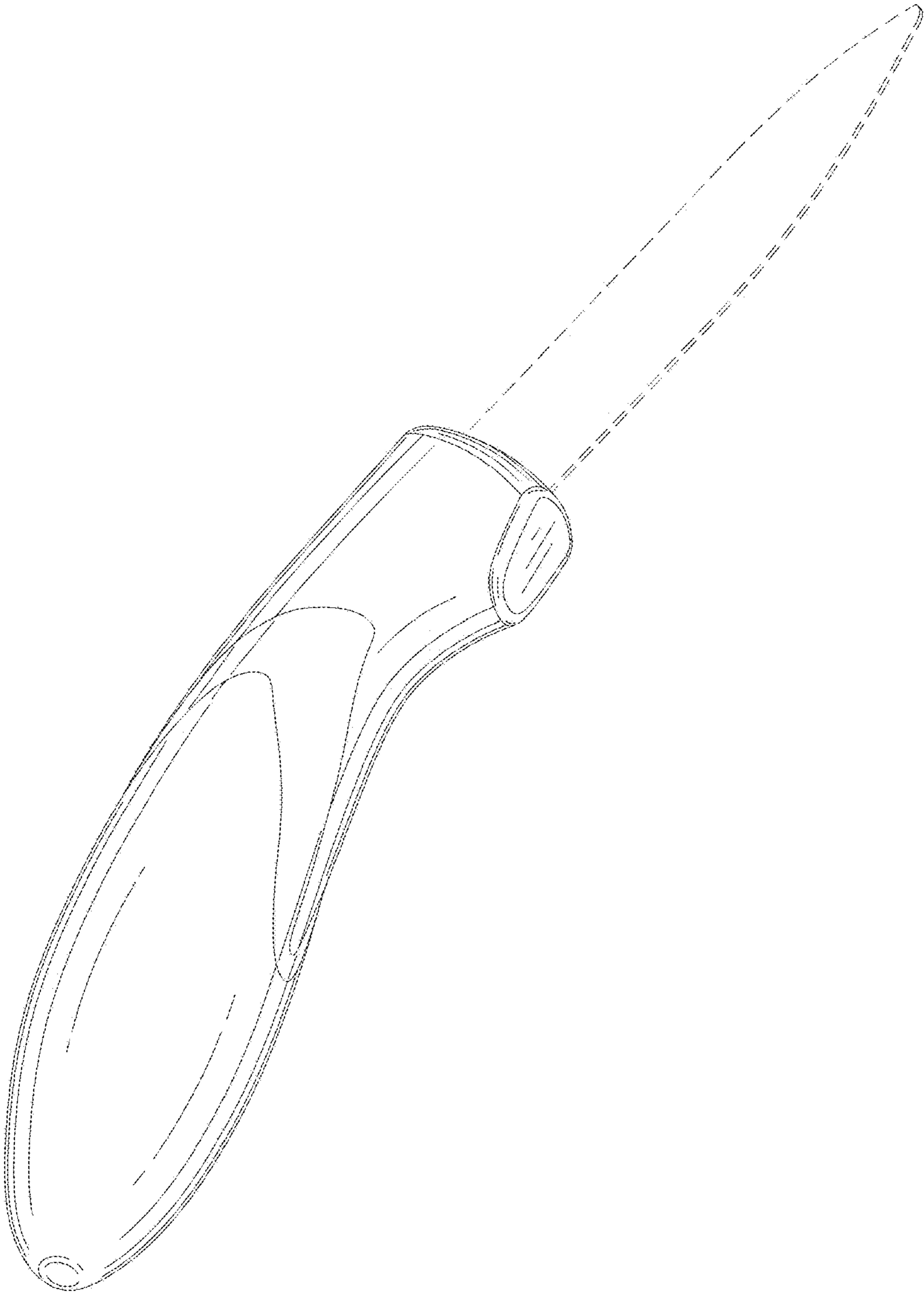

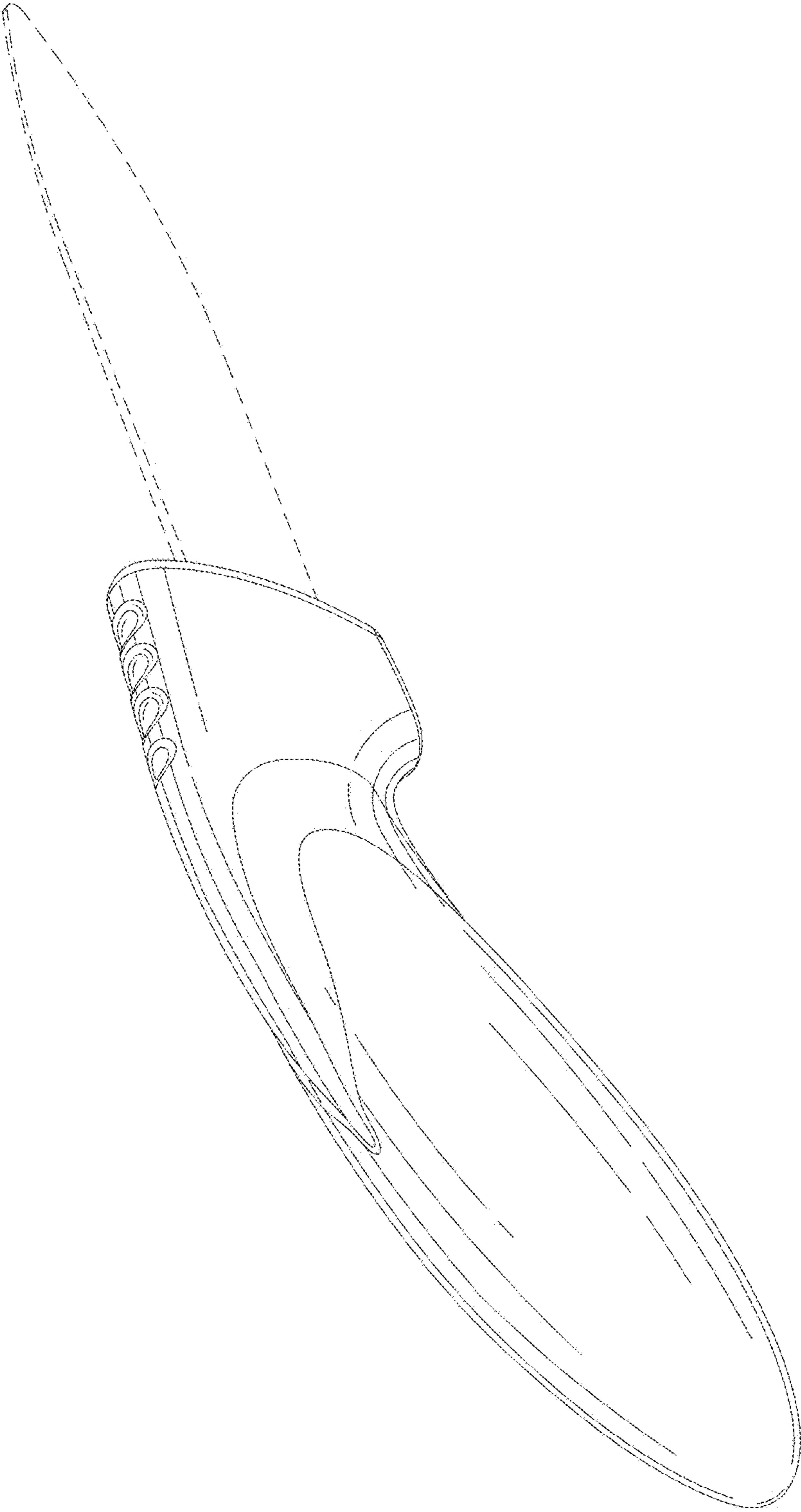

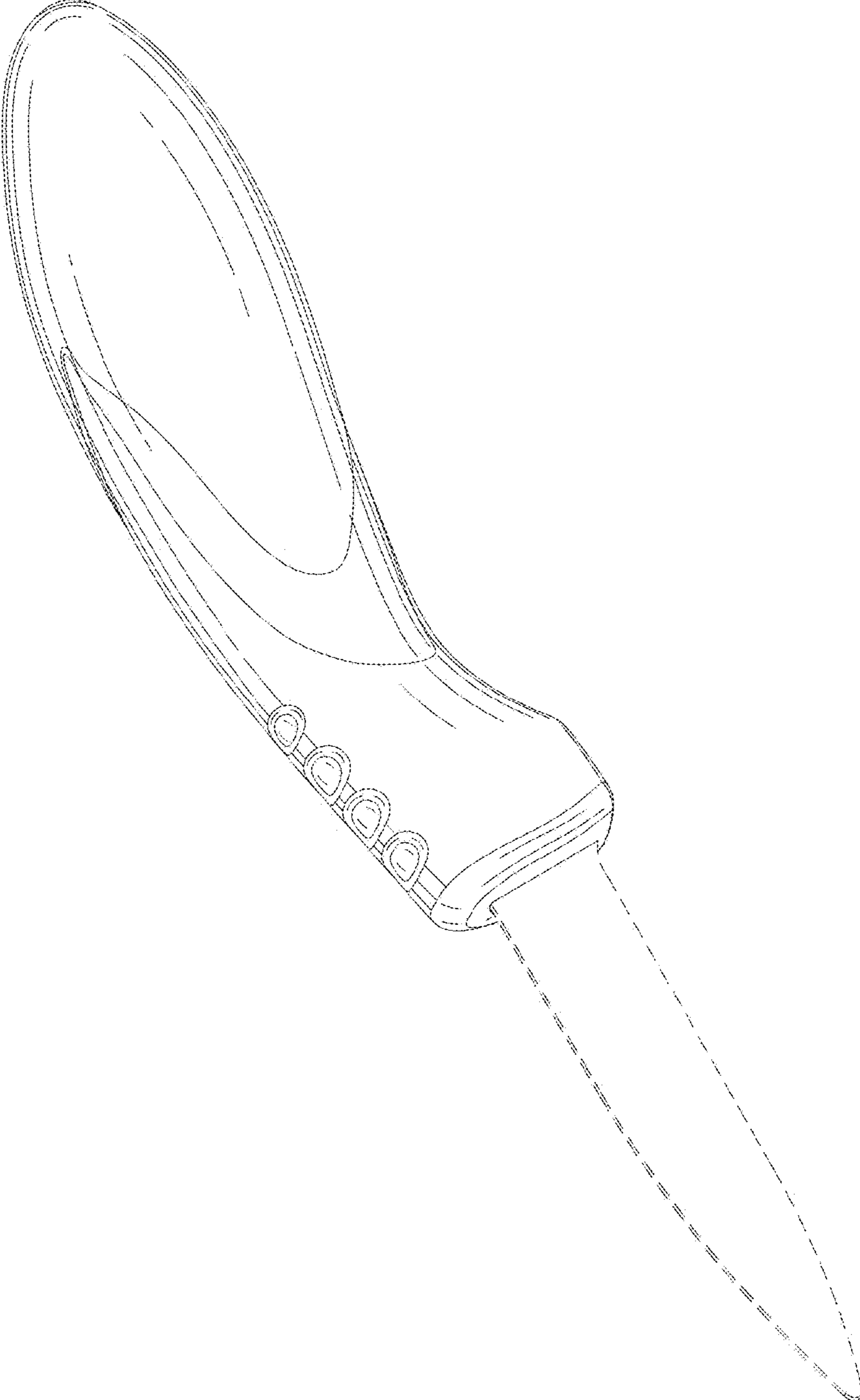

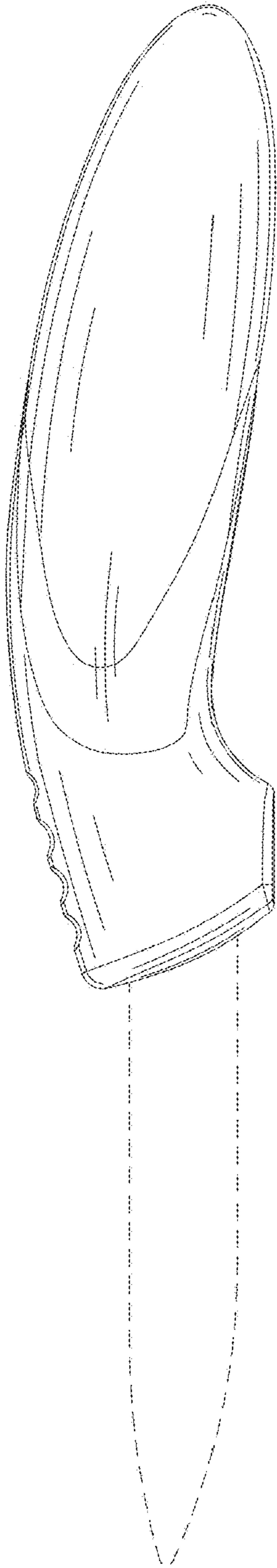

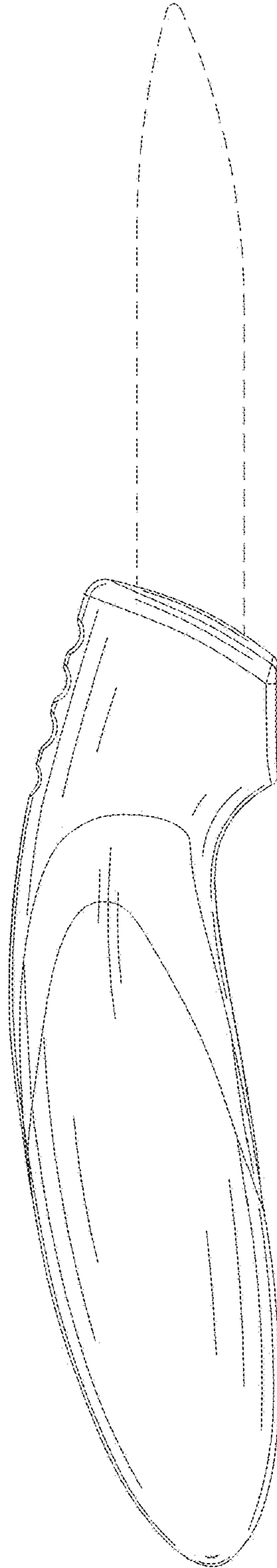

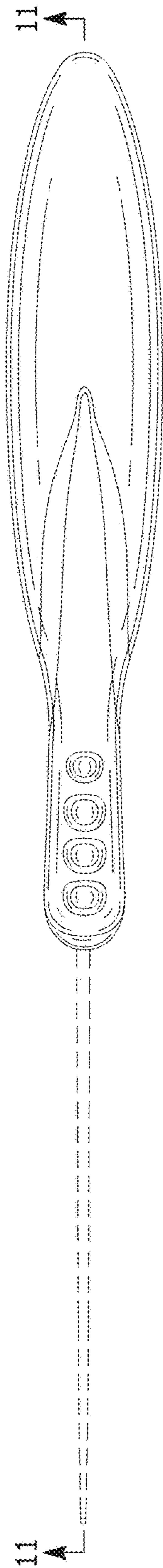

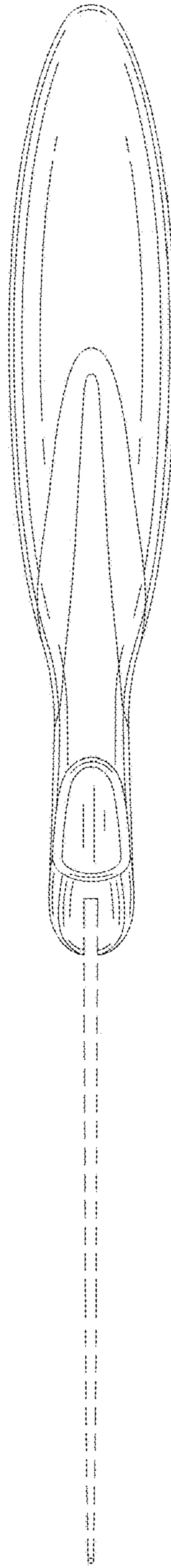

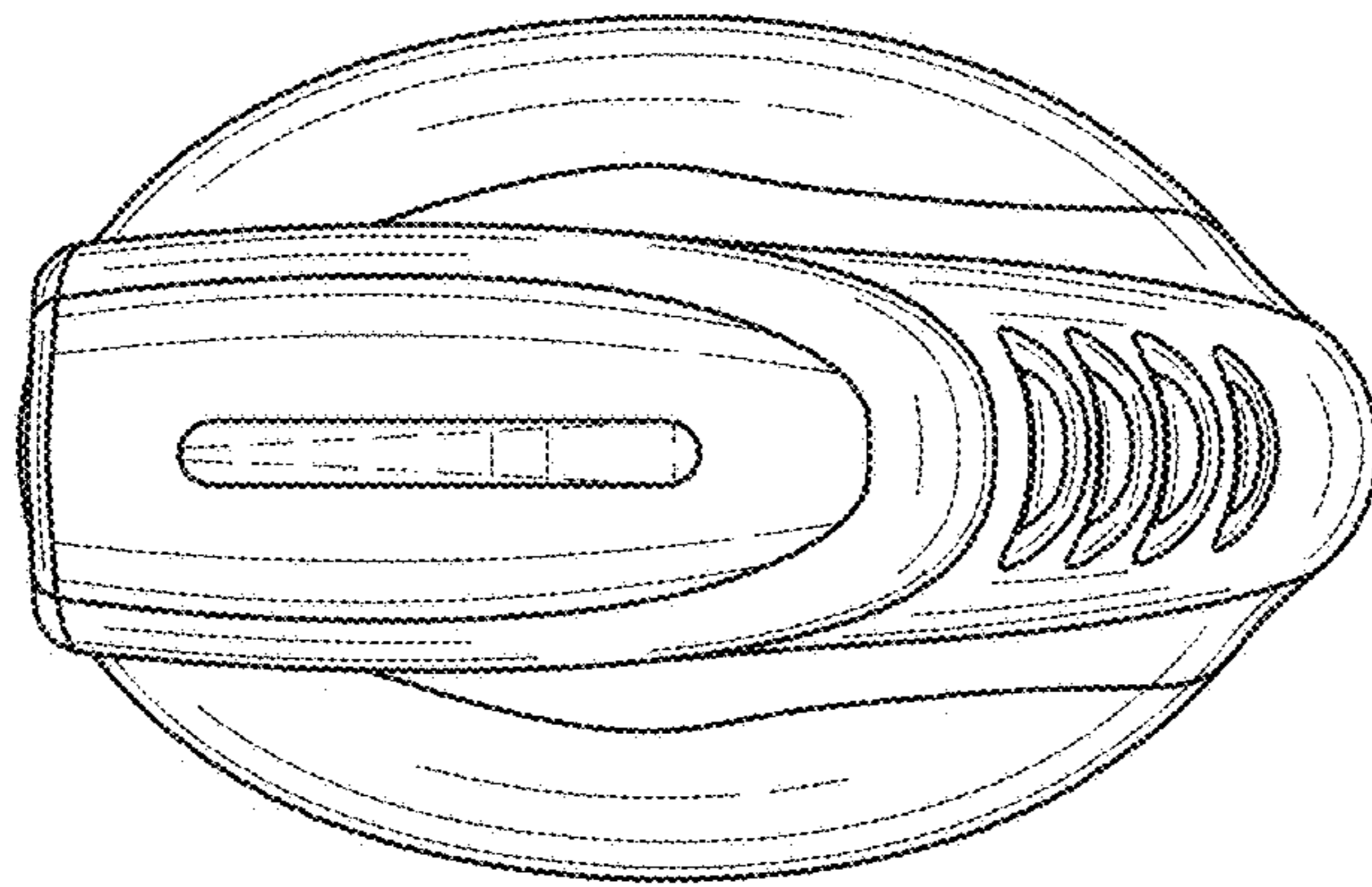

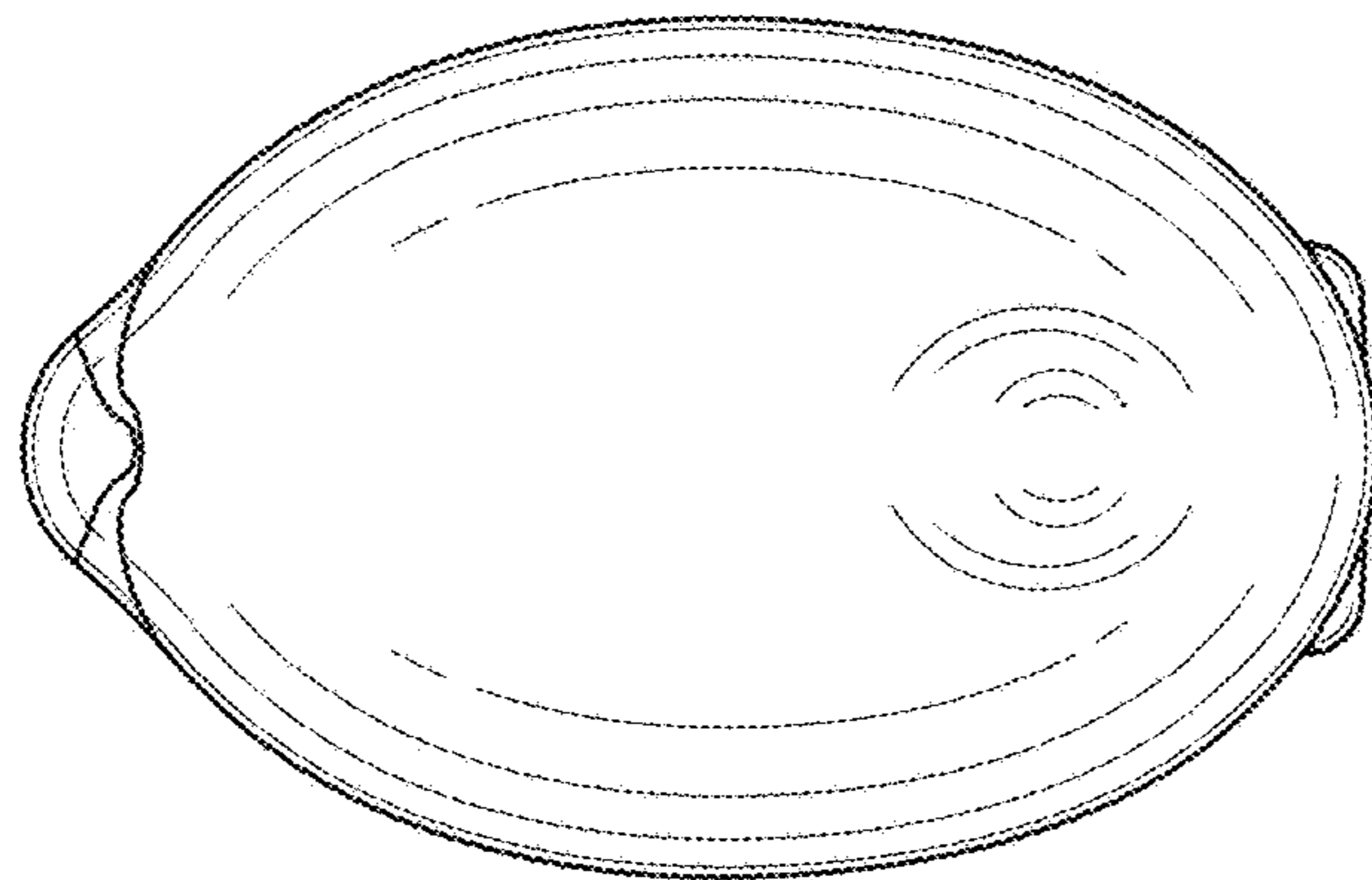

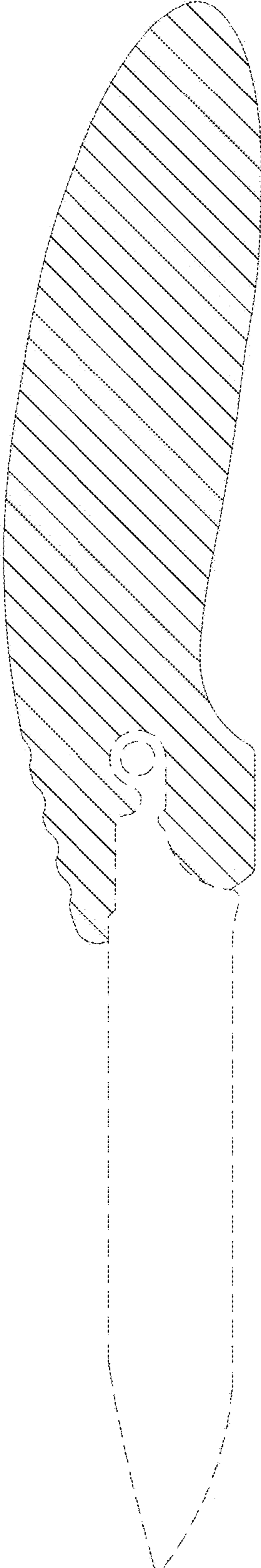
