(57) **CLAIM**

We claim as our invention the ornamental design for a garlic tray, as shown and described herein.

DESCRIPTION

FIG. 1 is a side, perspective, exploded view of a garlic tray having a lid portion, a middle portion, and a container portion;

FIG. 2 is a side view of the garlic tray with the lid, middle, and container portions nested, and the lid portion in a closed position;

FIG. 3 is a bottom view of the garlic tray with the lid, middle and container portions nested, and the lid portion in an open position;

FIG. 4 is a top, perspective view of the garlic tray with the lid, middle, and container portions nested, and the lid portion in an open position;

FIG. 5 is a side perspective view of the garlic tray with the lid, middle, and container portions nested, and the lid portion in an open position;

FIG. 6 is a top view of the garlic tray with the lid, middle, and container portions nested, and the lid portion in an open position;

FIG. 7 is a bottom view of the garlic tray with the lid, middle, and container portions nested, and the lid portion in an open position;

FIG. 22 is a perspective view of the container portion;

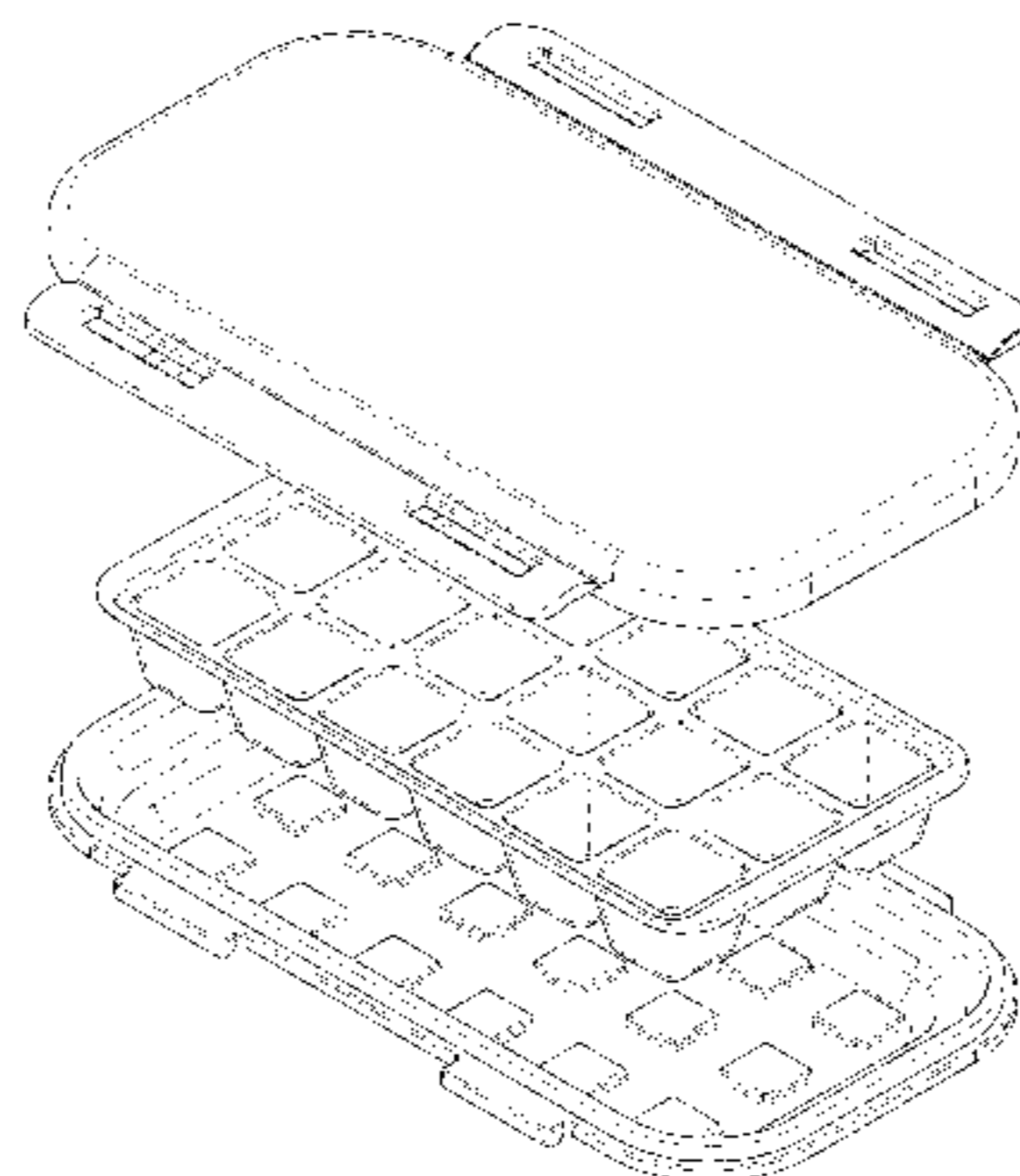
FIG. 23 is a top view of the container portion;

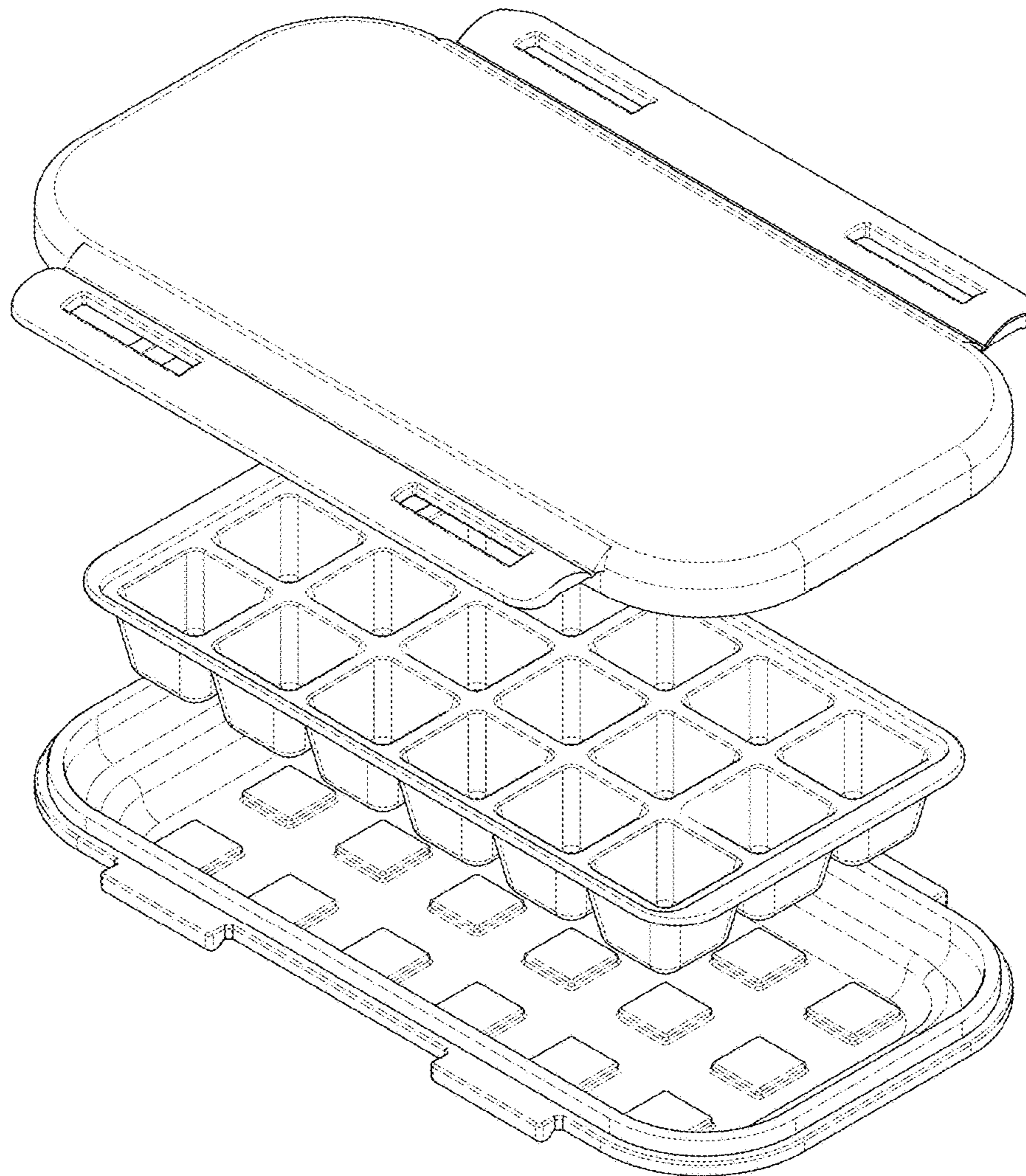

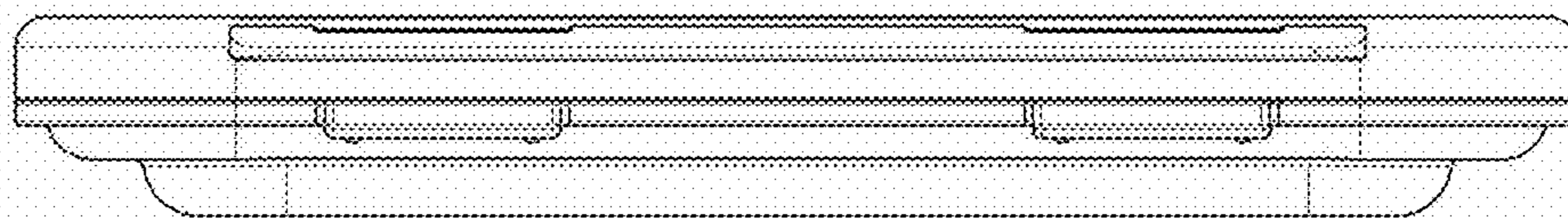

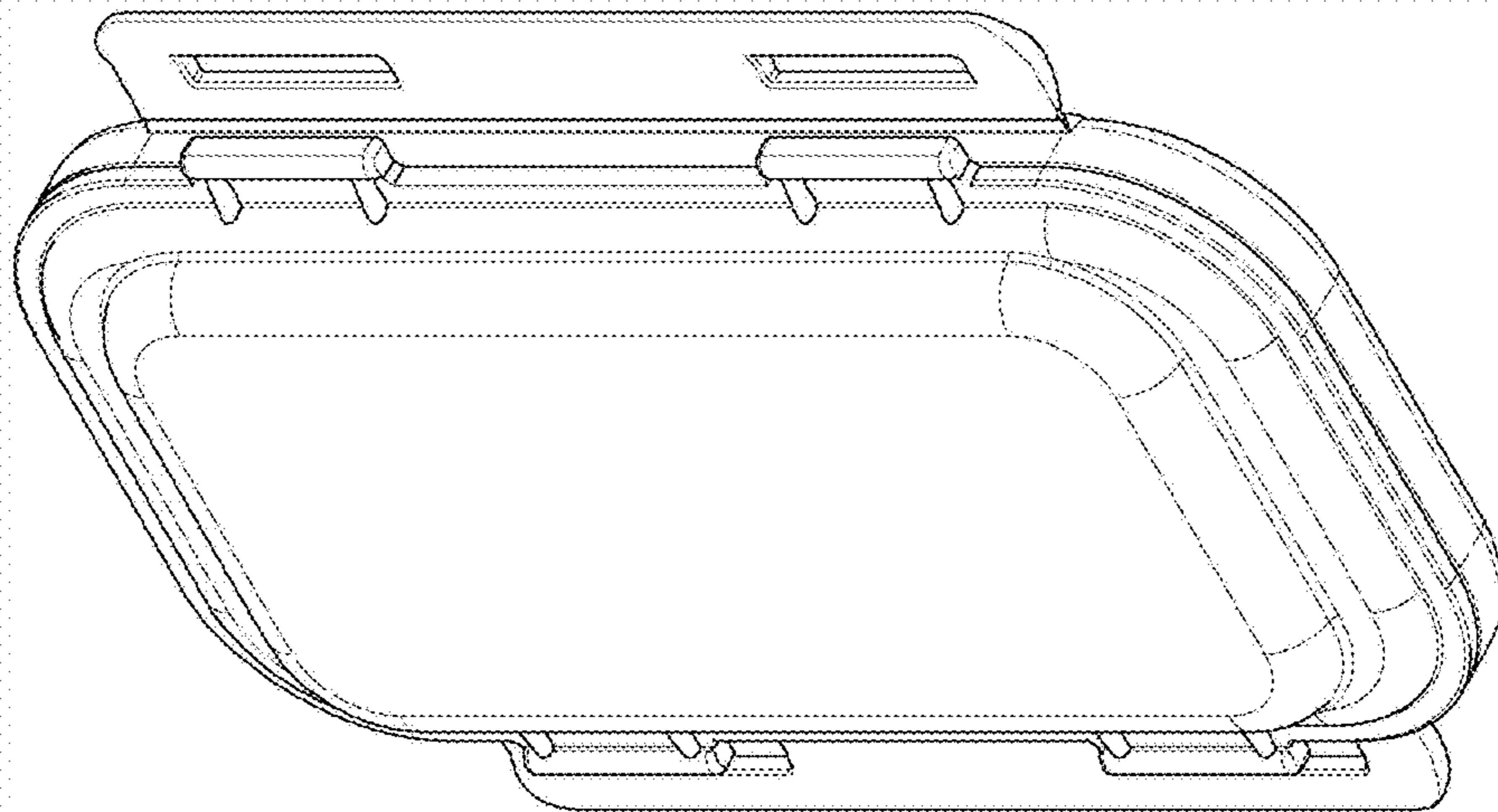

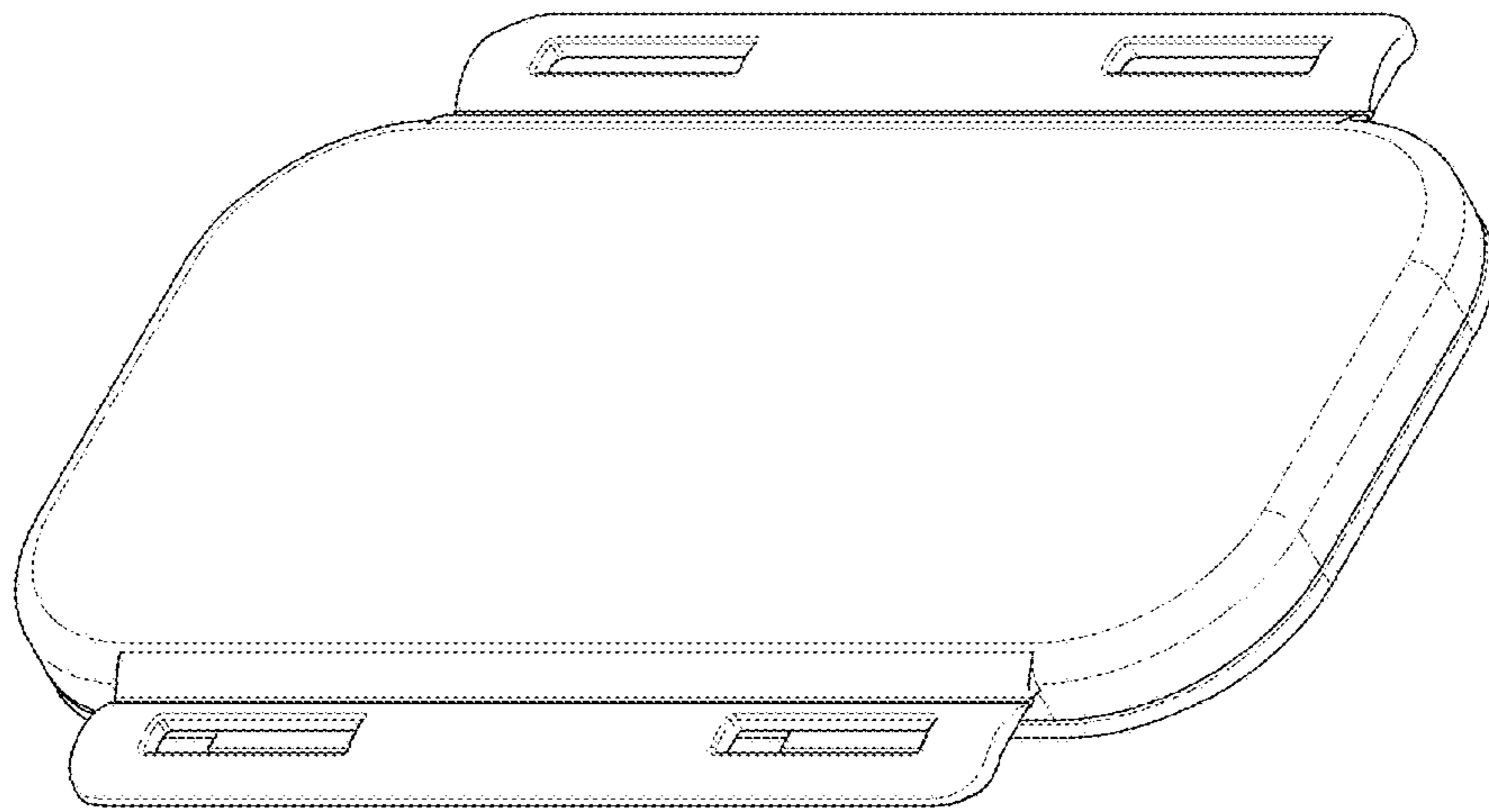

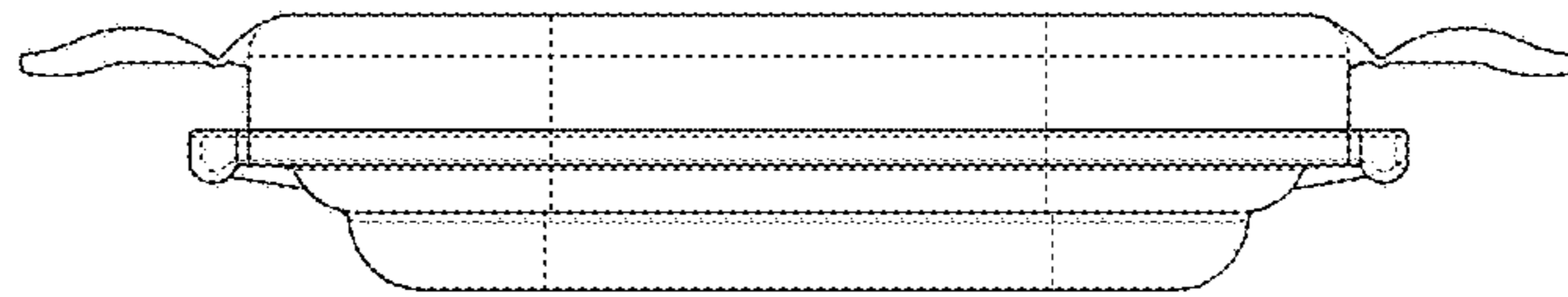

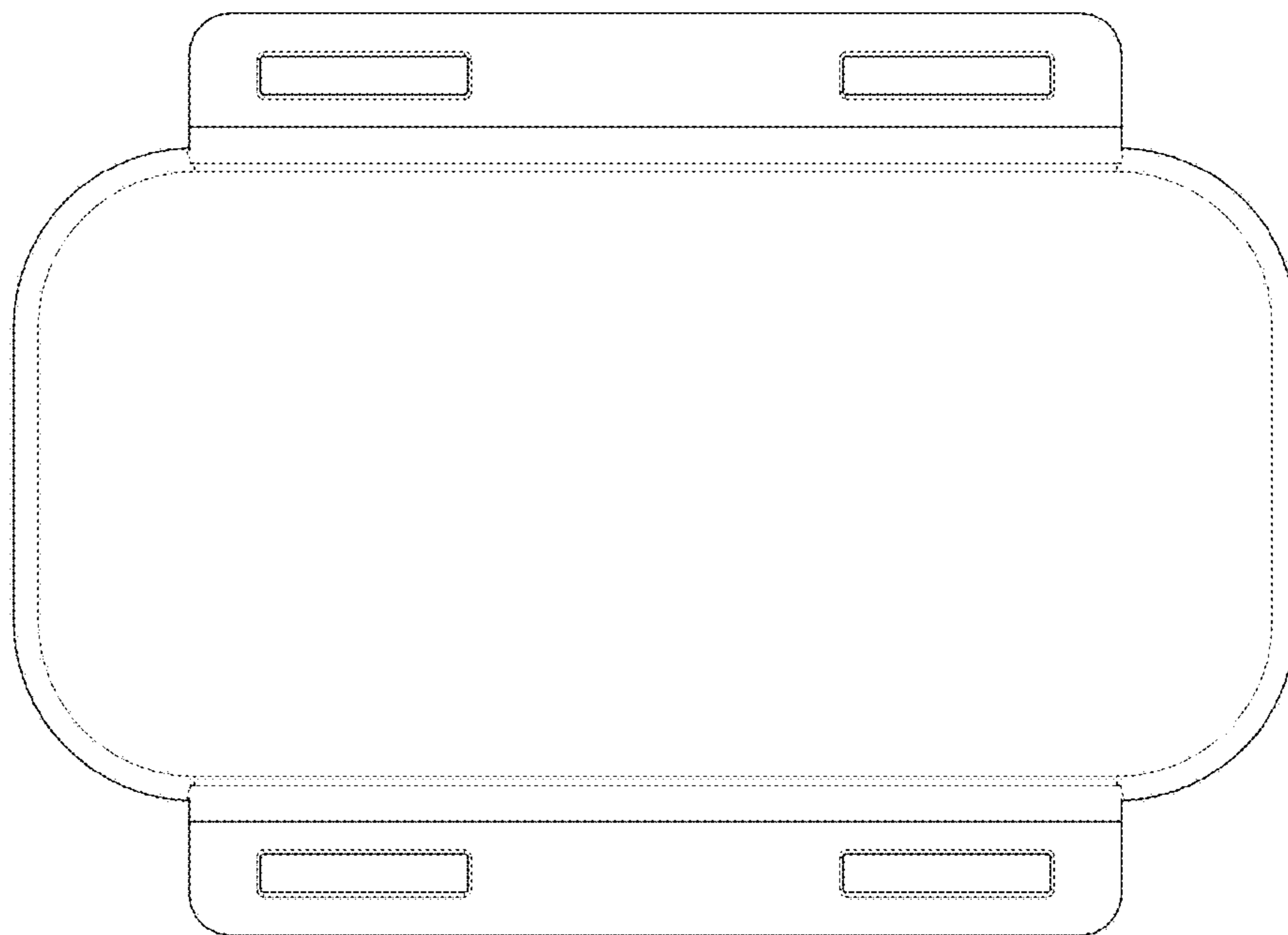

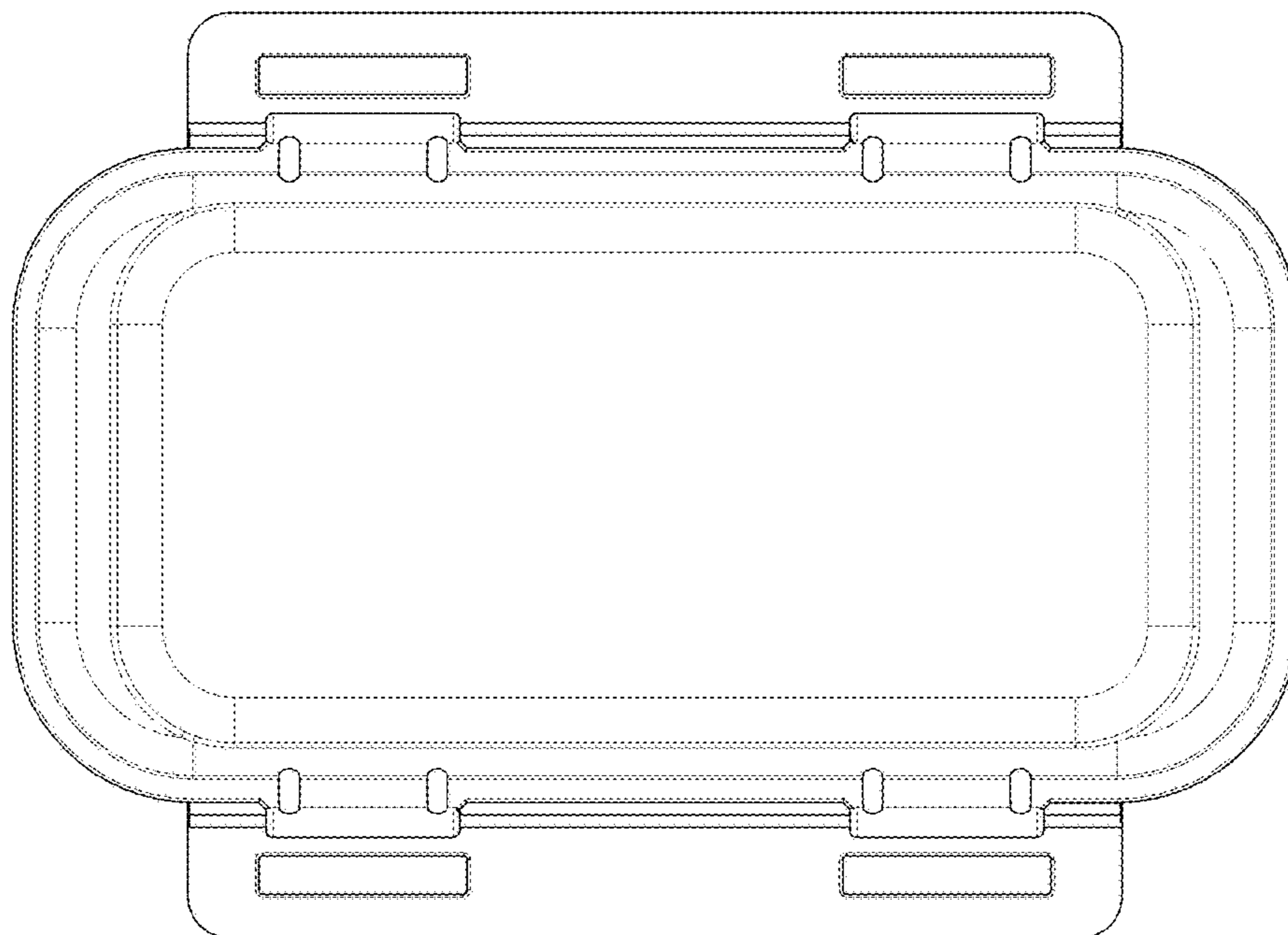

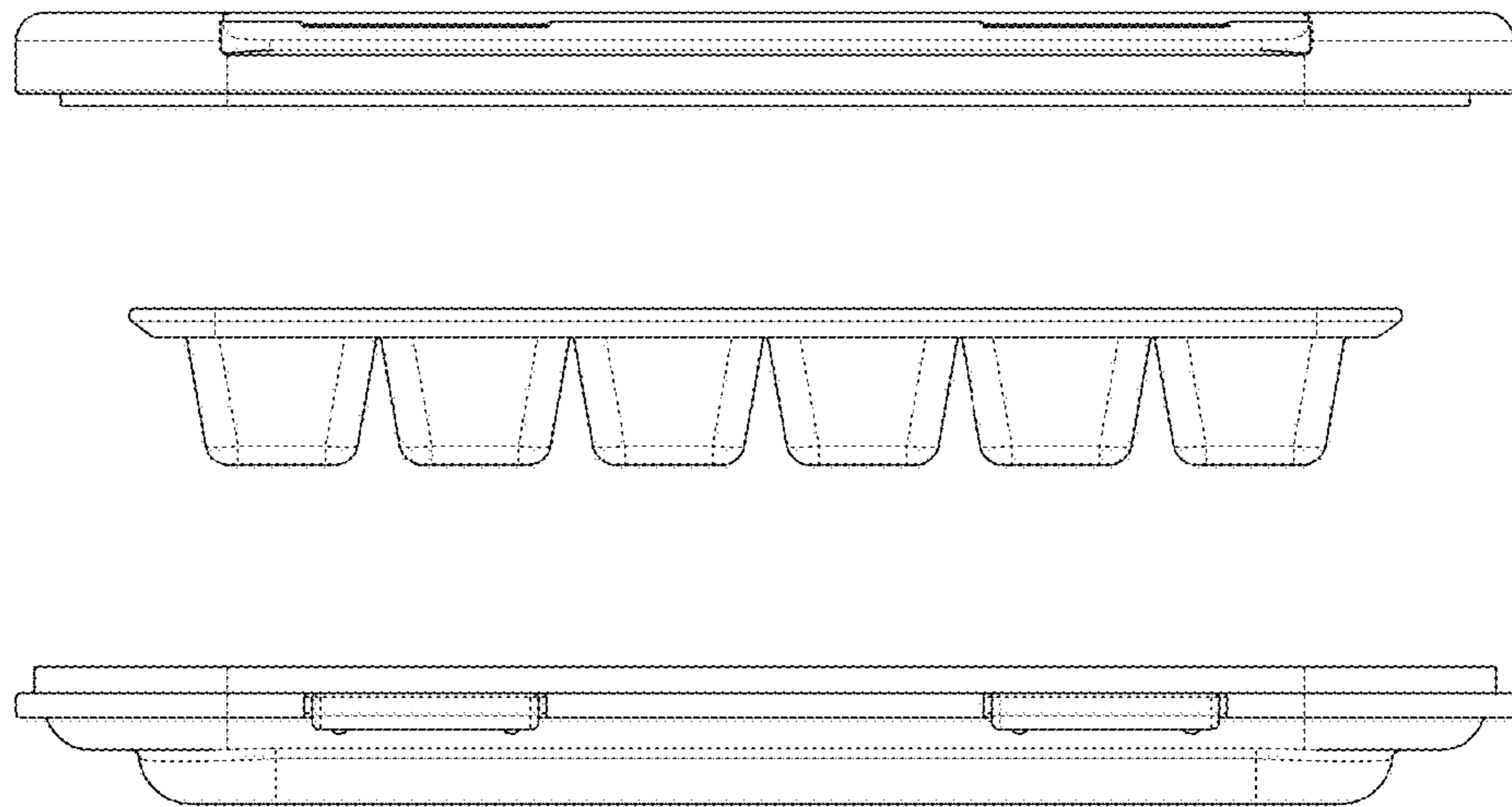

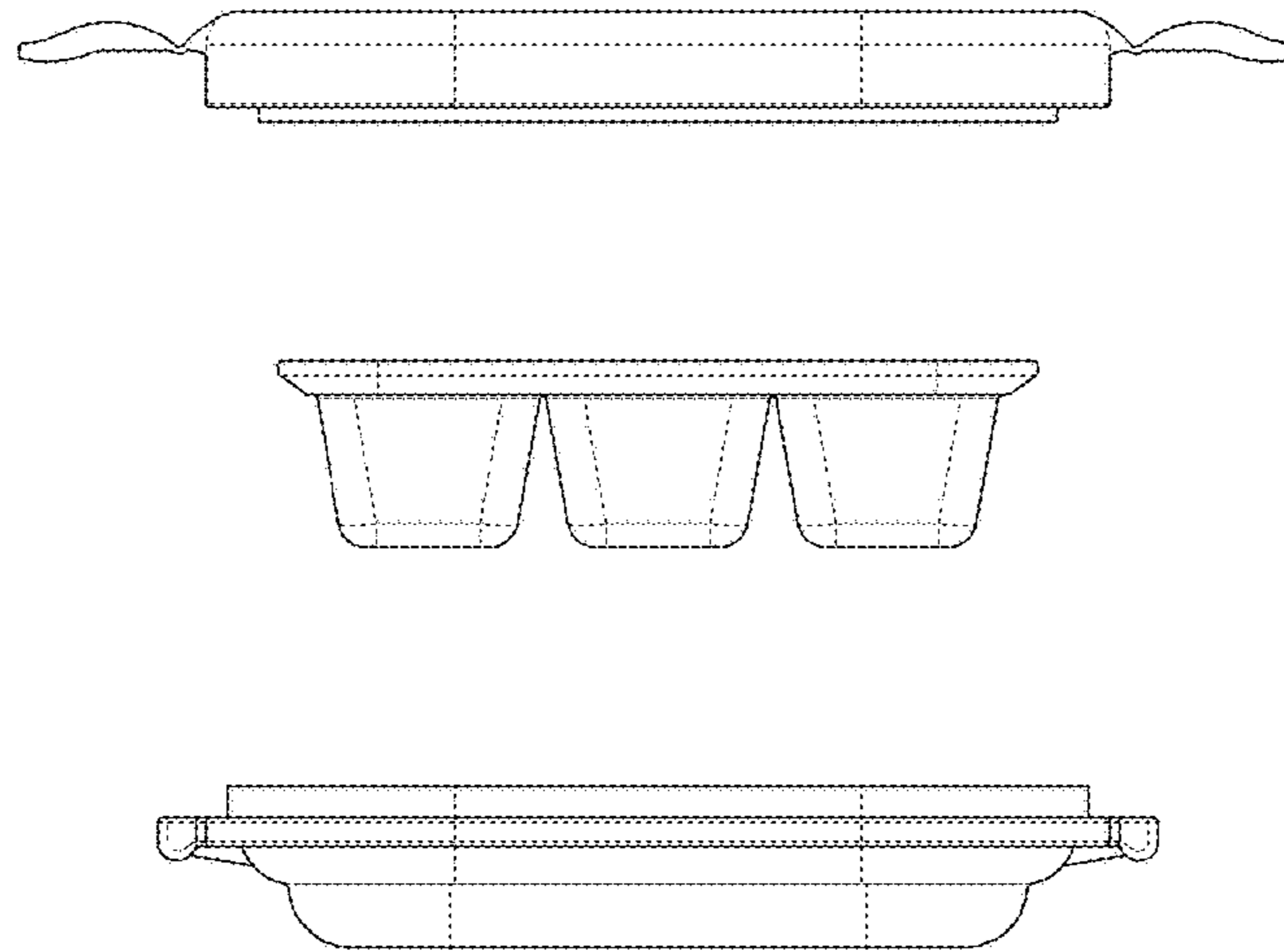

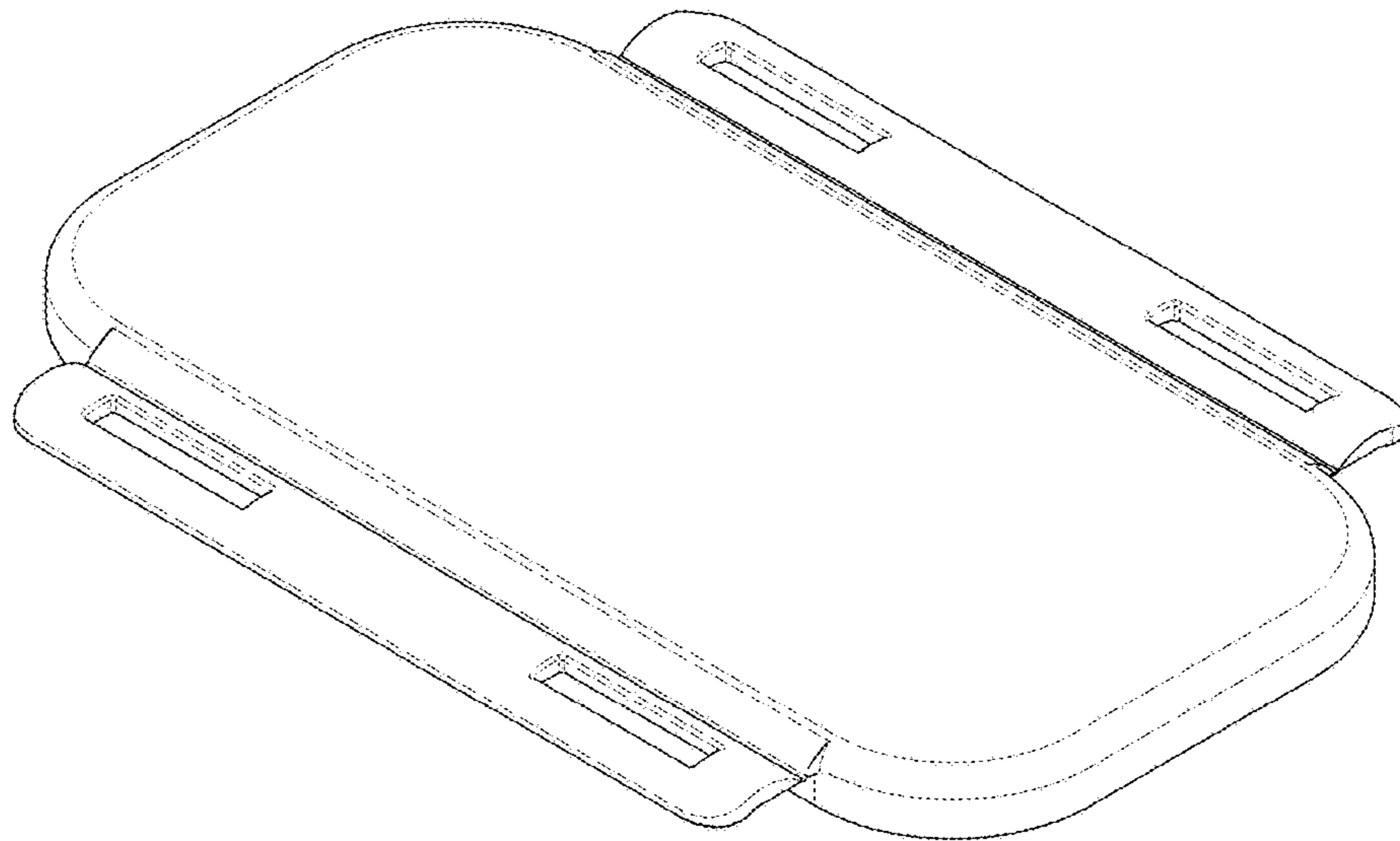

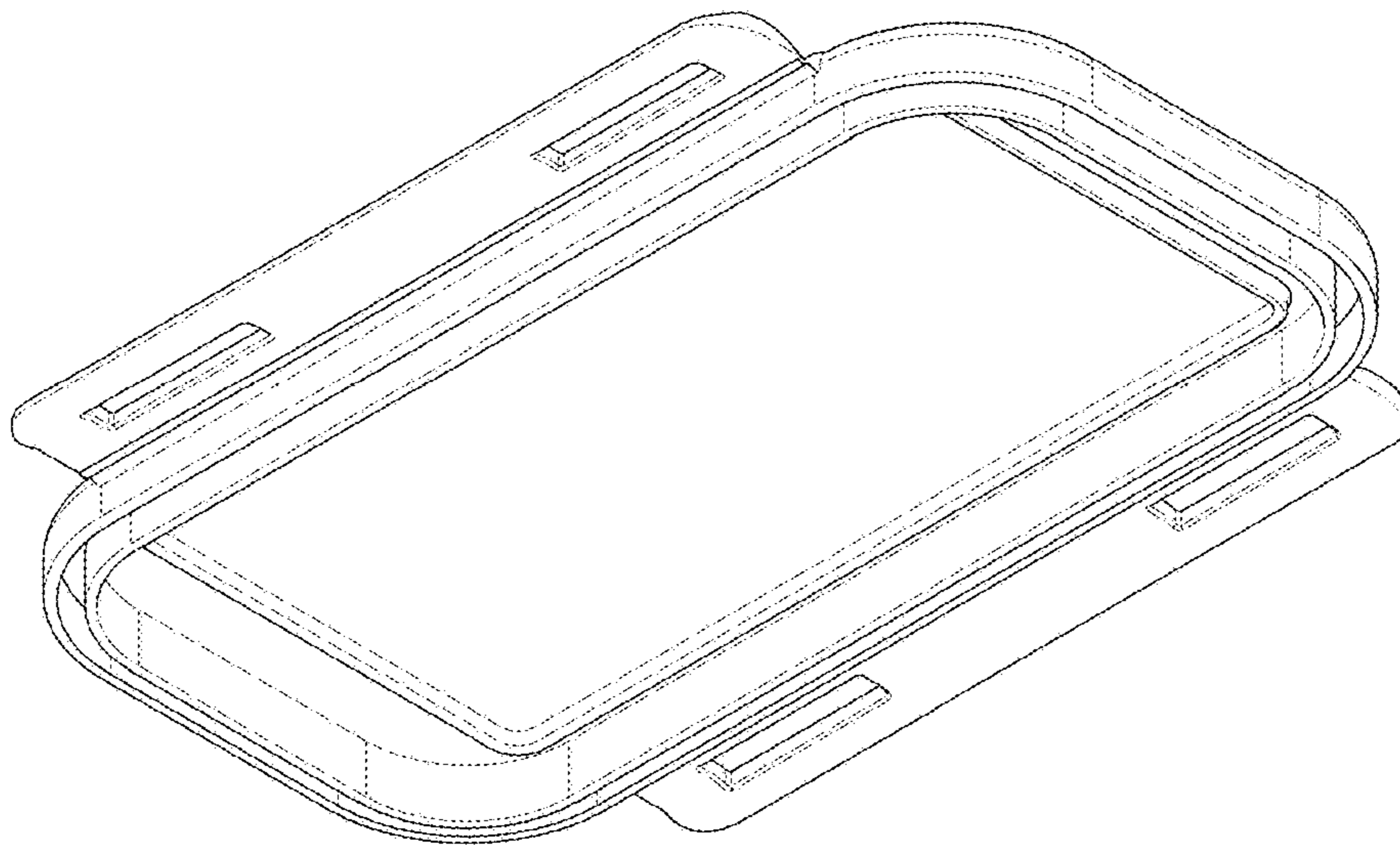

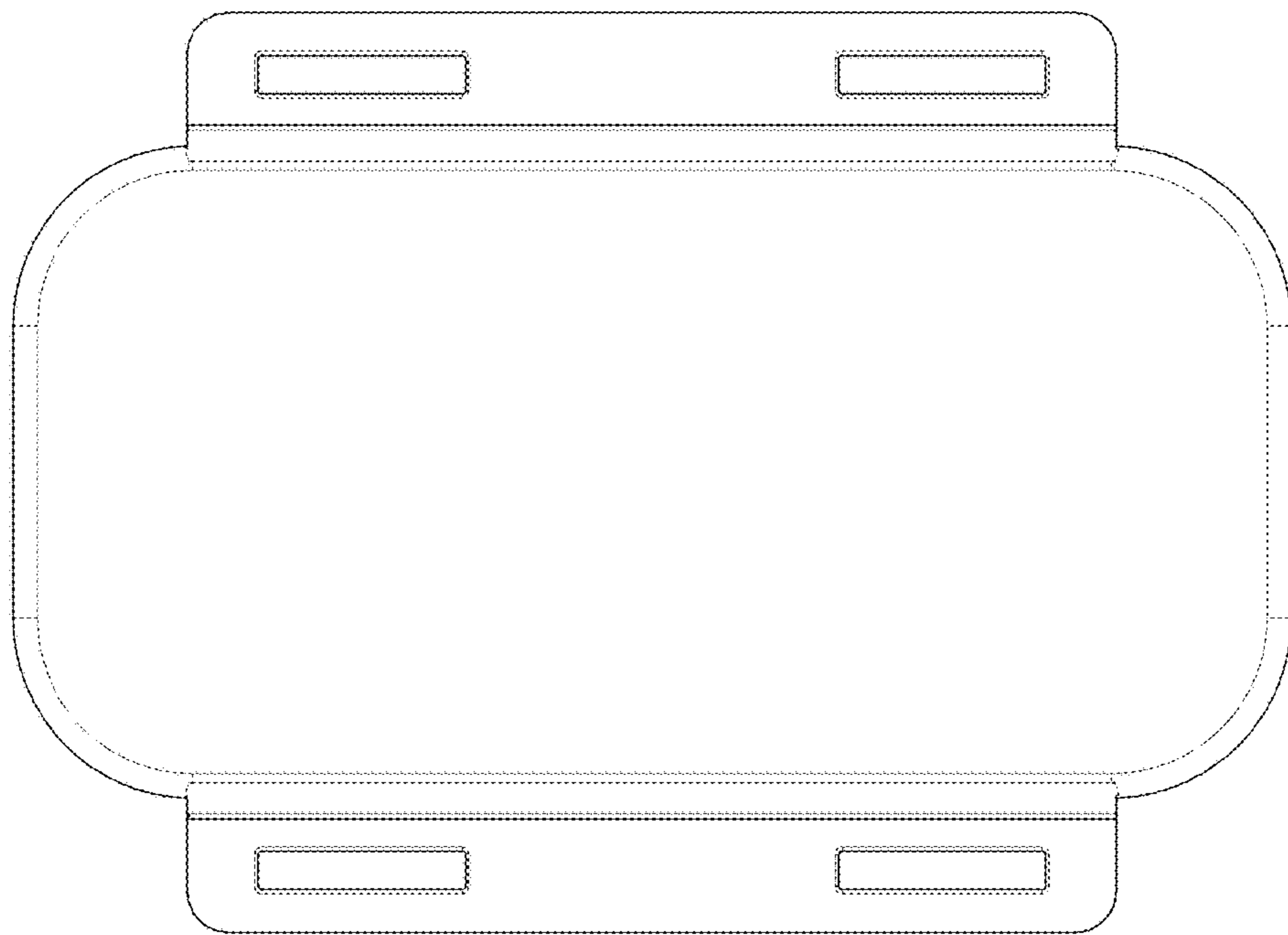

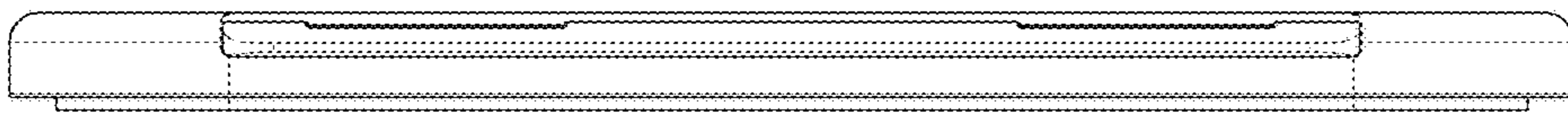

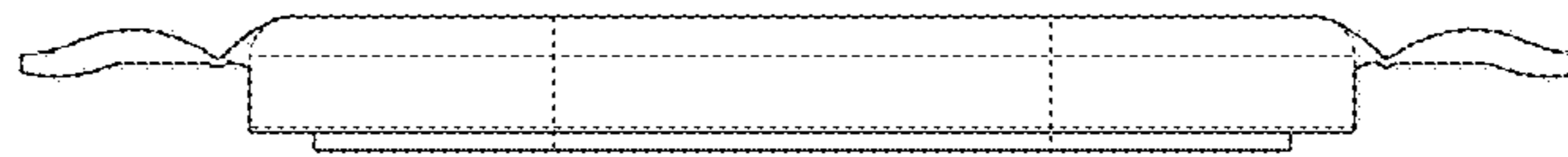

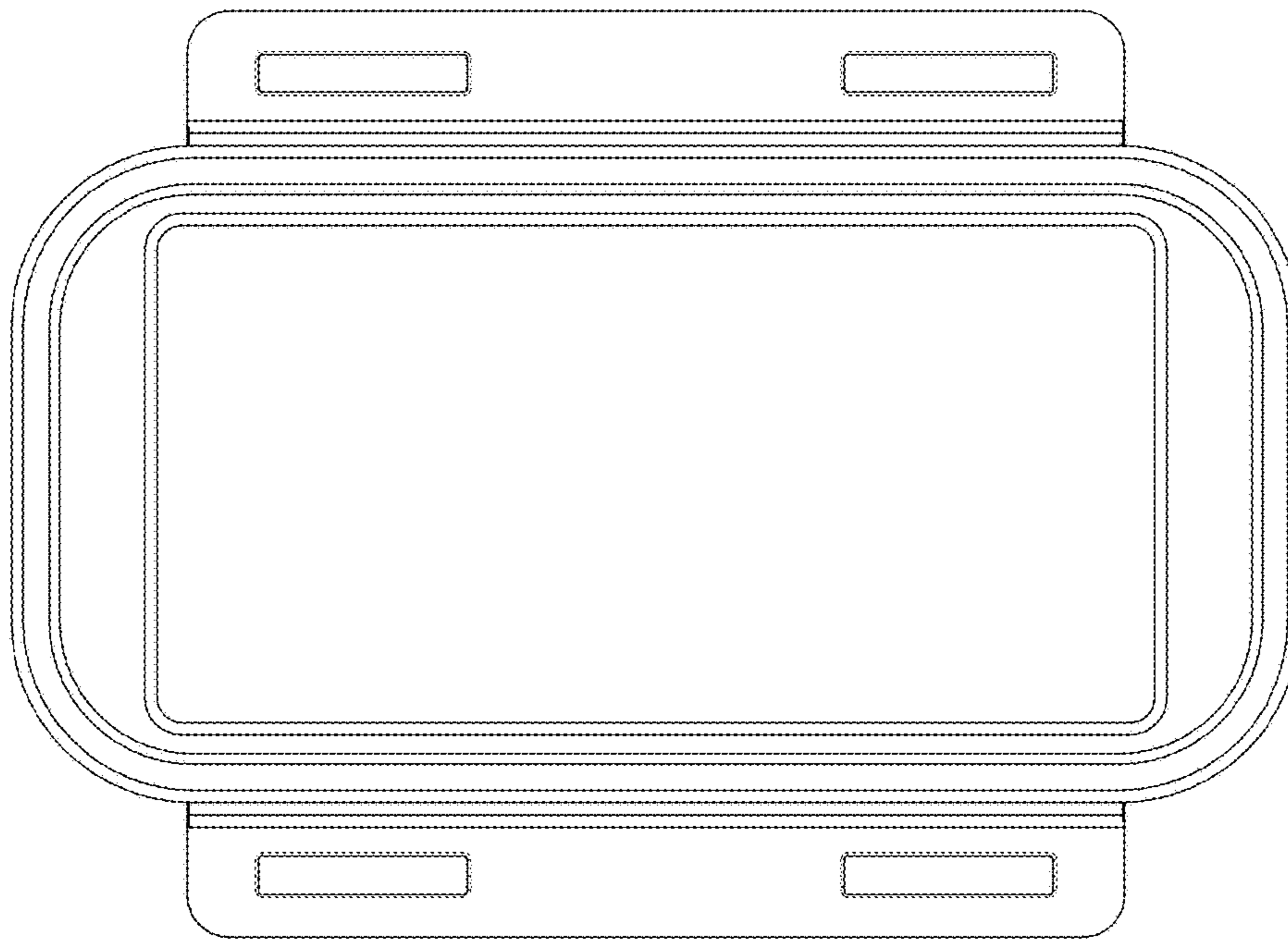

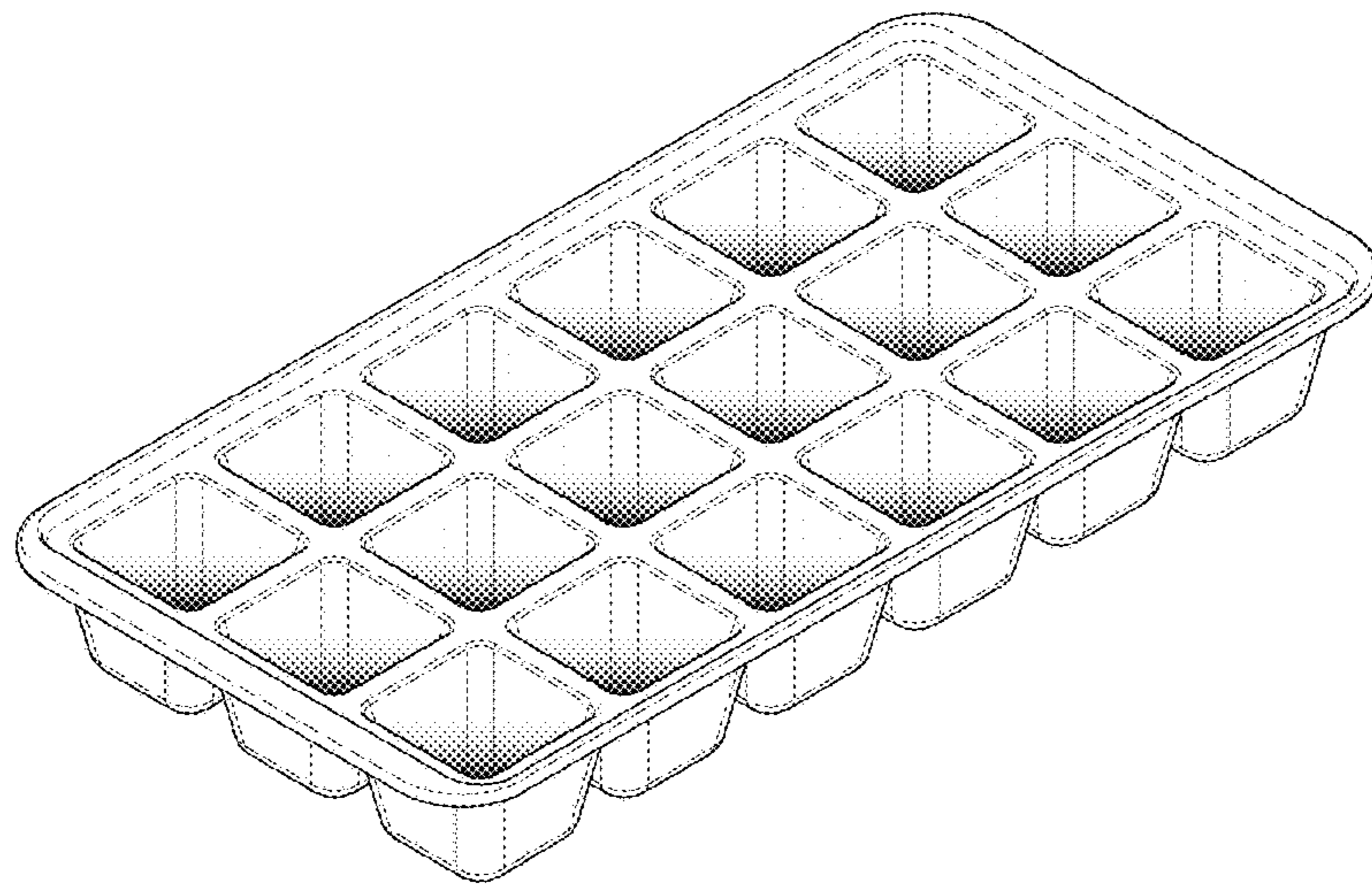

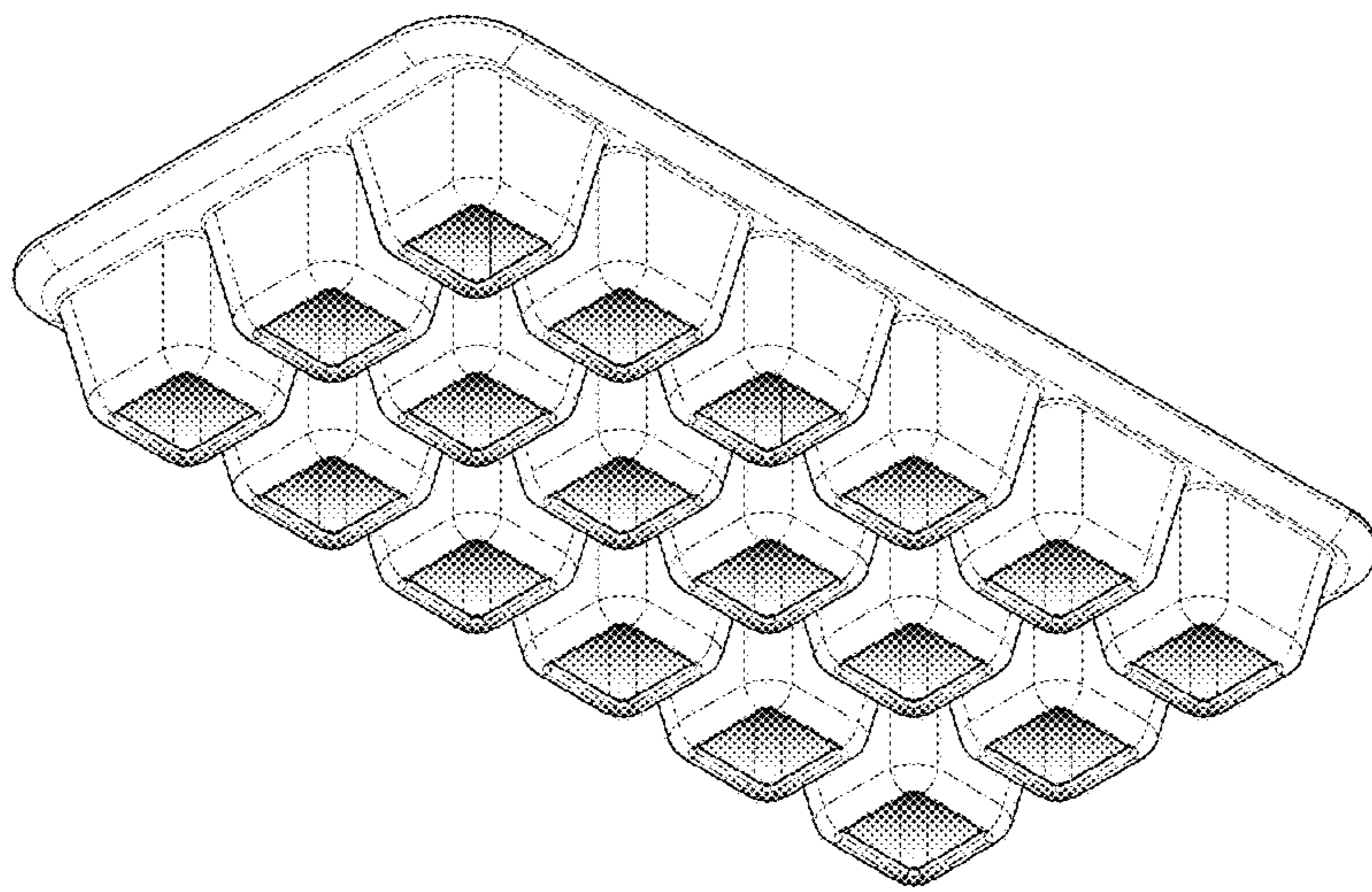

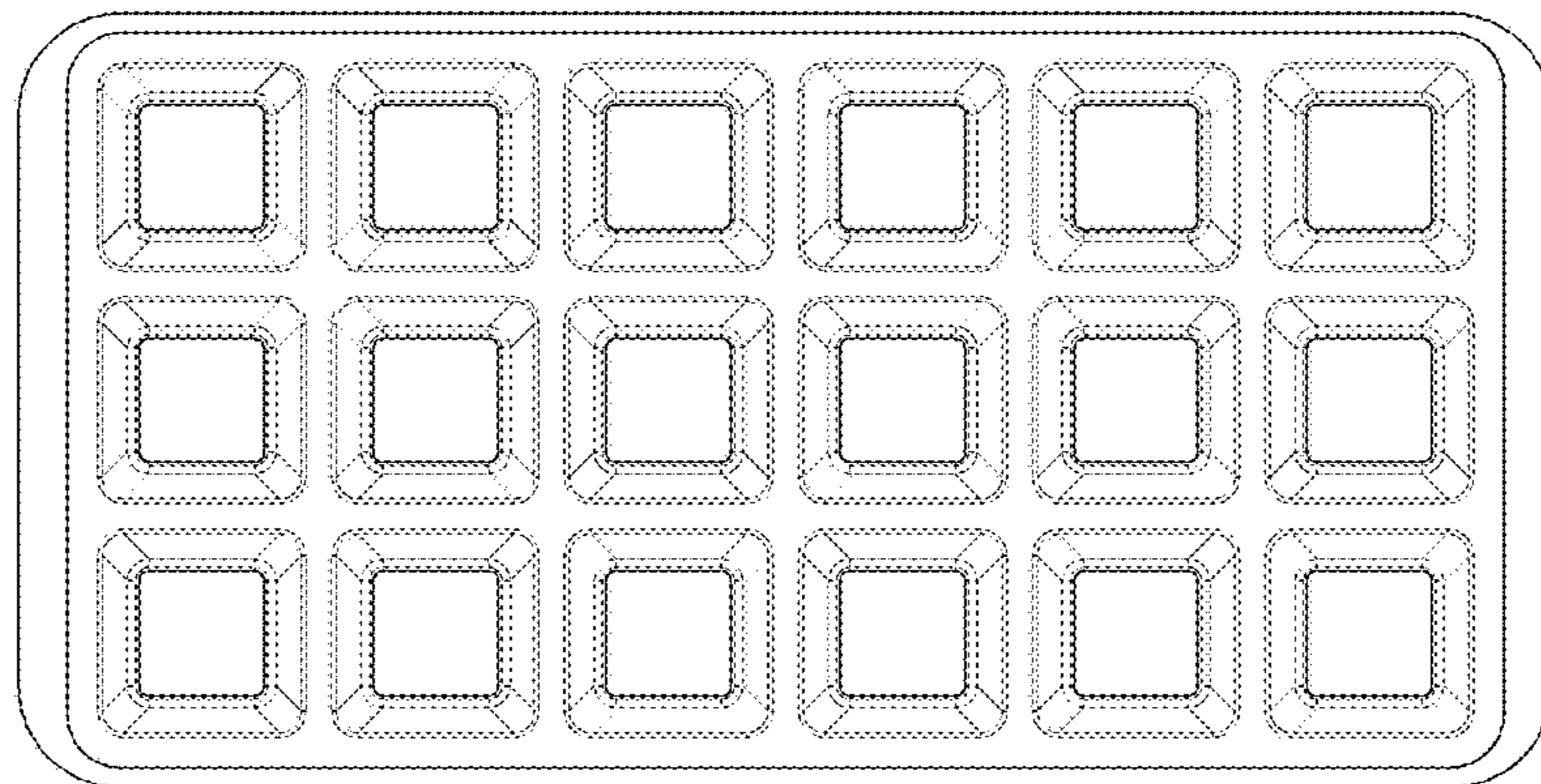

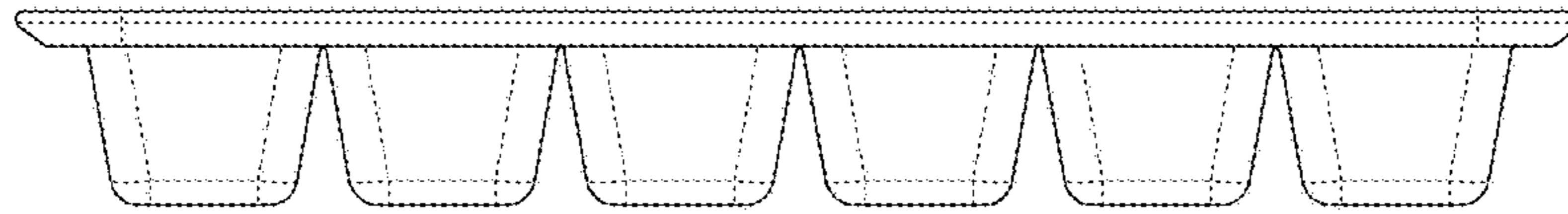

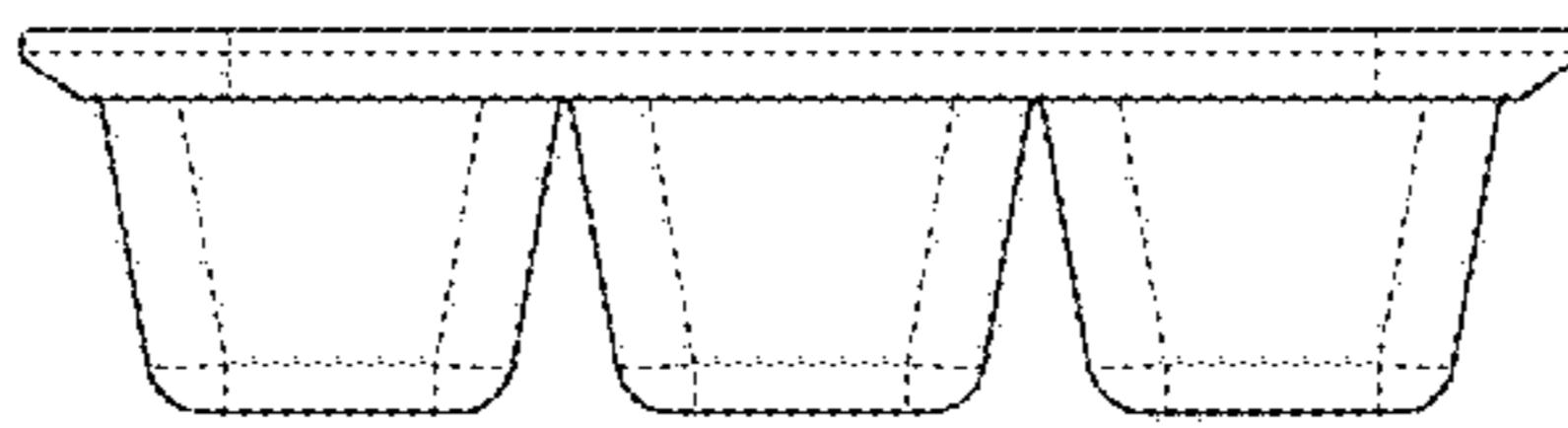

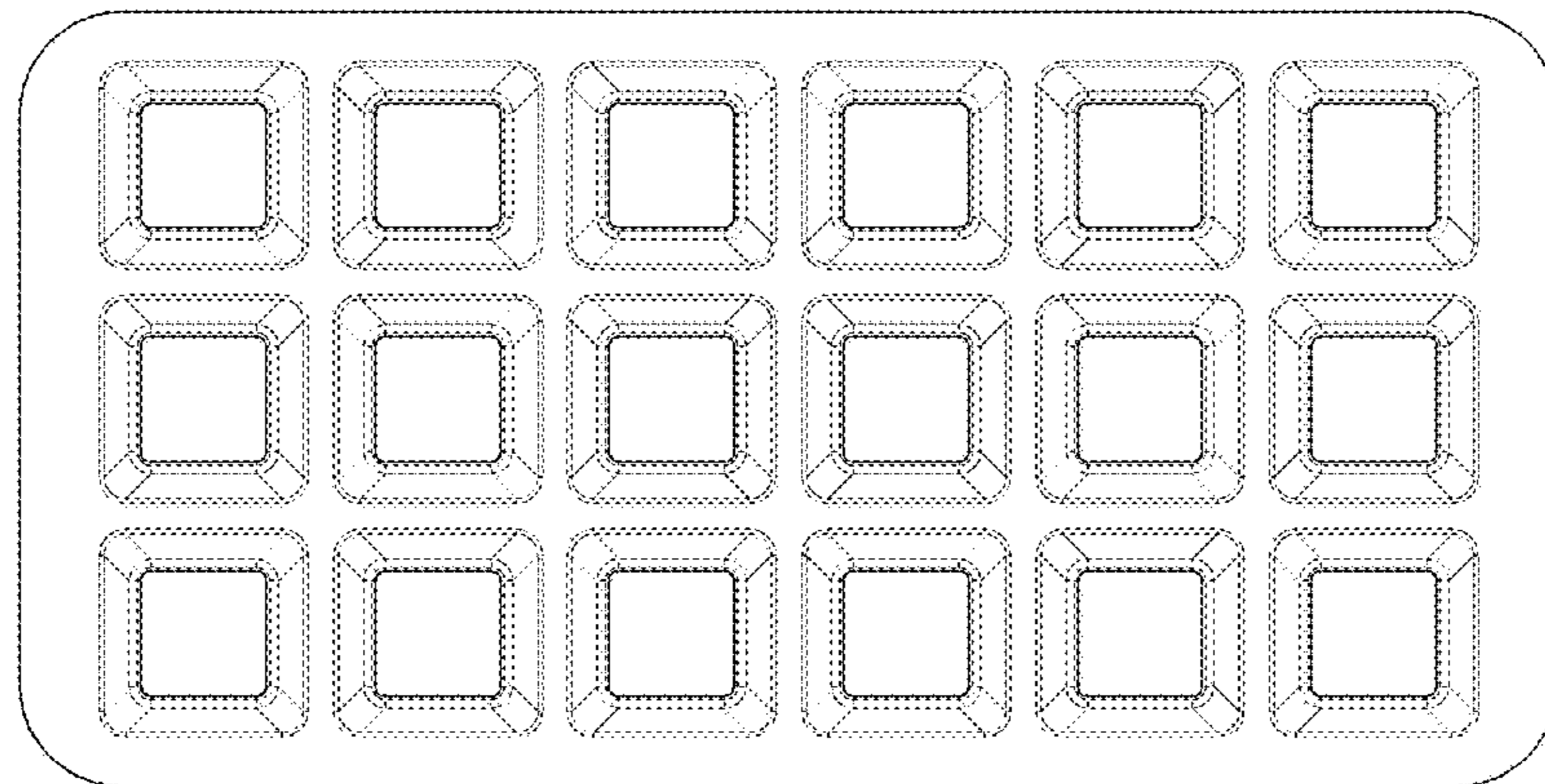

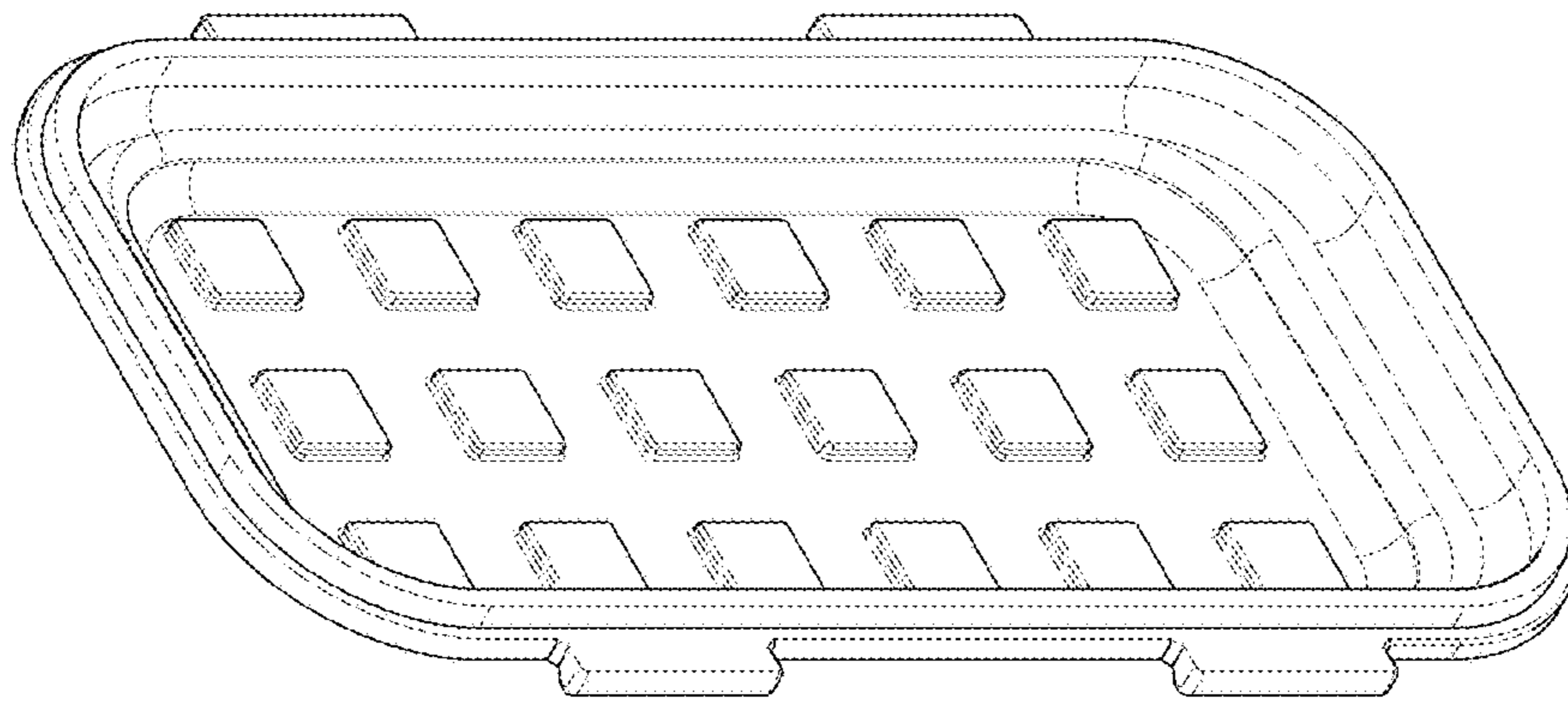

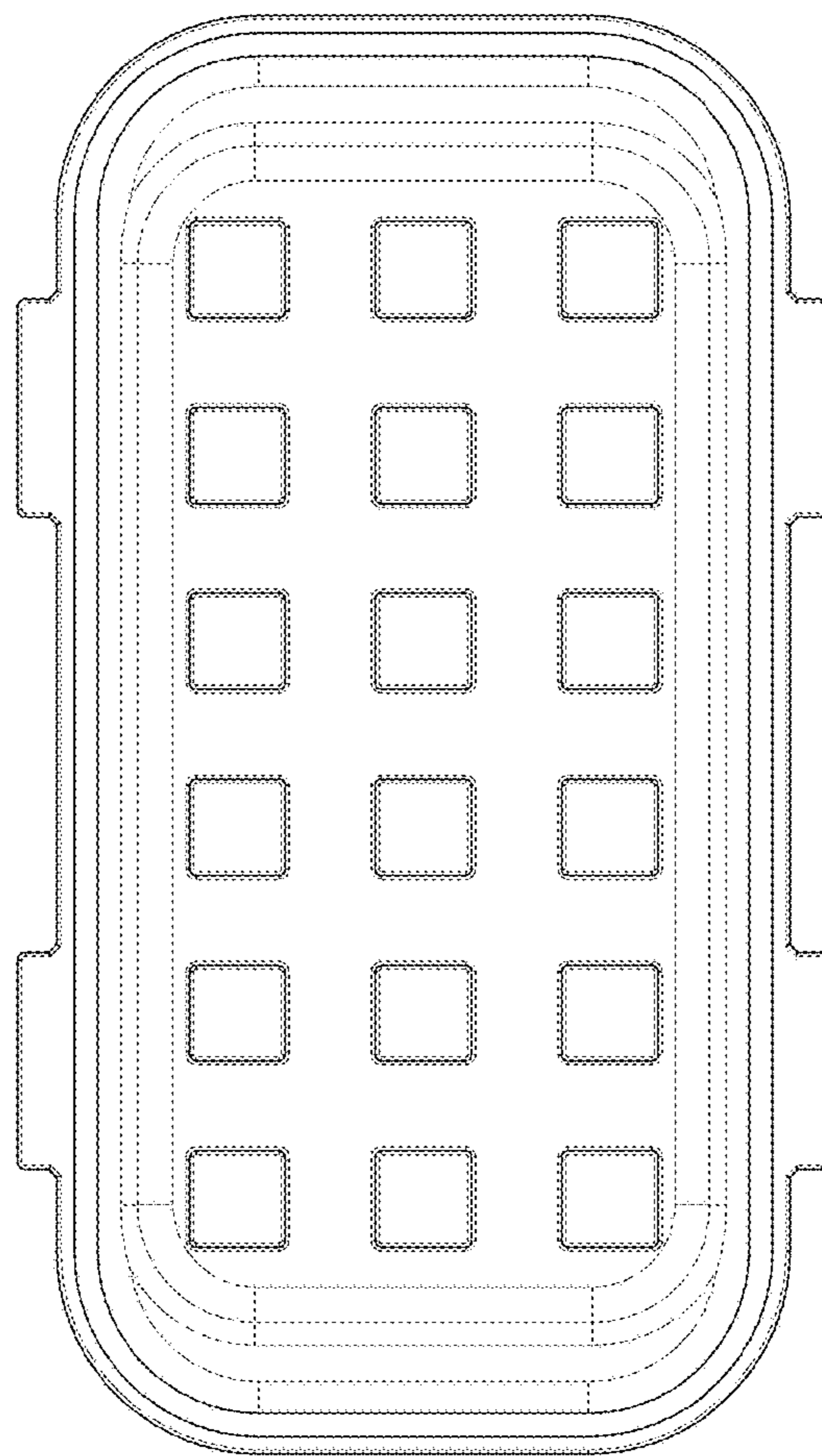

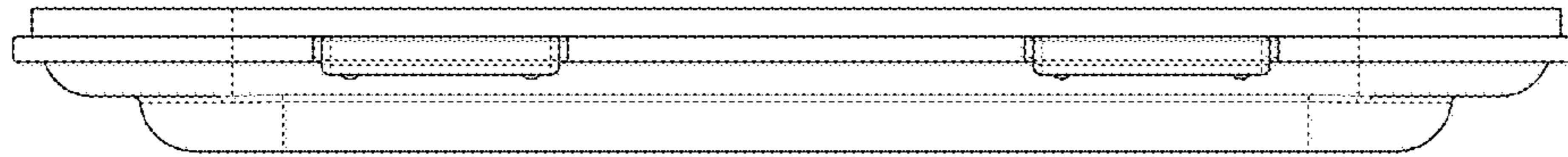

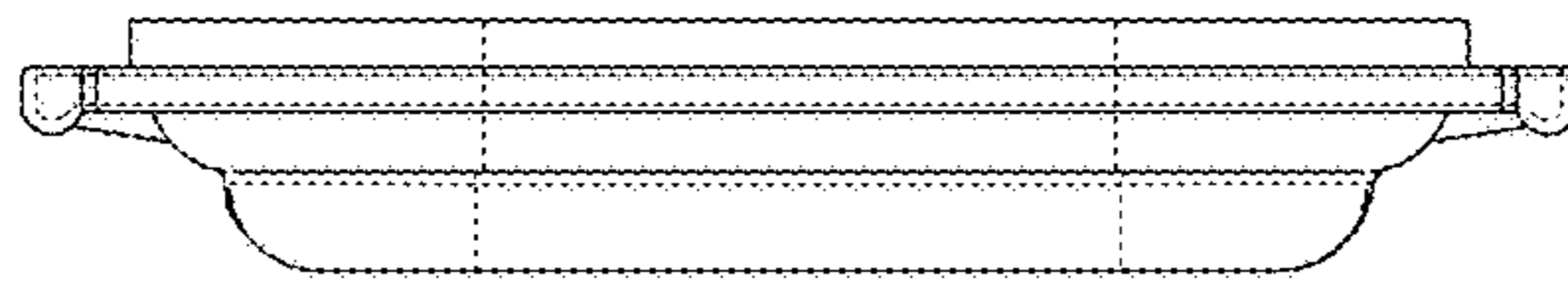

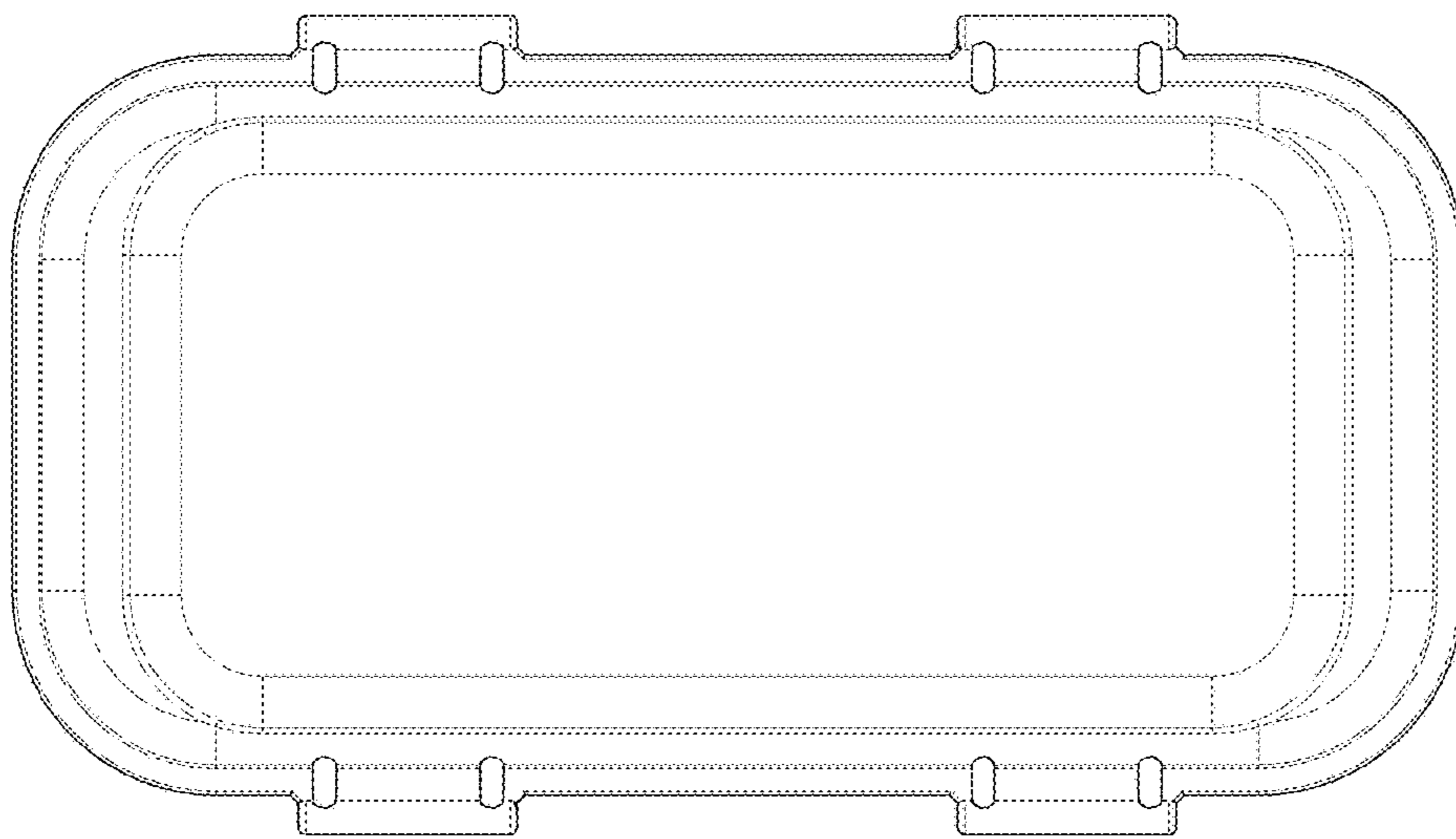
