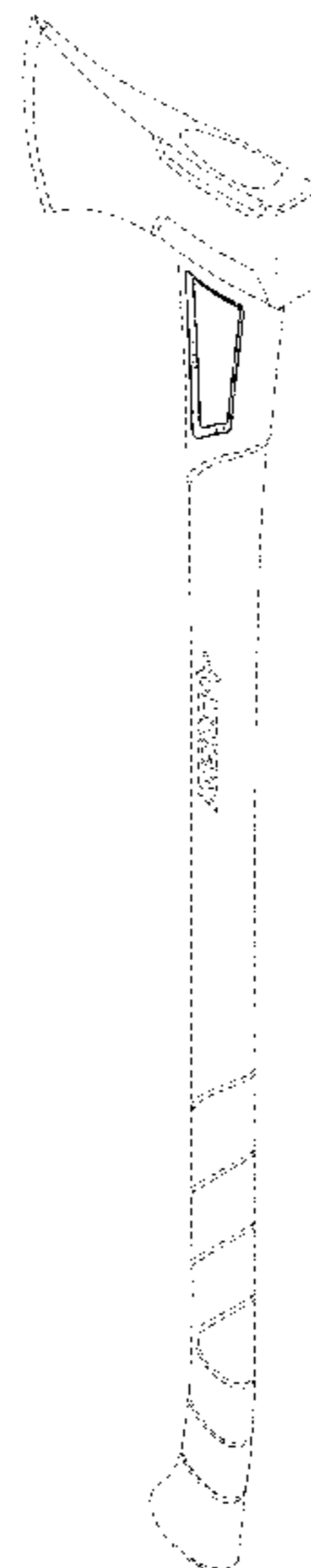
(57) **CLAIM**

The ornamental design for an overstrike for a striking tool,
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an overstrike for a striking tool
embodying my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left view thereof; and,
FIG. 5 is a right view thereof.
The broken lines within the claimed subject matter depict
features of the overstrike for a striking tool that form no part
of the claim. The remaining broken lines represent environ-
mental subject matter that also forms no part of the claim.

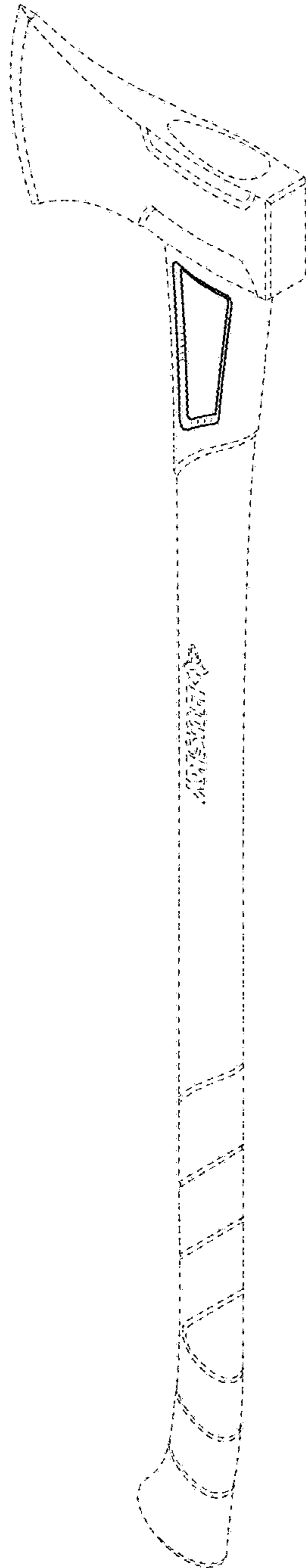

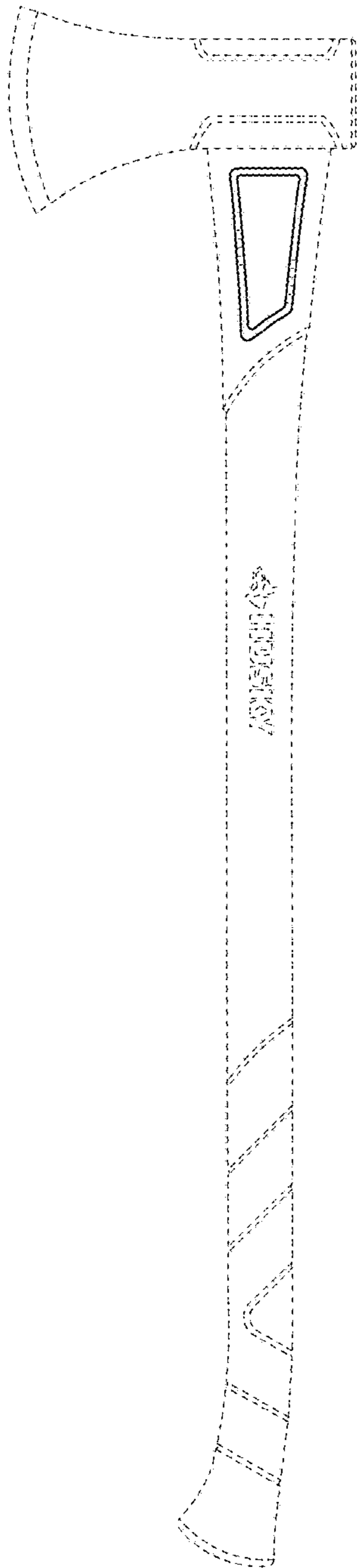

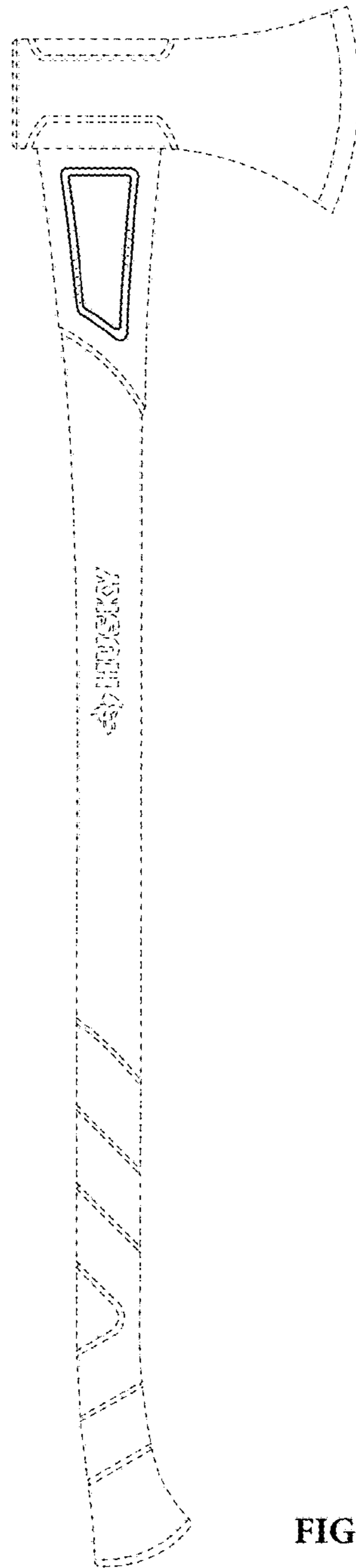

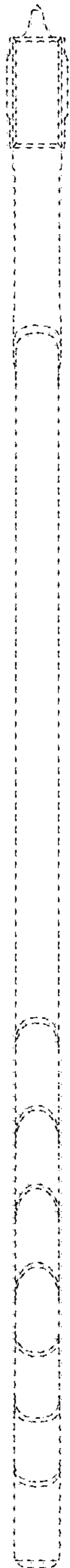

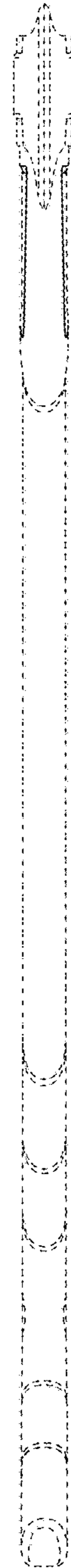
