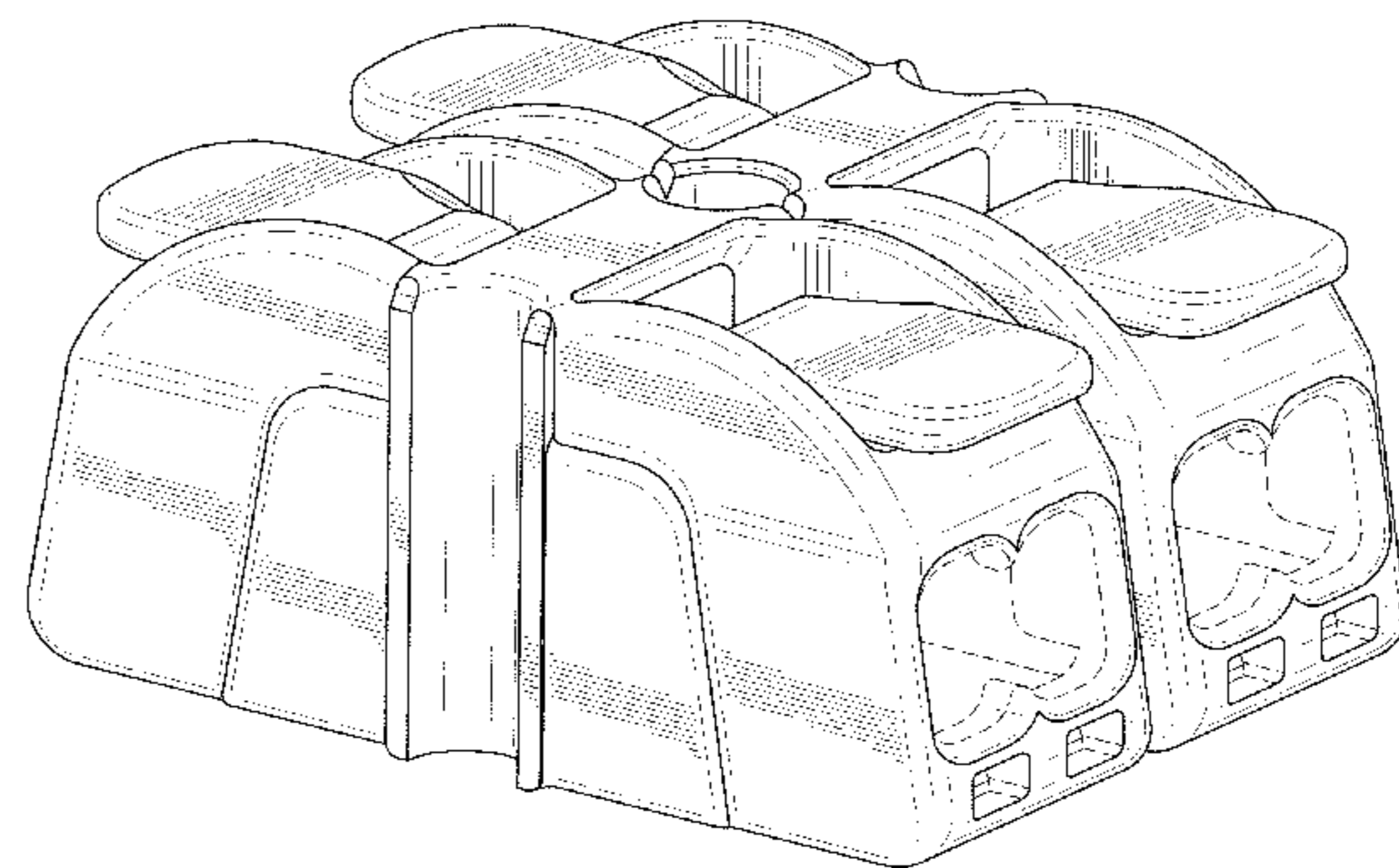
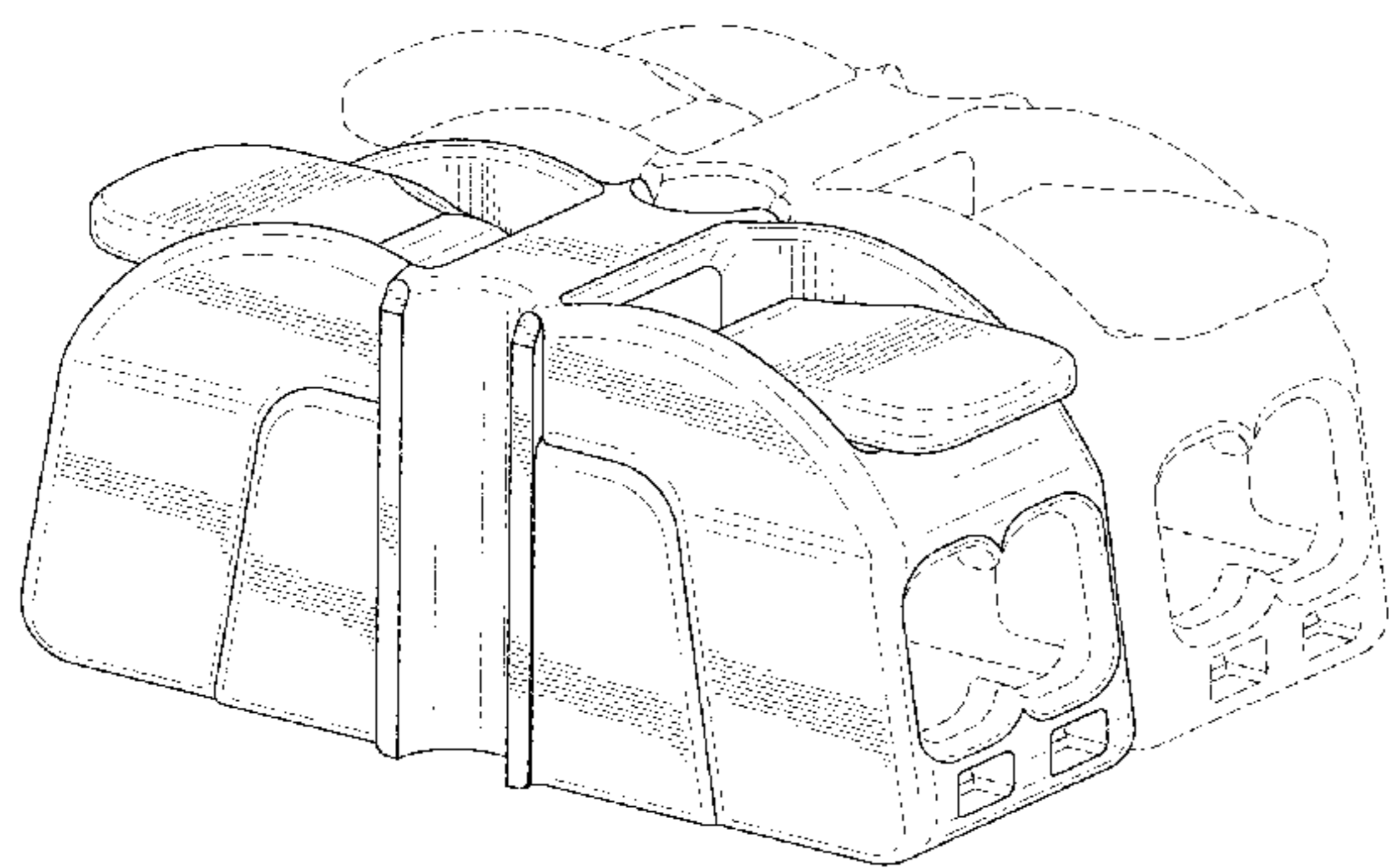
(57) **CLAIM**

The ornamental design for a cable connector, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of a cable connector showing our new invention; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and FIG. 7 is a bottom plan view thereof. FIG. 8 is a front perspective view of a second embodiment of a cable connector showing our new invention; FIG. 9 is a front elevation view thereof; FIG. 10 is a rear elevation view thereof; FIG. 11 is a left side elevation view thereof; FIG. 12 is a right side elevation view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof. The dashed lines illustrate environment that does not form a part of the present invention, and no claim is made to the material illustrated with dashed lines.

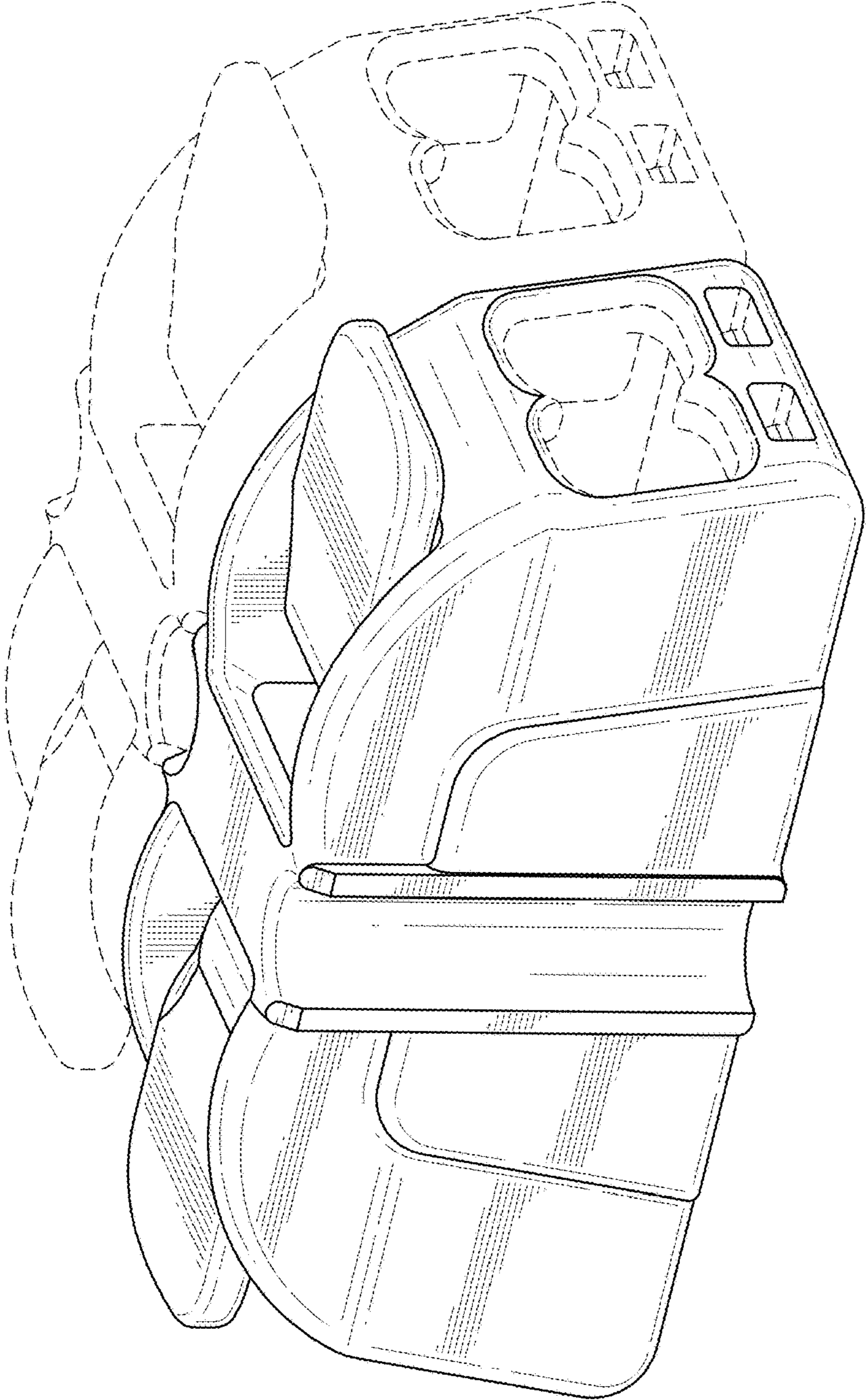

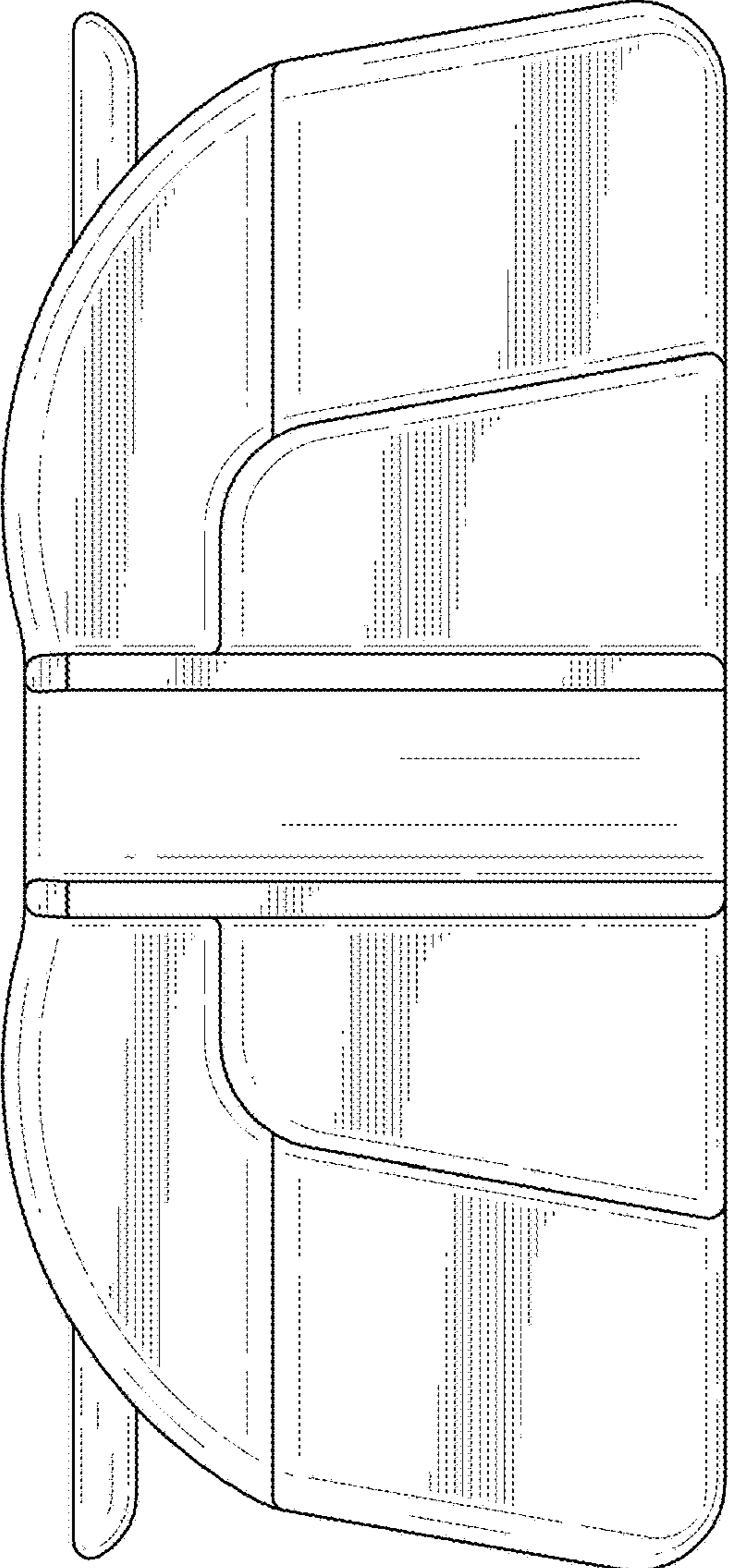

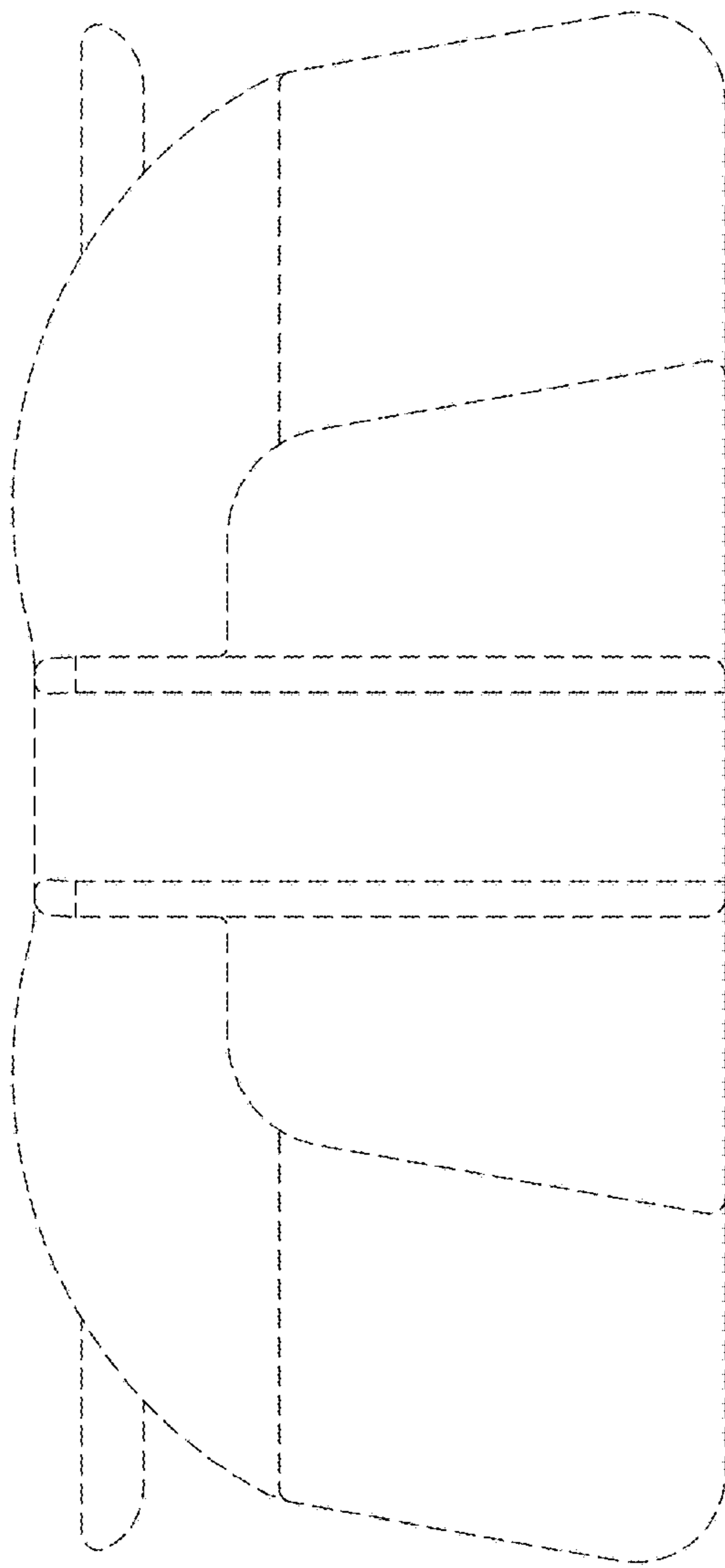

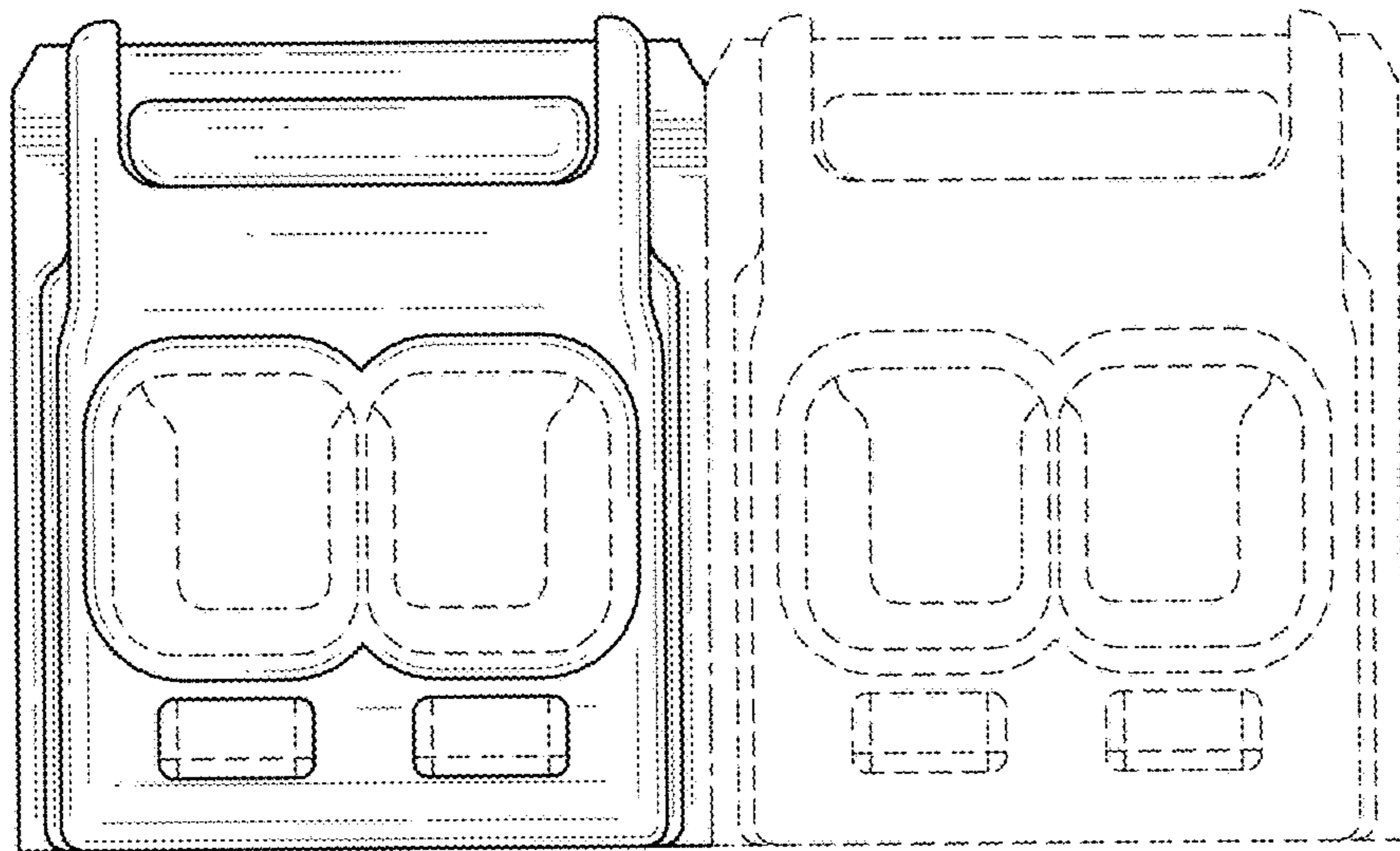

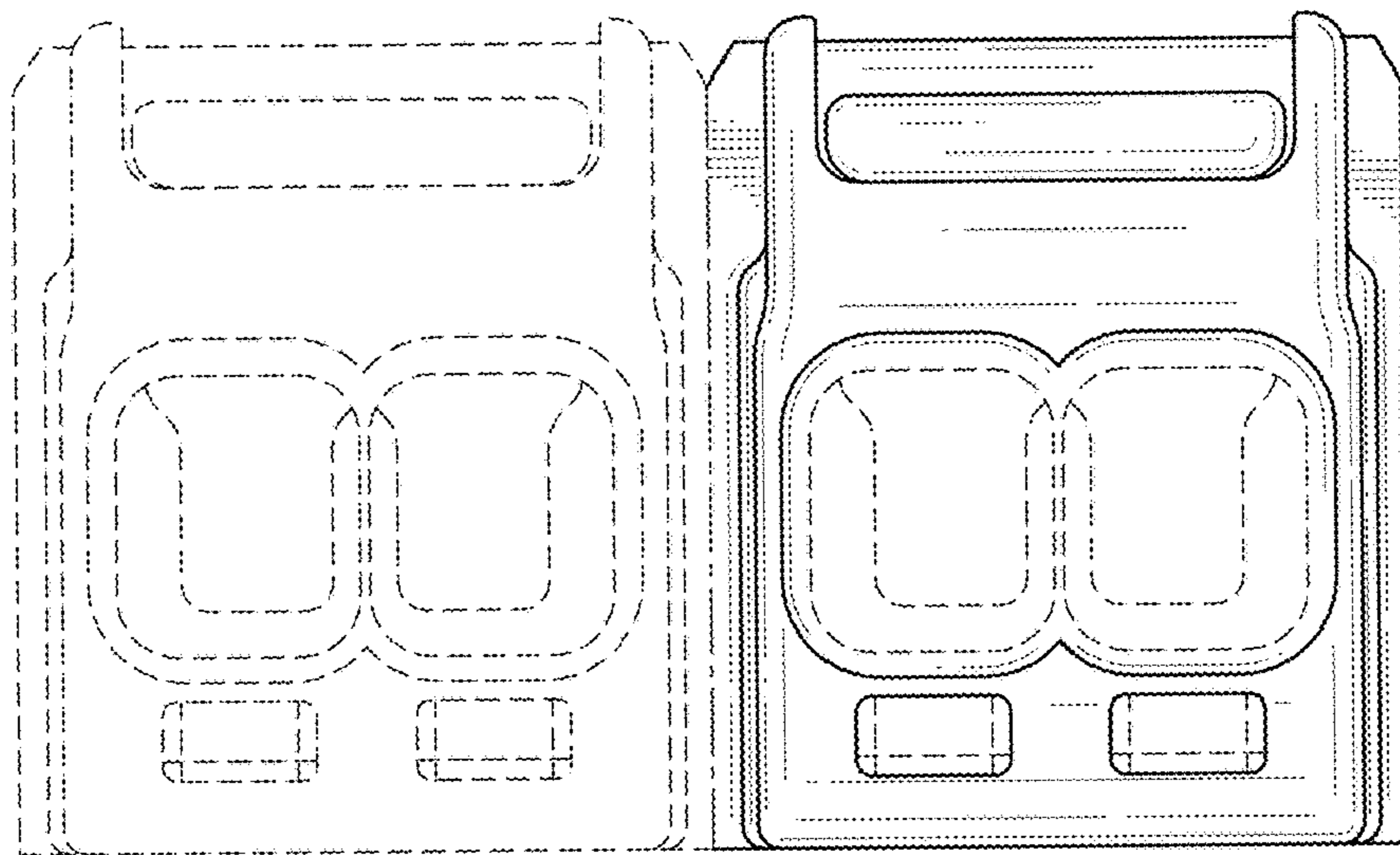

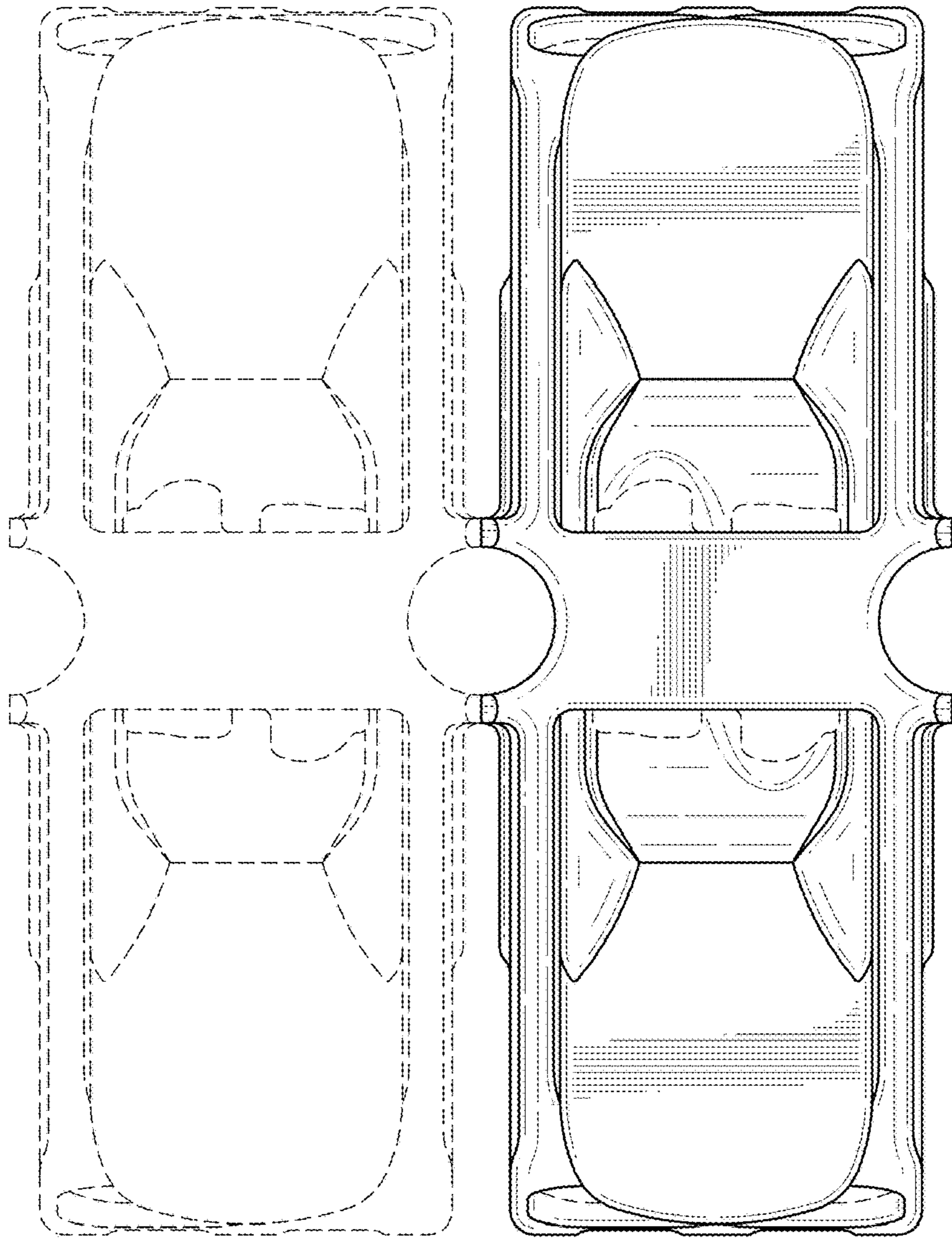

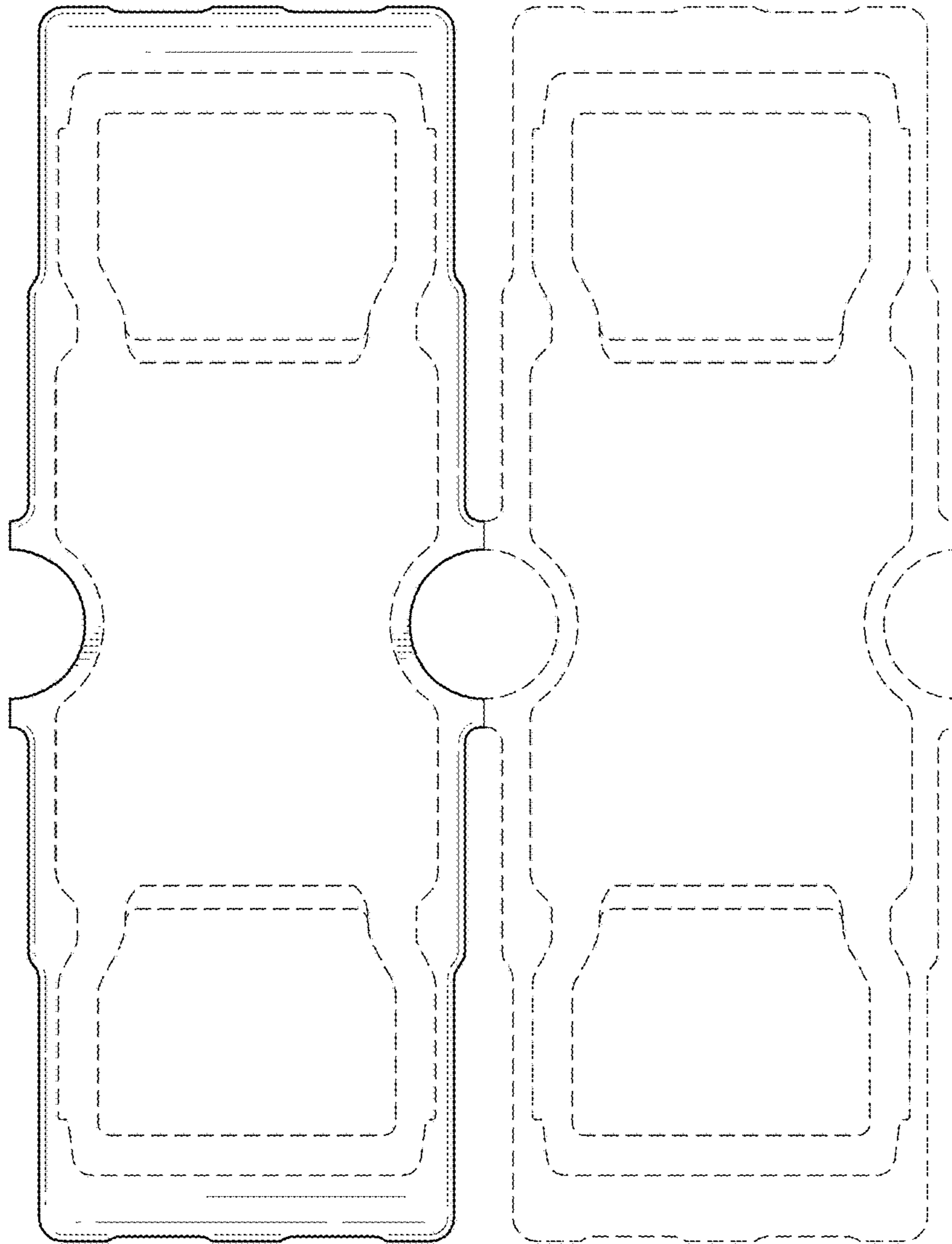

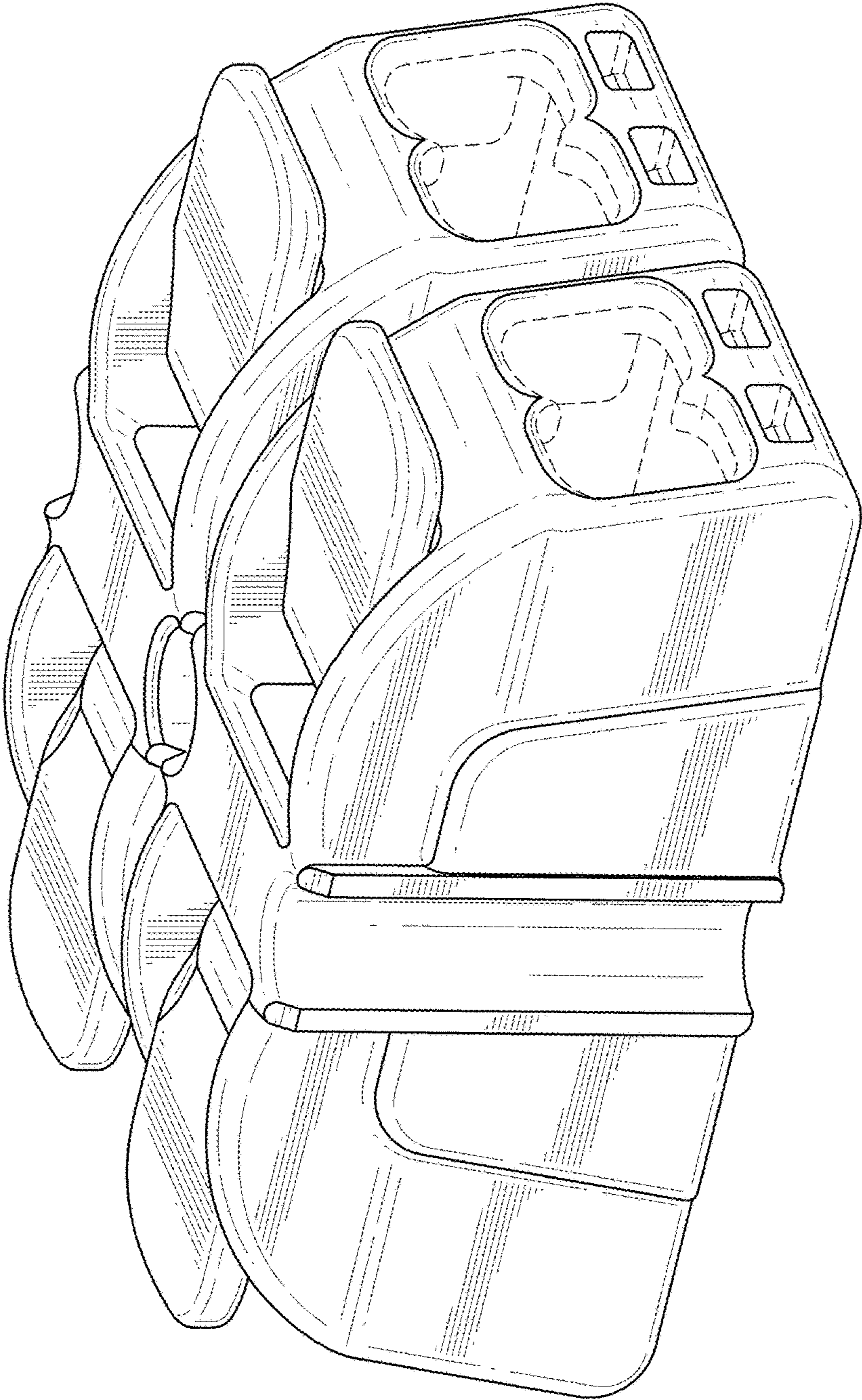

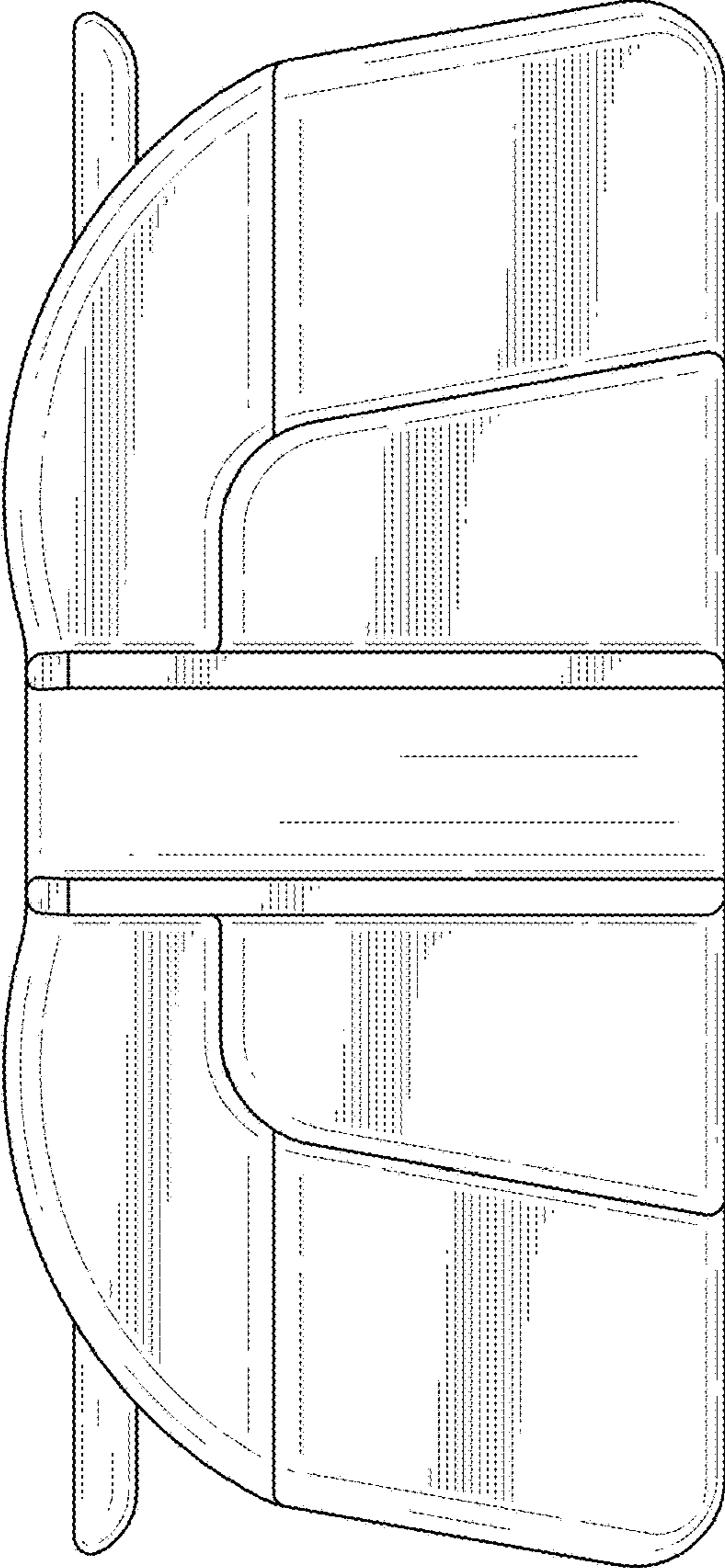

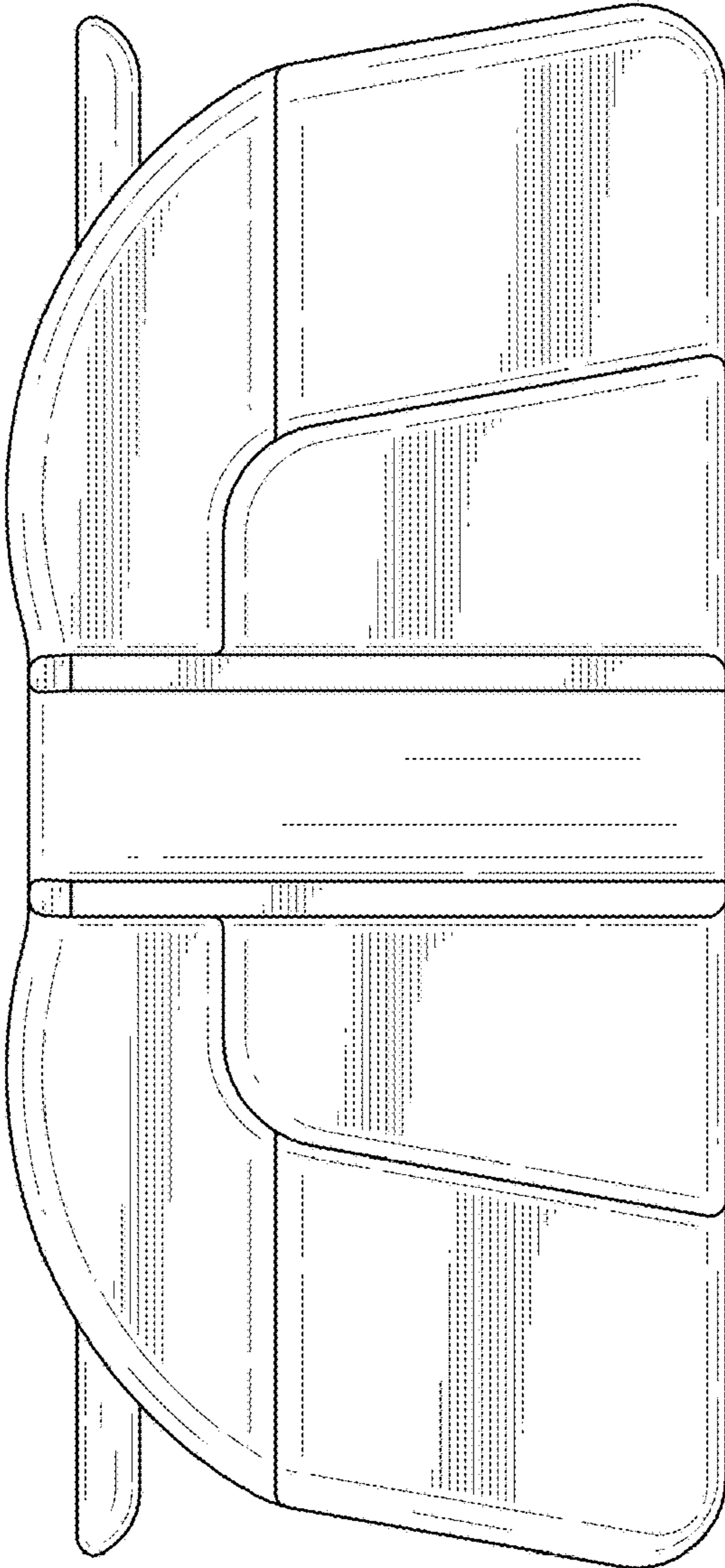

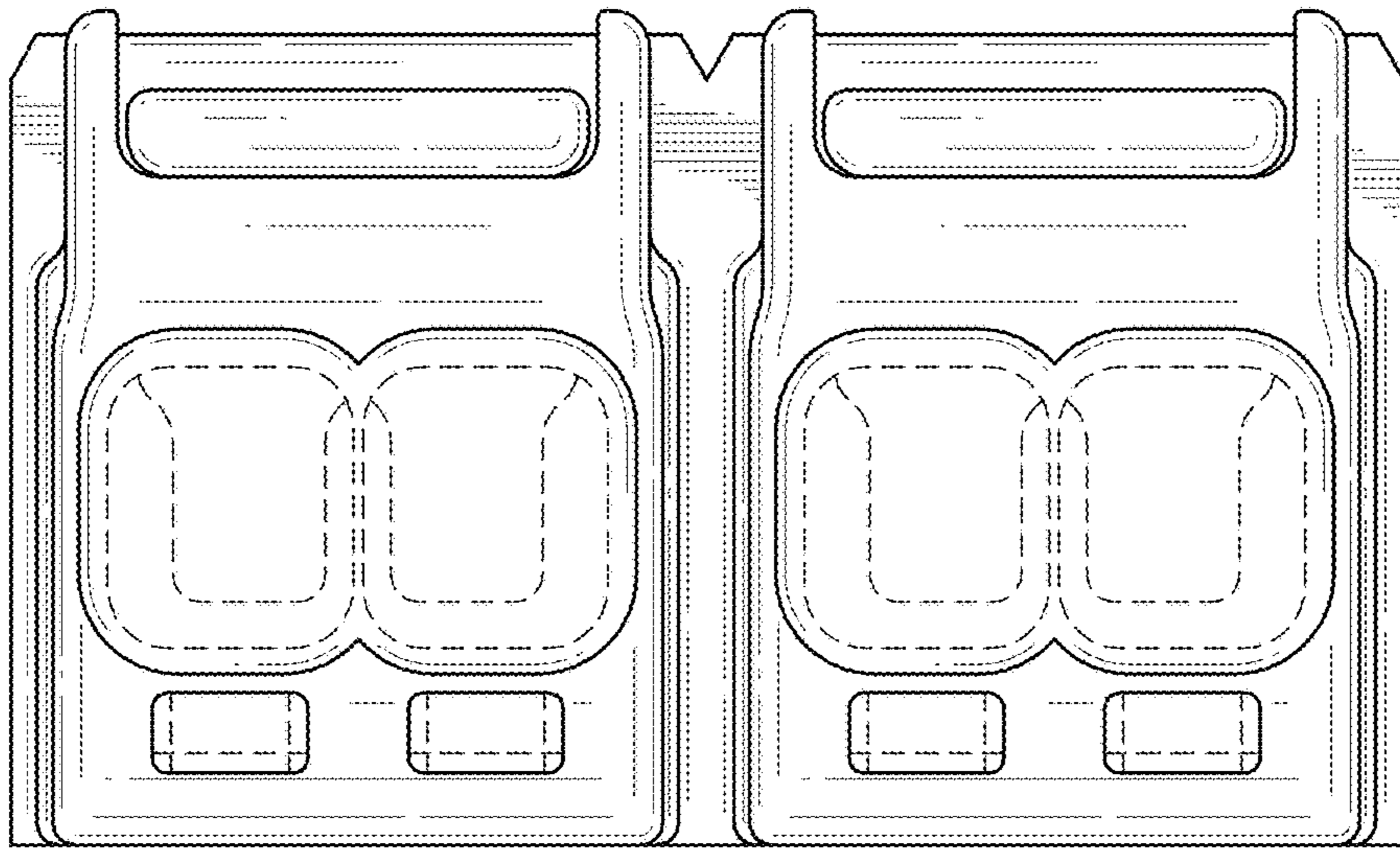

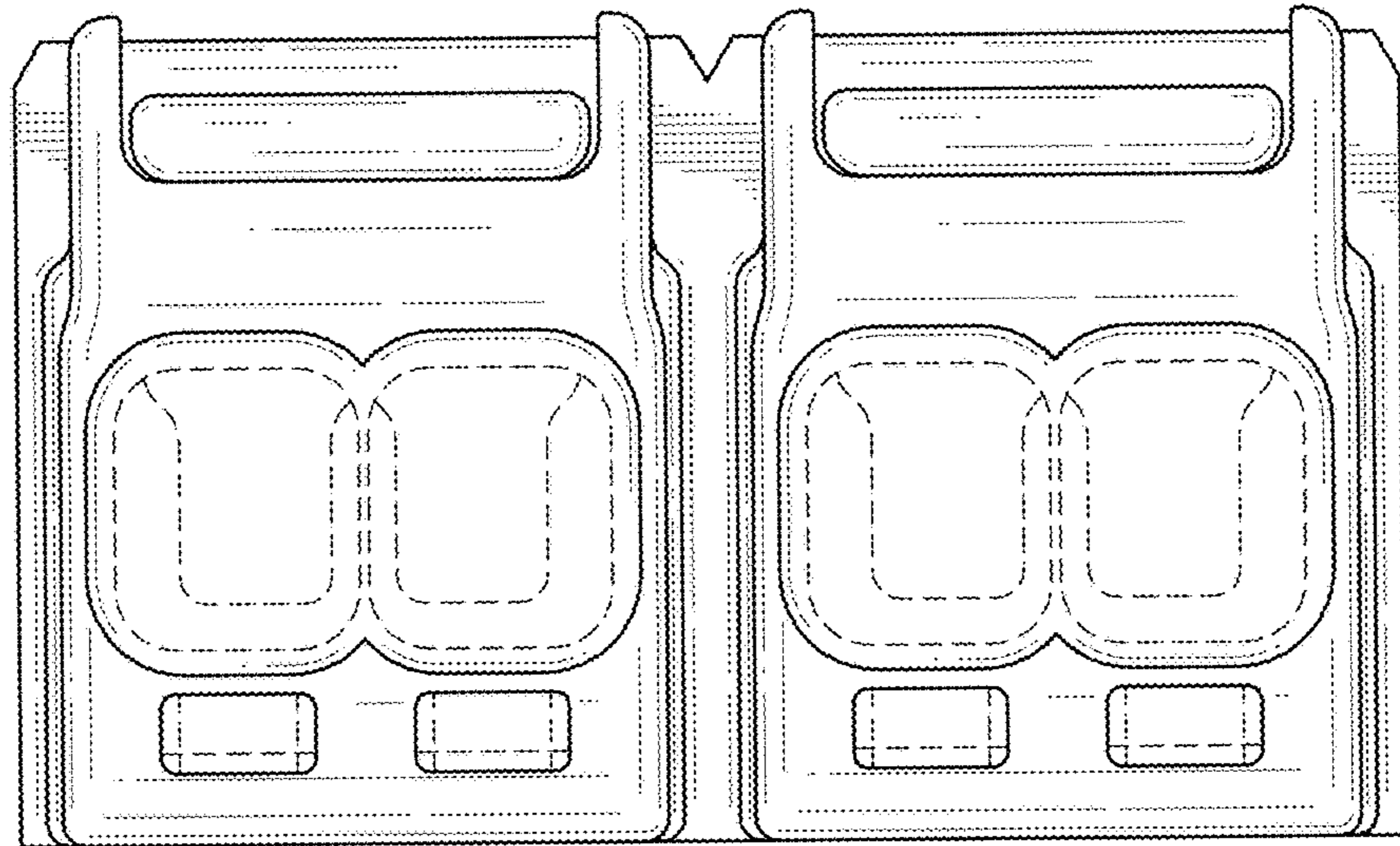

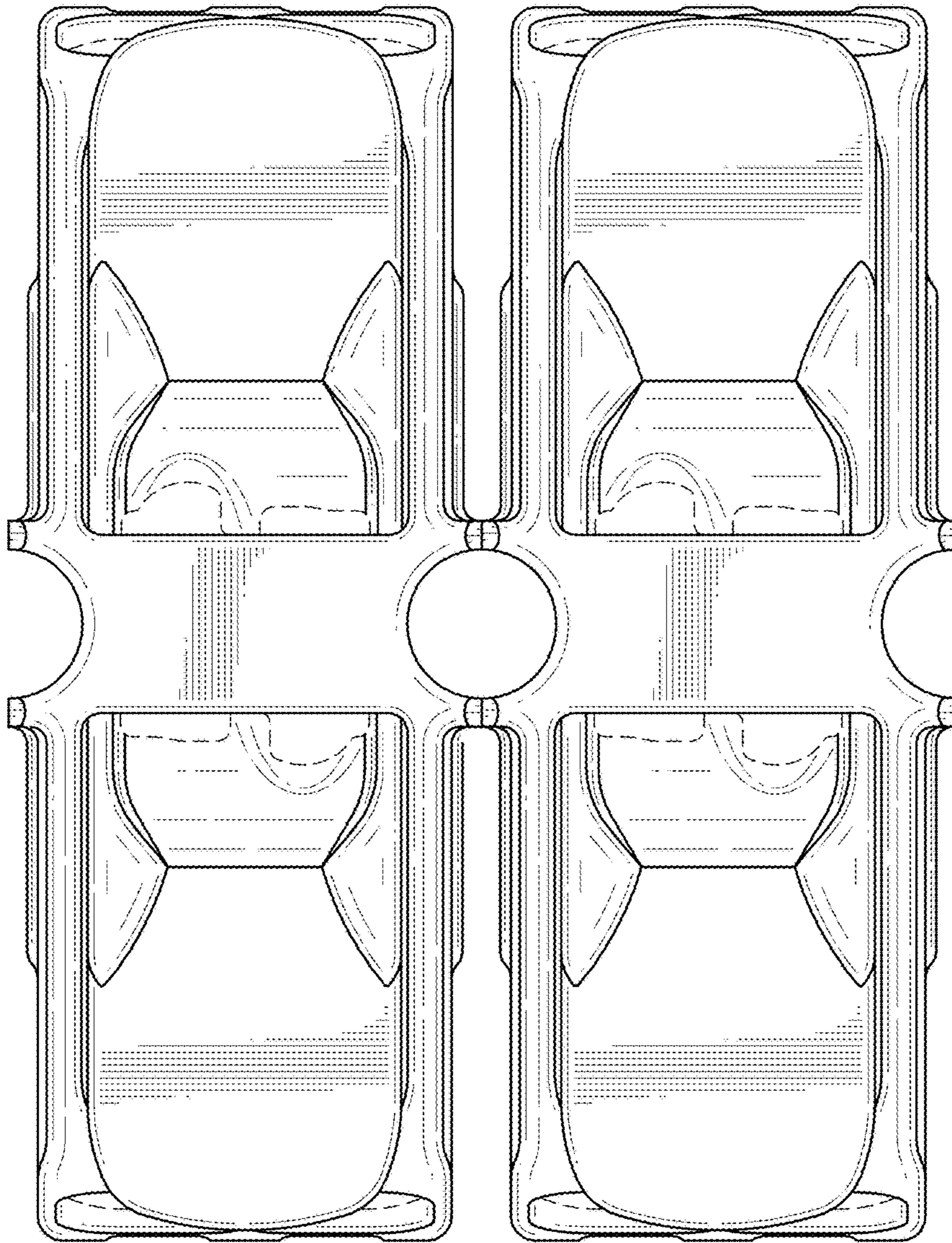

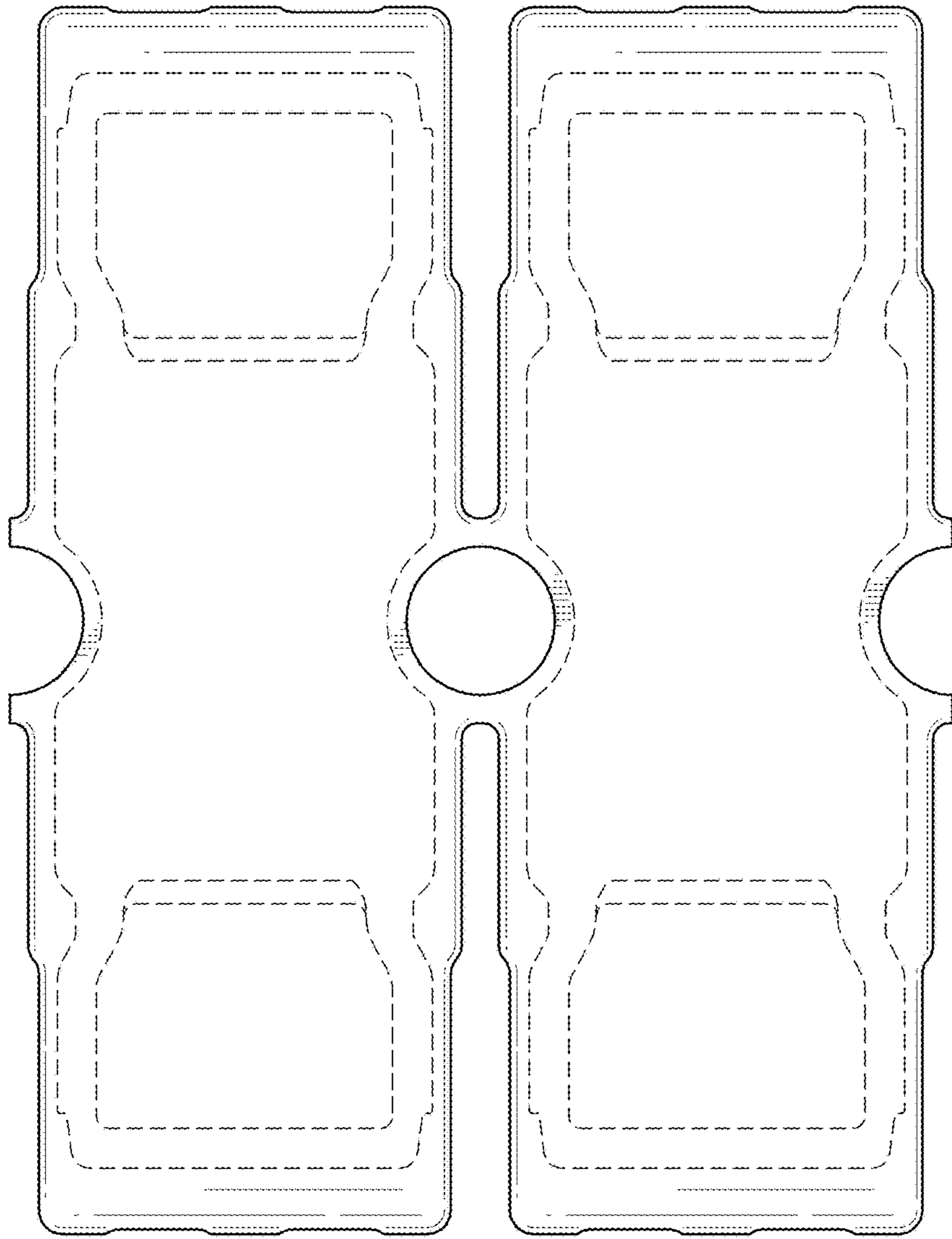
