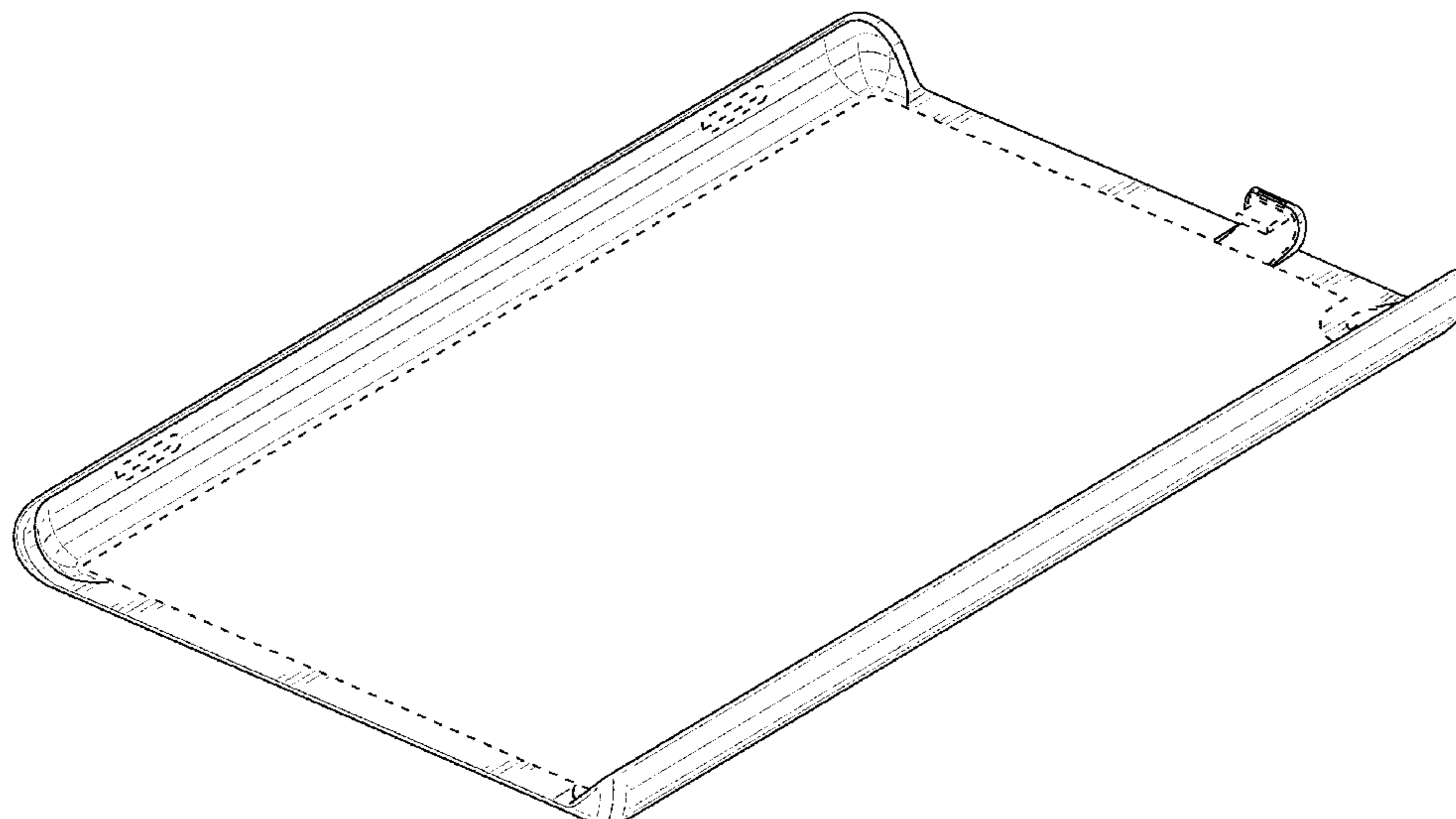
(57) **CLAIM**

The ornamental design for a device cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of a device cover;

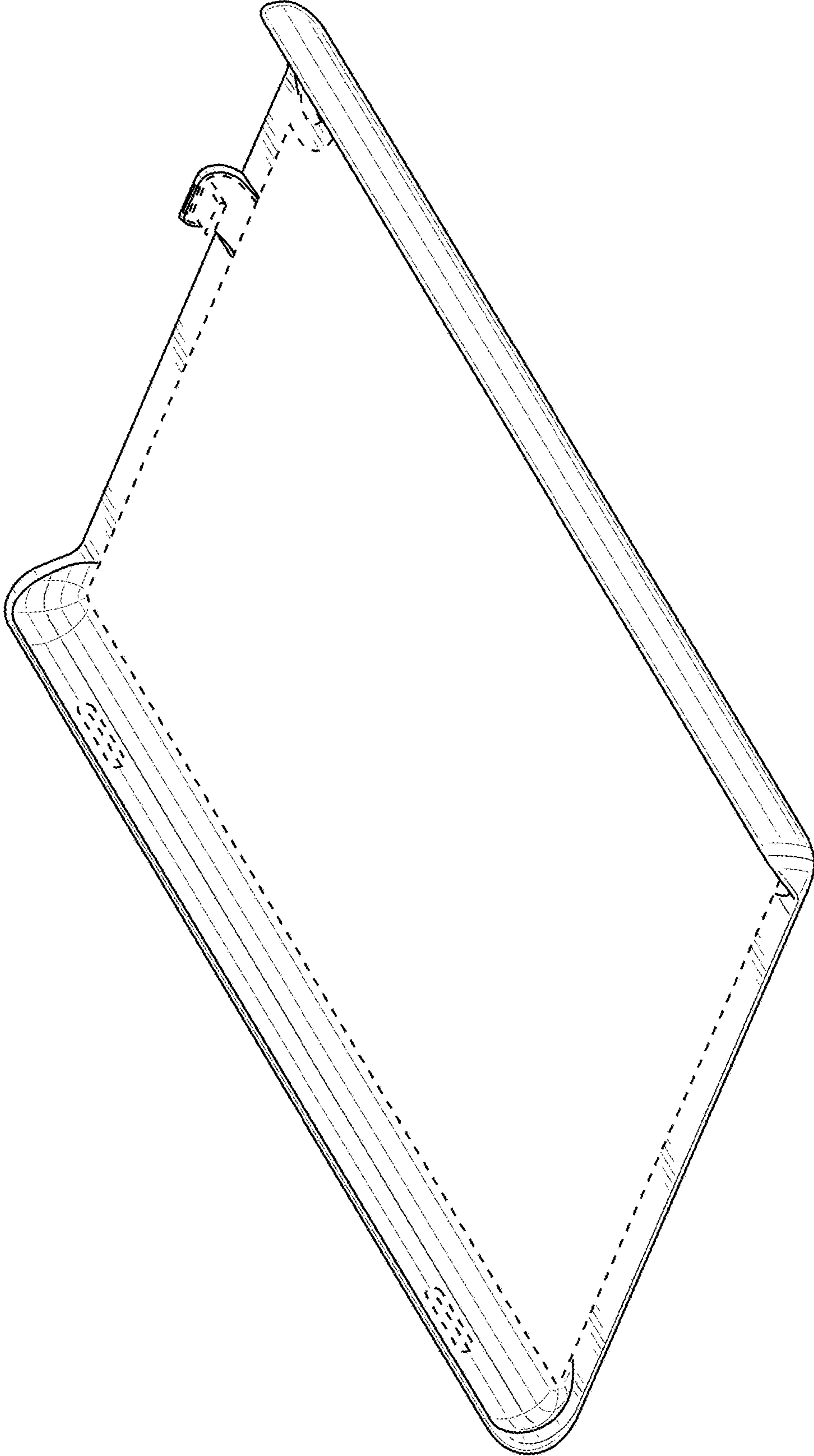

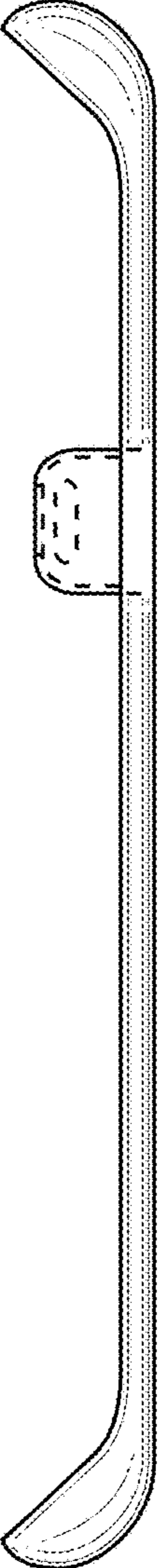

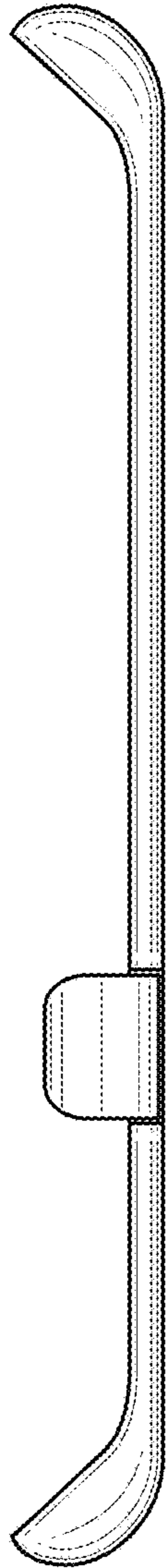

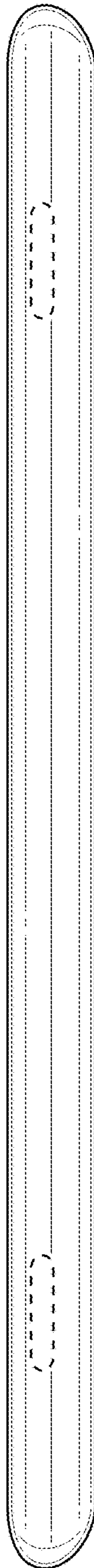

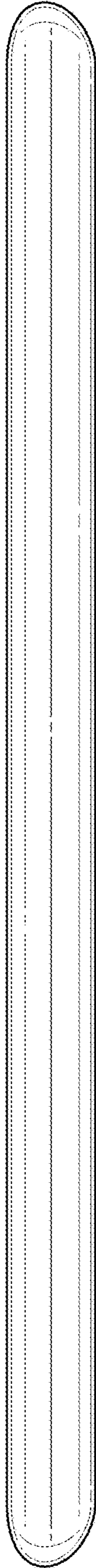

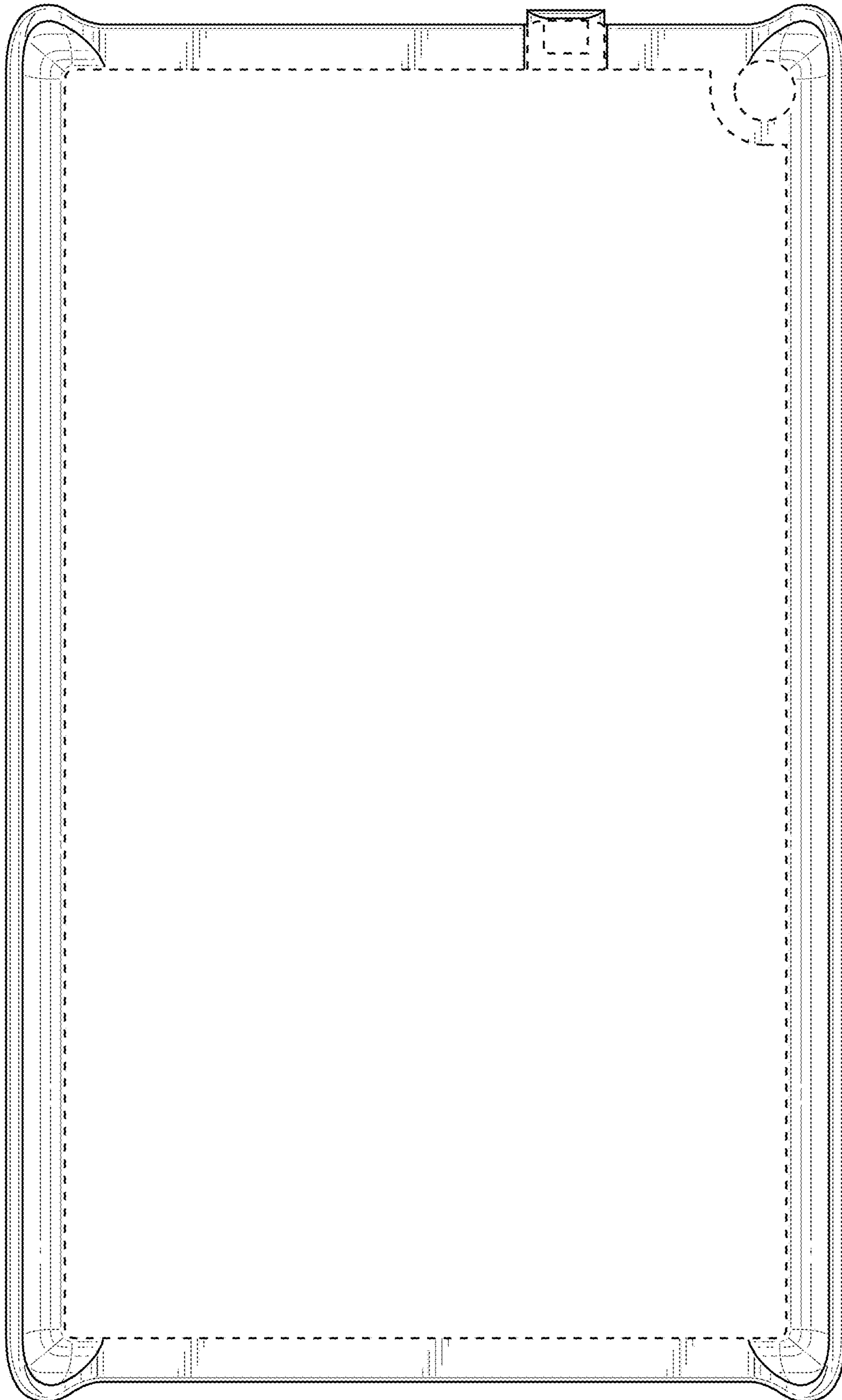

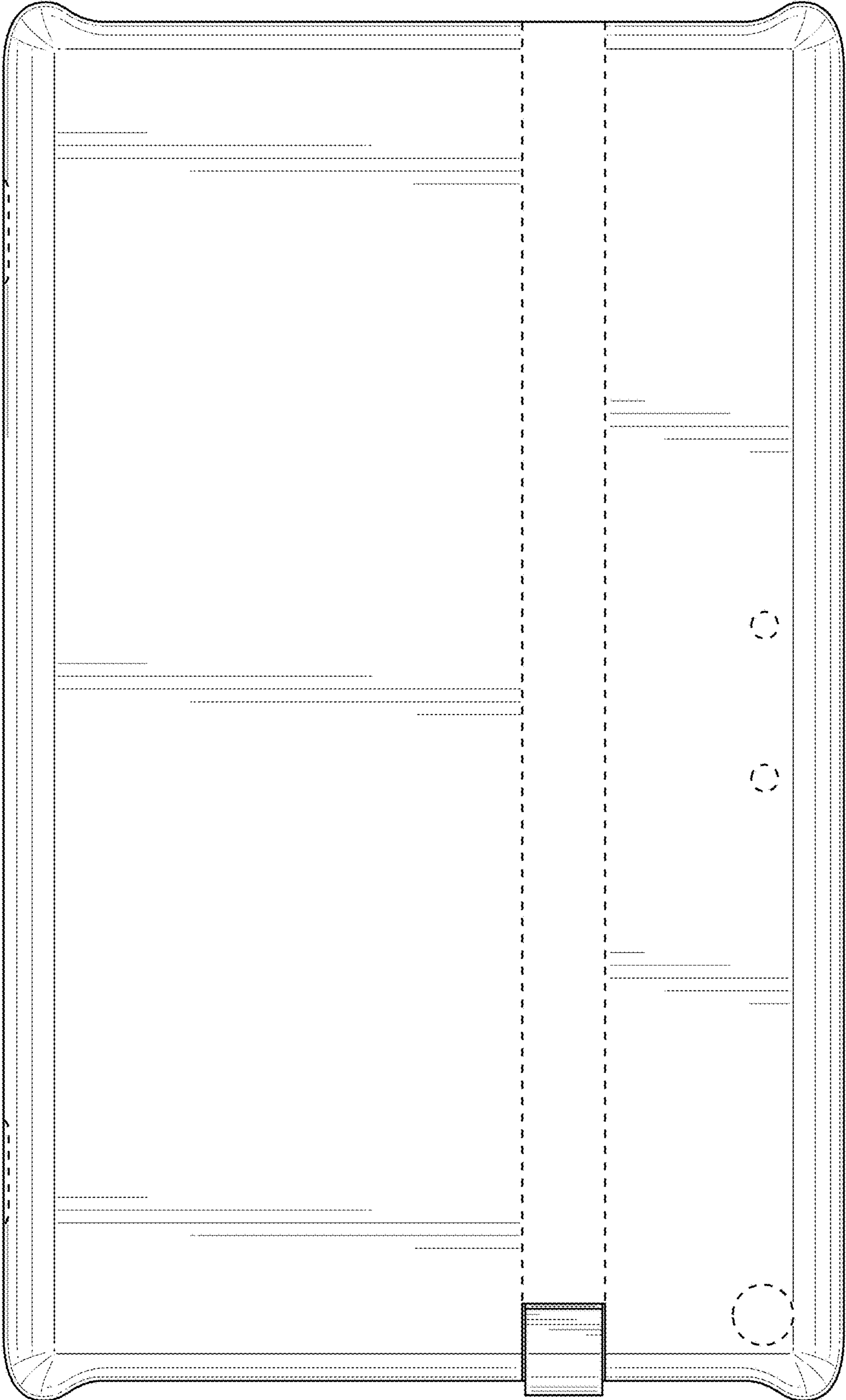

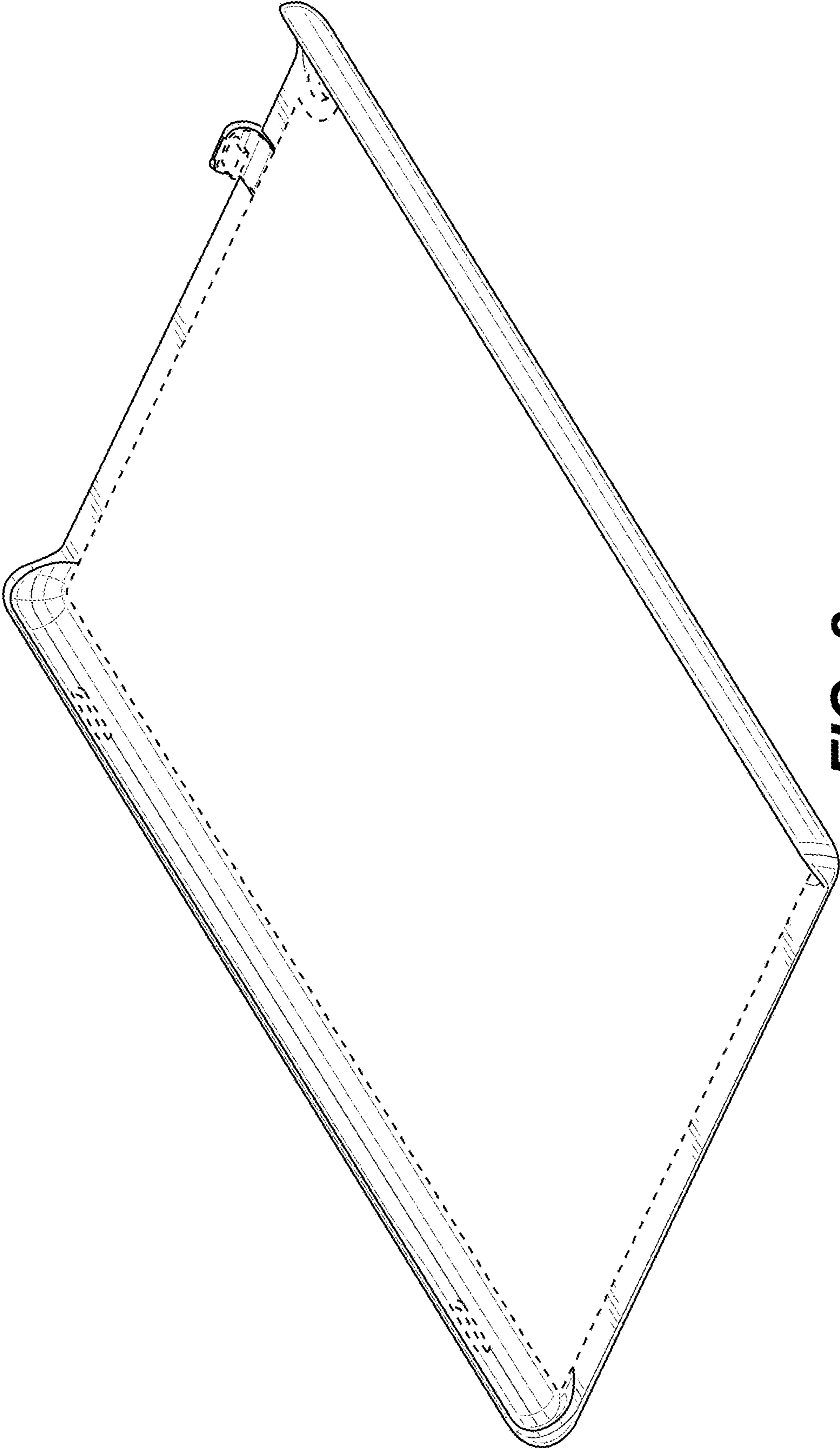

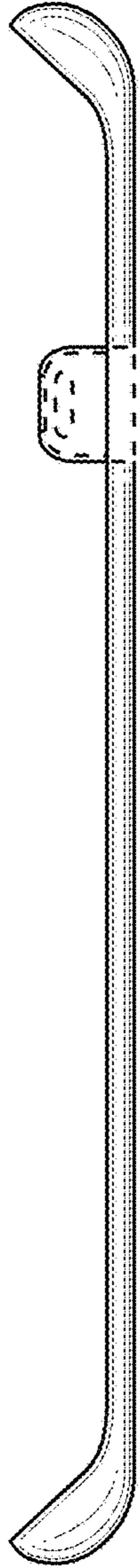

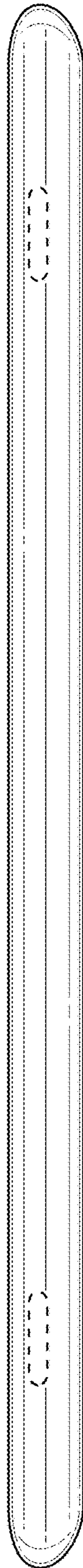

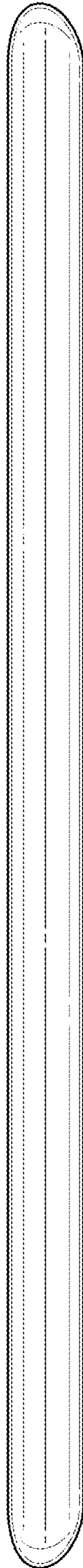

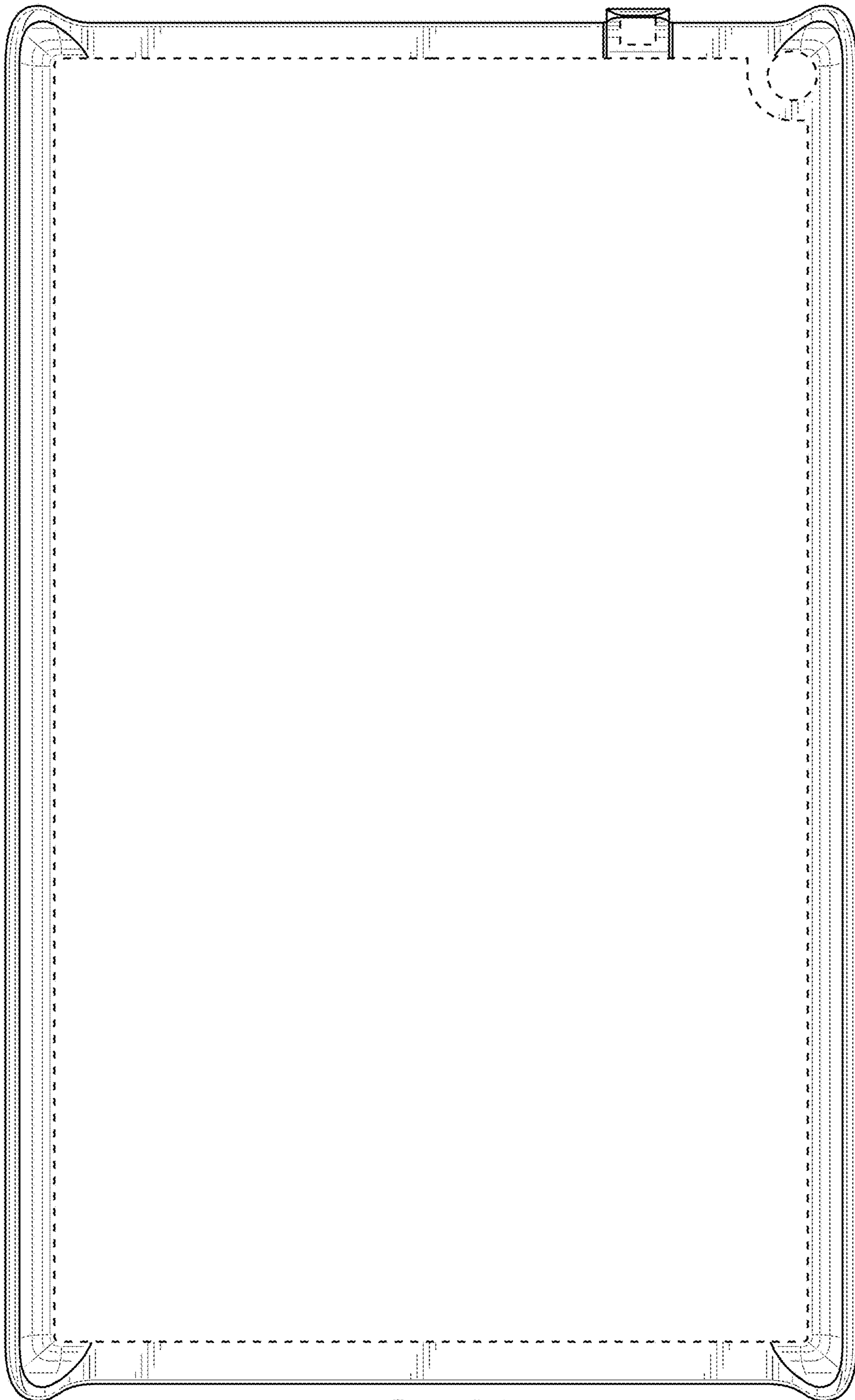

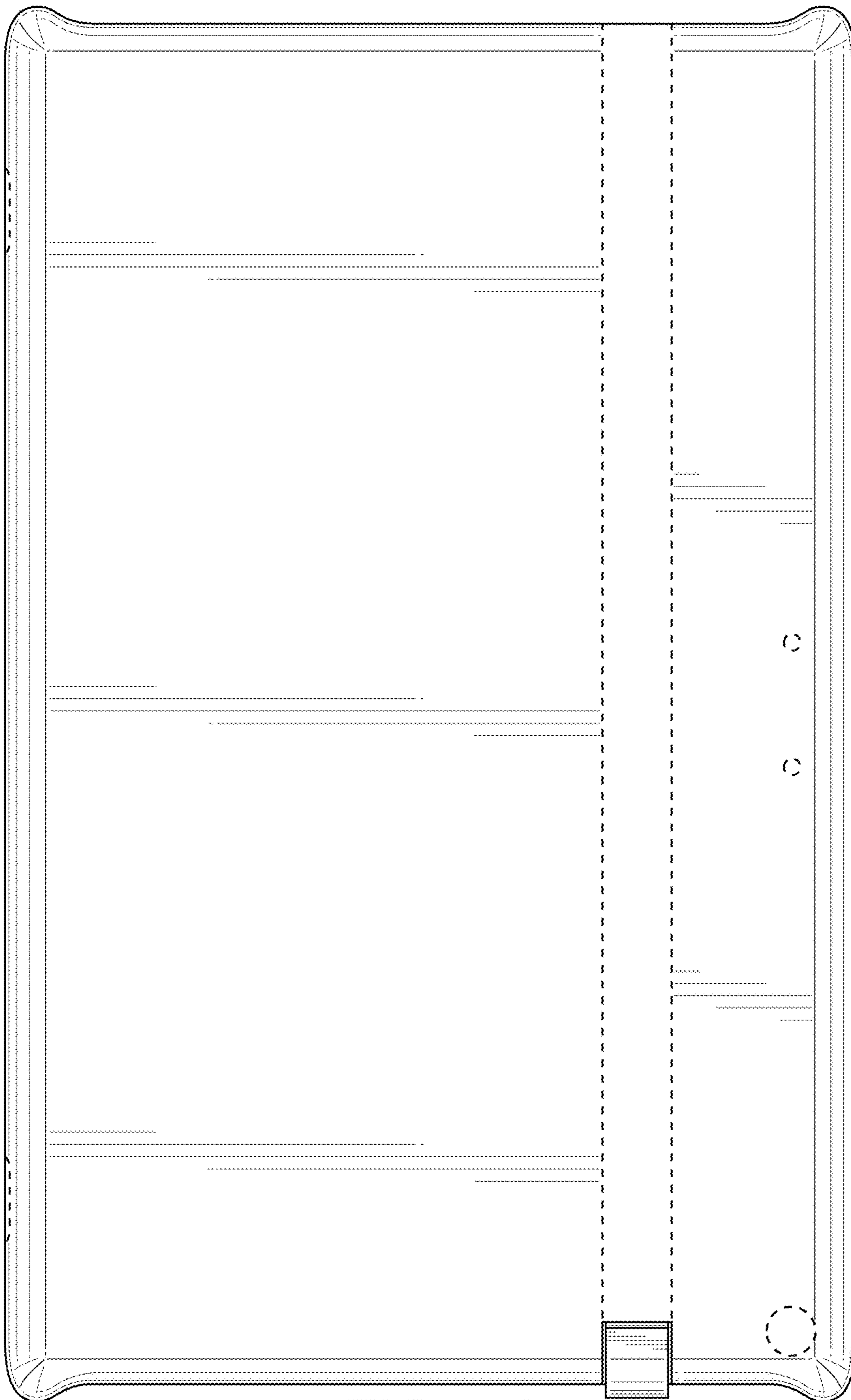
