(57) **CLAIM**

The ornamental design for a mobile device with a graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image in a sequence of a mobile device with a graphical user interface, illustrating the new design.

FIG. 3 is a third image thereof;

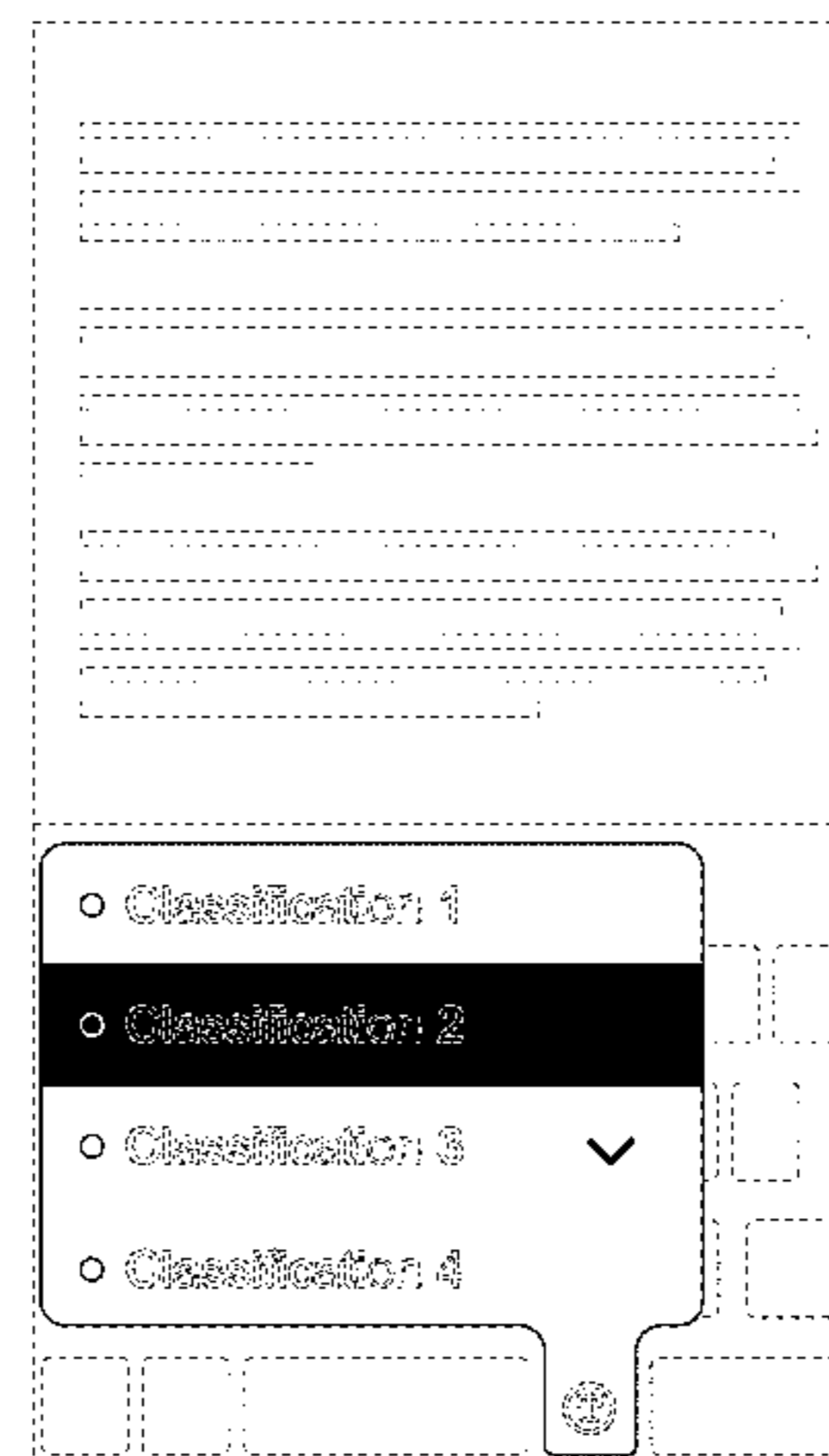
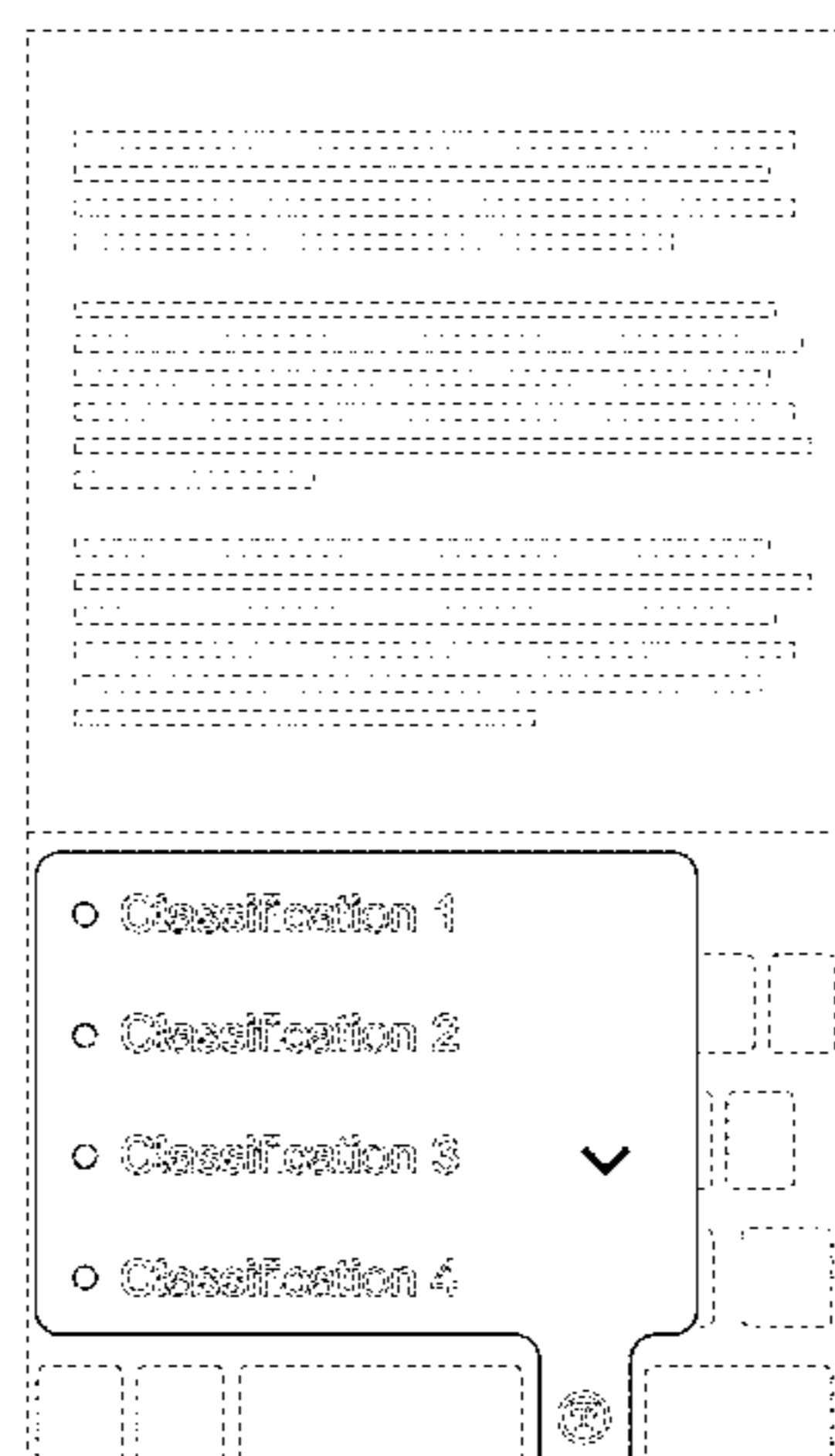
FIG. 4 is a fourth image thereof; and,

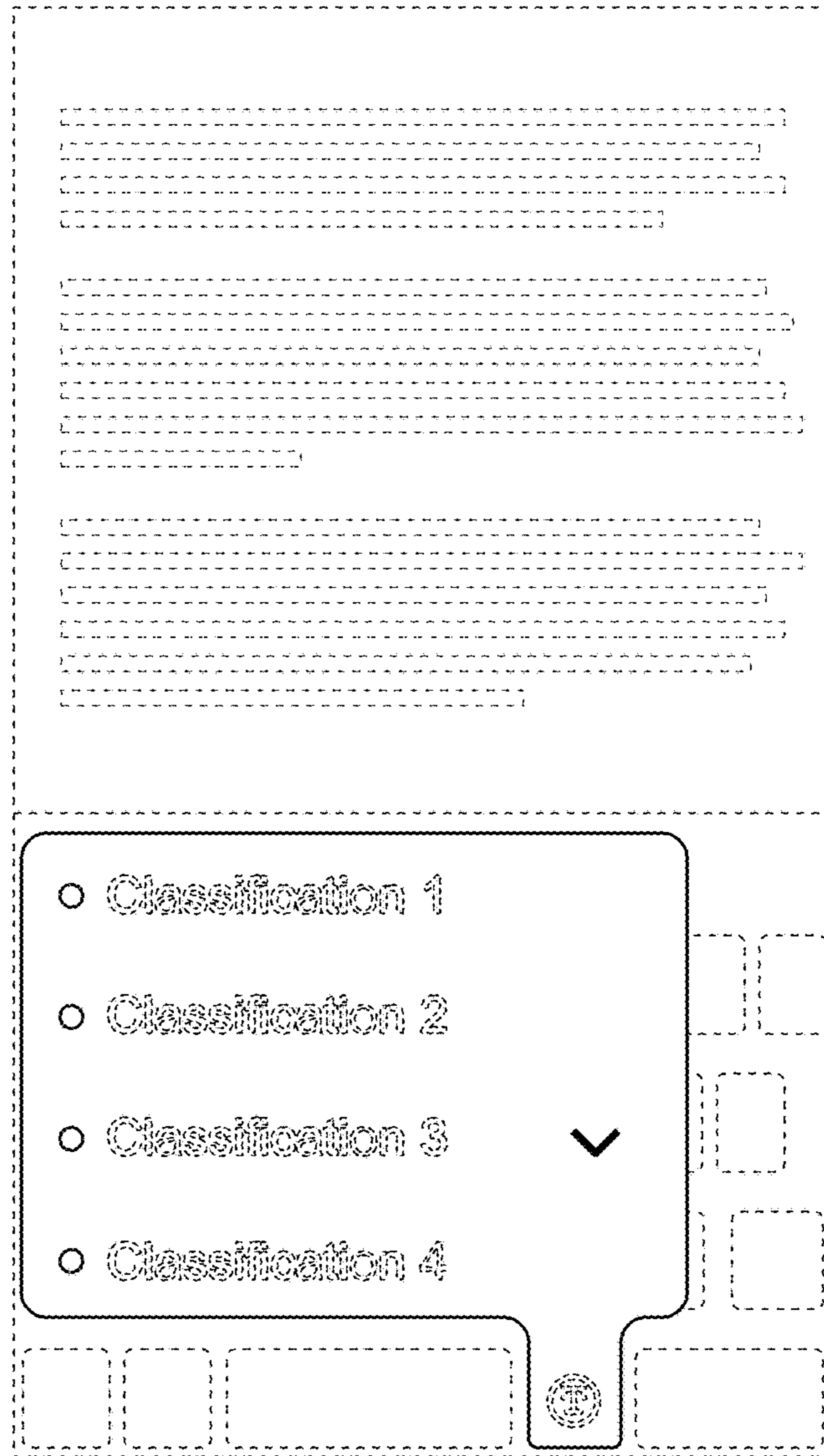

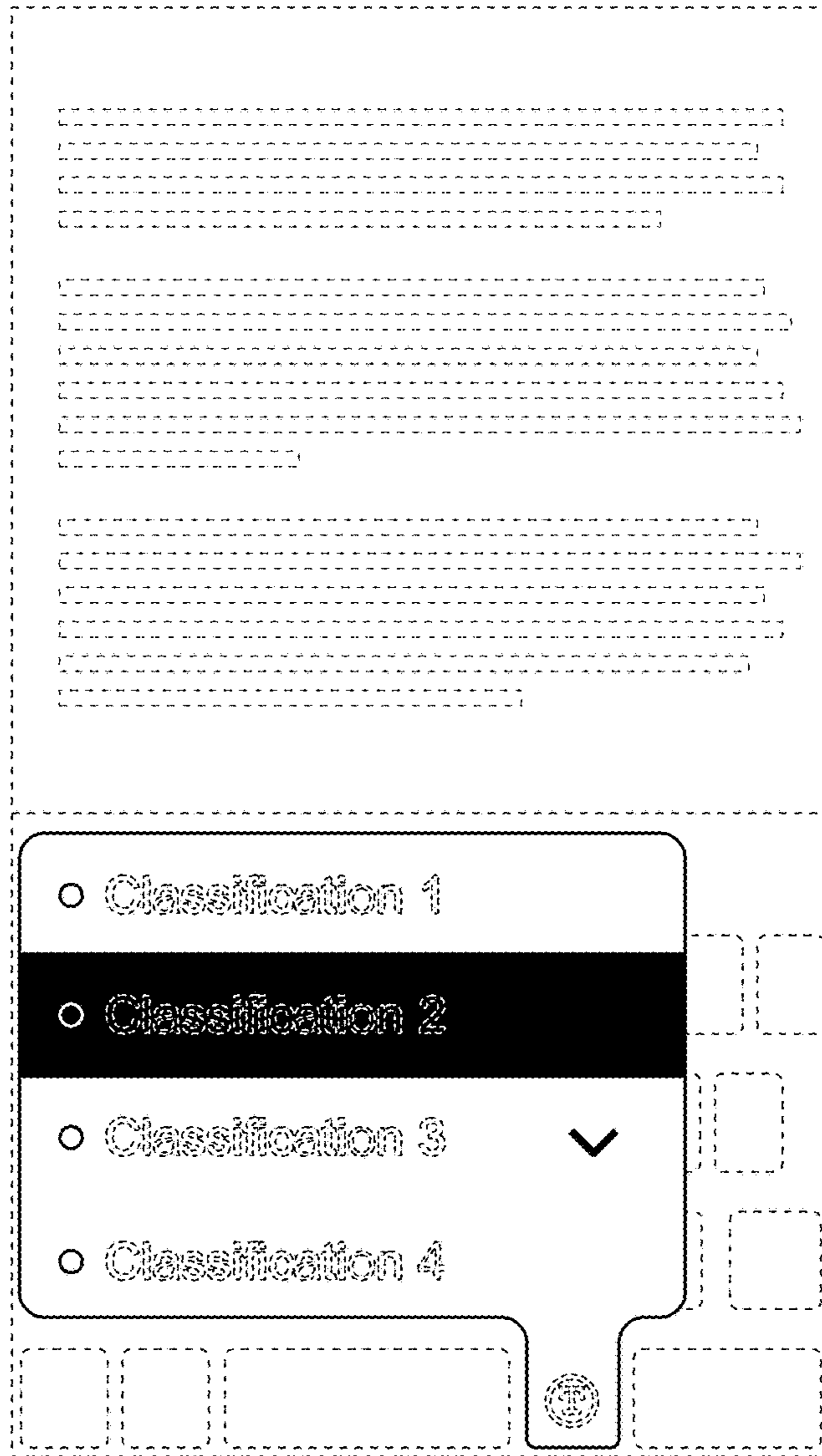

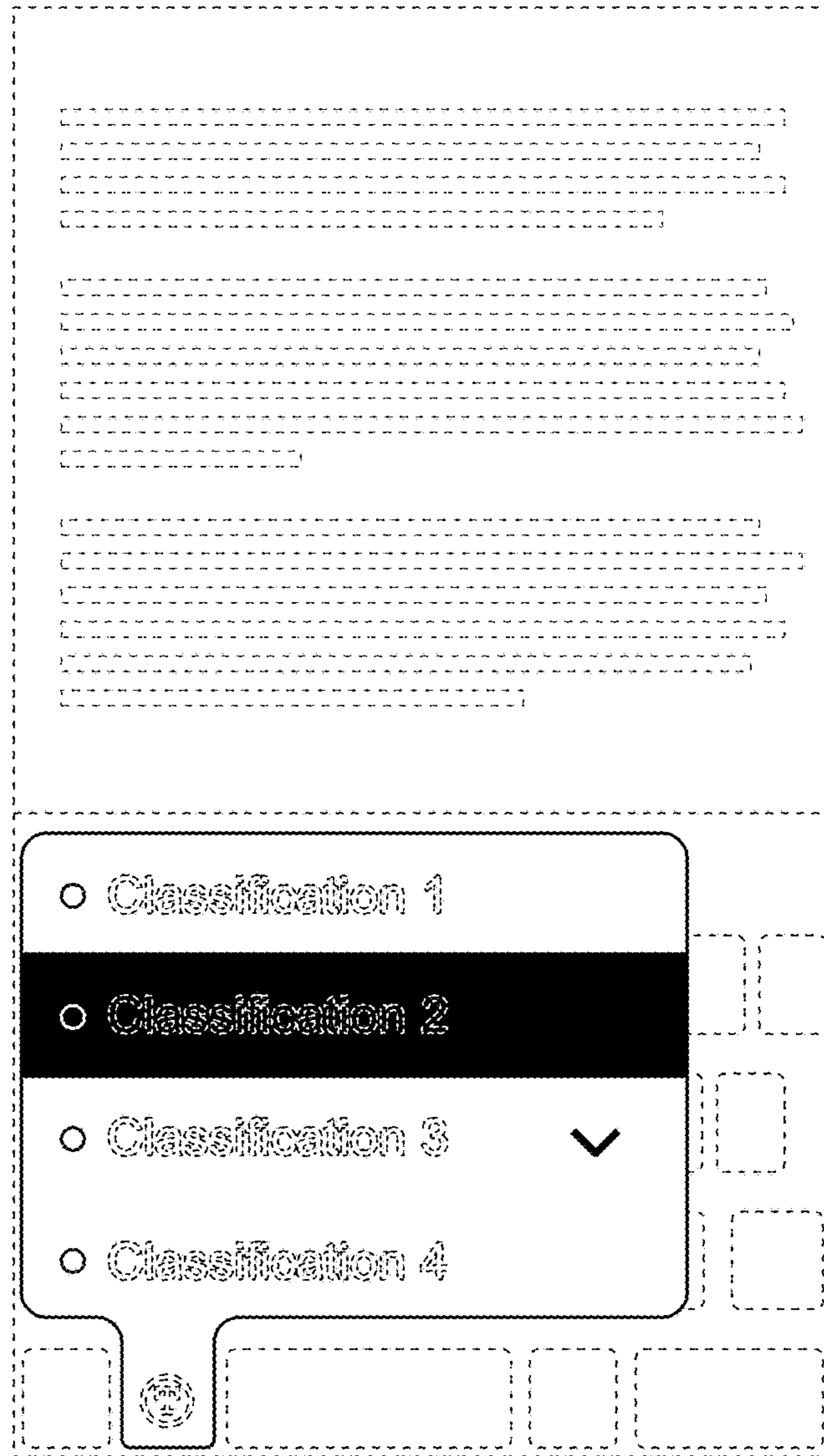

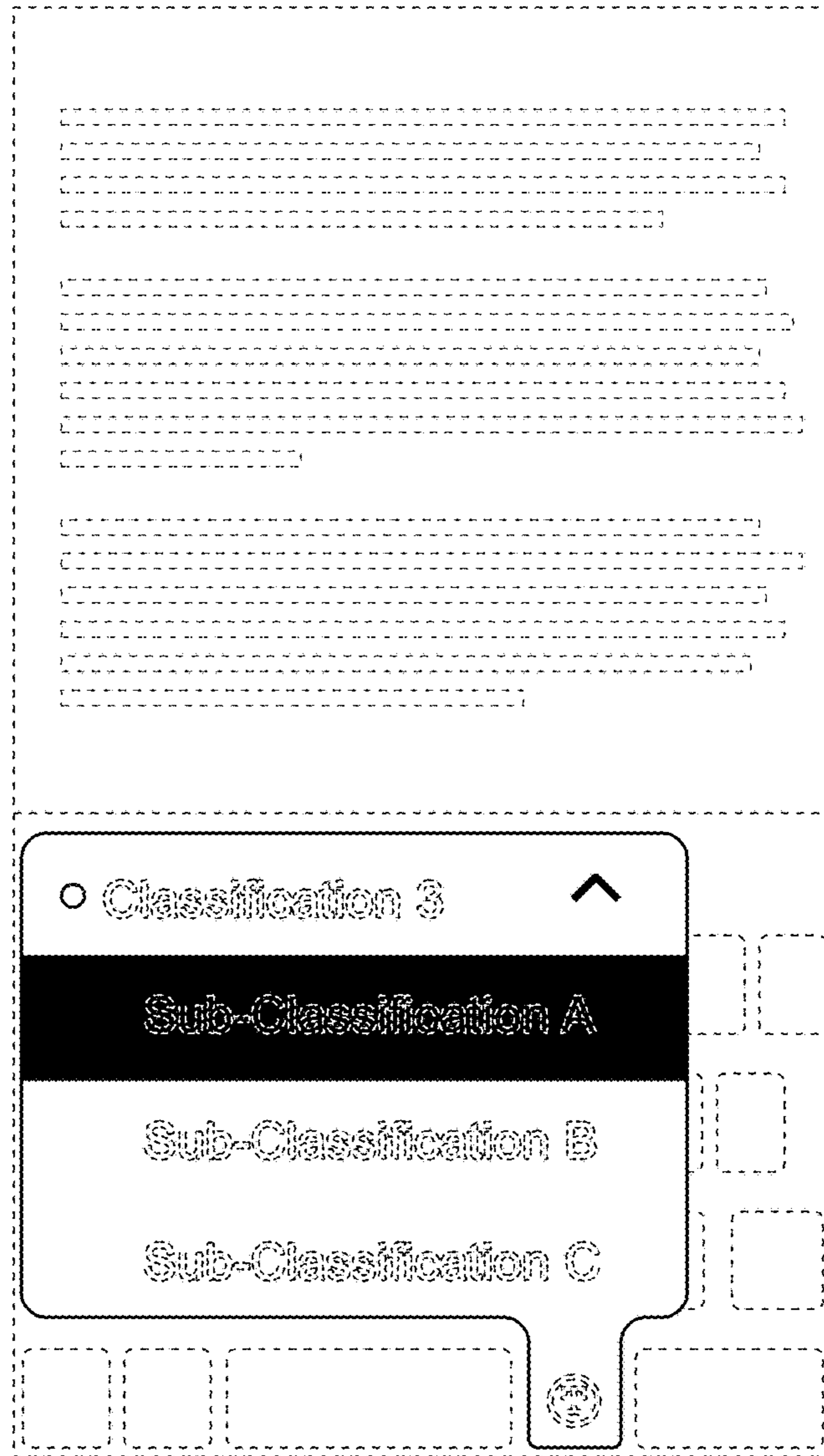

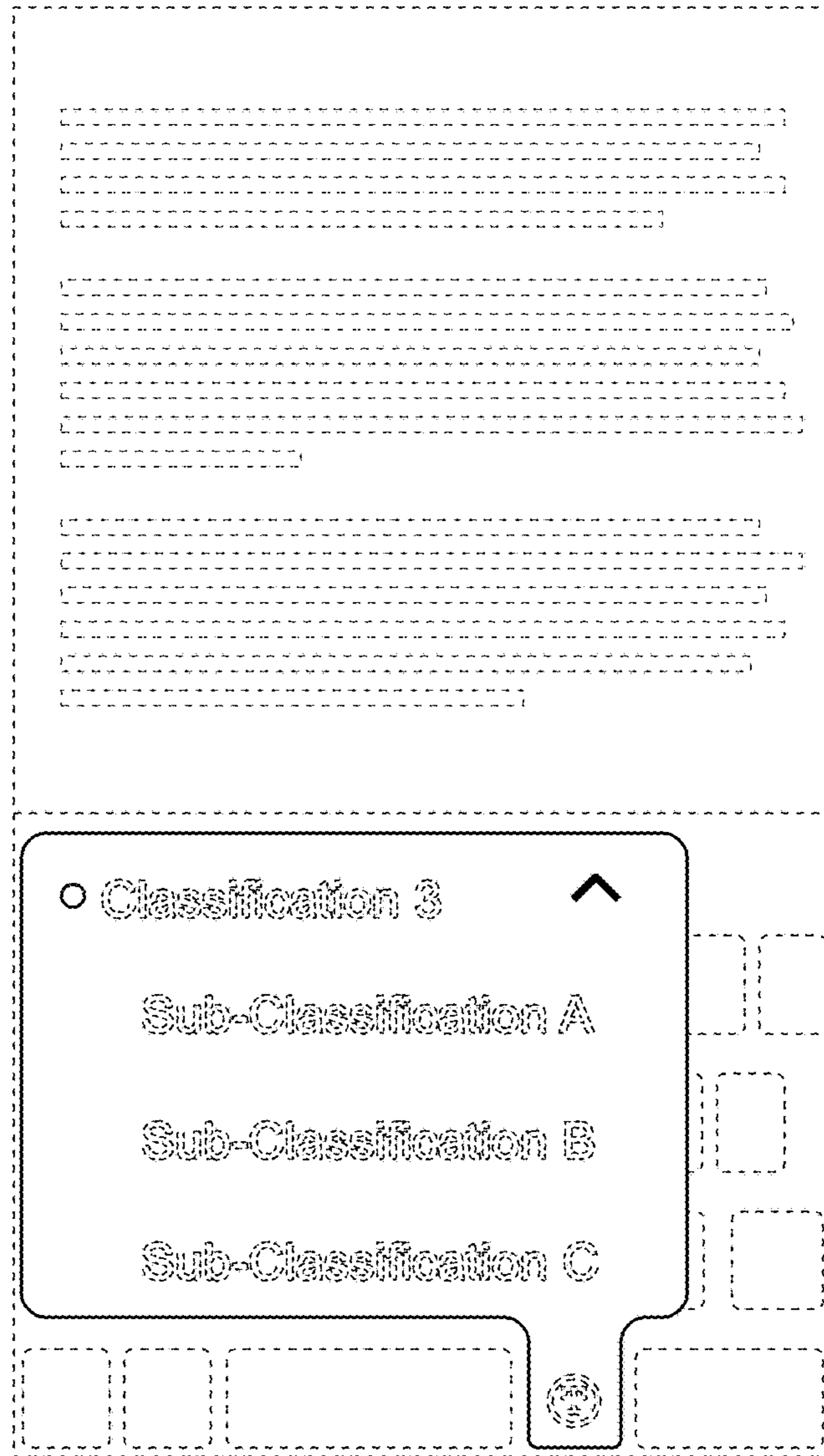
