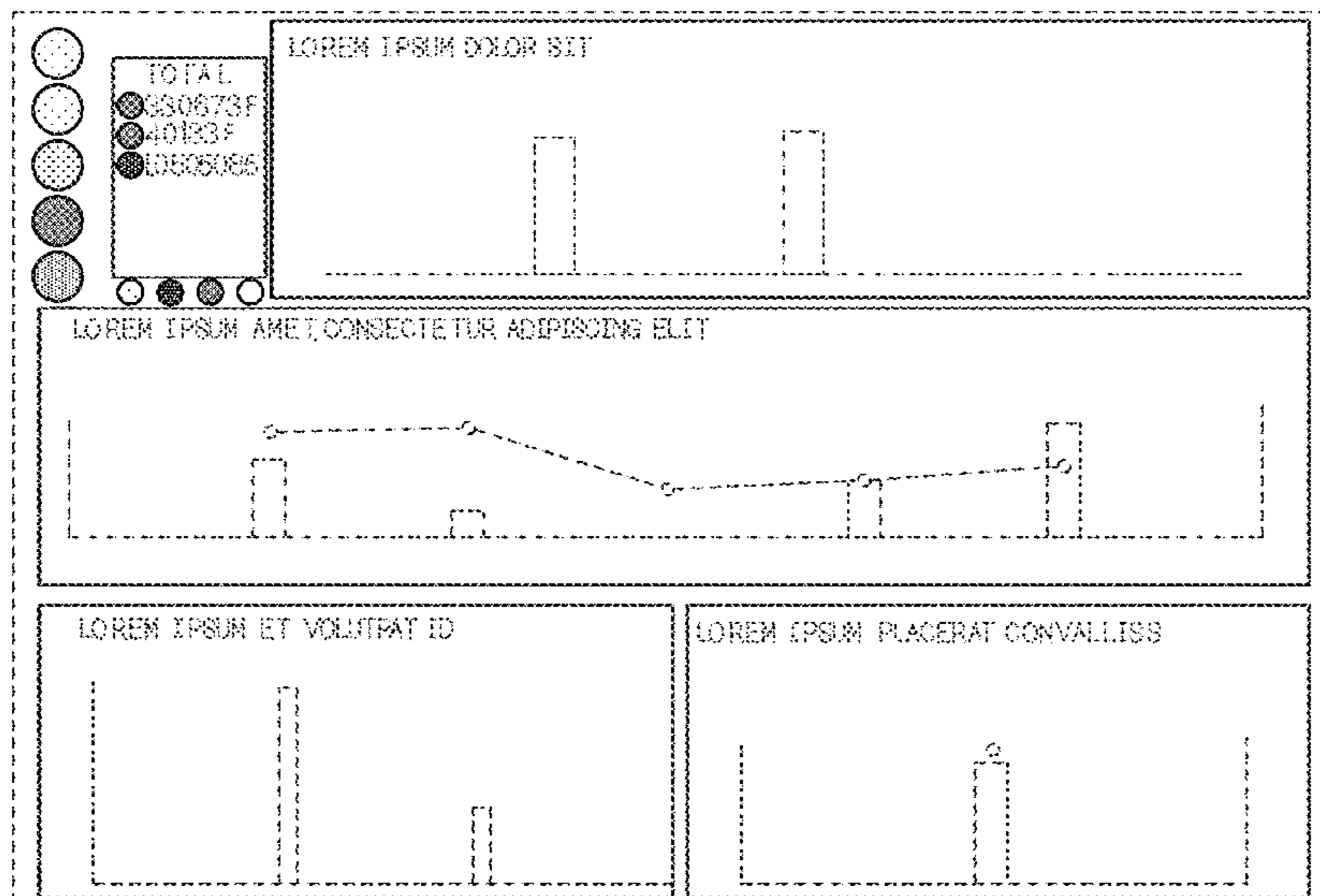
DESCRIPTION

FIG. 1 is a front view of a display with a graphical user interface; and,

FIG. 2 is a front view of a display with a graphical user interface.

The broken line at the periphery of the figures illustrate a display and the remainder of the broken lines in the figures illustrate portions of the graphical user interface. None of the broken lines form part of the claimed design. The variation in stippling within the circles of the graphical user interface demonstrate a contrast in appearance.

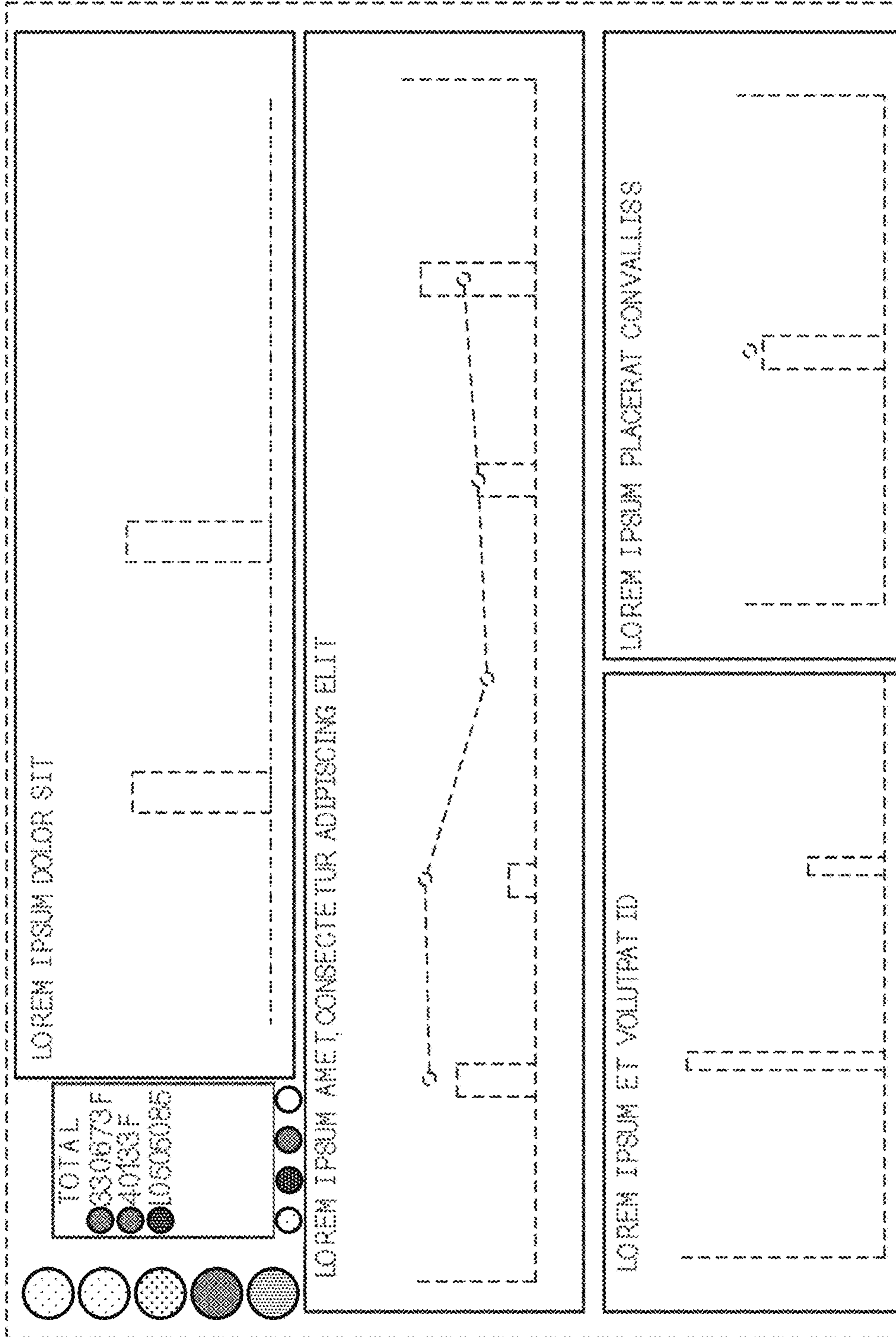

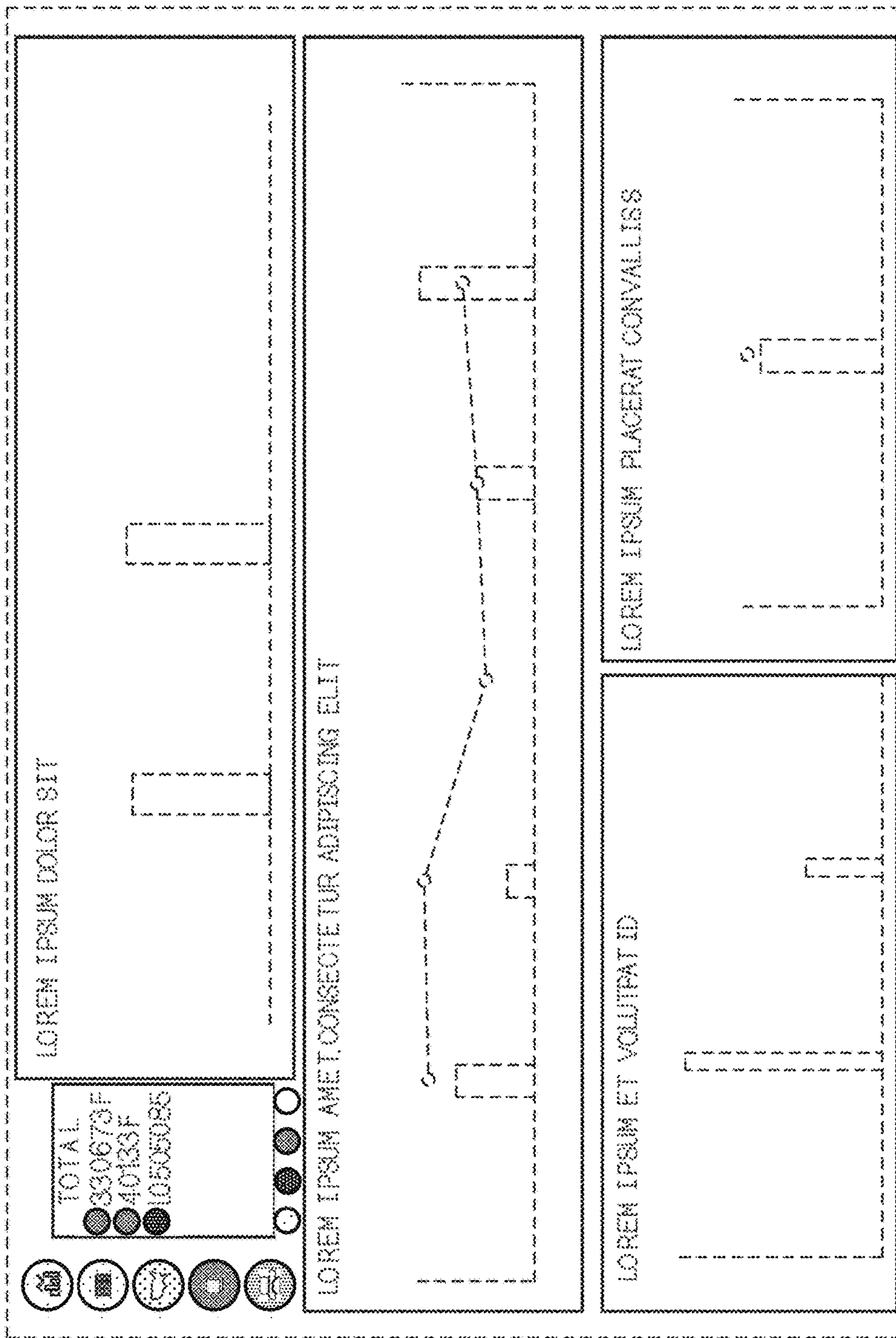
