(57) **CLAIM**

The ornamental design for a display panel with graphical user interface having an indicator, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display panel with graphical user interface having an indicator of a first embodiment of the present invention;

FIG. 2 is a front view of a display panel with graphical user interface having an indicator of a second embodiment of the present invention; and,

FIG. 3 is a front view of a display panel with graphical user interface having an indicator of a third embodiment of the present invention.

The broken lines in the drawings illustrate a display panel on which the graphical user interface is displayed, or portions of the display panel with graphical user interface having an indicator and form no part of the claimed design. In FIGS. 1 and 3, where colors are present, the color forms a part of the claimed design. The stippling and hatching within the small circles of FIG. 2 form part of the claimed design, with the variations in shading method representing a contrast of appearance.
