(57) **CLAIM**

We claim the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a display screen or portion thereof with graphical user interface showing our new design;

FIG. 2 is a front view of a second embodiment thereof;

FIG. 3 is a front view of a third embodiment thereof;

FIG. 4 is a front view of a fourth embodiment thereof;

FIG. 5 is a partial enlargement of the portion defined by dot-dash broken lines shown in FIG. 1;

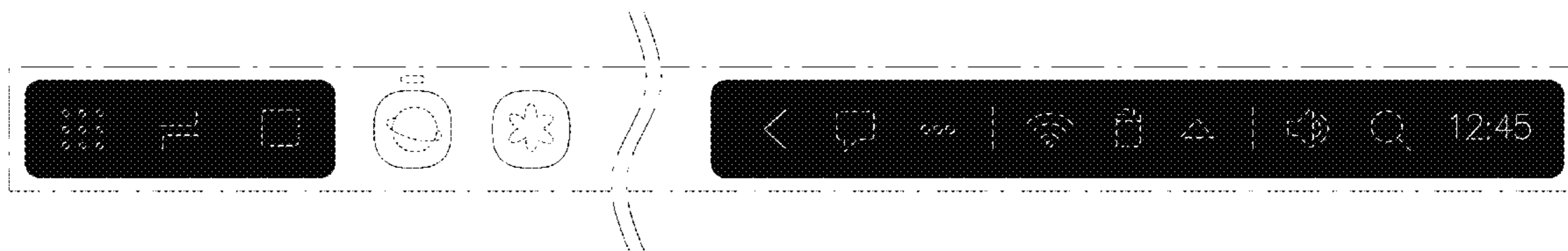
FIG. 6 is a partial enlargement of the portion defined by dot-dash broken lines shown in FIG. 2;

FIG. 7 is a partial enlargement of the portion defined by dot-dash broken lines shown in FIG. 3; and,

FIG. 8 is a partial enlargement of the portion defined by dot-dash broken lines shown in FIG. 4.

The outer short dash-dash broken lines in FIGS. 1 to 4 illustrate a display screen or portion thereof and form no part of the claimed design. The remaining short dash-dash broken lines in the figures illustrate portions of the graphical user interface that form no part of the claimed design. The dot-dash broken lines defining portions of the claimed design that are illustrated in enlargements form no part of the claimed design. The dot-dot-dash wave lines shown in FIGS. 5 to 8 represent a truncation of a portion of the graphical user interface design in the enlarged views.

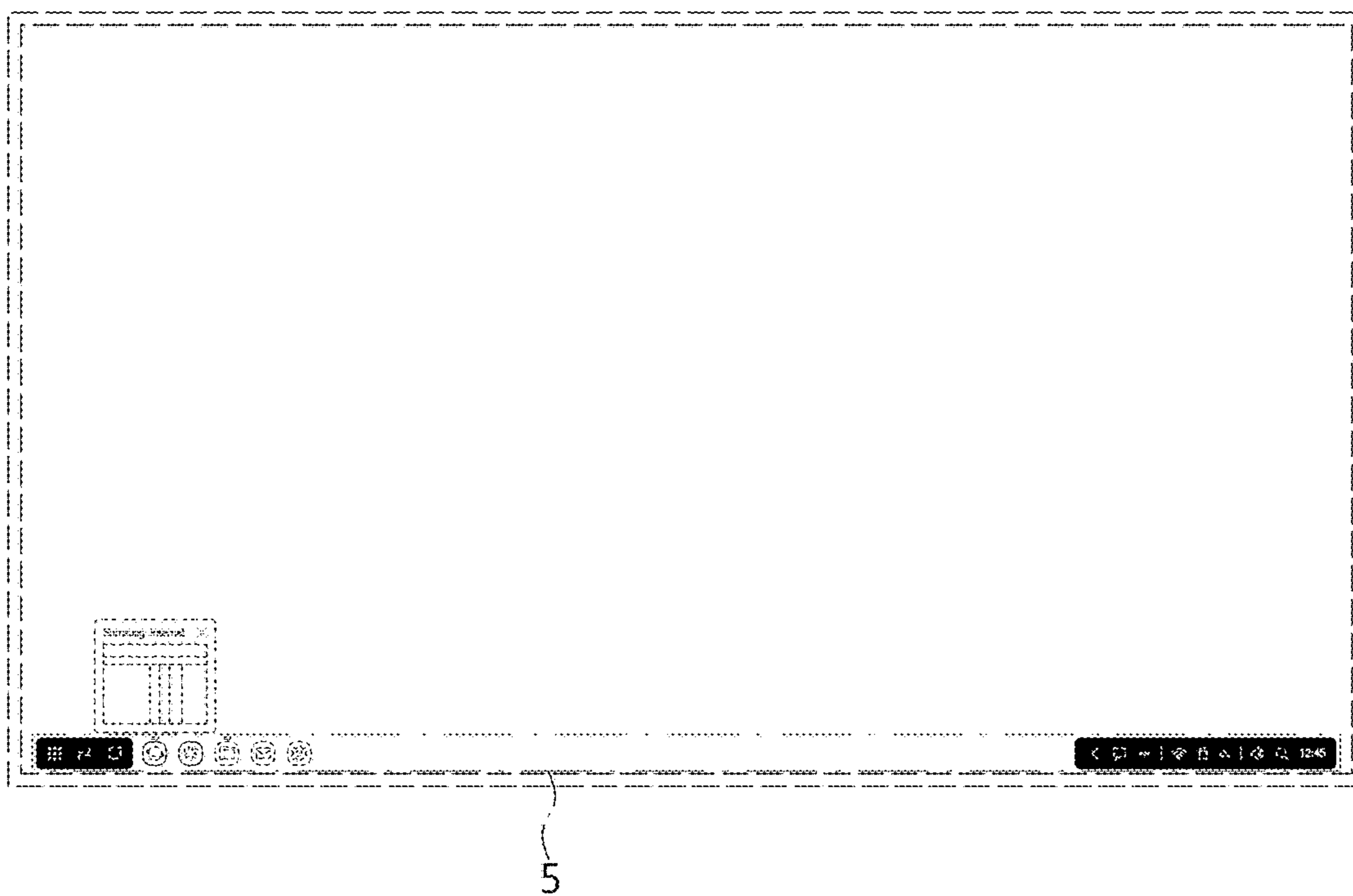

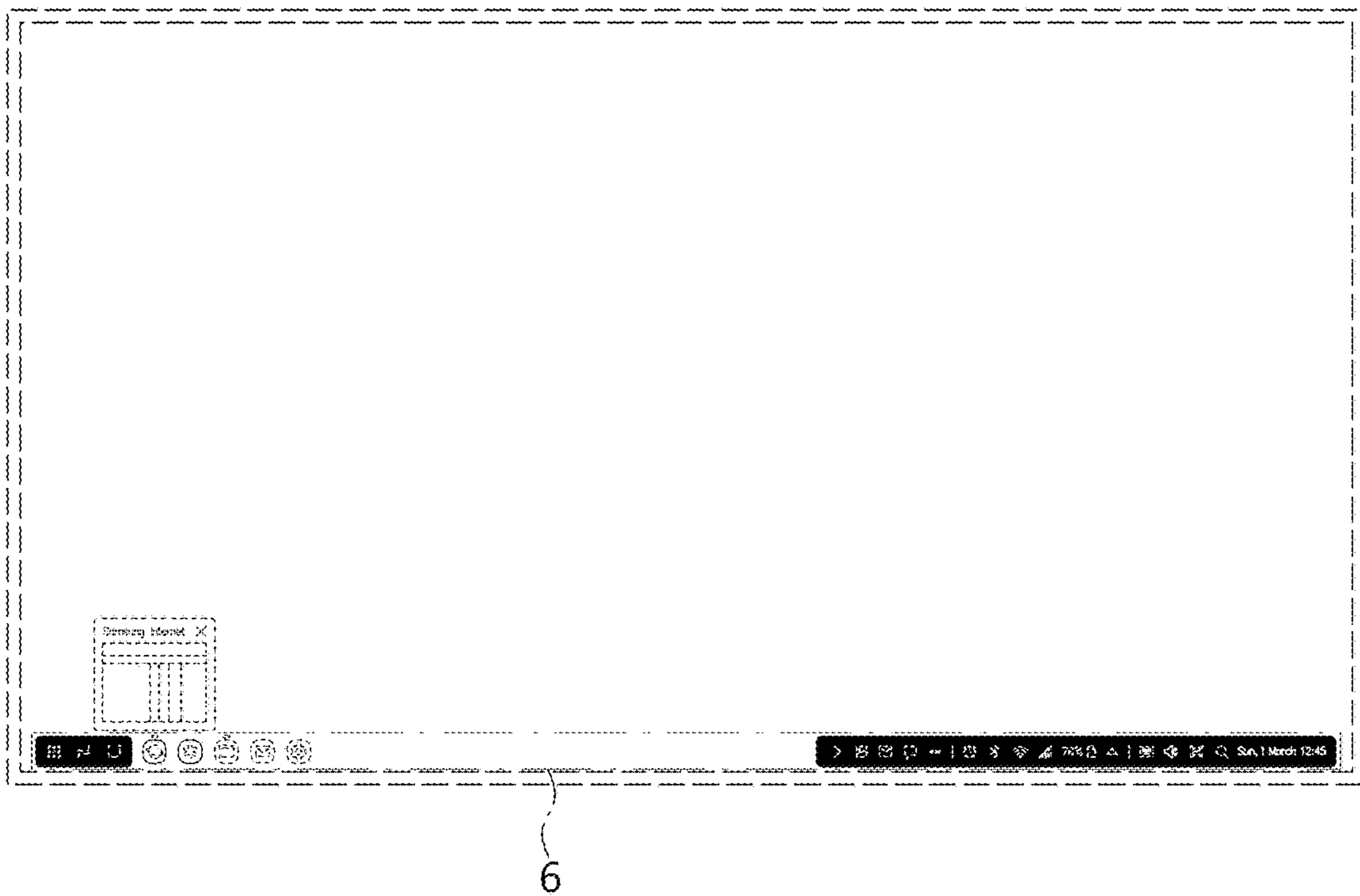

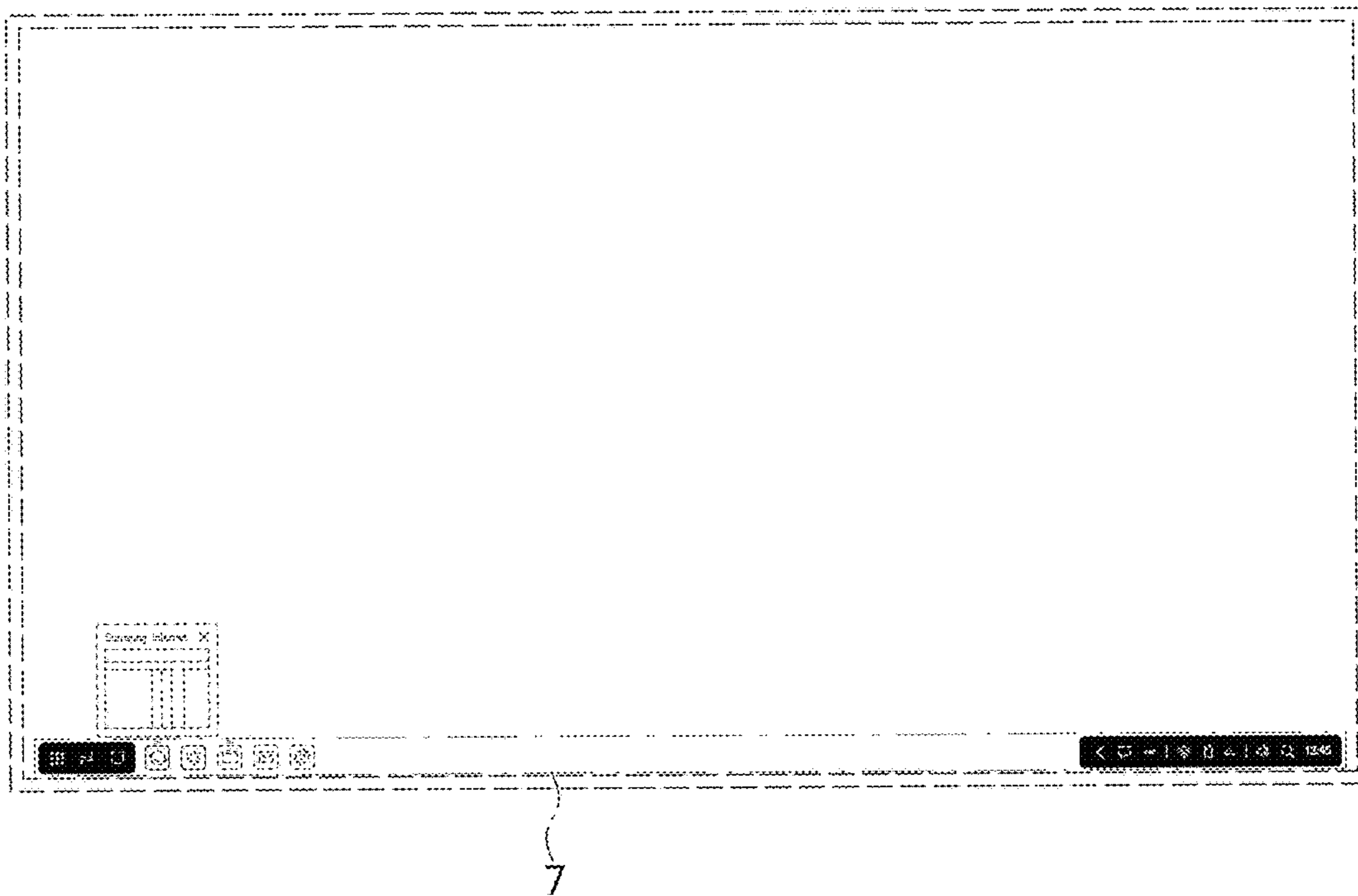

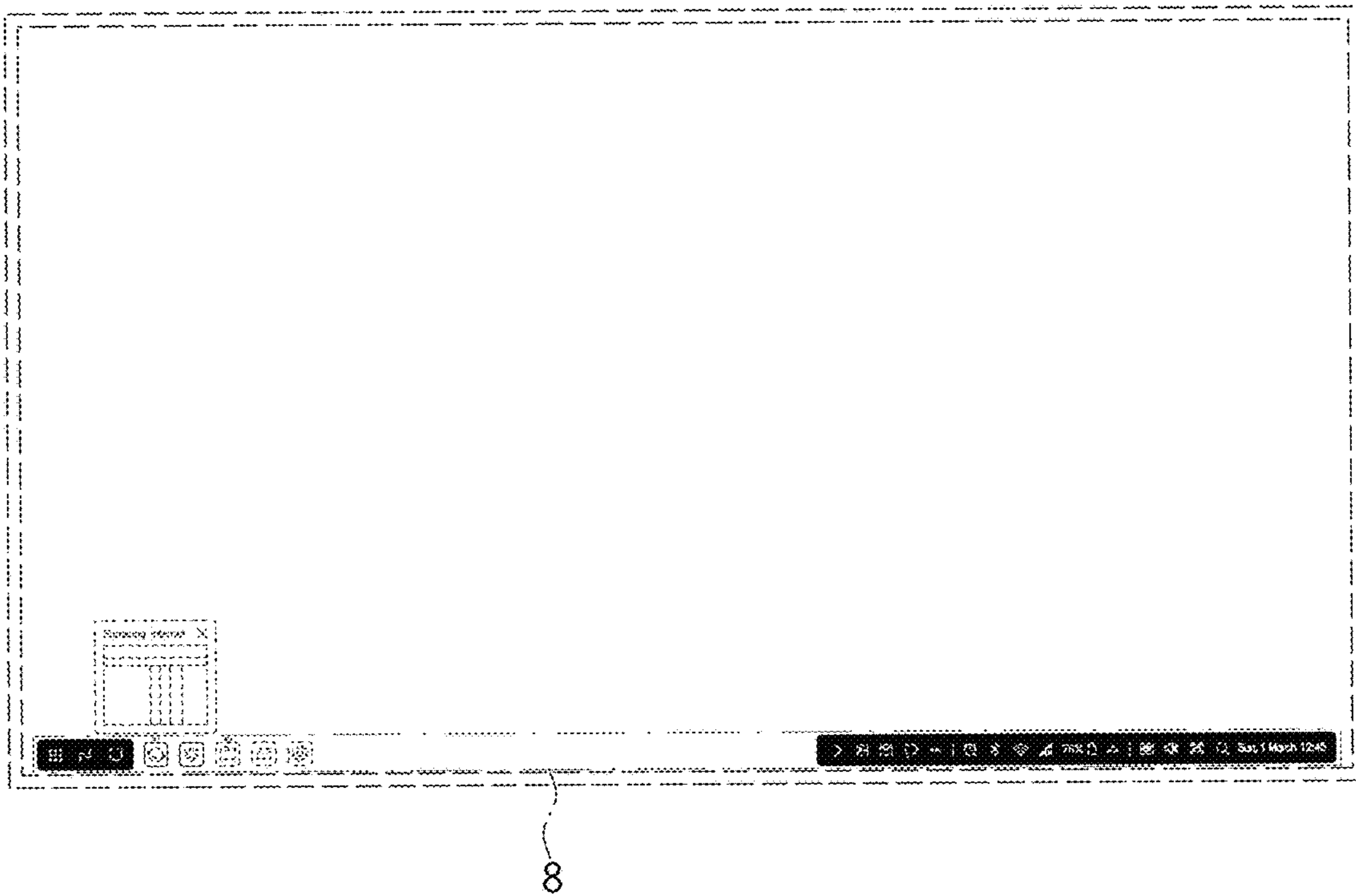

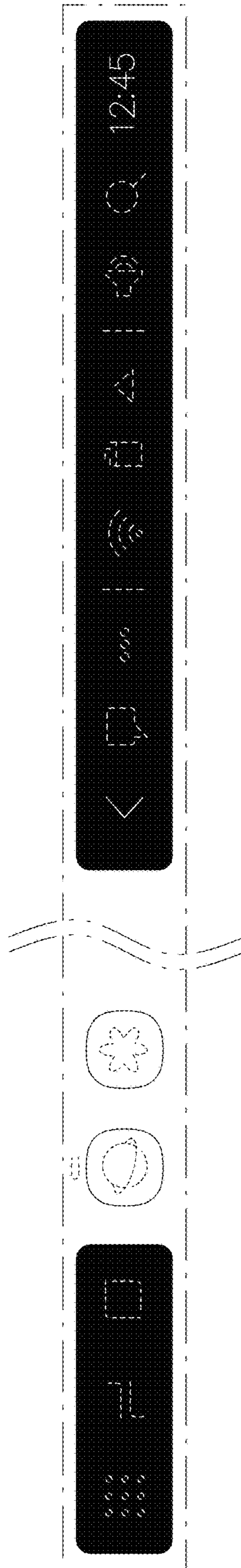

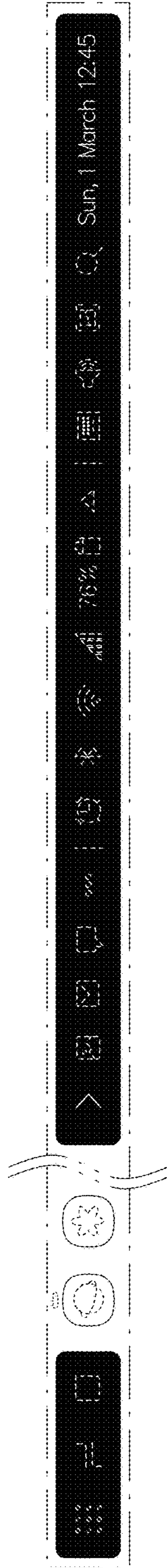

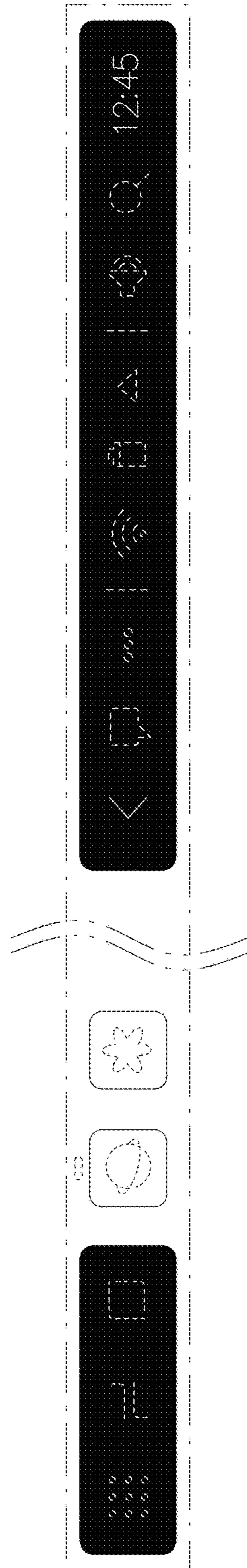
